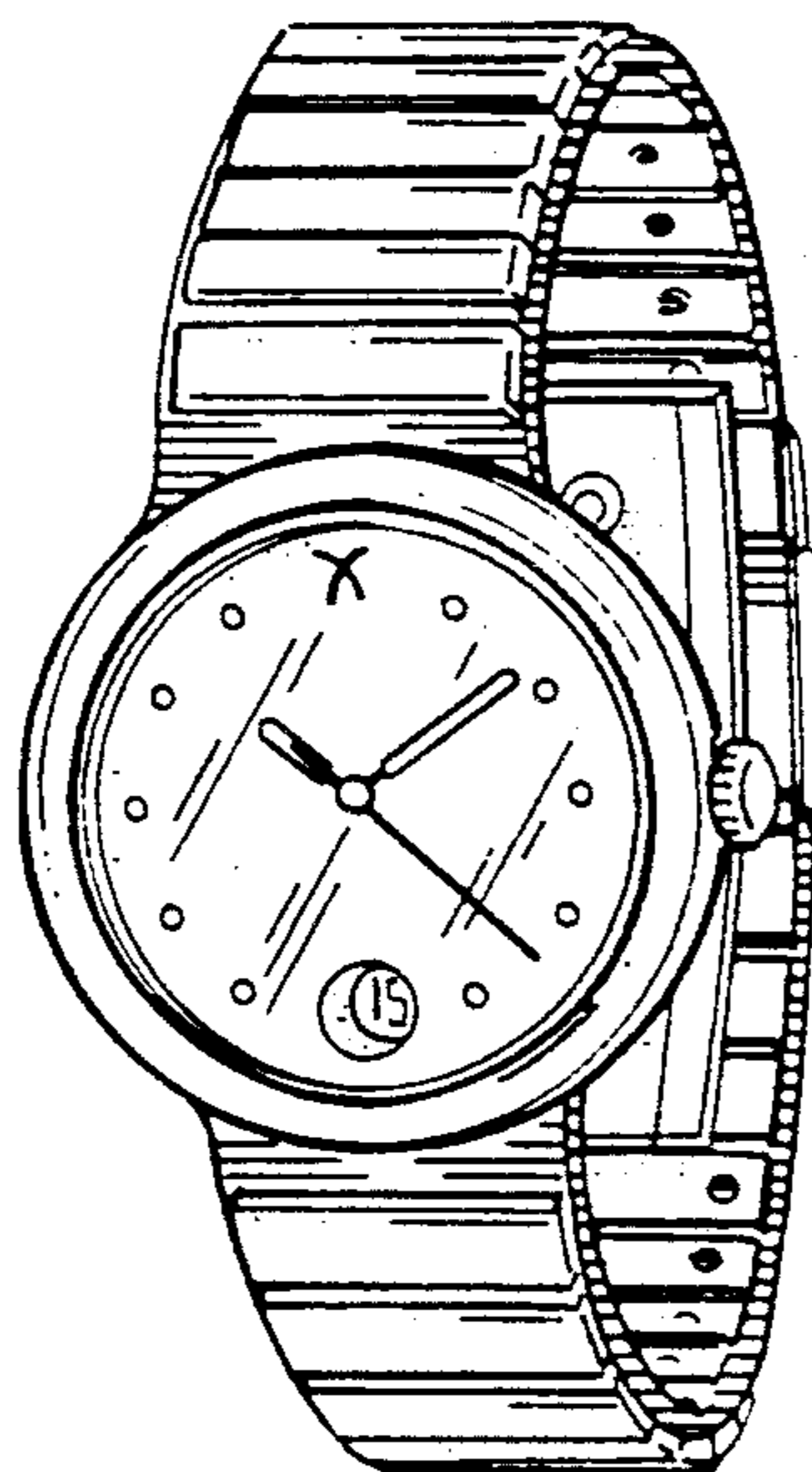

[57] CLAIM

The ornamental design for a wristwatch and strap, as shown and described.

DESCRIPTION

FIG. 1 is a front and right side perspective view of a wristwatch and strap showing my new design; FIG. 2 is a rear elevational view, with the fastening portion being eliminated for ease of illustration; FIG. 3 is a left side elevational view; FIG. 4 is a front and left side perspective view; and FIG. 5 is a top plan view thereof, the bottom plan view being a mirror image.



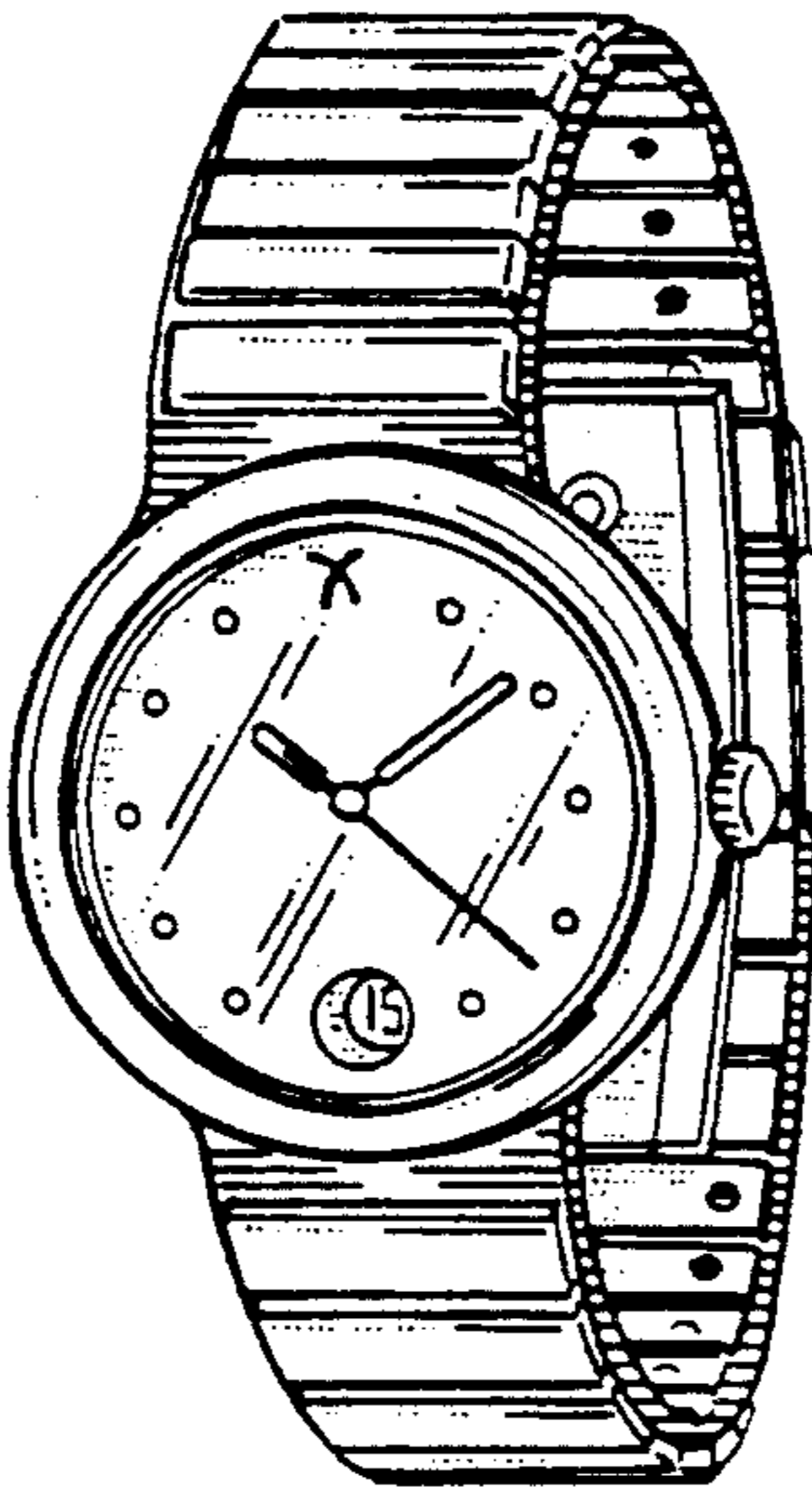

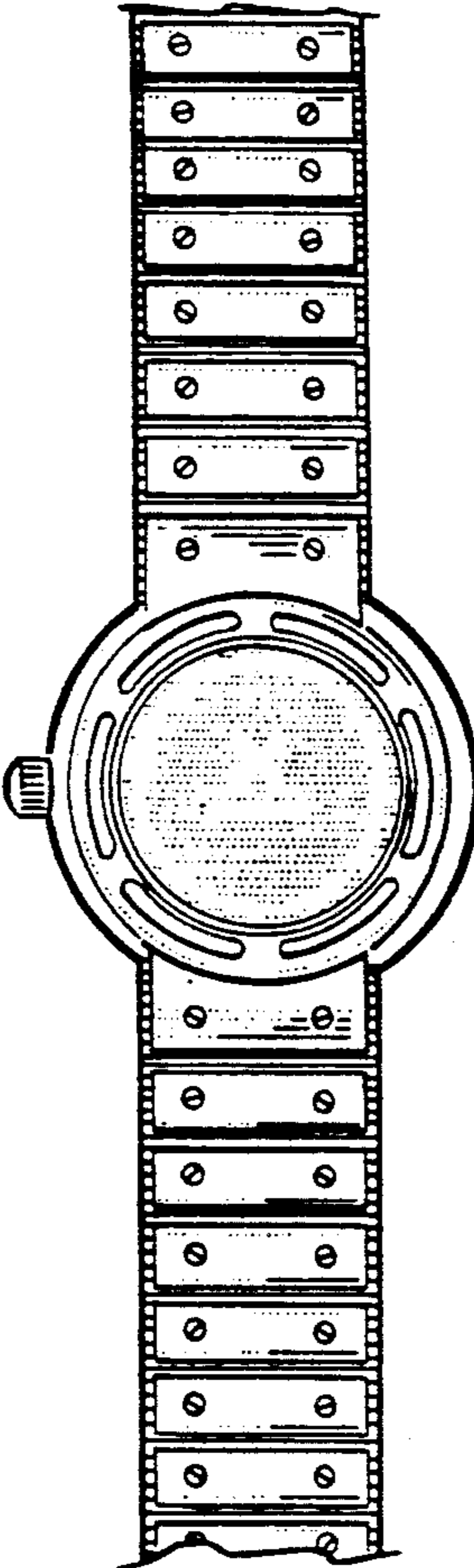
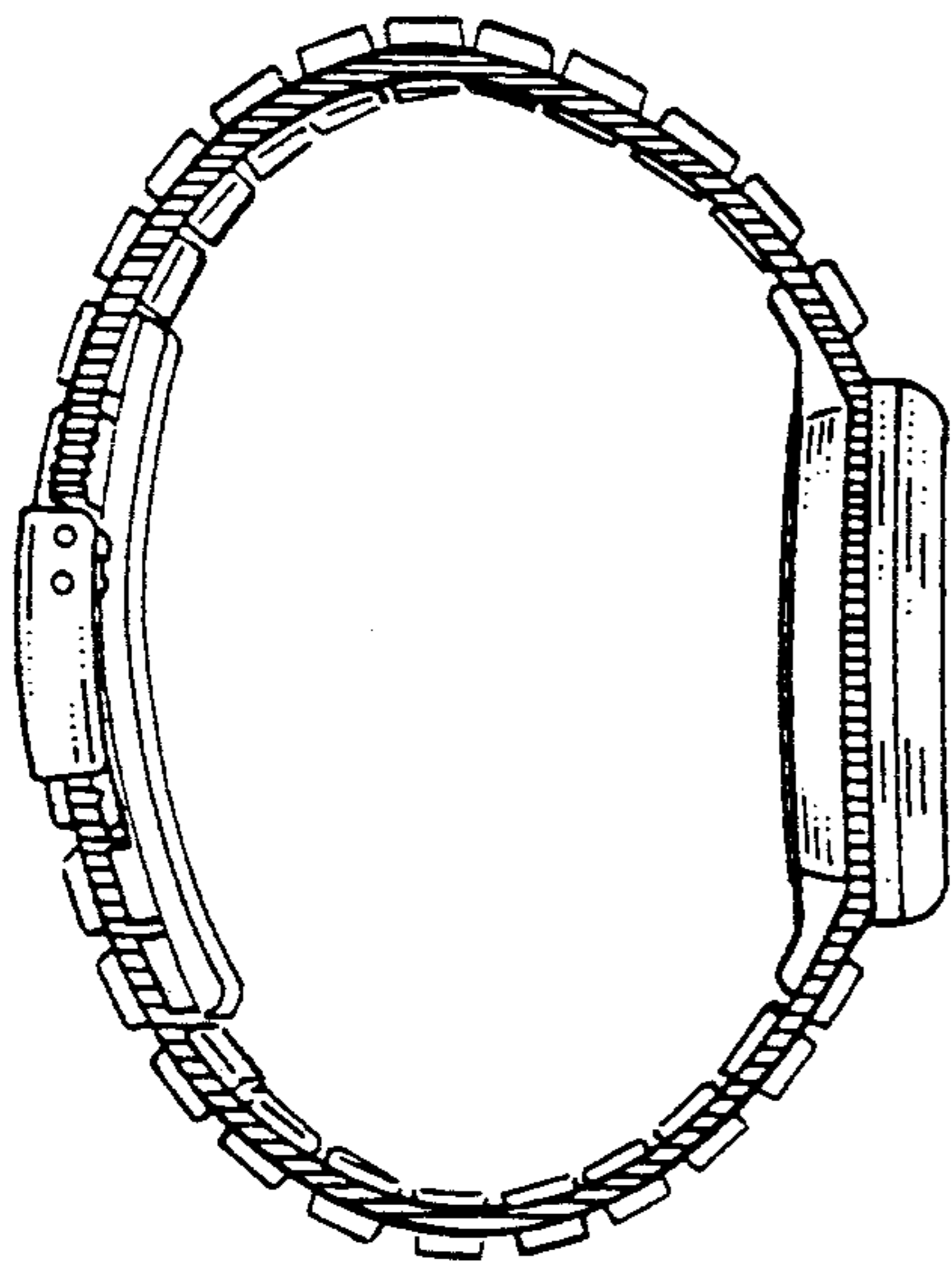
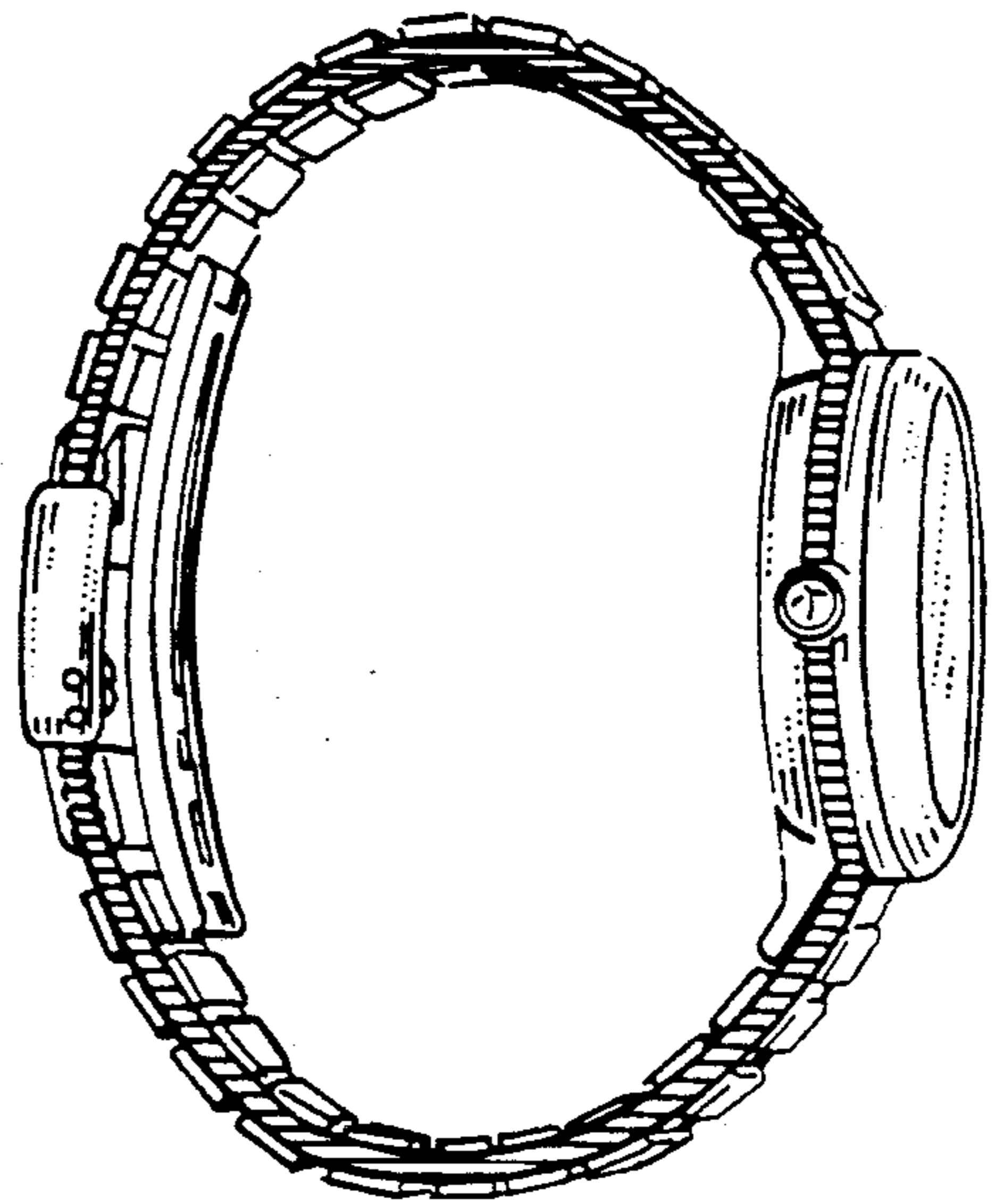


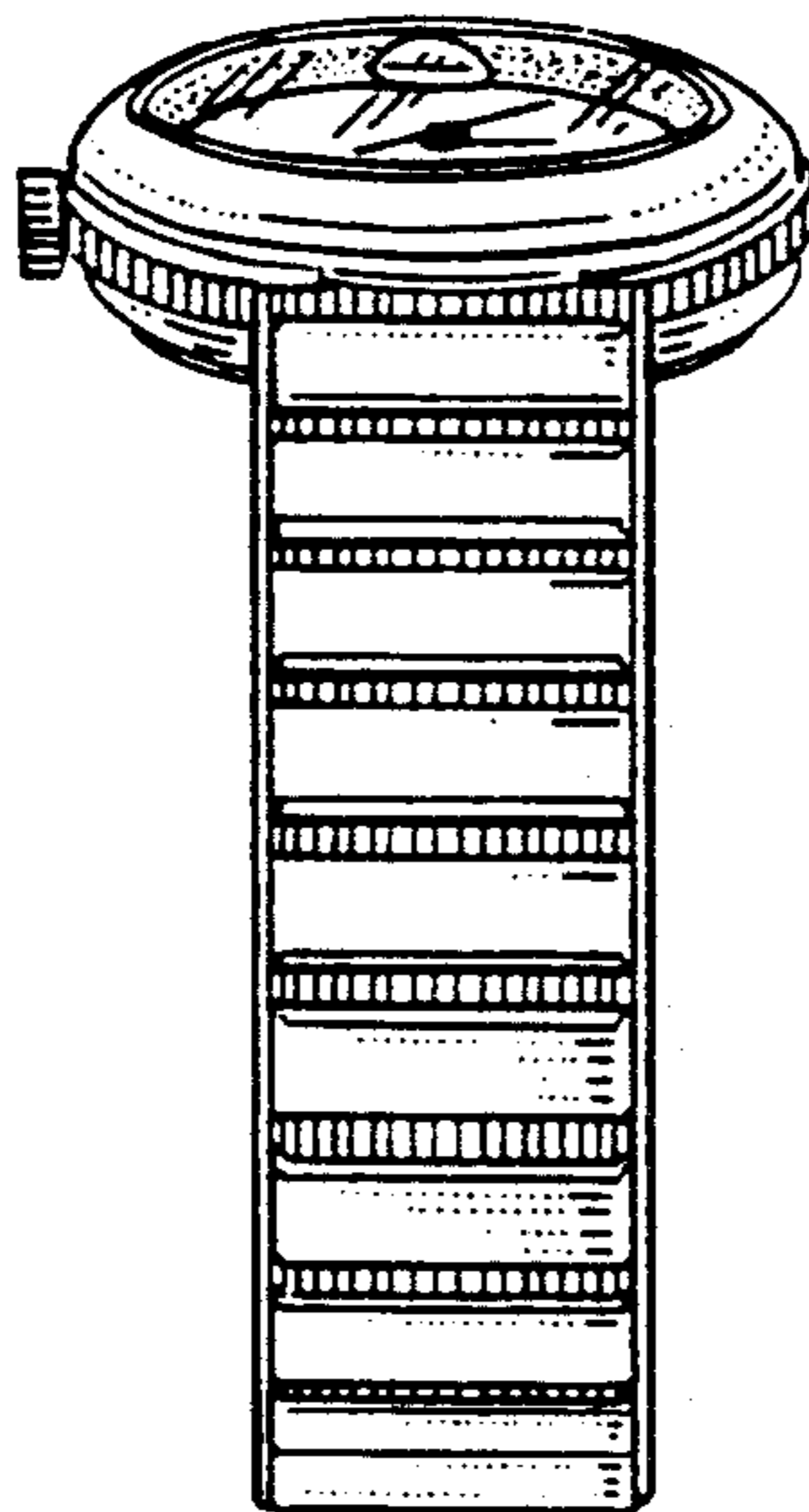
