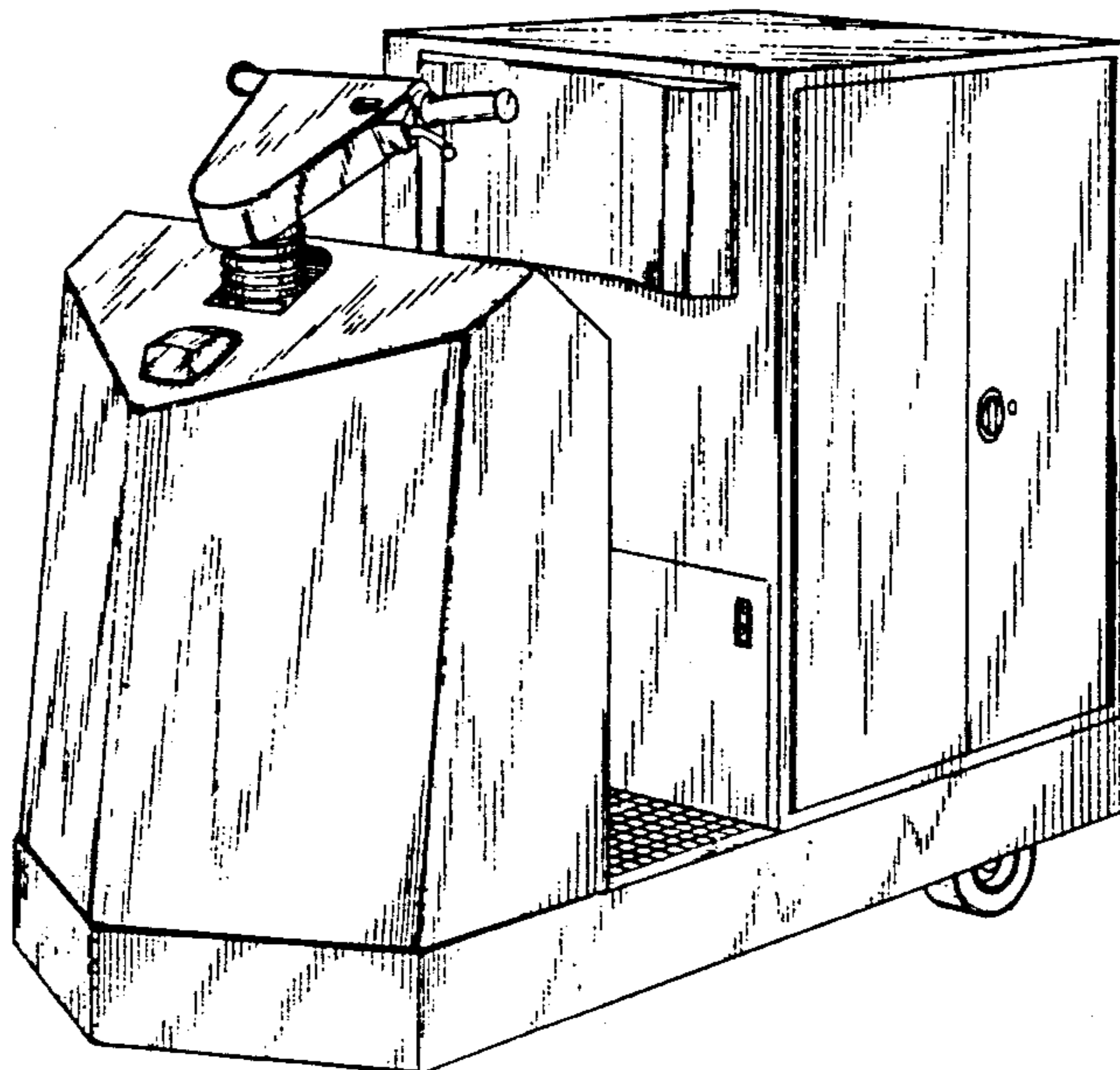

The ornamental design of a vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a vehicle showing my design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a left side elevational view thereof;  
 FIG. 4 is a front elevational view thereof; and  
 FIG. 5 is a right side elevational view thereof;  
 FIG. 6 is a perspective view of a second embodiment of a vehicle showing my design;  
 FIG. 7 is a perspective view of a third embodiment of a vehicle showing my design;  
 FIG. 8 is a perspective view of a fourth embodiment of a vehicle showing my design;  
 FIG. 9 is a top plan view of the fourth embodiment;  
 FIG. 10 is a left side elevational view of the fourth embodiment;  
 FIG. 11 is a perspective view of a fifth embodiment of a vehicle showing my design;  
 FIG. 12 is a top plan view of the fifth embodiment; and  
 FIG. 13 is a left side elevational view of the fifth embodiment, the right side being substantially a mirror image thereof.  
 The right side of the second, third and fourth embodiments of the vehicle are substantially identical to the right side of the first embodiment thereof show in FIG. 5, and the rear surface of all five embodiments of the vehicle is flat and unornamented.



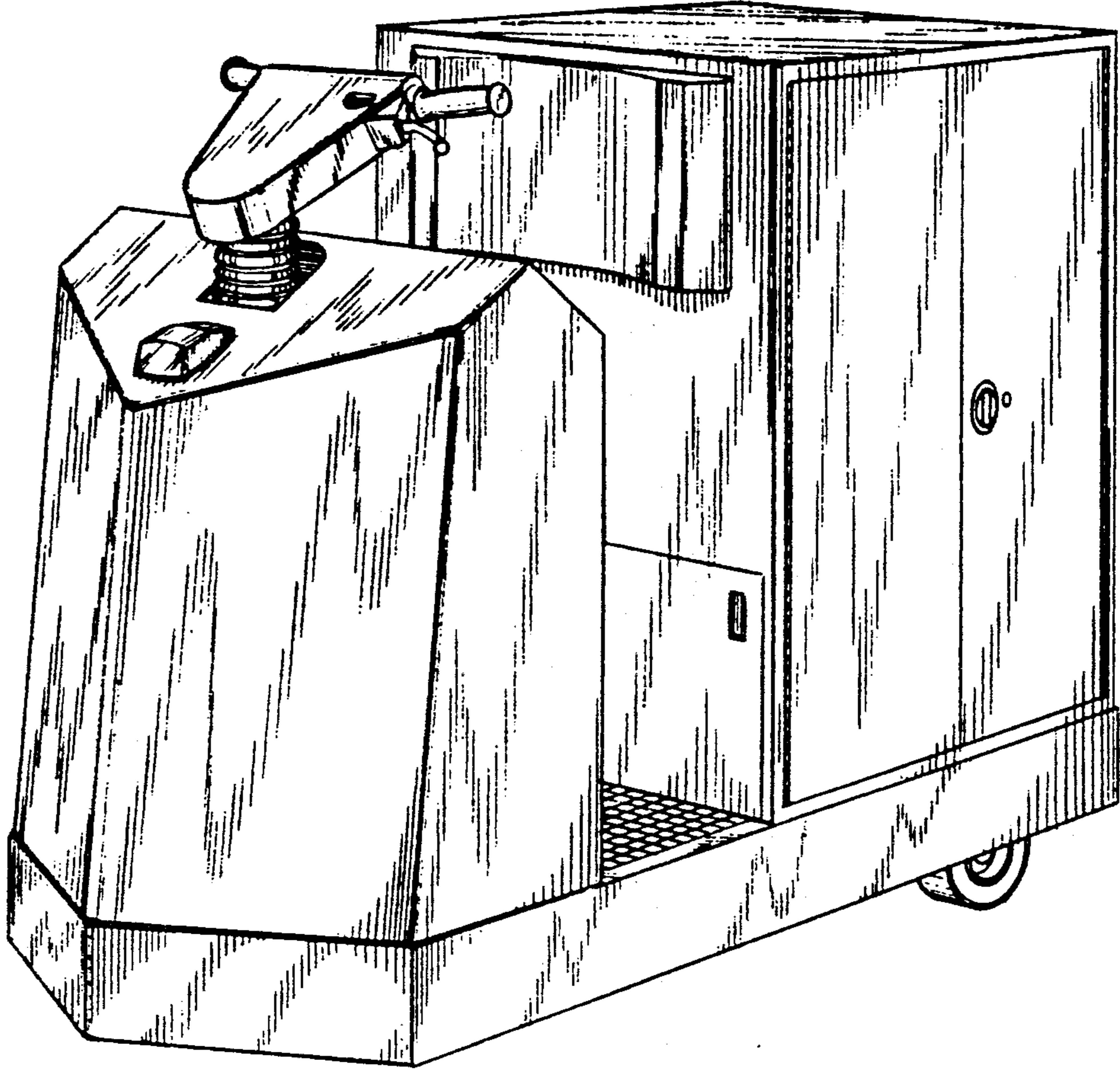

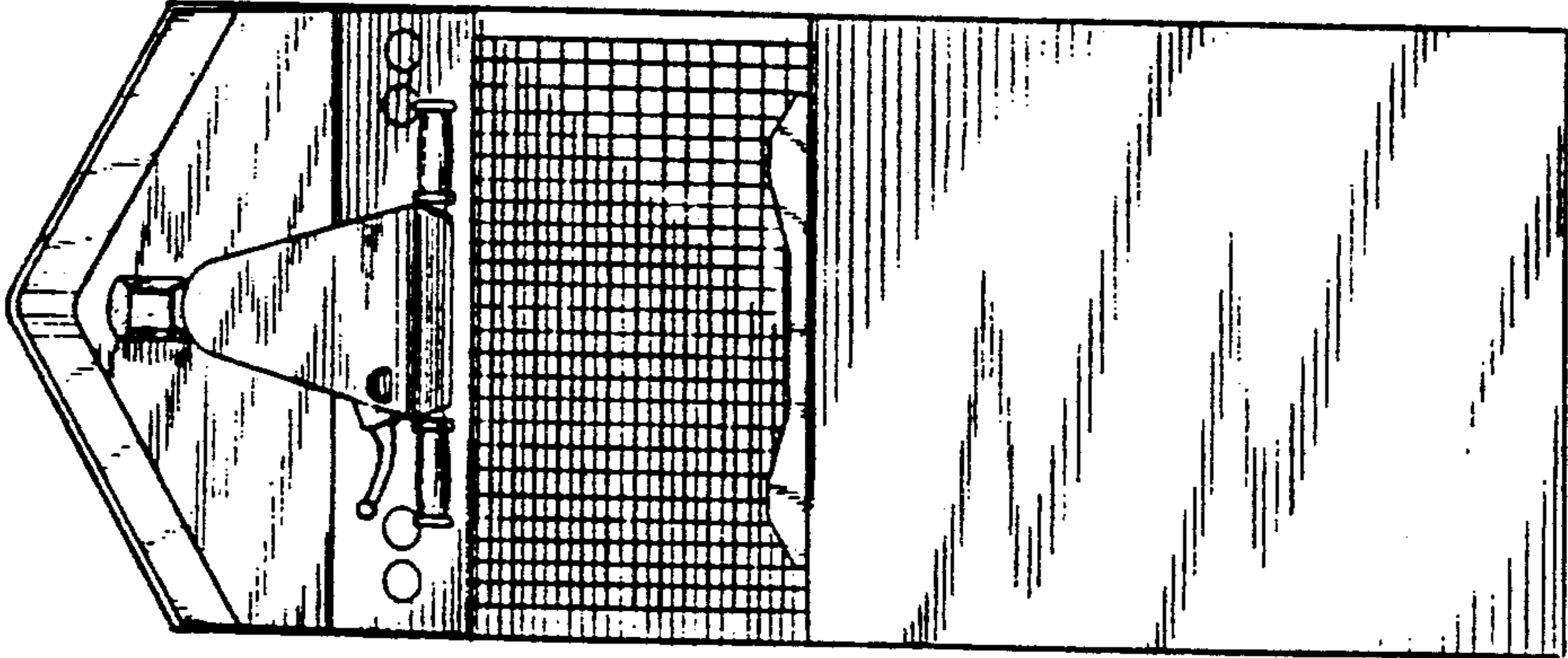

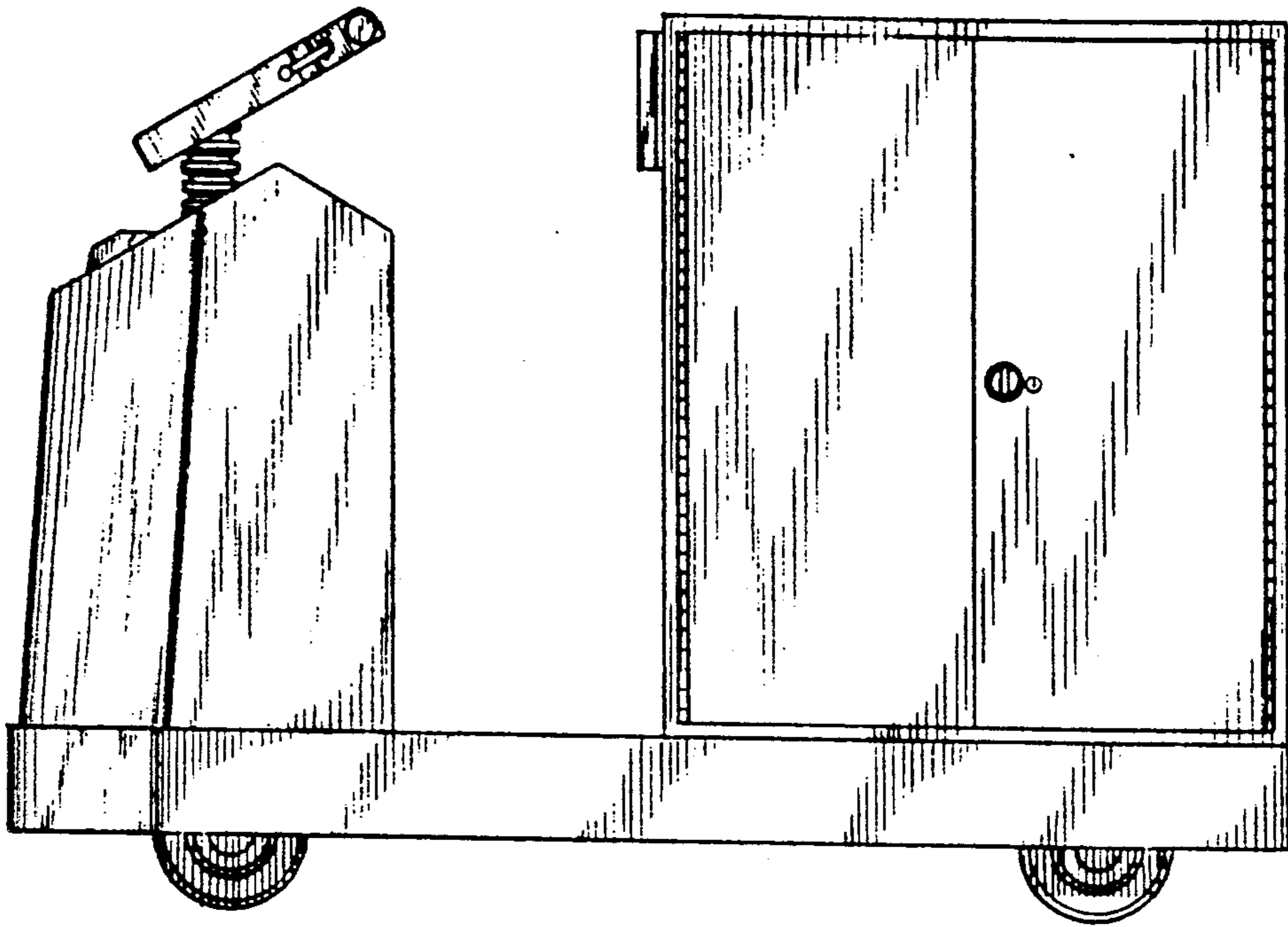

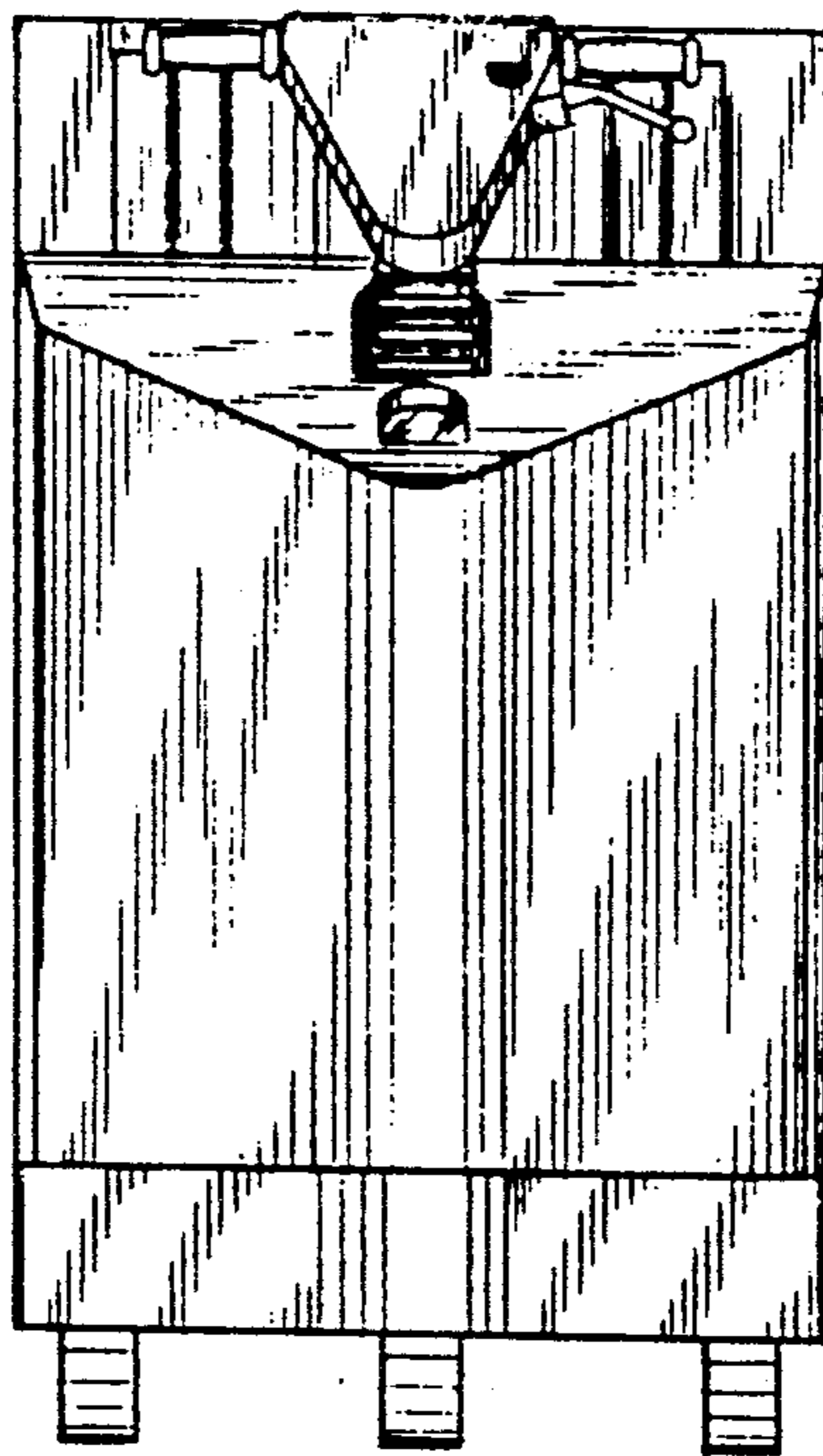

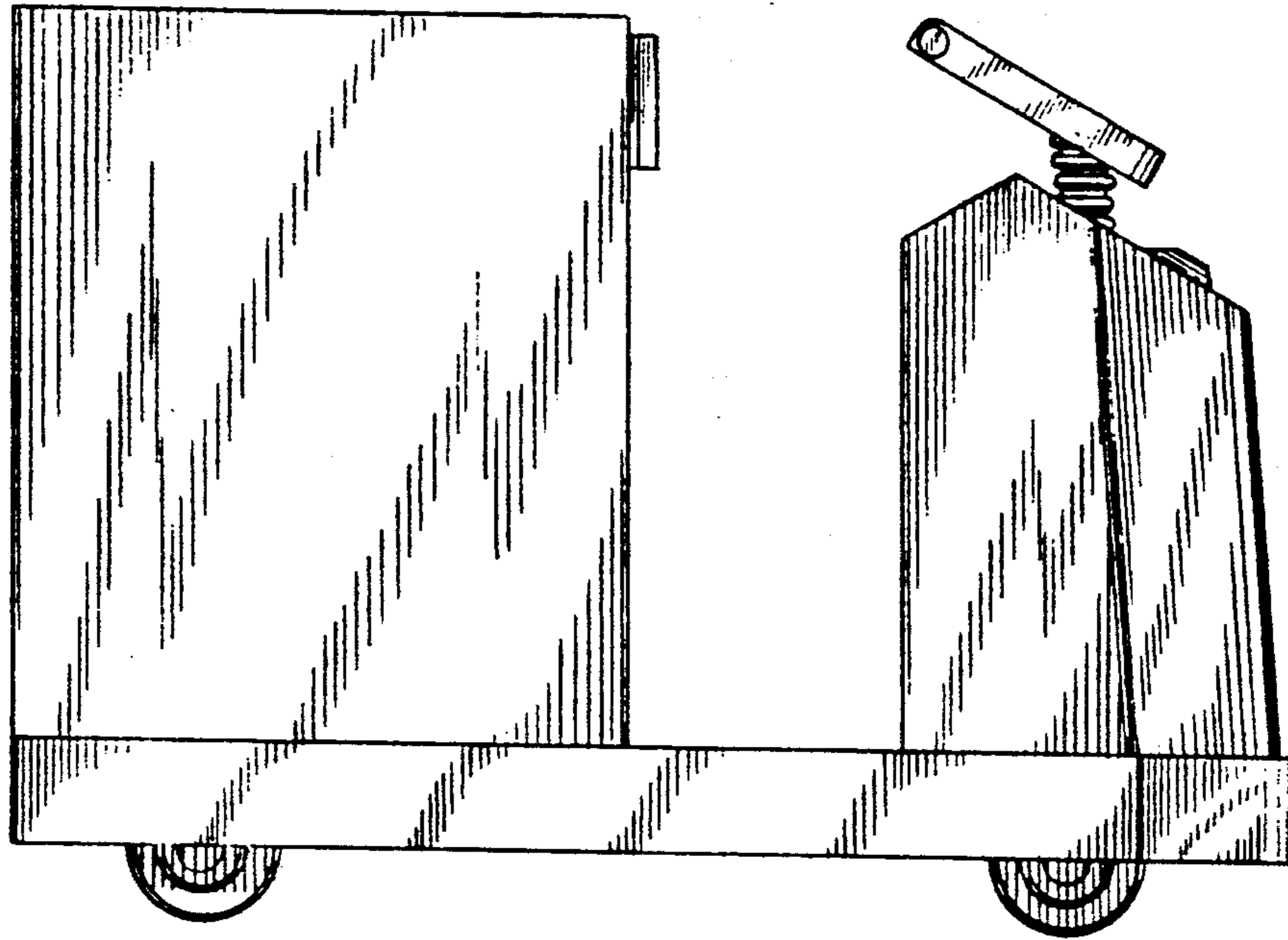

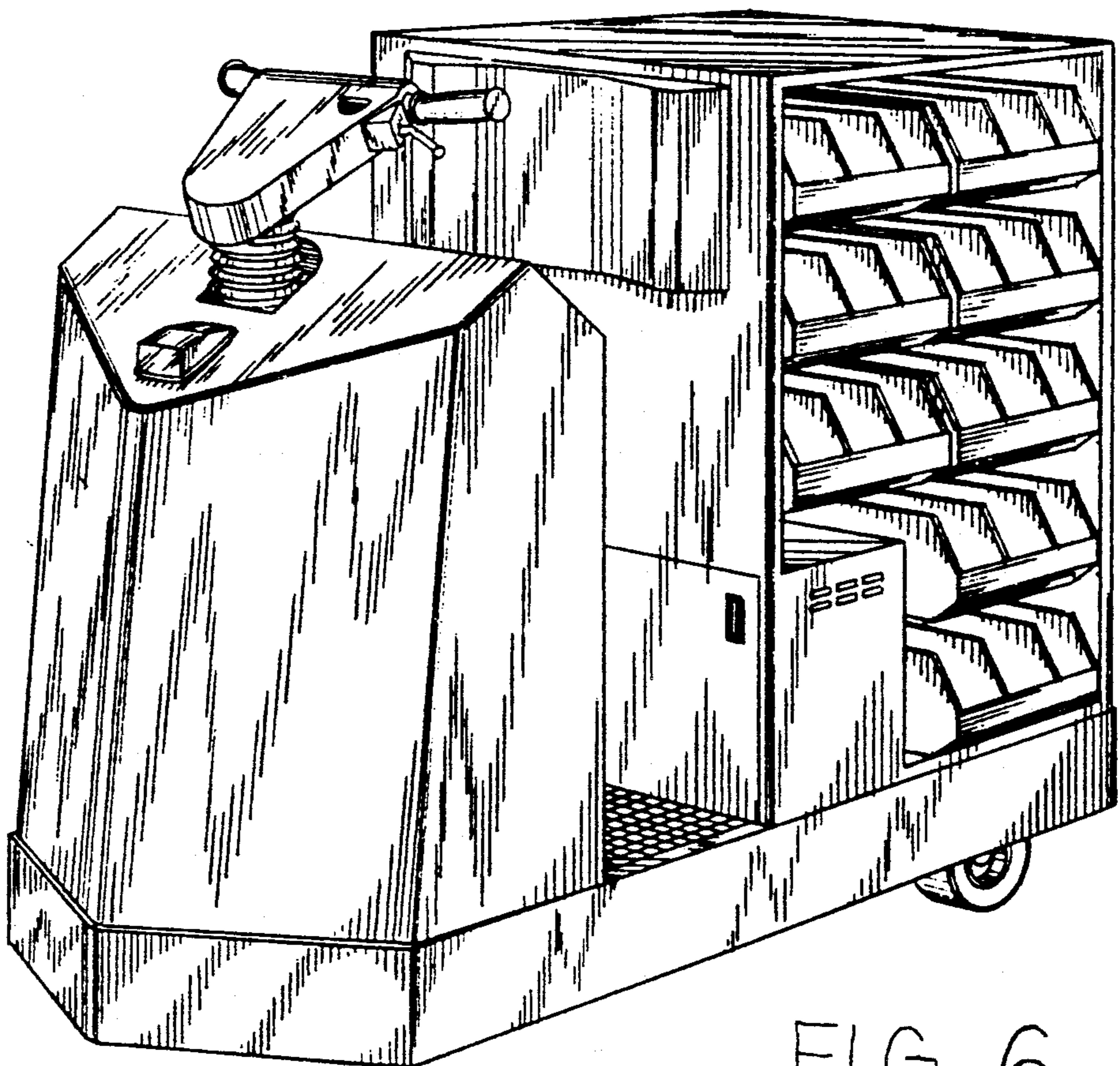

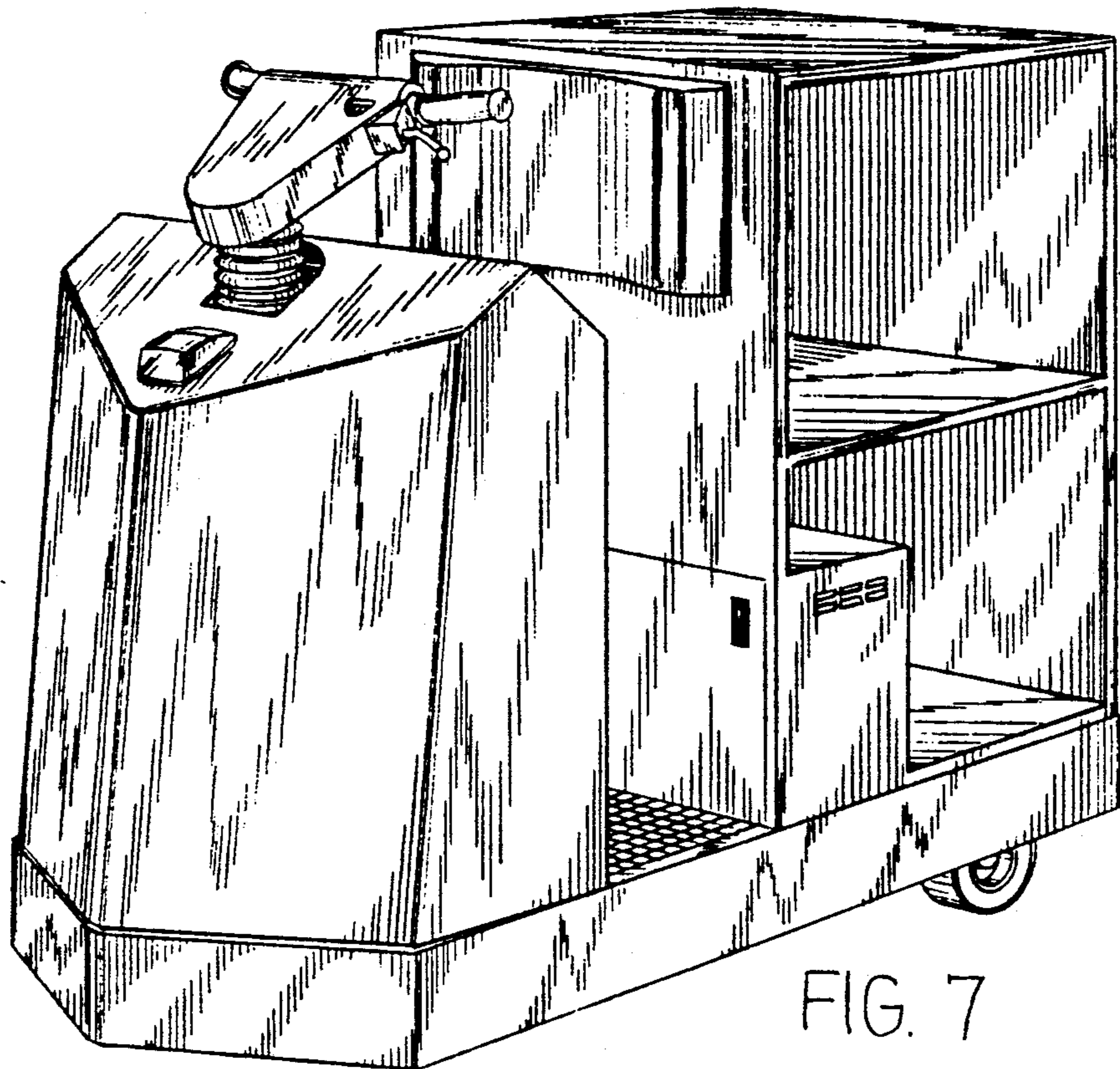

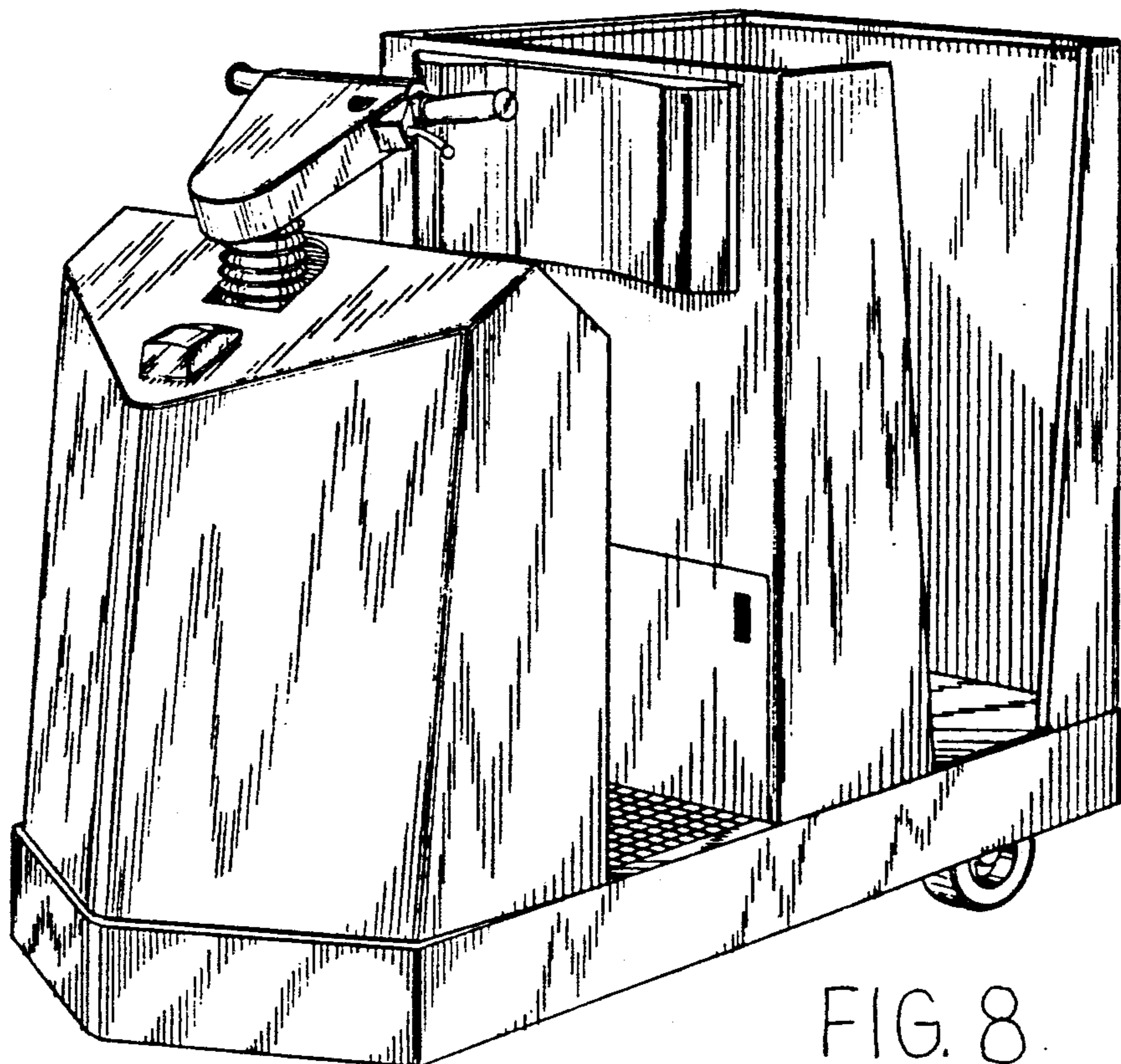

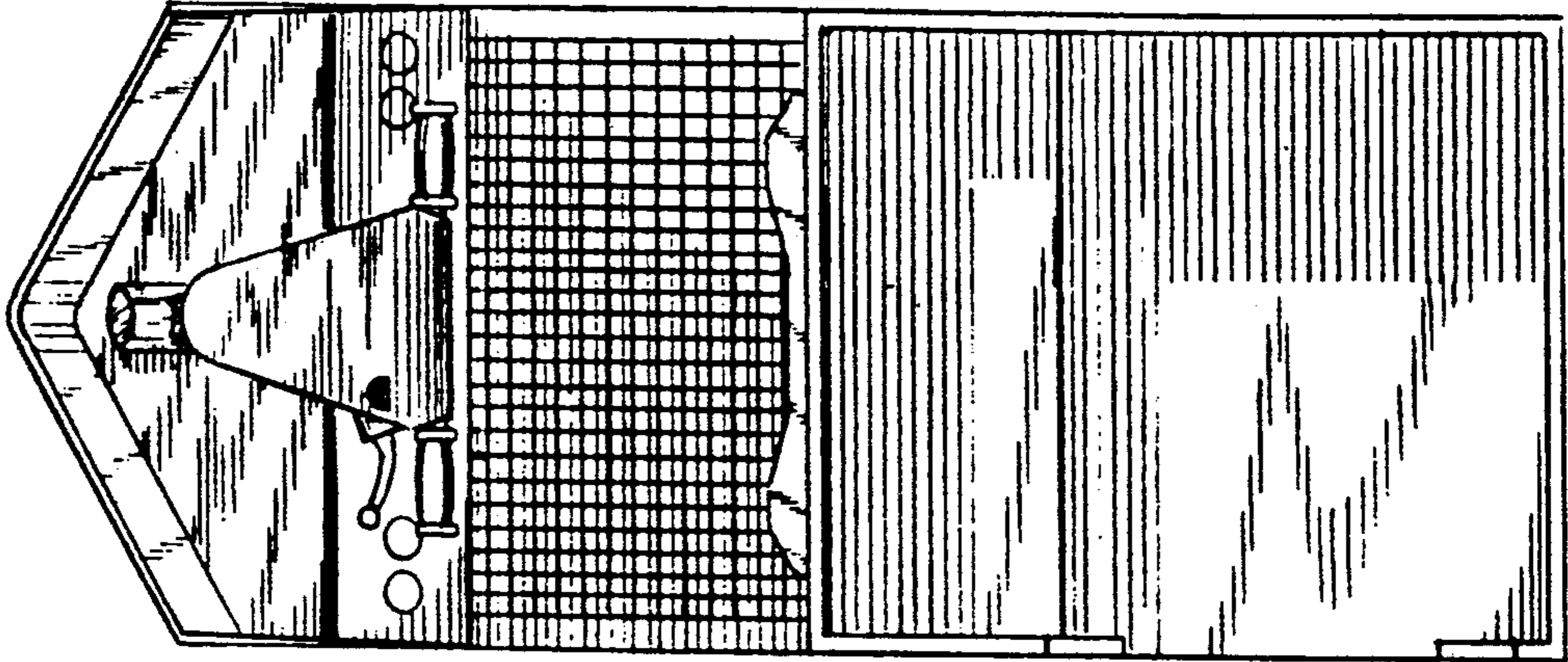

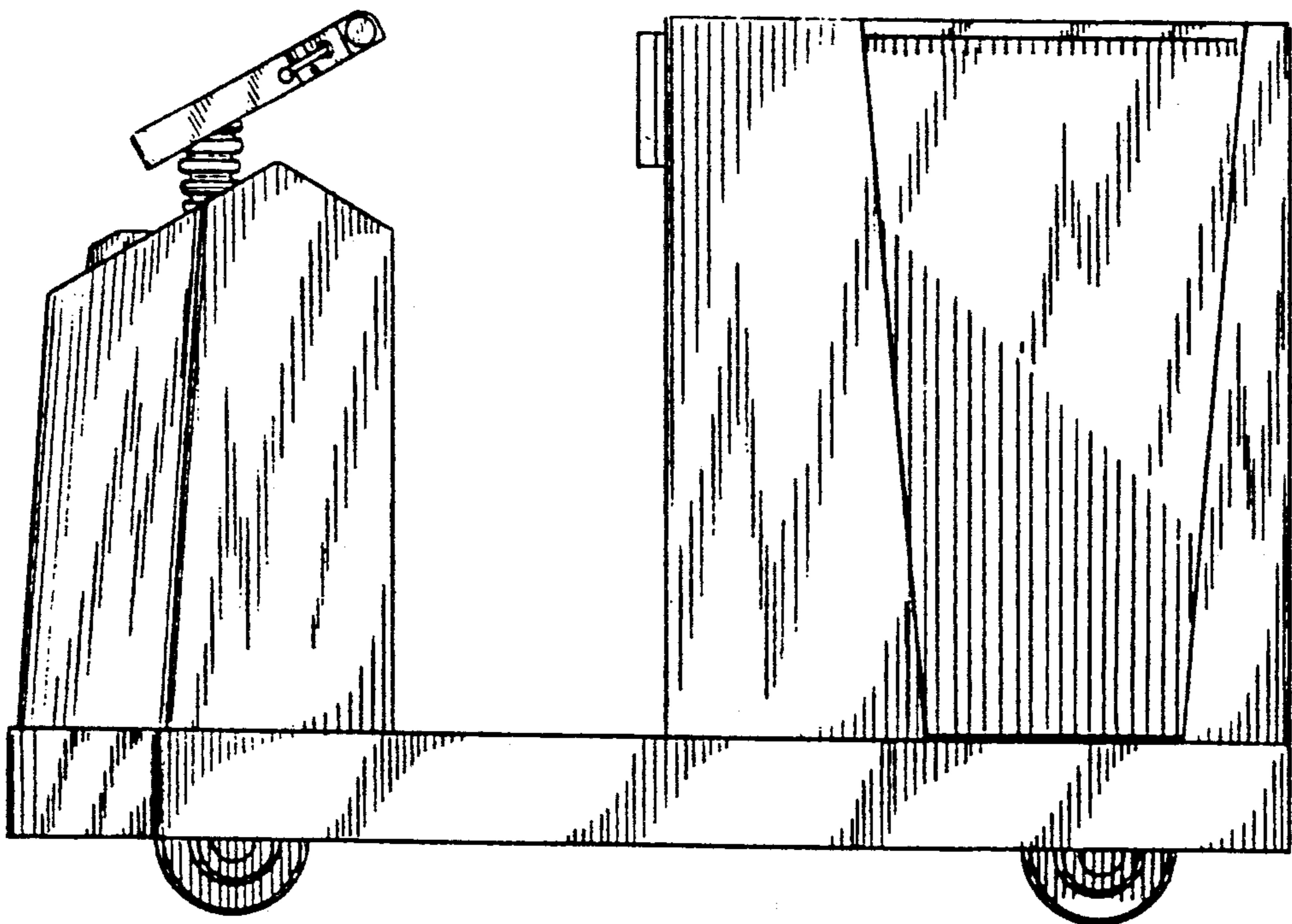

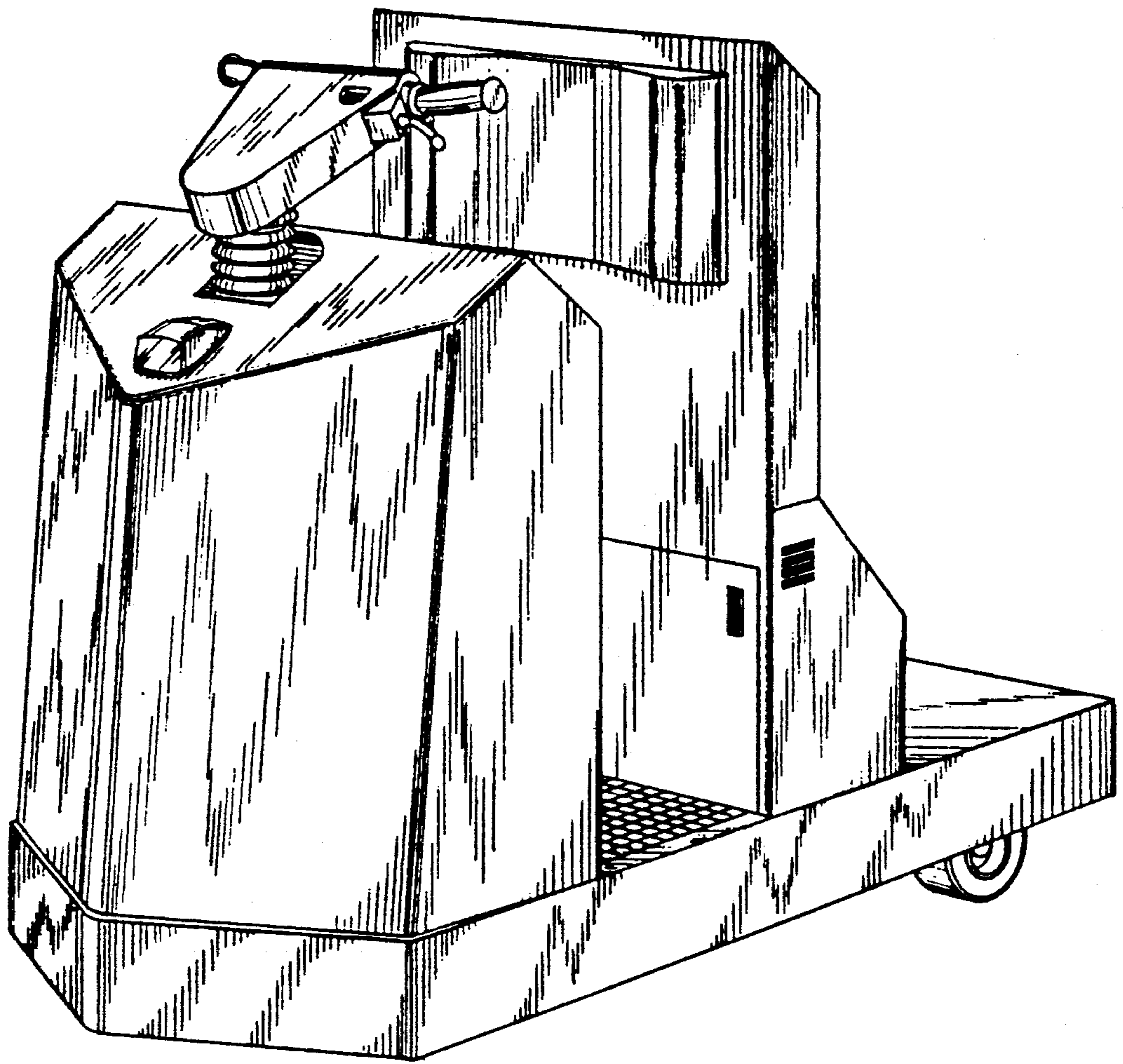

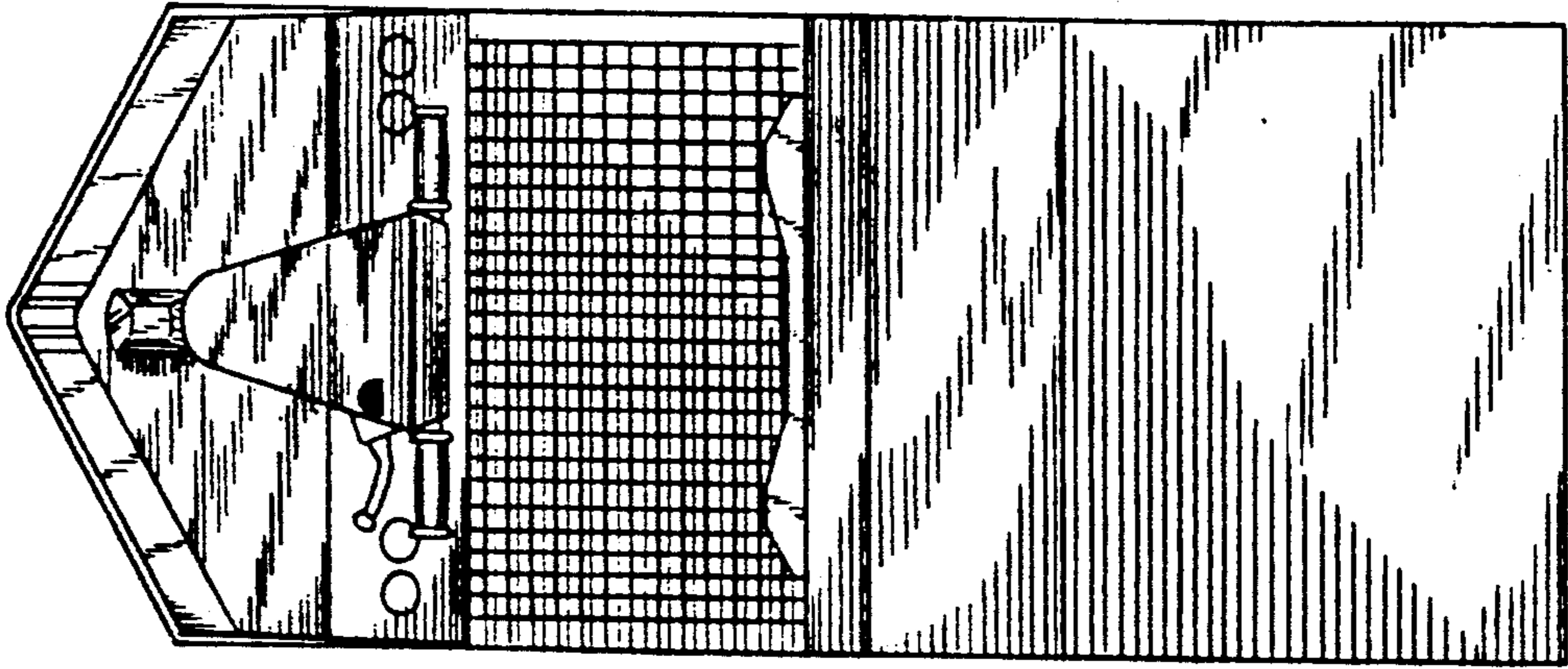

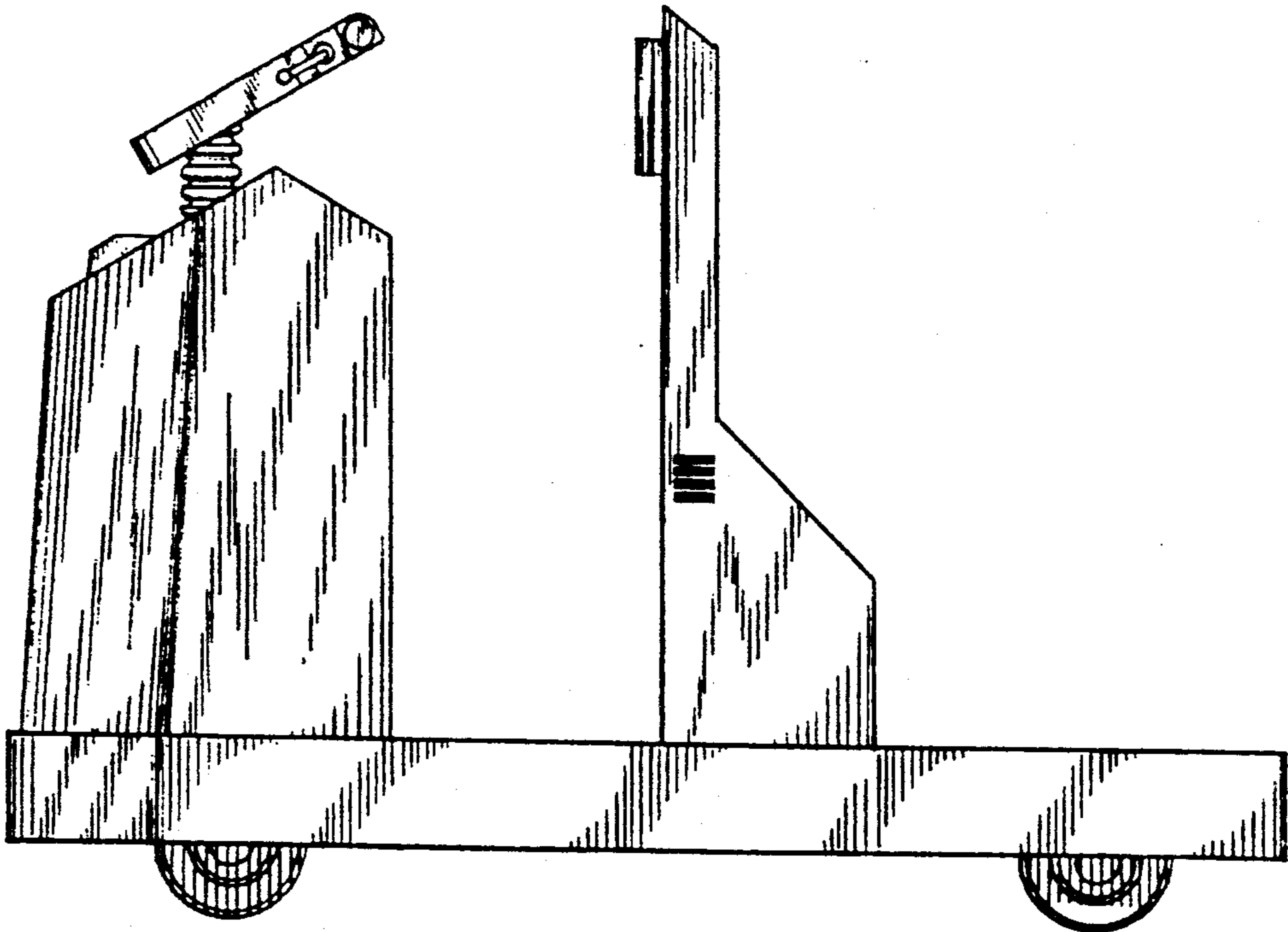
