FIG. 9 is a right side elevation view of a FIG. 8;

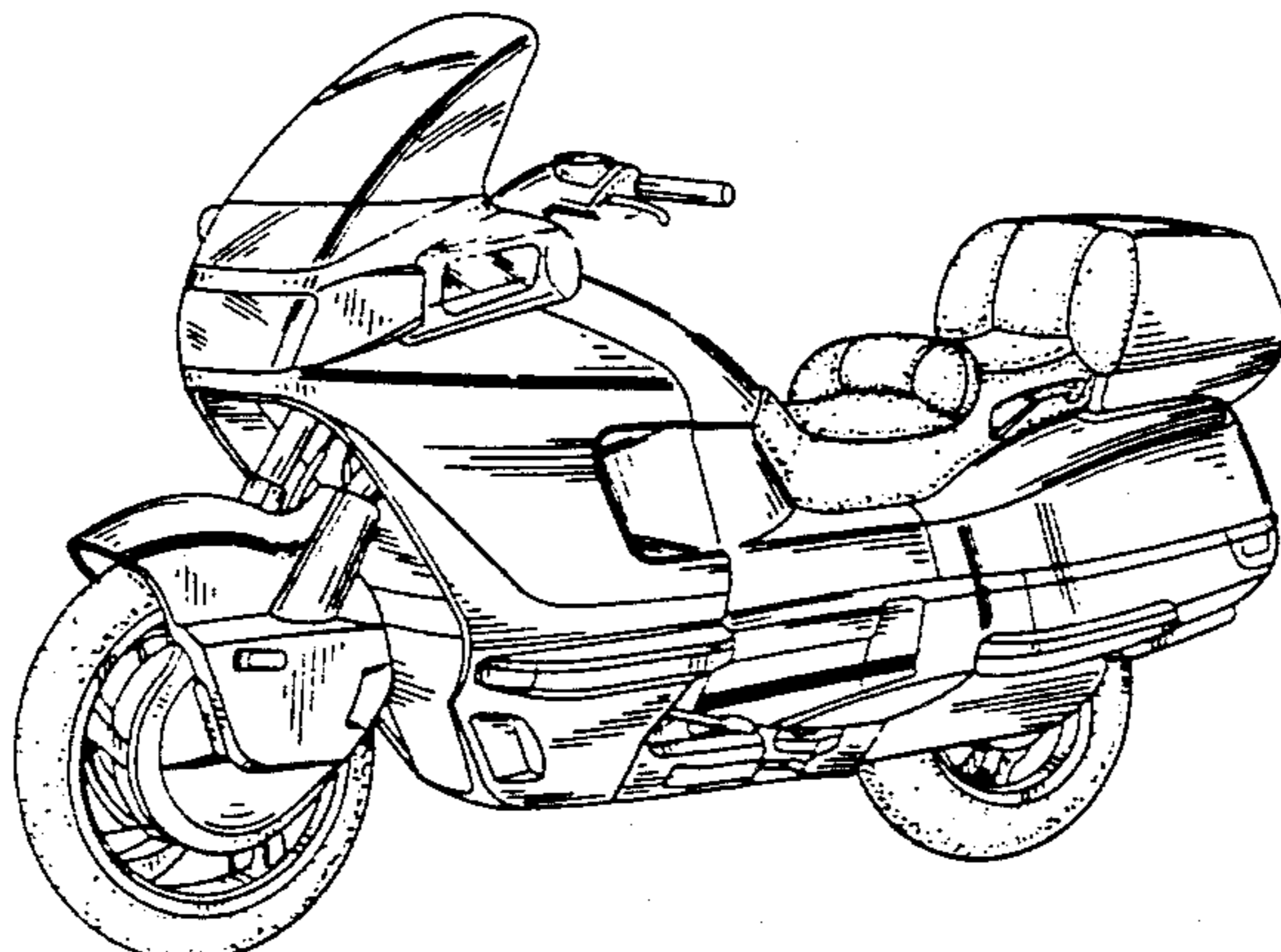
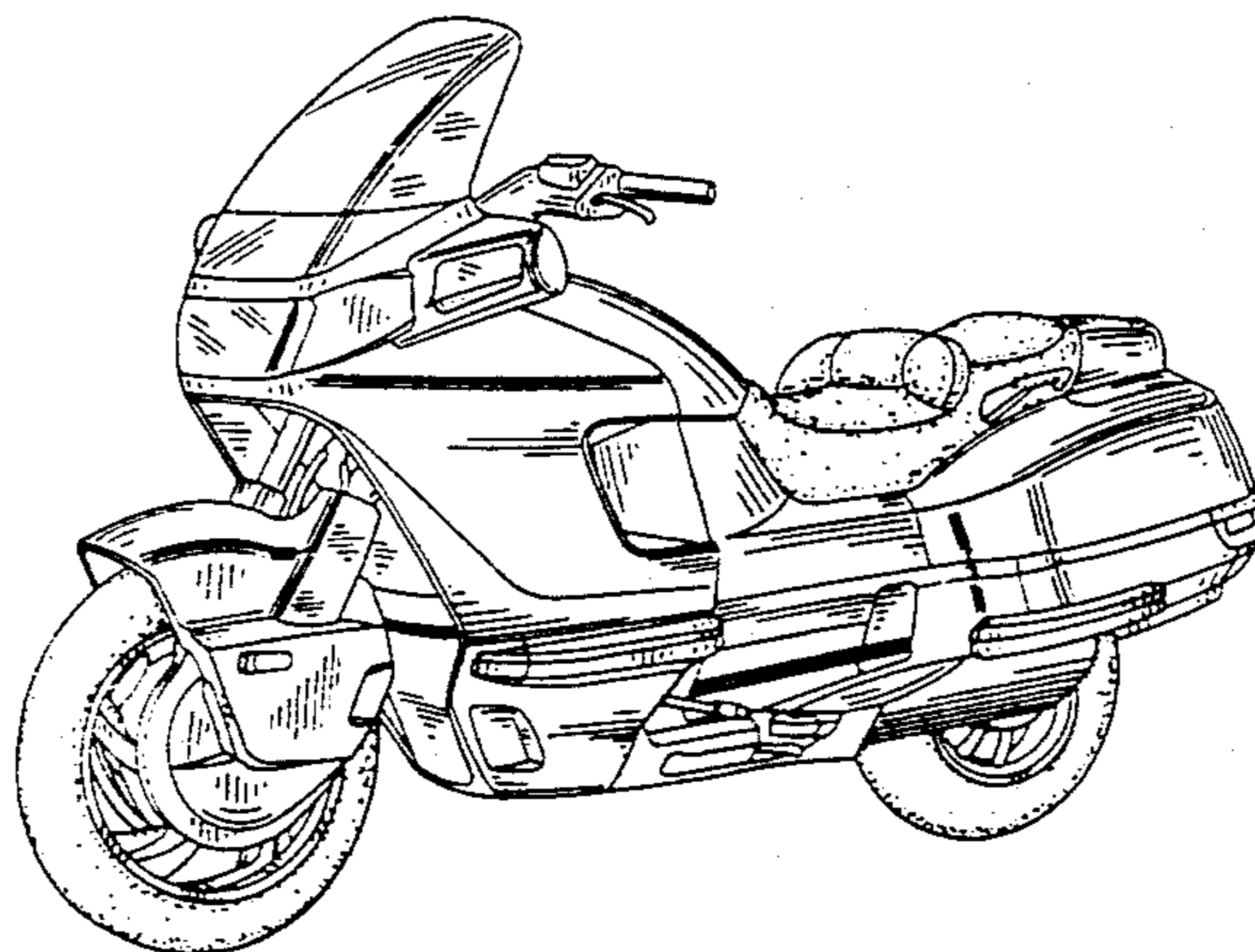
FIG. 10 is a front elevation view of FIG. 8;

FIG. 14 is a left side perspective view of FIG. 8.



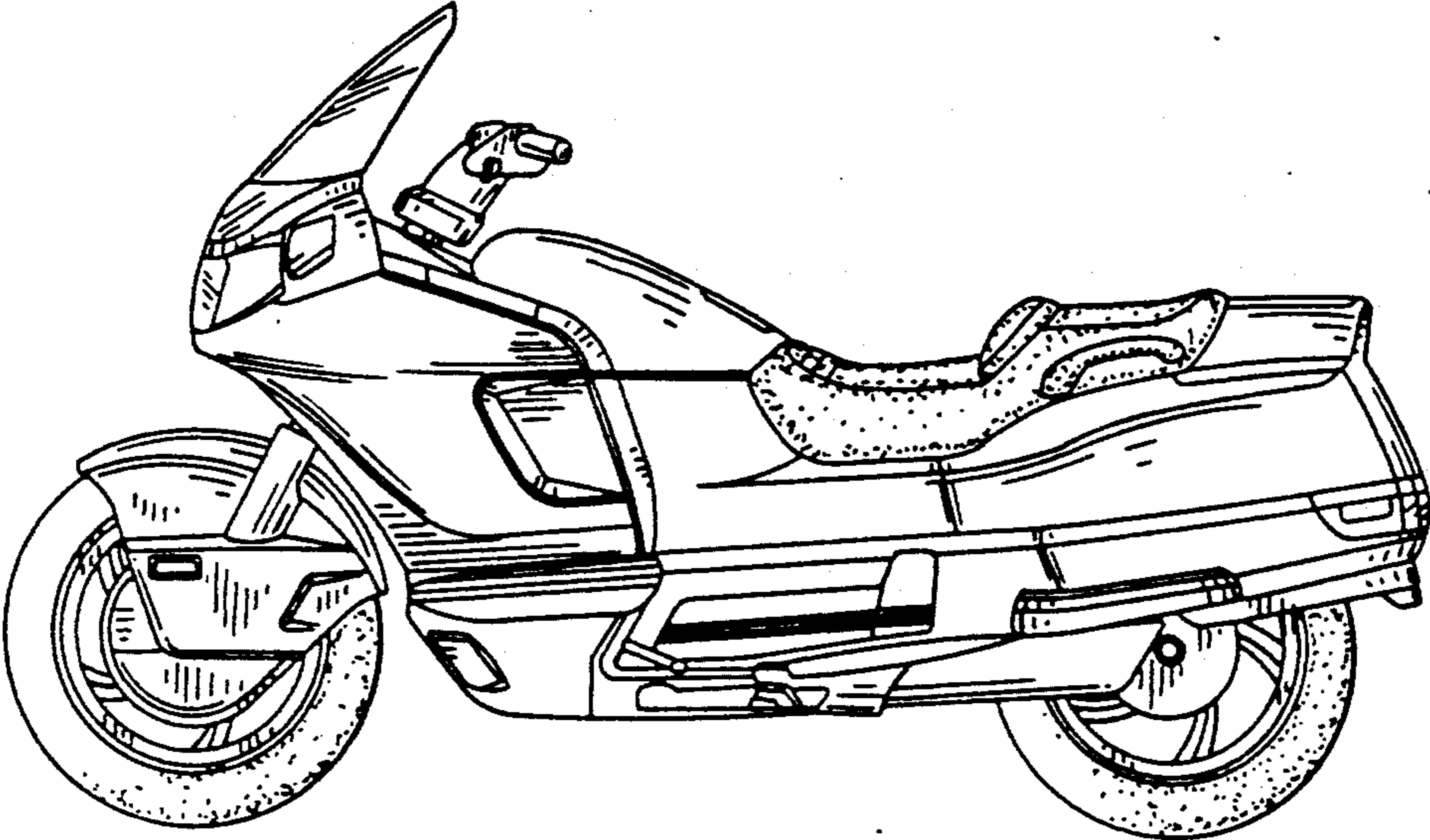

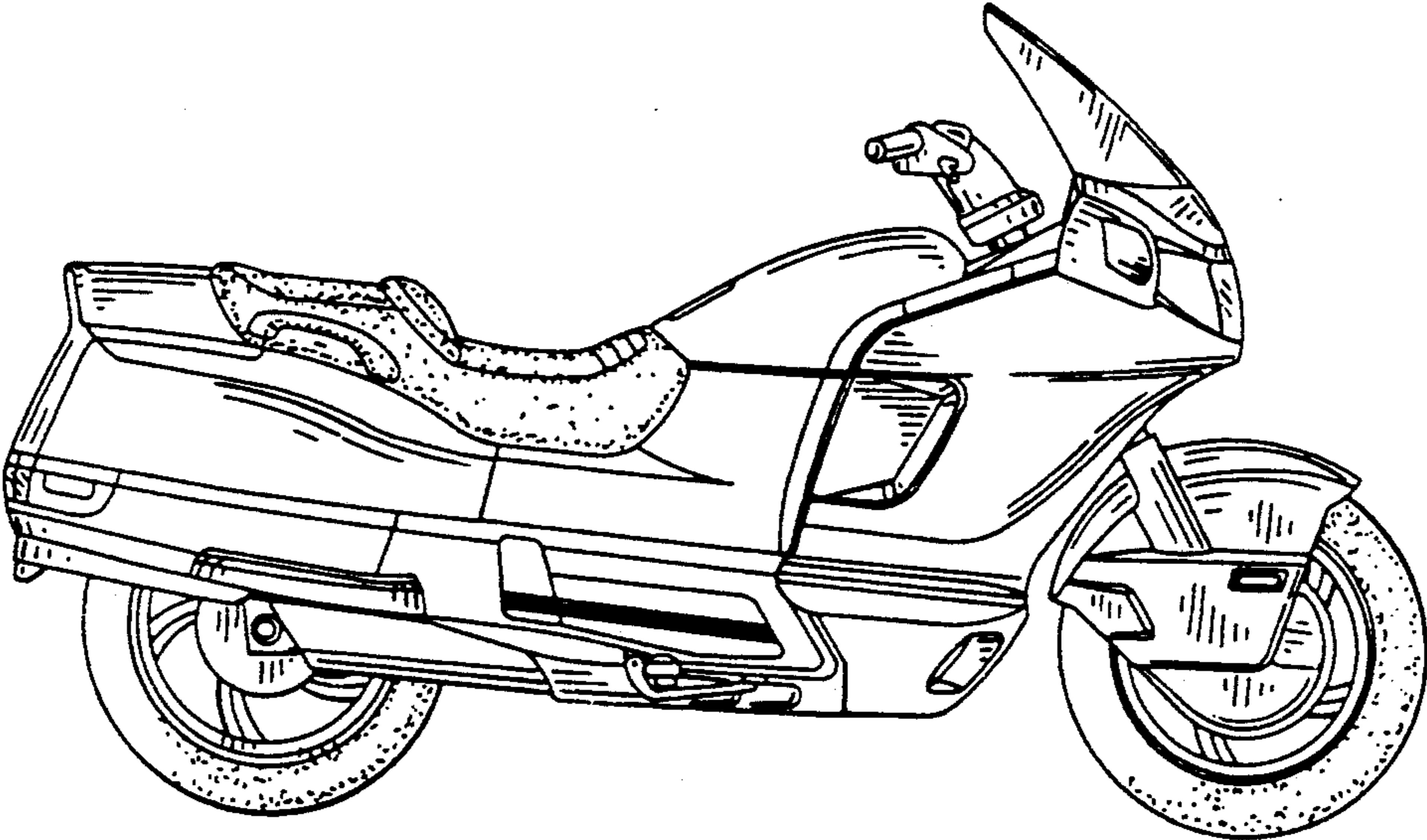

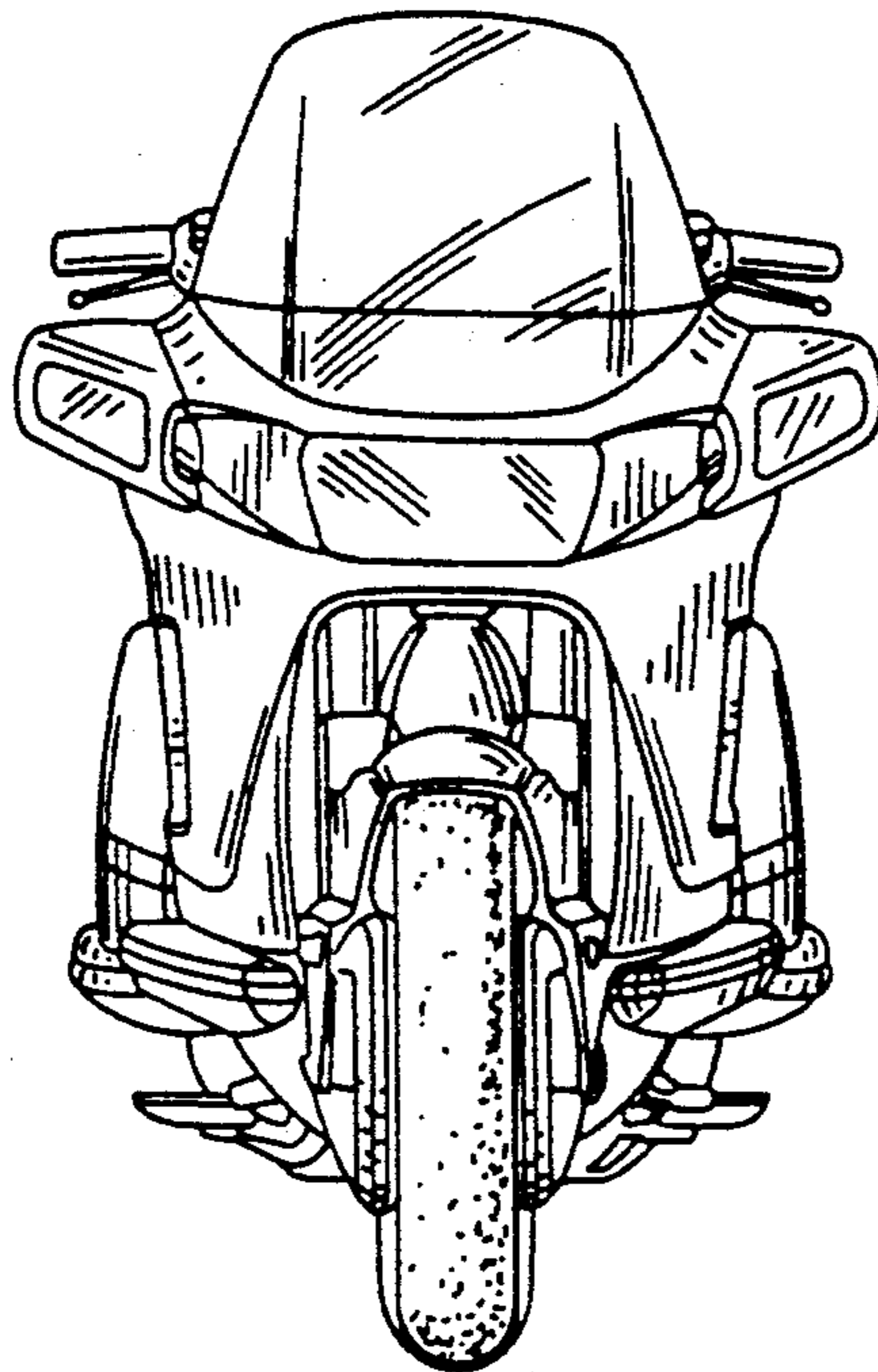

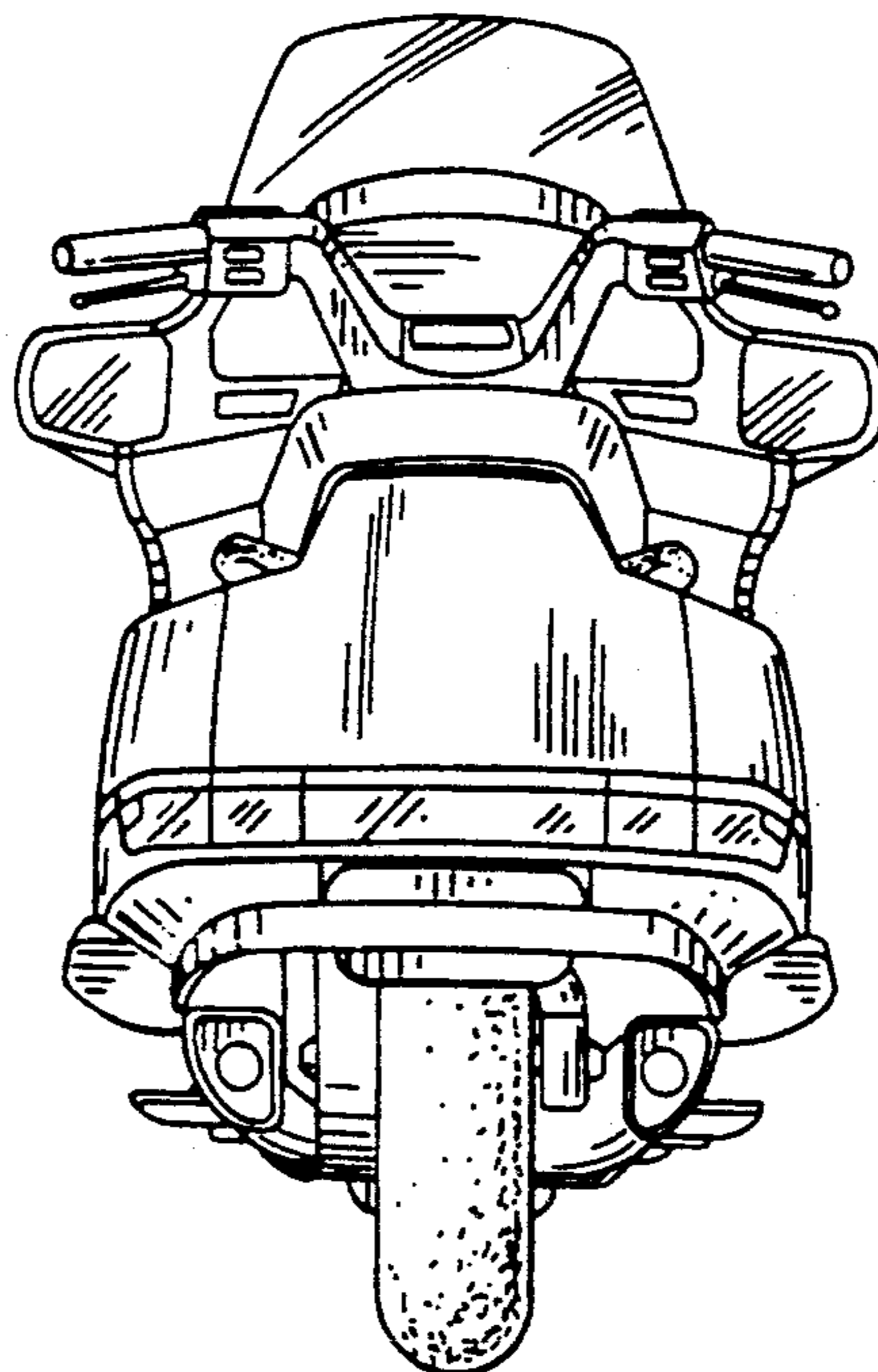

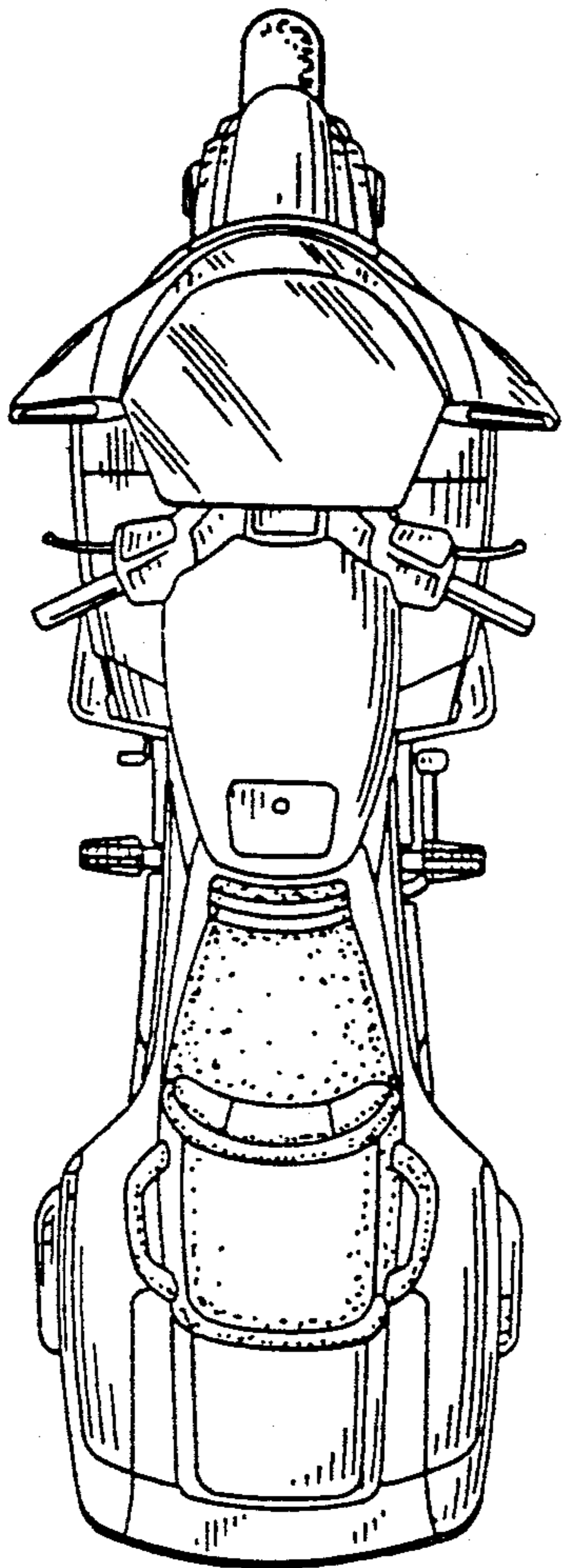

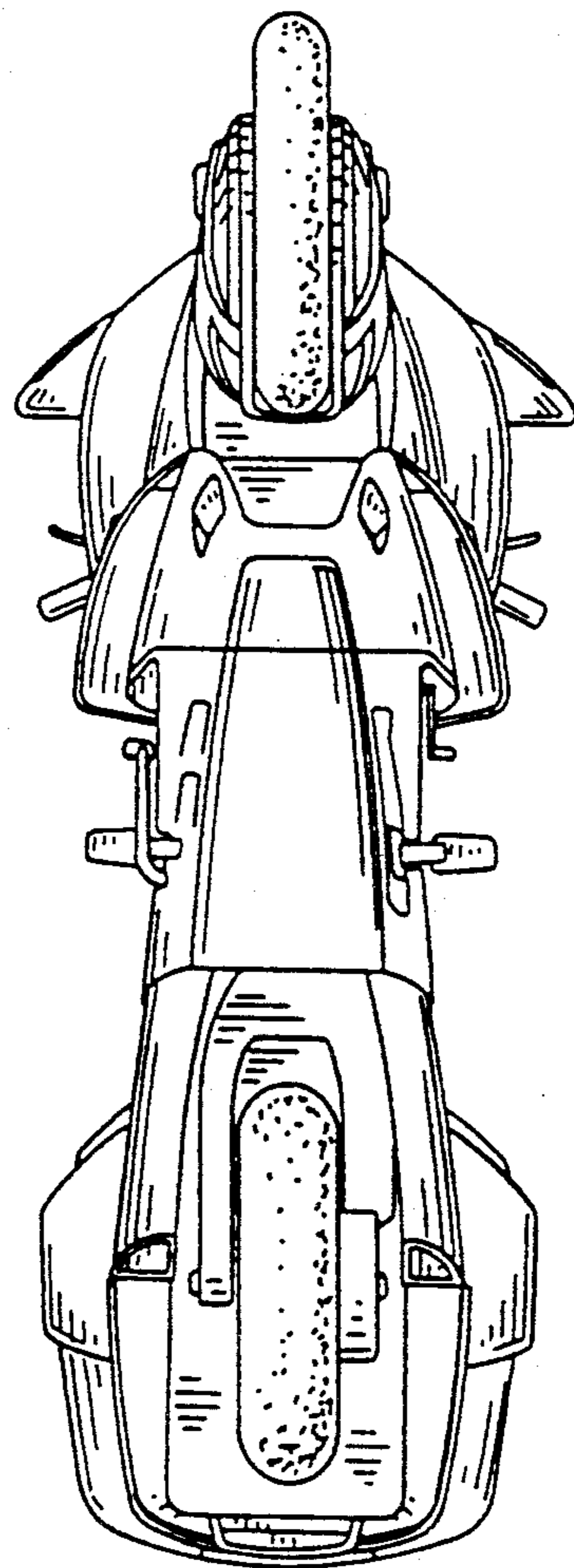

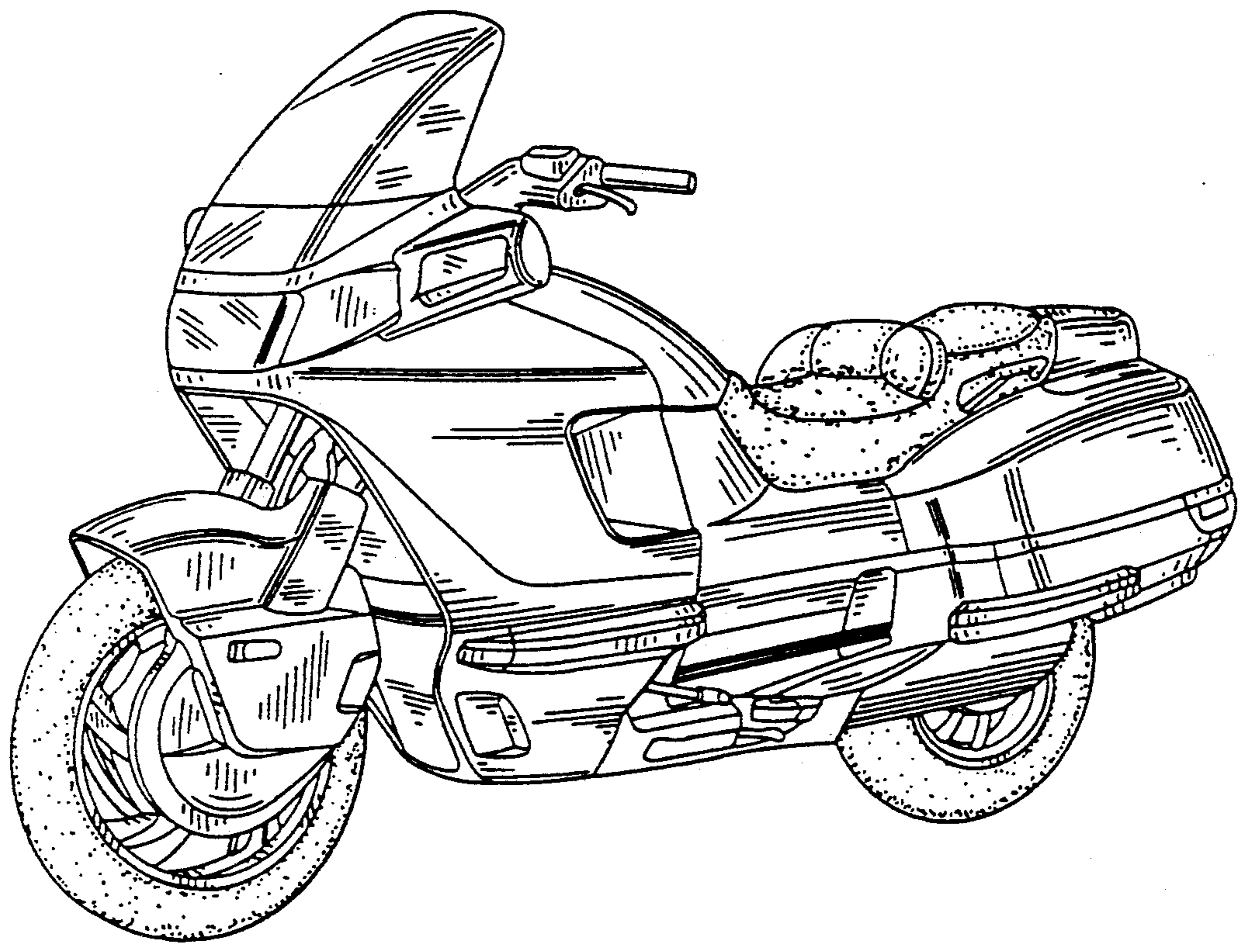

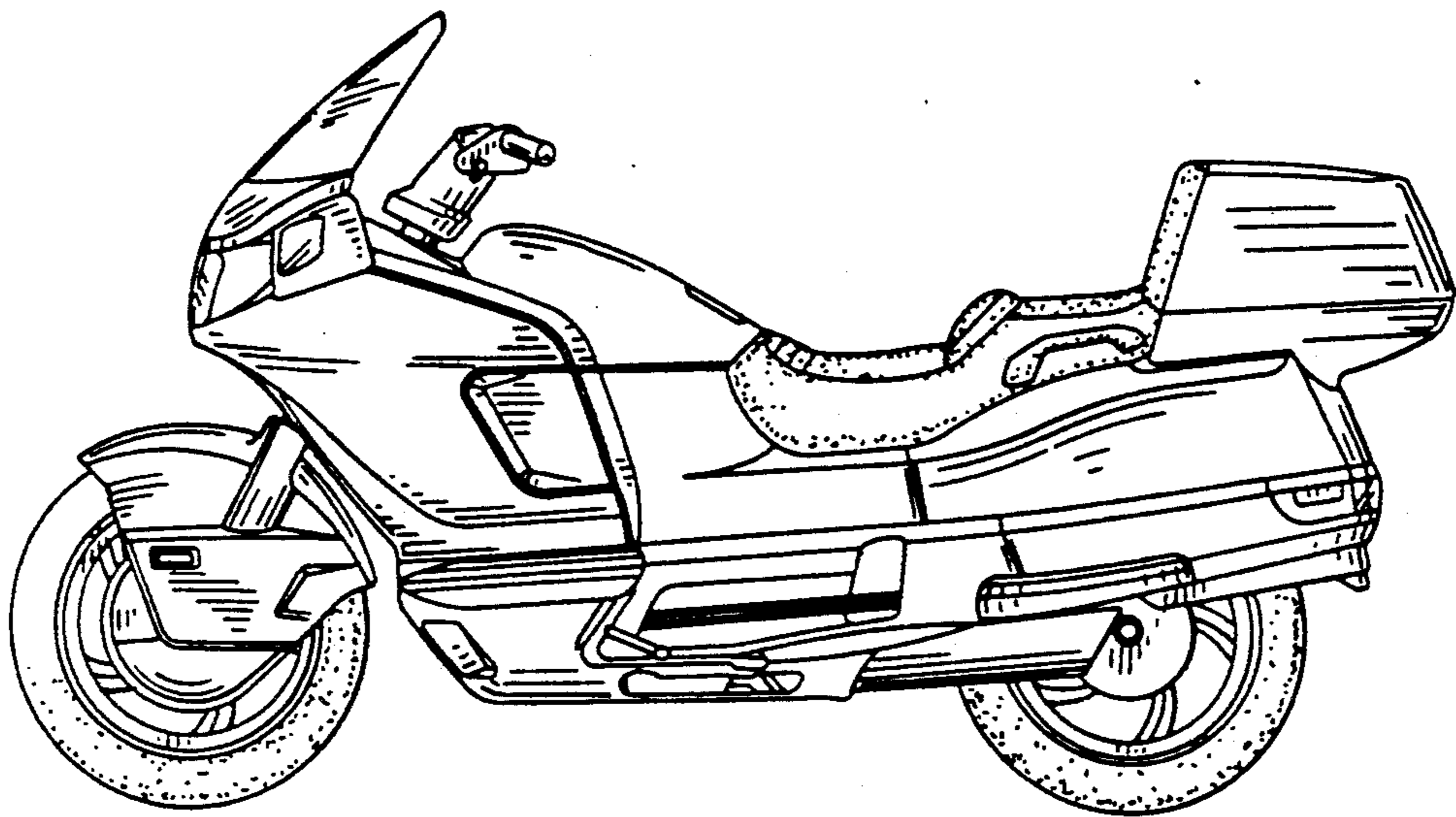

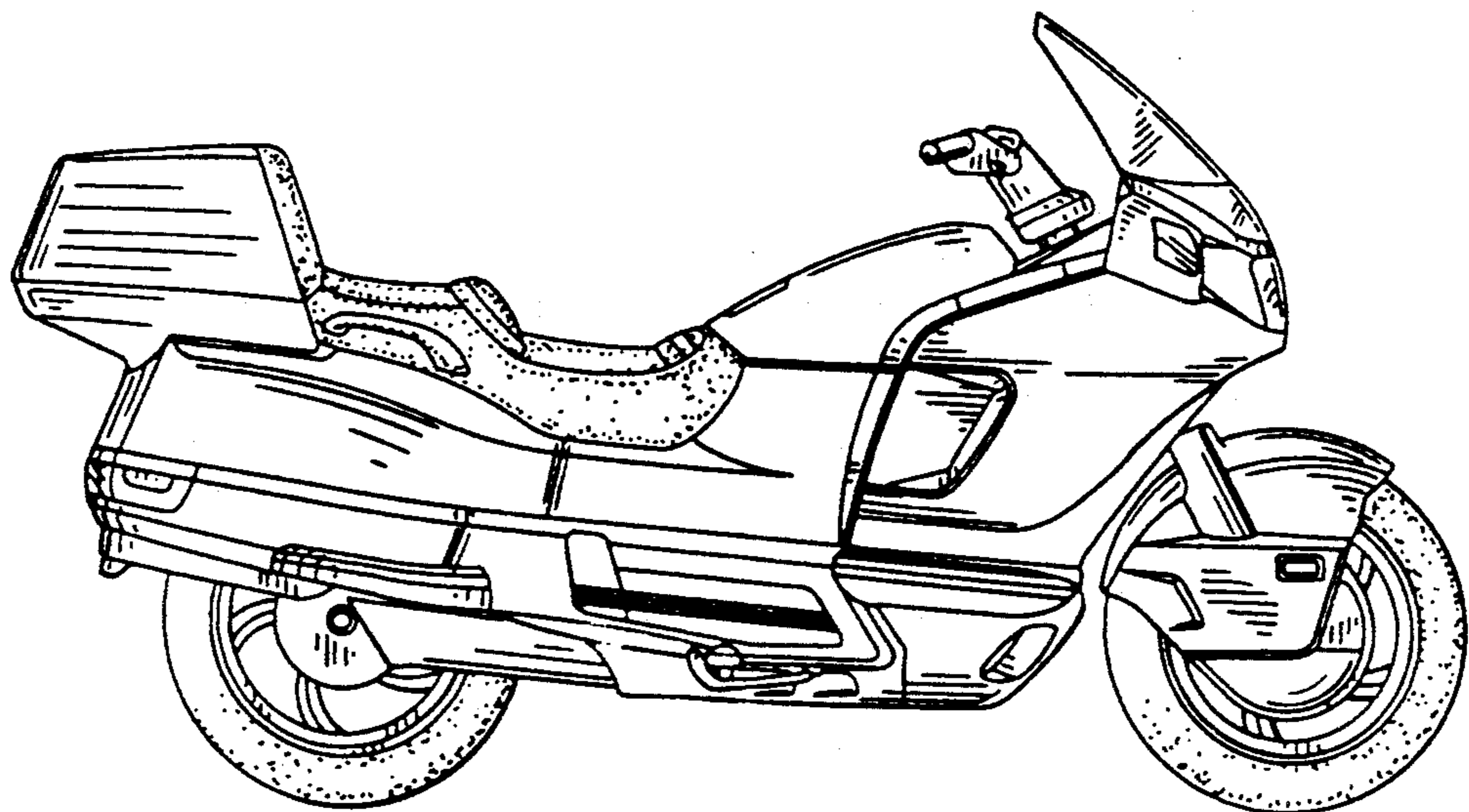

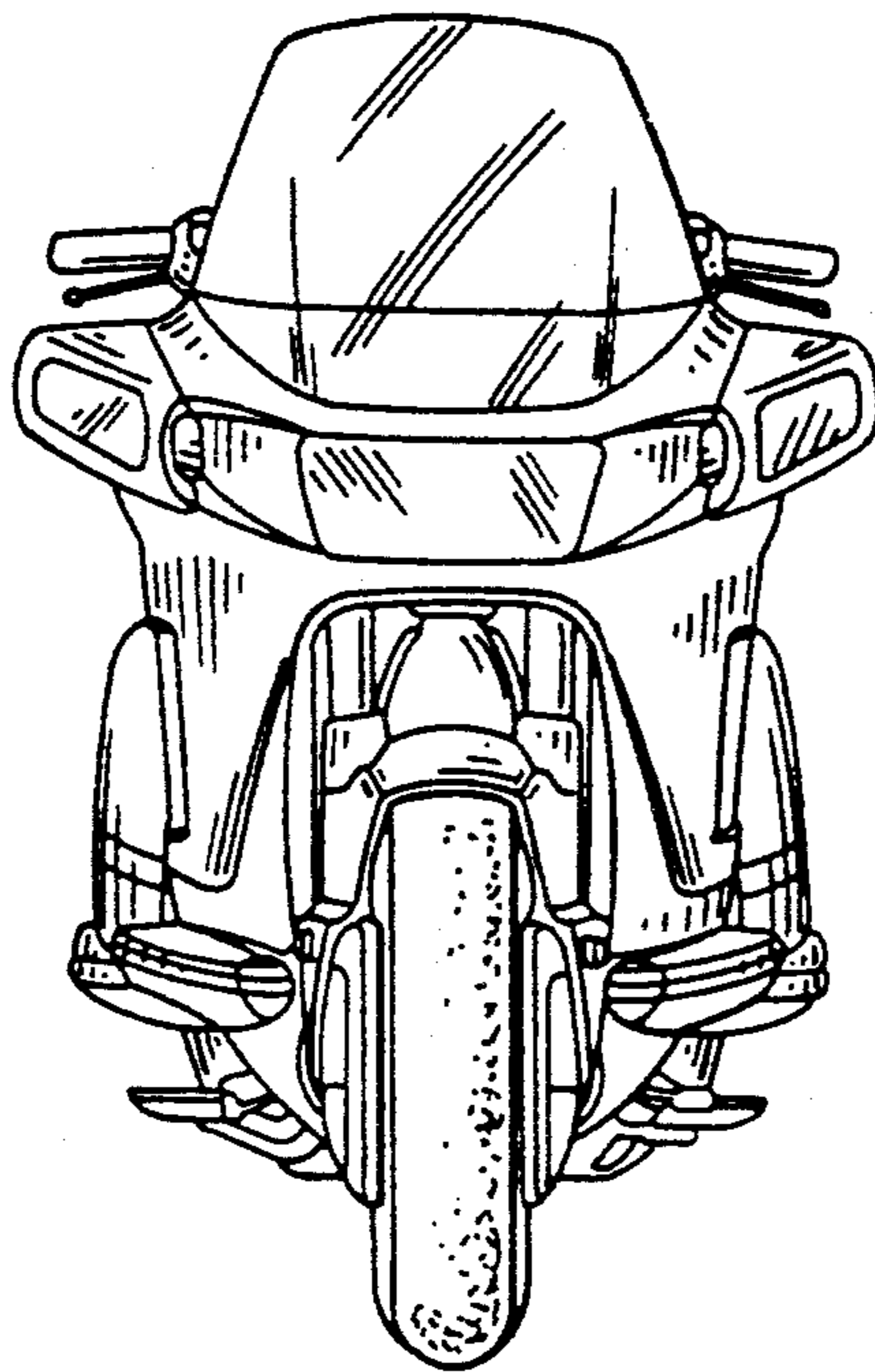

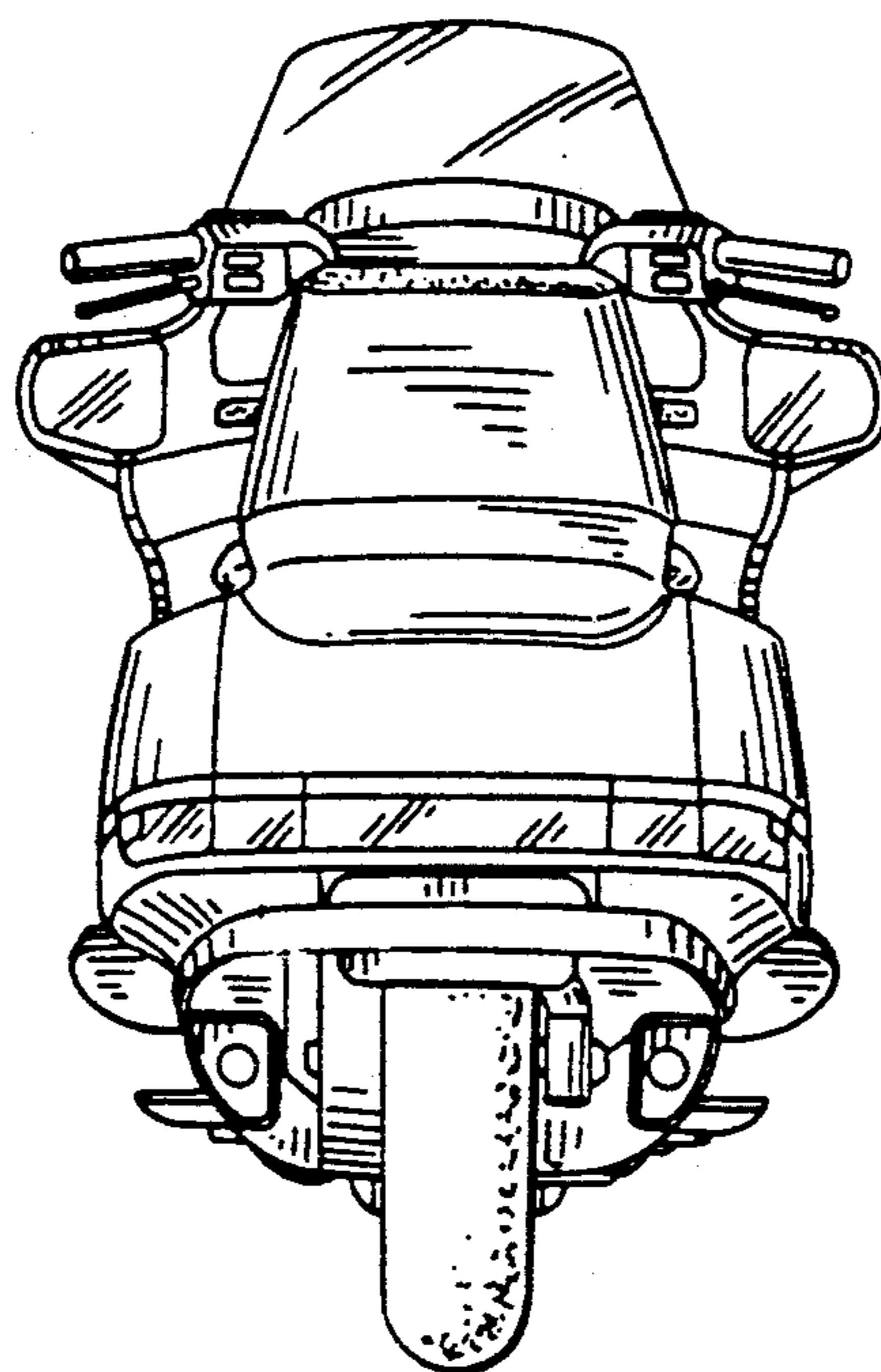

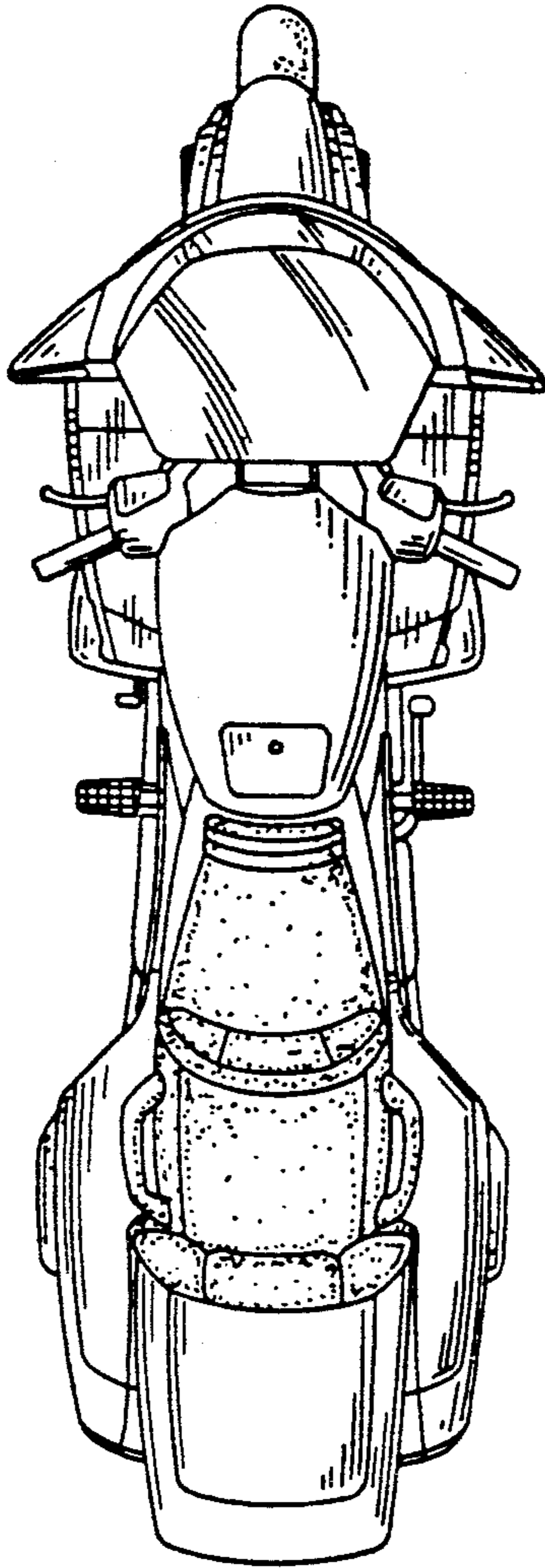

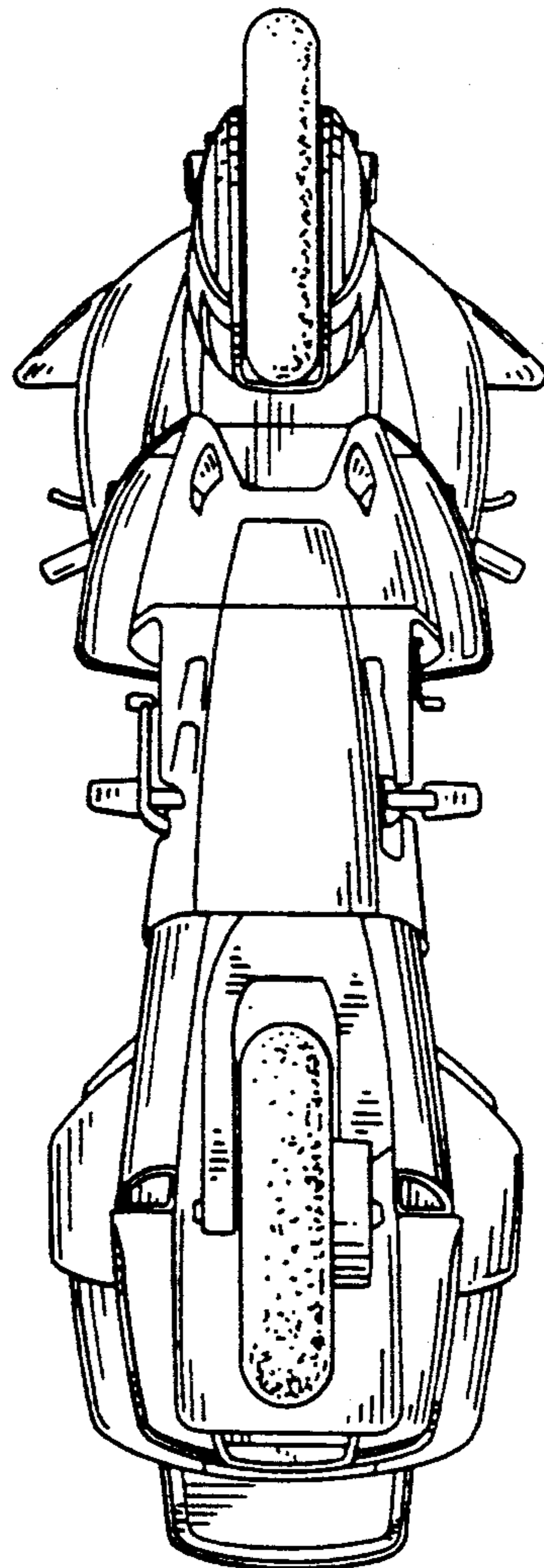

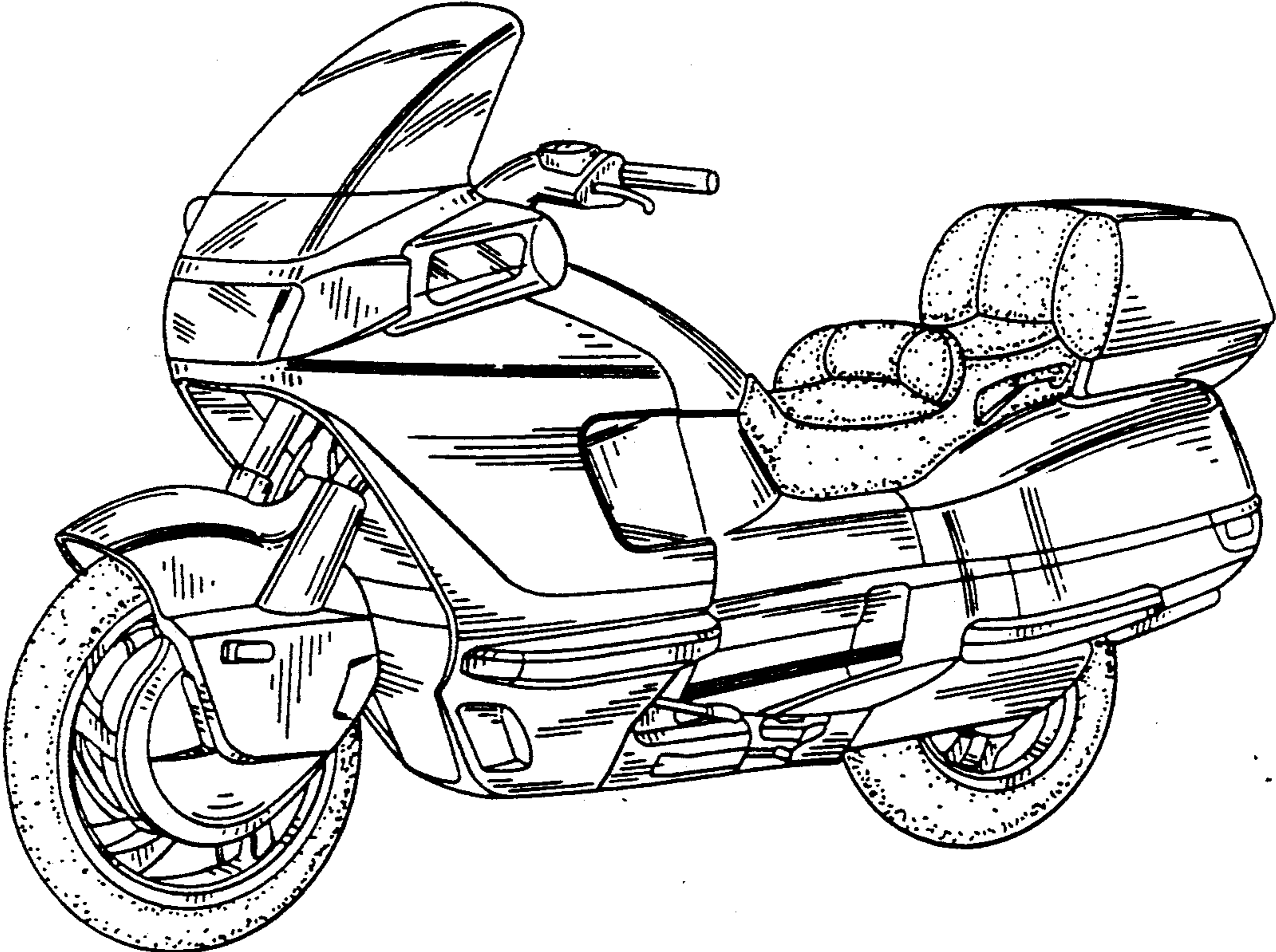
