[57] CLAIM

The ornamental design for a telephone set, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side and top perspective view from above of a telephone set showing my new design in cradled status;

FIG. 2 is a top plan view thereof;

FIG. 3 is a top plan view of the stand of the set, with the handset shown spaced apart in a bottom and left side perspective view; and

FIG. 4 is a right side elevational view of the handset and stand shown in cradled position.

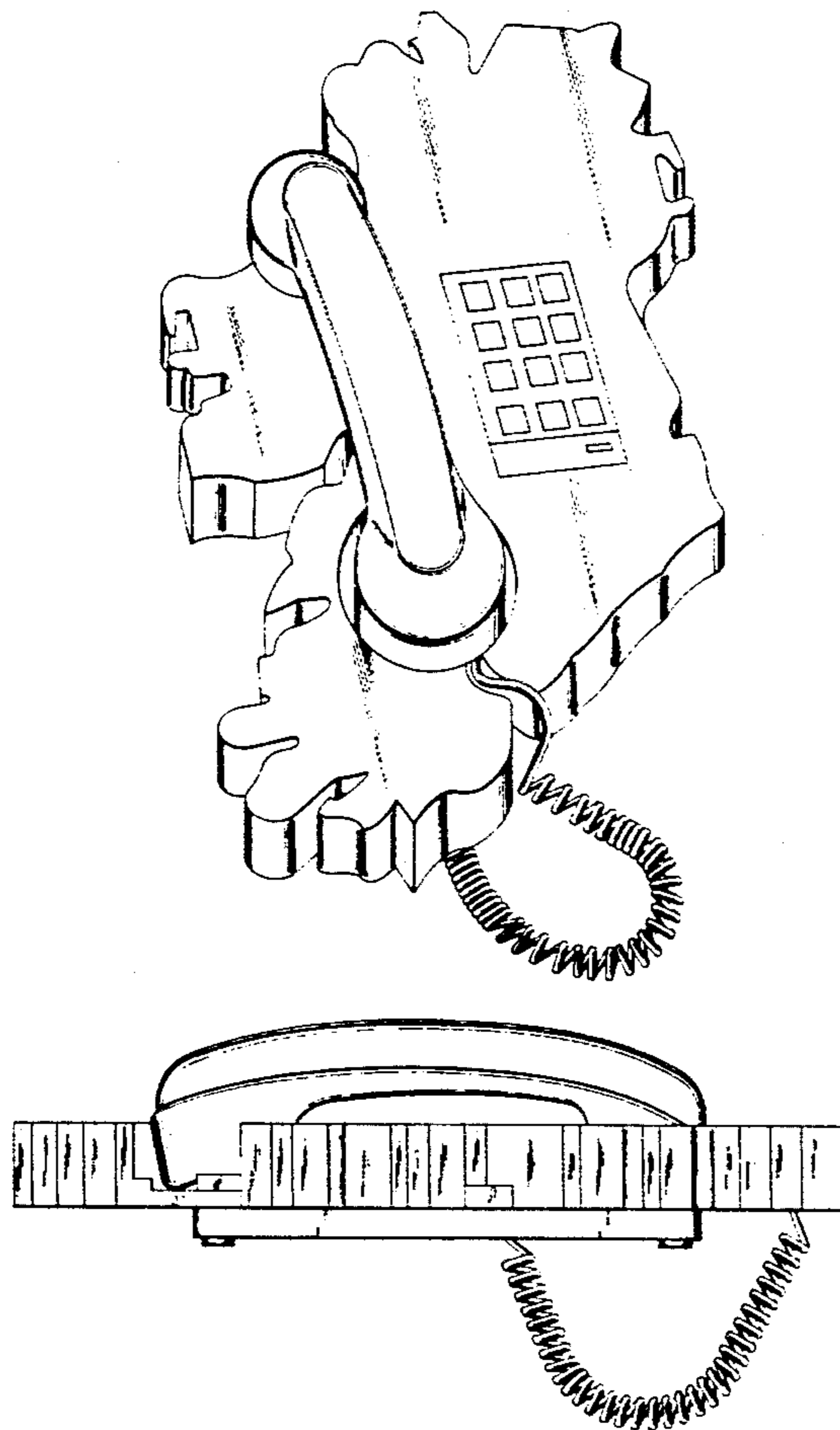

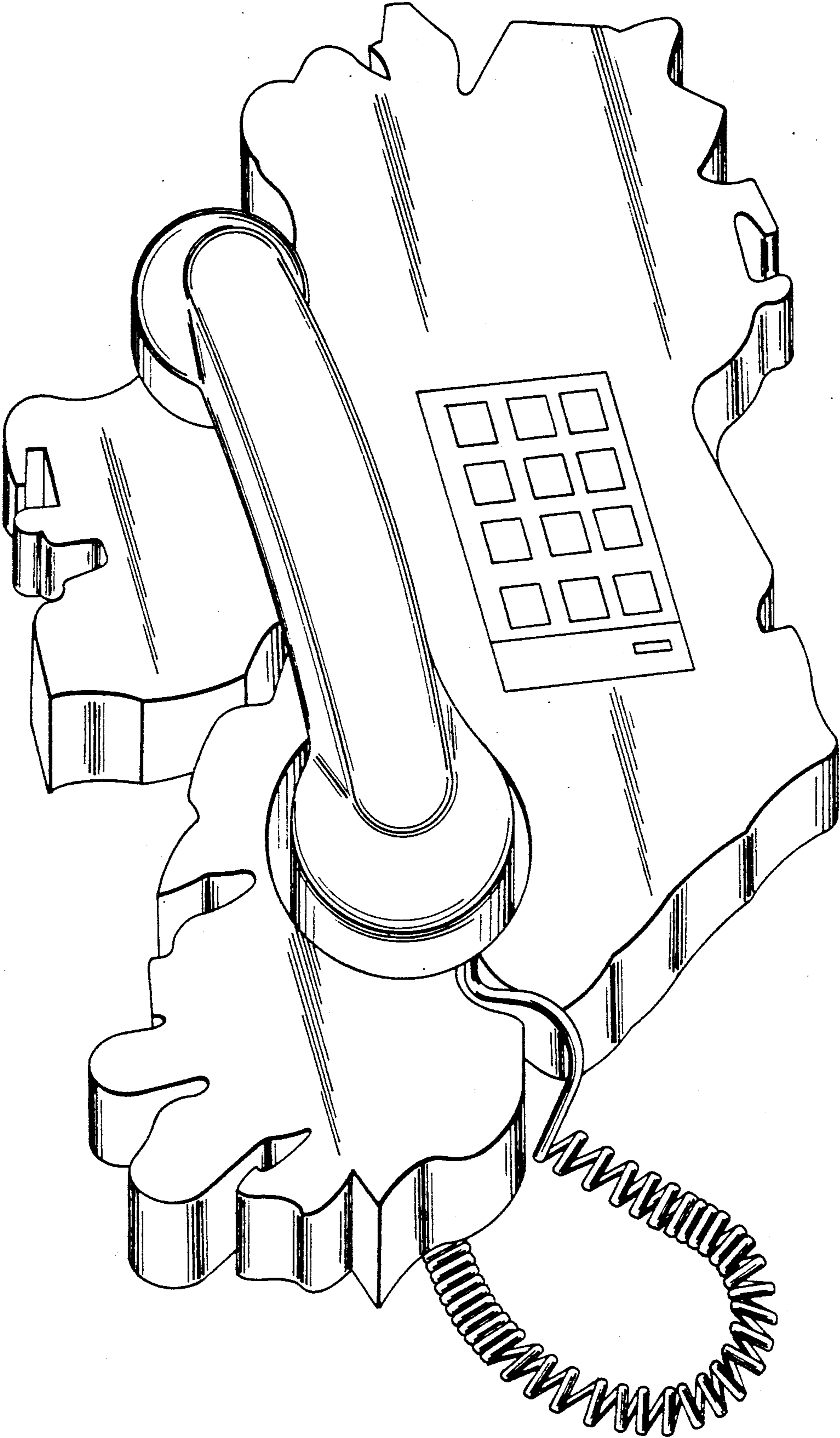

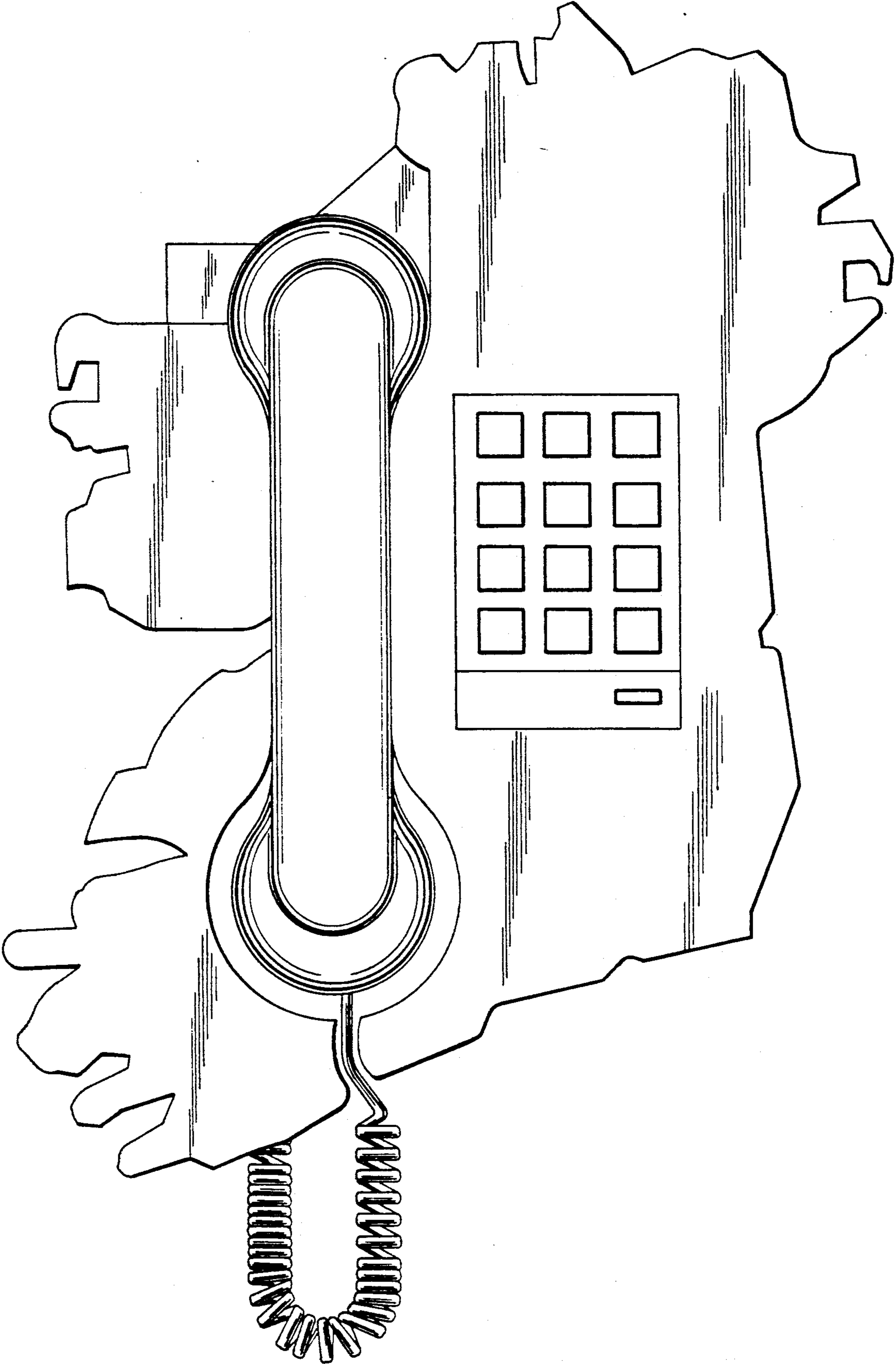

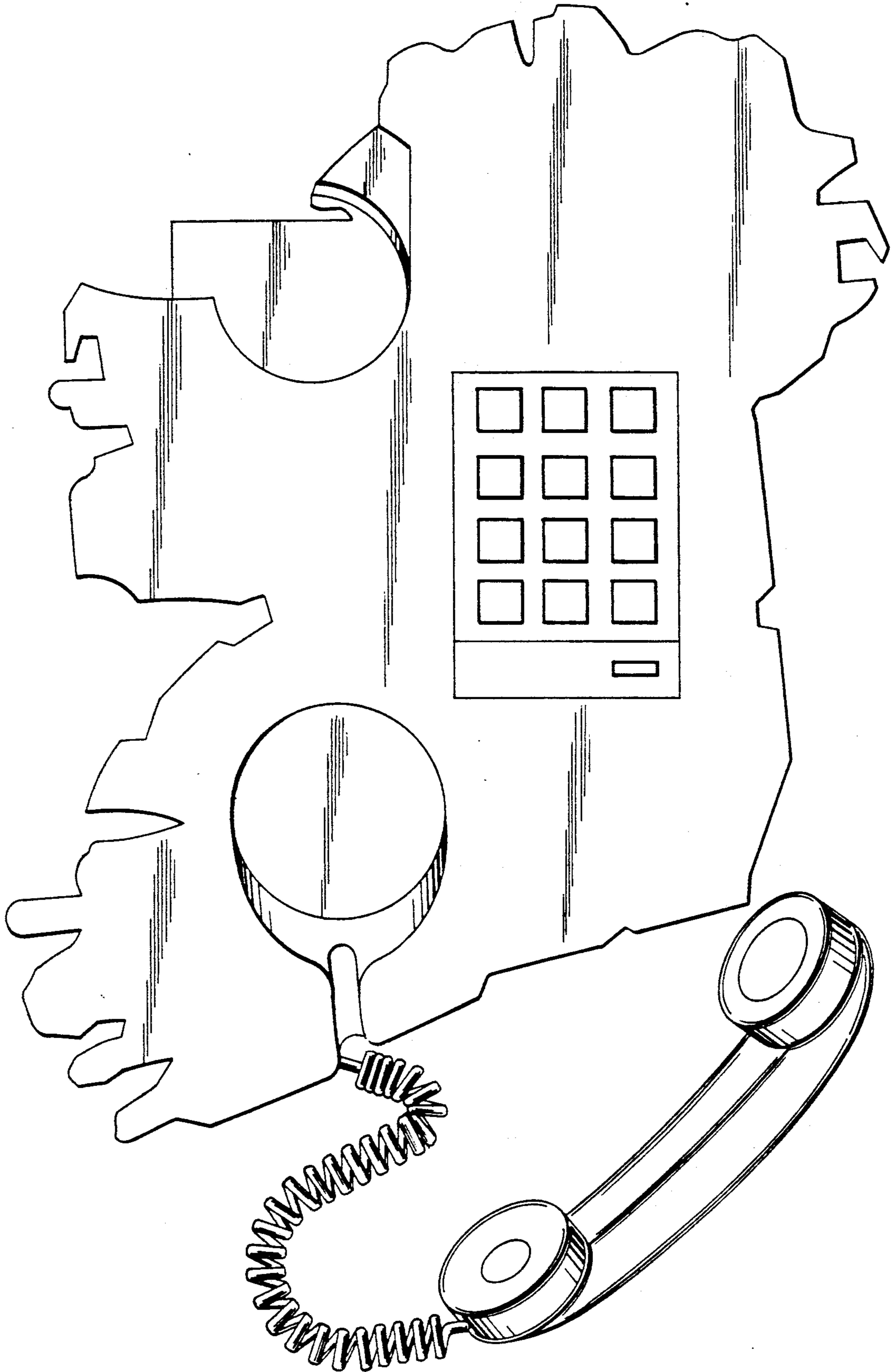
