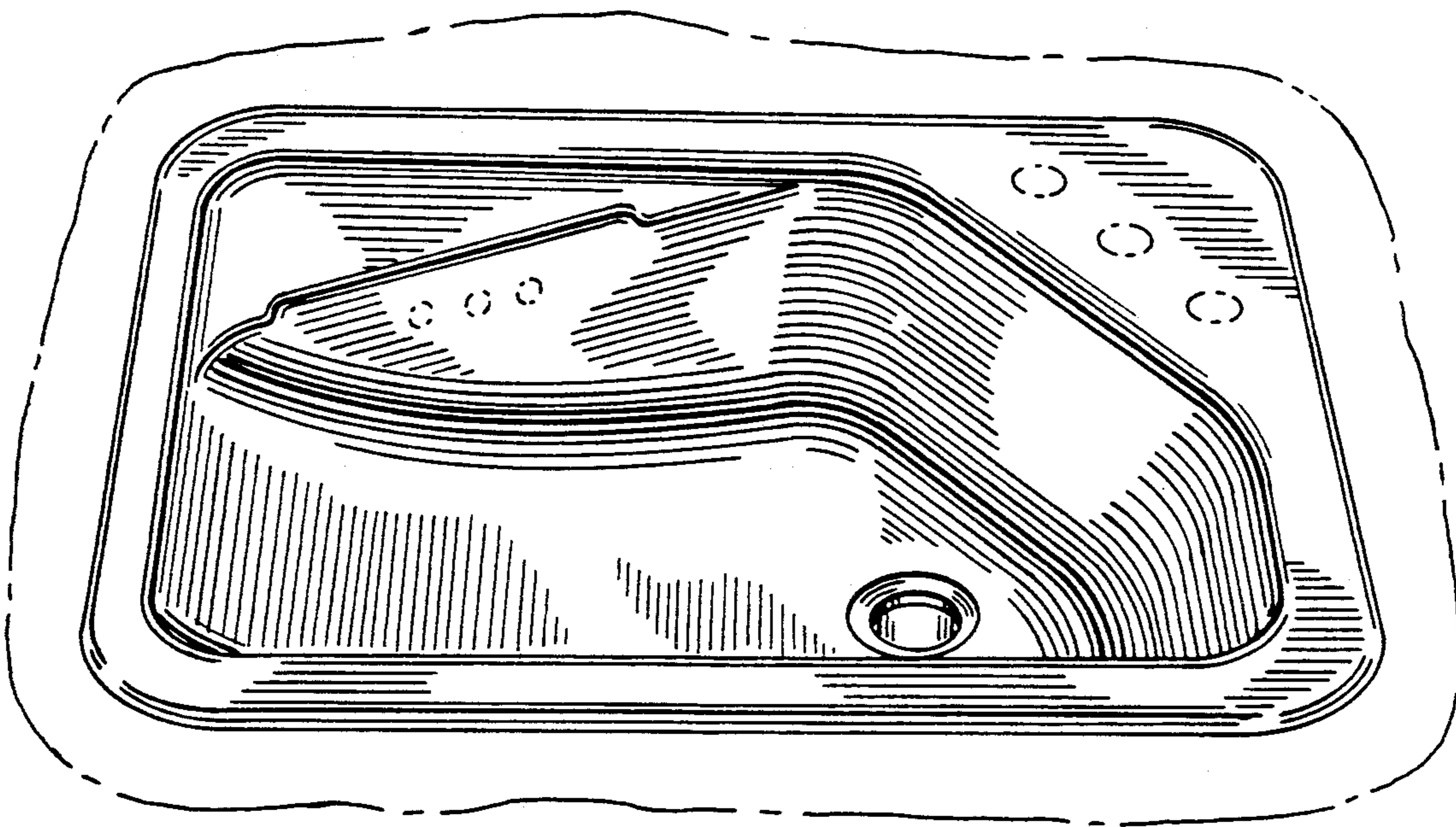
[57] CLAIM

The ornamental design for a lavatory, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from the top and front of a lavatory showing our new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a rear elevational view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a cross-sectional view taken on line 8-8 of FIG. 2;
FIG. 9 is a cross-sectional view taken on line 9-9 of FIG. 2;
FIG. 10 is a cross-sectional view taken on line 10-10 of FIG. 2; and
FIG. 11 is a top plan view of a second embodiment thereof.

The fragmentary broken line representation of a countertop in FIG. 1 and the broken line representations of holes in FIGS. 1, 2 and 7 through 11 are for purposes of illustration only and form no part of the claimed design.



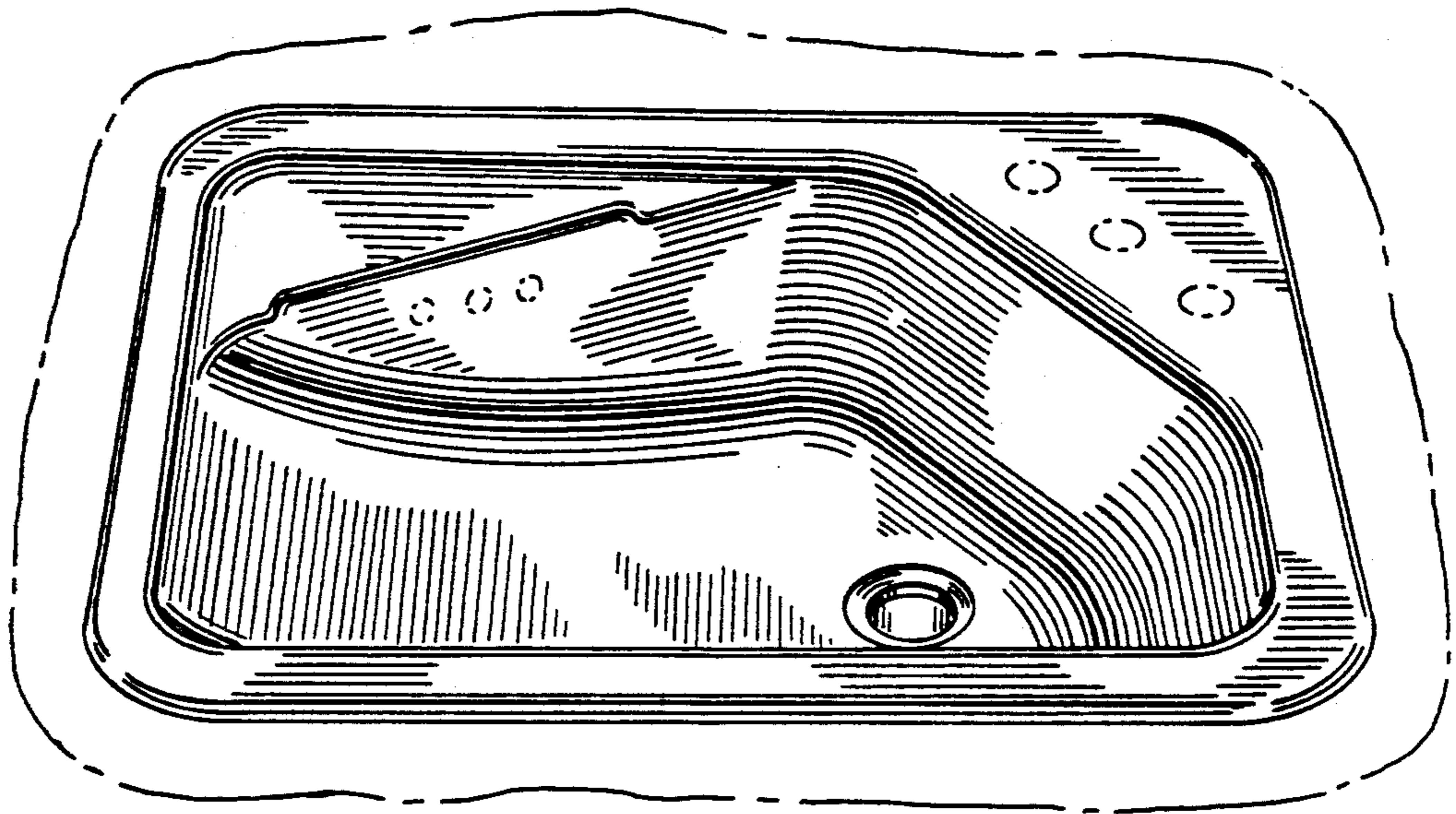

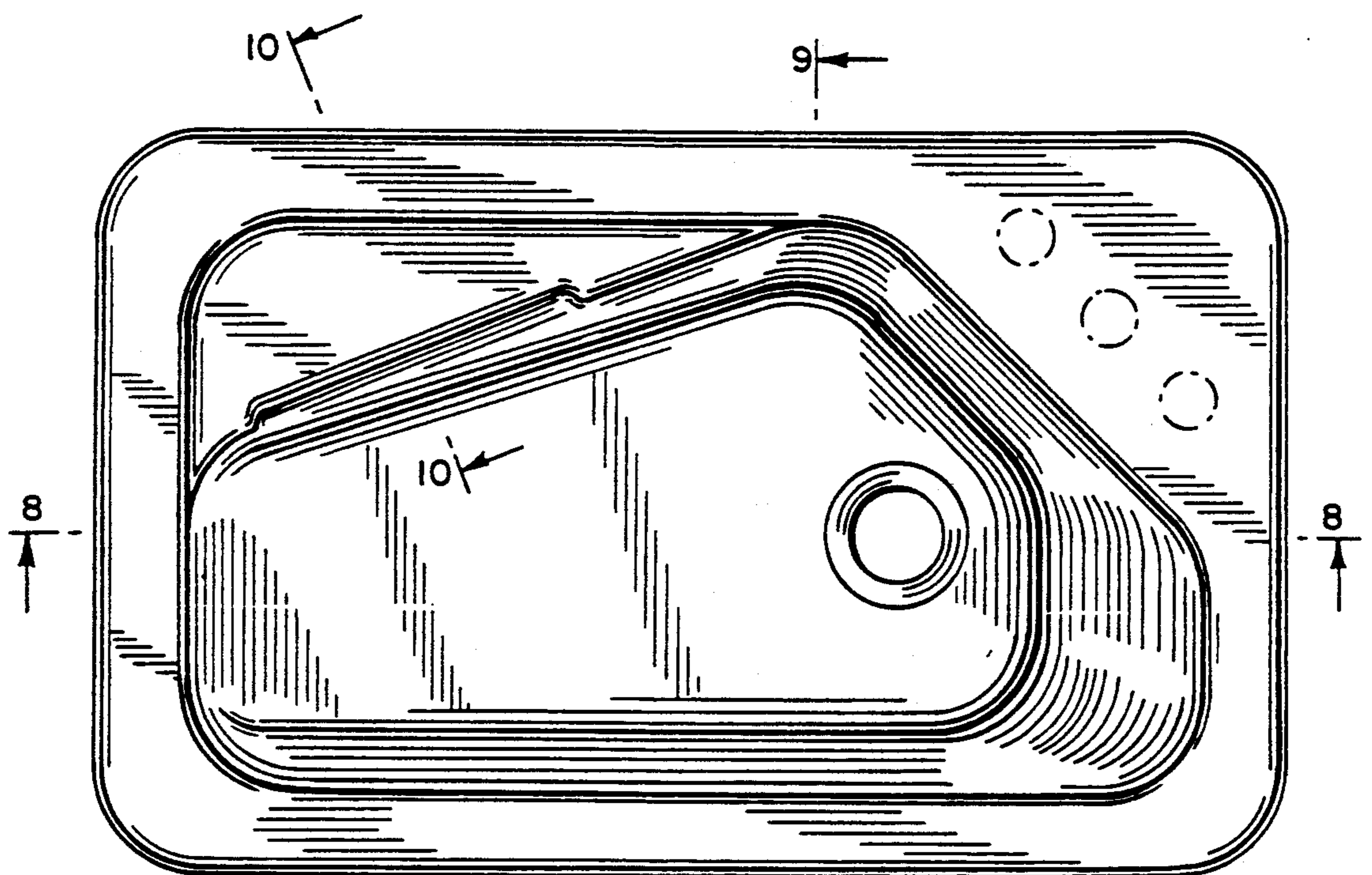

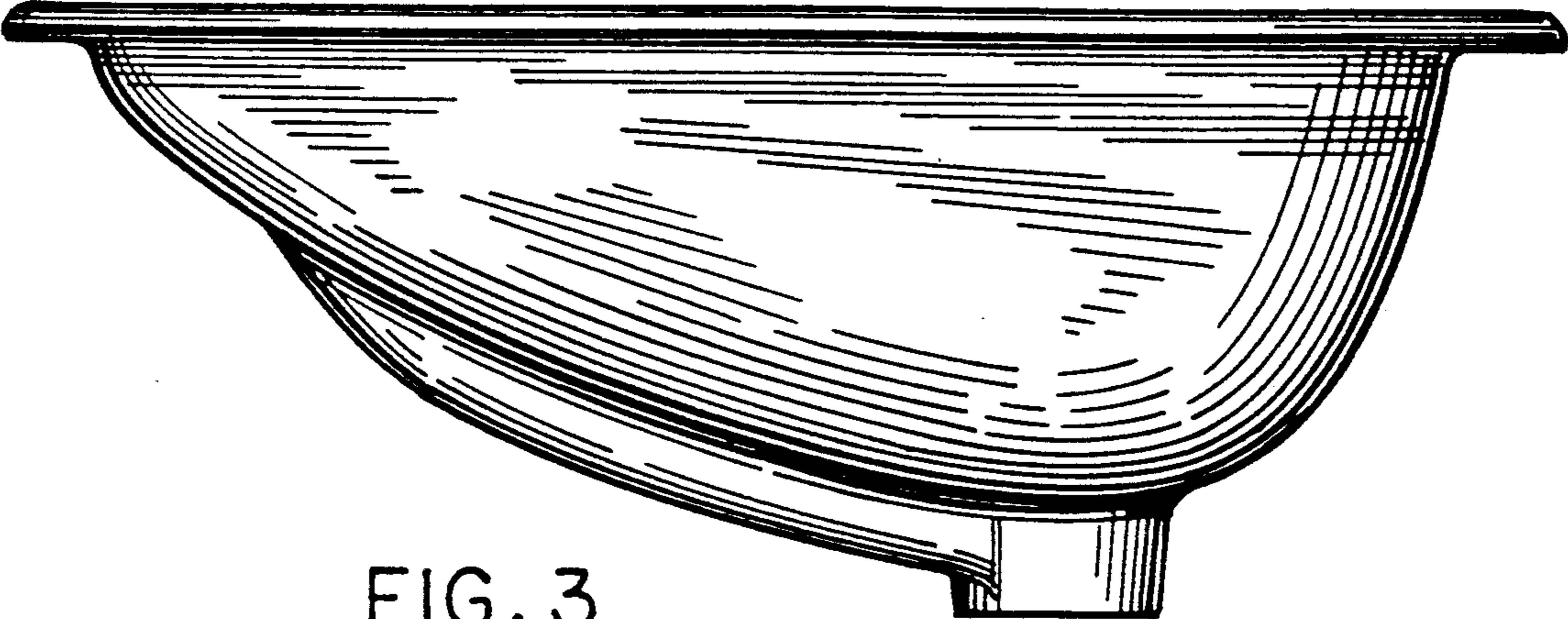

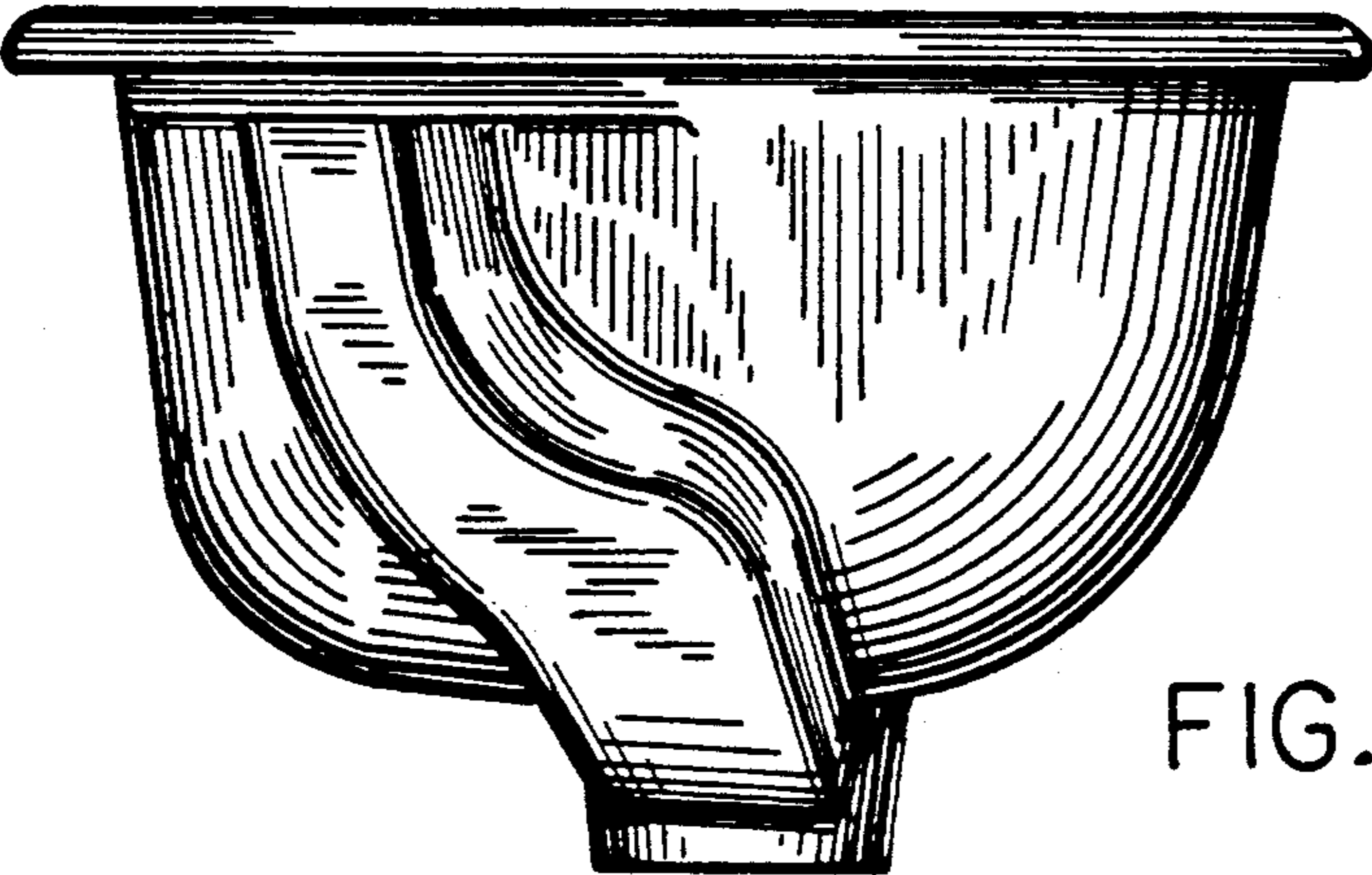

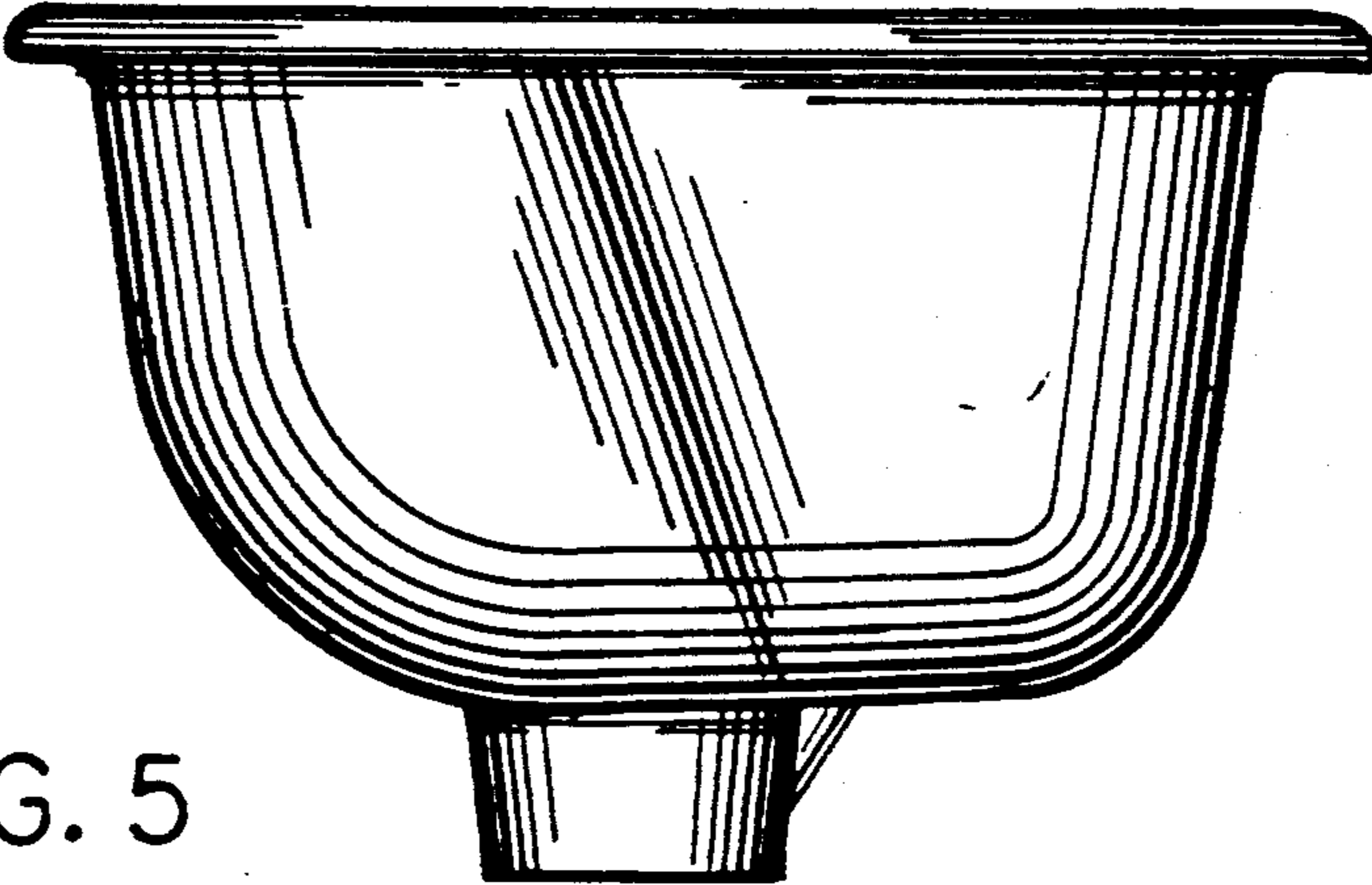

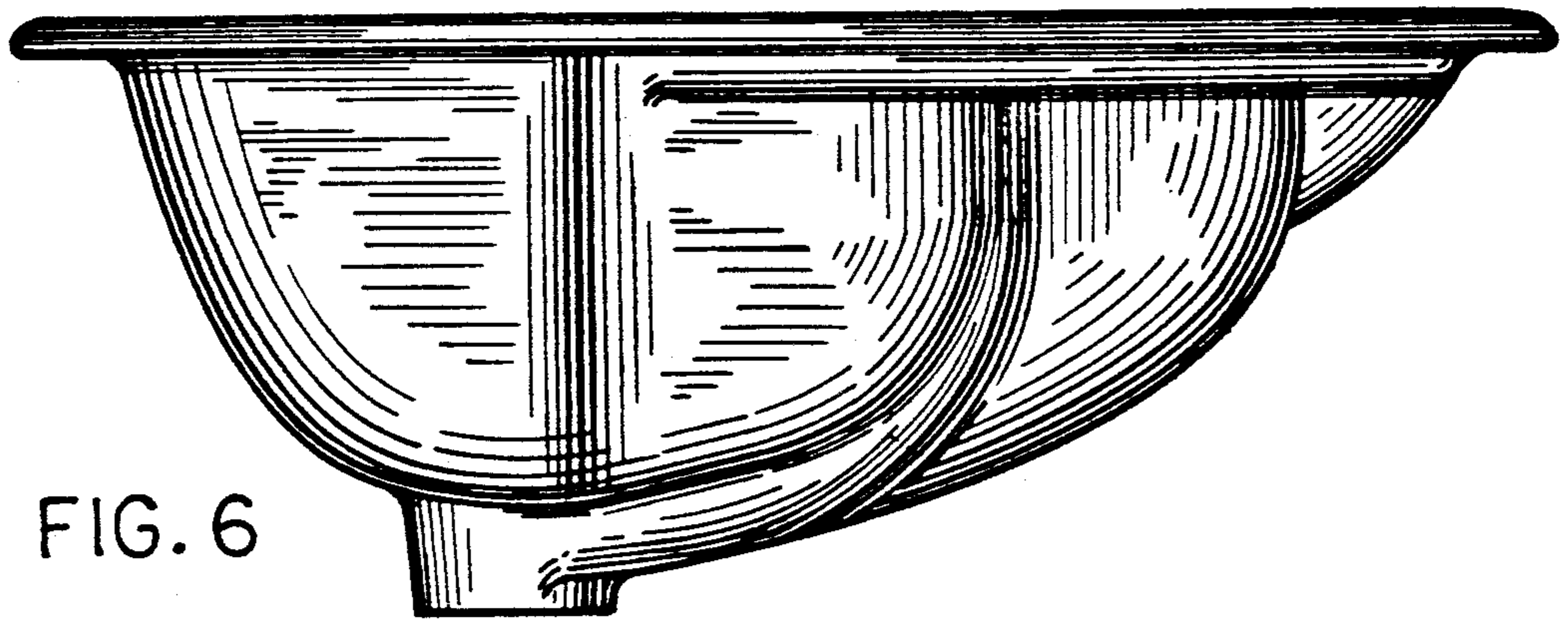

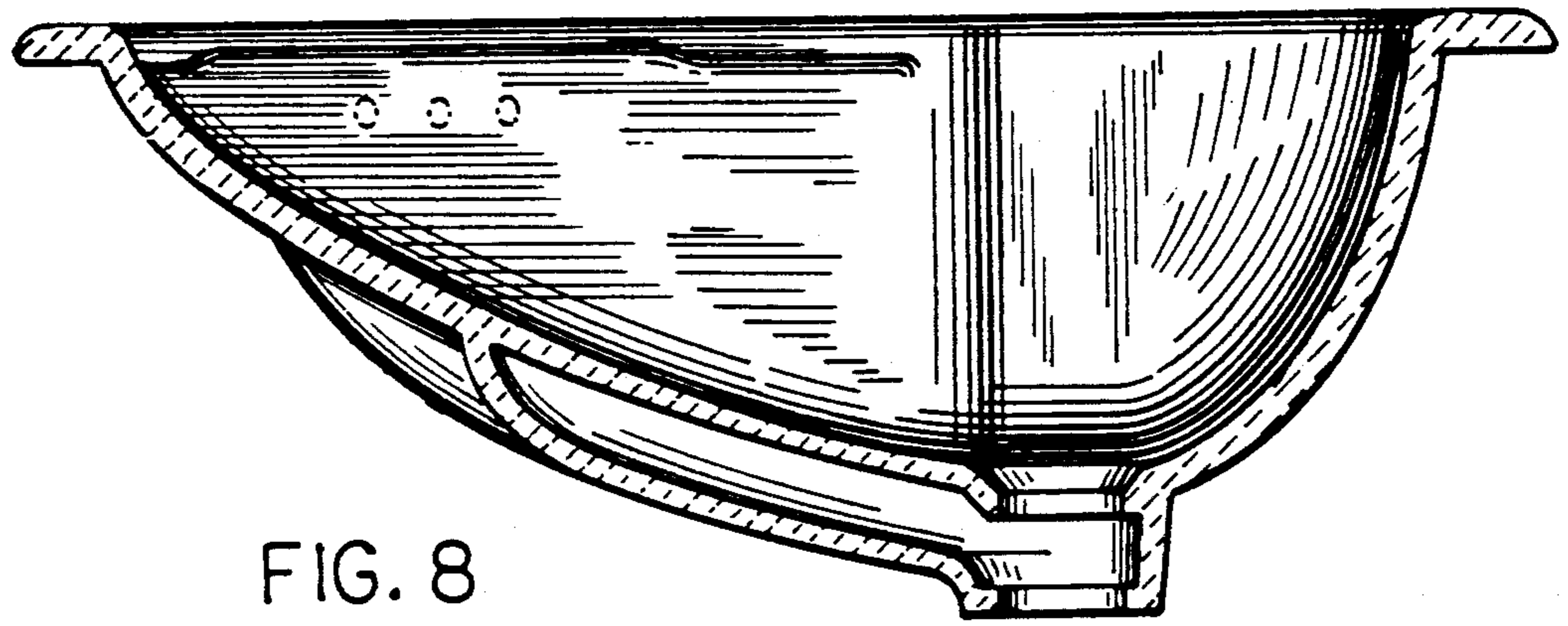
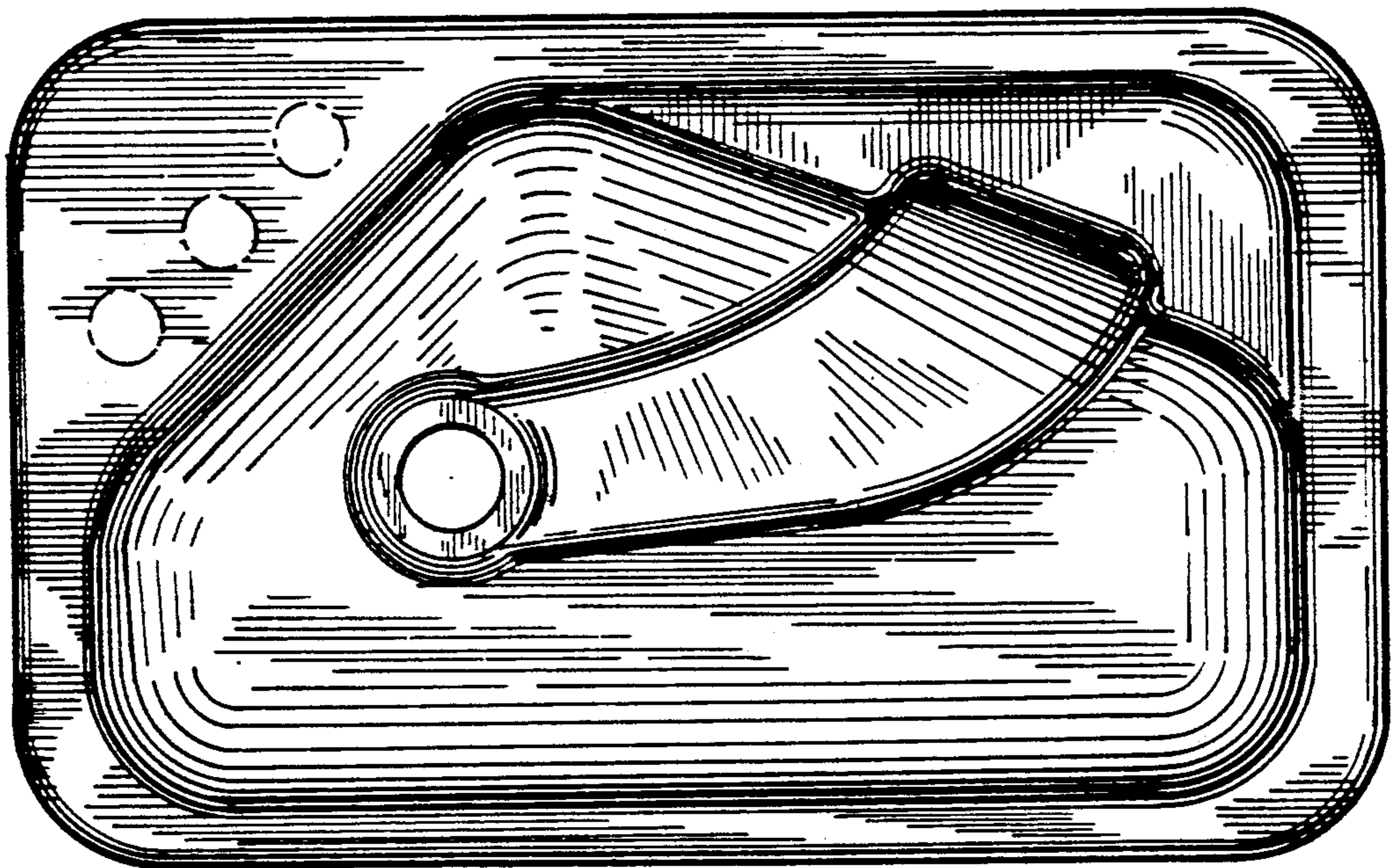

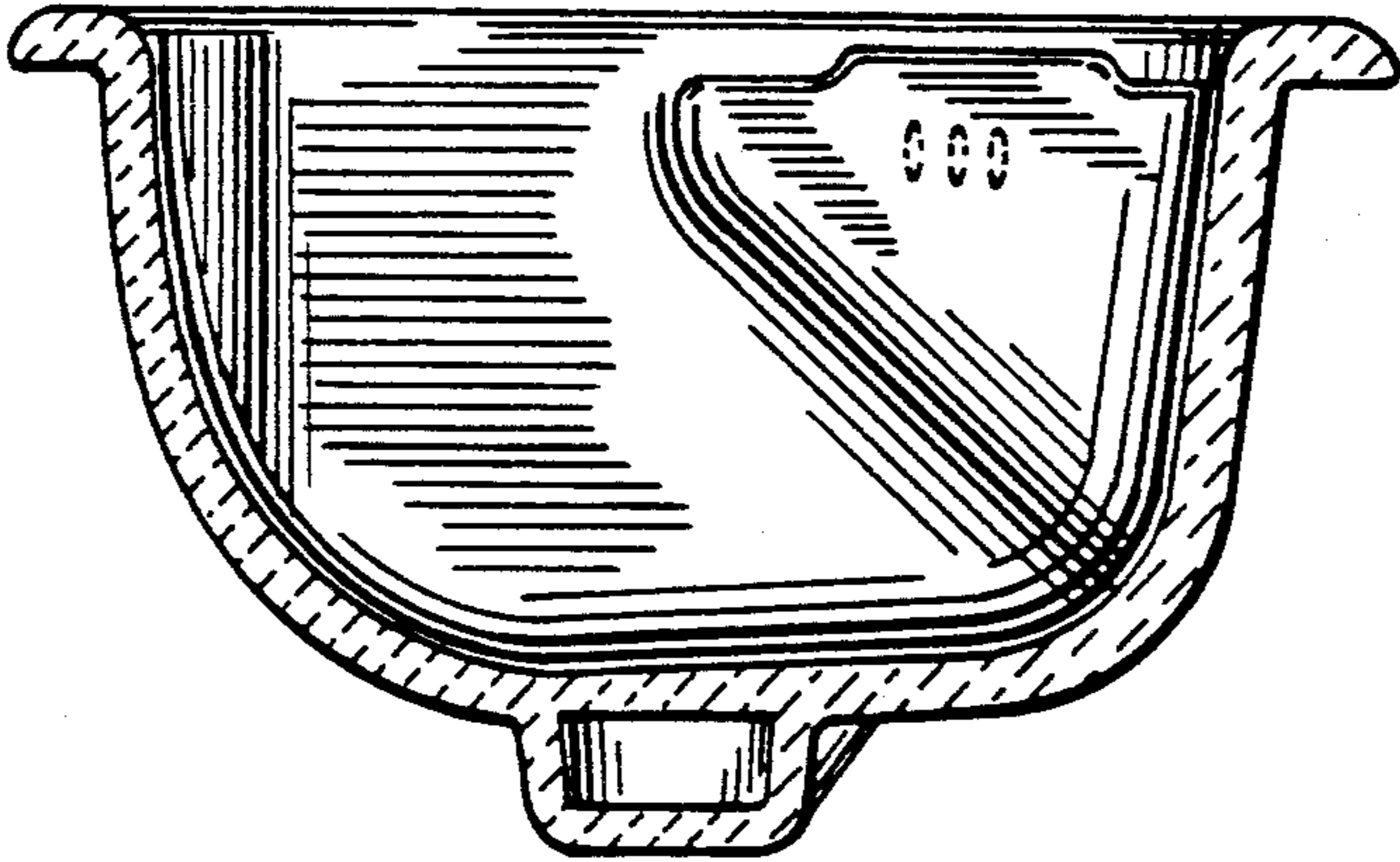

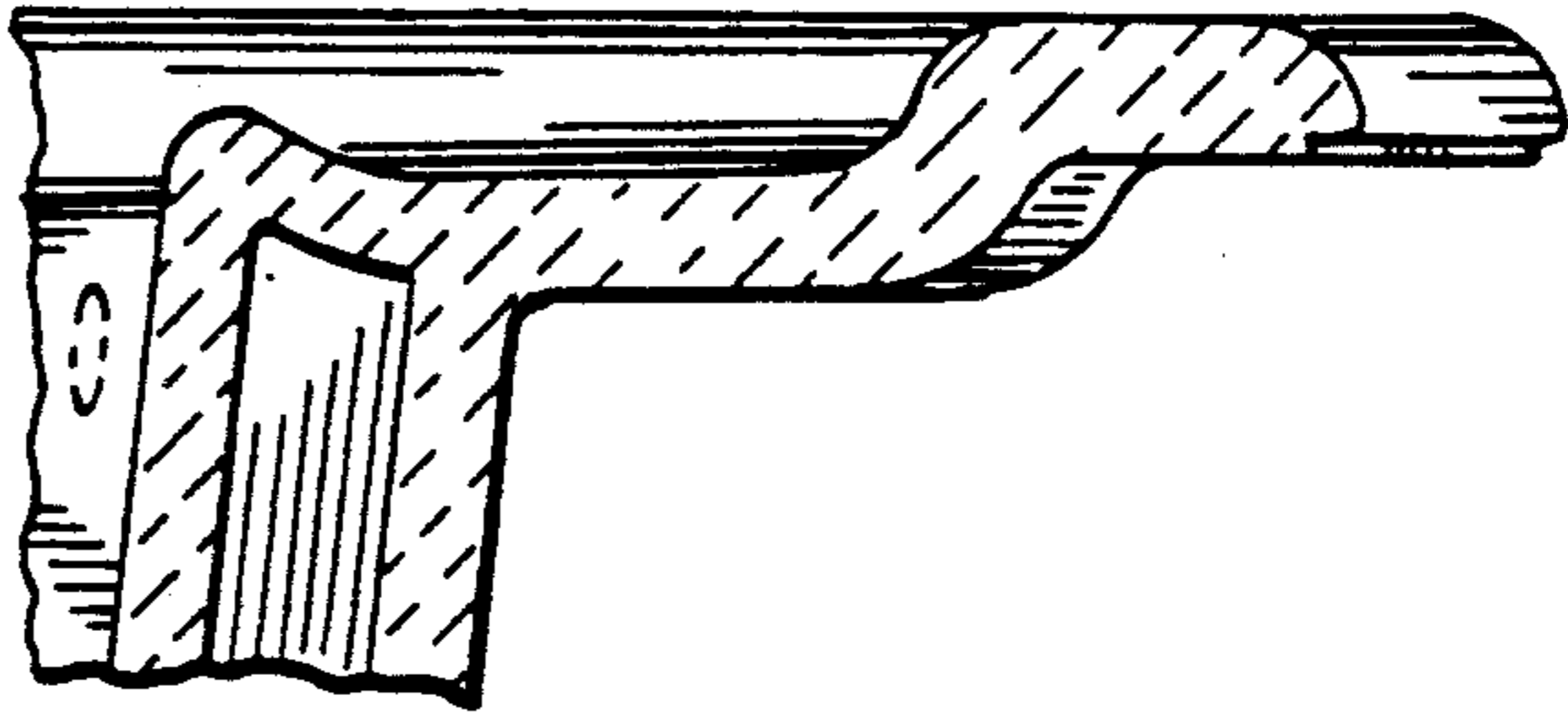
