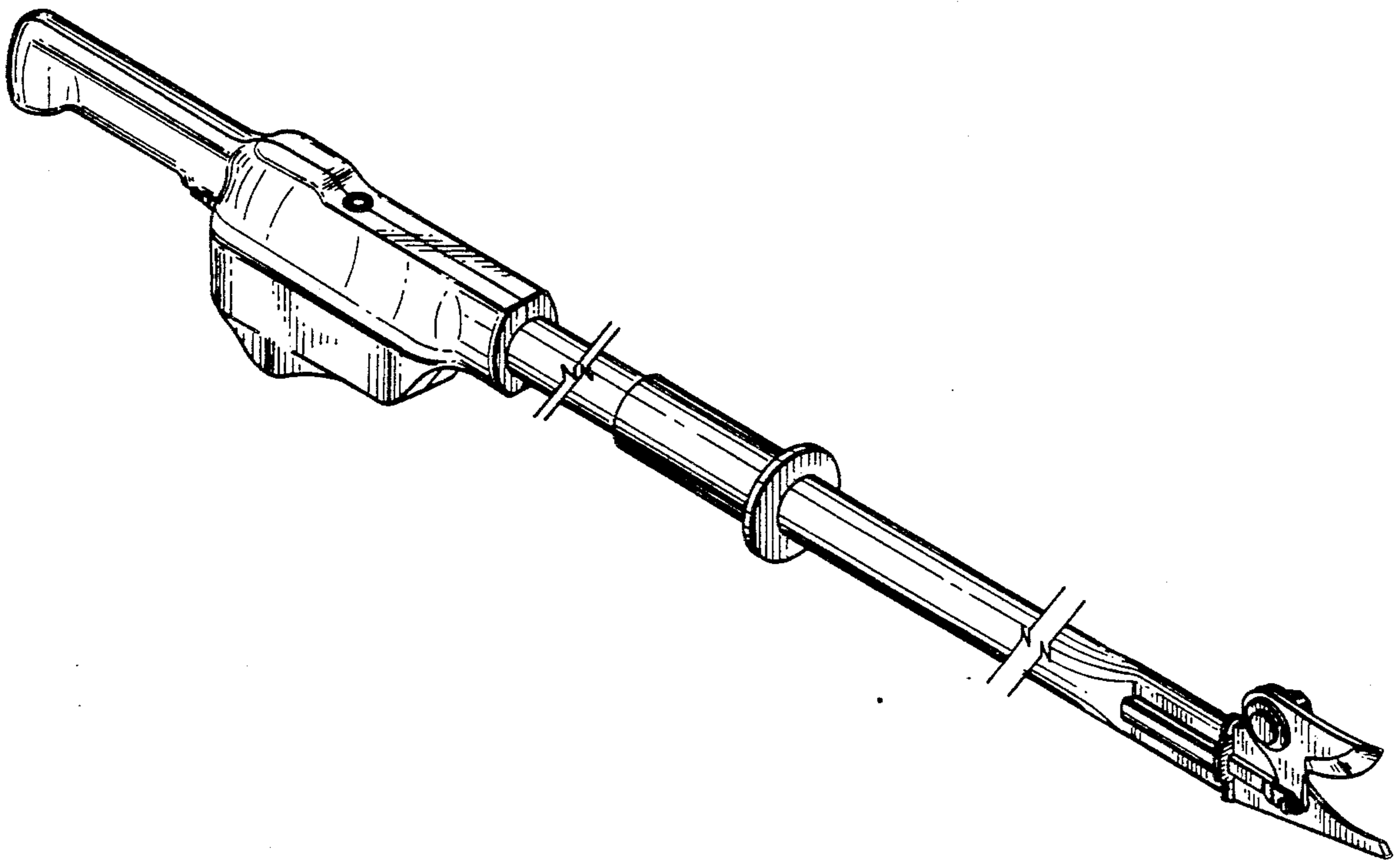
The ornamental design for a tree pruner, as shown and described.

FIG. 3 is a rear, side perspective view thereof.



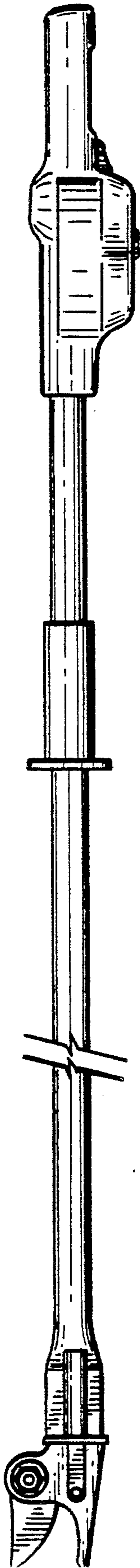

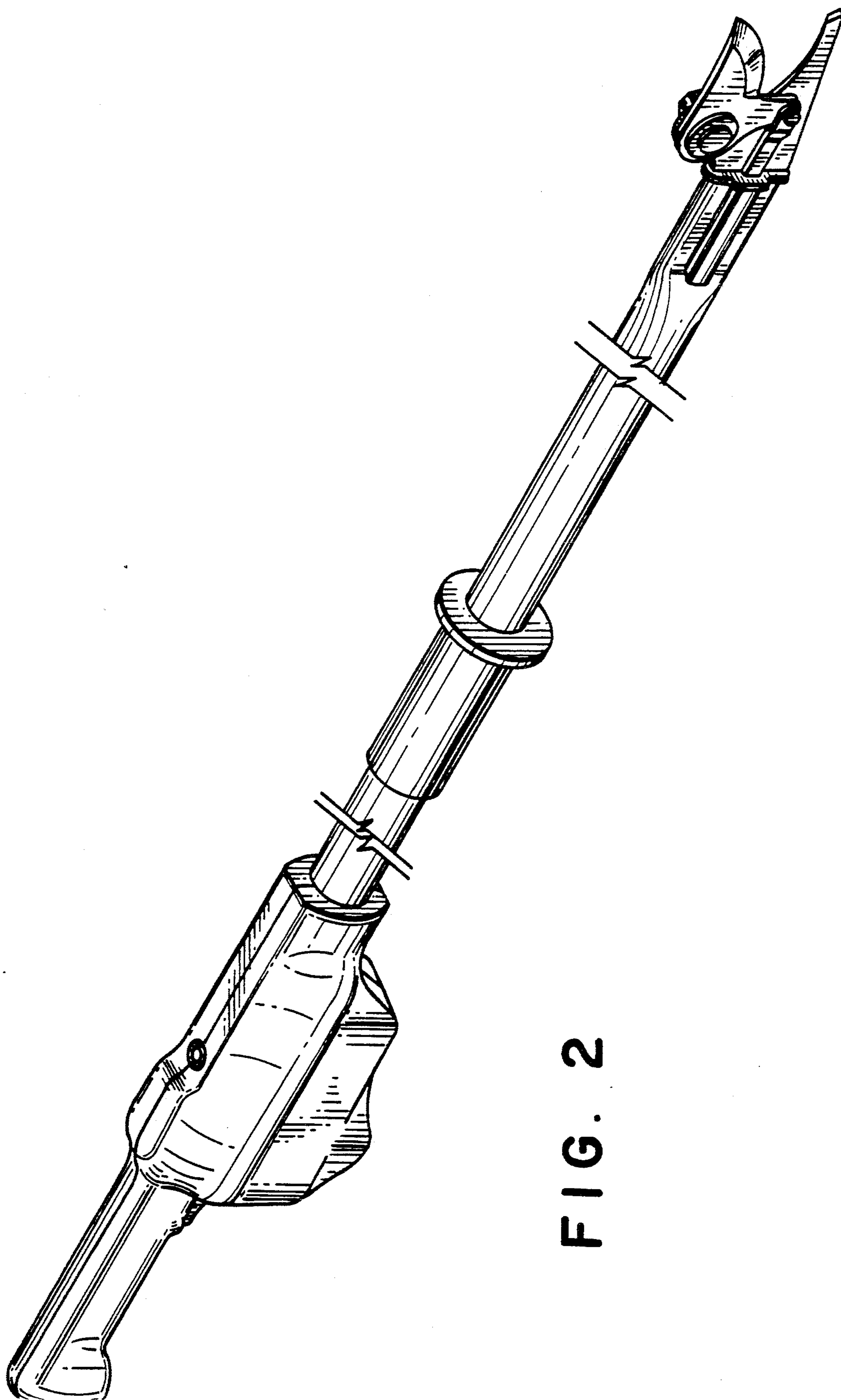

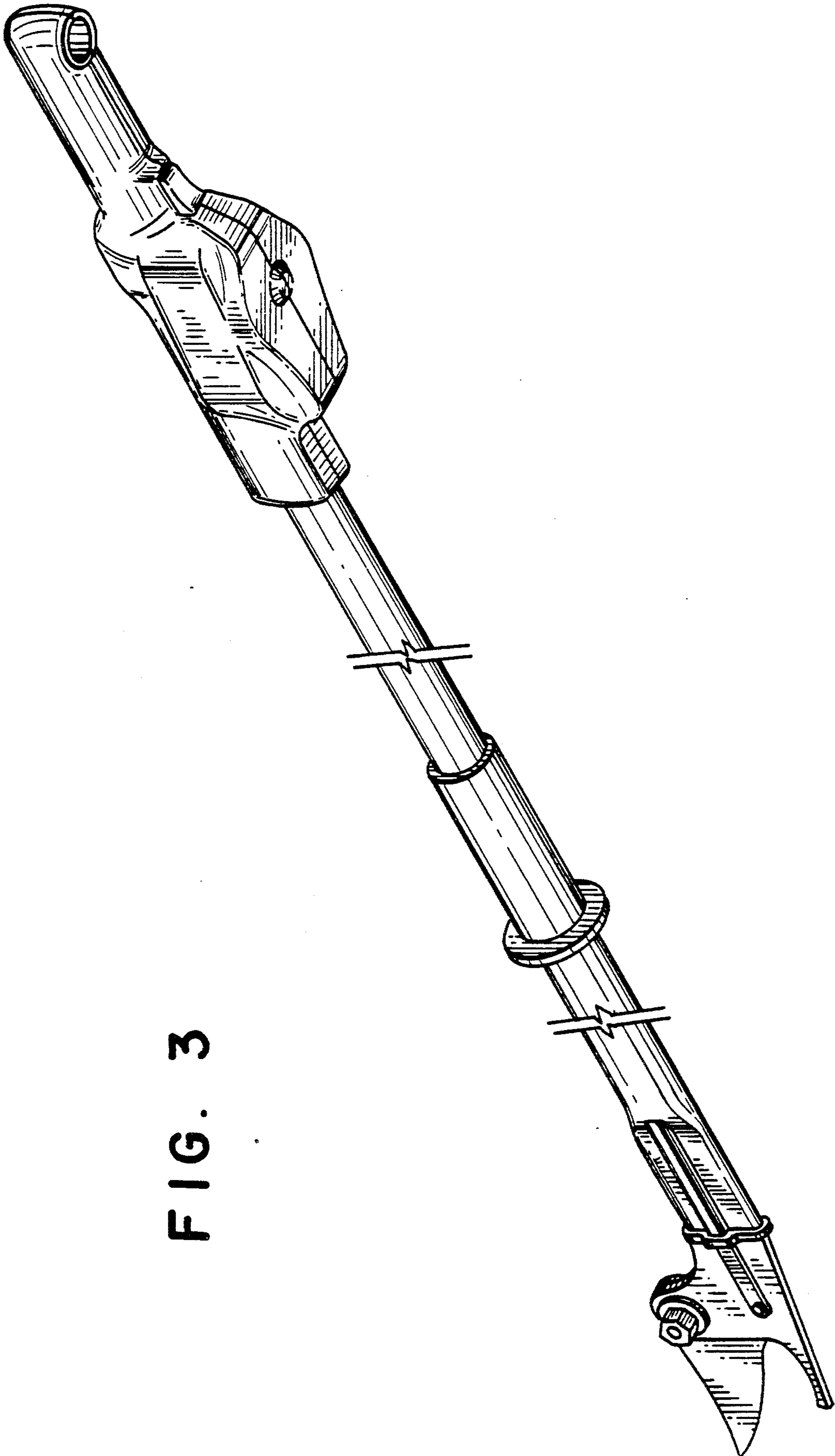
