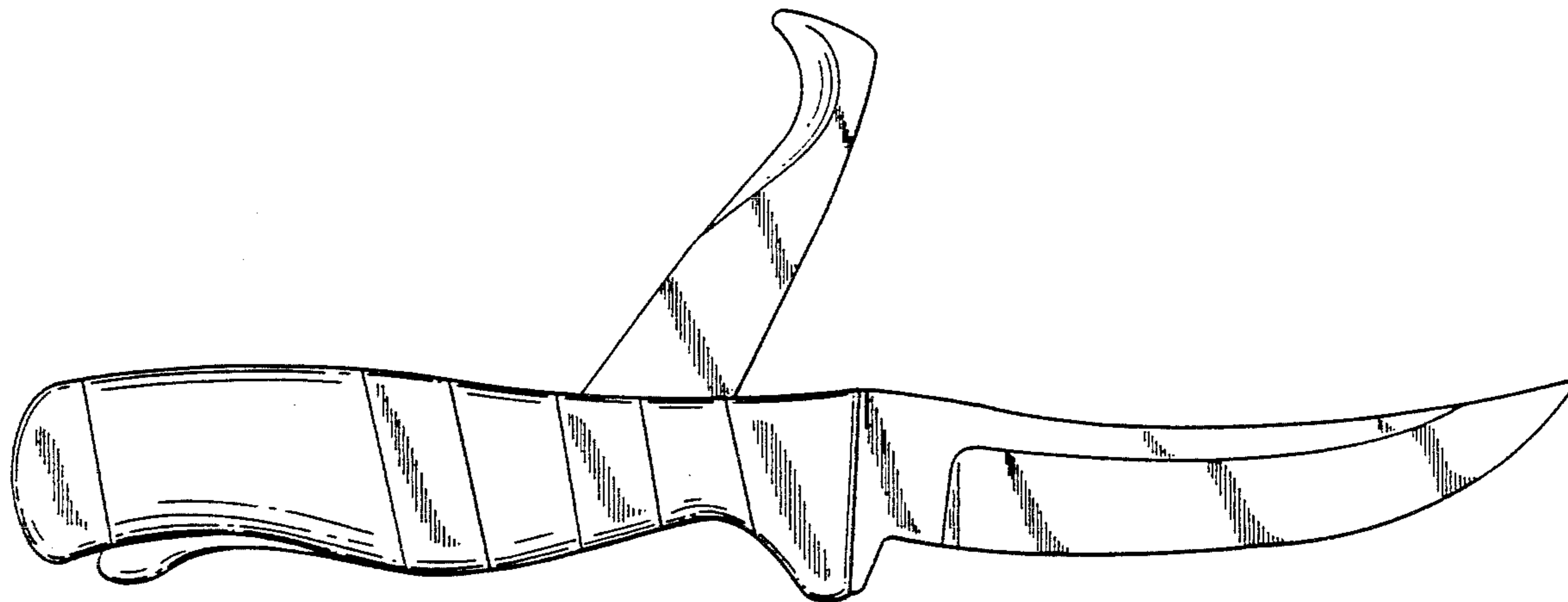

The ornamental design for a combined knife and dressing tool for use primarily by a hunter, as shown and described.

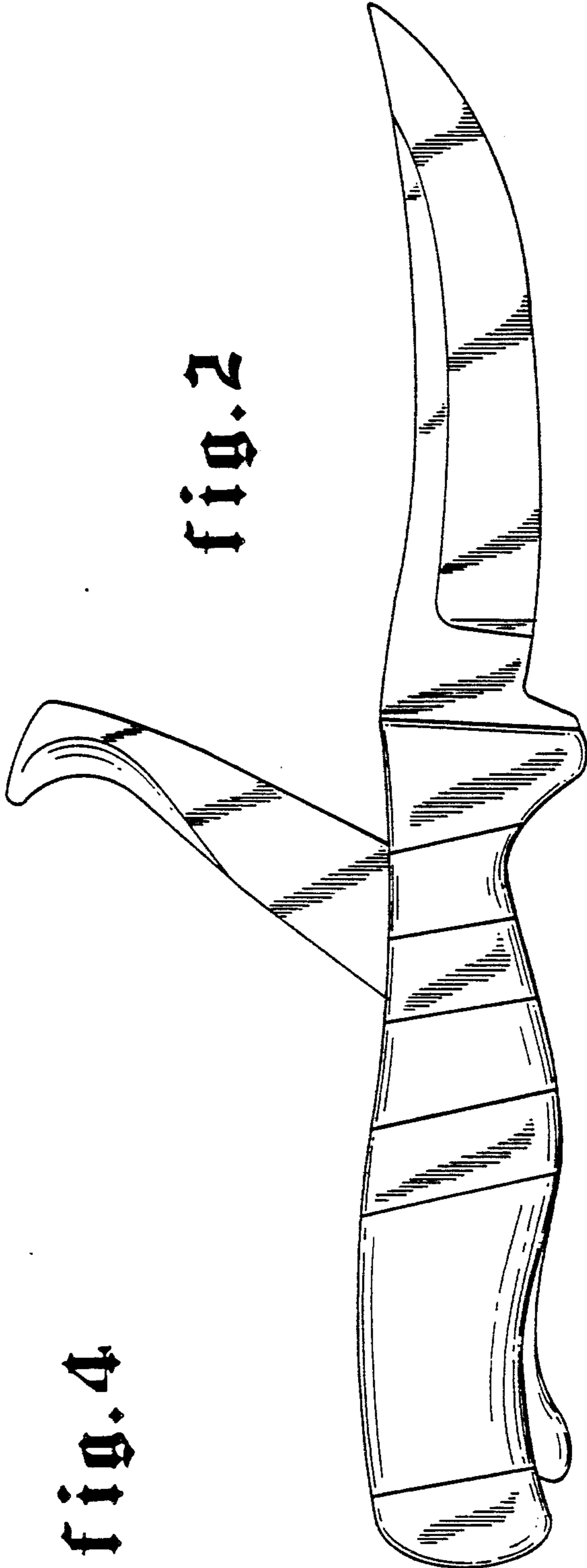
DESCRIPTION

FIG. 1 is a top plan view of a combined knife and dressing tool for use primarily by a hunter showing my new design;
FIG. 2 is a side elevational view, the opposite side being a mirror image thereof;
FIG. 3 is a bottom plan view;
FIG. 4 is a rear elevational view; and
FIG. 5 is a front elevational view thereof.



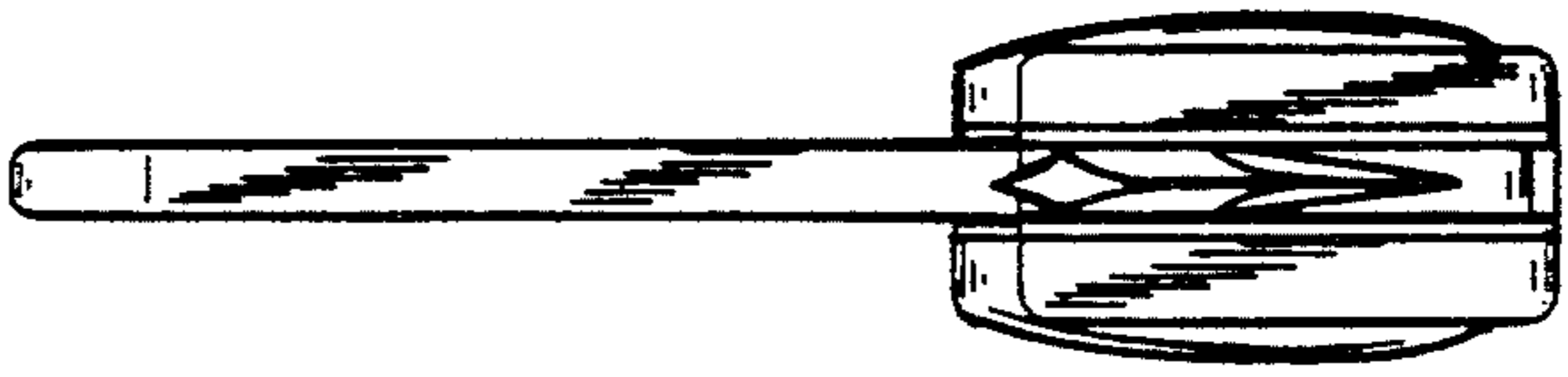

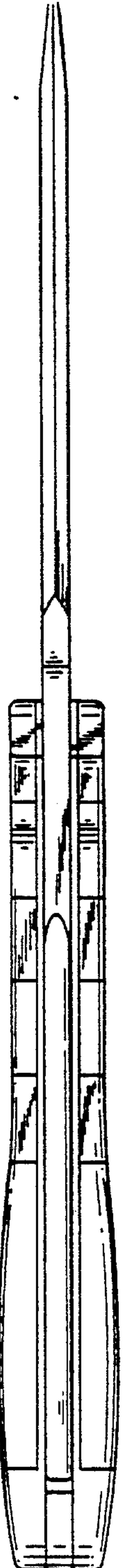
