CLAIM

The ornamental design for a shoe outsole bottom, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a shoe outsole bottom showing, an embodiment of my new design with a translucent section in a portion of the rear part as illustrated by the shading;
FIG. 2 is a sectional view taken along line 2—2 of FIG. 1;
FIG. 3 is a sectional view taken along line 3—3 of FIG. 1;
FIG. 4 is a sectional view taken along line 4—4 of FIG. 1;
FIG. 5 is a bottom plan view of a shoe outsole bottom showing another embodiment of my new design;
FIG. 6 is a sectional view taken along line 6—6 of FIG. 1; and
FIG. 7 is a sectional view taken along line 7—7 of FIG. 1.

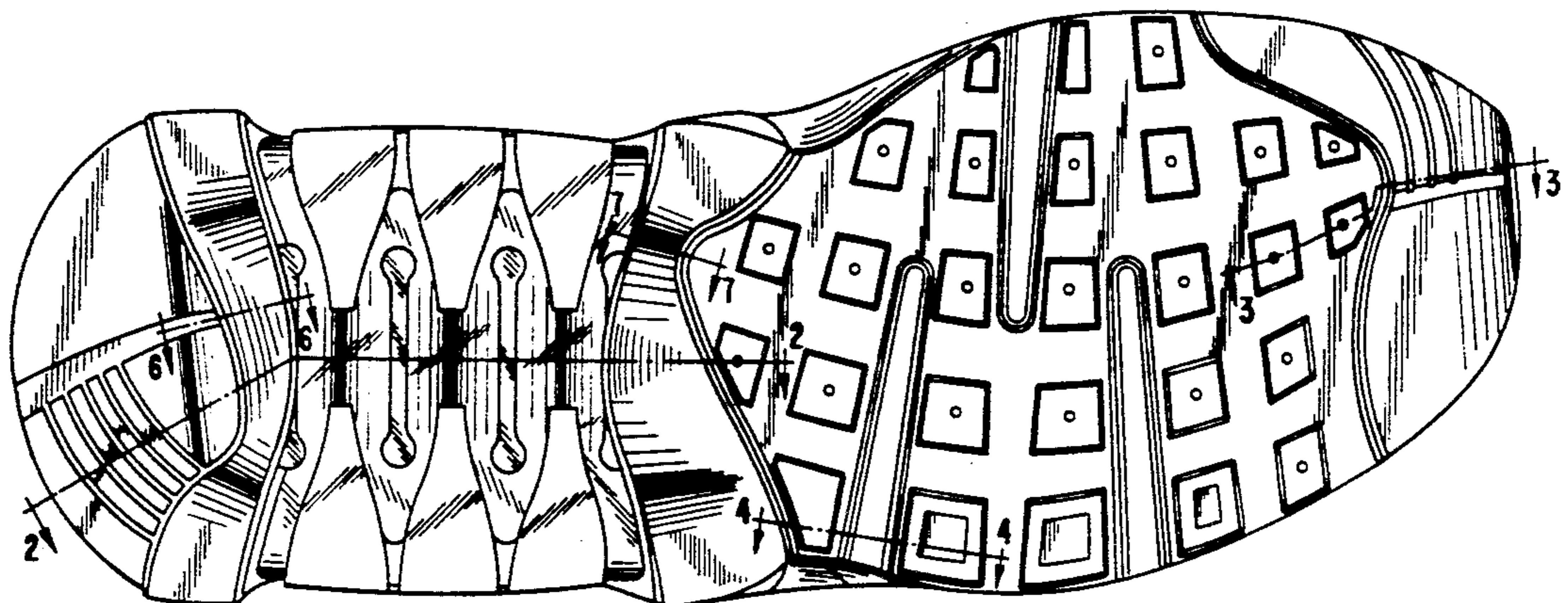

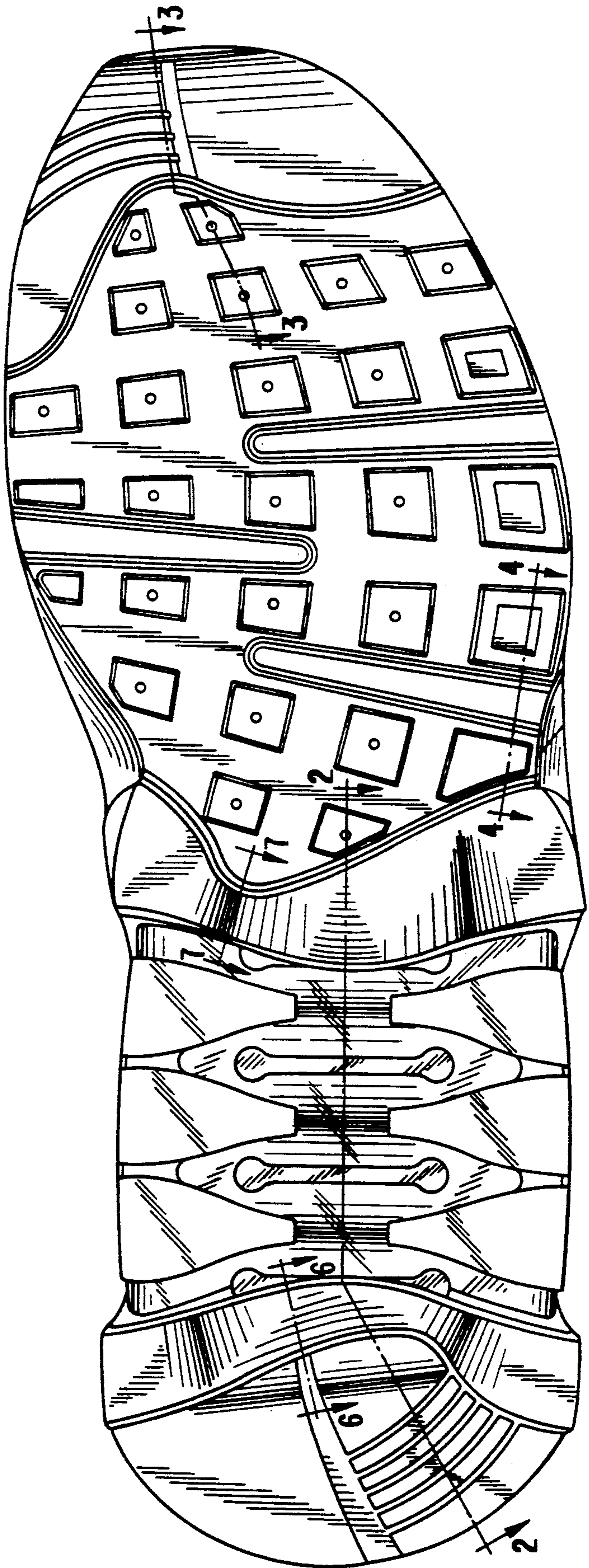

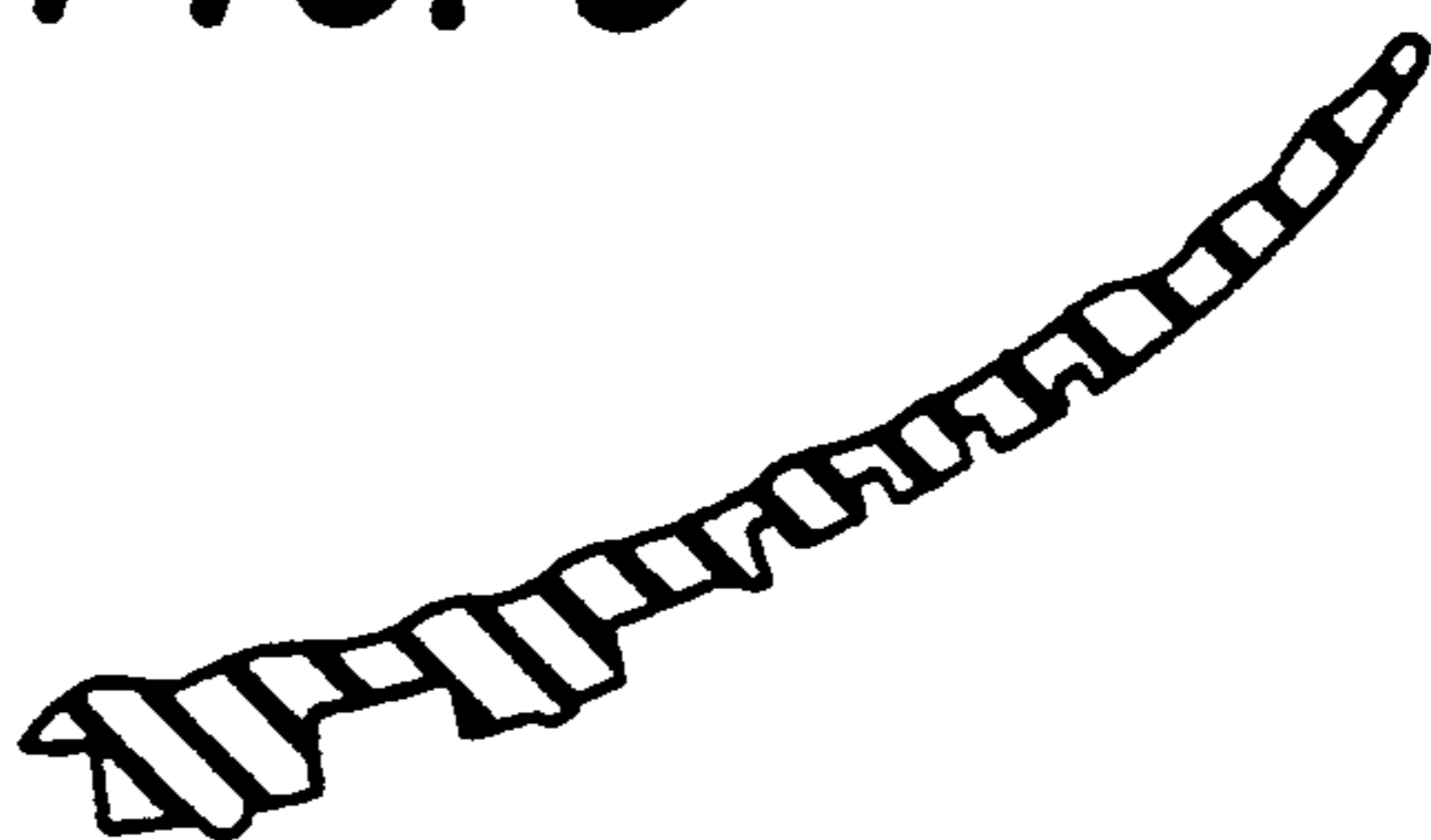
