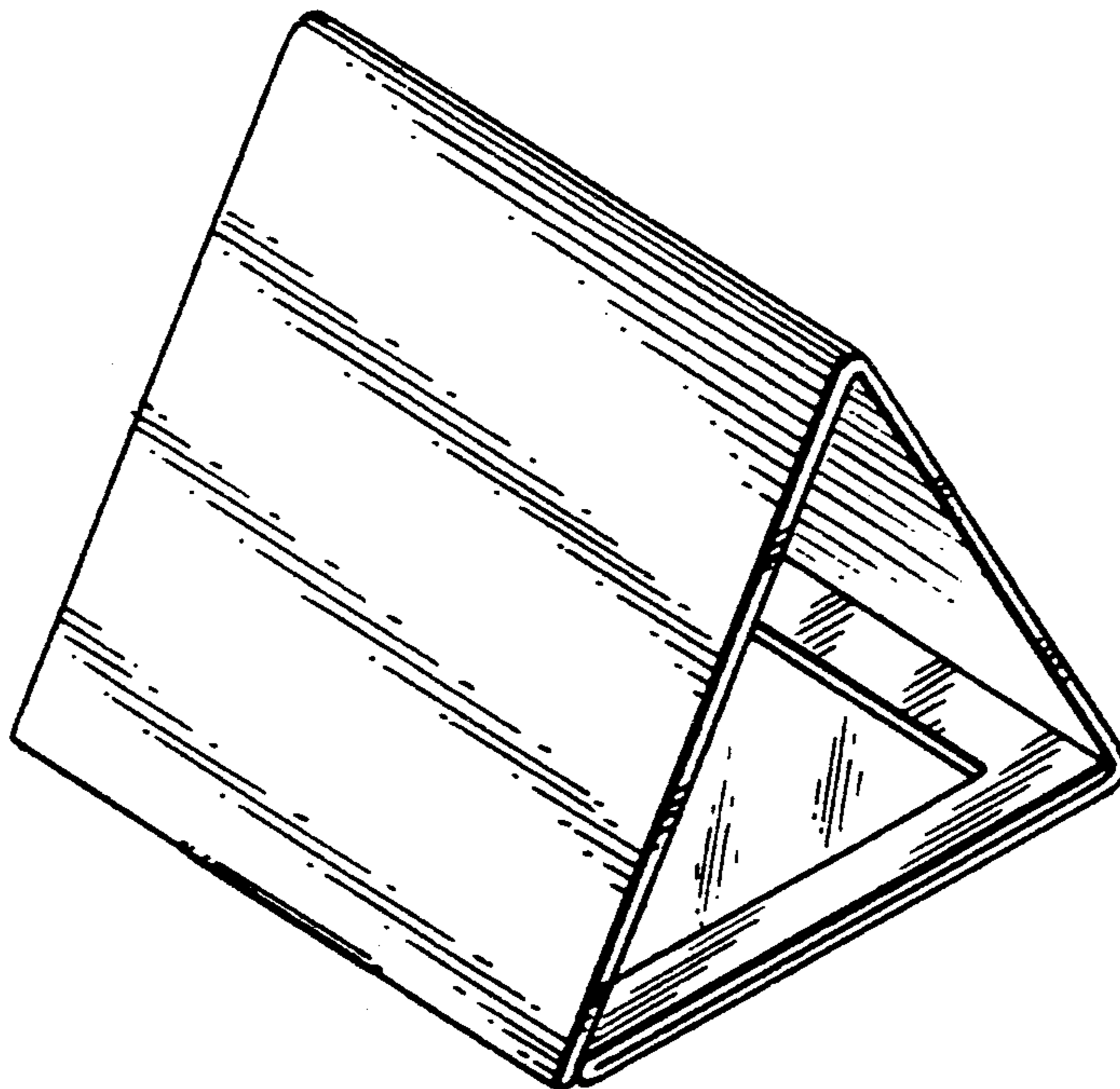

[57] **CLAIM**

The ornamental design for a compact disc case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a compact disc case showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left-side elevational view thereof;
FIG. 5 is a right-side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a front elevational view thereof, shown fully extended, the rear being unornamented; and
FIG. 9 is a perspective view thereof shown folded into a triangular position.



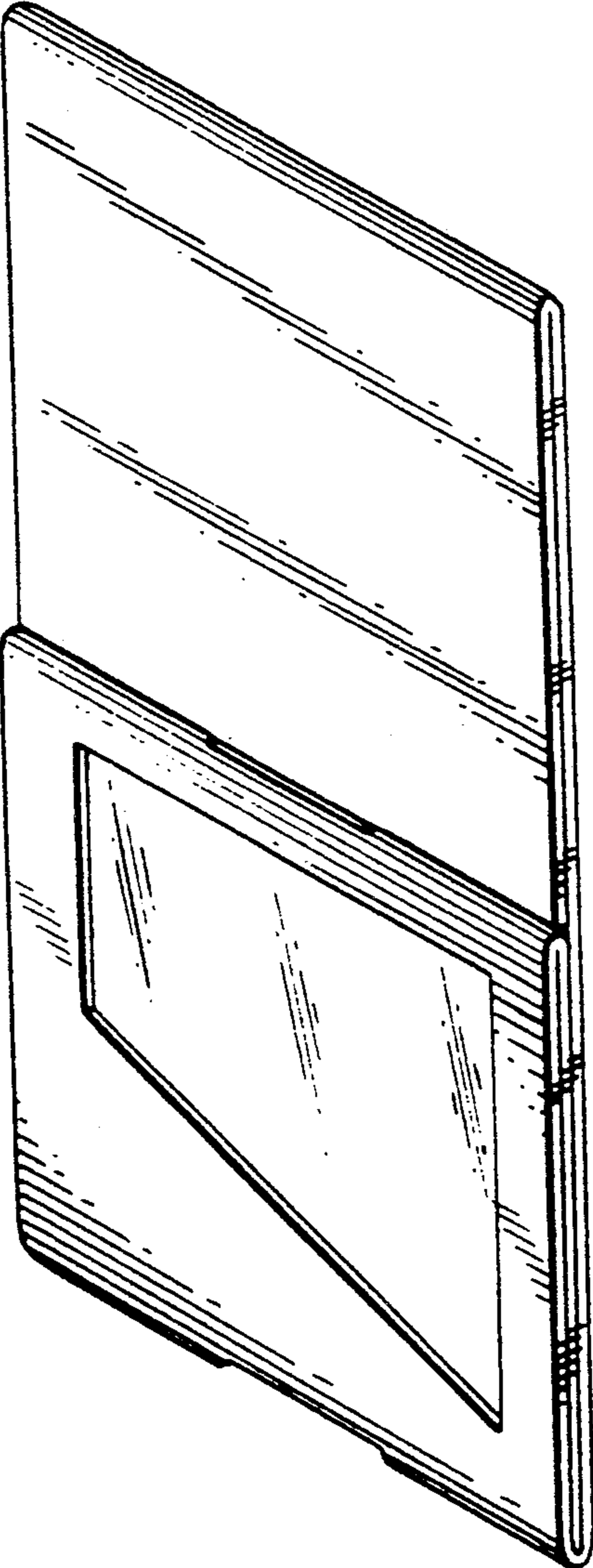

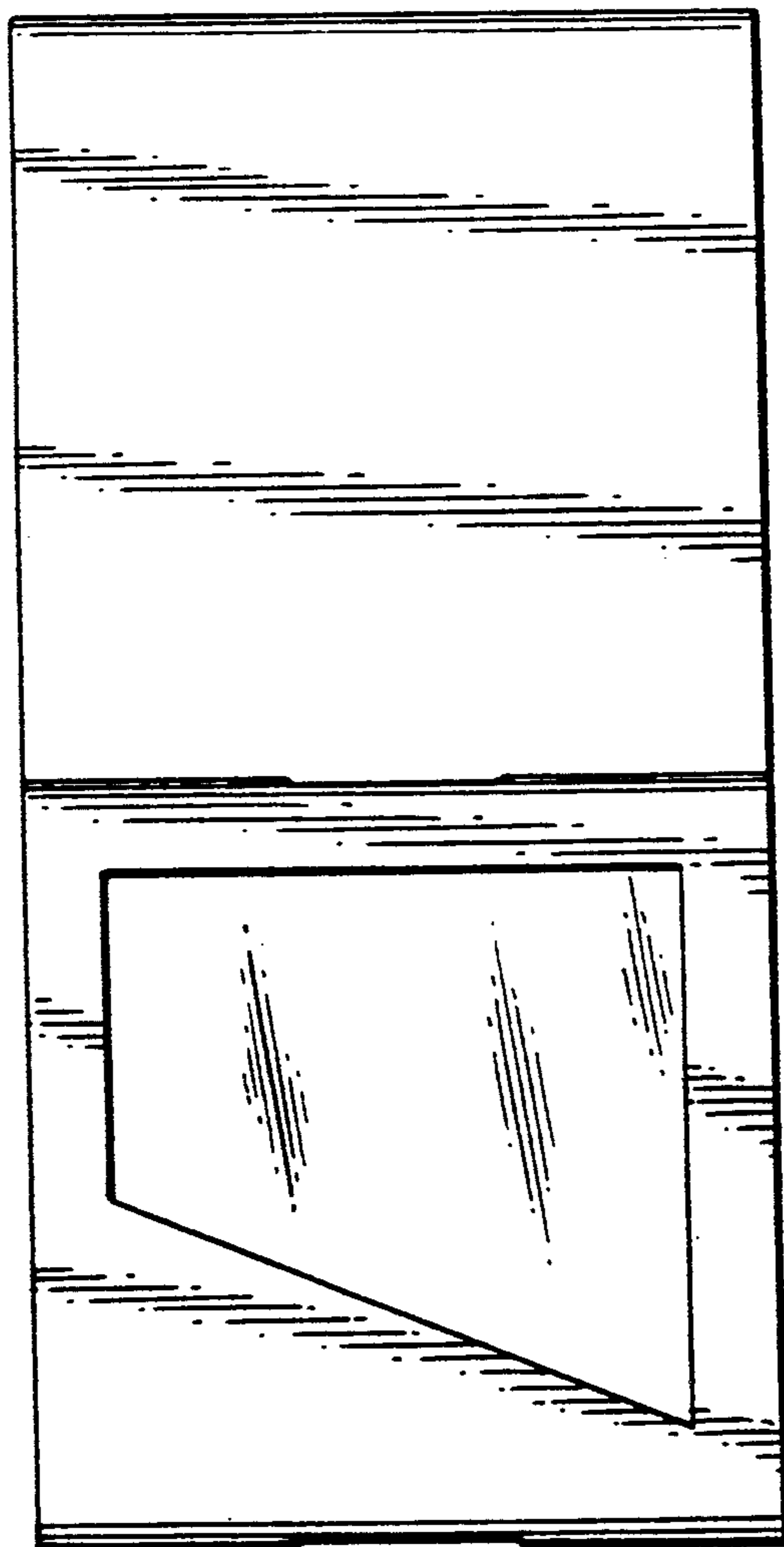

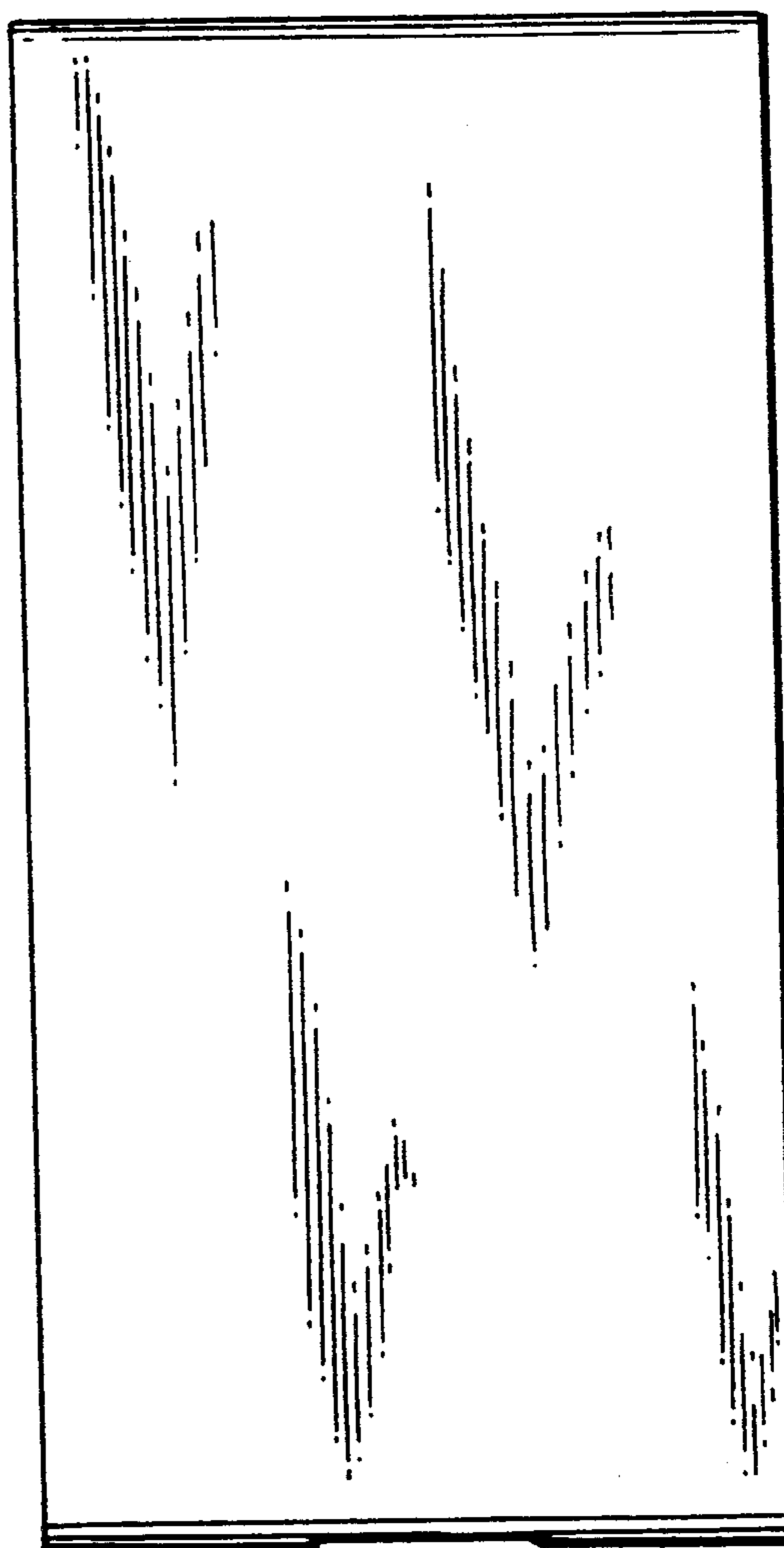

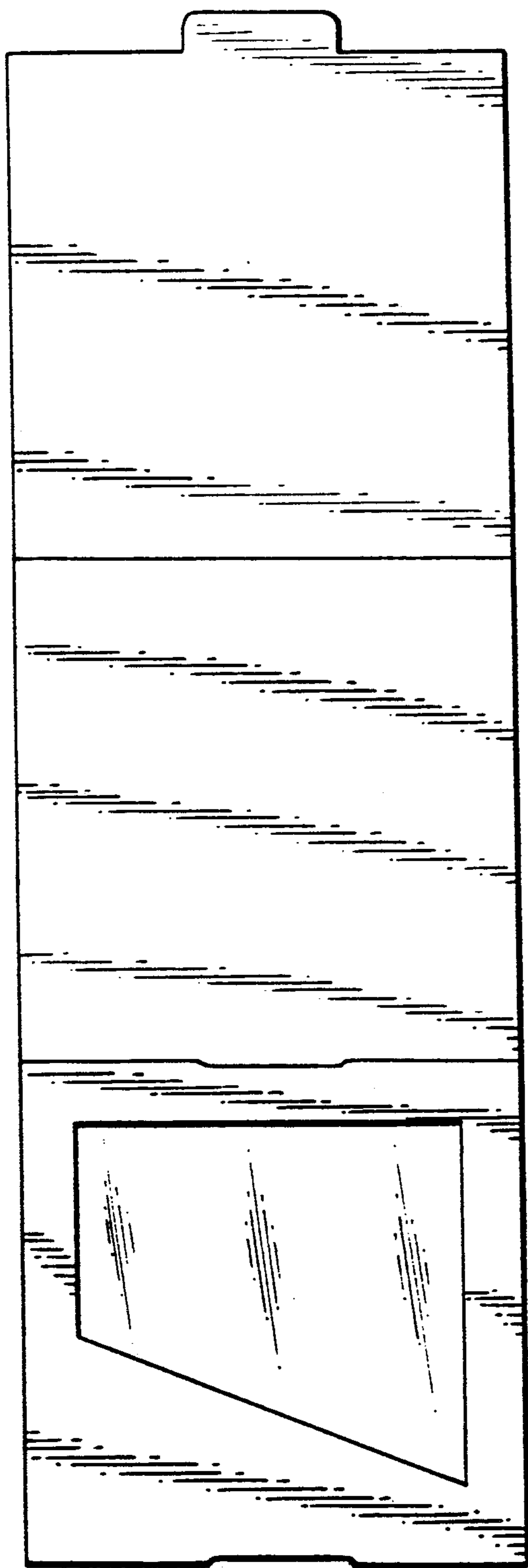

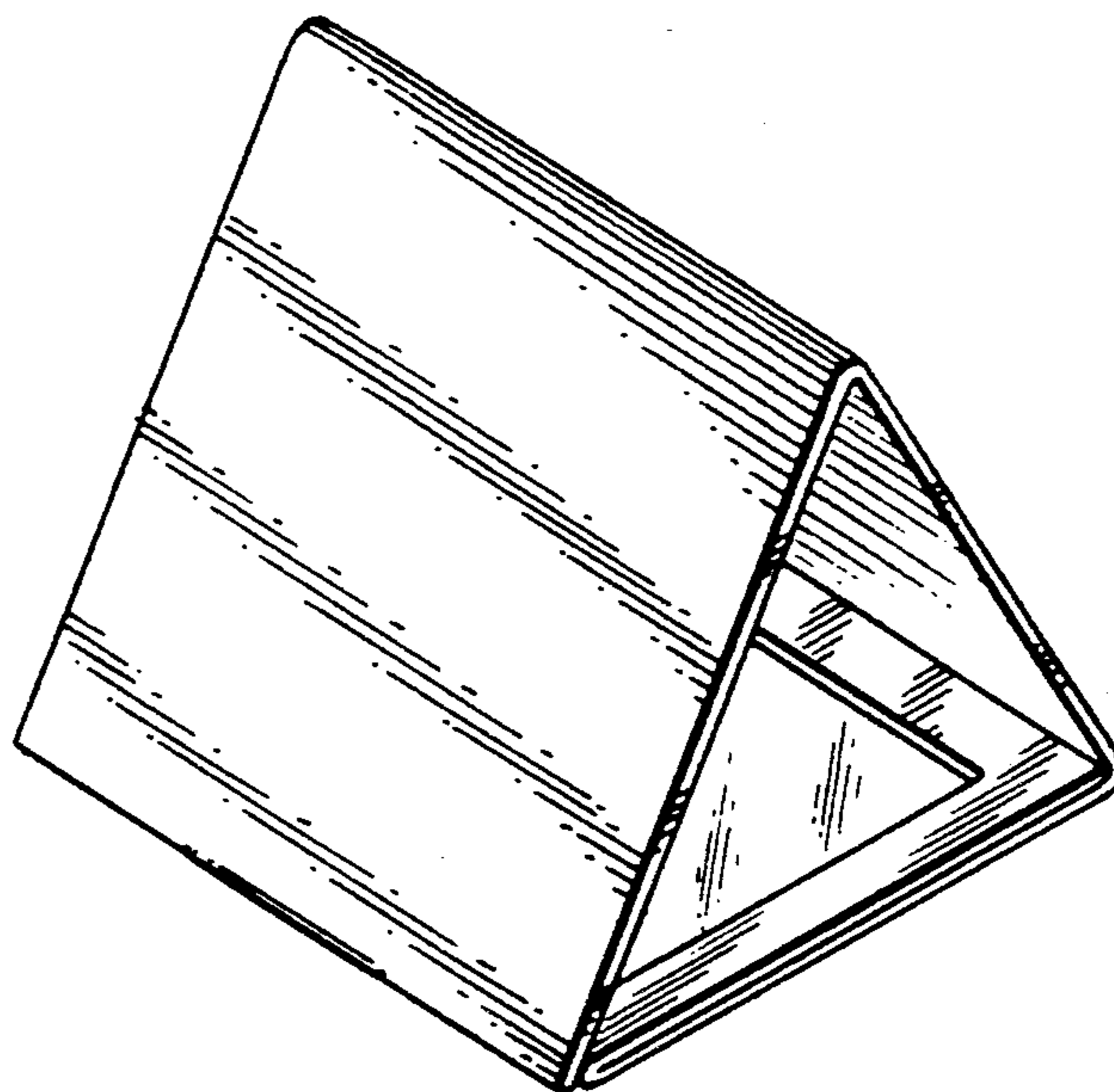
