DESCRIPTION

FIG. 1 is a left side elevational view of a handsaw showing my new design;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is an end elevational view thereof;

FIG. 6 is an opposite end elevational view thereof;

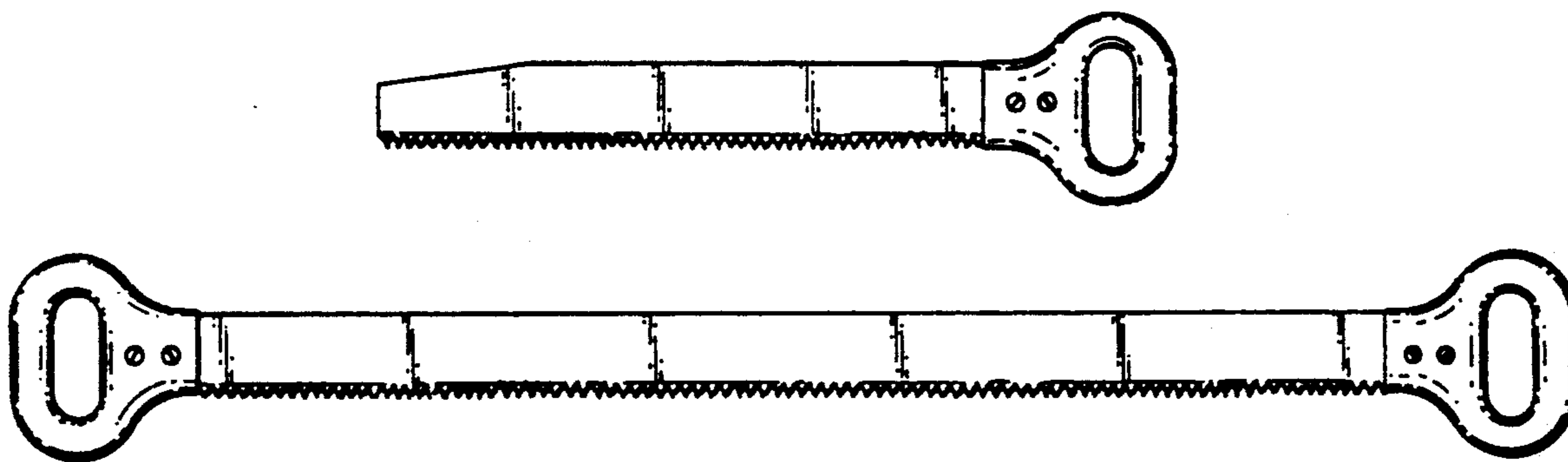
FIG. 7 is a left side elevational view of the second embodiment of FIG. 1 thereof;

FIG. 11 is an end elevational view of the second embodiment, the opposite end being a mirror image thereof.



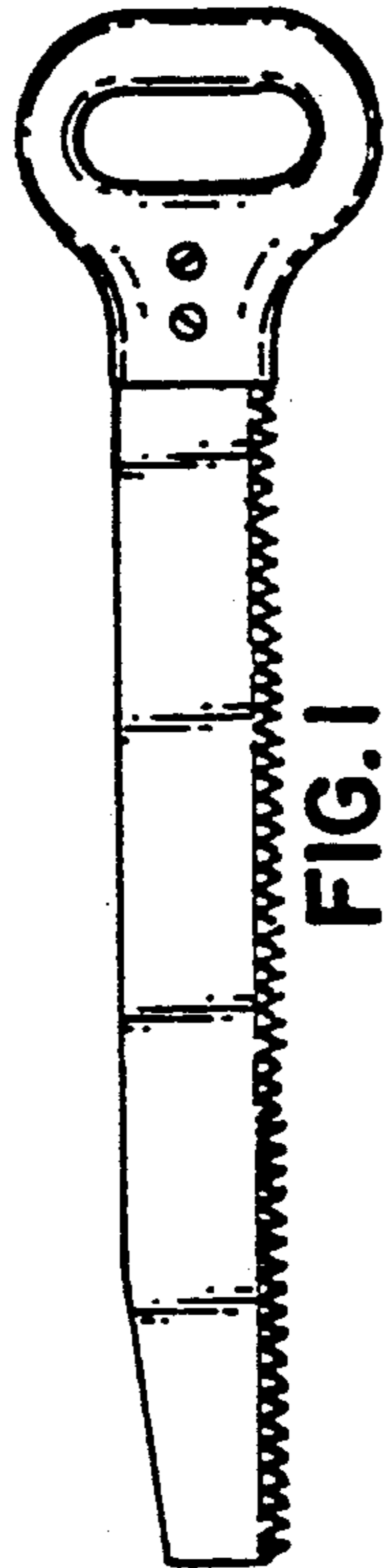

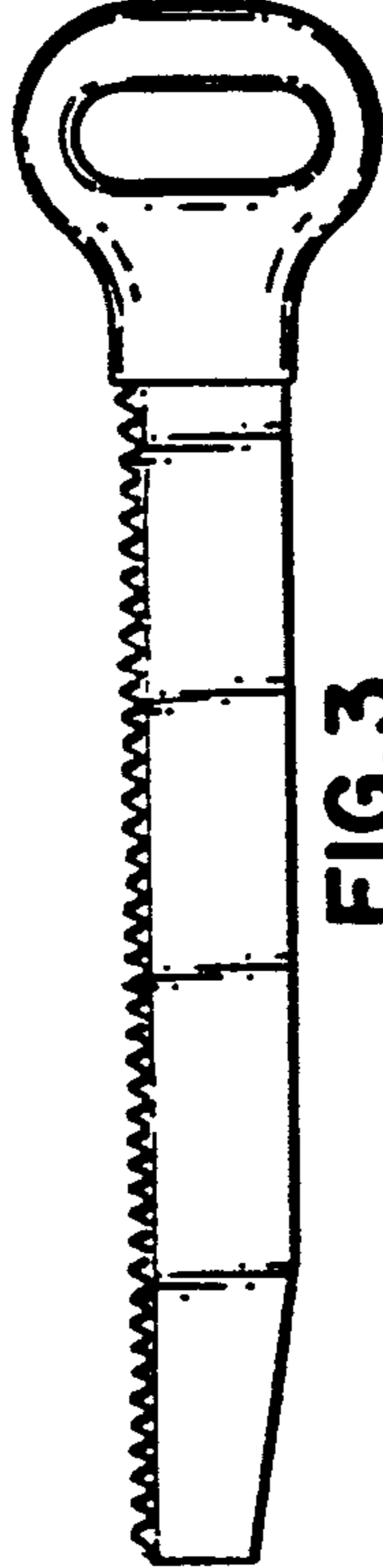

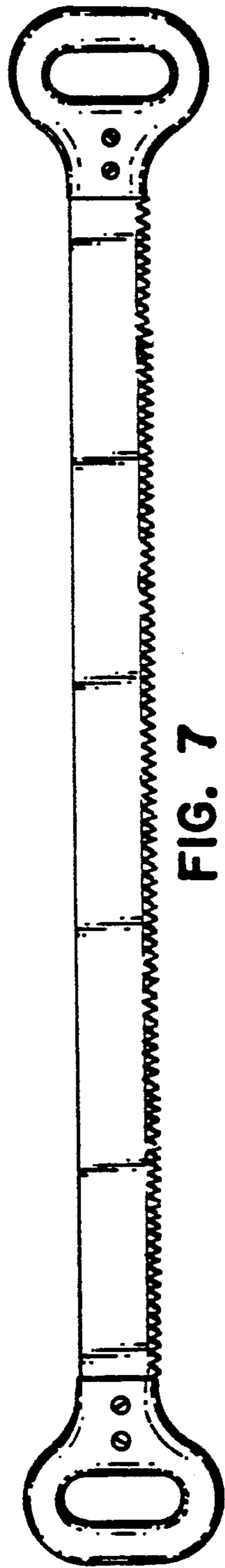

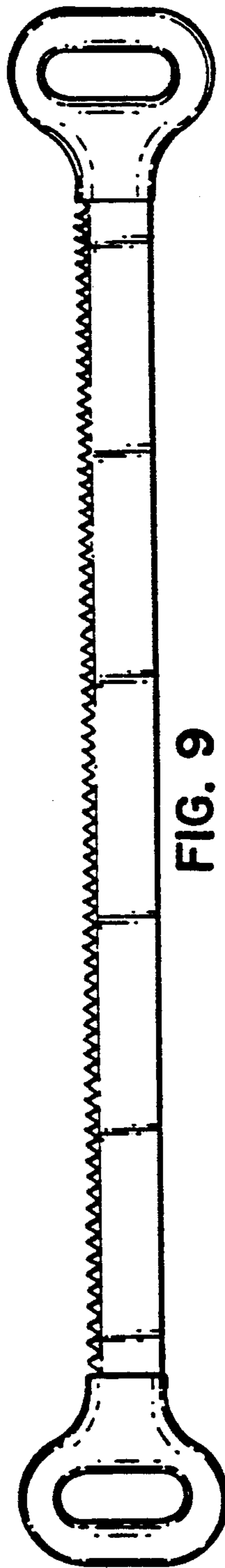
