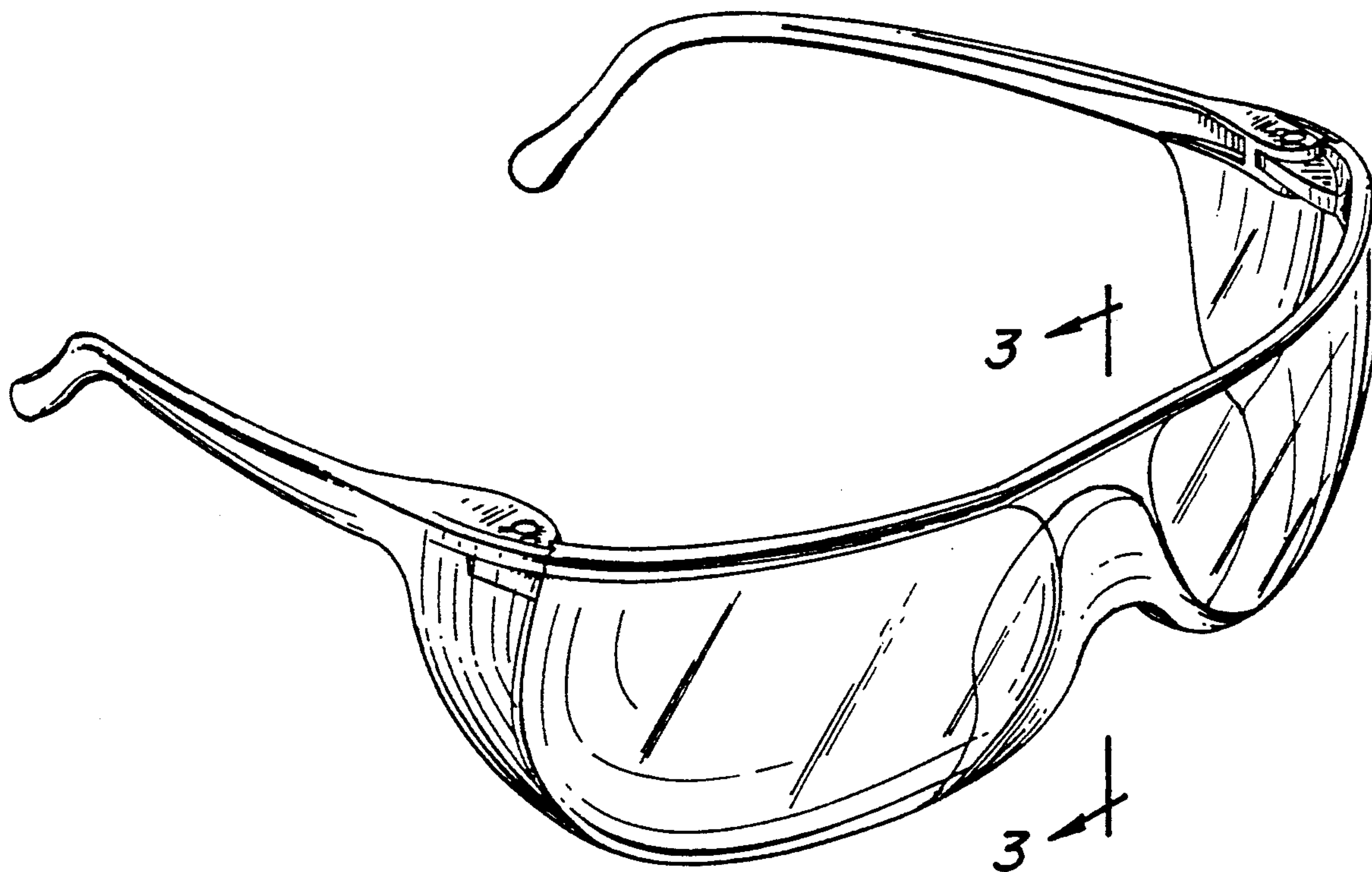

DESCRIPTION

FIG. 1 is a front perspective view of an safety eyeglasses showing my new design;  
FIG. 2 is a side elevation view thereof;  
FIG. 3 is a vertical sectional elevation view thereof, taken along the line 3—3 of FIG. 1;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a front elevation view thereof;

FIG. 7 is a bottom plan view thereof.



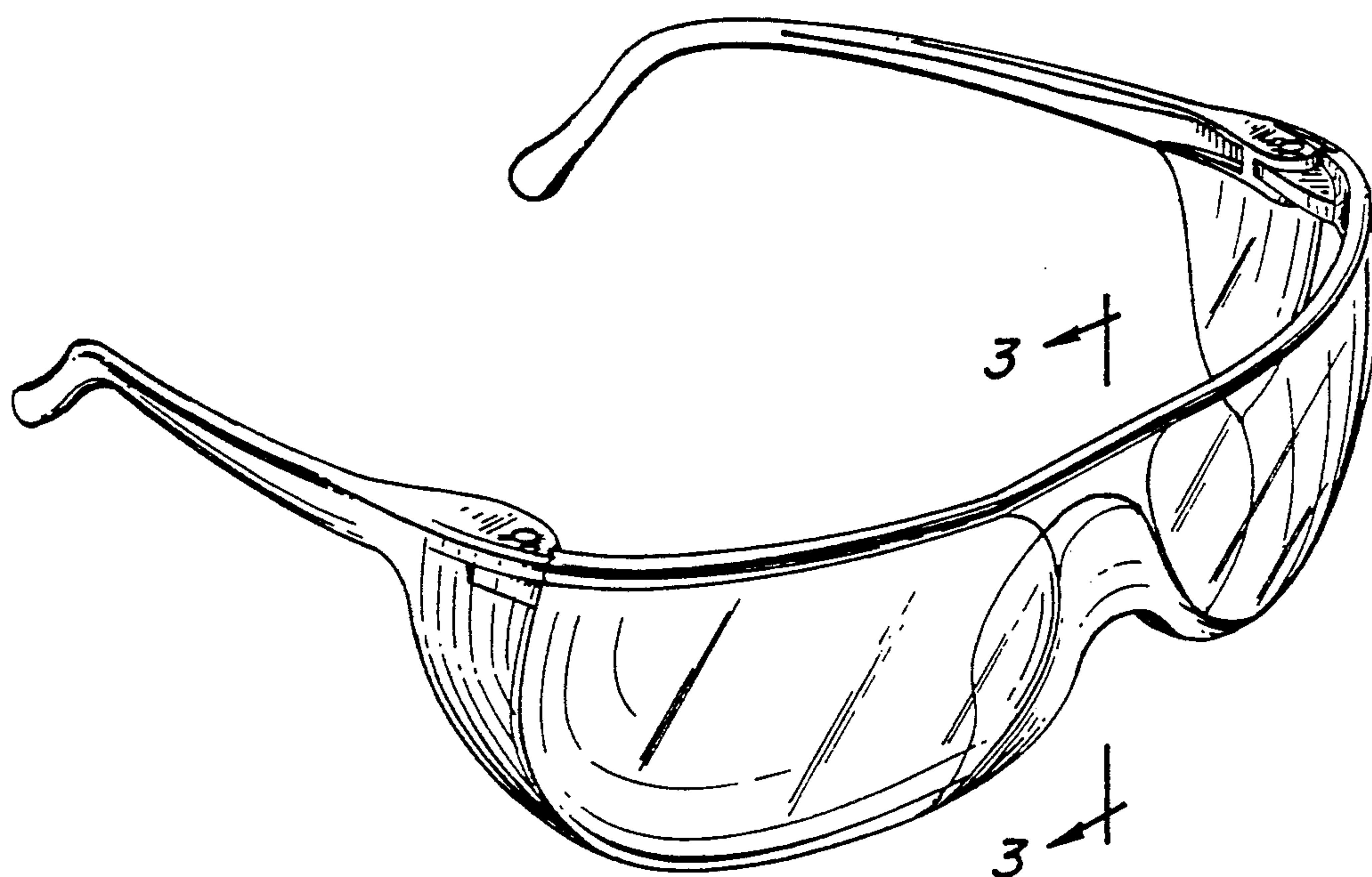

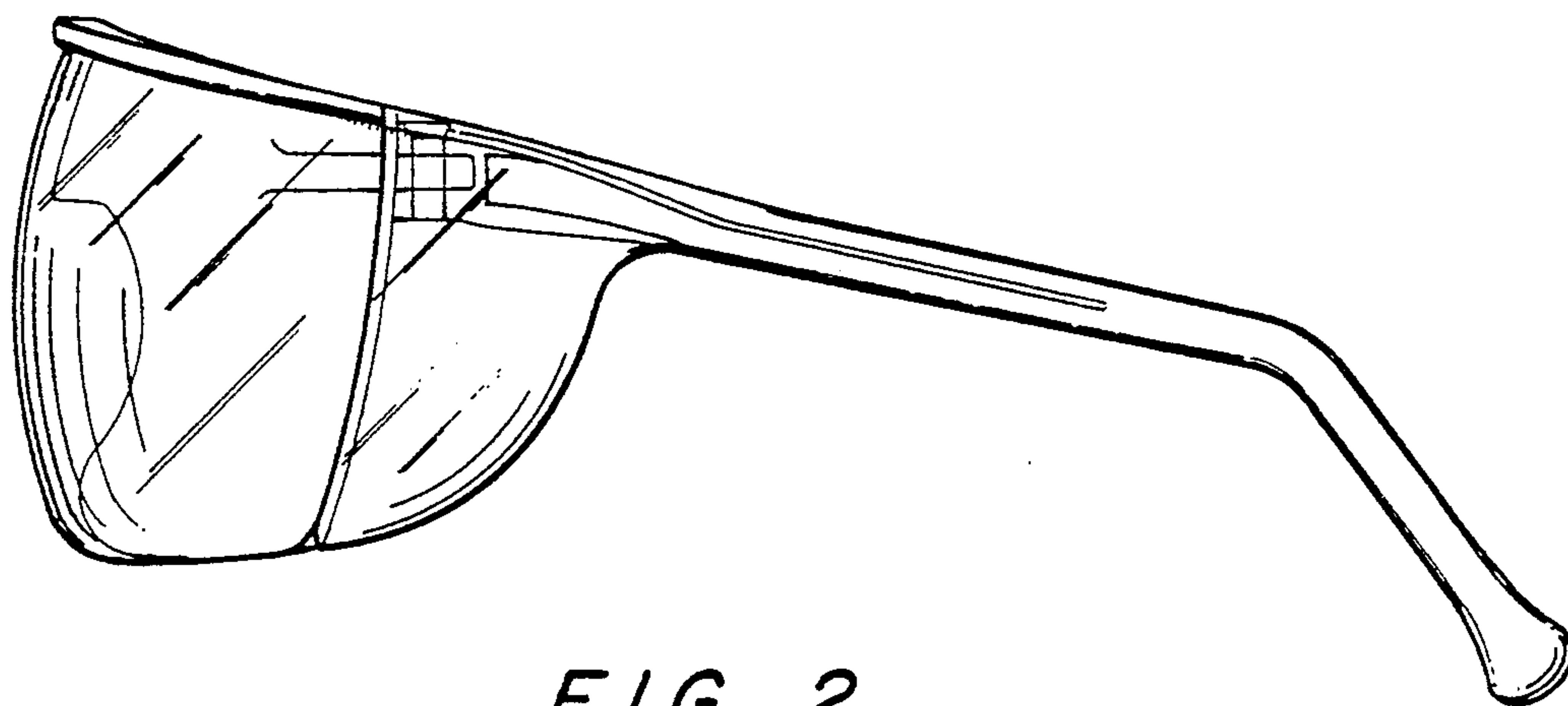

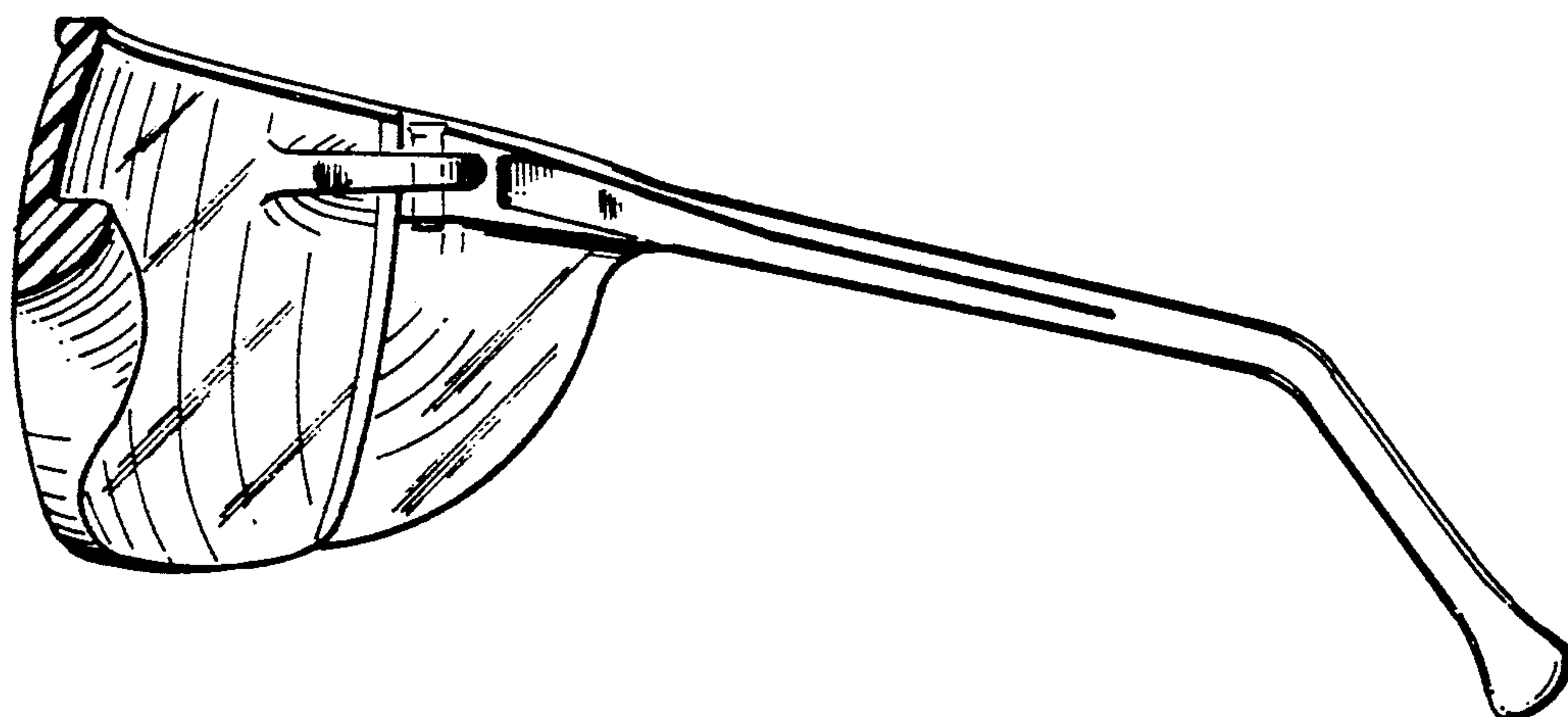

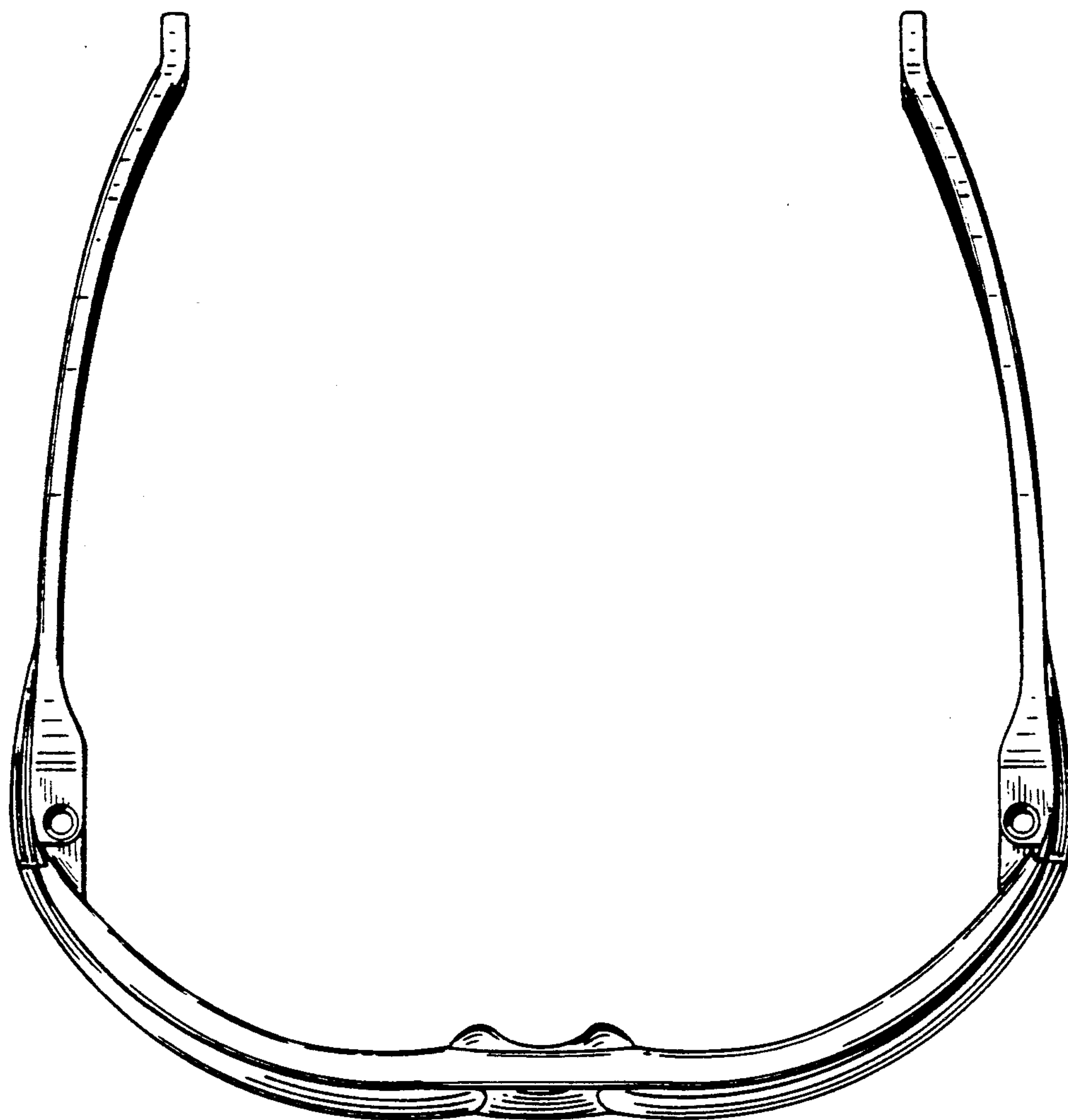

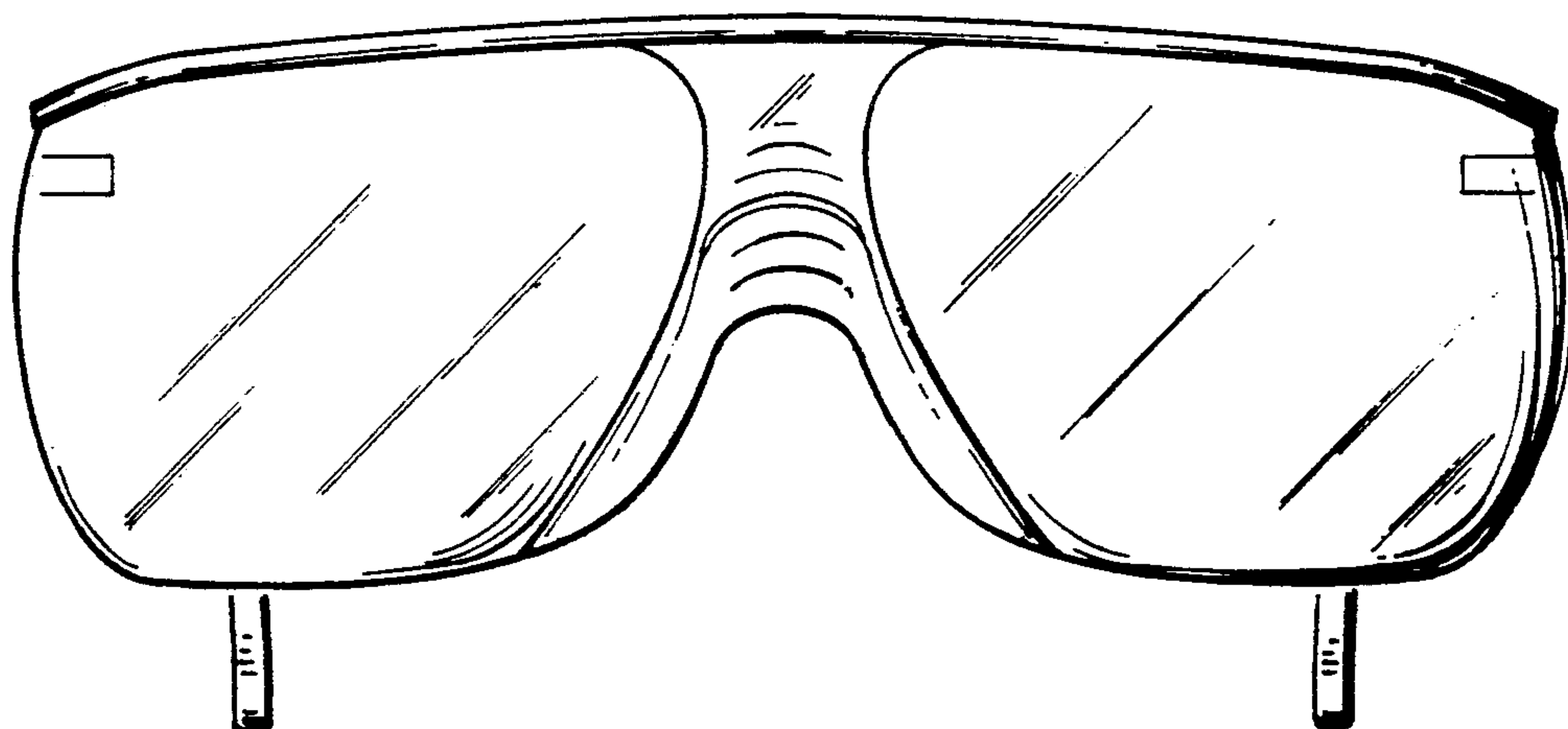

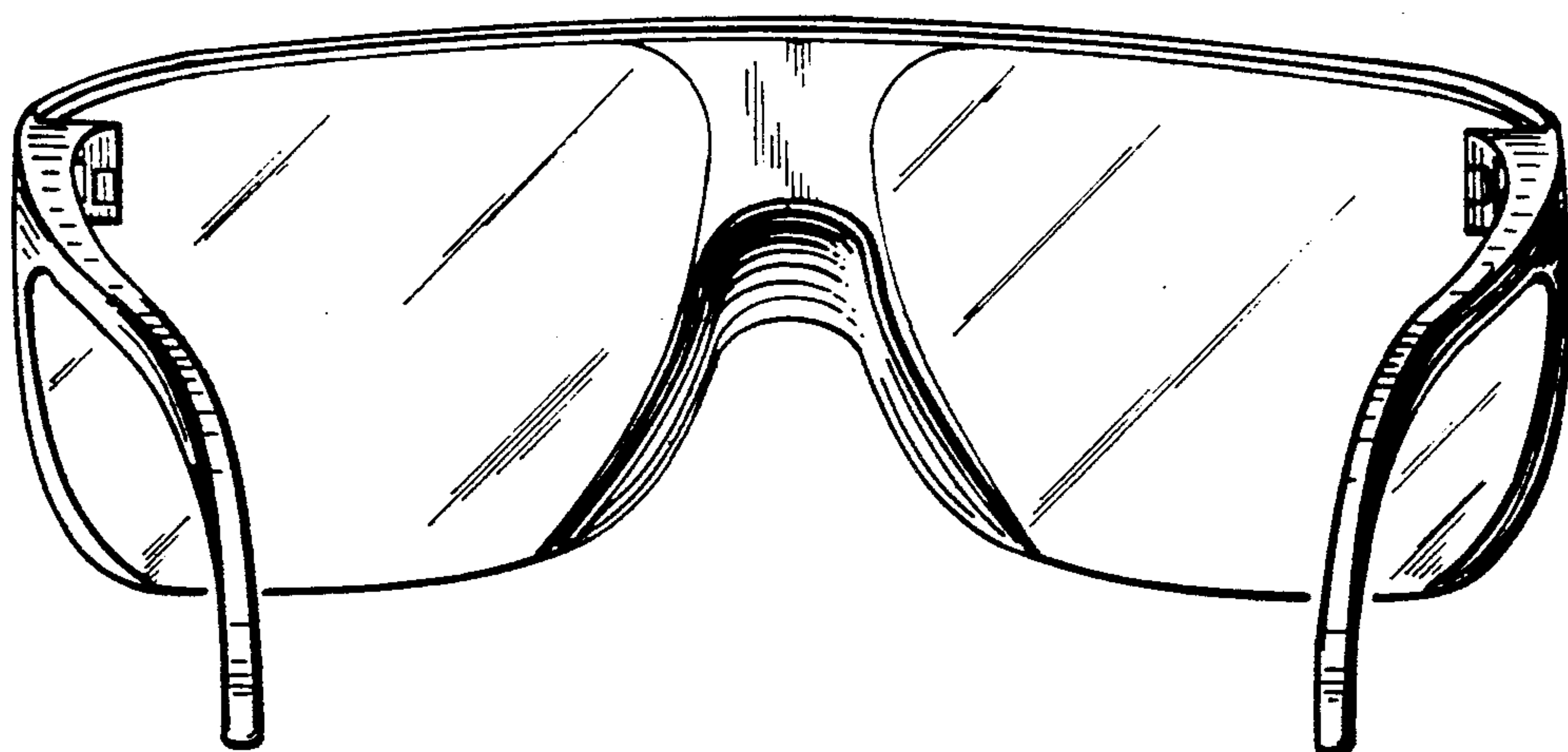

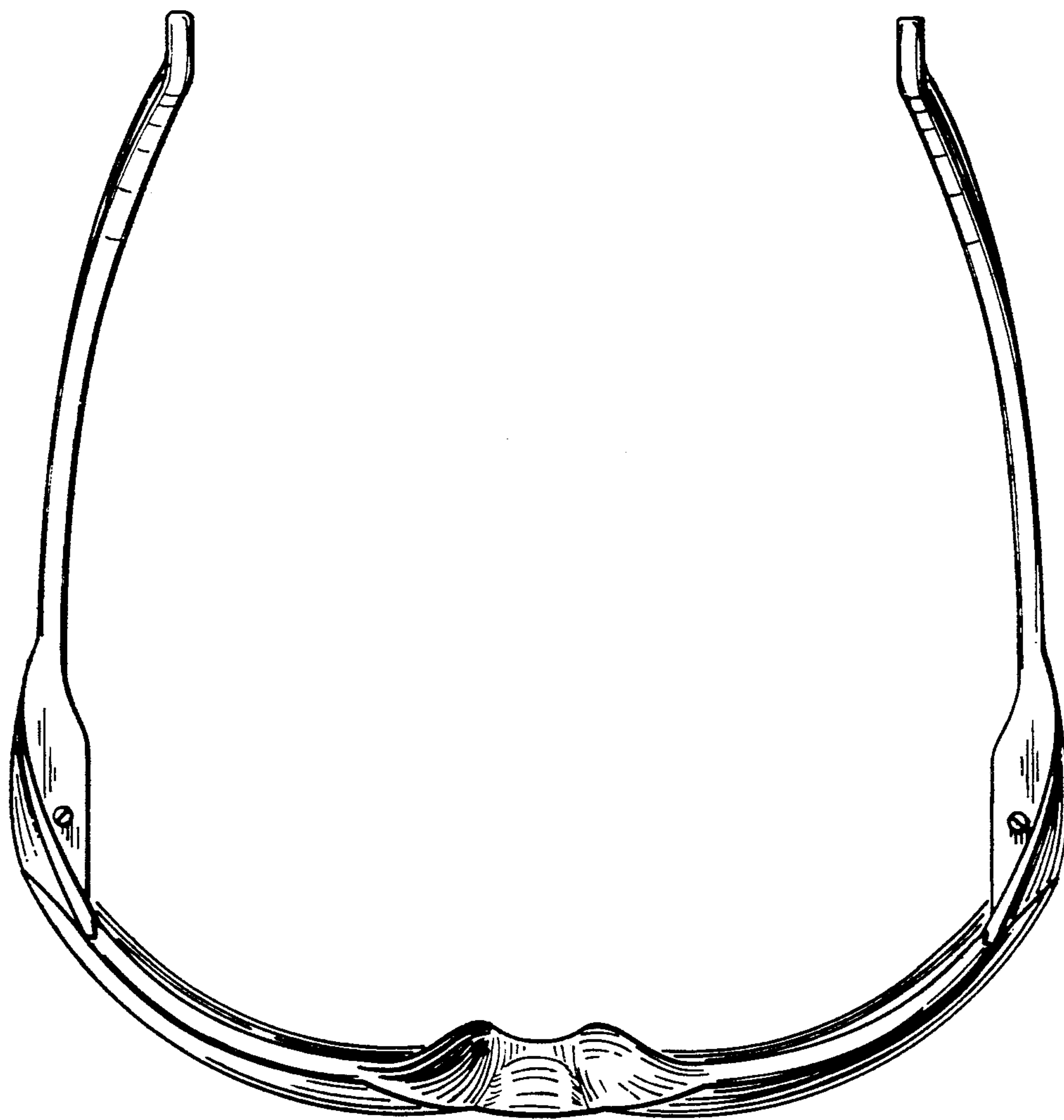
