The ornamental design for a hand-held electronic game or the like, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation of a hand-held electronic game or the like showing my new design;  
FIG. 2 is a rear side elevation thereof;  
FIG. 3 is a left side elevation thereof, the right side elevation being a mirror image thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof; and  
FIG. 6 is a perspective view thereof.

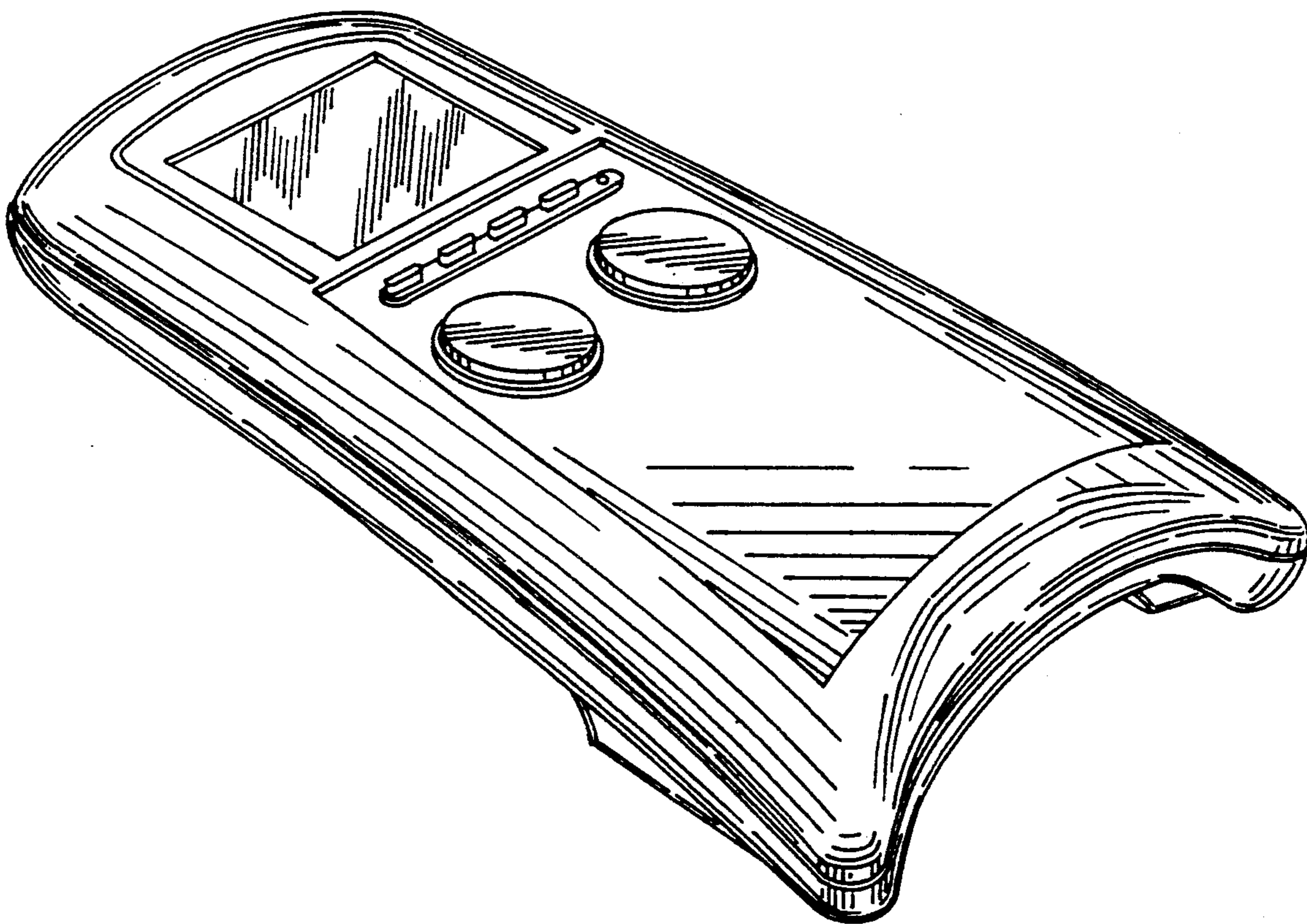

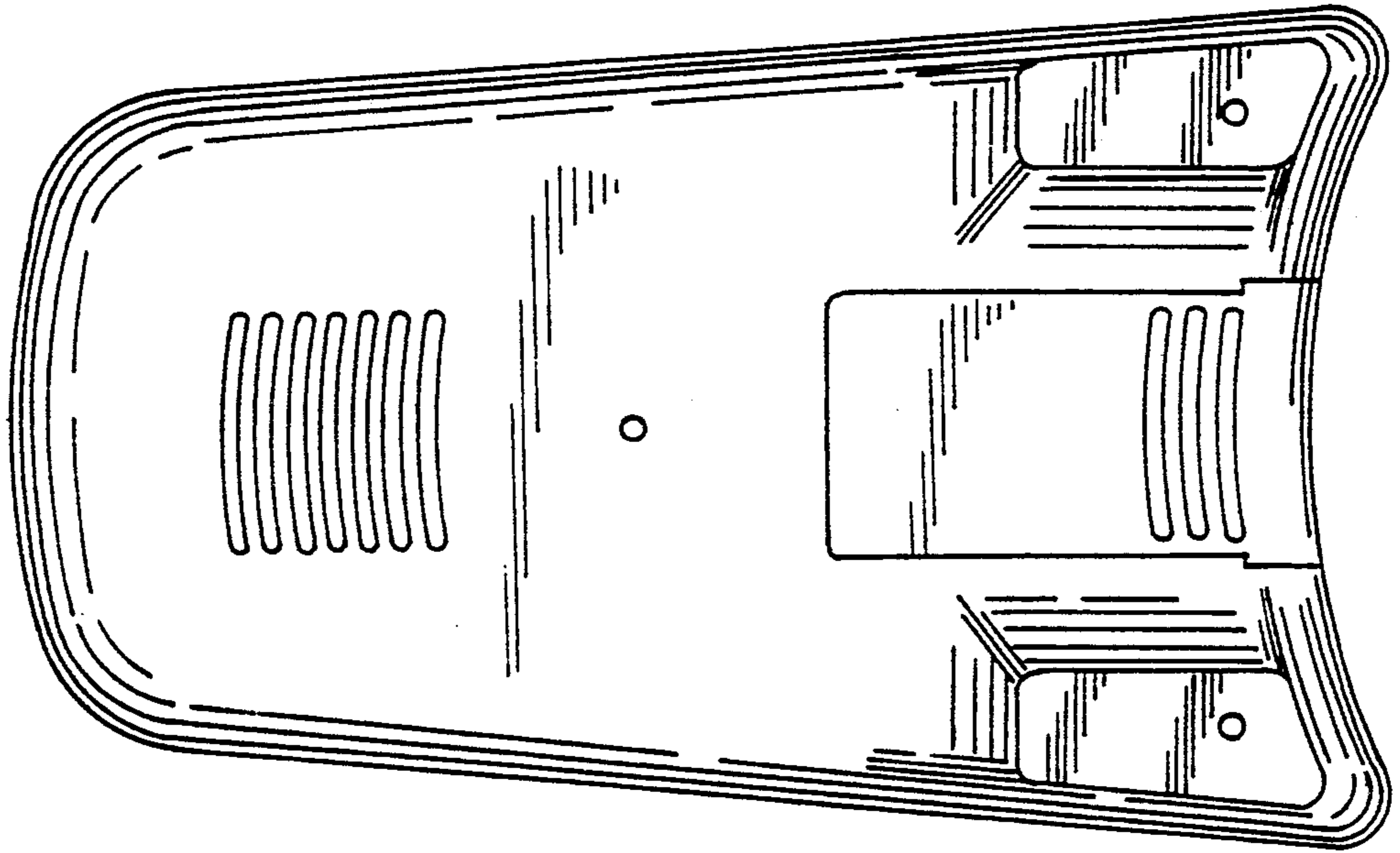

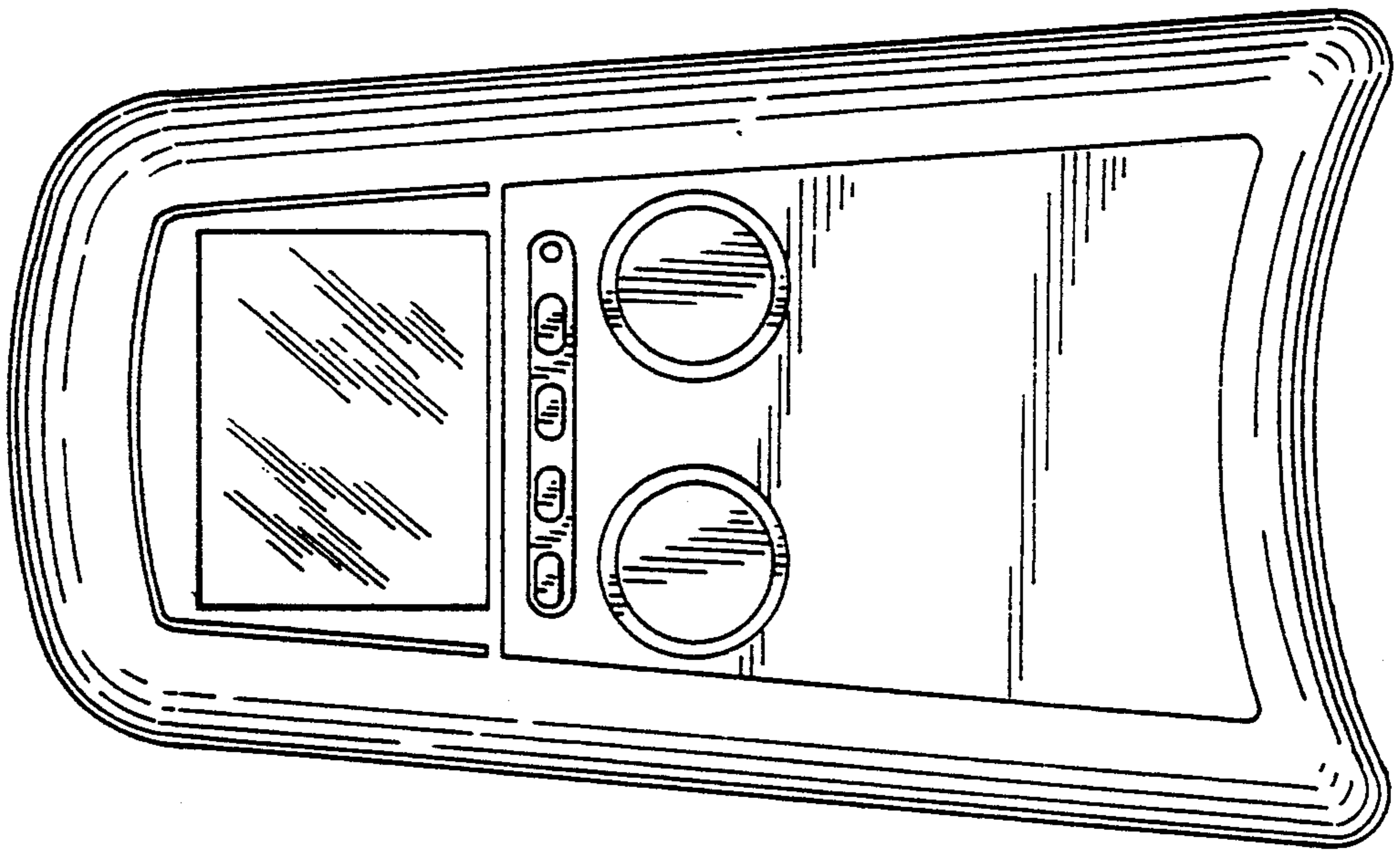

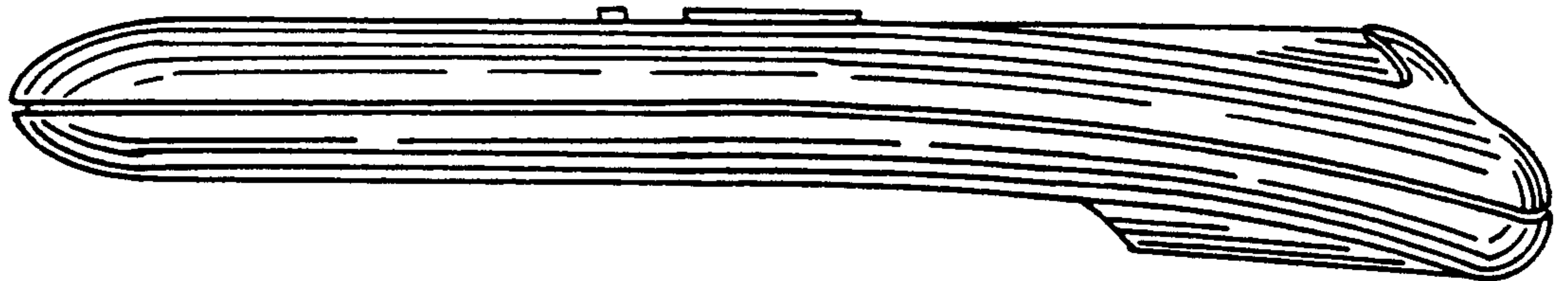

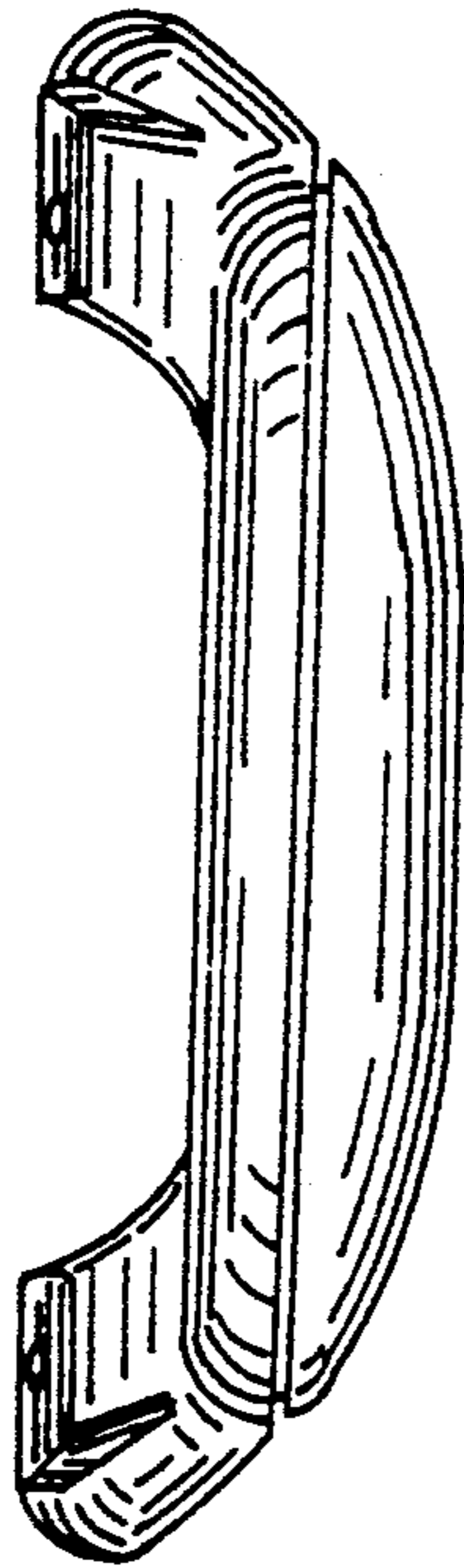
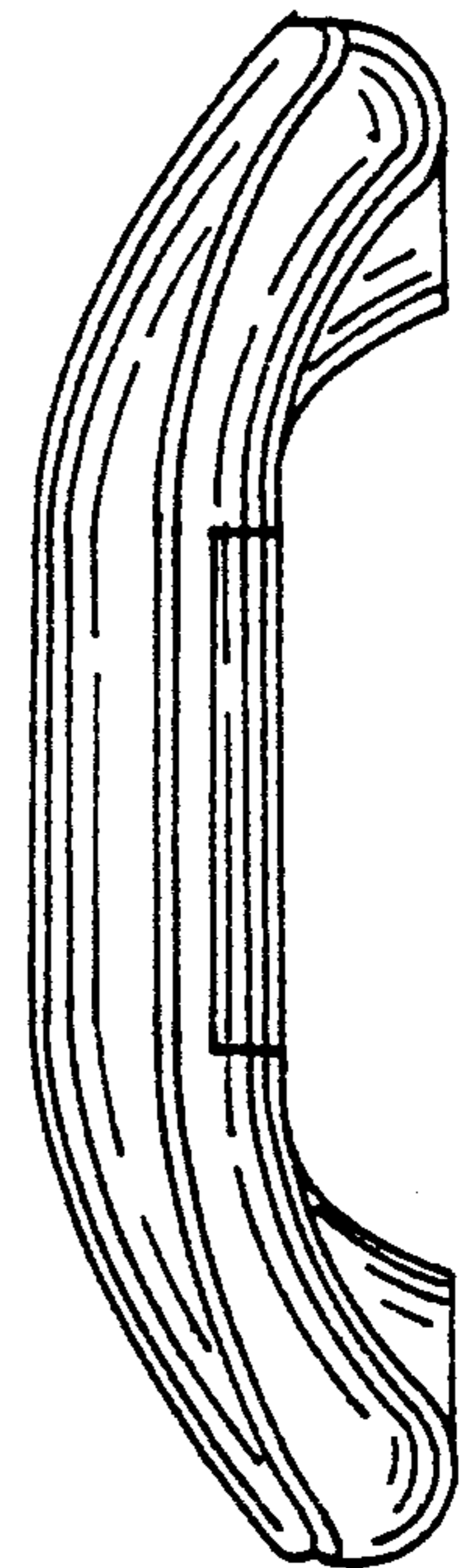

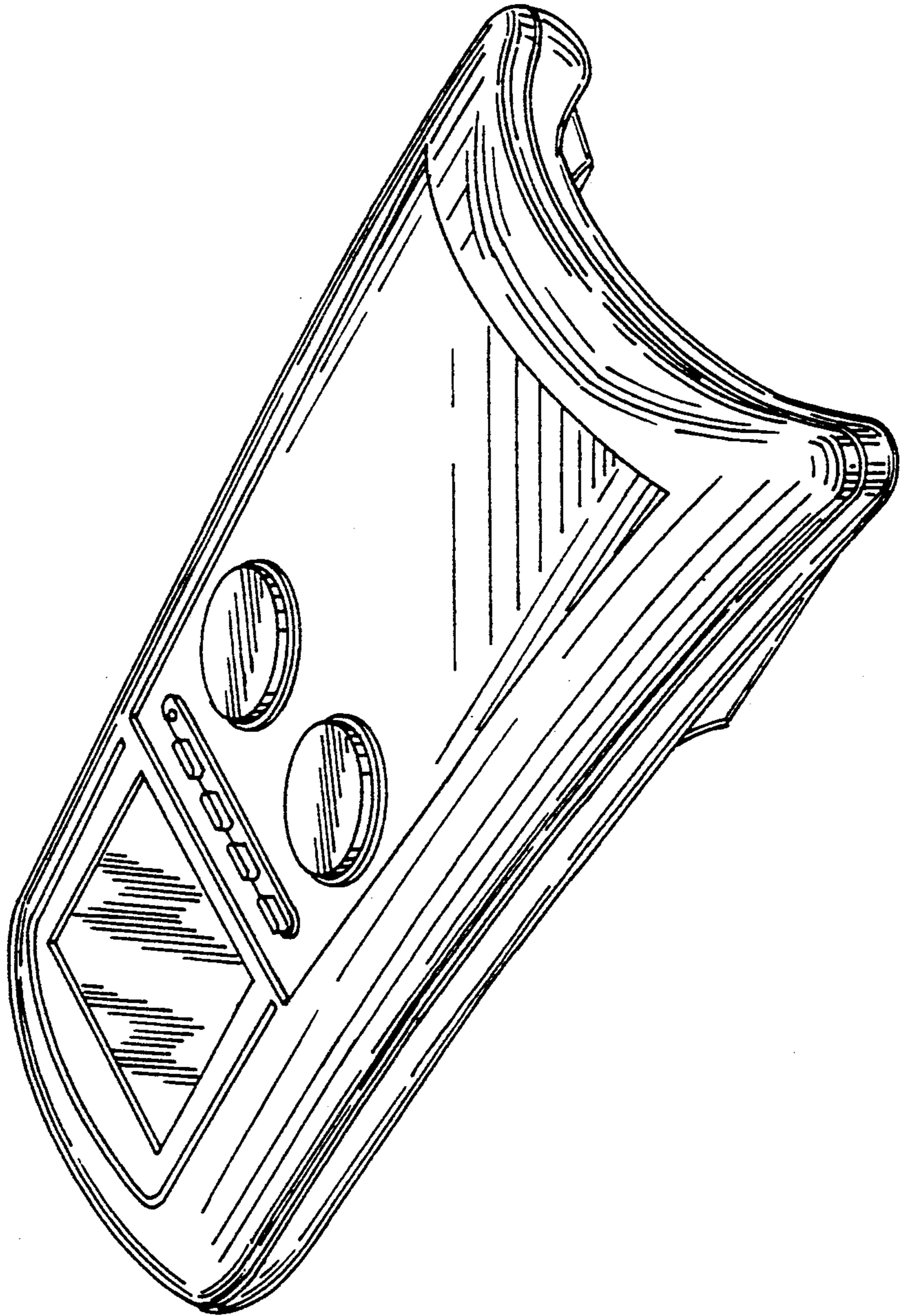
