[57] CLAIM

The ornamental design for clip-hanger for suspending articles from walls, as shown and described.

DESCRIPTION

FIG. 1 is a bottom, front and right side perspective view of a clip-hanger for suspending articles from walls showing our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a top plan view of a second embodiment thereof;

FIG. 9 is a left side elevational view thereof;

FIG. 10 is a front elevational view thereof;

FIG. 11 is a right side elevational view thereof;

FIG. 12 is a rear elevational view thereof; and

FIG. 13 is a bottom plan view thereof.

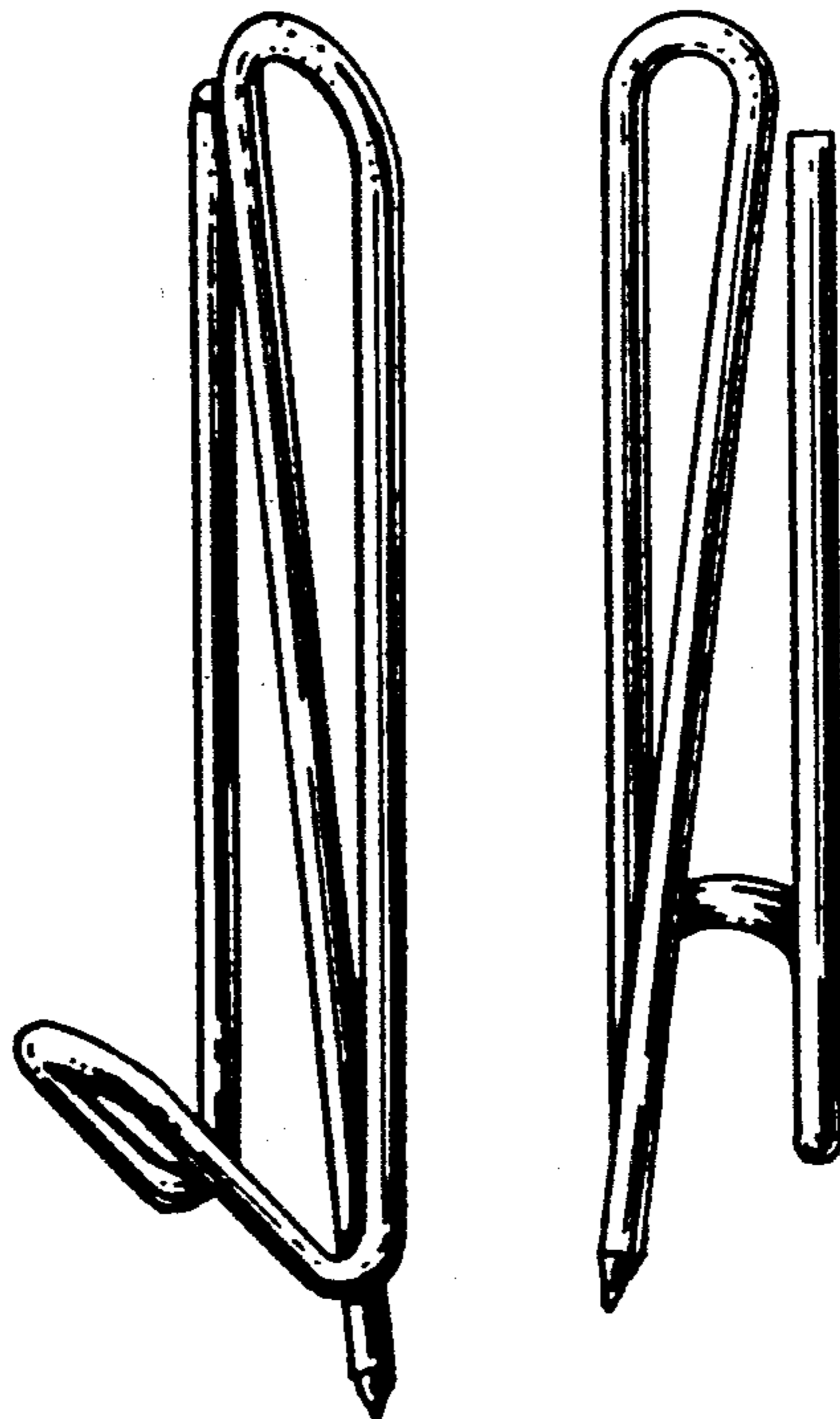

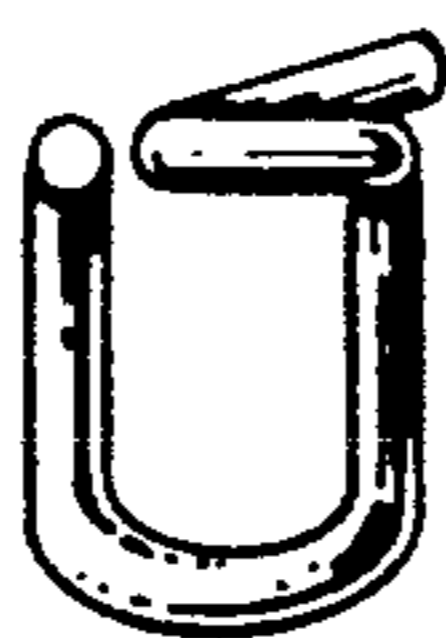

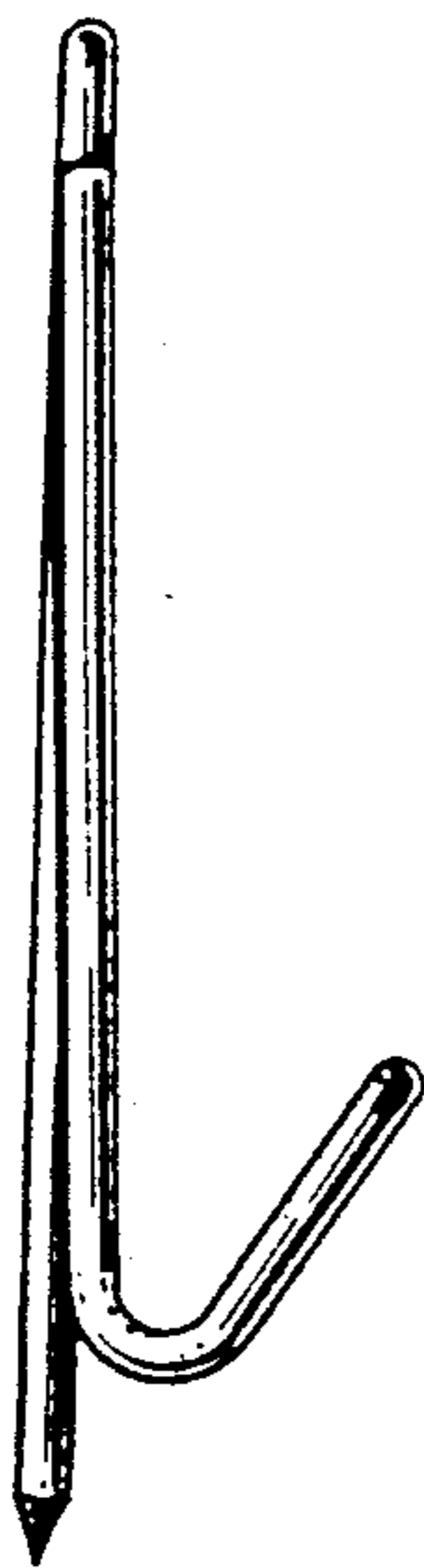

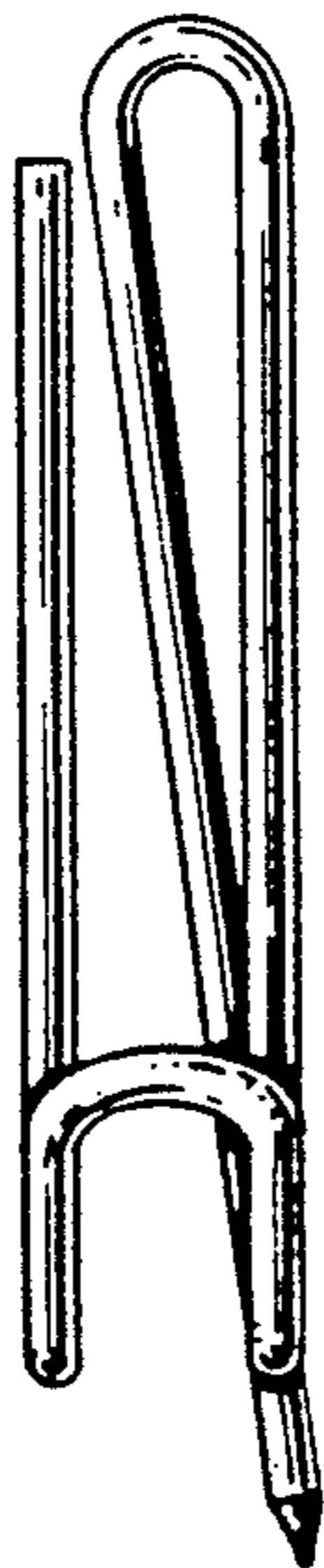

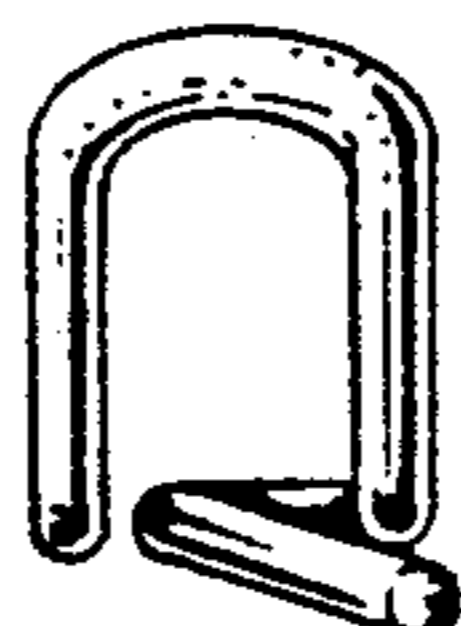

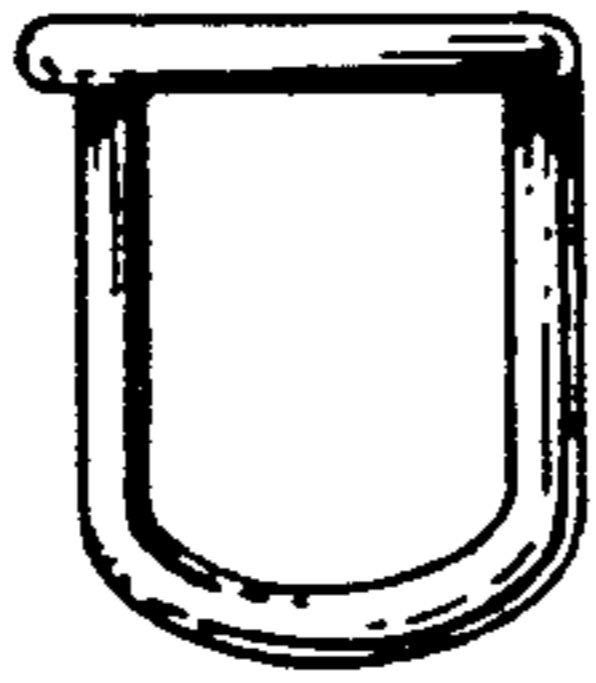

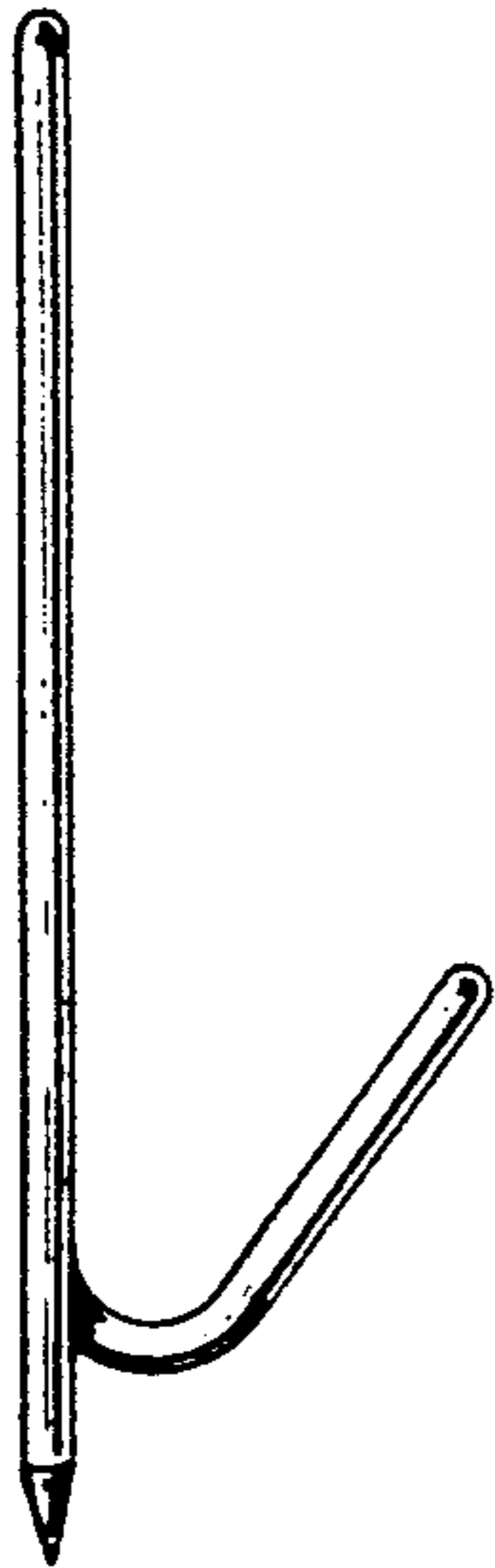

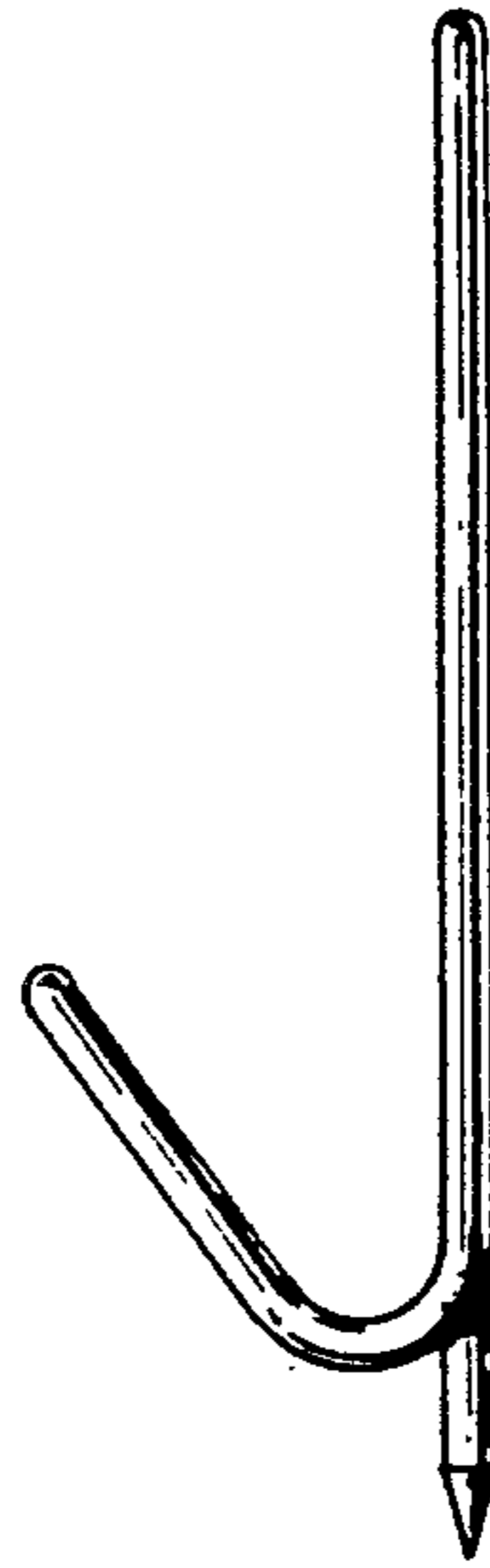

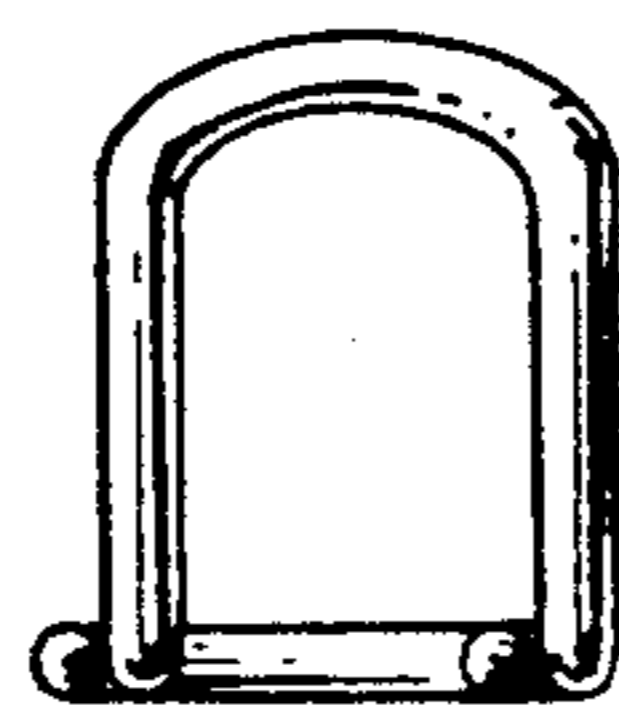
