FIG. 1 is a perspective view of a gem setting showing my new design;

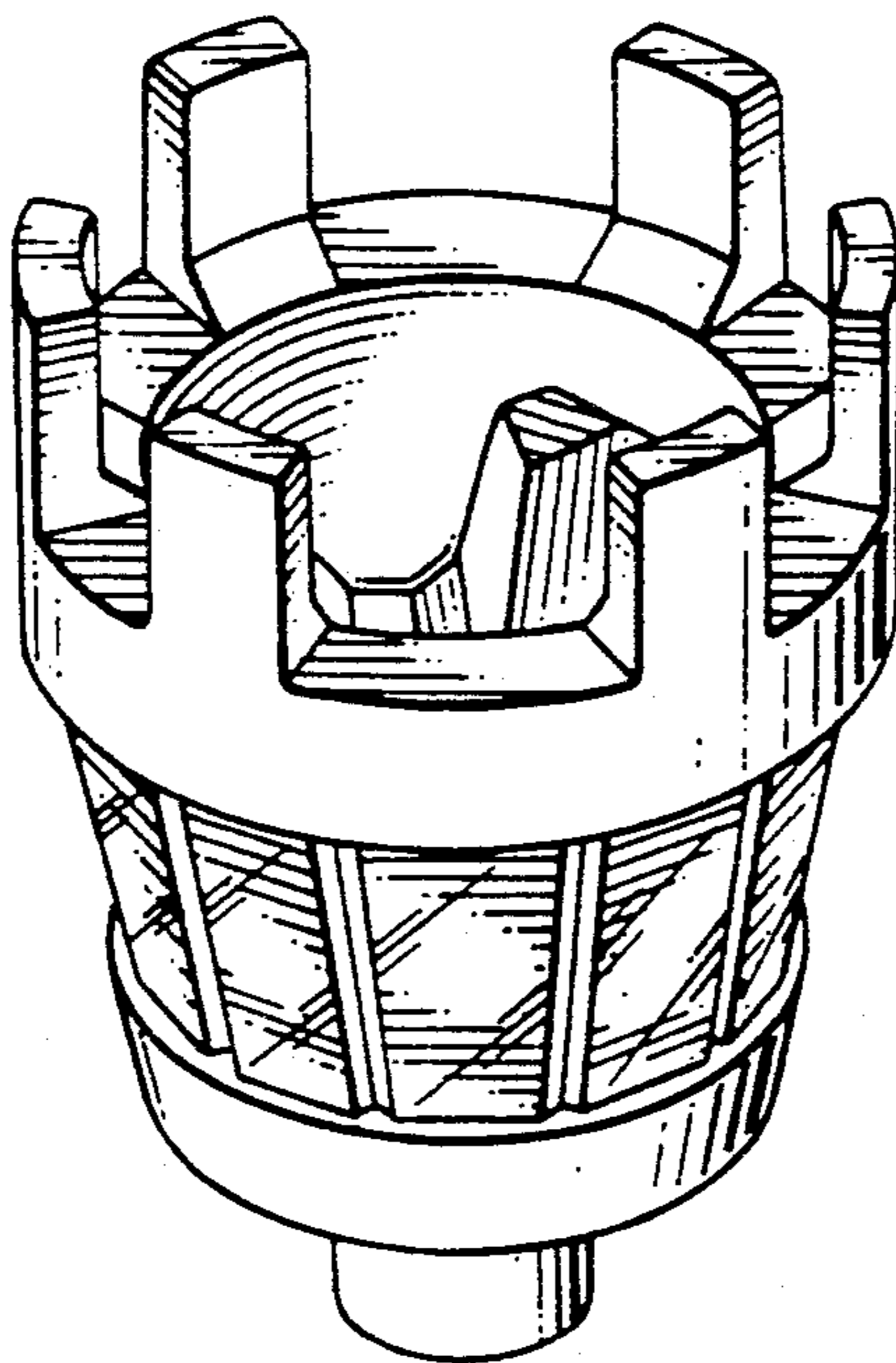
FIG. 2 is a side elevational view;

FIG. 3 is an end elevational view;

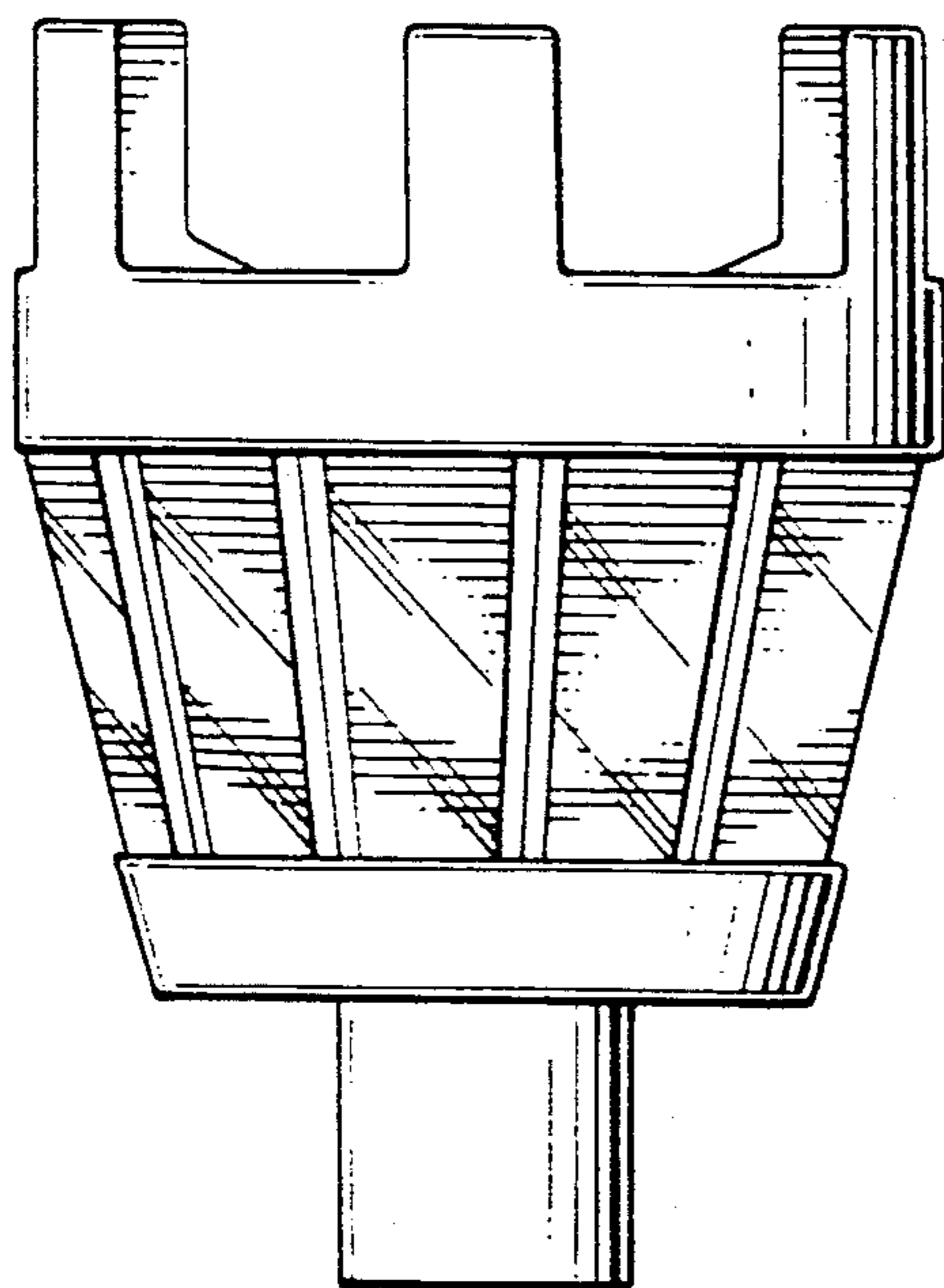
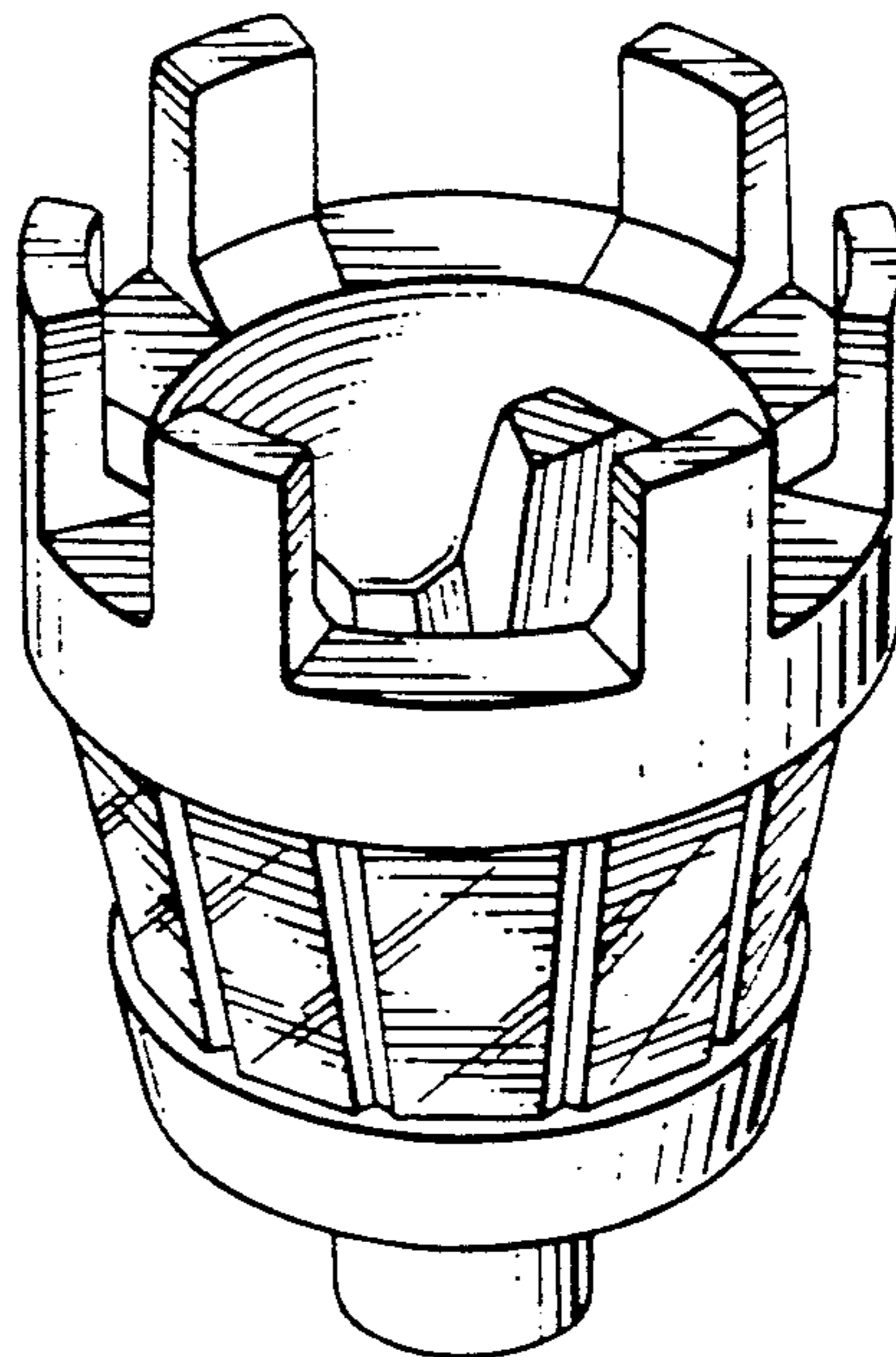
FIG. 4 is a top plan view;

FIG. 6 is a side elevational view, the broken line showing of a gem and finger ring is for illustrative purposes only and forms no part of the claimed design.

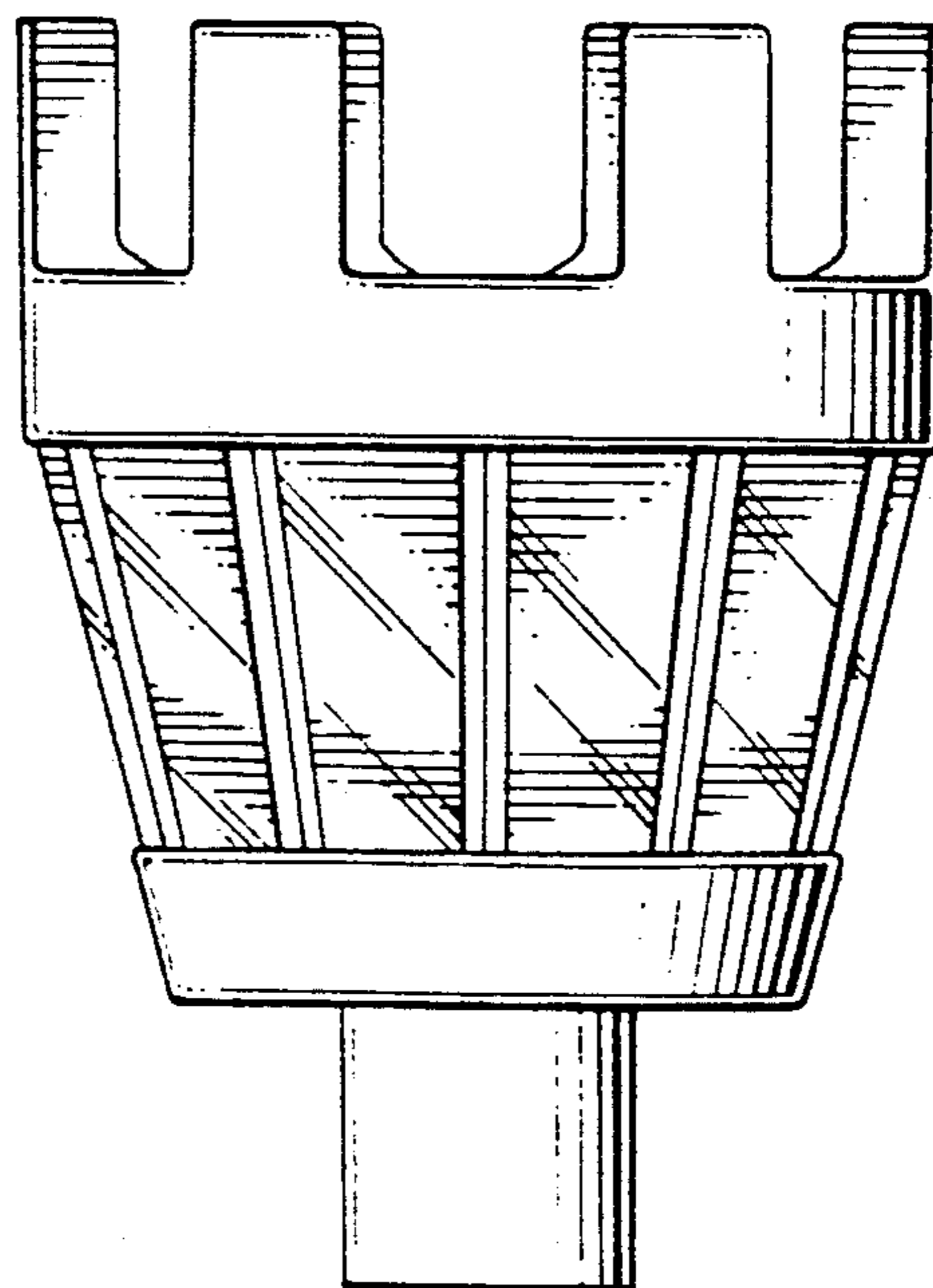

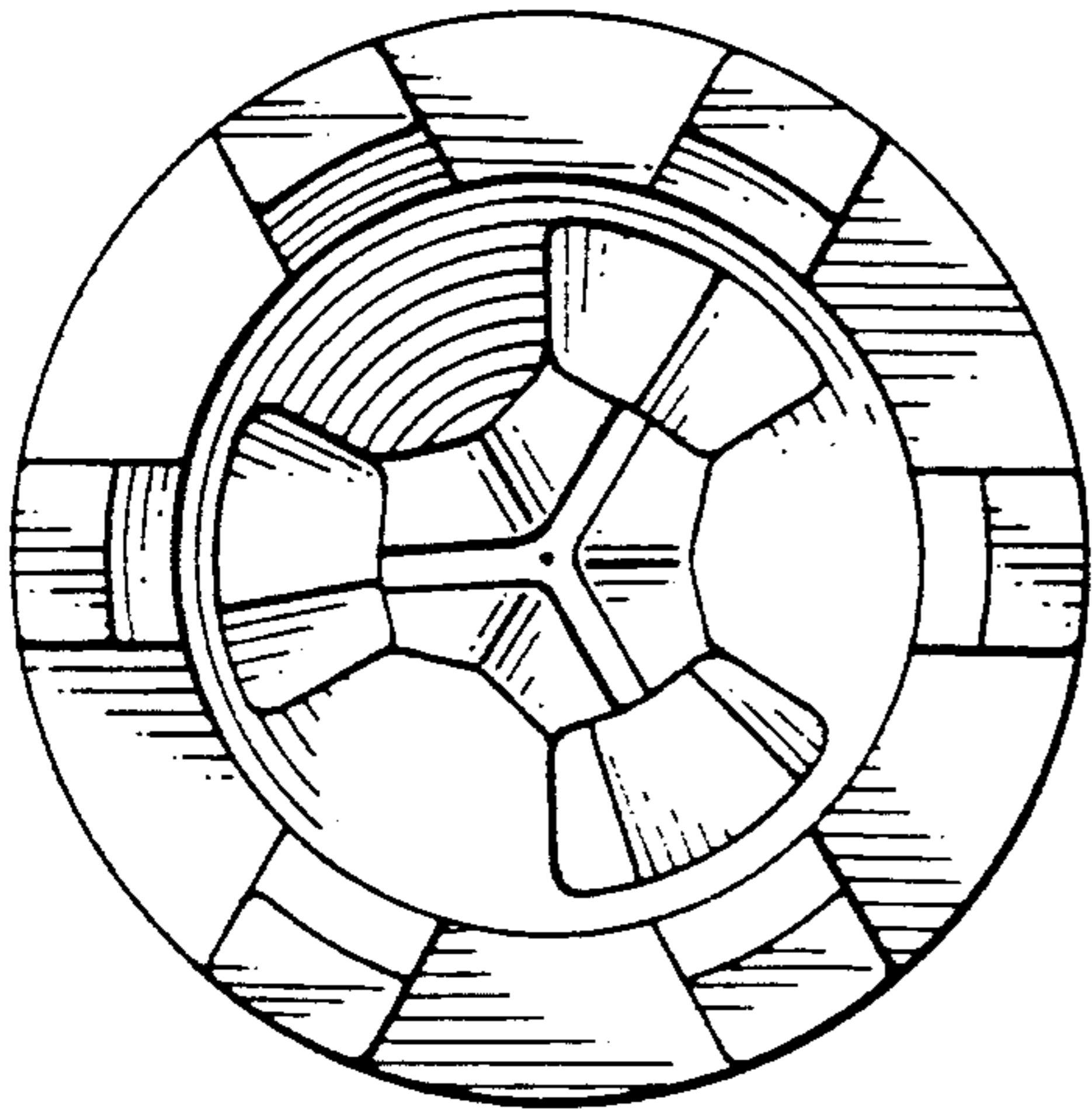

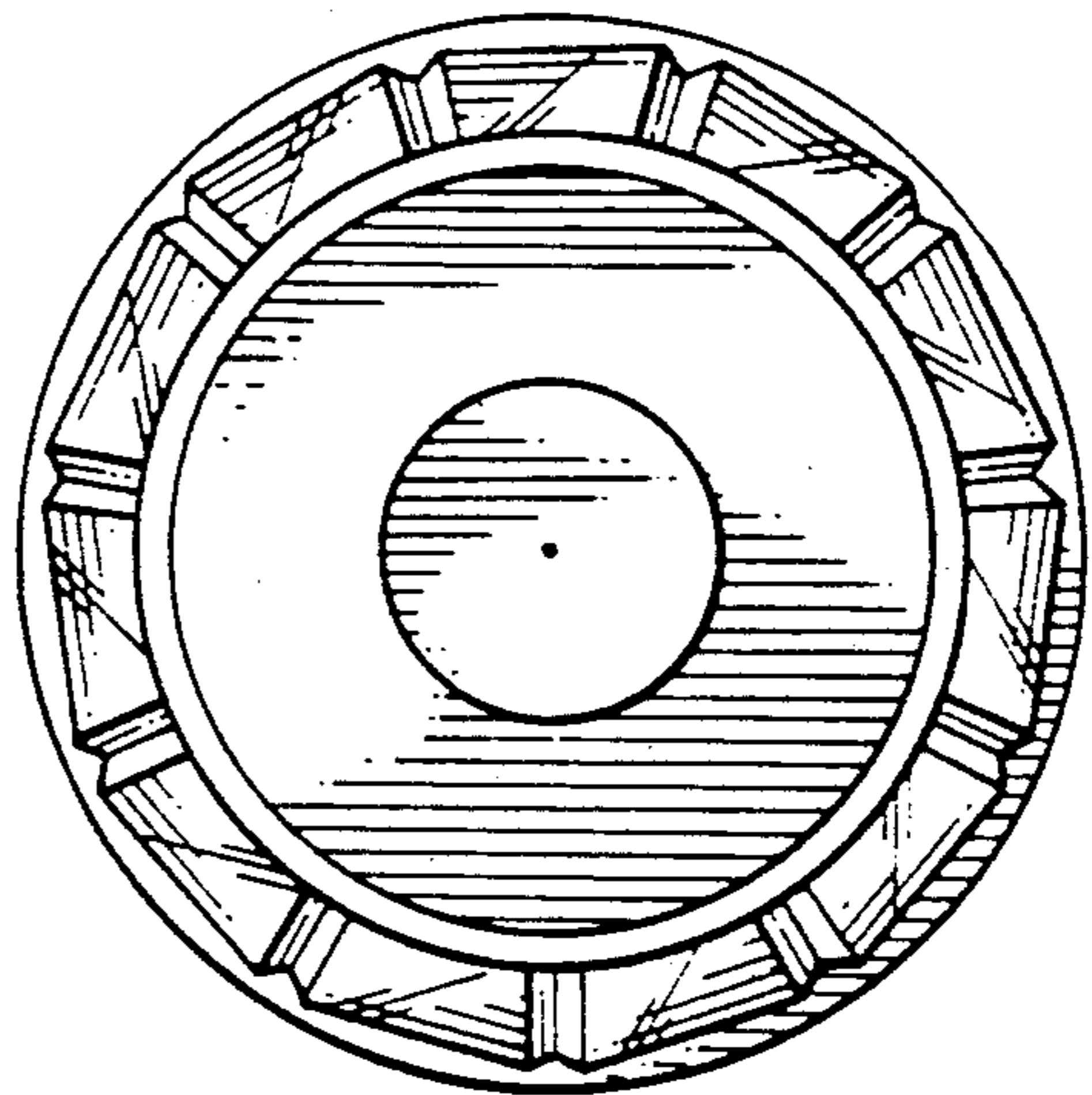
