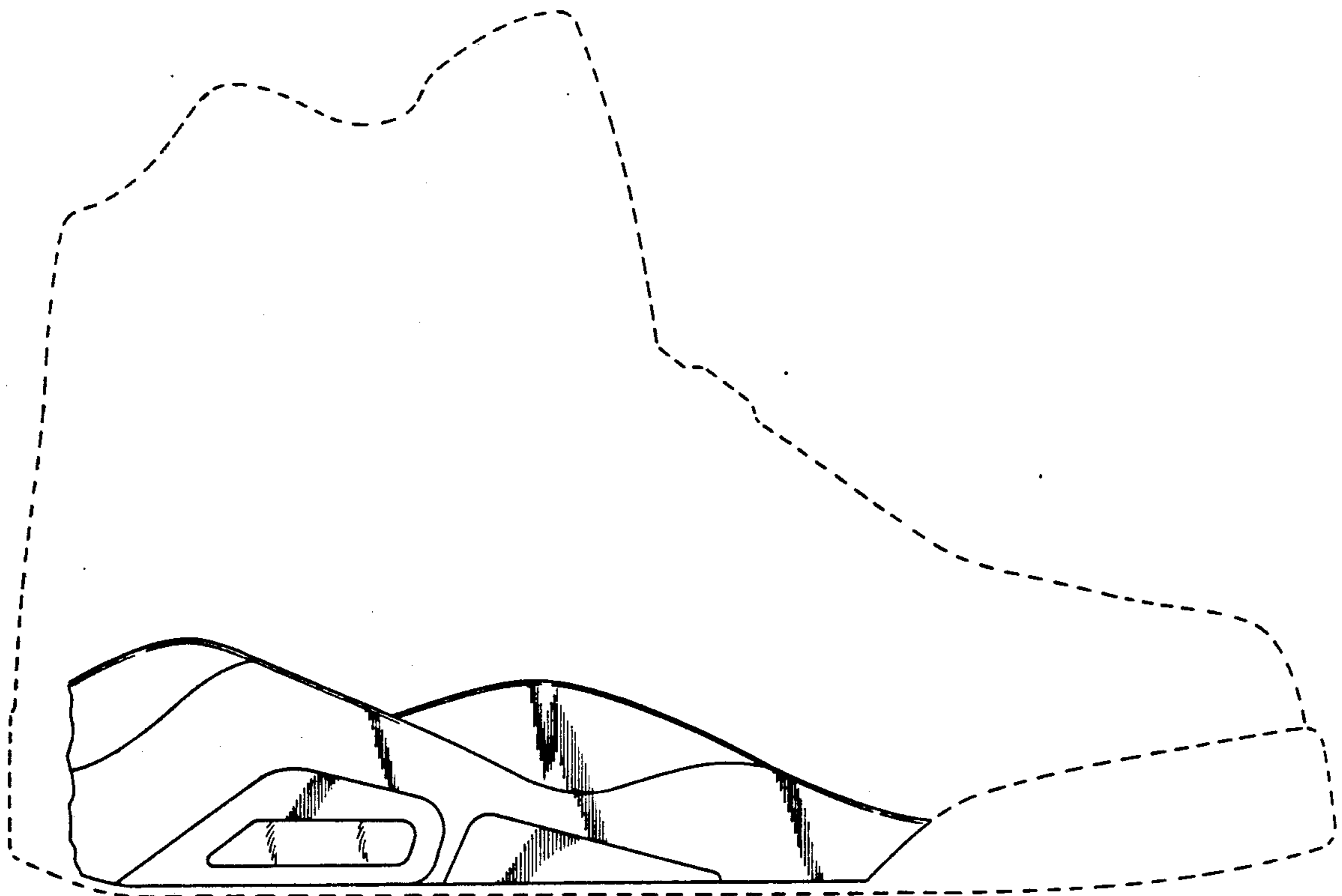
[57] **CLAIM**

The ornamental design for a shoe midsole lateral surface, as shown and described.

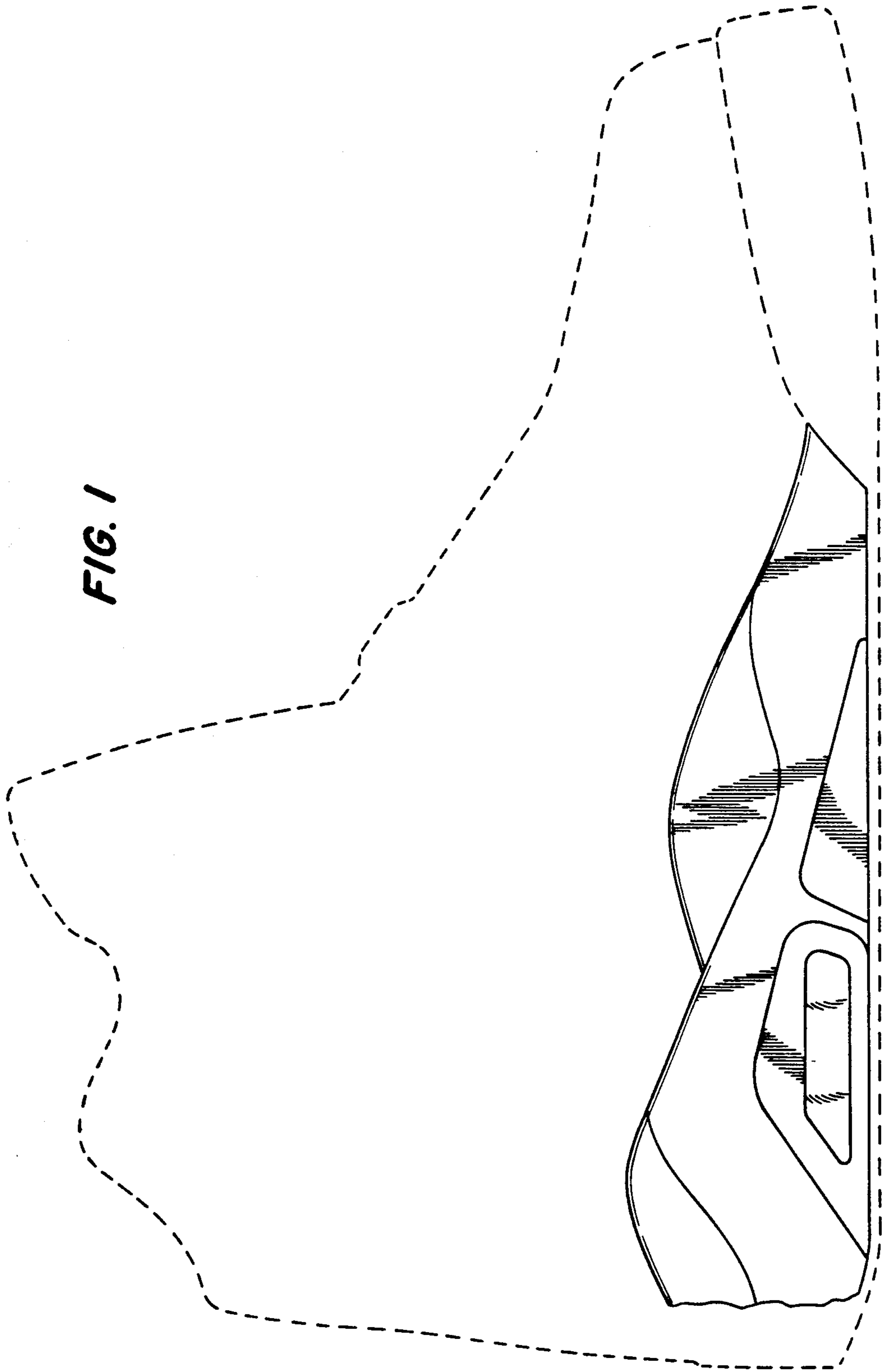
**DESCRIPTION**

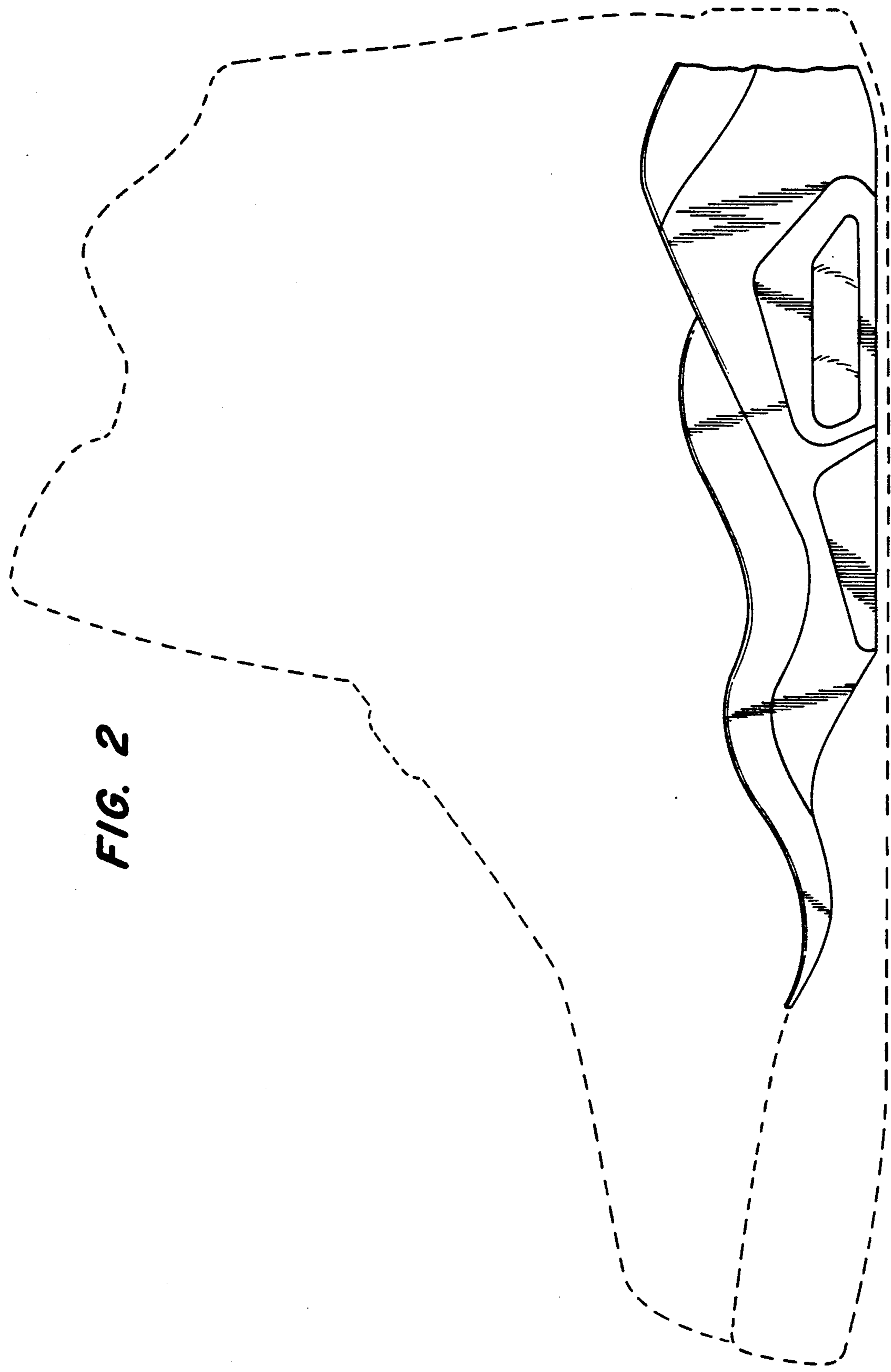
FIG. 1 is a side elevational view of a shoe midsole lateral surface showing my new design;  
FIG. 2 is a side elevational view of a shoe midsole lateral surface showing a second embodiment of my new design, consisting of the opposing surface;  
FIG. 3 is a side elevational view of a shoe midsole lateral surface showing a third embodiment of my new design; and  
FIG. 4 is a side elevational view of a shoe midsole lateral surface showing a fourth embodiment of my new design, consisting of the surface opposing the third embodiment.

The broken line showing of a shoe and sole in FIGS. 1-4 is for illustrative purposes only and forms no part of the claimed design.



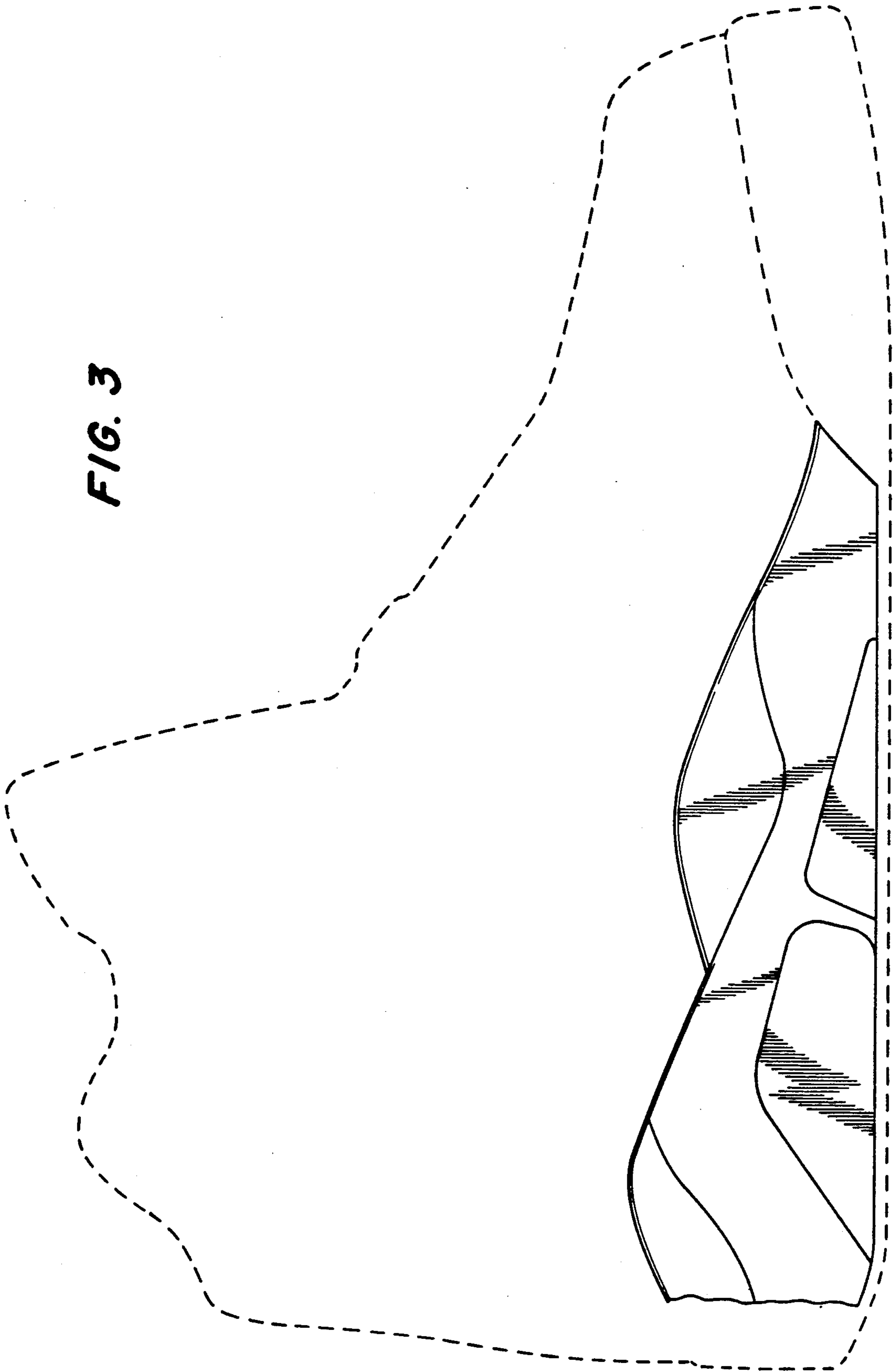

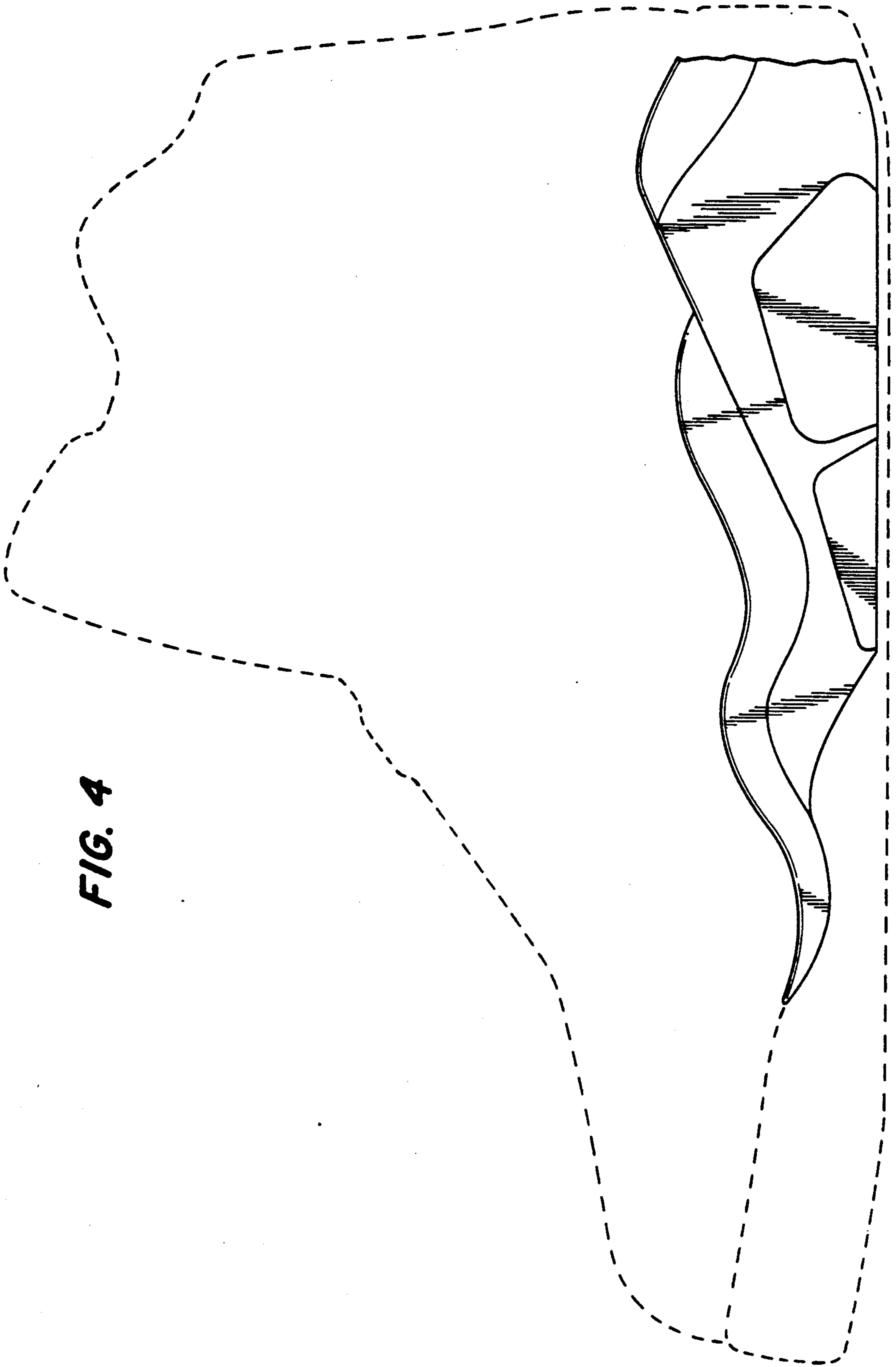
