The ornamental design for a combined container and applicator for fluid correction, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a combined container and applicator for correction fluid showing my new design;

 FIG. 6 is an exploded front elevational view thereof.

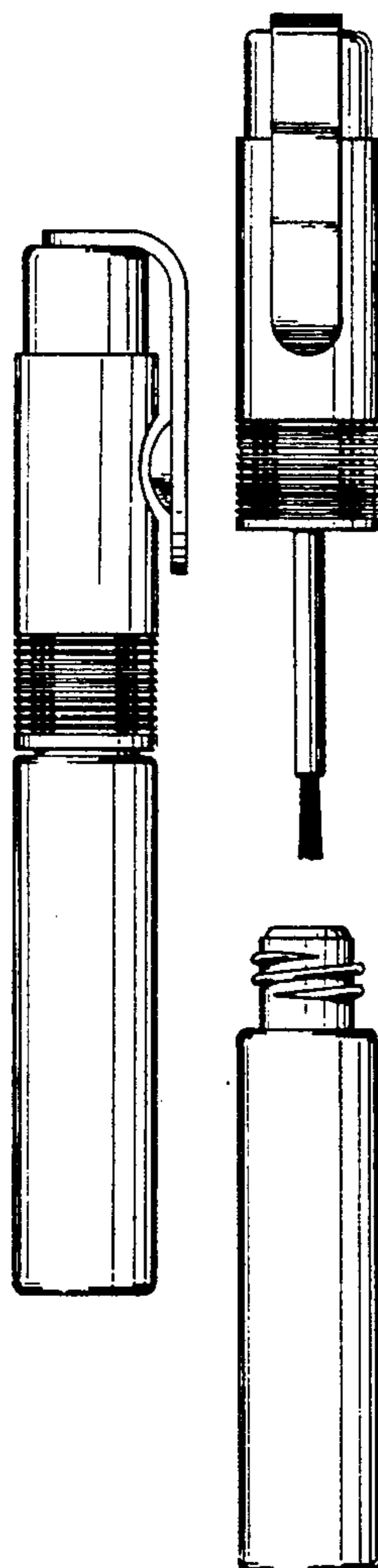

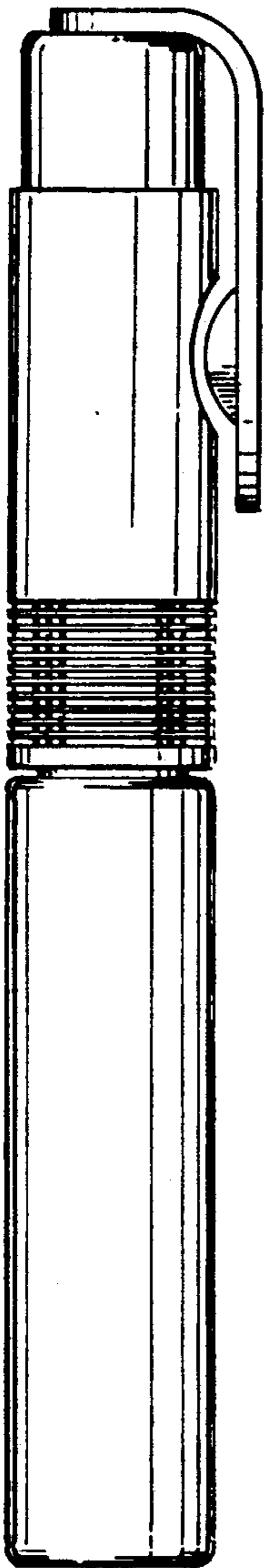

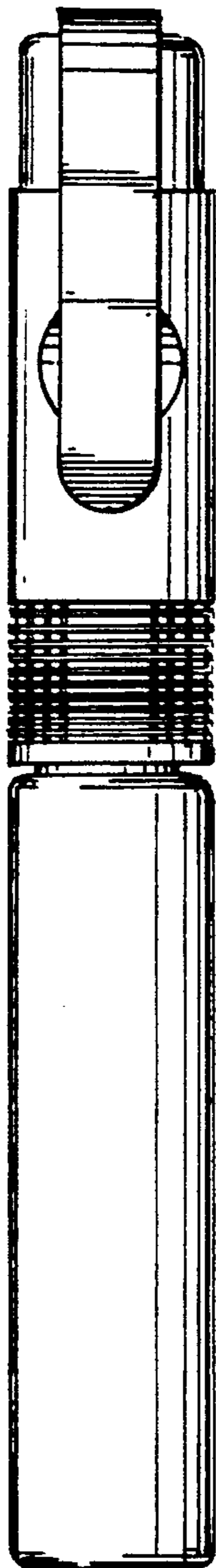

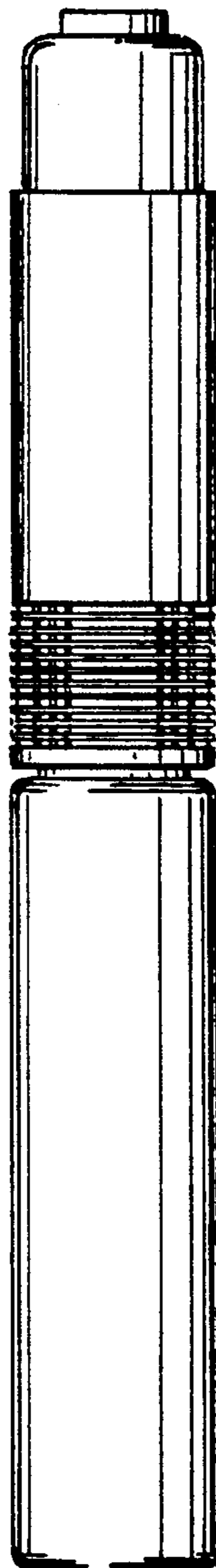

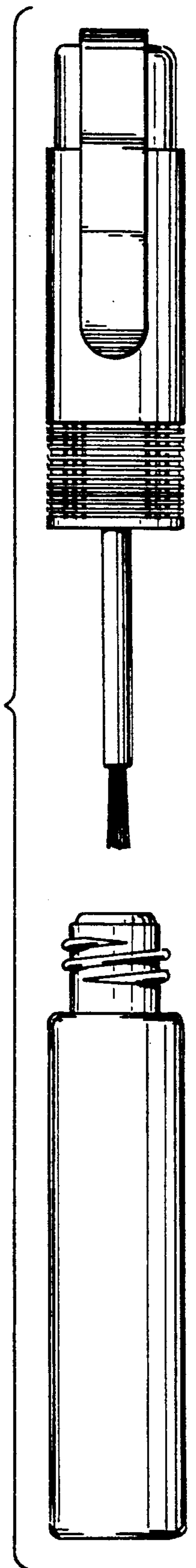

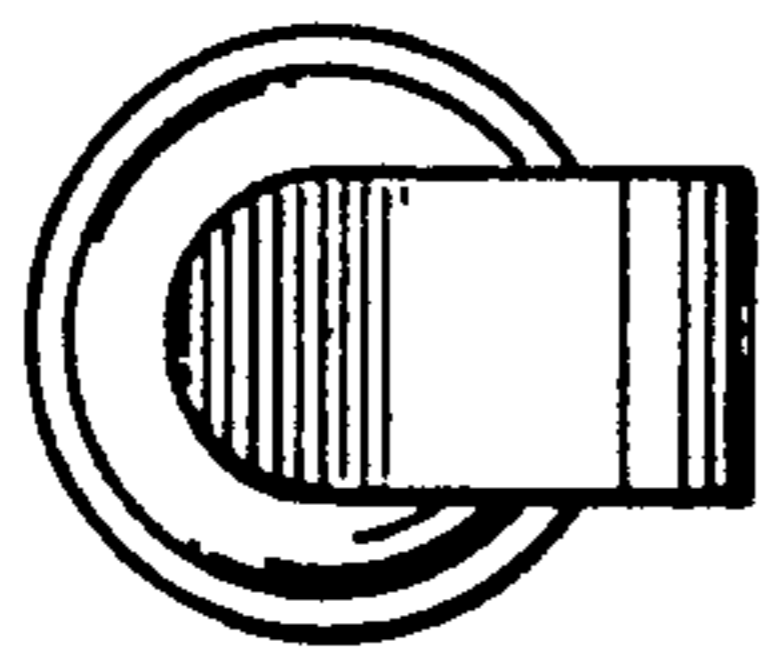
