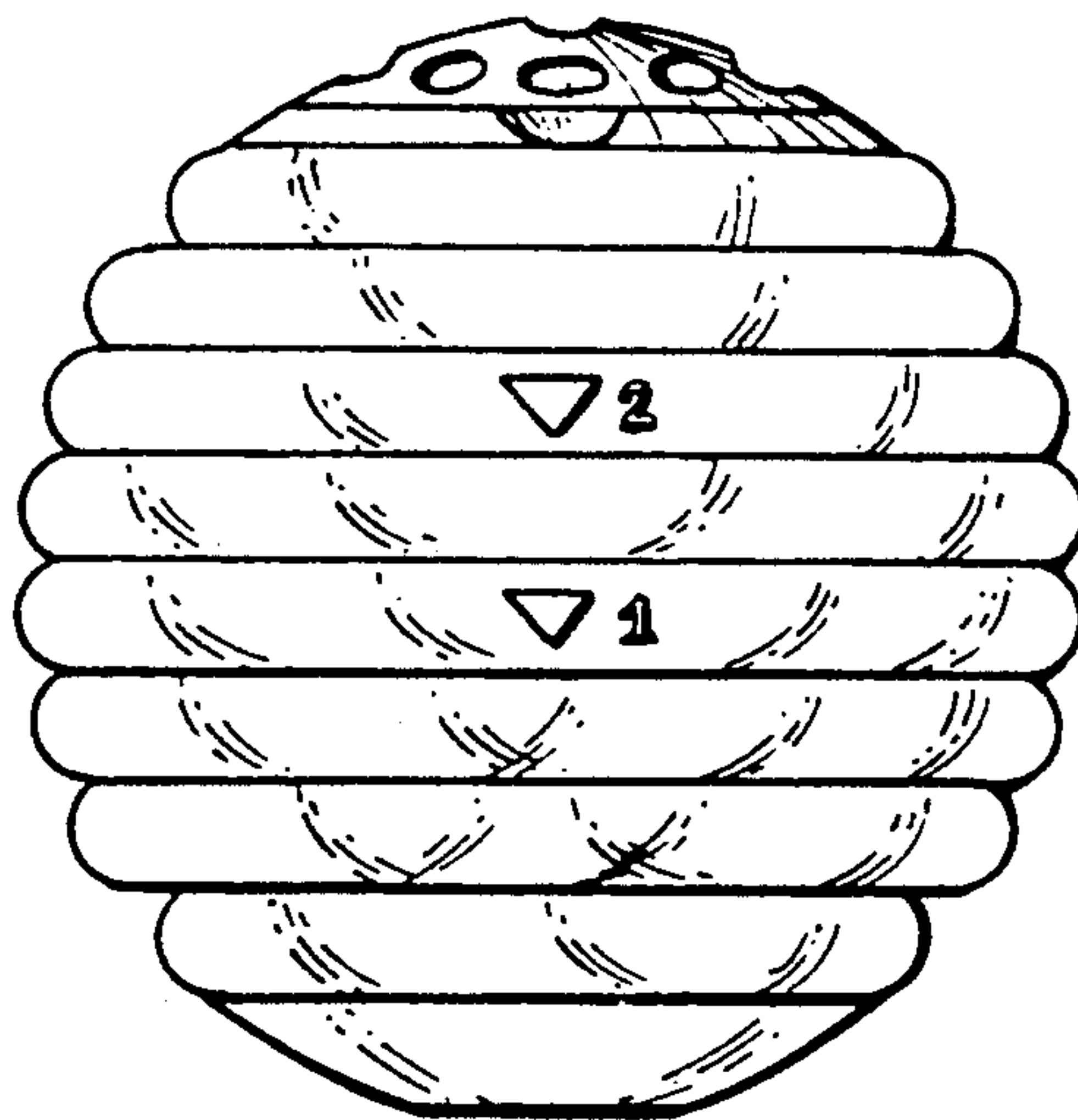

[57] CLAIM

The ornamental design for a dispenser for liquid detergent or similar article, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a dispenser for liquid detergent or similar article showing our new design;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a right side elevational view thereof, wherein the left side elevational view is a mirror image thereof;  
FIG. 4 is a top plan view thereof; and  
FIG. 5 is a bottom plan view thereof.



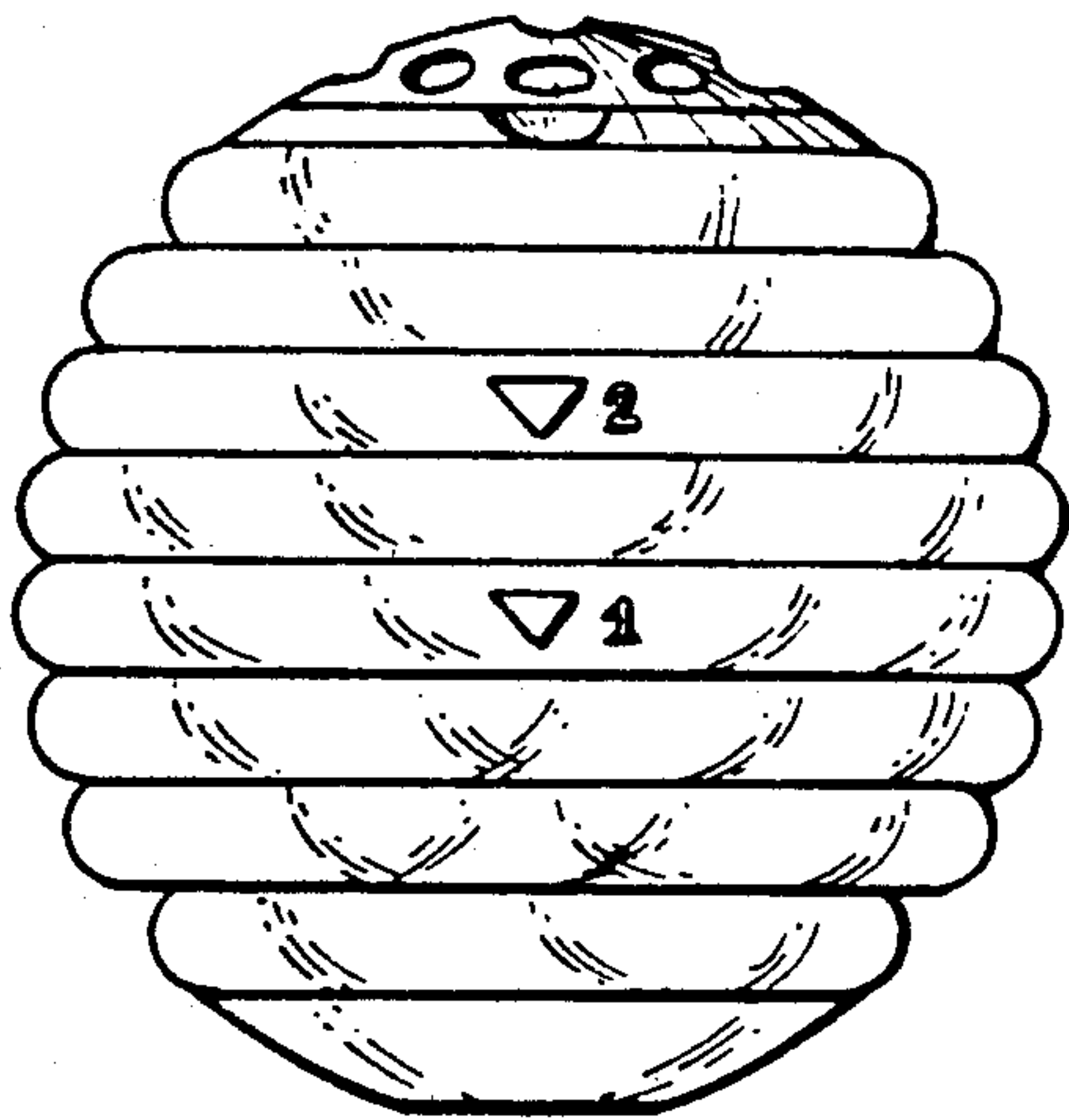

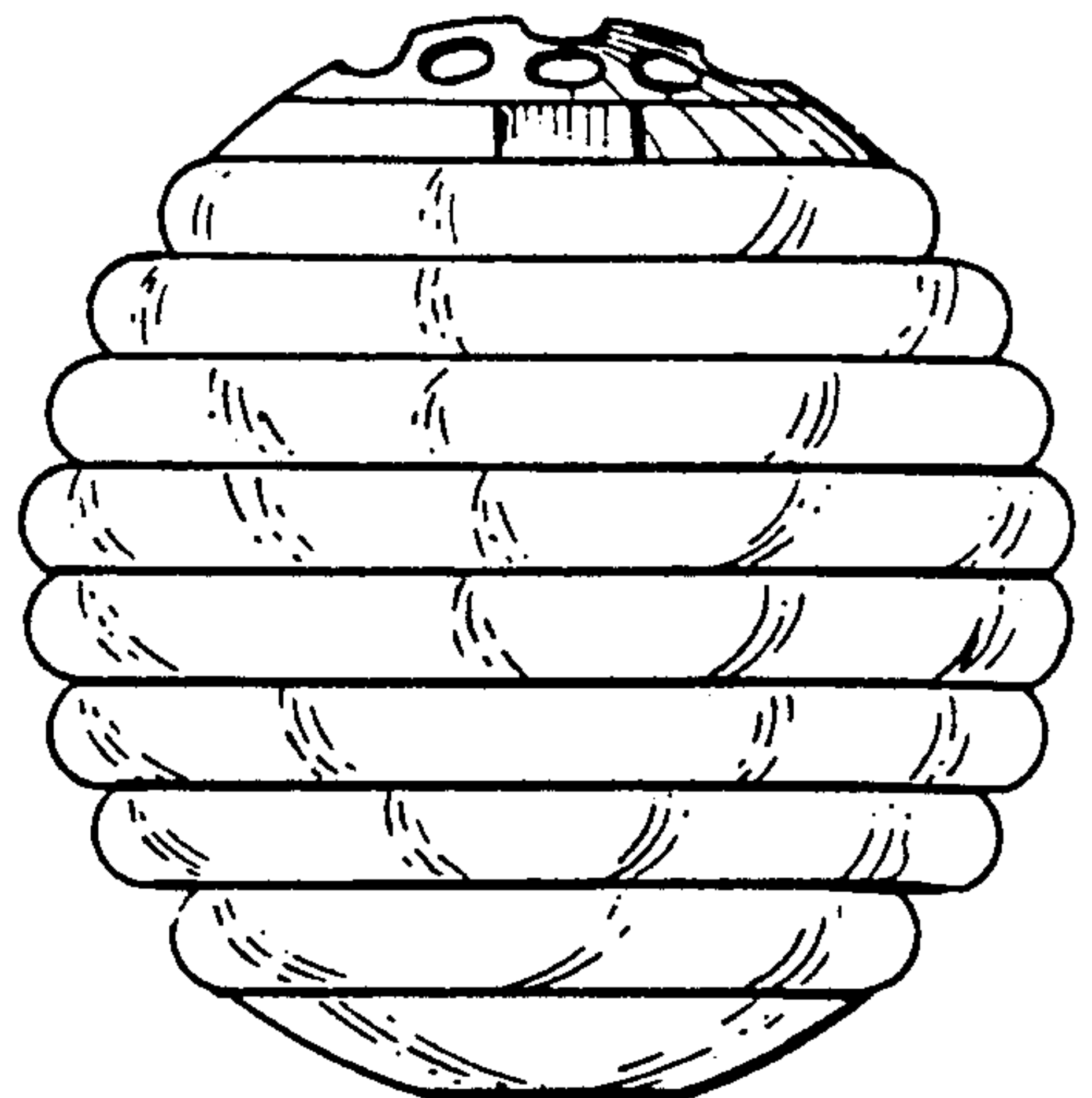

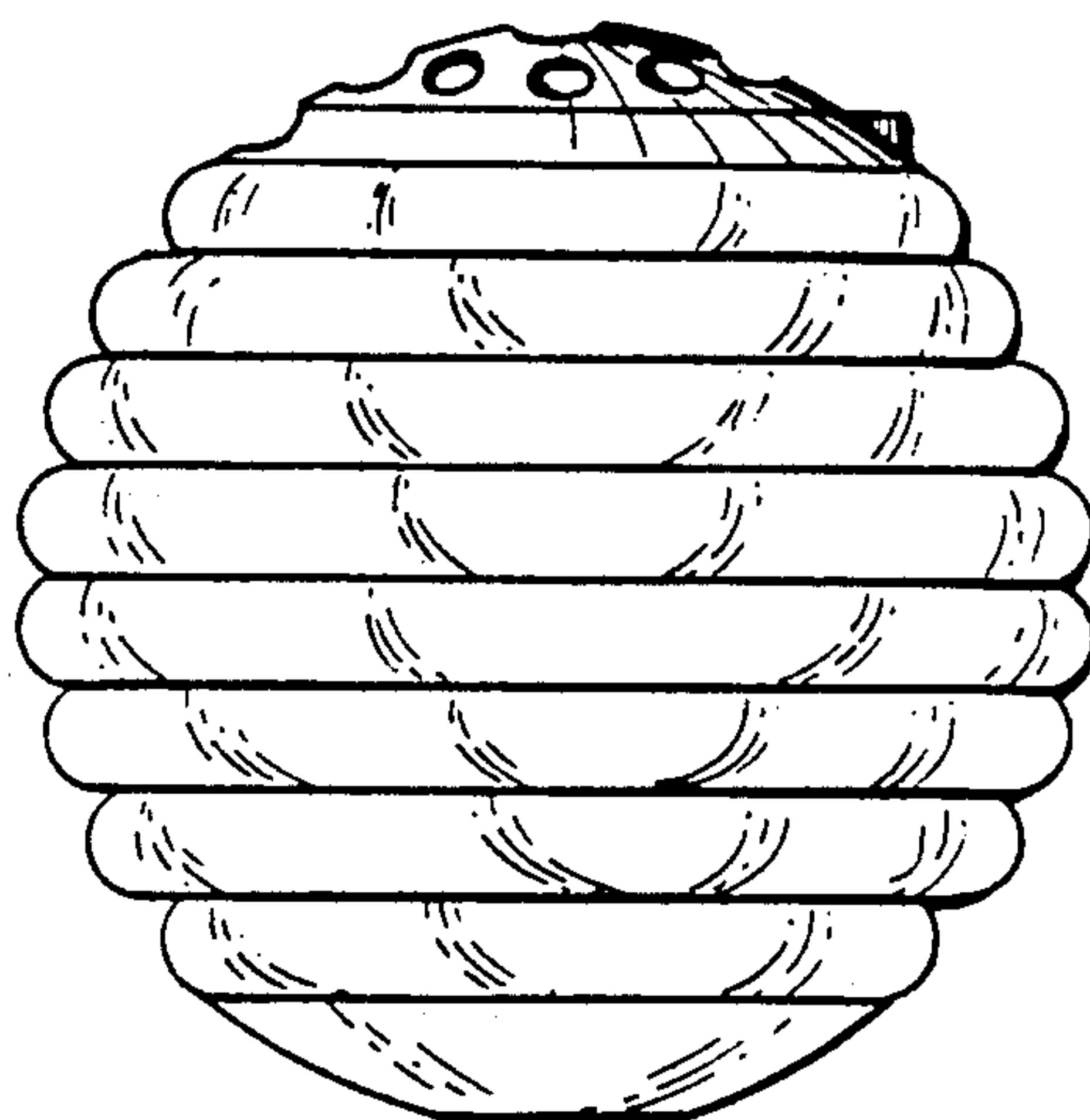

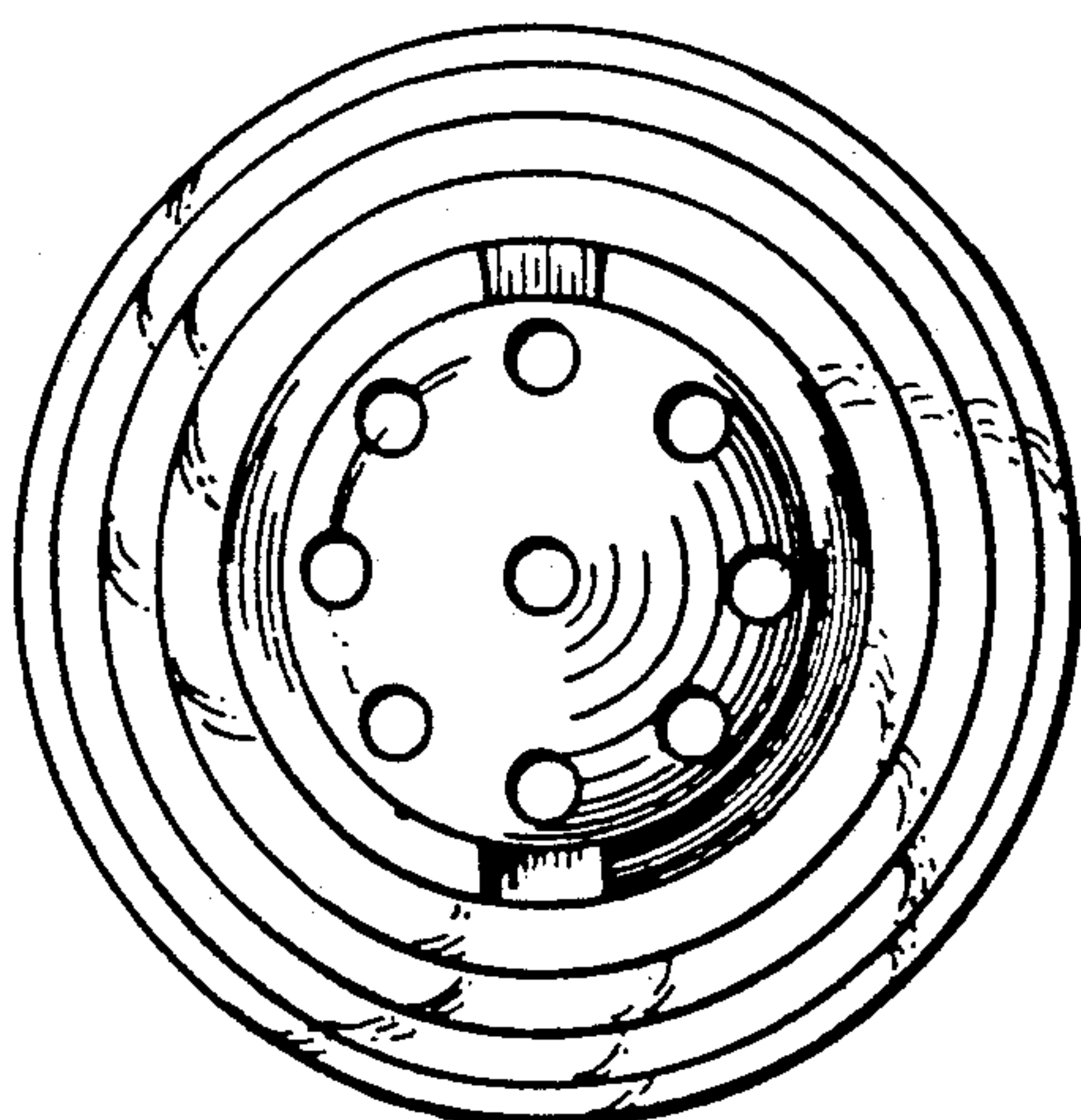

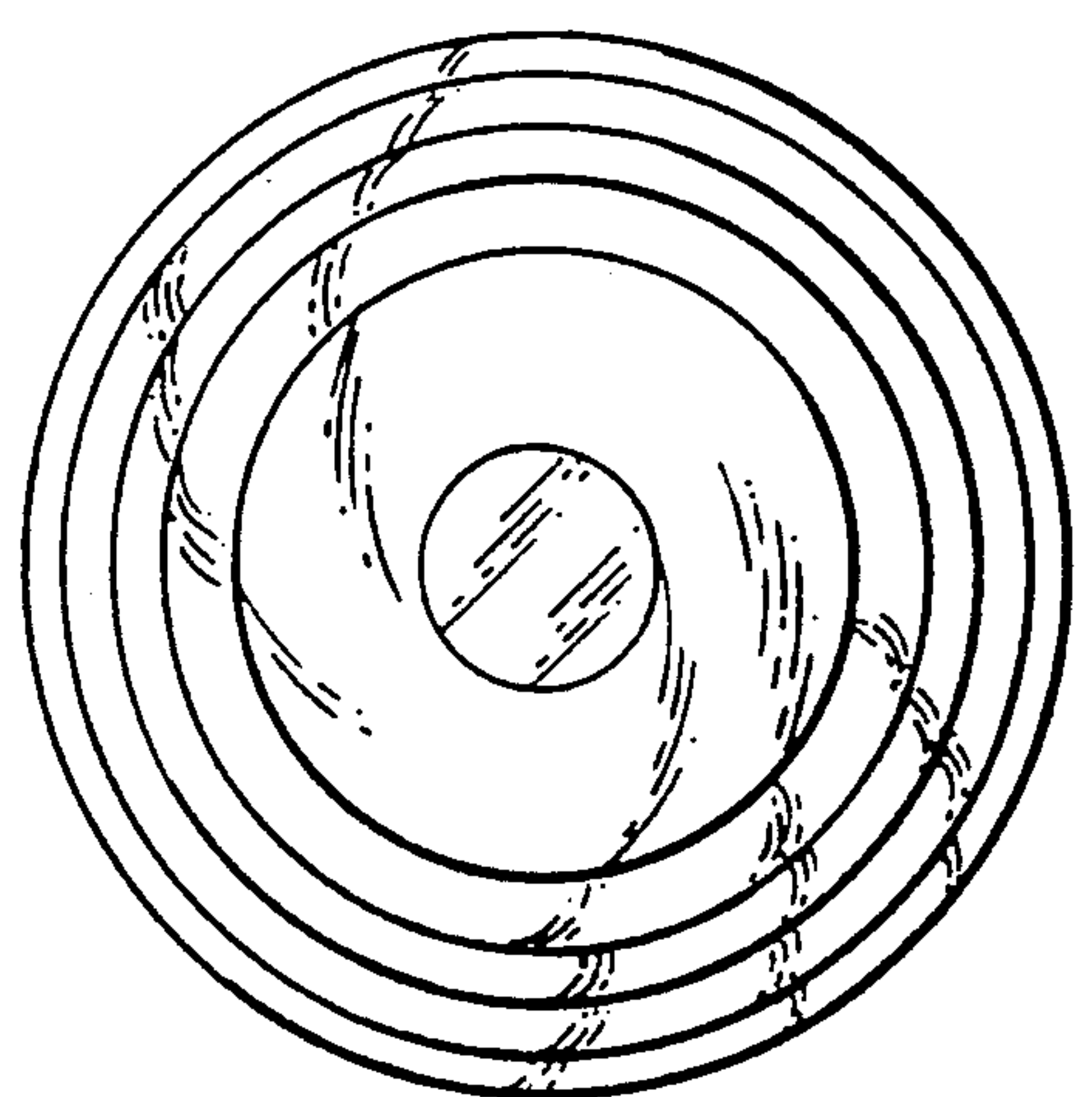
