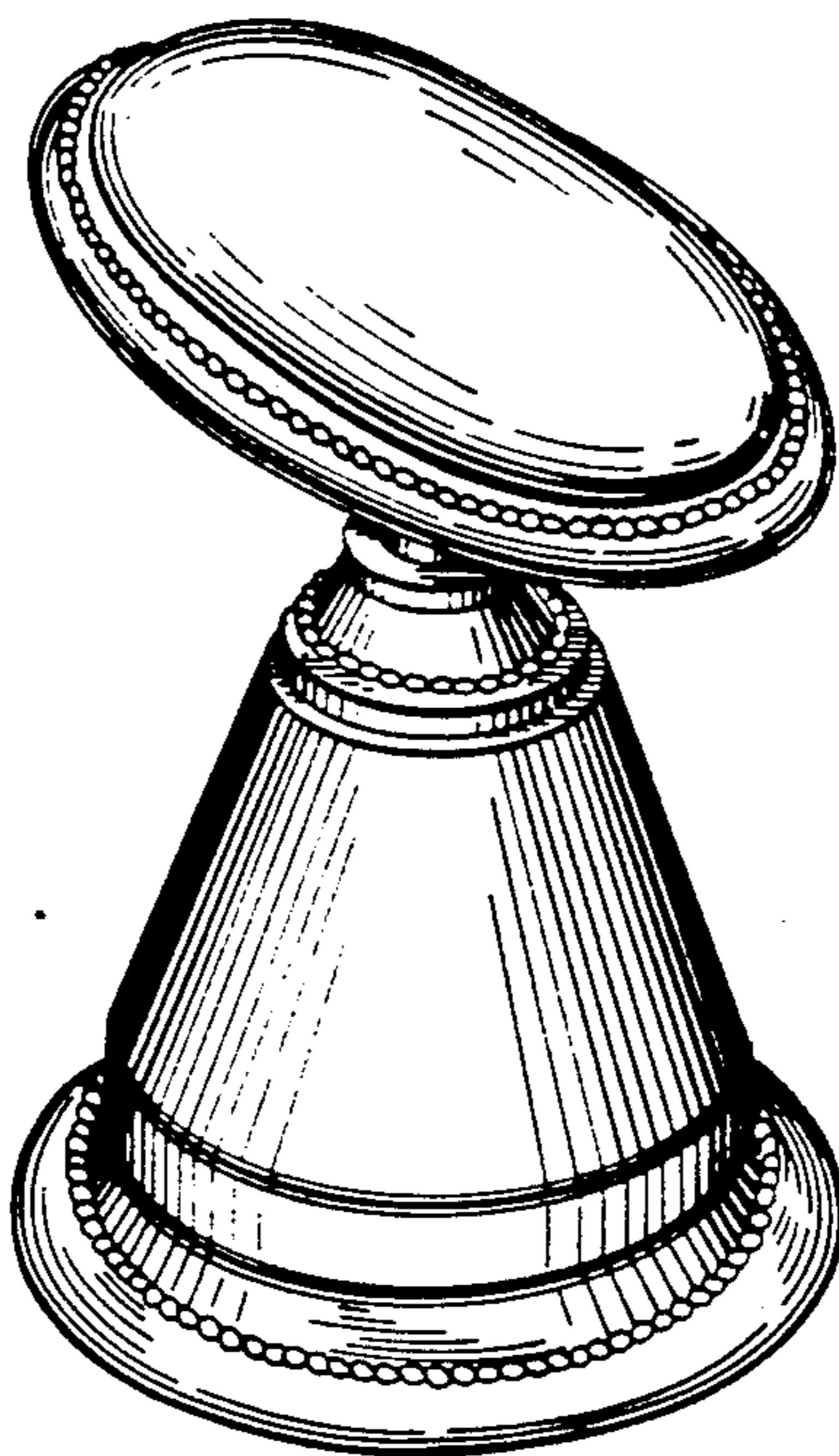

[57] CLAIM

The ornamental design for a faucet handle, as shown and described.

DESCRIPTION

- FIG. 1 is a perspective view taken from the top, front and right side of a faucet handle showing our new design;
- FIG. 2 is a front elevational view thereof, the rear being the same as the front;
- FIG. 3 is a top plan view thereof;
- FIG. 4 is a right side elevational view thereof, the left side being the mirror image of the right side;
- FIG. 5 is a bottom plan view thereof;
- FIG. 6 is a front elevational view of a second embodiment thereof;
- FIG. 7 is a rear elevational view of FIG. 6;
- FIG. 8 is a top plan view of FIG. 6;
- FIG. 9 is a perspective view taken from the top, front and right side of a third embodiment thereof;
- FIG. 10 is a front elevational view of FIG. 9, the rear being the same as the front;
- FIG. 11 is a top plan view of FIG. 9;
- FIG. 12 is a right side elevational view of FIG. 9, the left side being a mirror image of the right side;
- FIG. 13 is a bottom plan view of FIG. 9;
- FIG. 14 is a front elevational view of a fourth embodiment thereof;
- FIG. 15 is a rear elevational view of FIG. 14; and
- FIG. 16 is a top plan view of FIG. 14.



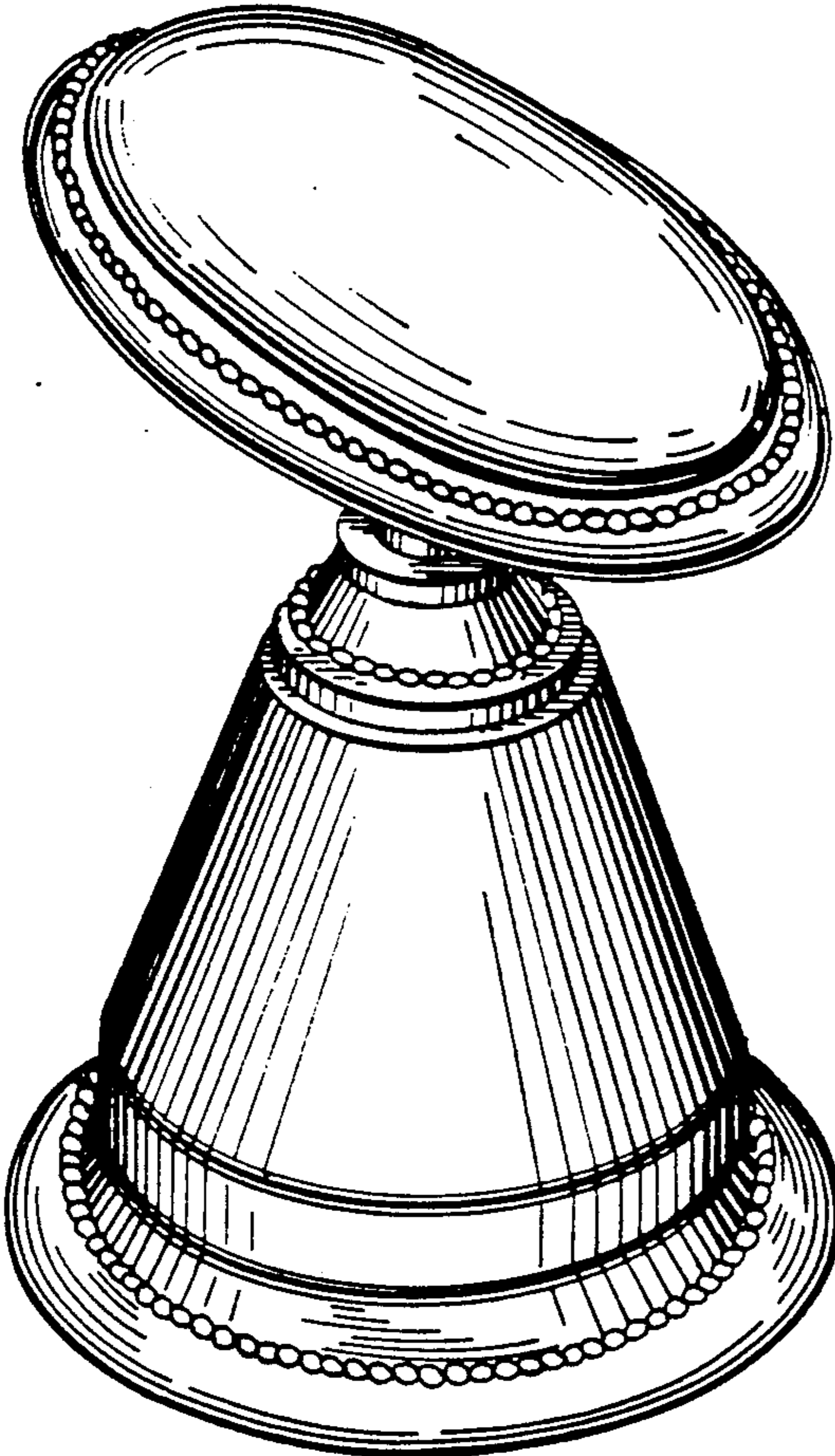

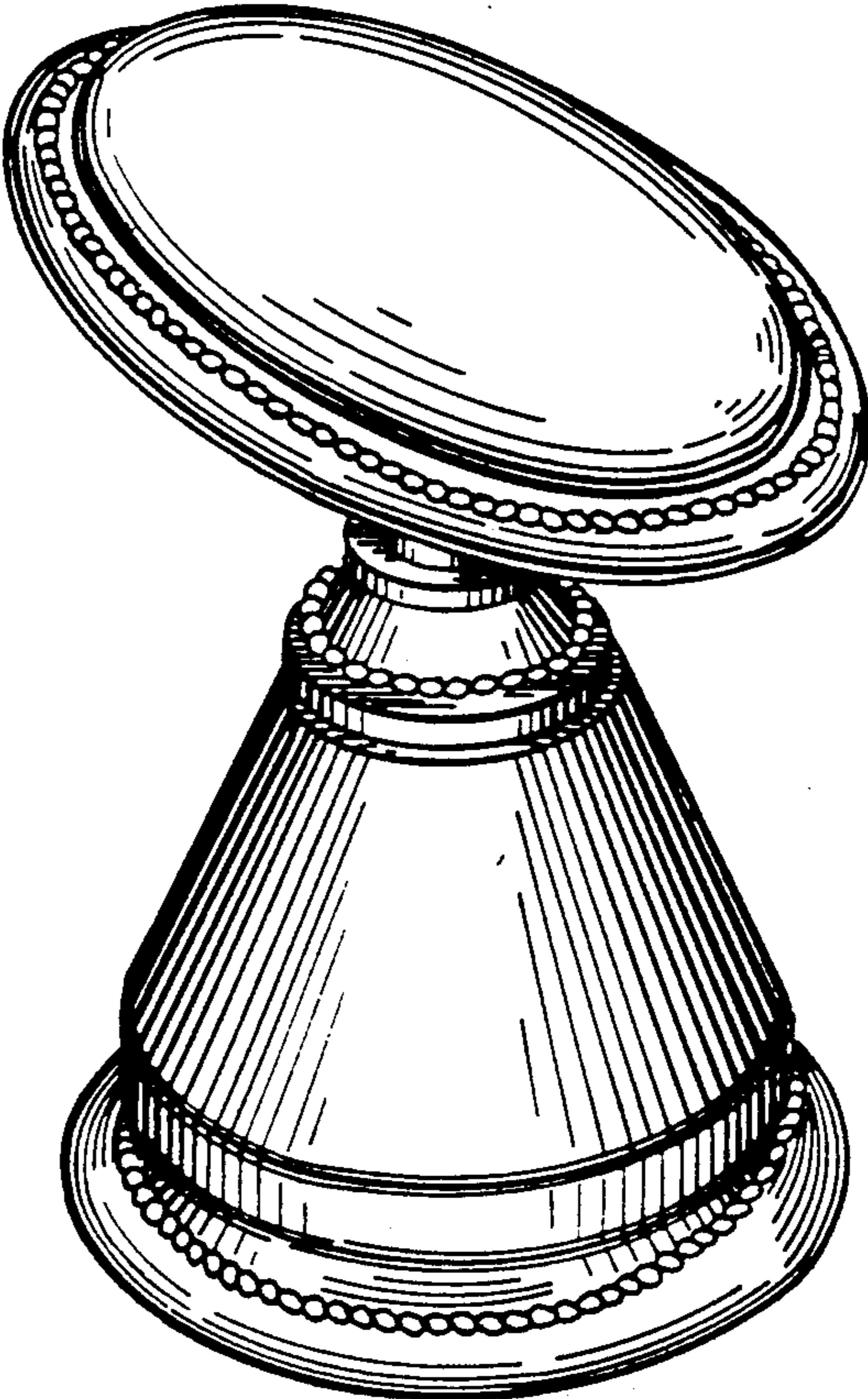

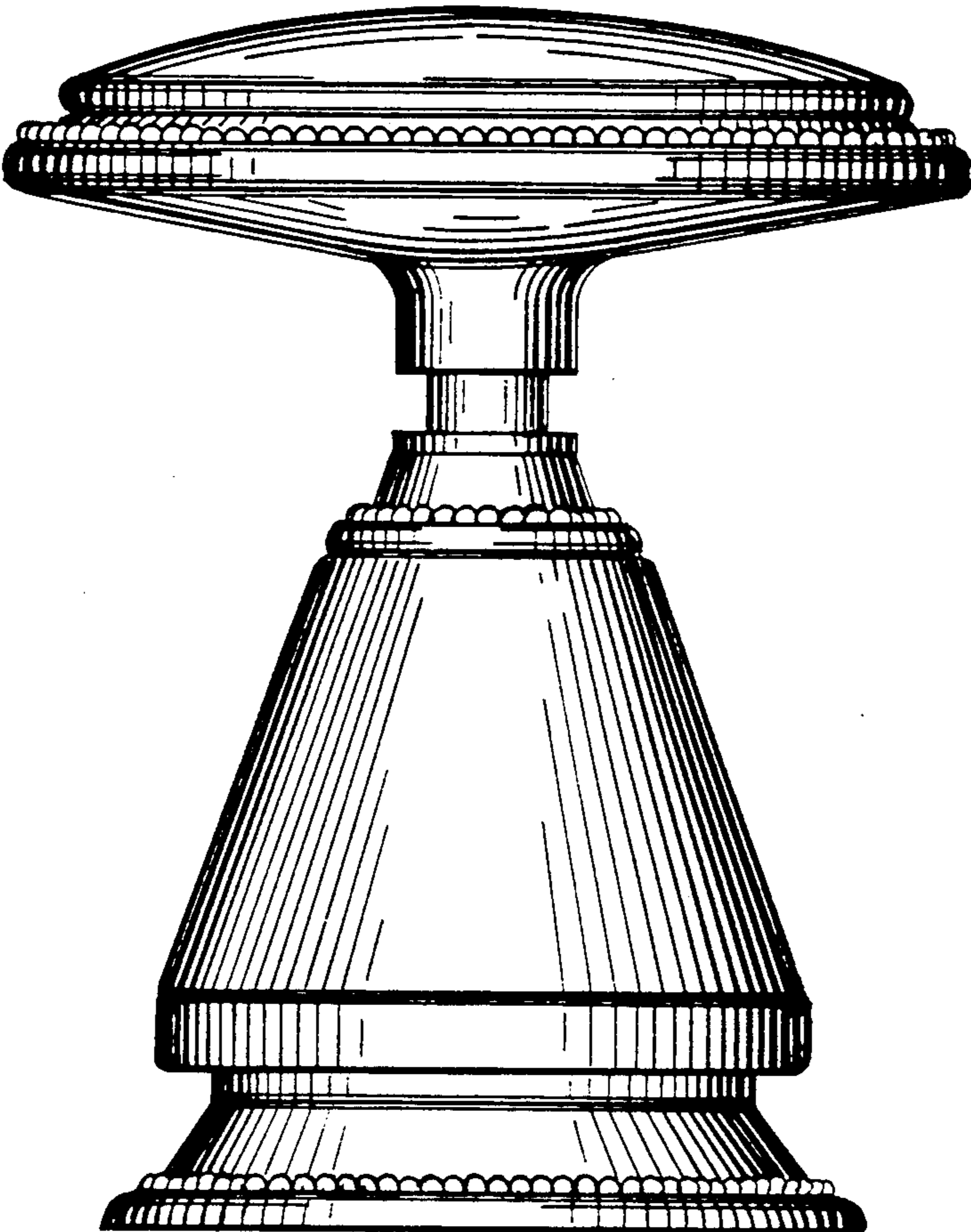

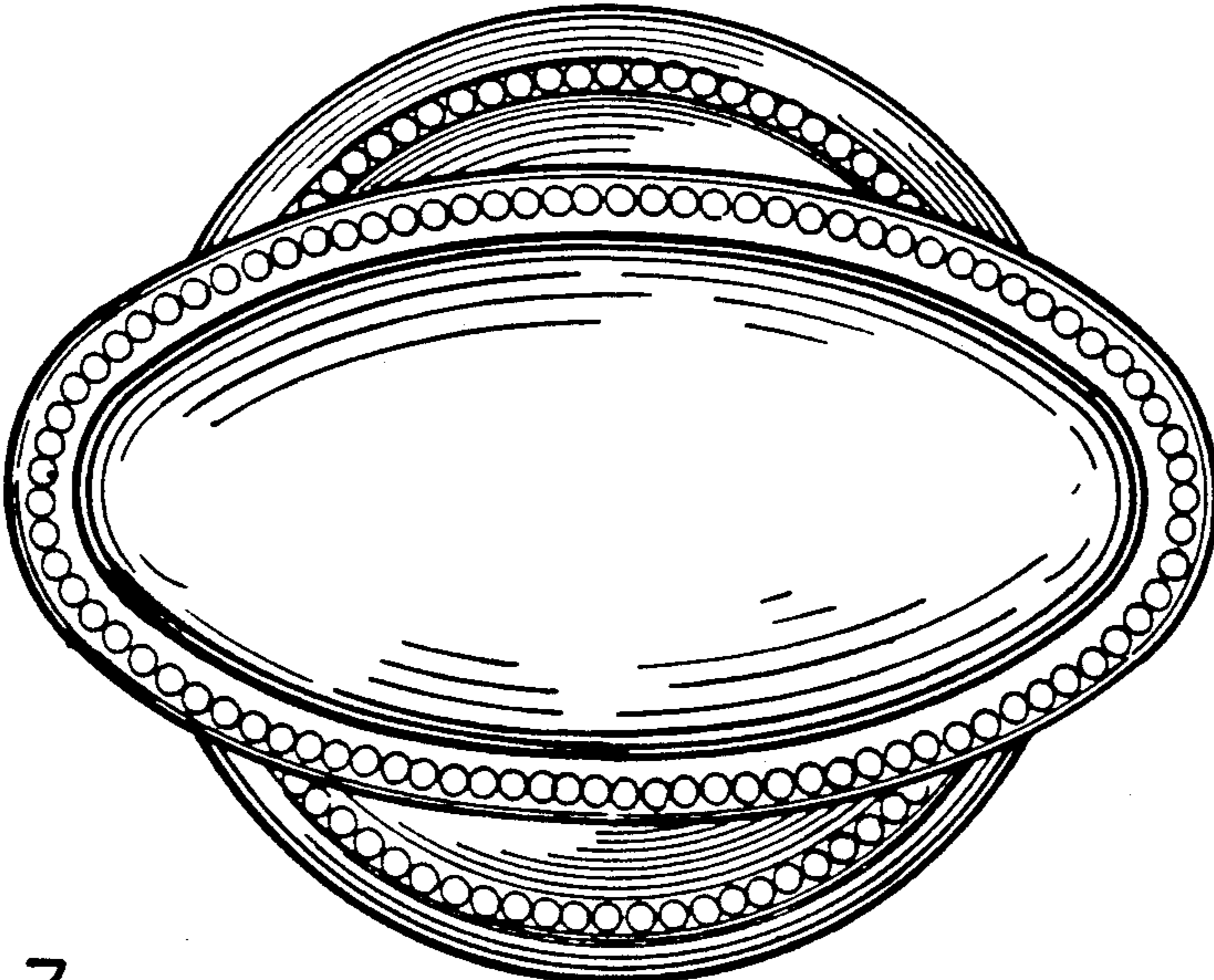

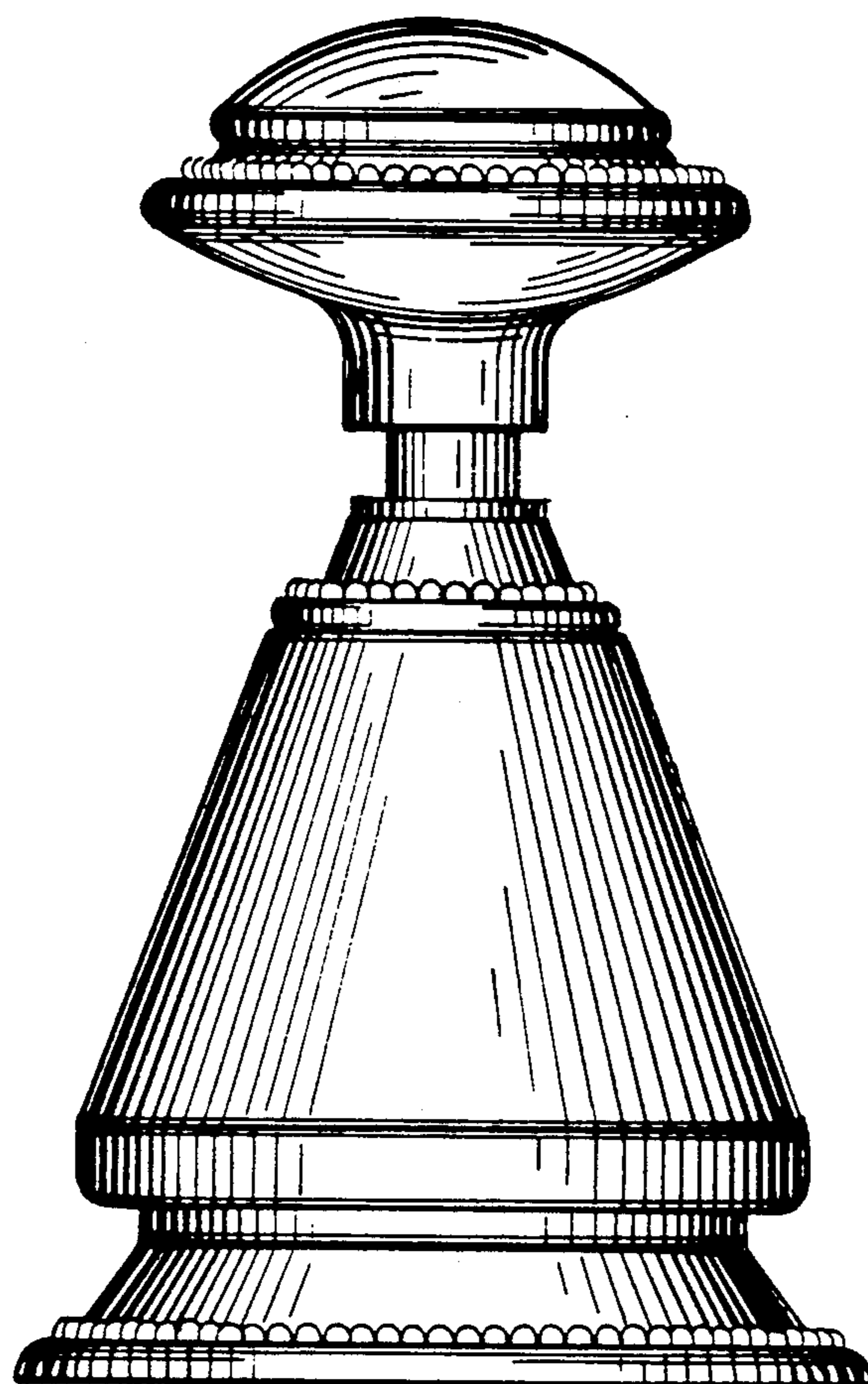
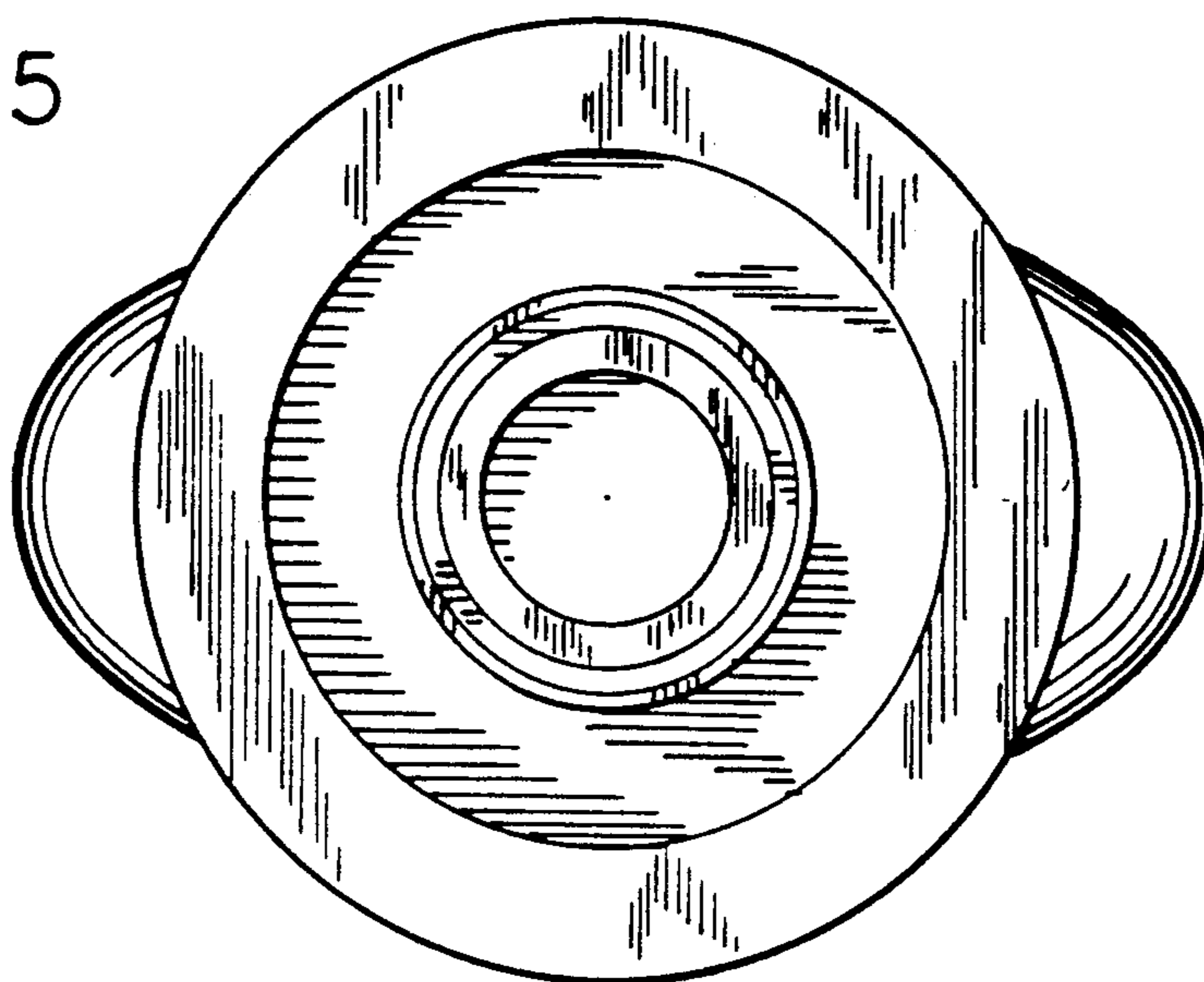

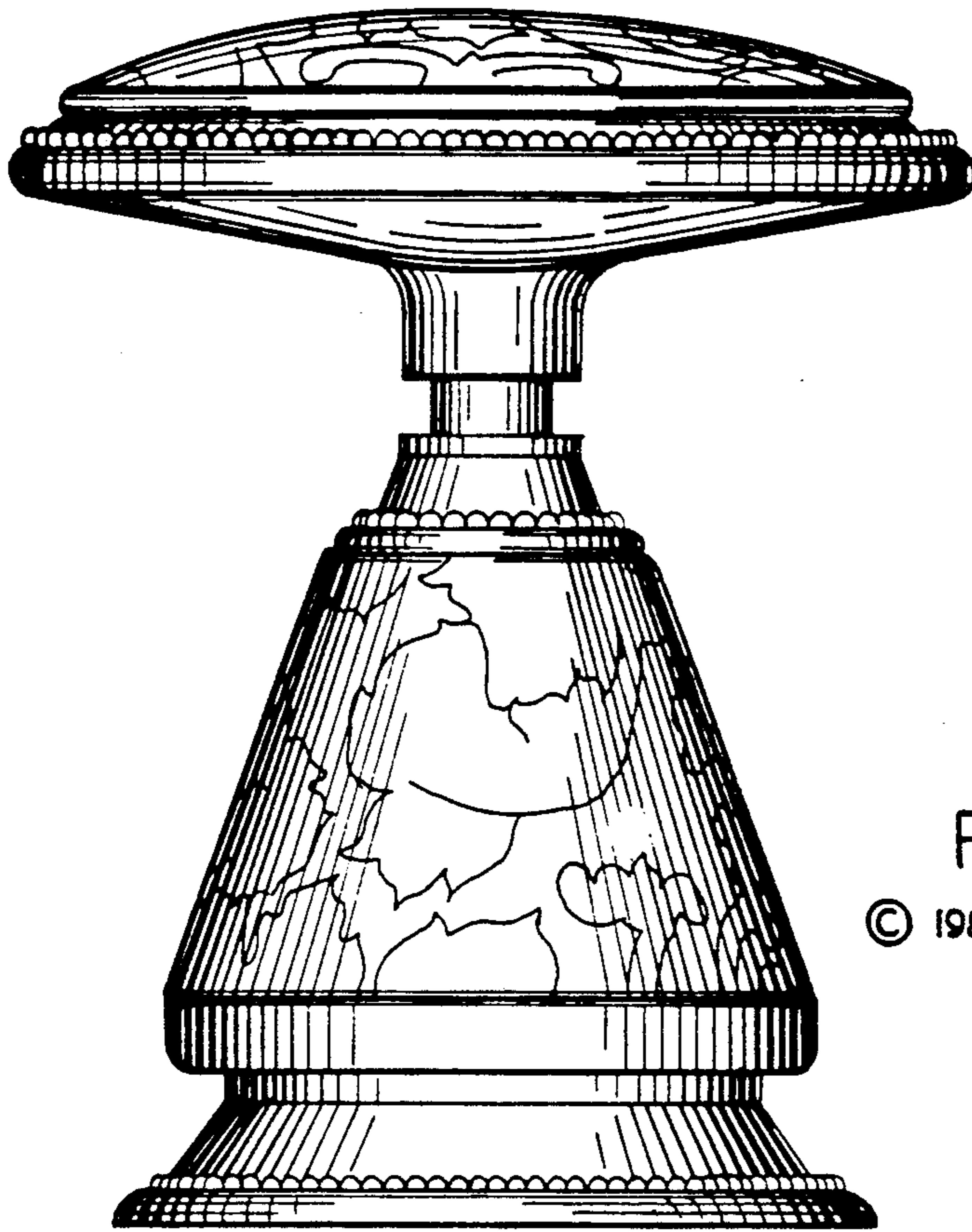

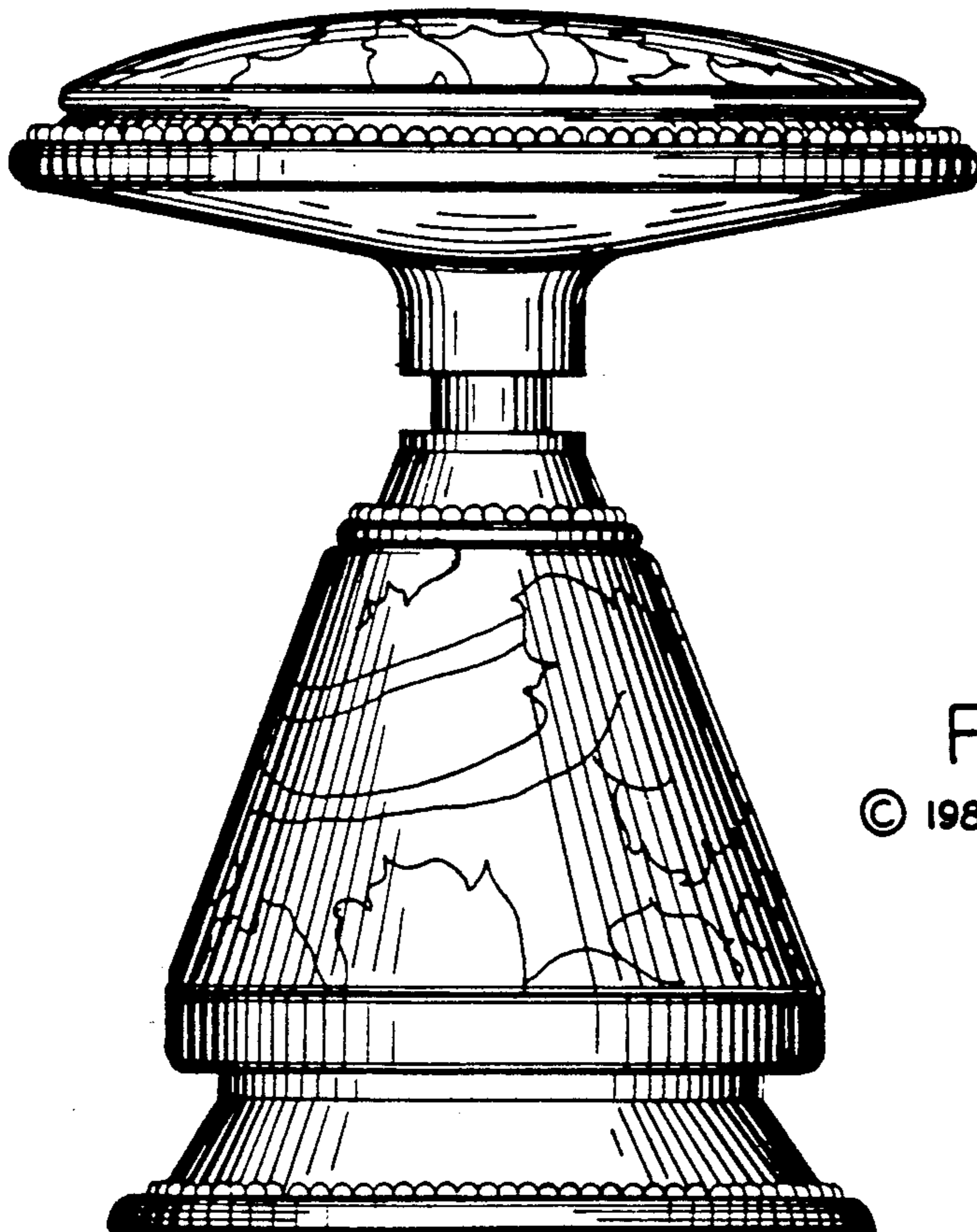

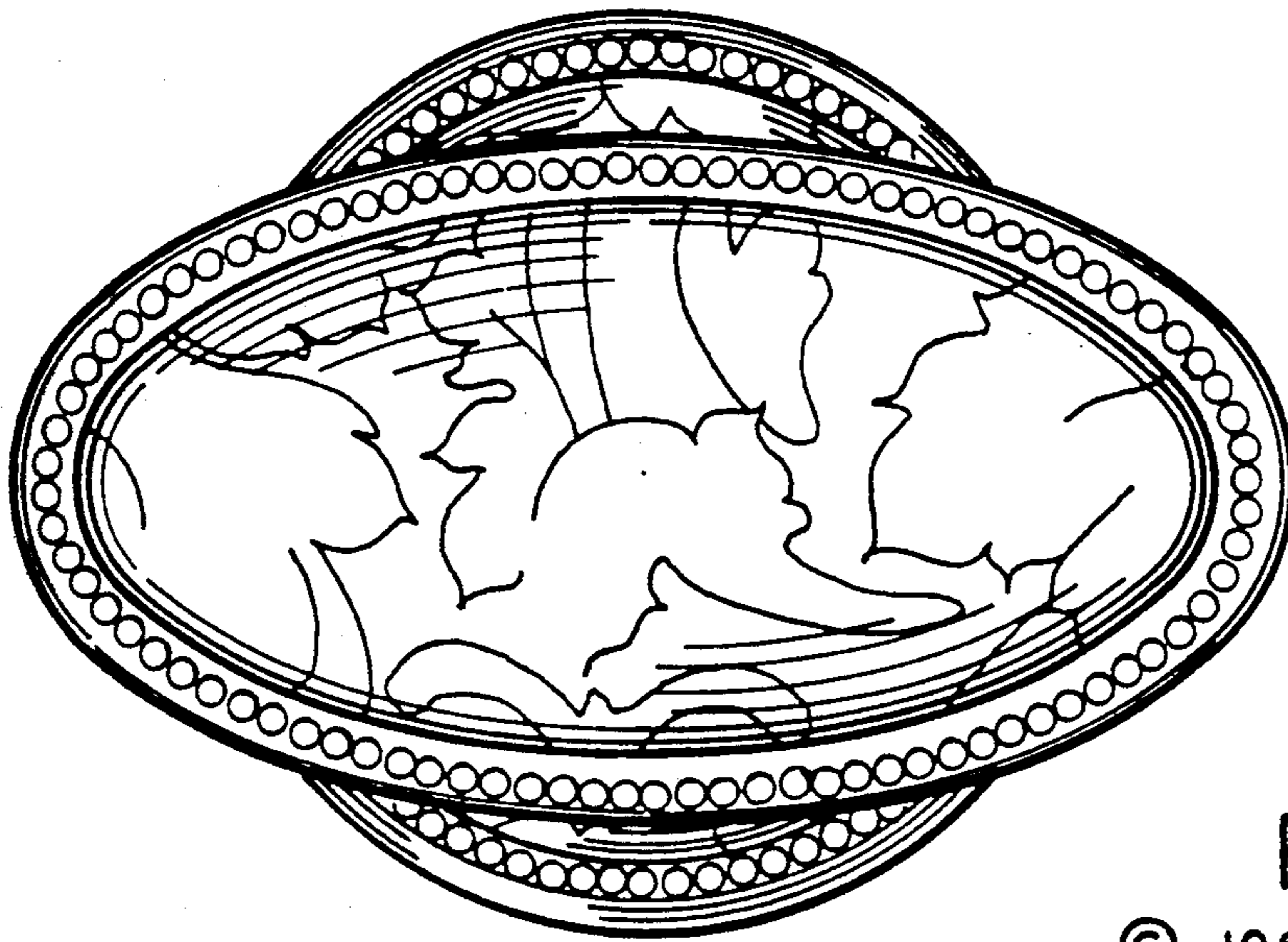

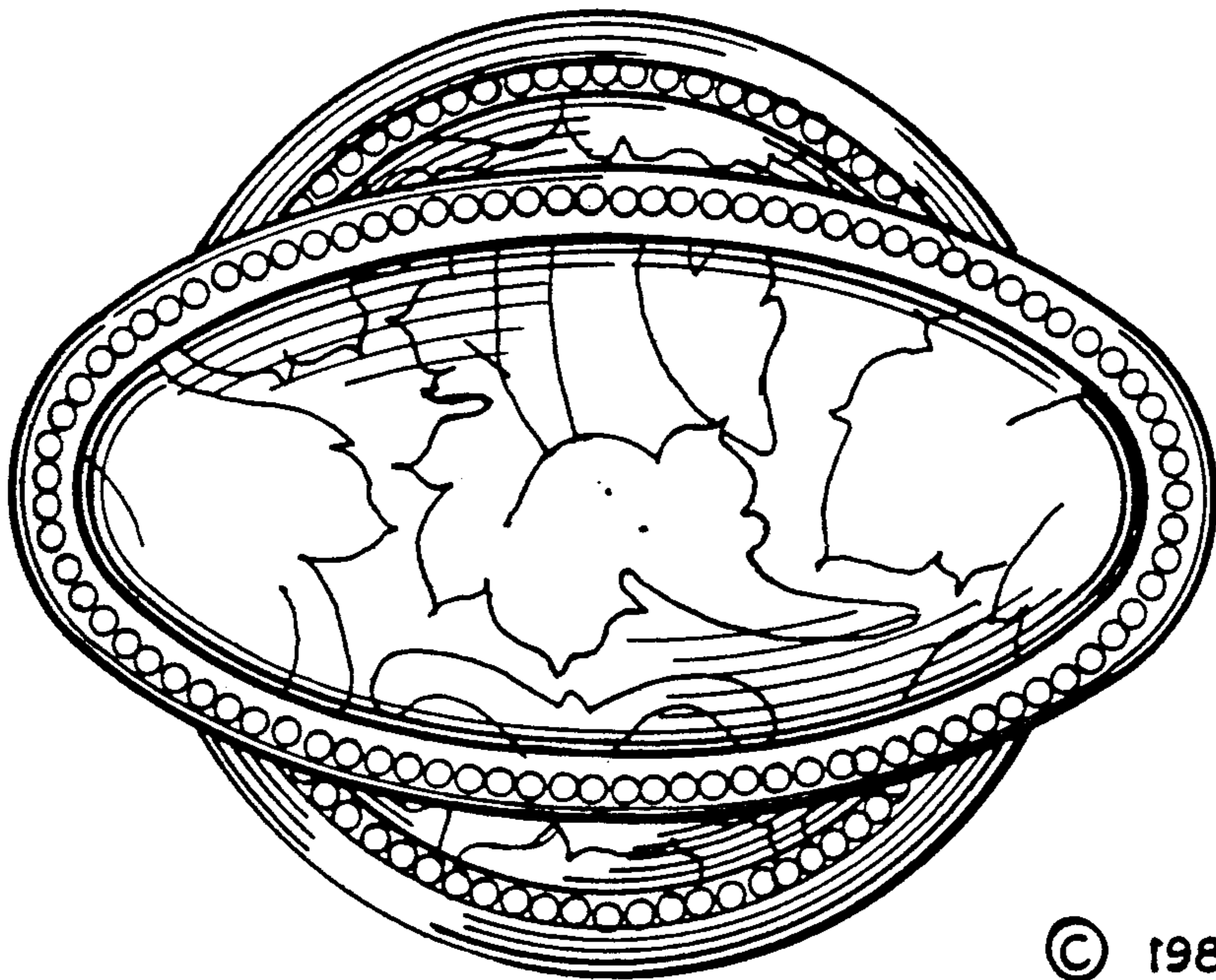

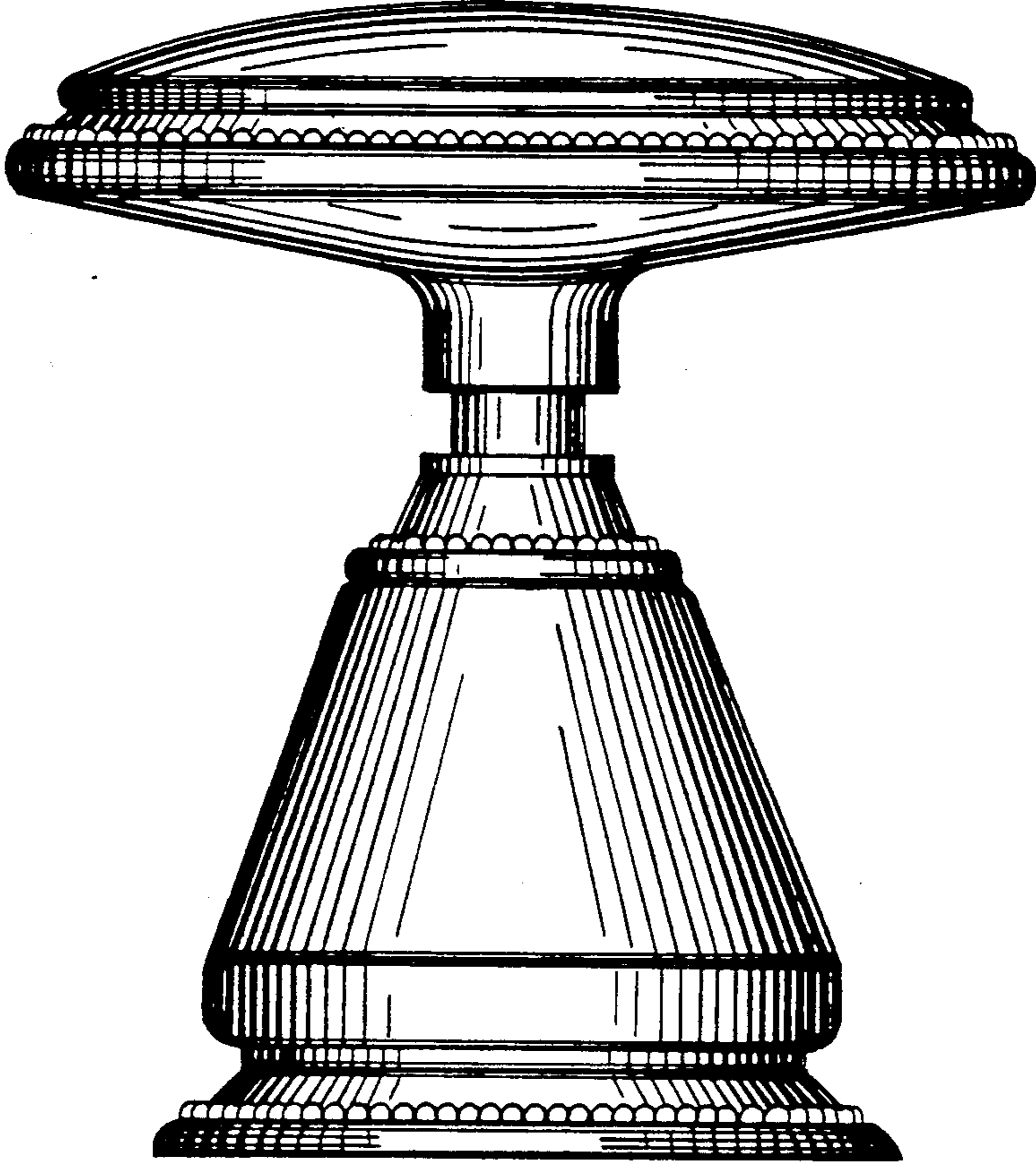

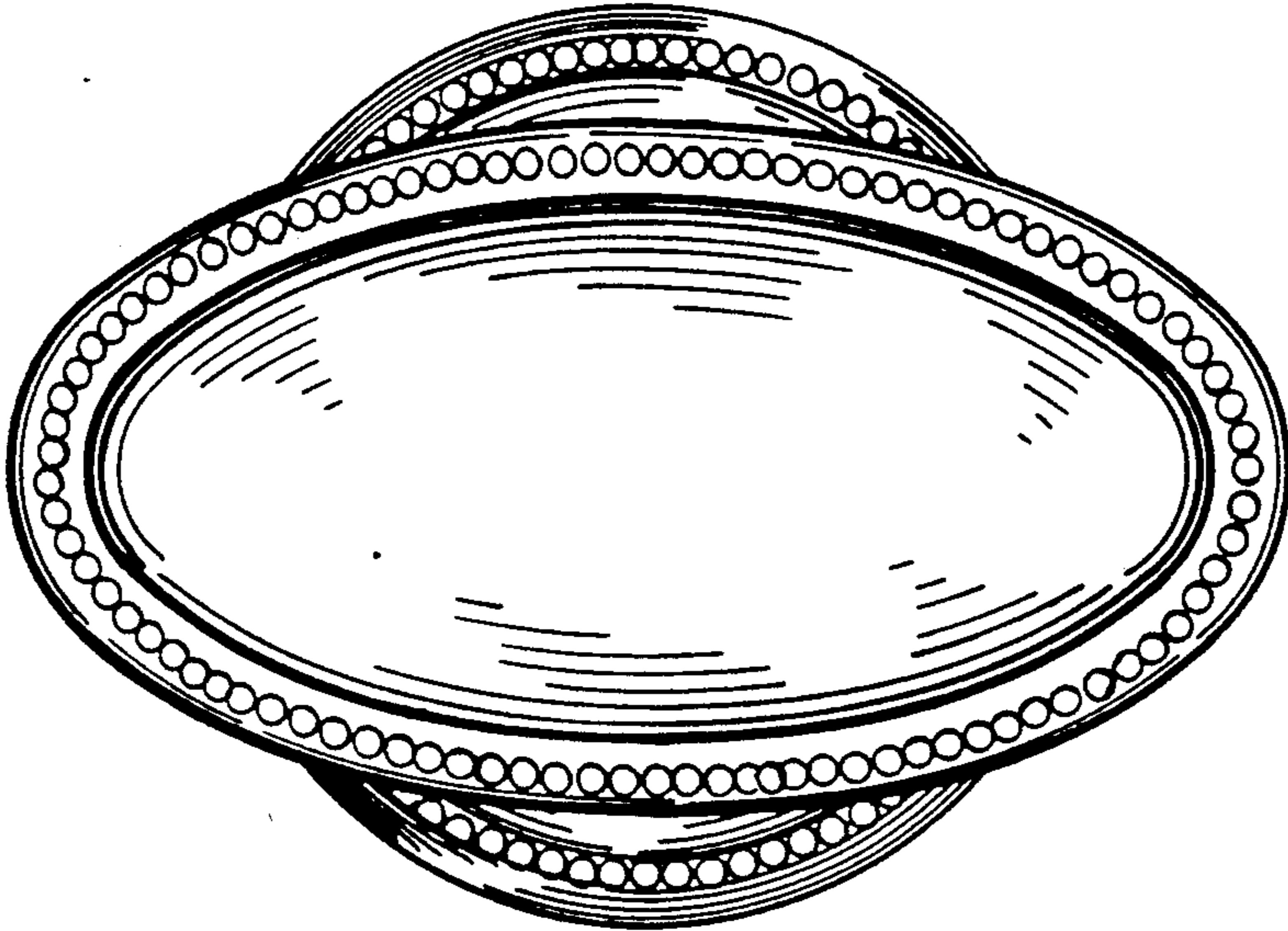

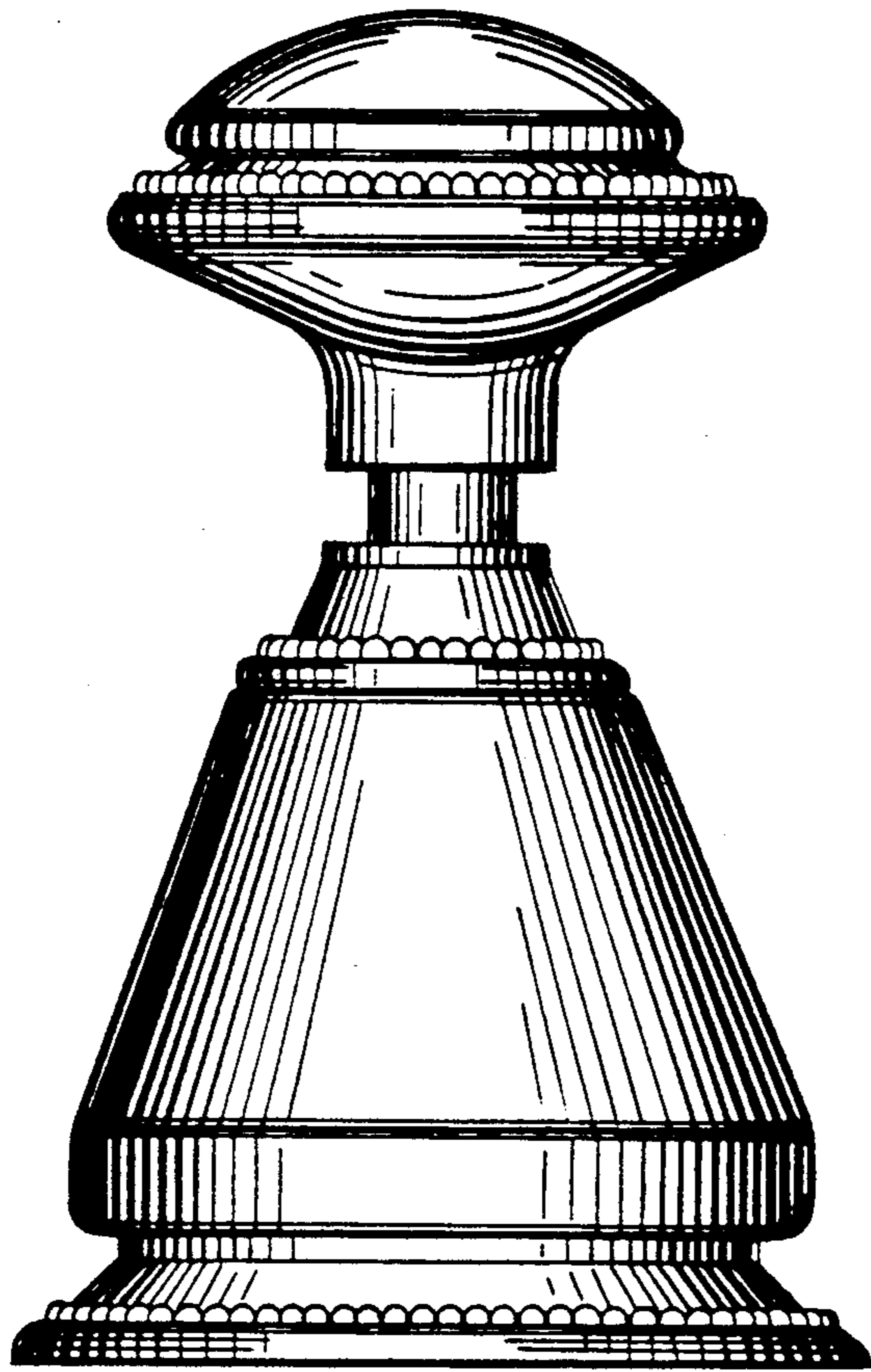

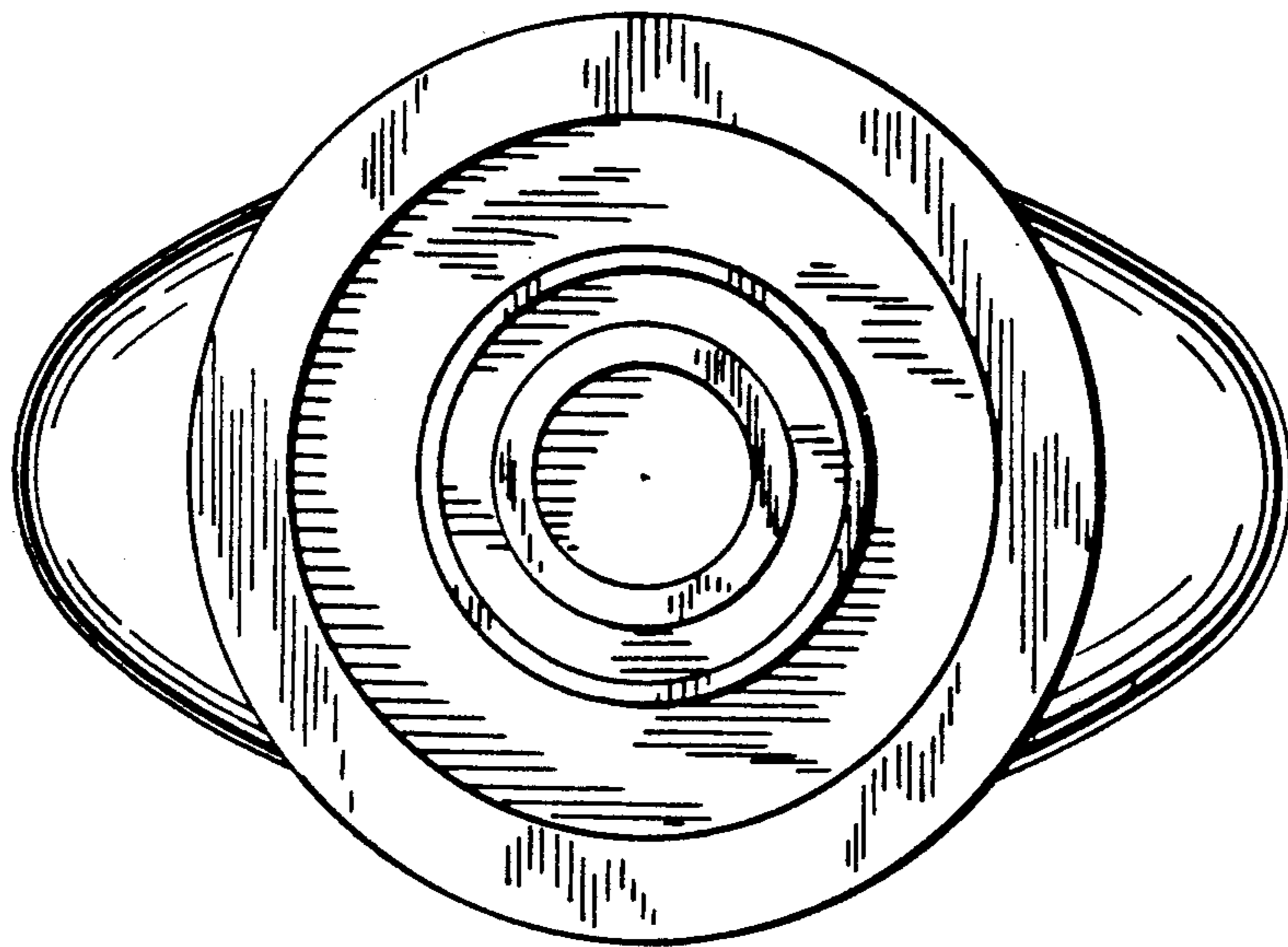

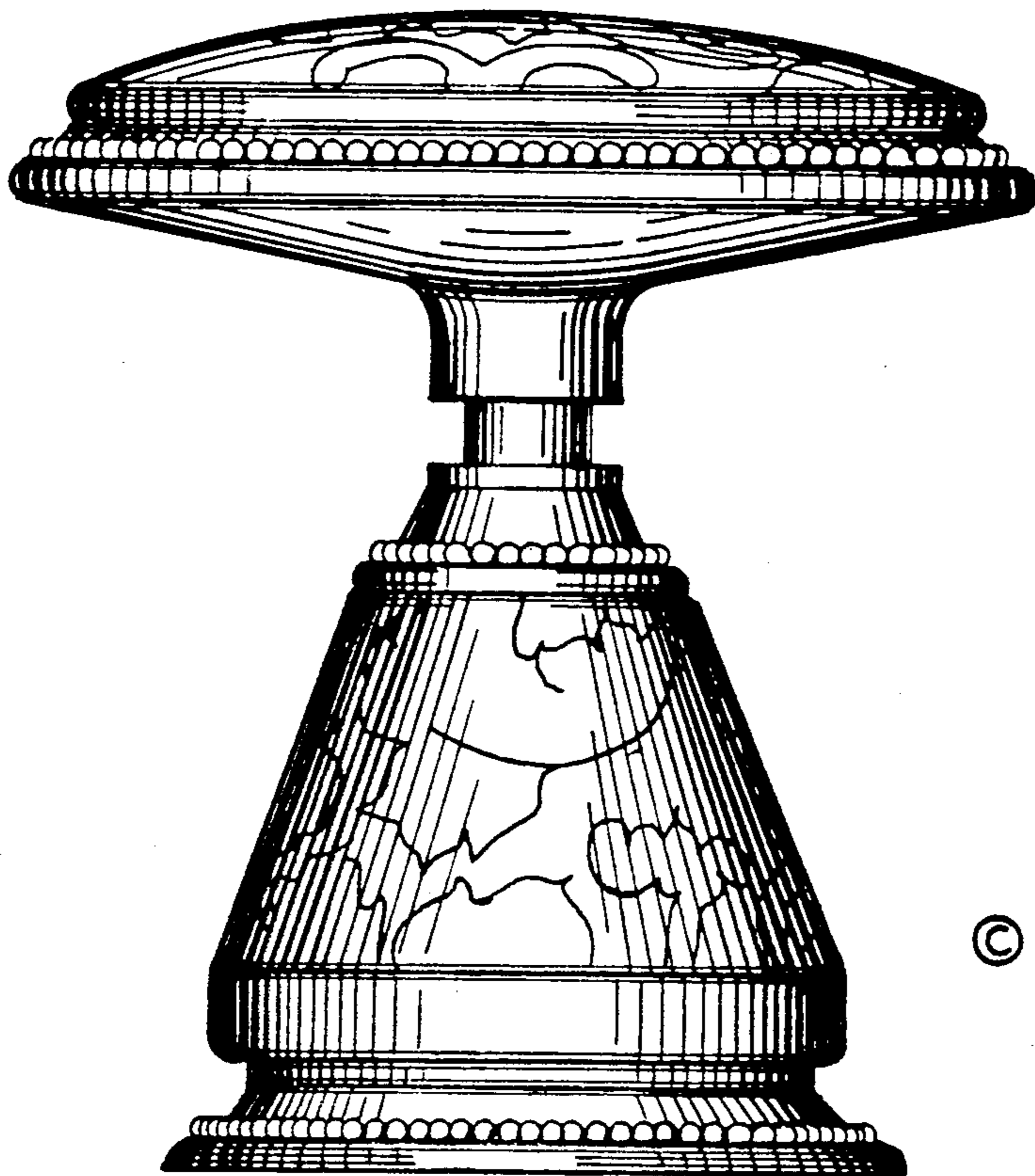

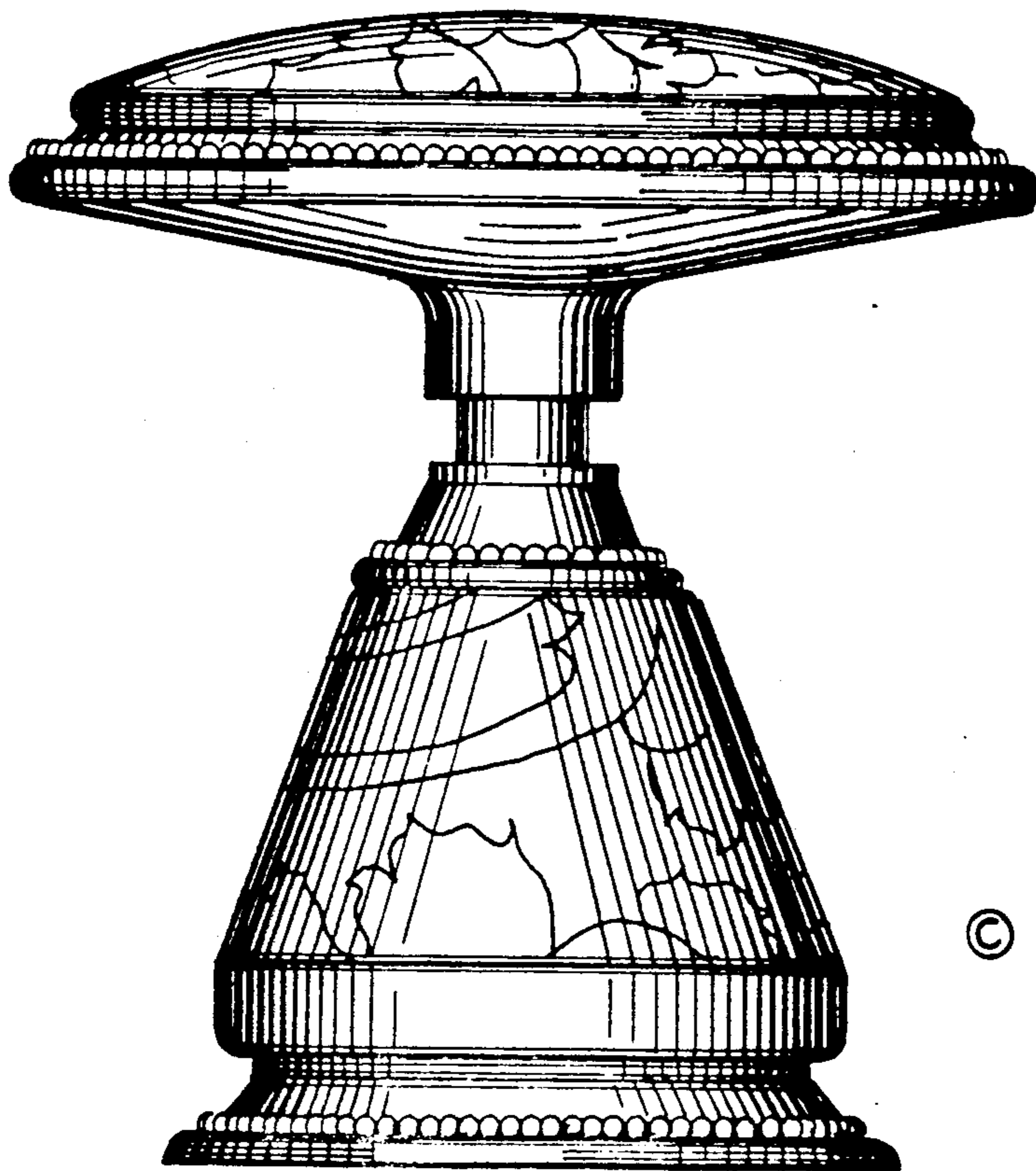
