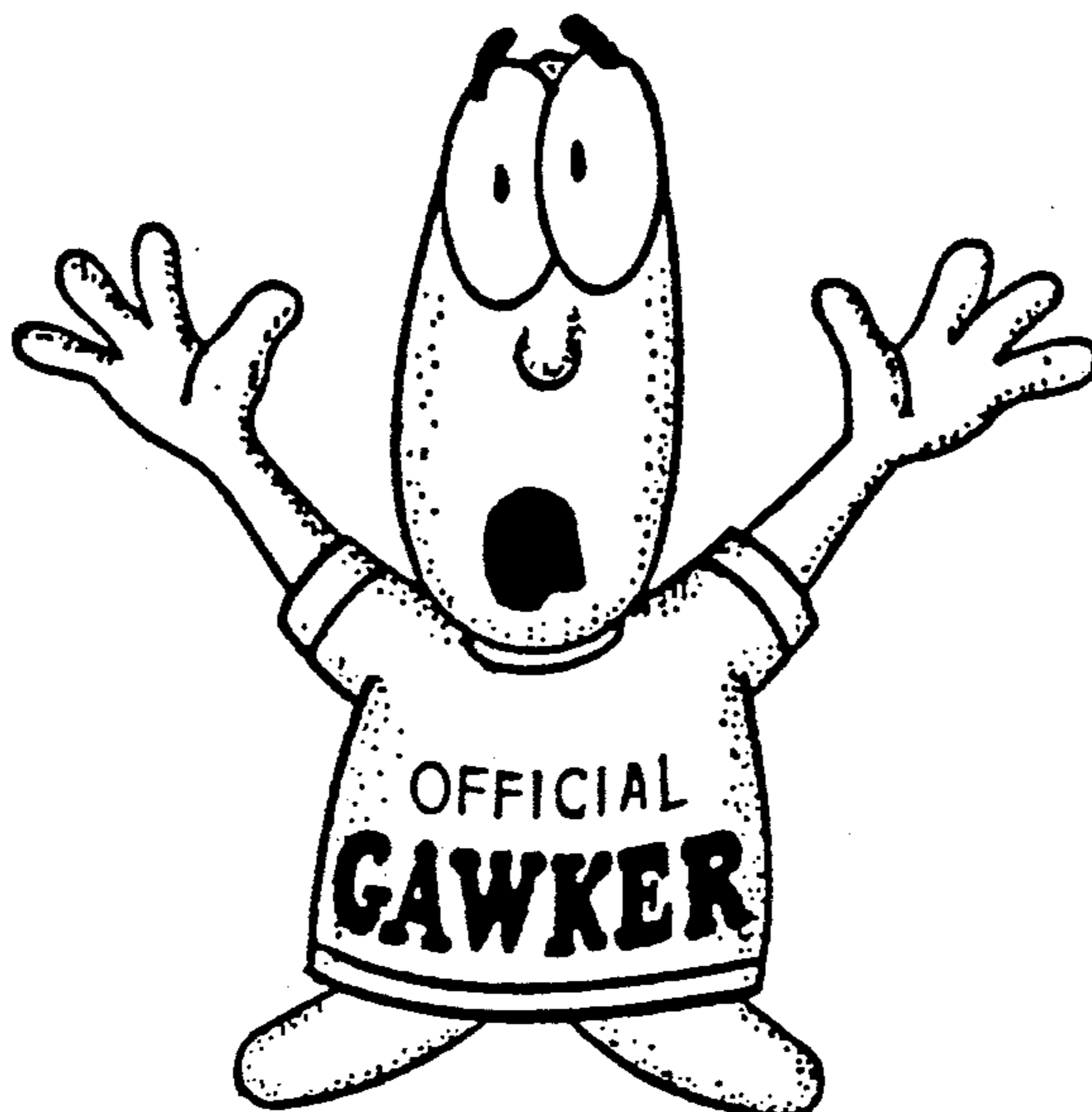

The ornamental design for a doll or similar article, as shown and described.

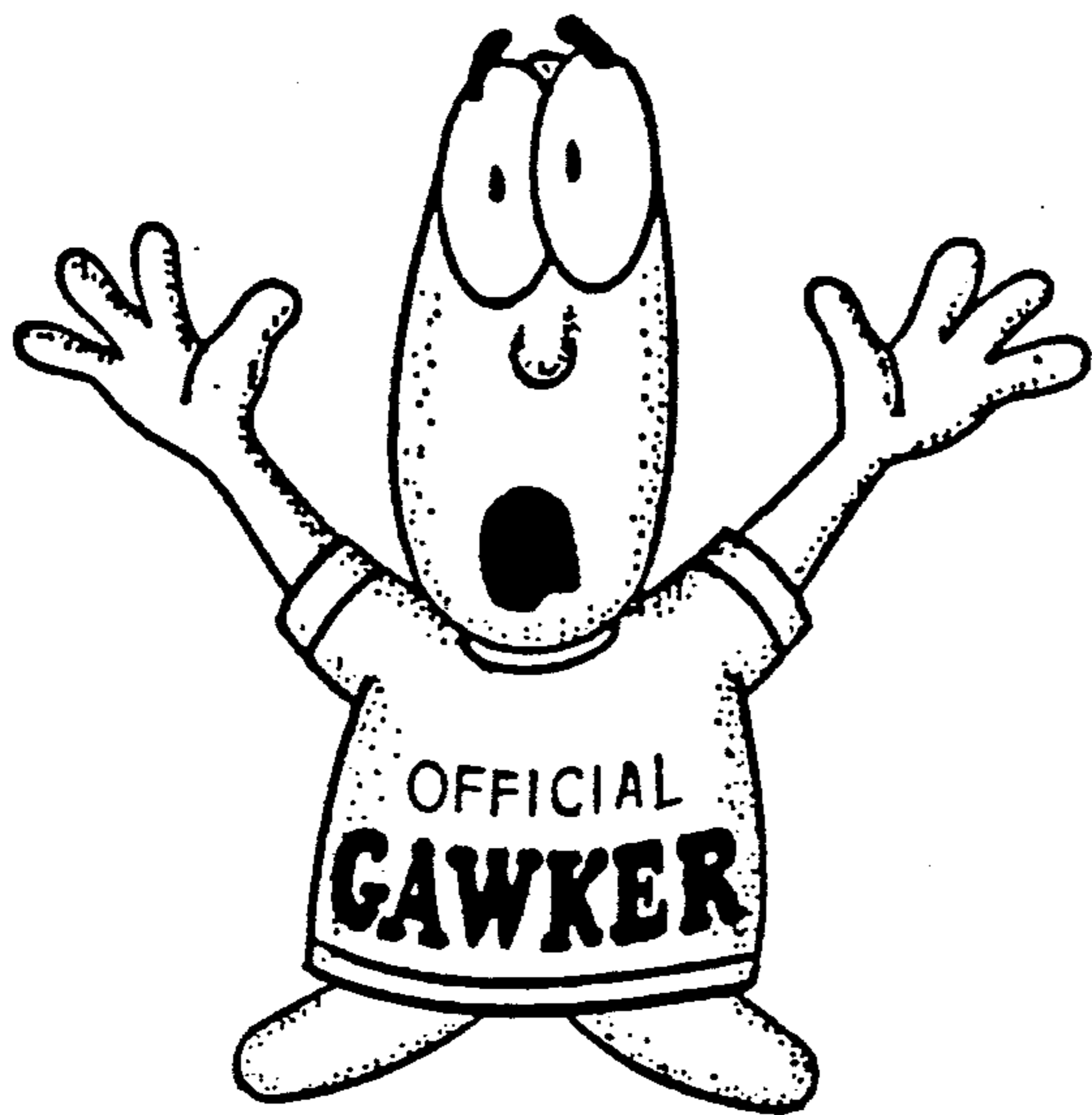

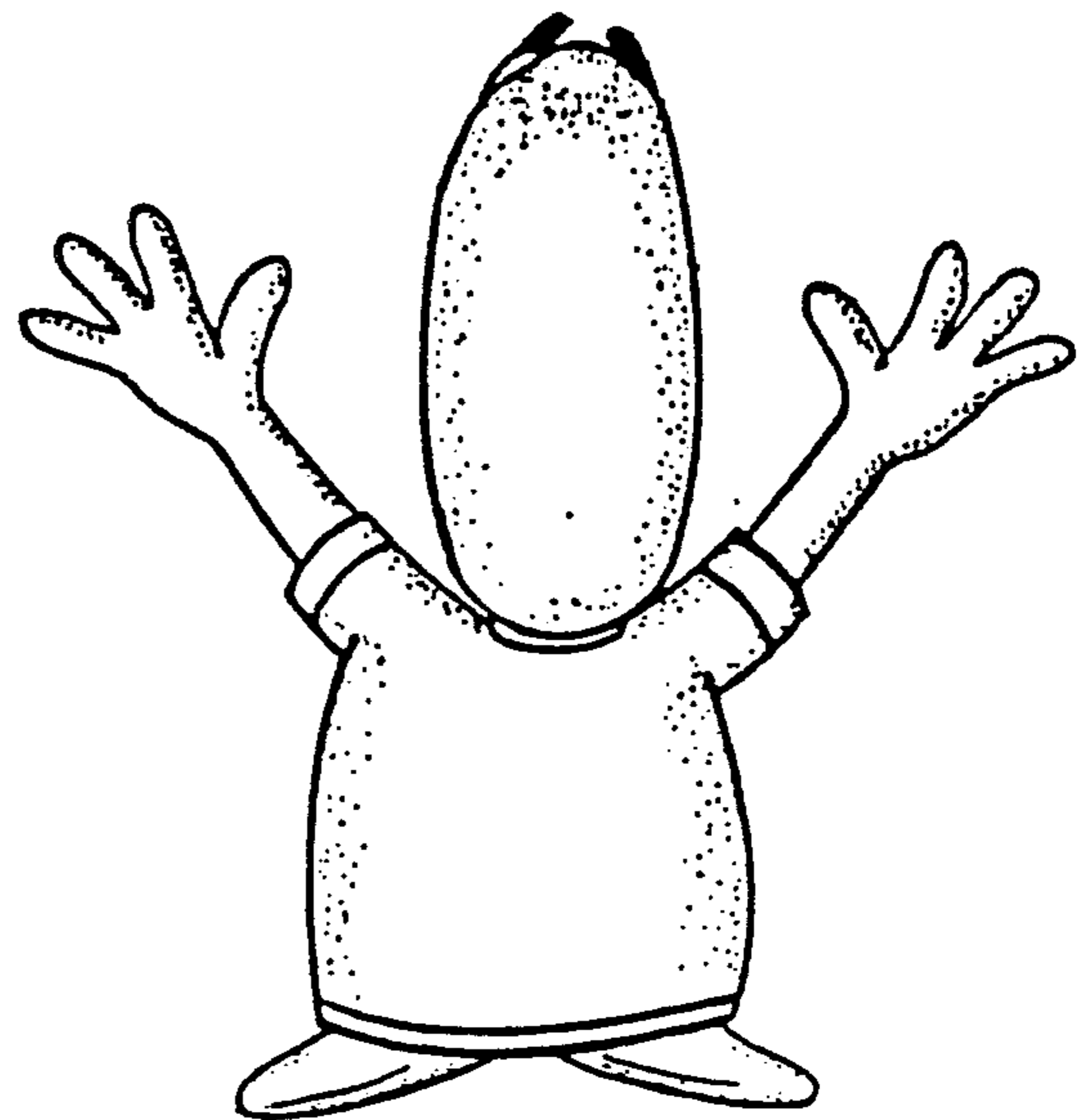

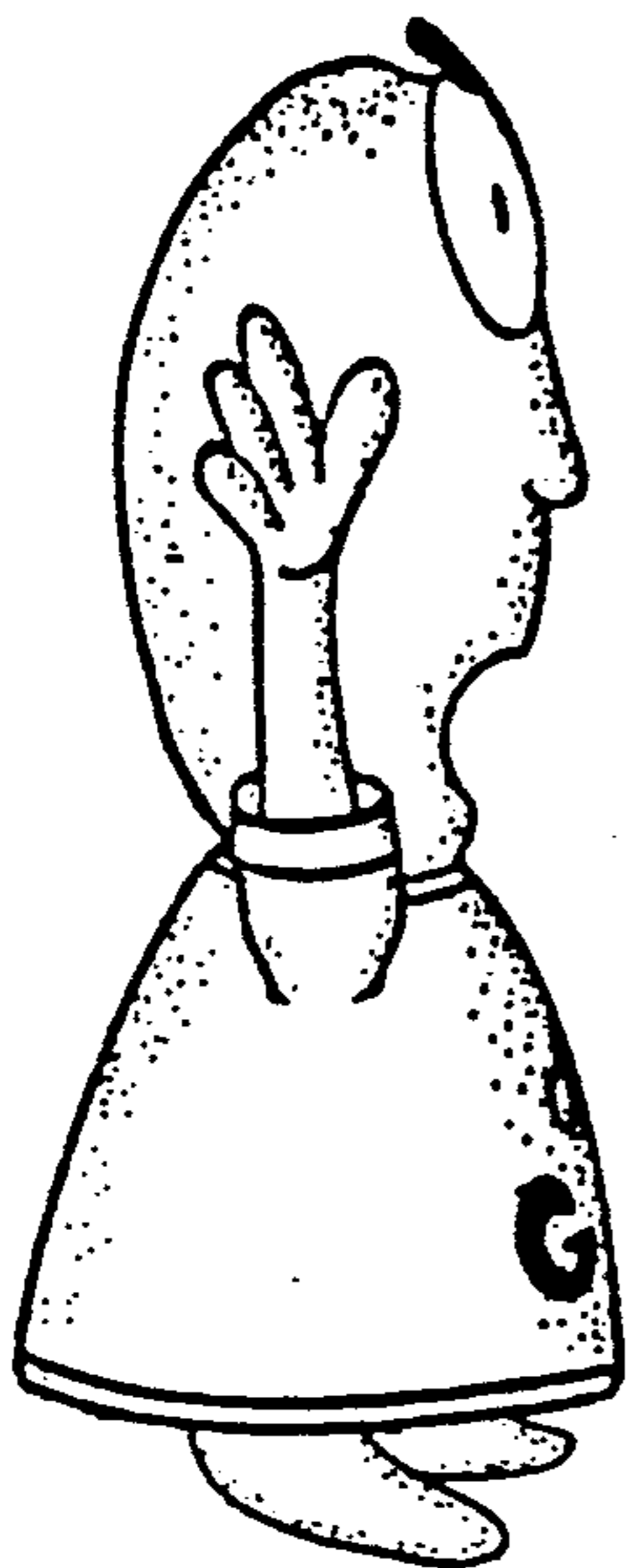

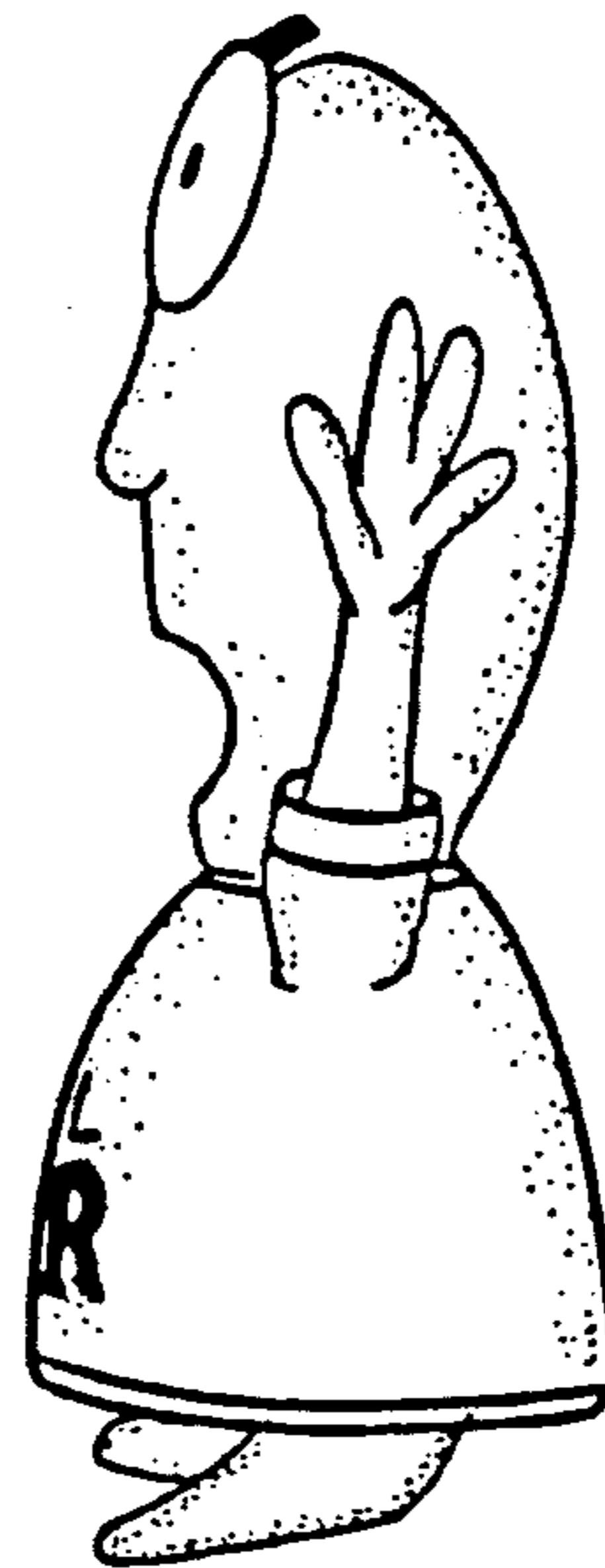

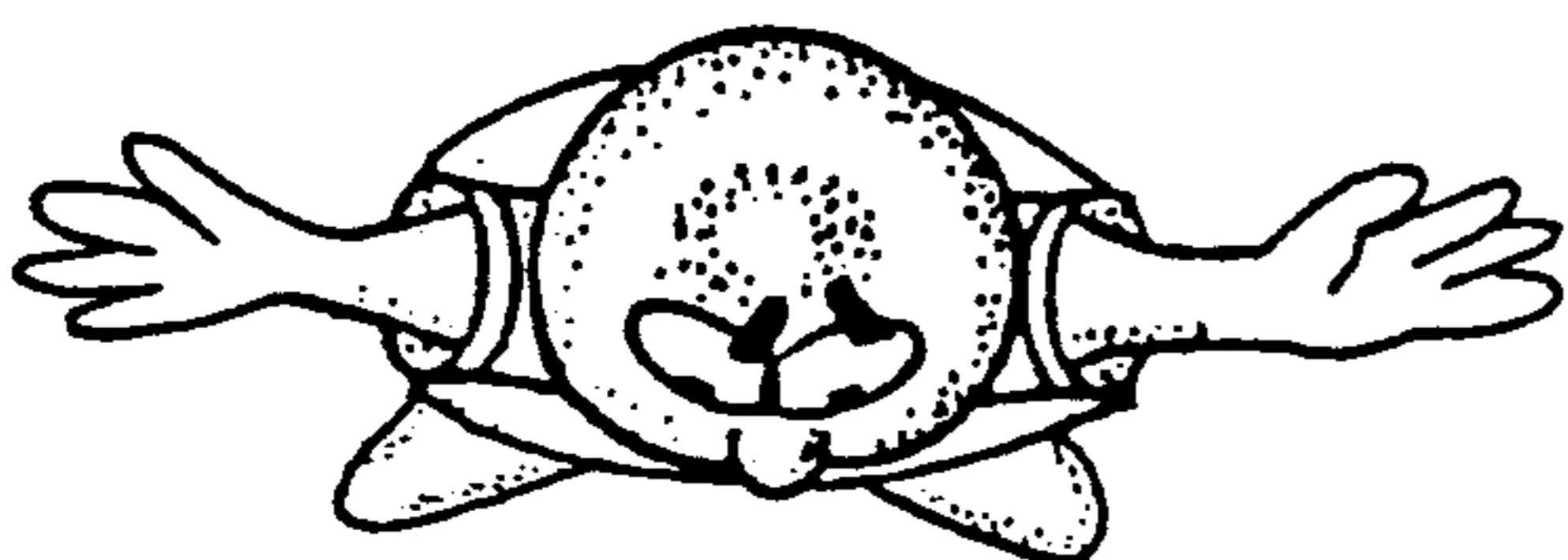

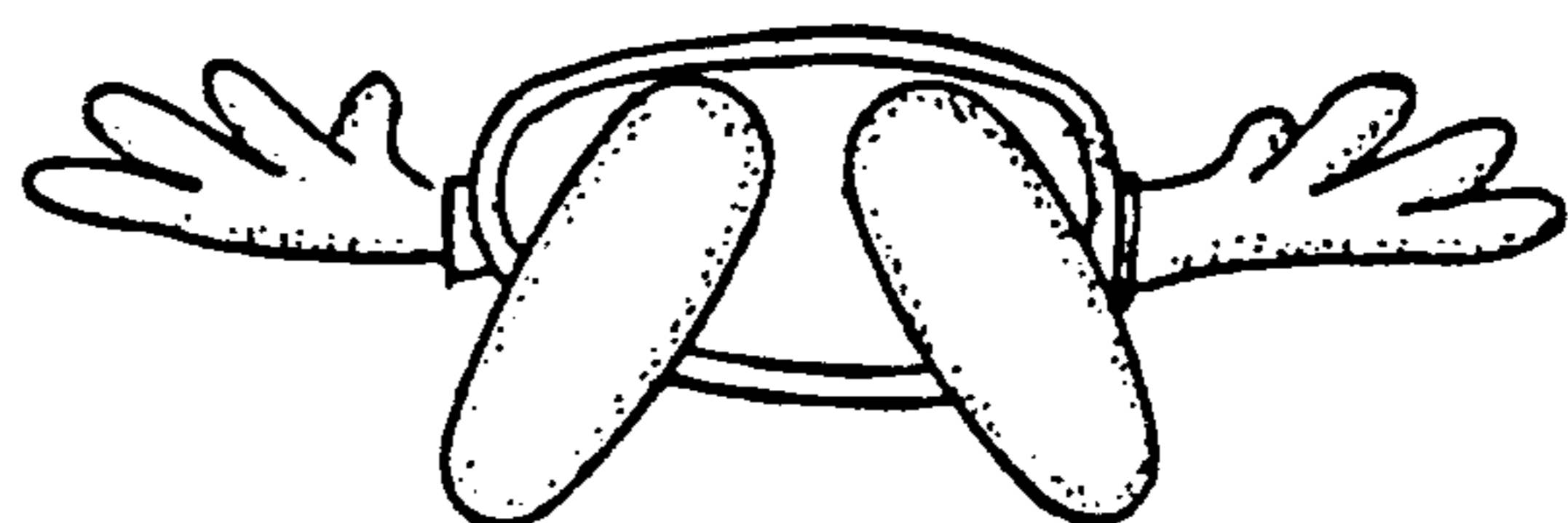

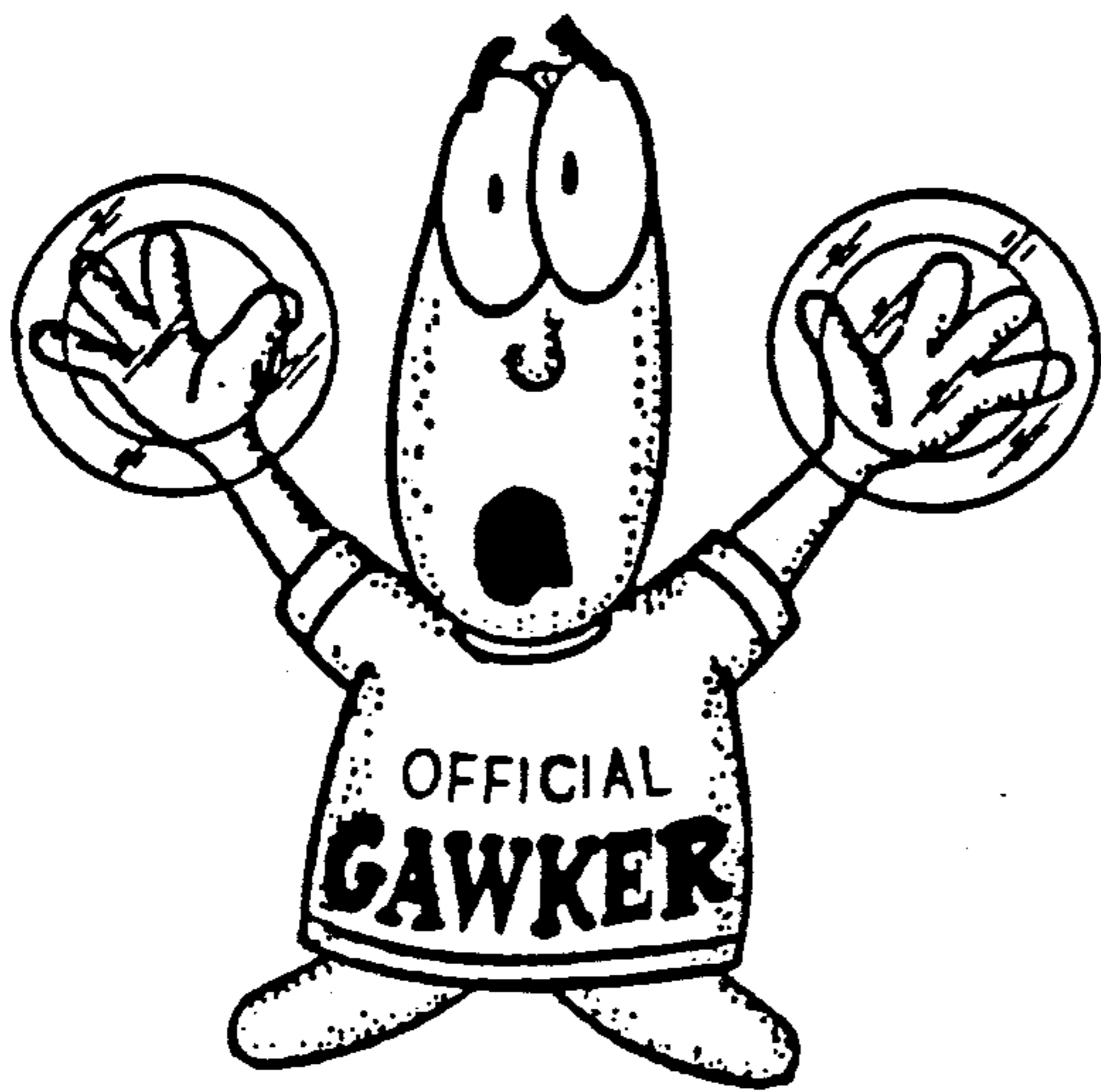

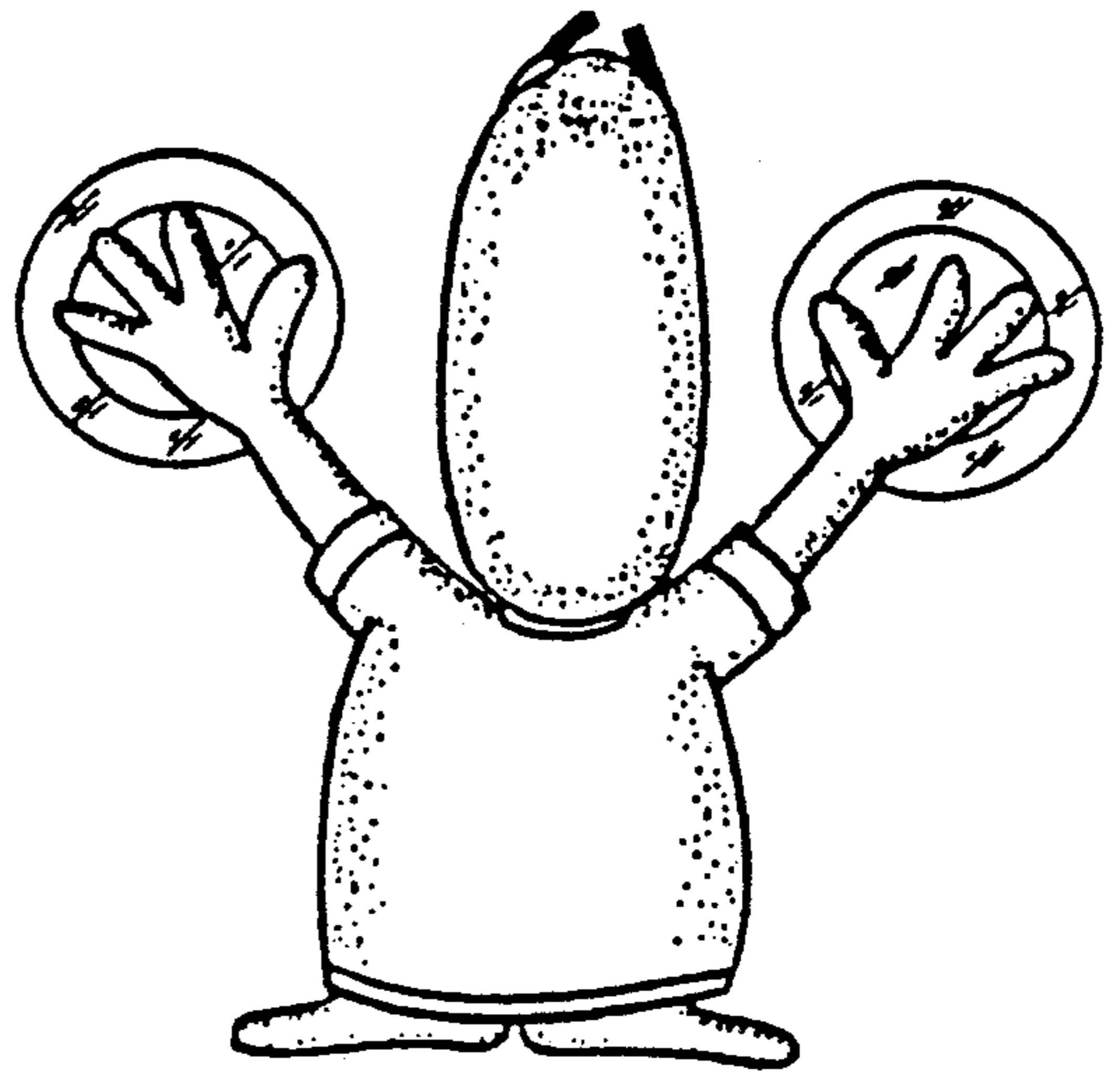

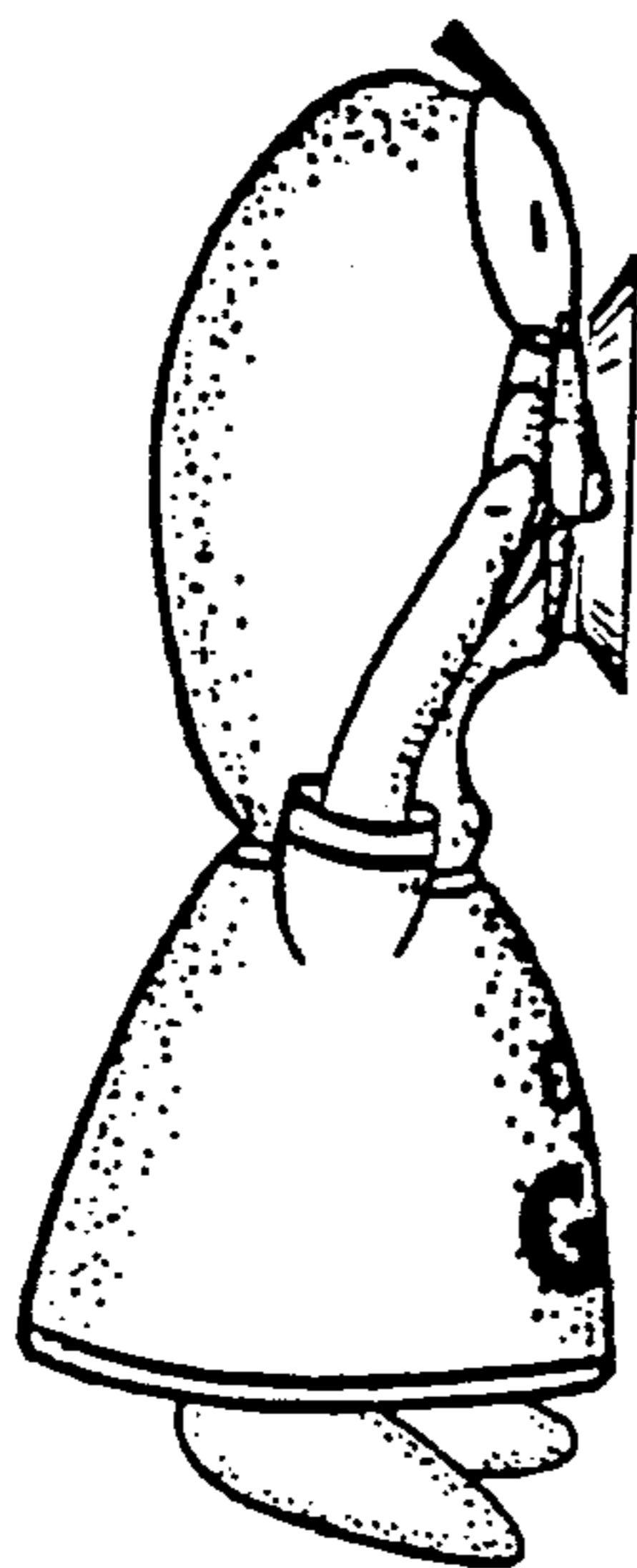

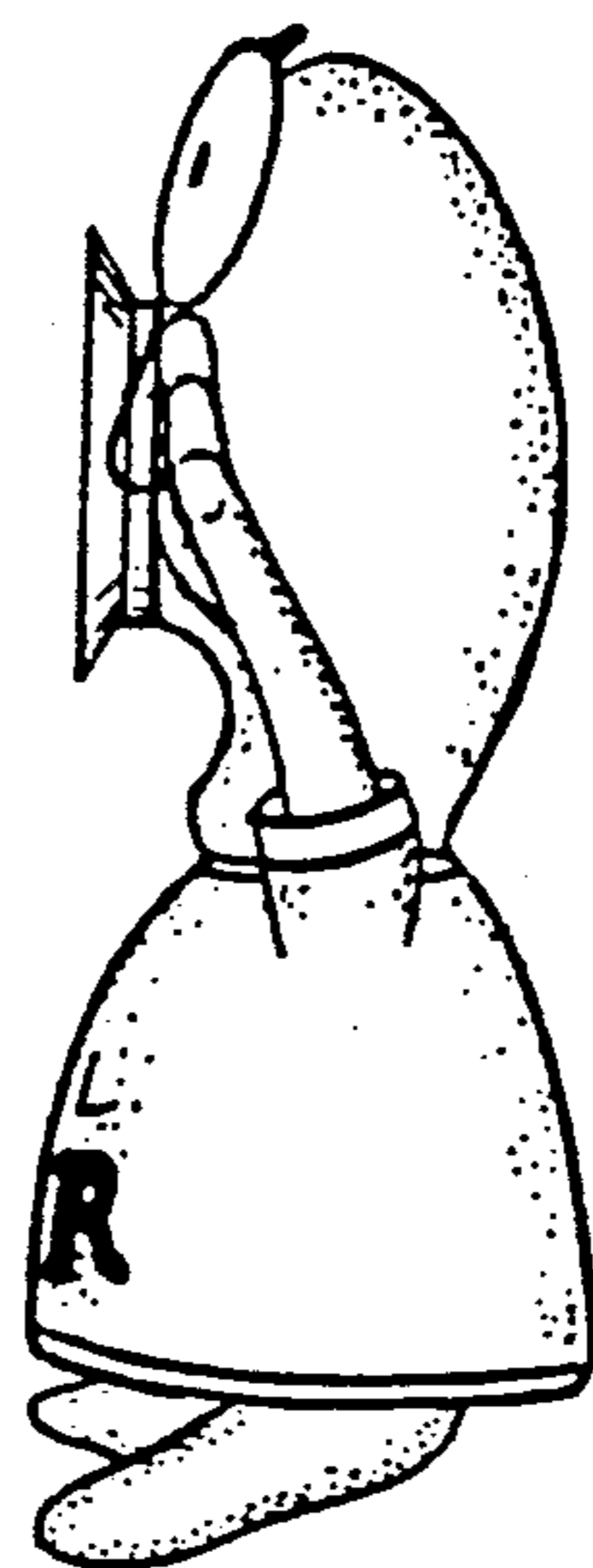

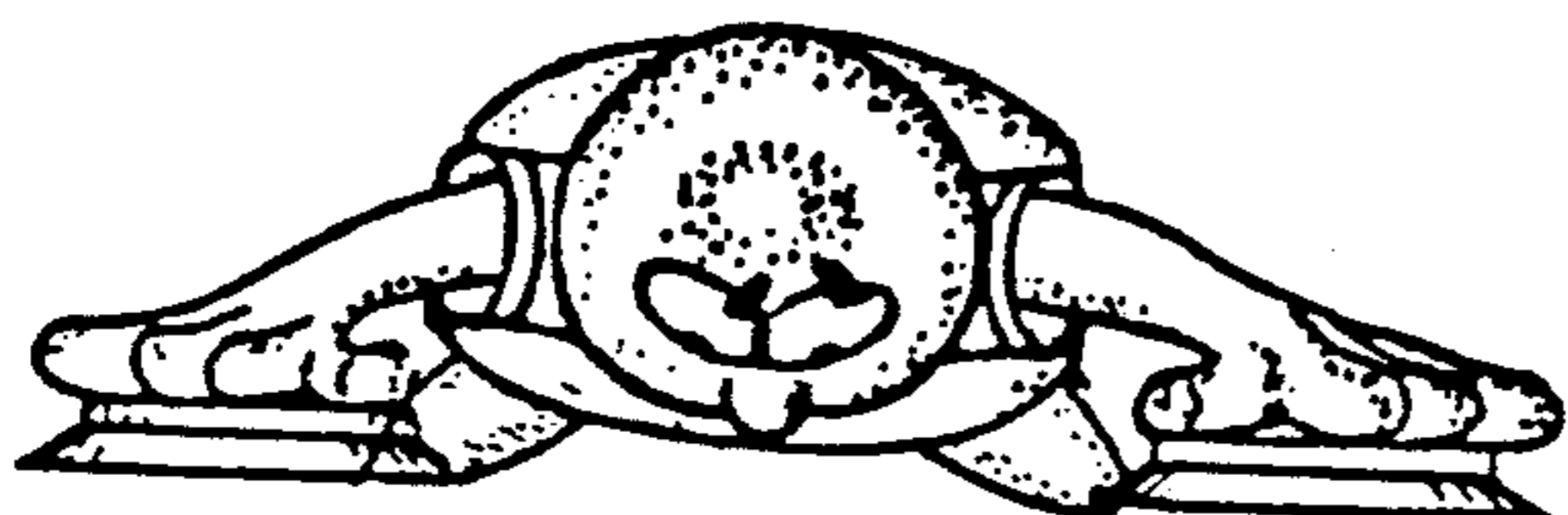

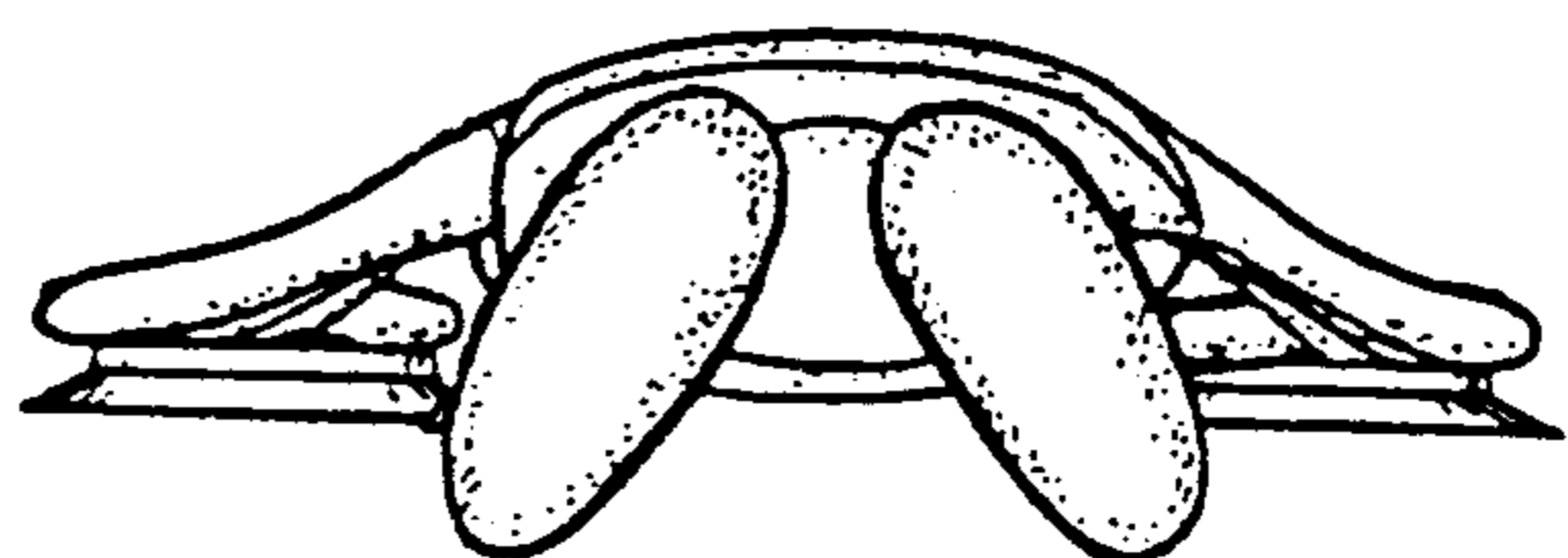

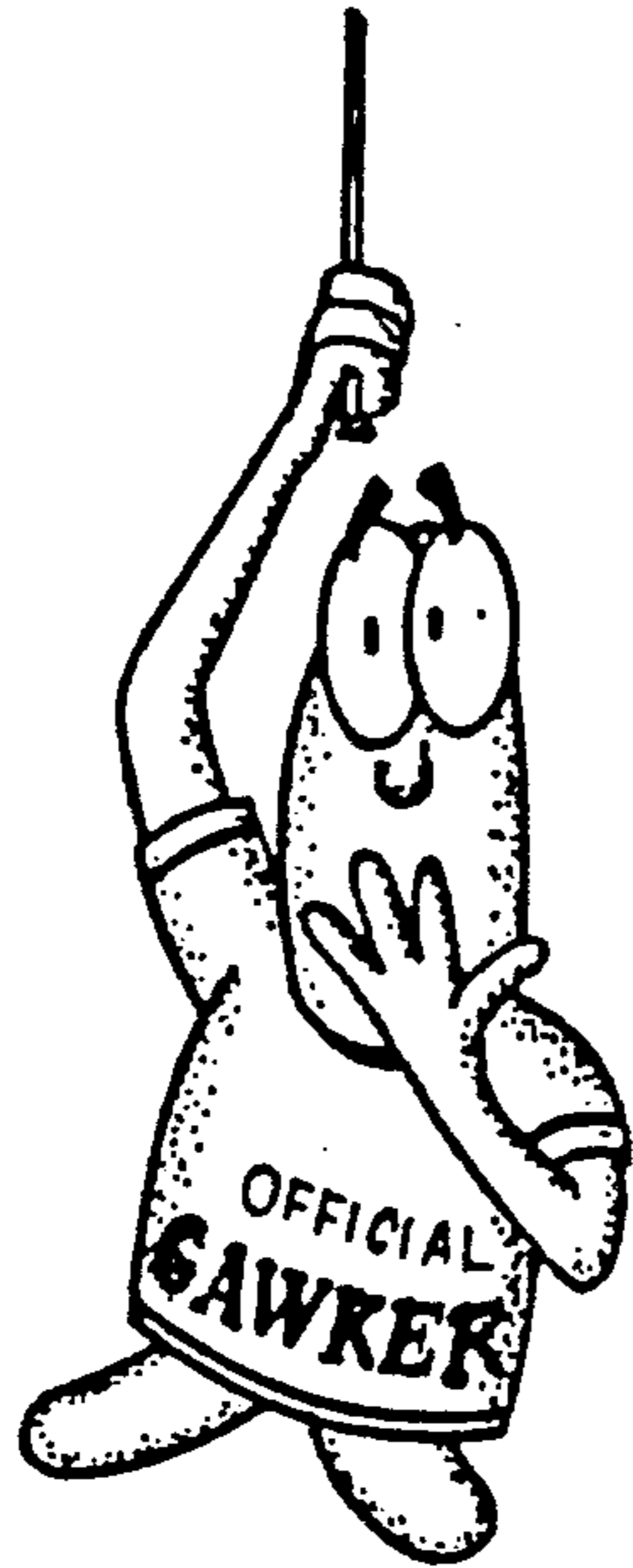

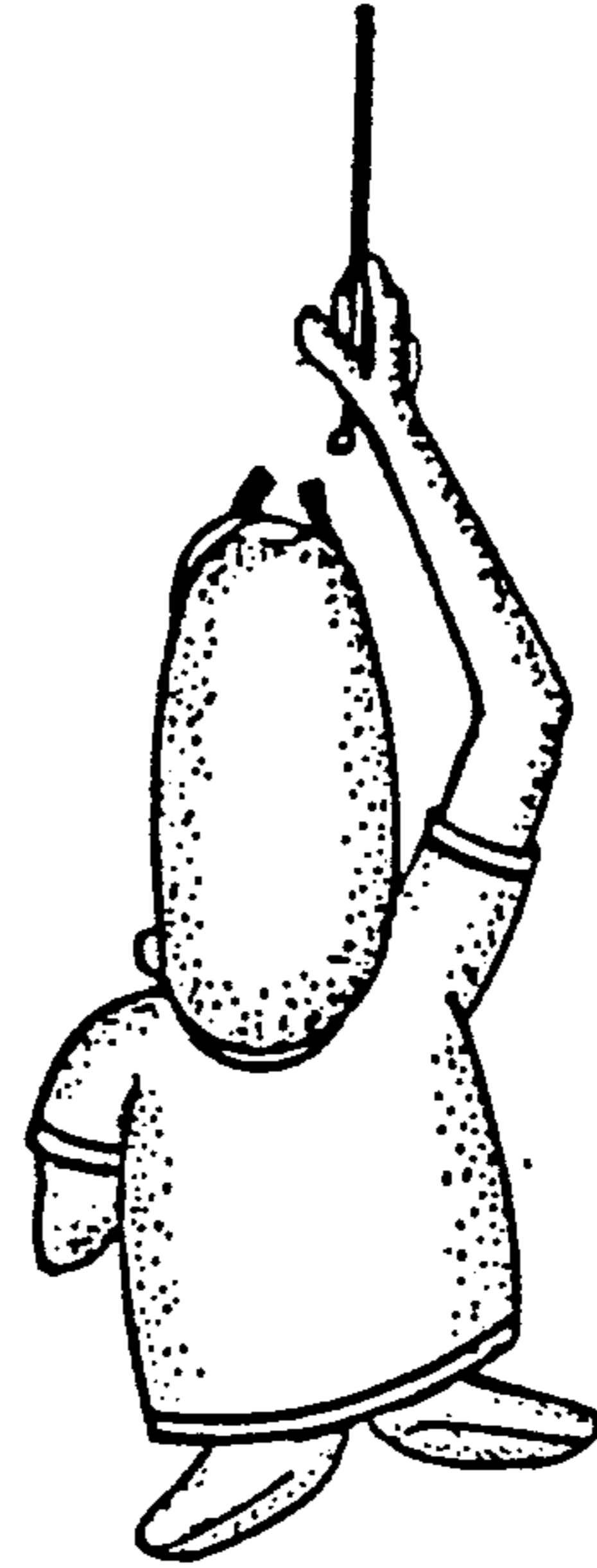

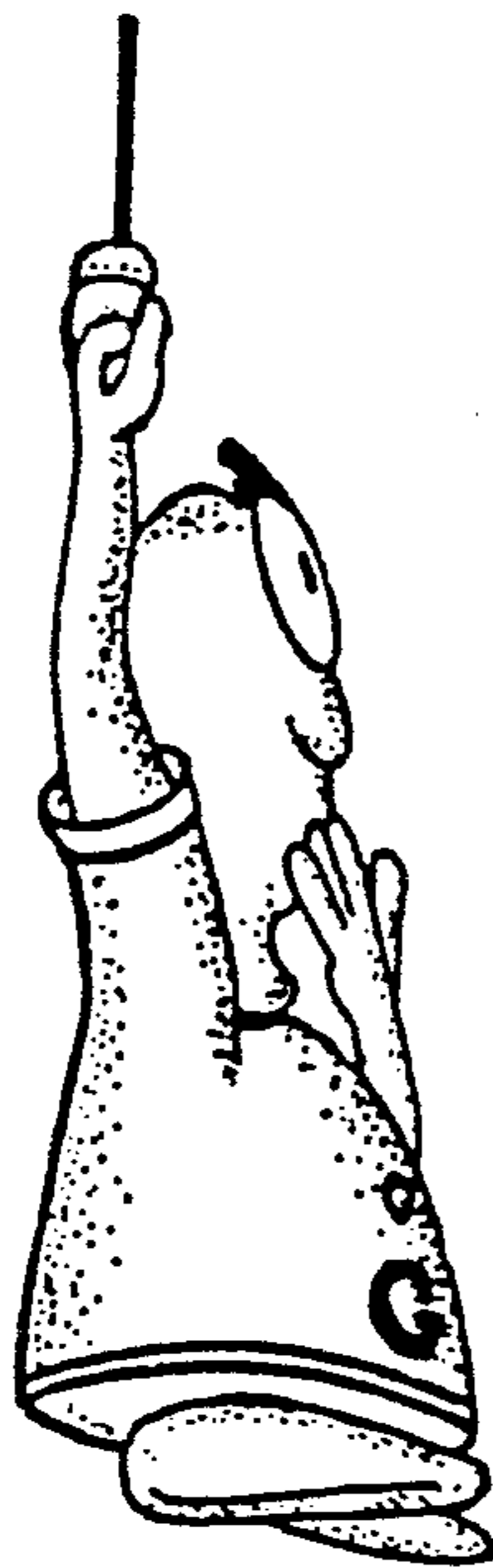

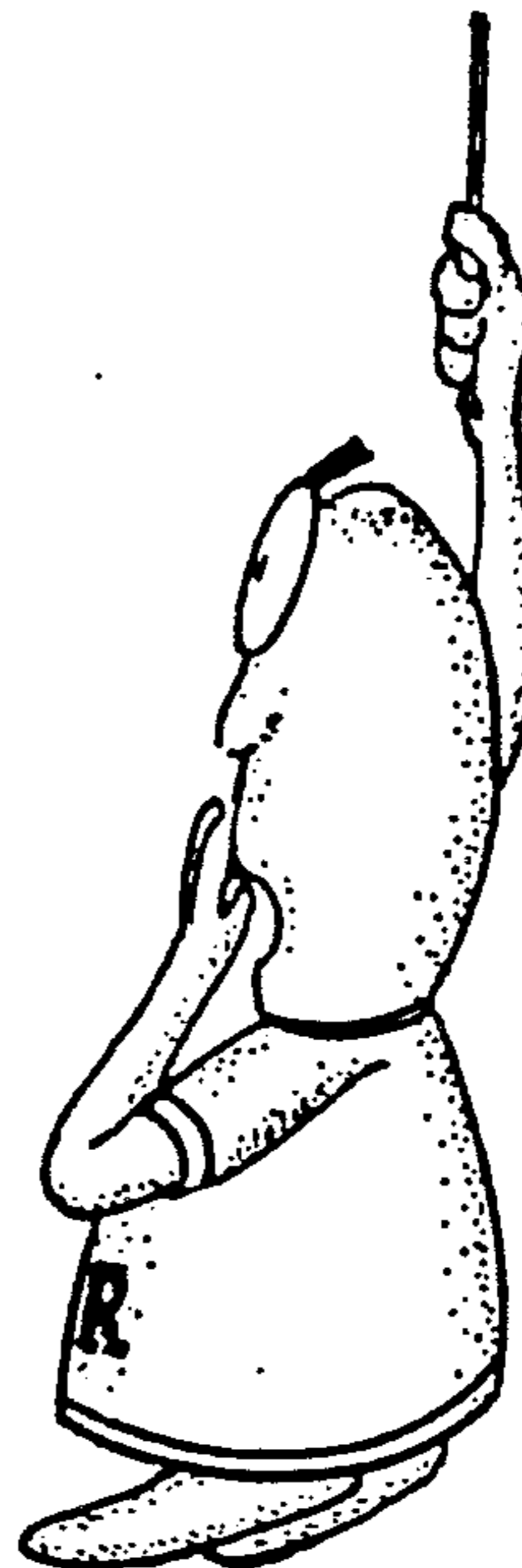

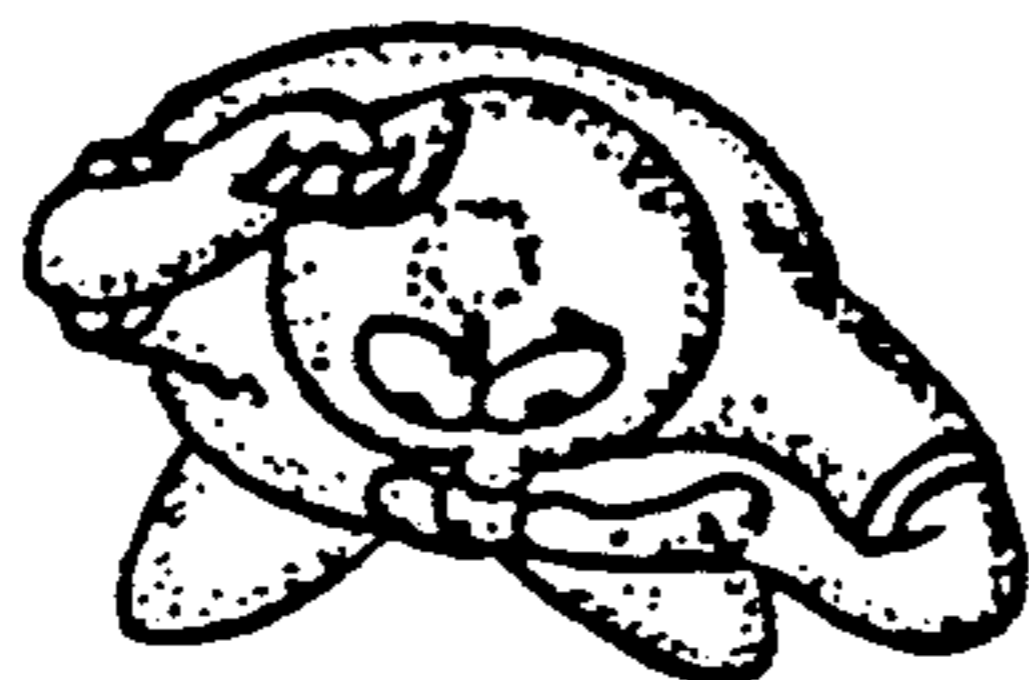

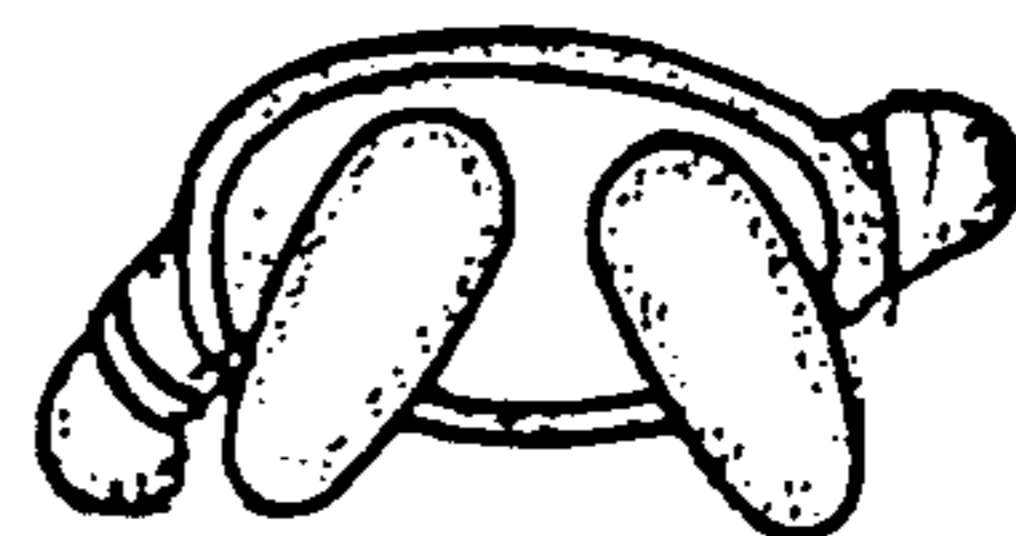

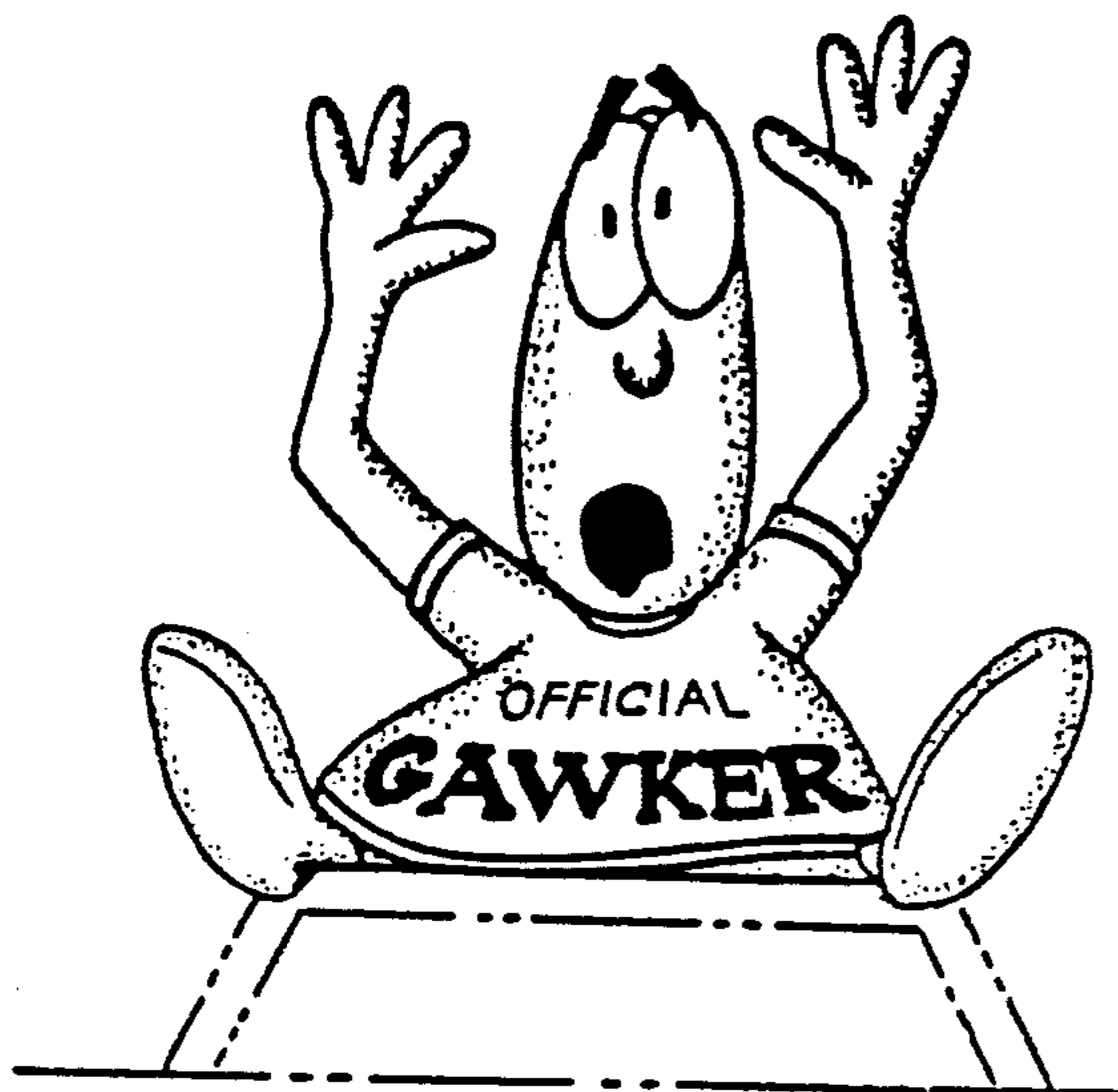

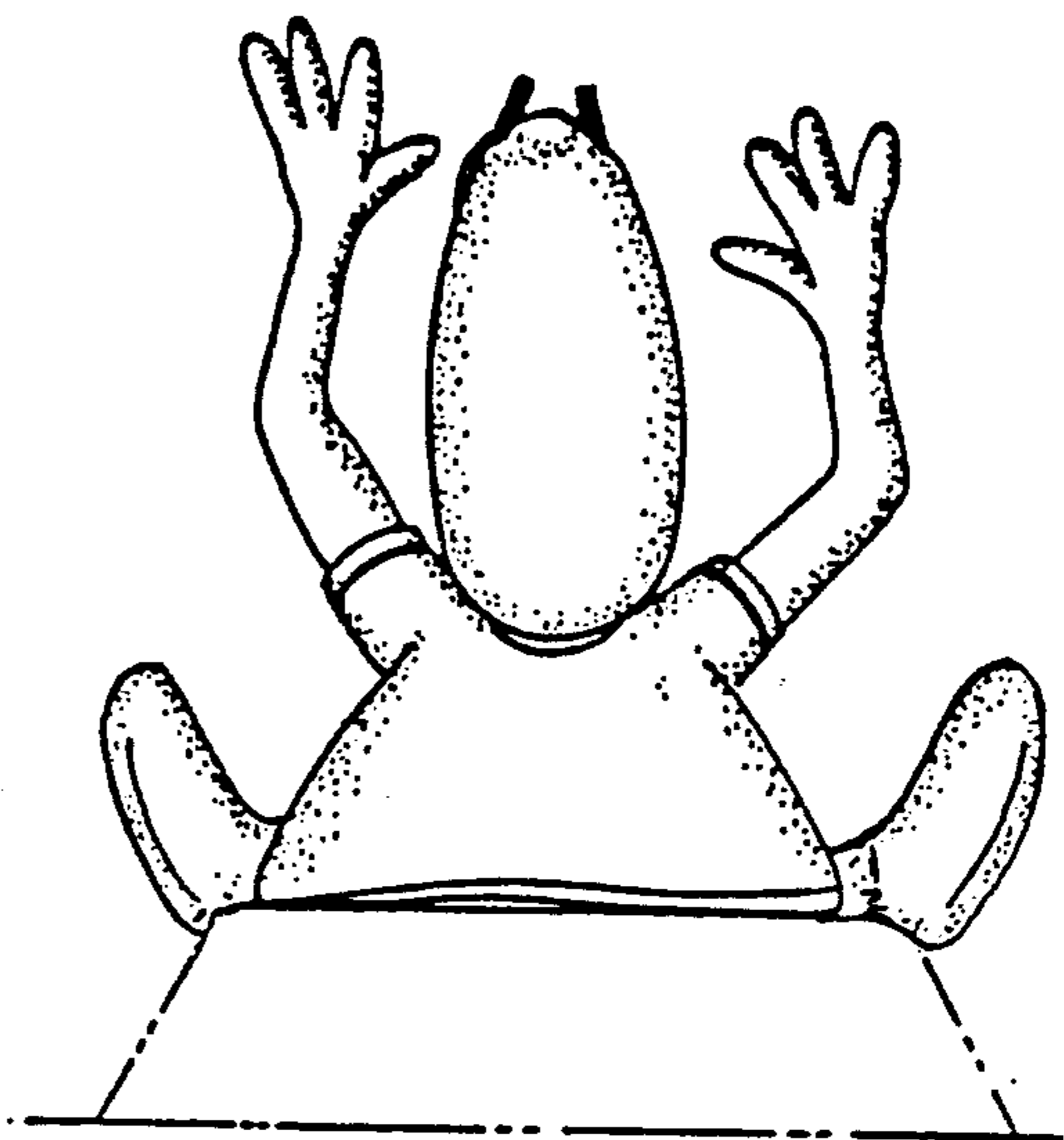

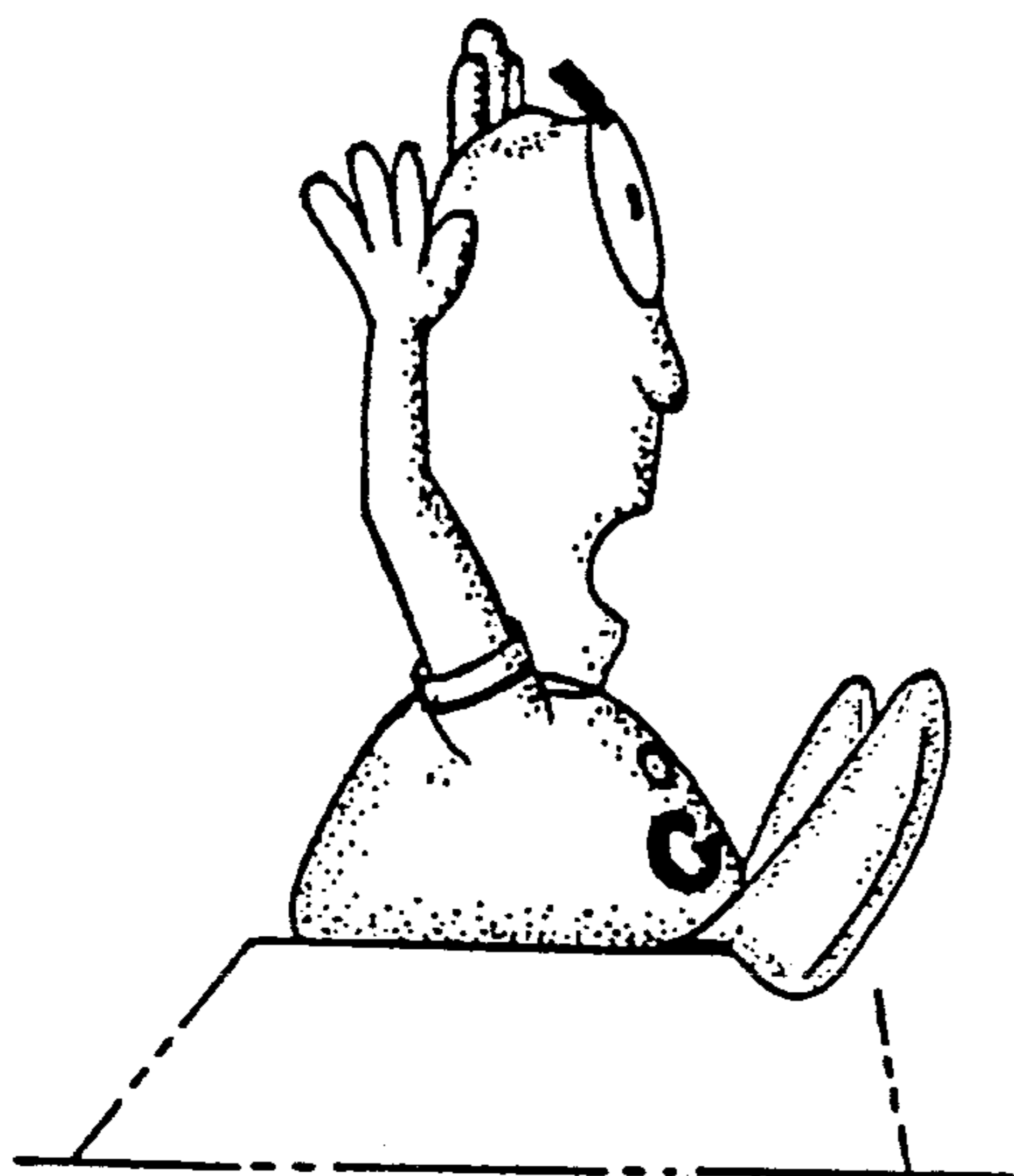

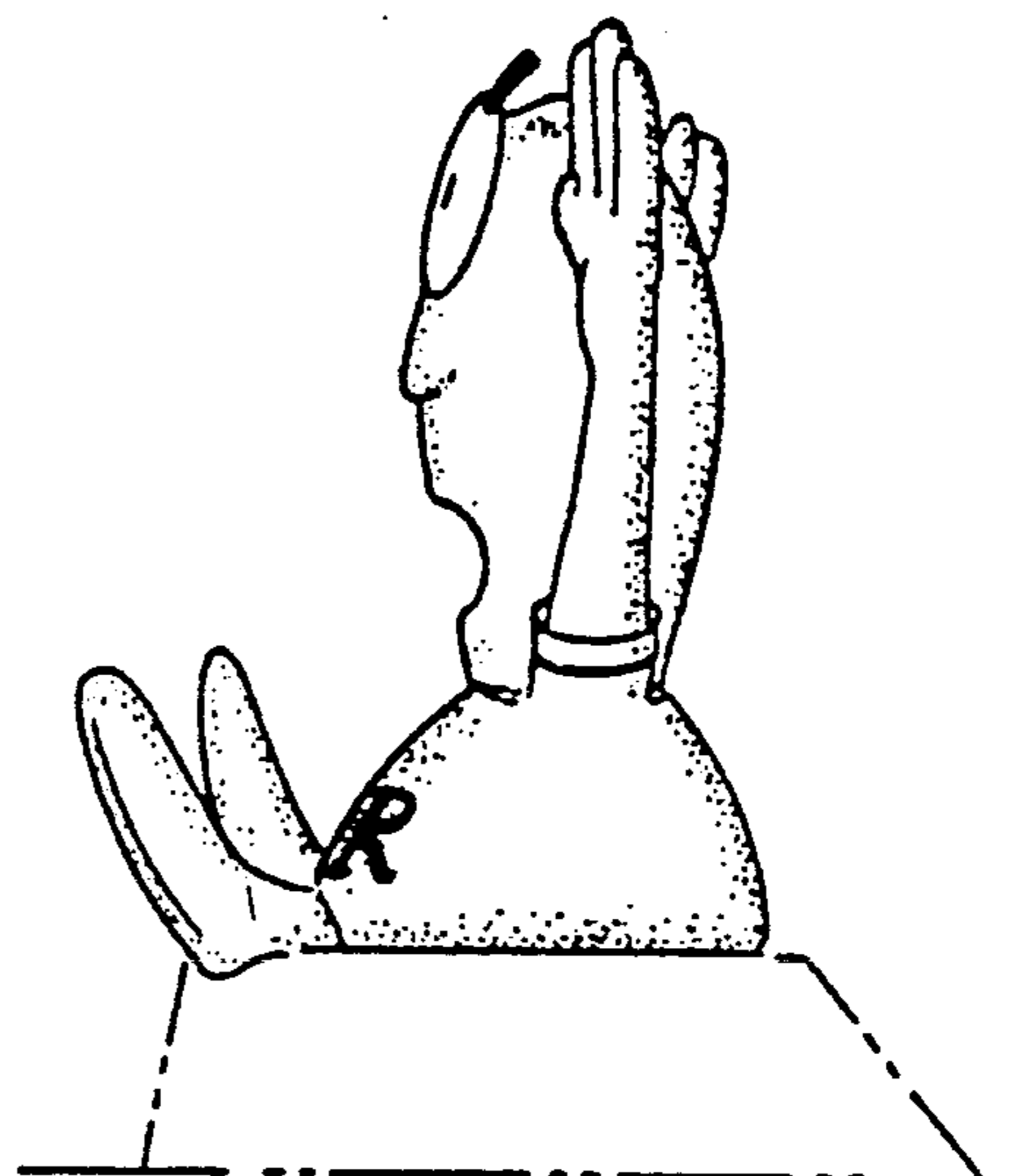

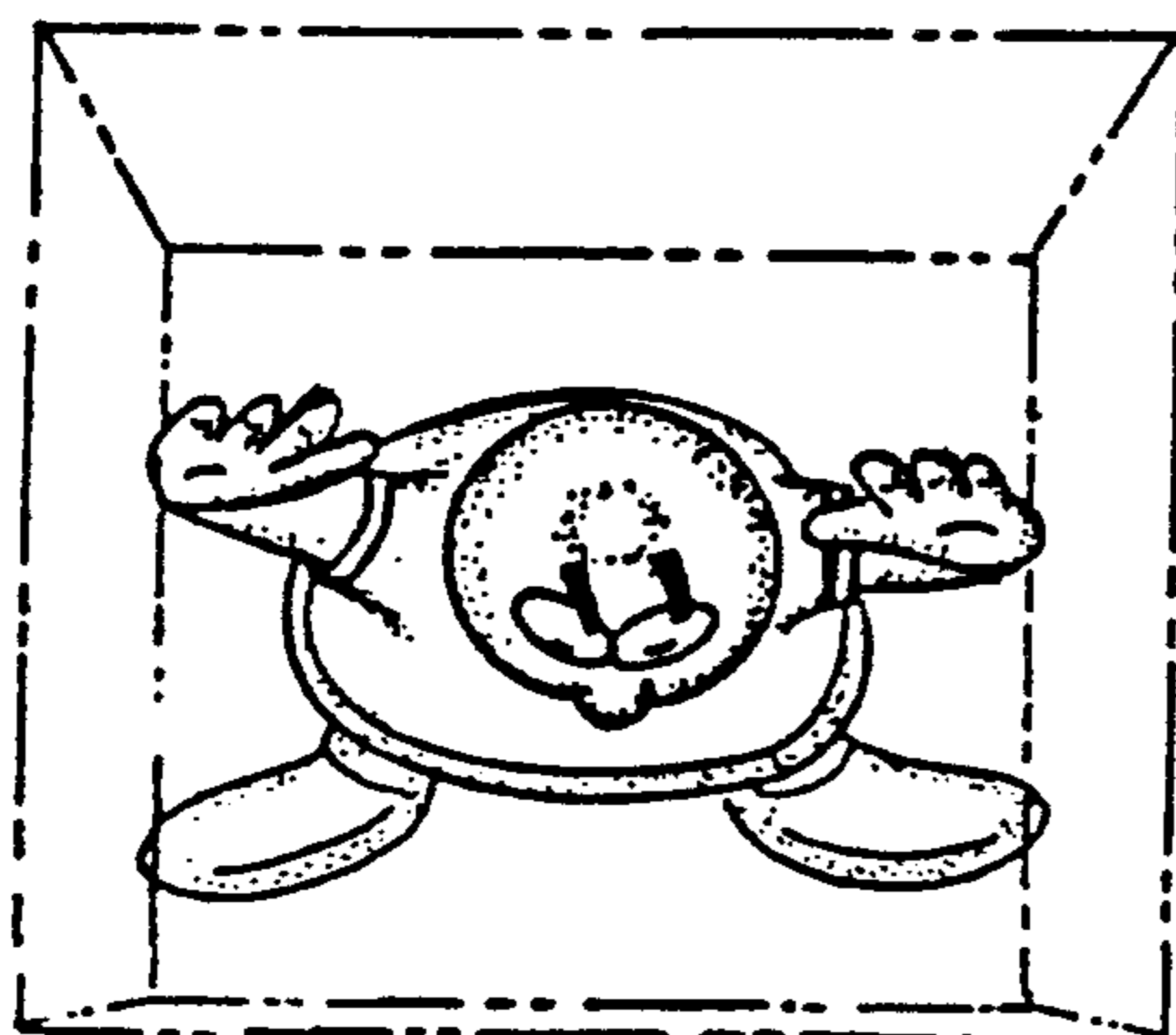

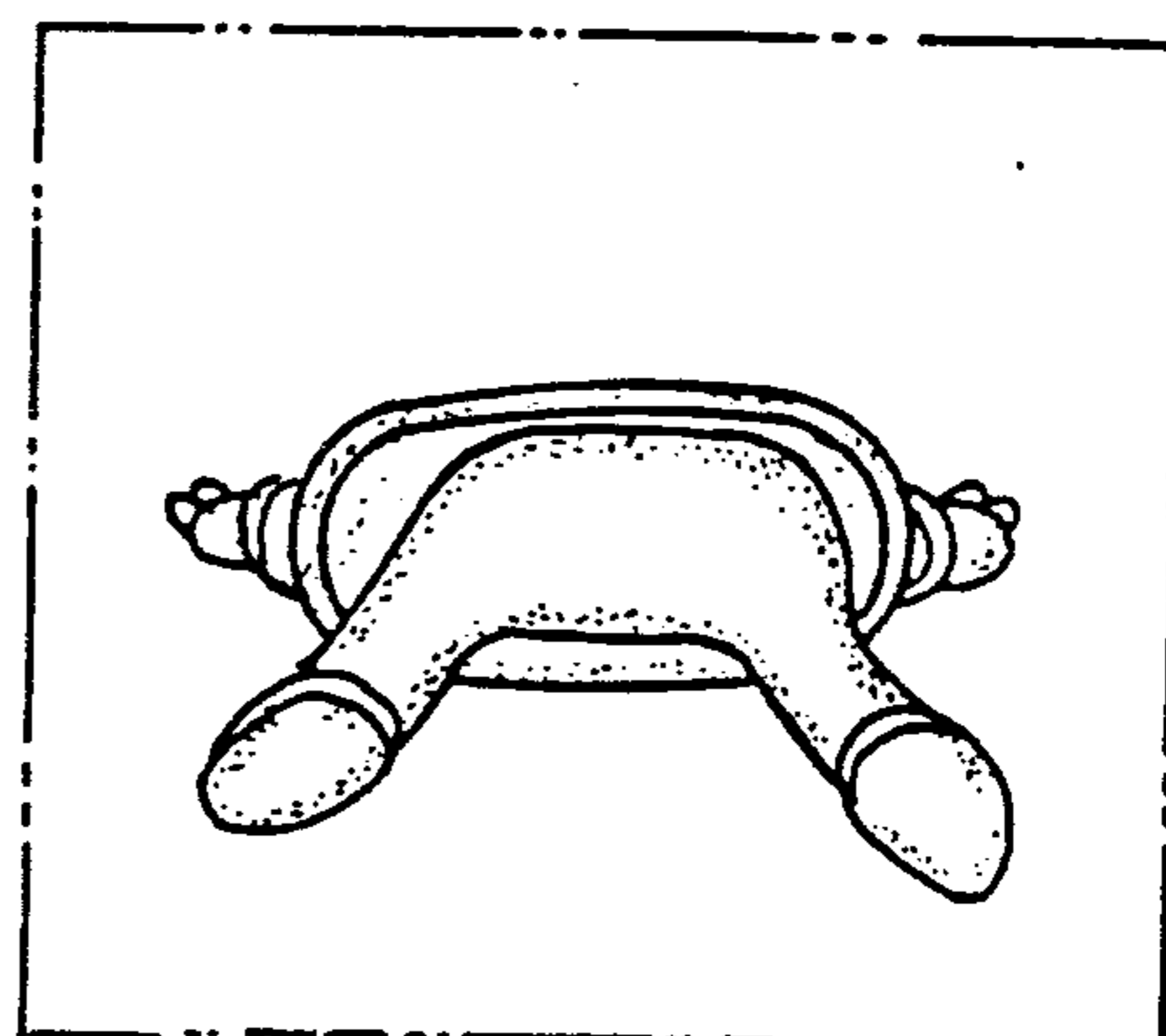
