[57] **CLAIM**

The ornamental design for a hanger for a bucket or a similar article, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and right side perspective view of as a hanger for a bucket or a similar article showing my new design;

FIG. 2 is a front elevational vie thereof;

FIG. 3 is a right side elevational view thereof, the side opposite being a mirror image;

FIG. 4 is a rear elevational view thereof; and

FIGS. 5 and 6 are respectively top and bottom plan view thereof.

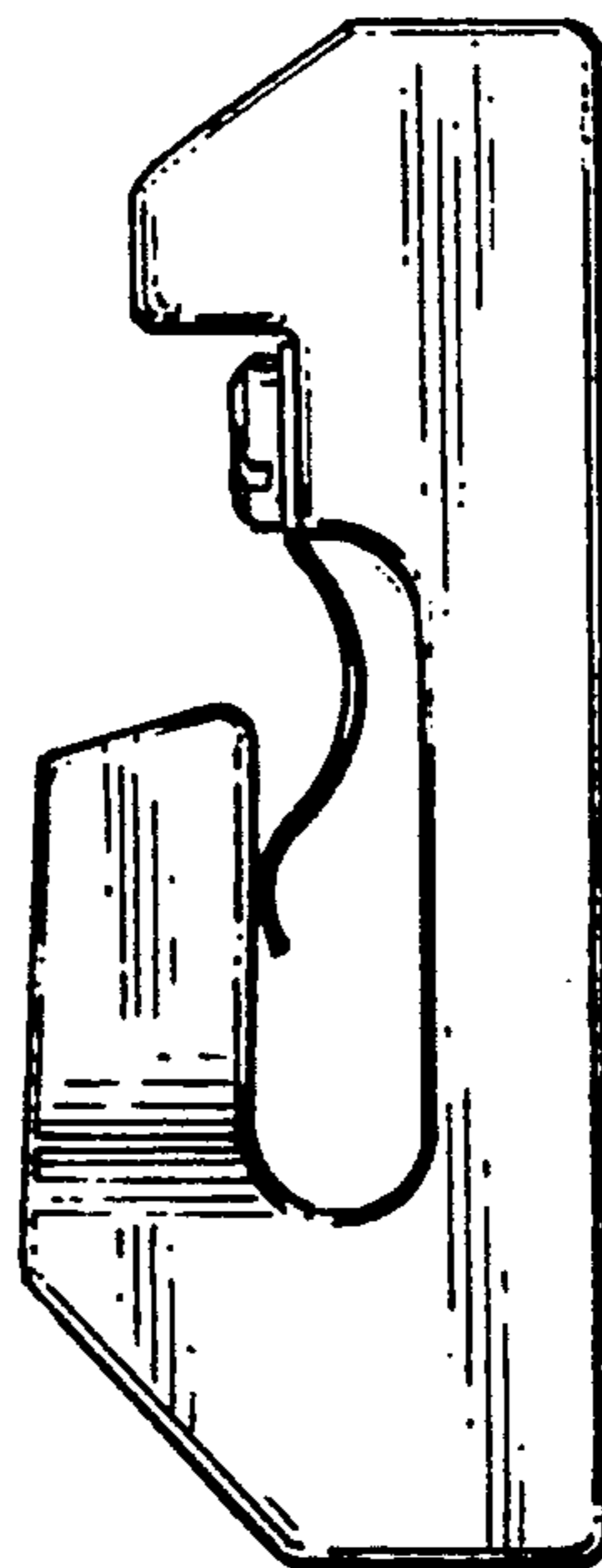
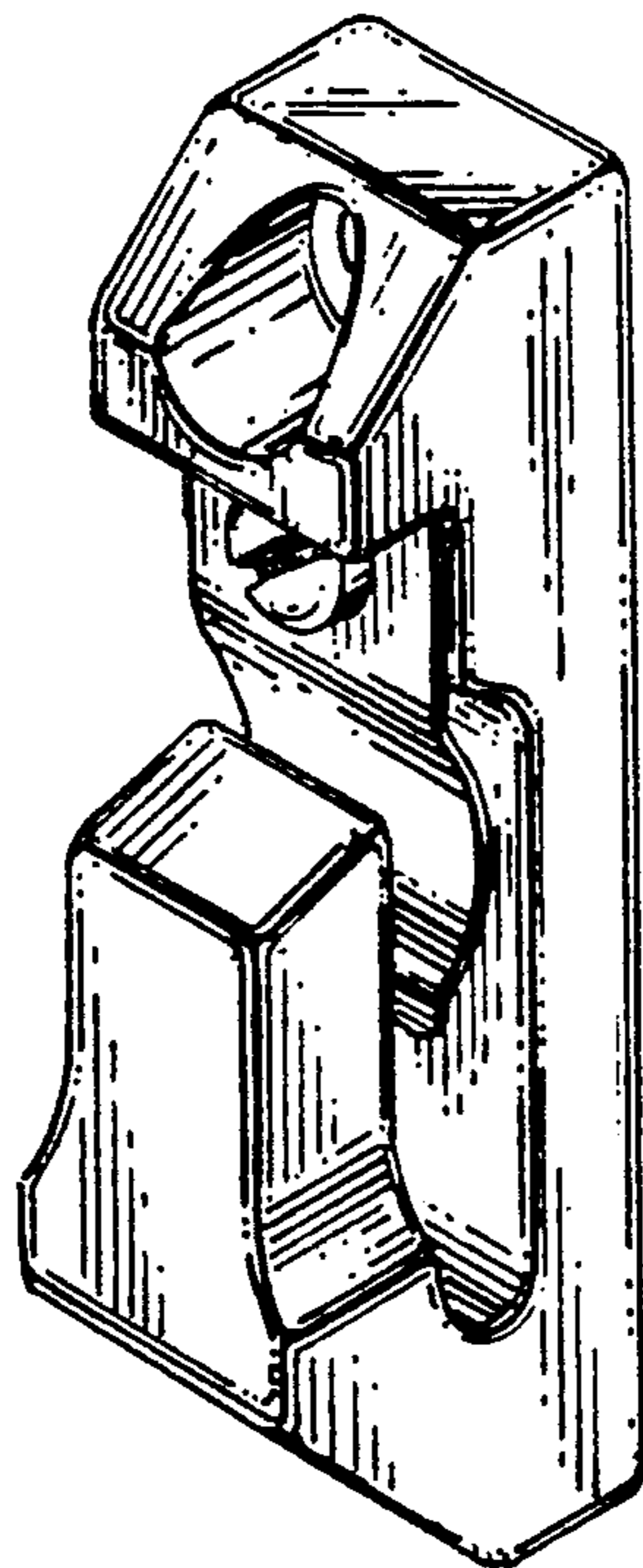

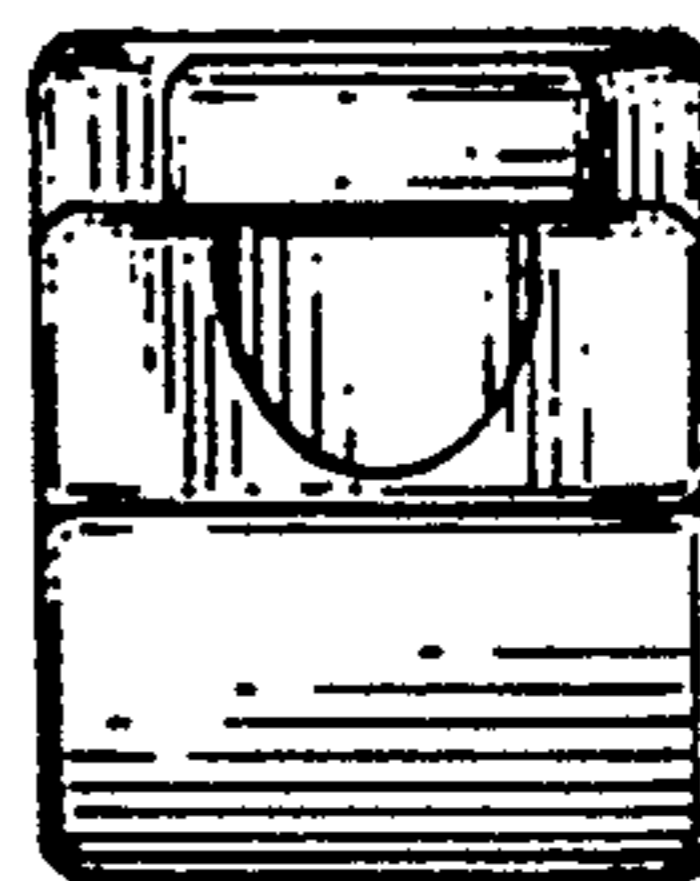
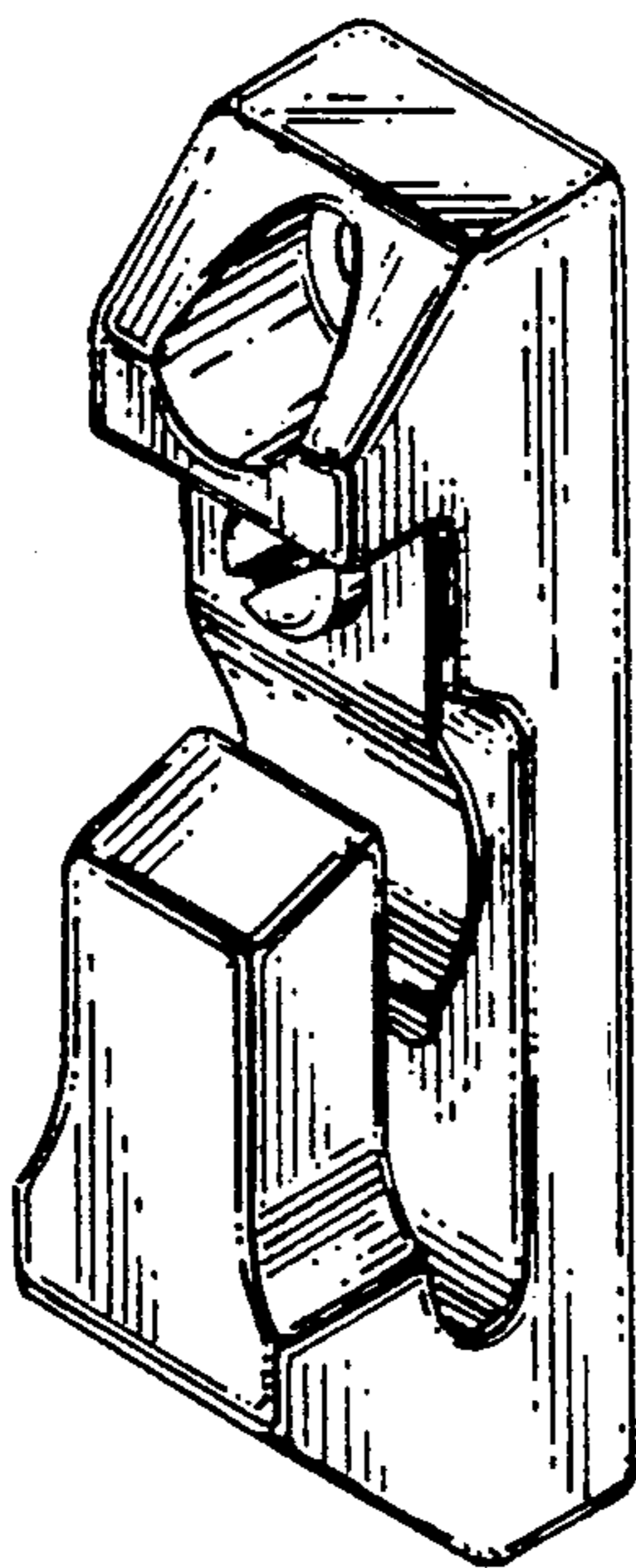

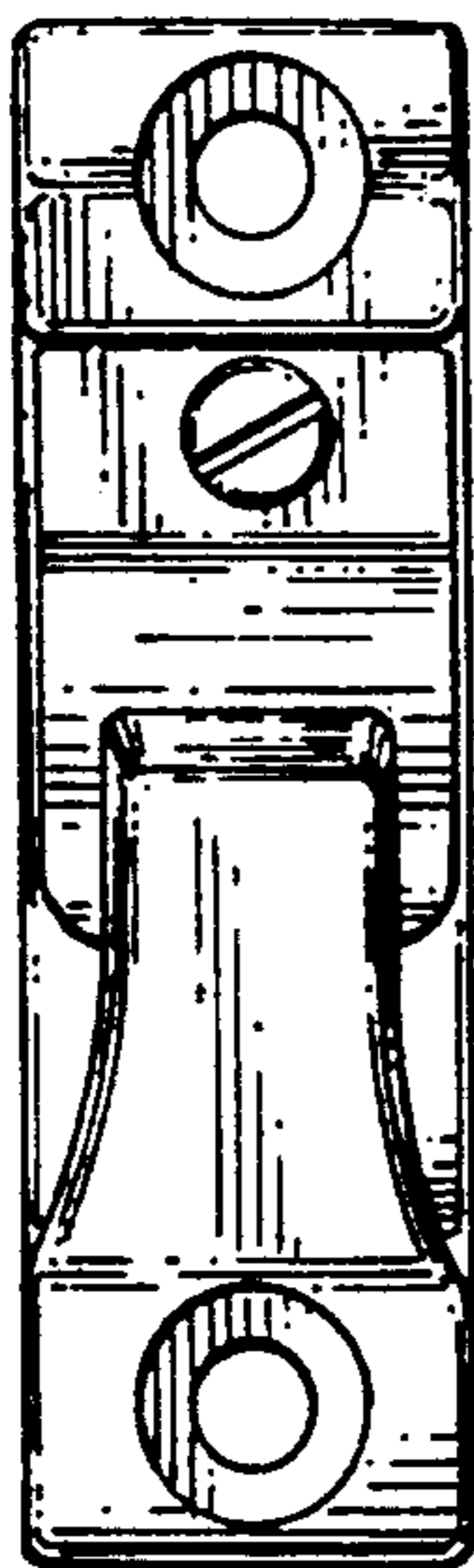

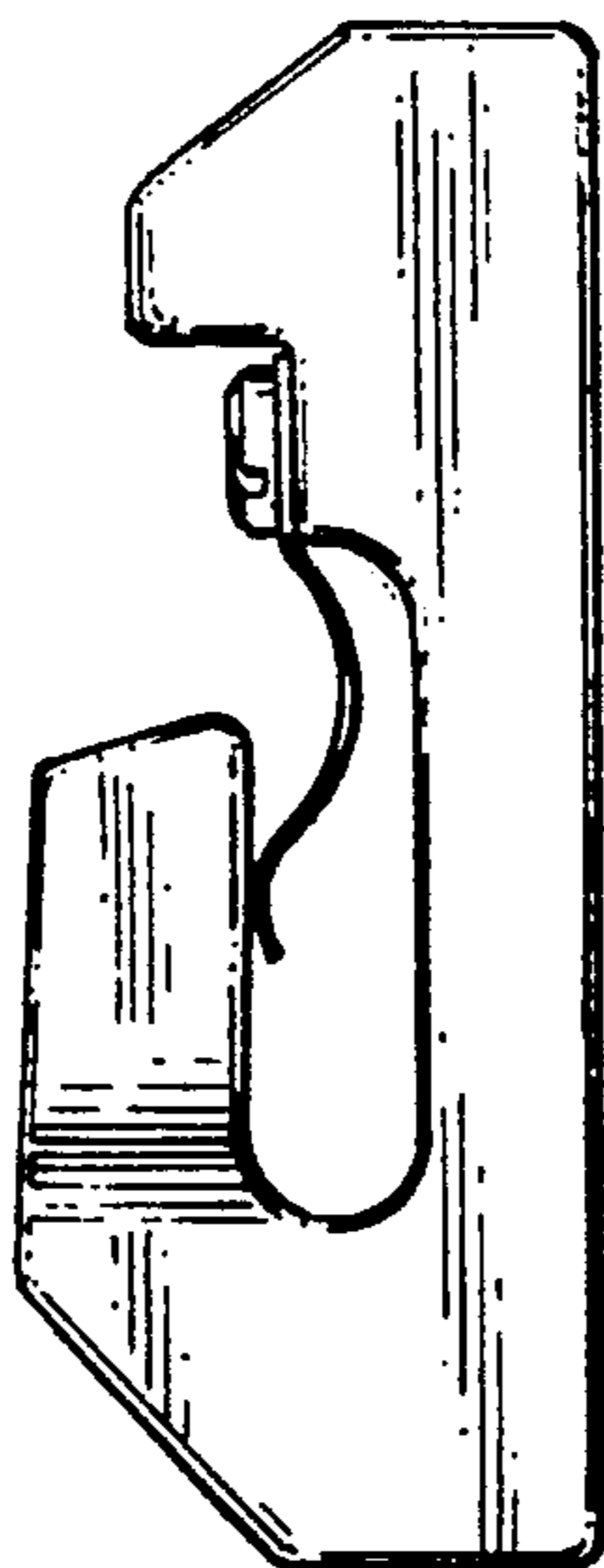

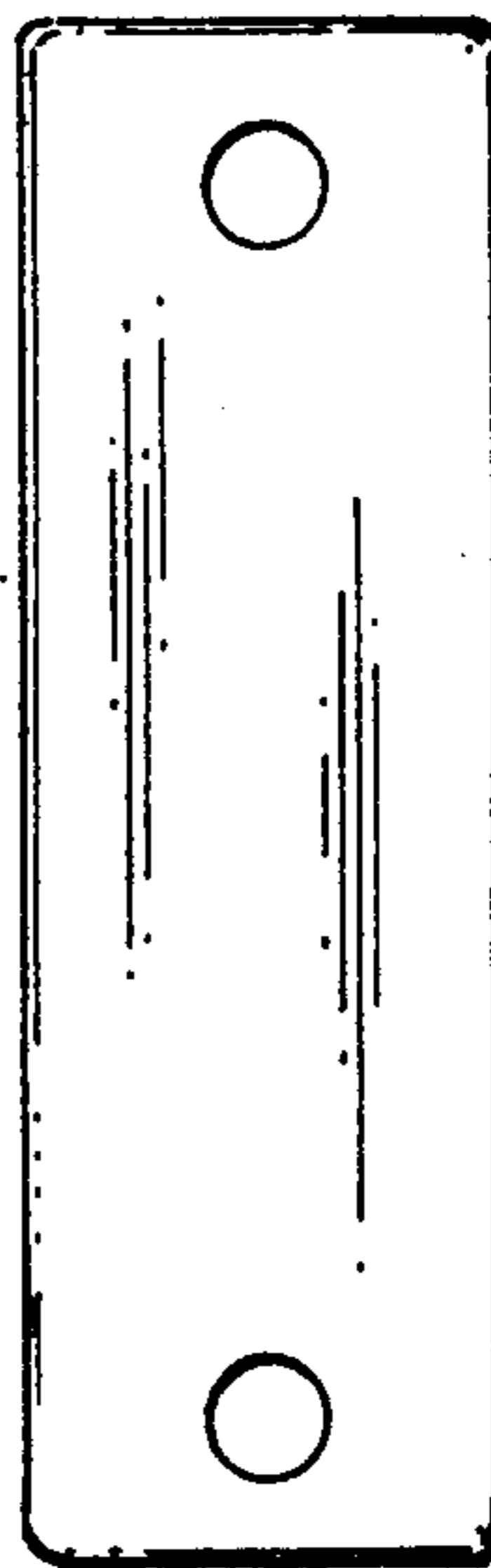
