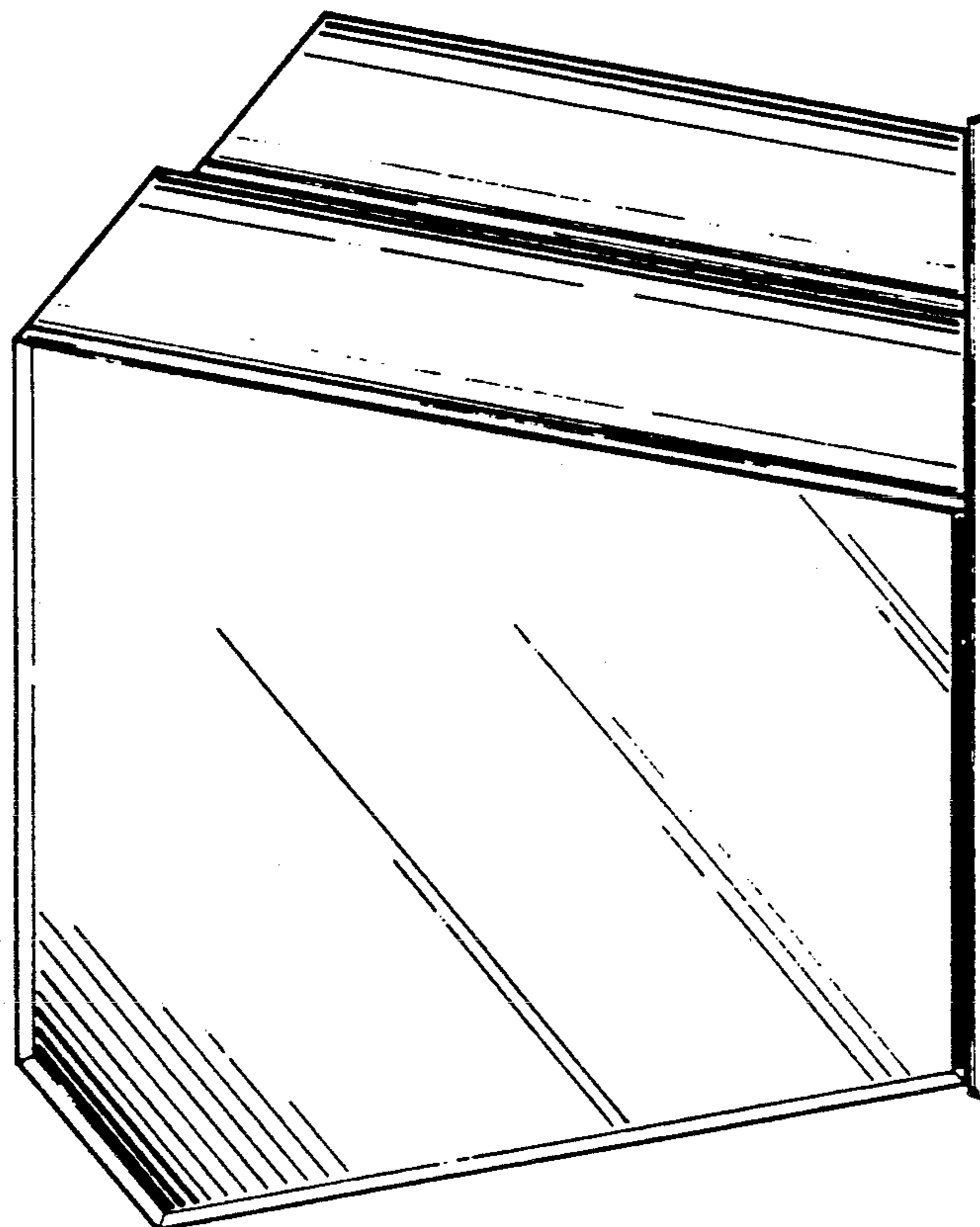

[57] CLAIM

The ornamental design for mirror, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a mirror, showing my new design;
FIG. 2 is a right side elevational view;
FIG. 3 is a top plan view; and
FIG. 4 is a left side elevational view.
The undisclosed rear and bottom surfaces of the mirror are conventionally flat and unadorned.



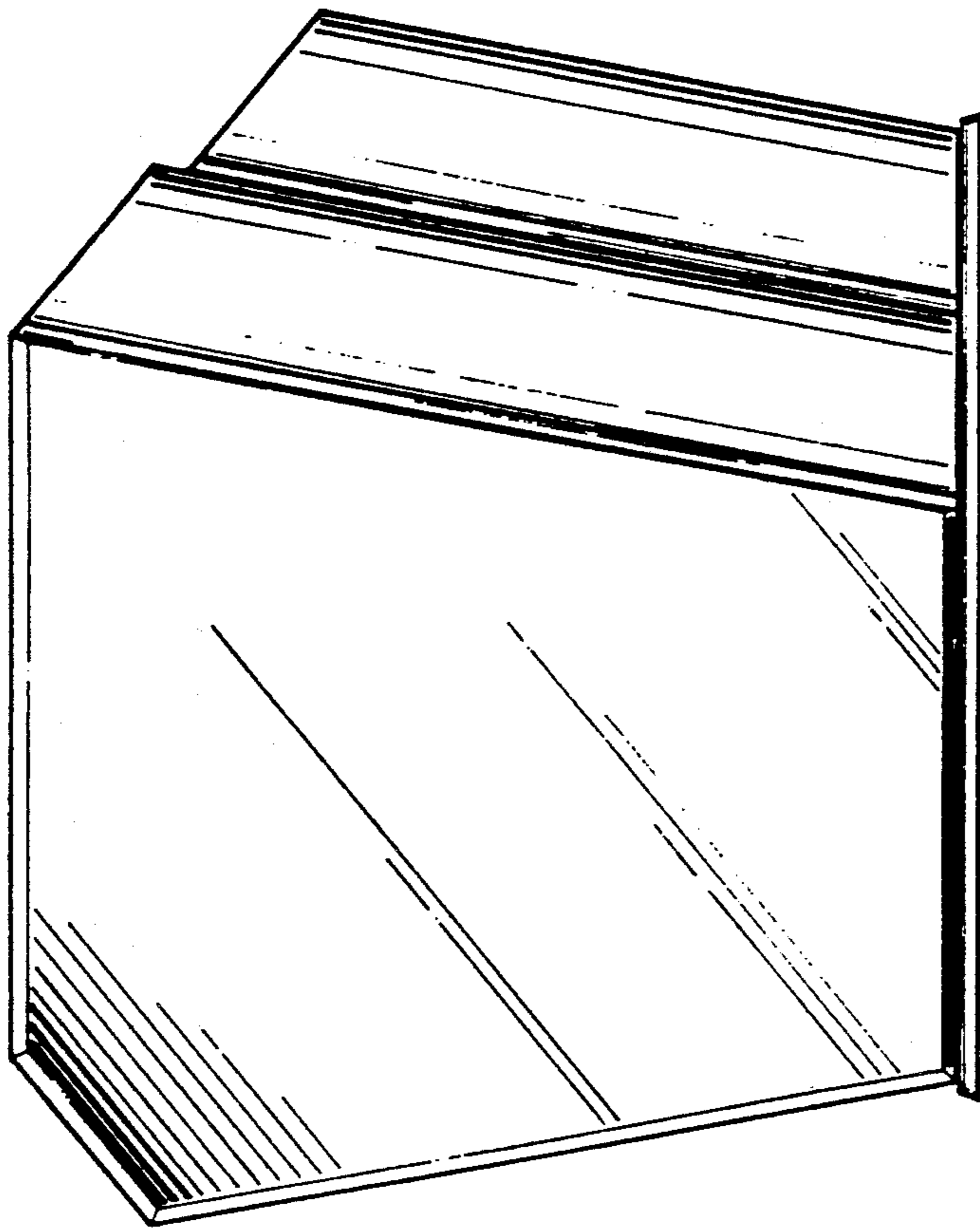

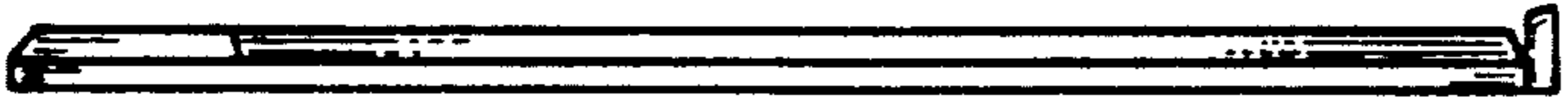
