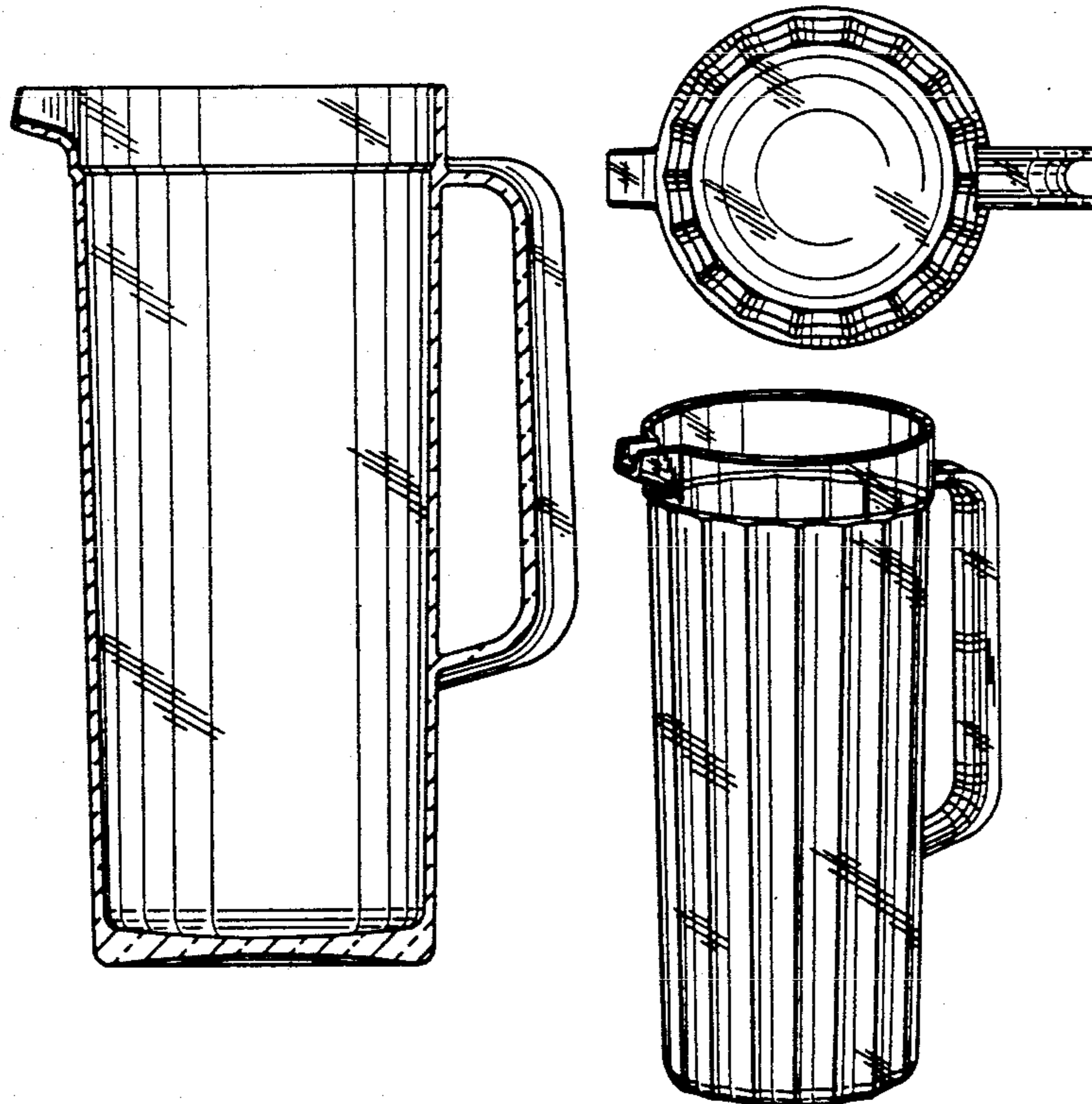

[57] CLAIM

The ornamental design for a pitcher or the like, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the pitcher or the like showing our new design;
FIG. 2 is a side elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a bottom plan view thereof; and
FIG. 7 is a cross-sectional view thereof on an enlarged scale taken along line 7-7 of FIG. 3 with the fluting that would be visible through the wall portion omitted for clarity of illustration.



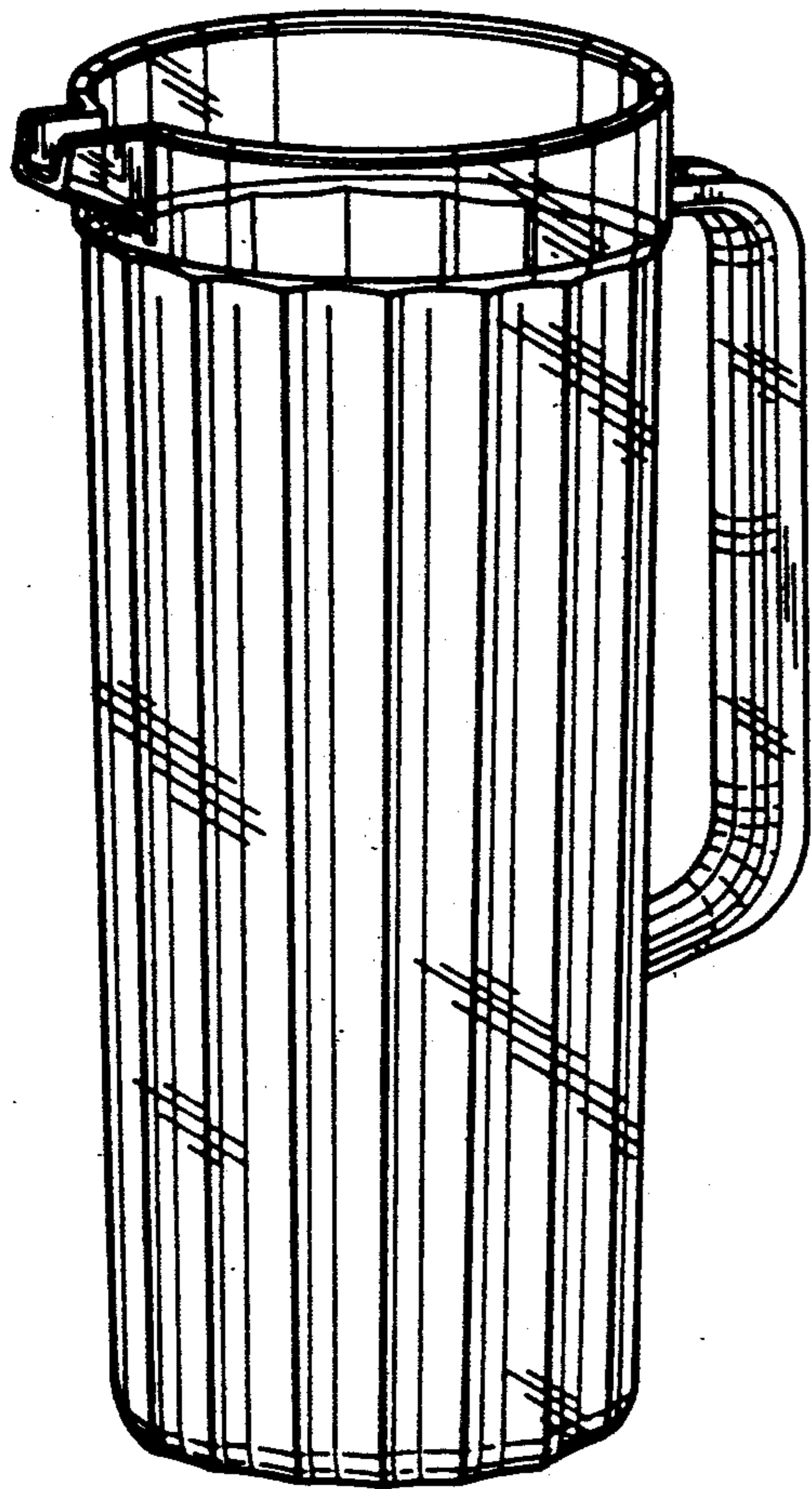

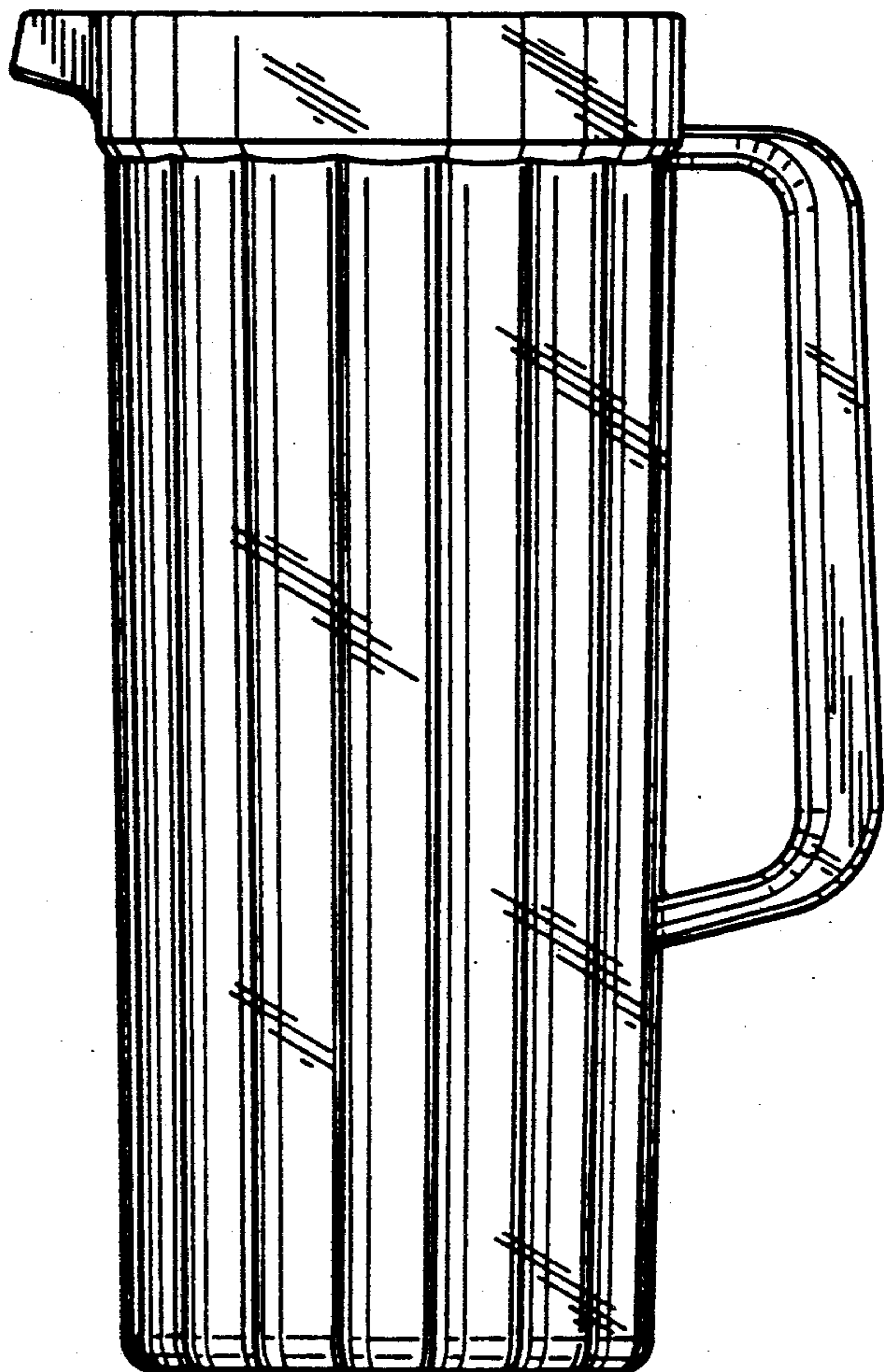

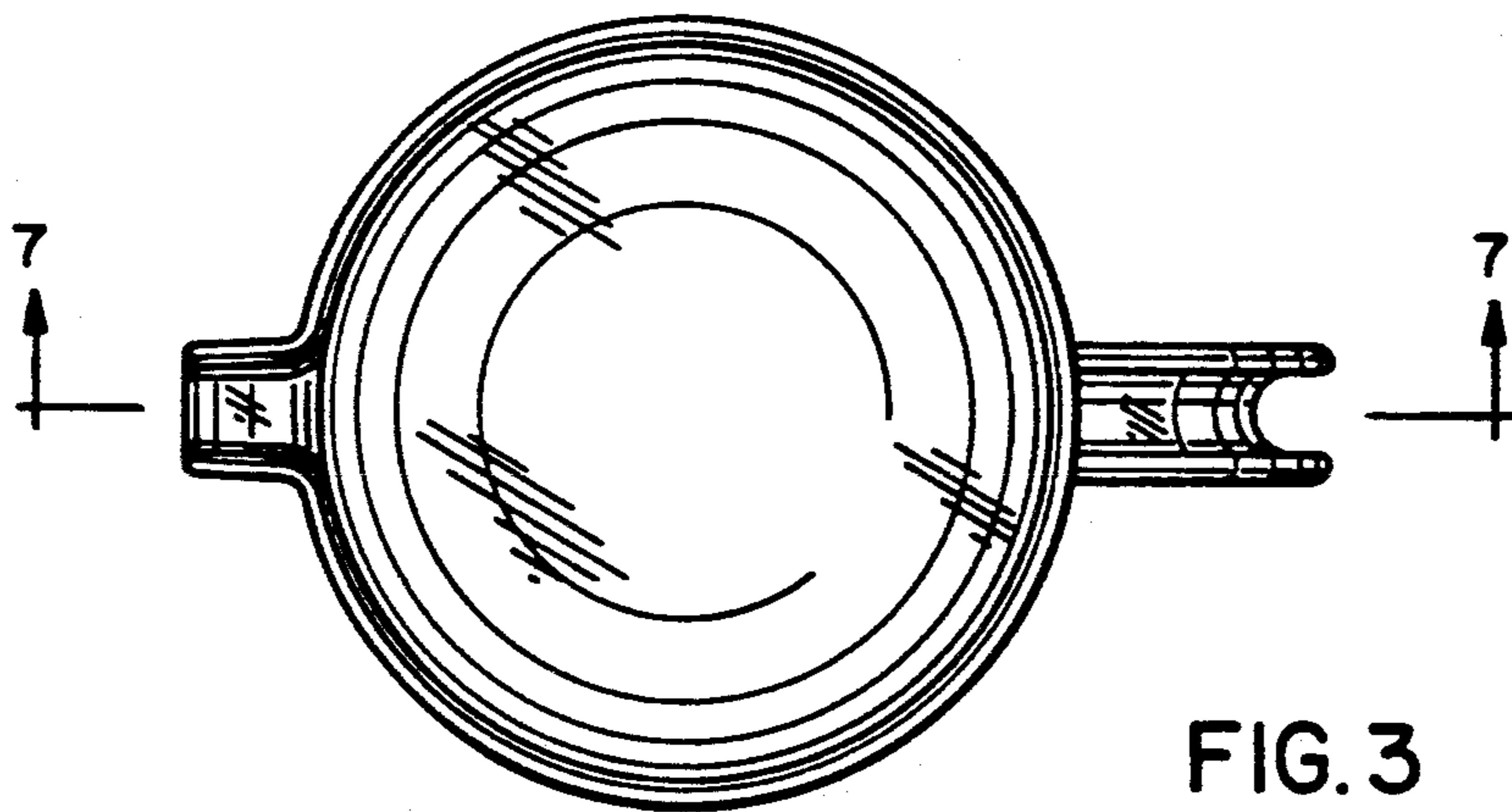

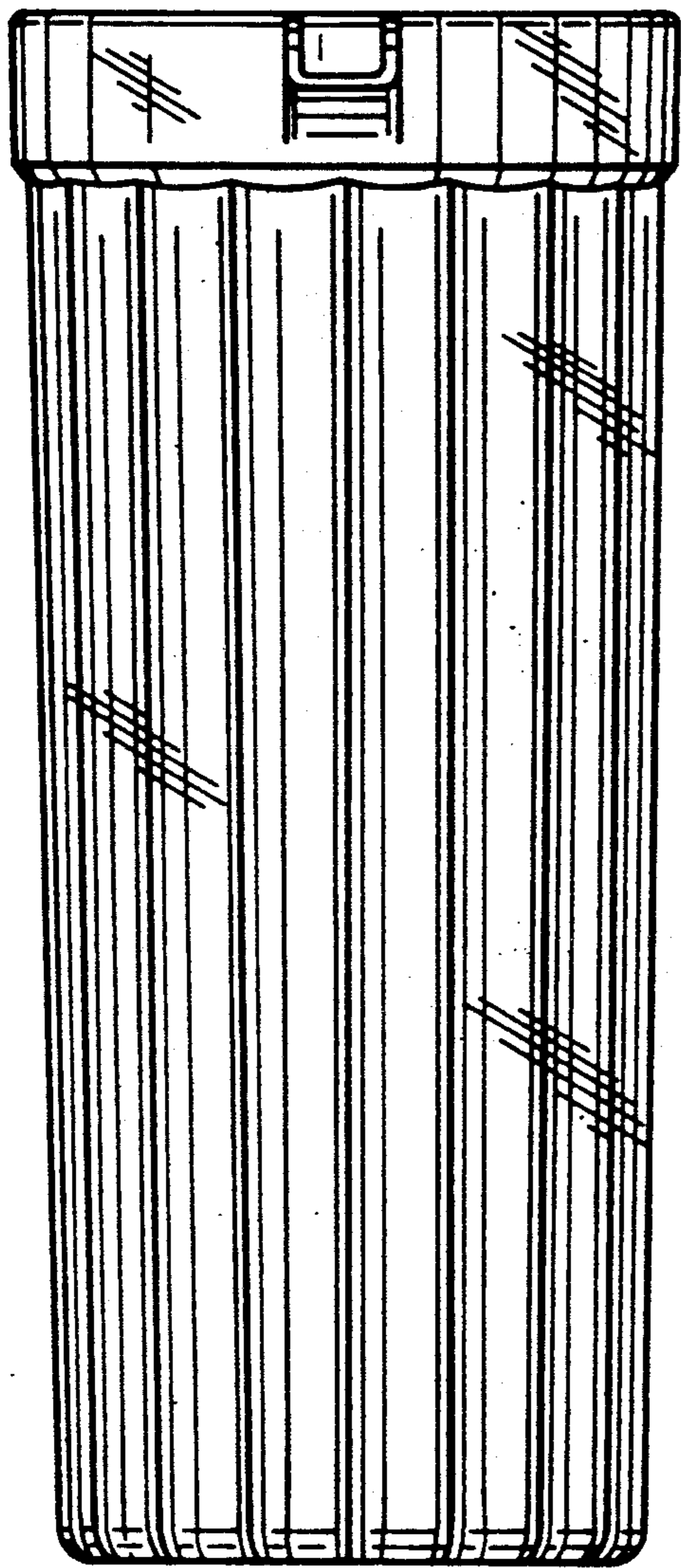

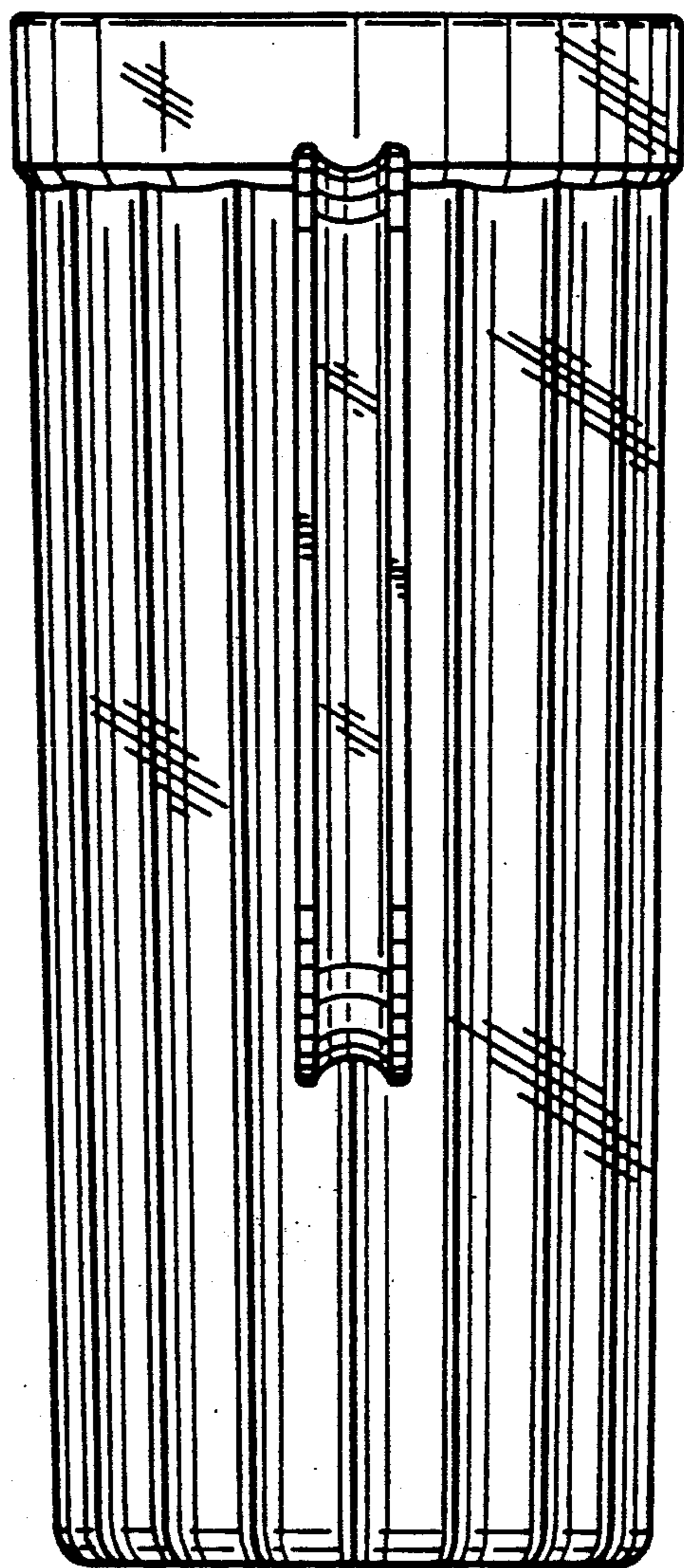

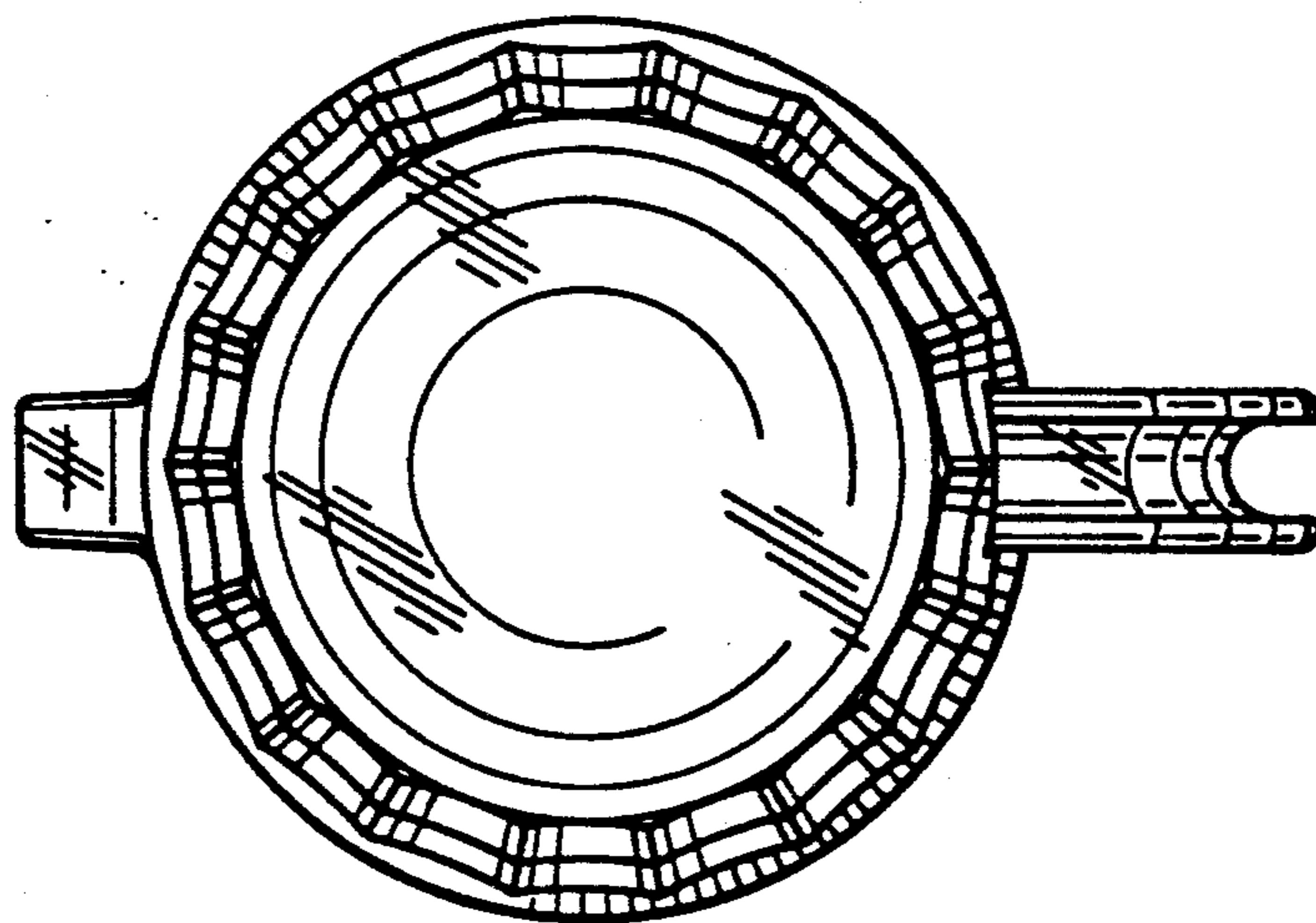

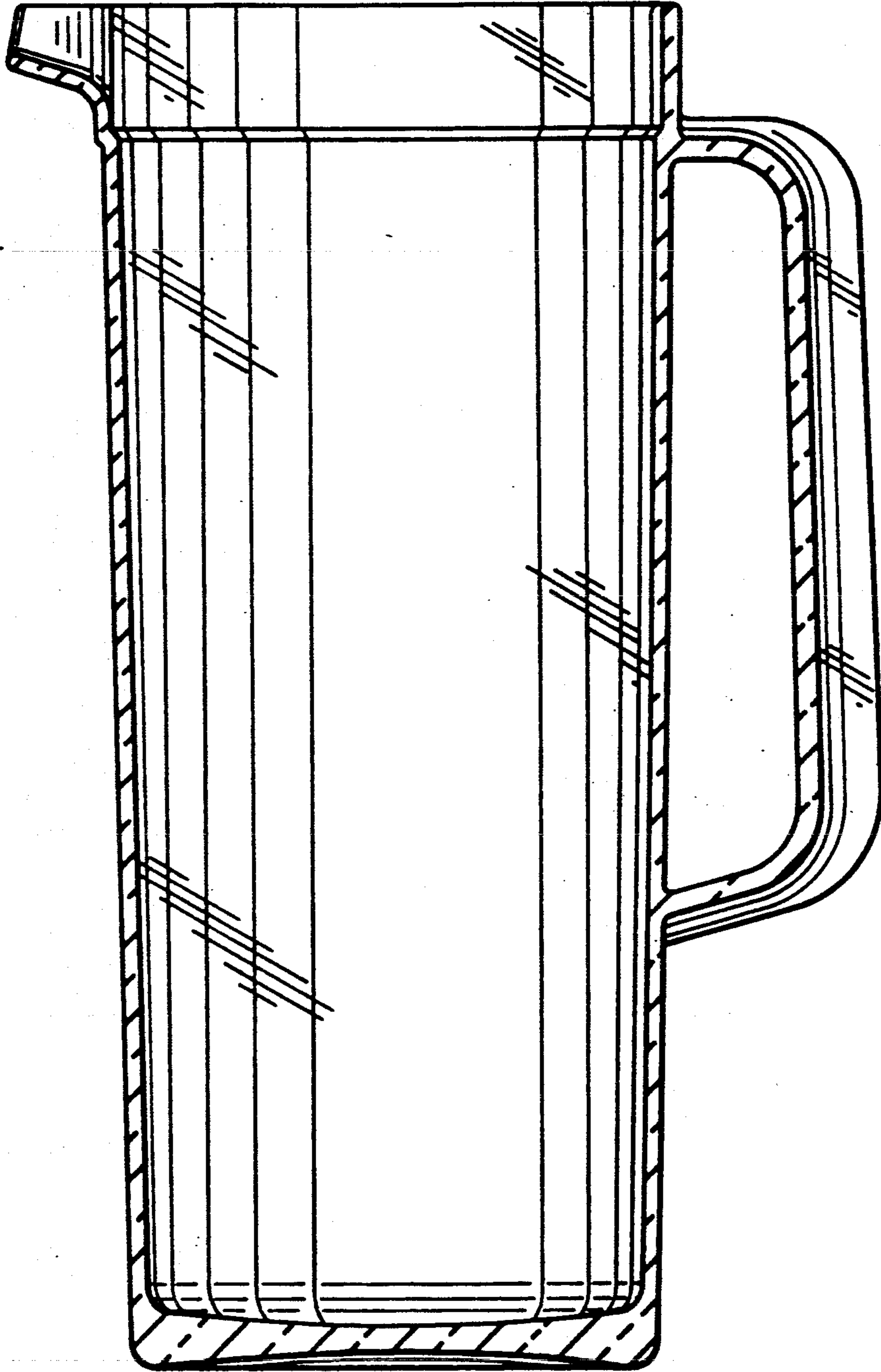
