[57] **CLAIM**

The ornamental design for an electrical connector housing, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of an electrical connector housing showing our new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a bottom plan view thereof;  
 FIG. 4 is a left side elevational view thereof, the right side elevational view thereof being a mirror image;  
 FIG. 5 is a rear elevational view thereof;  
 FIG. 6 is a cross-sectional view thereof, taken along line 6—6 of FIG. 2;  
 FIG. 7 is a cross-sectional view thereof, taken along line 7—7 of FIG. 2; and  
 FIG. 8 is a perspective view thereof taken primarily from the bottom.

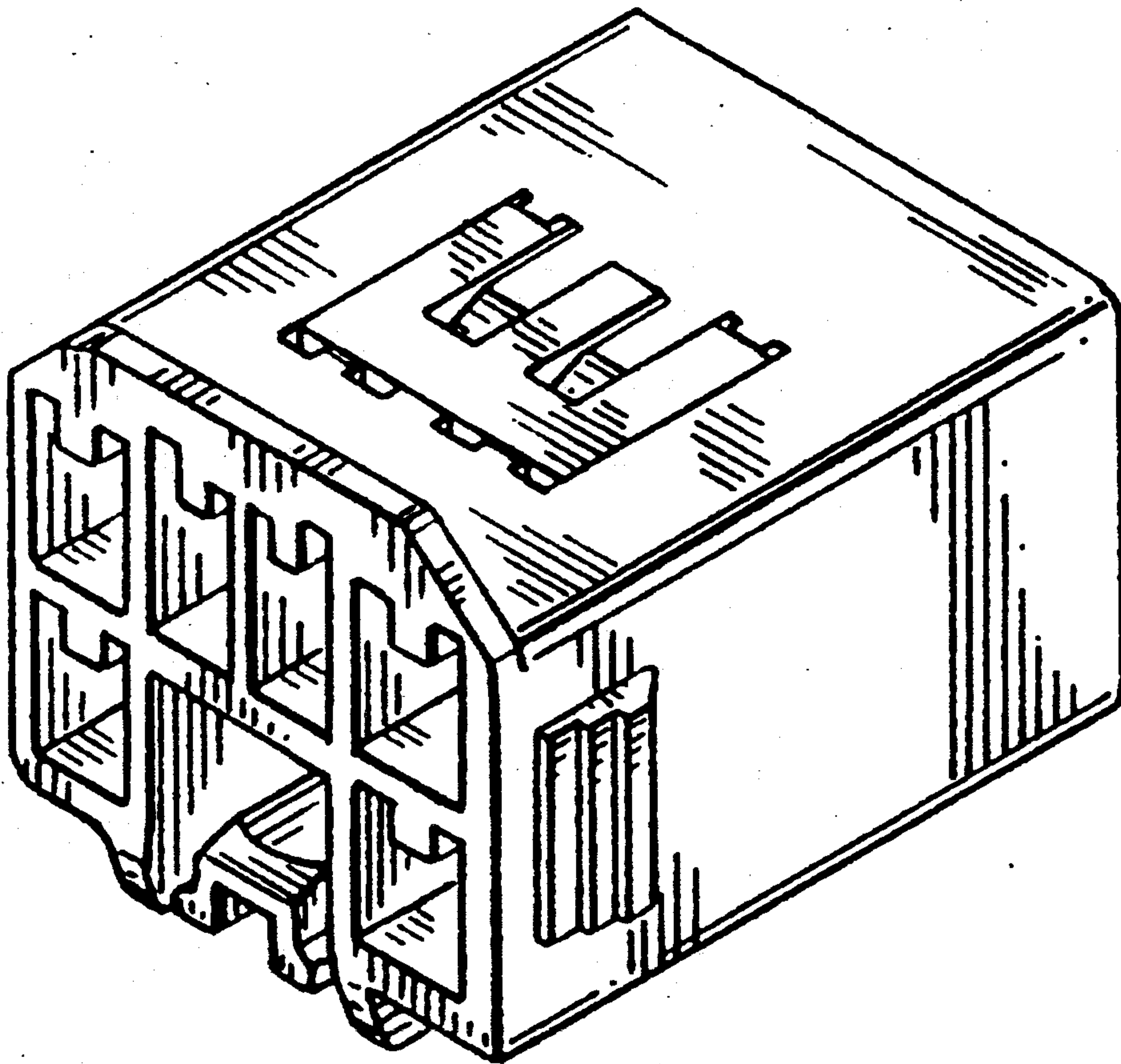

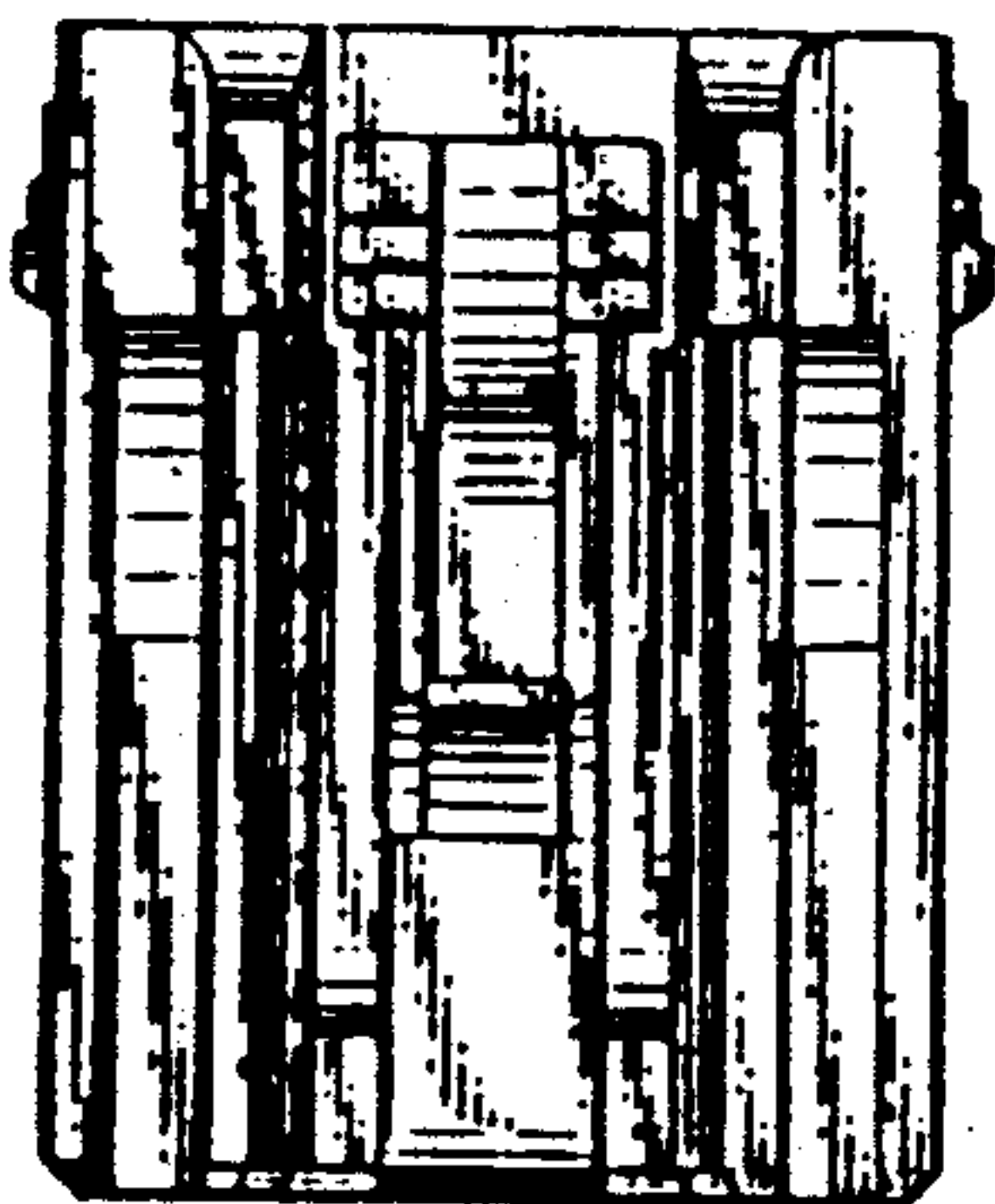

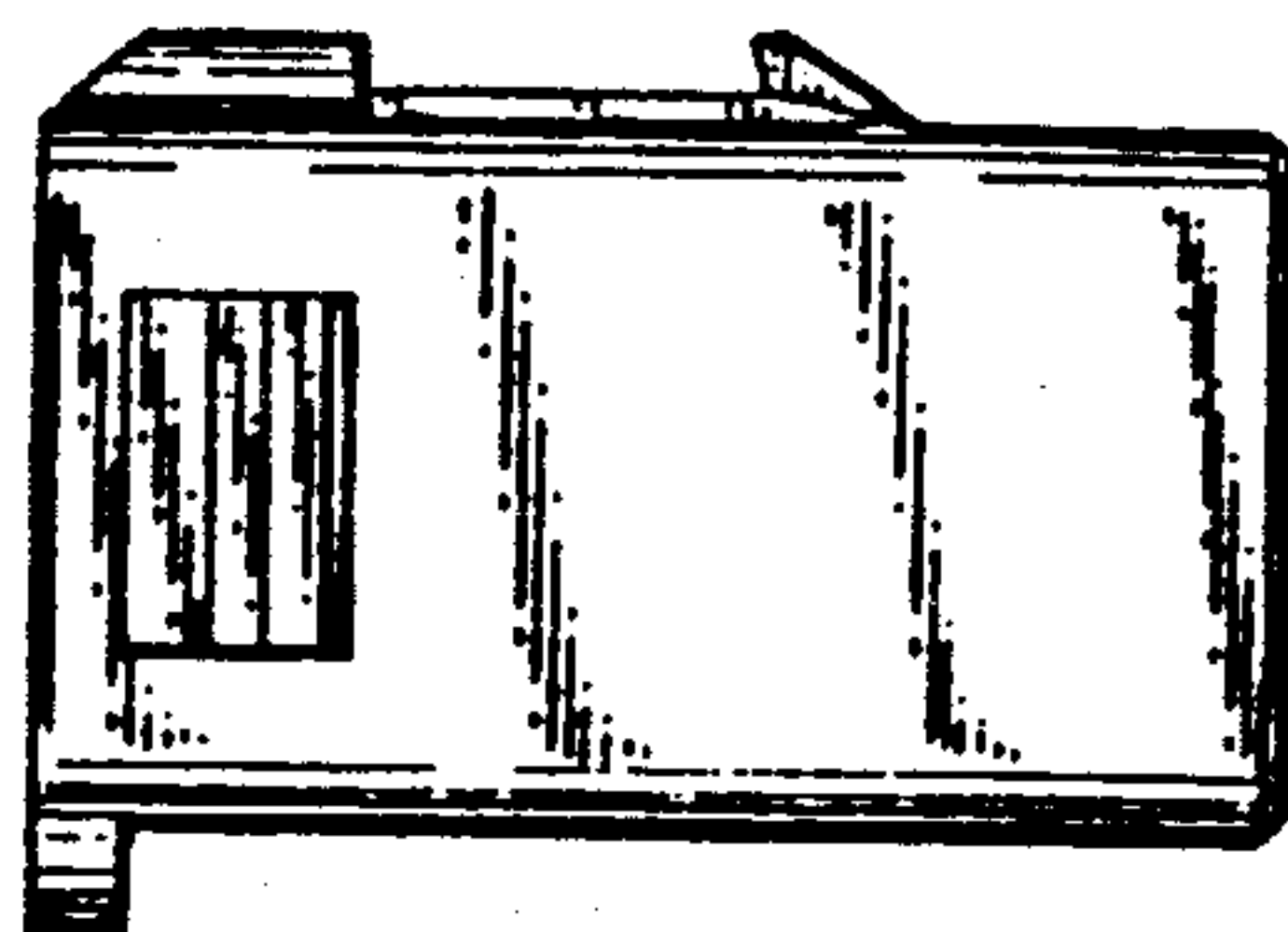

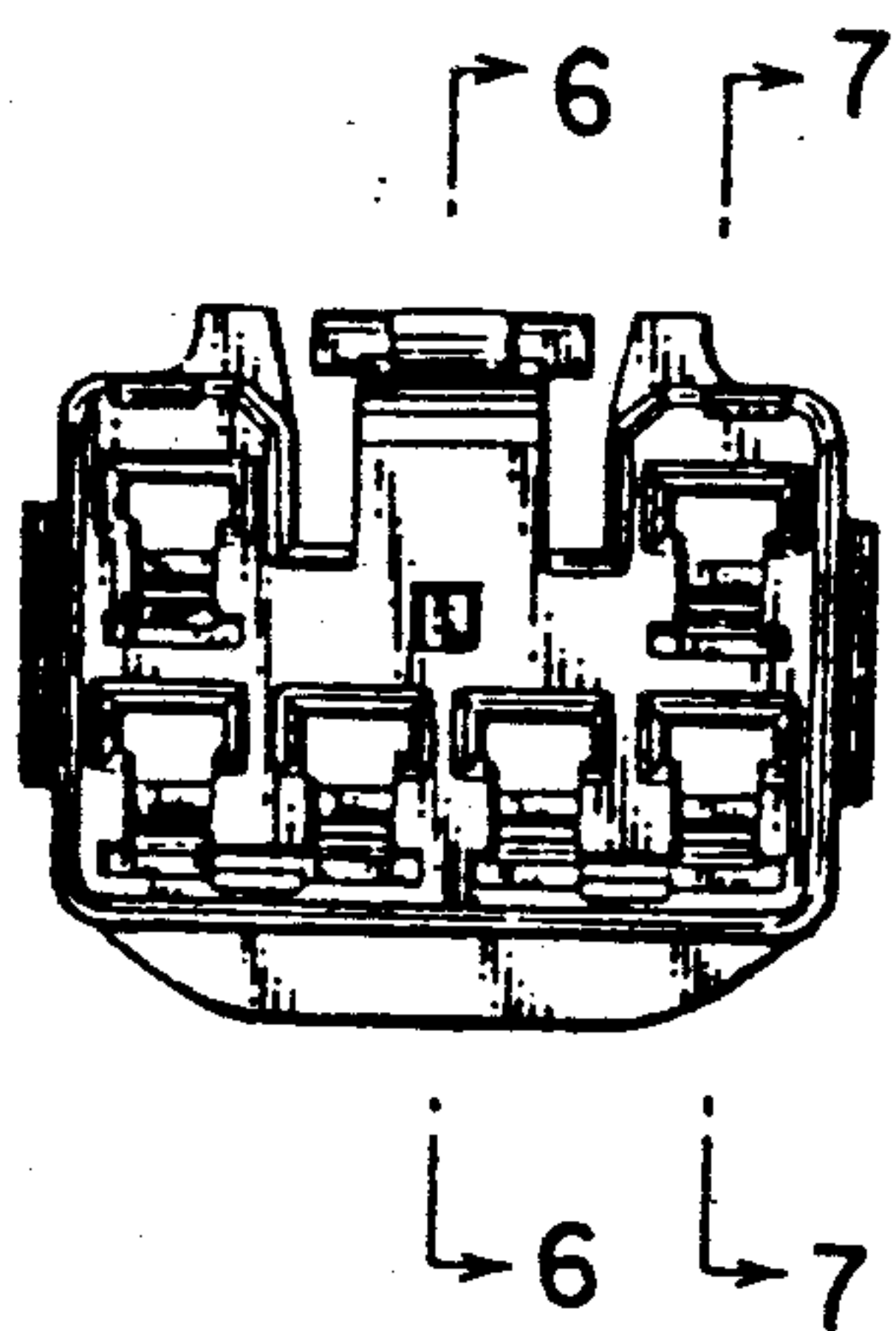

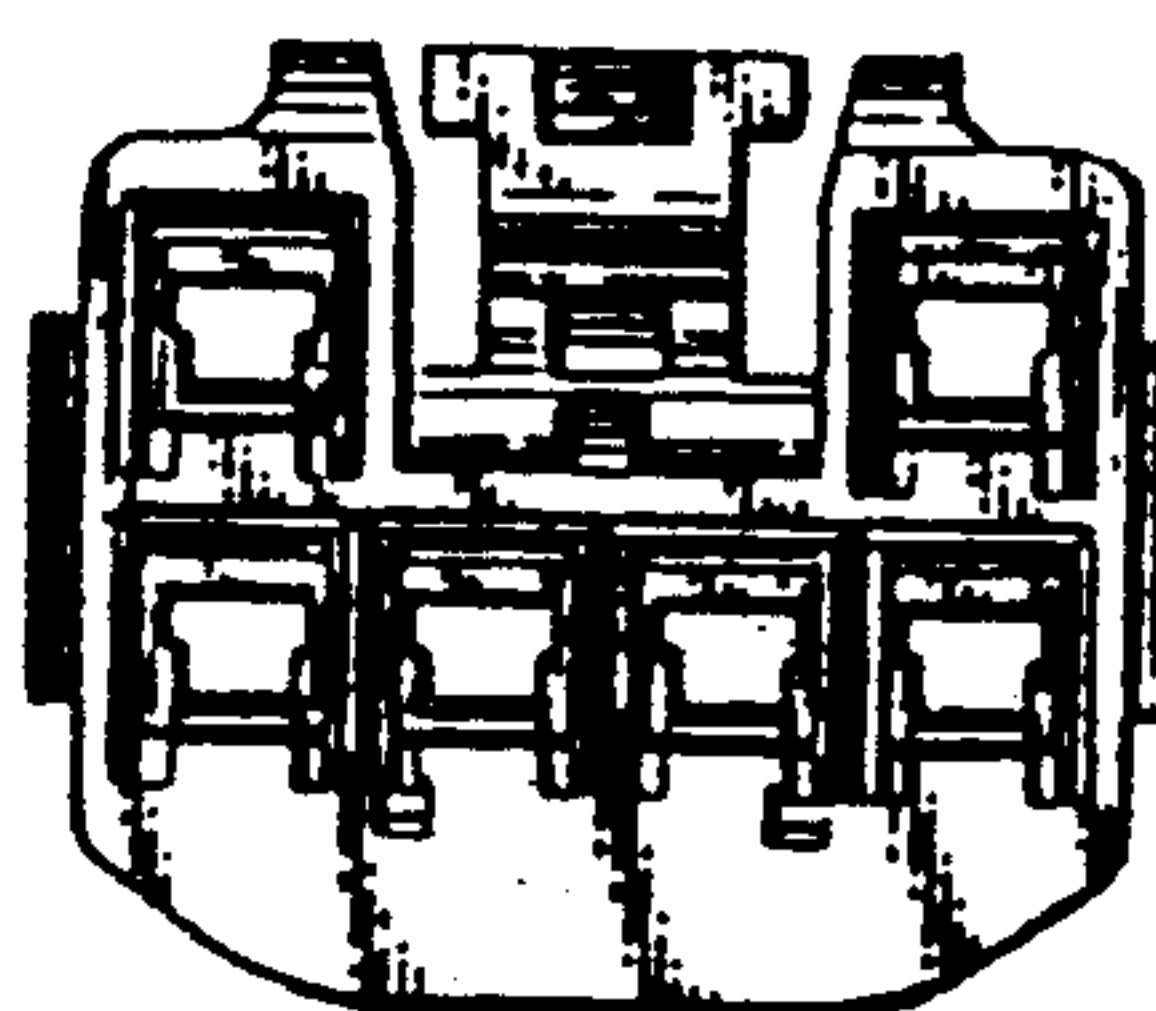

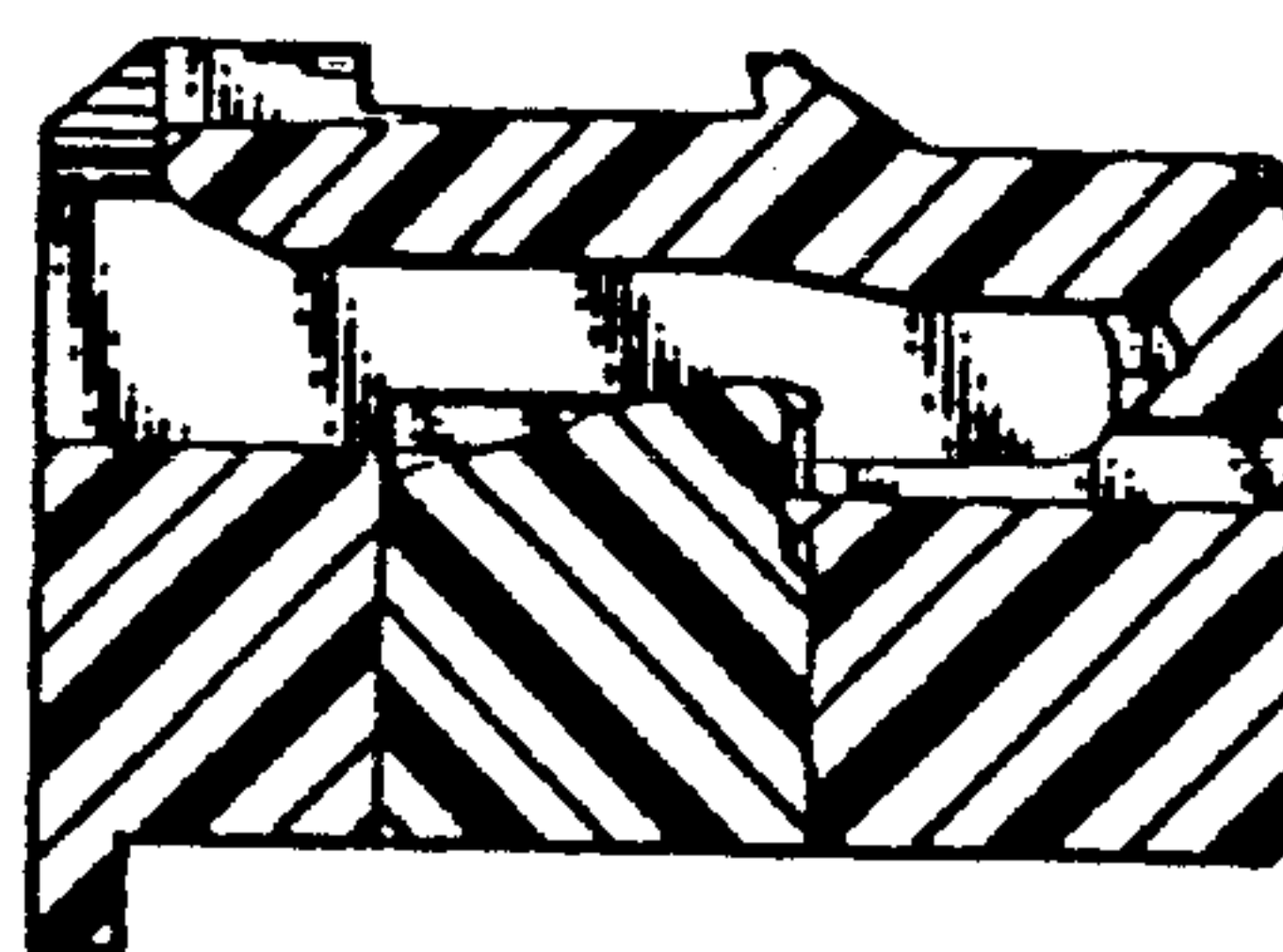

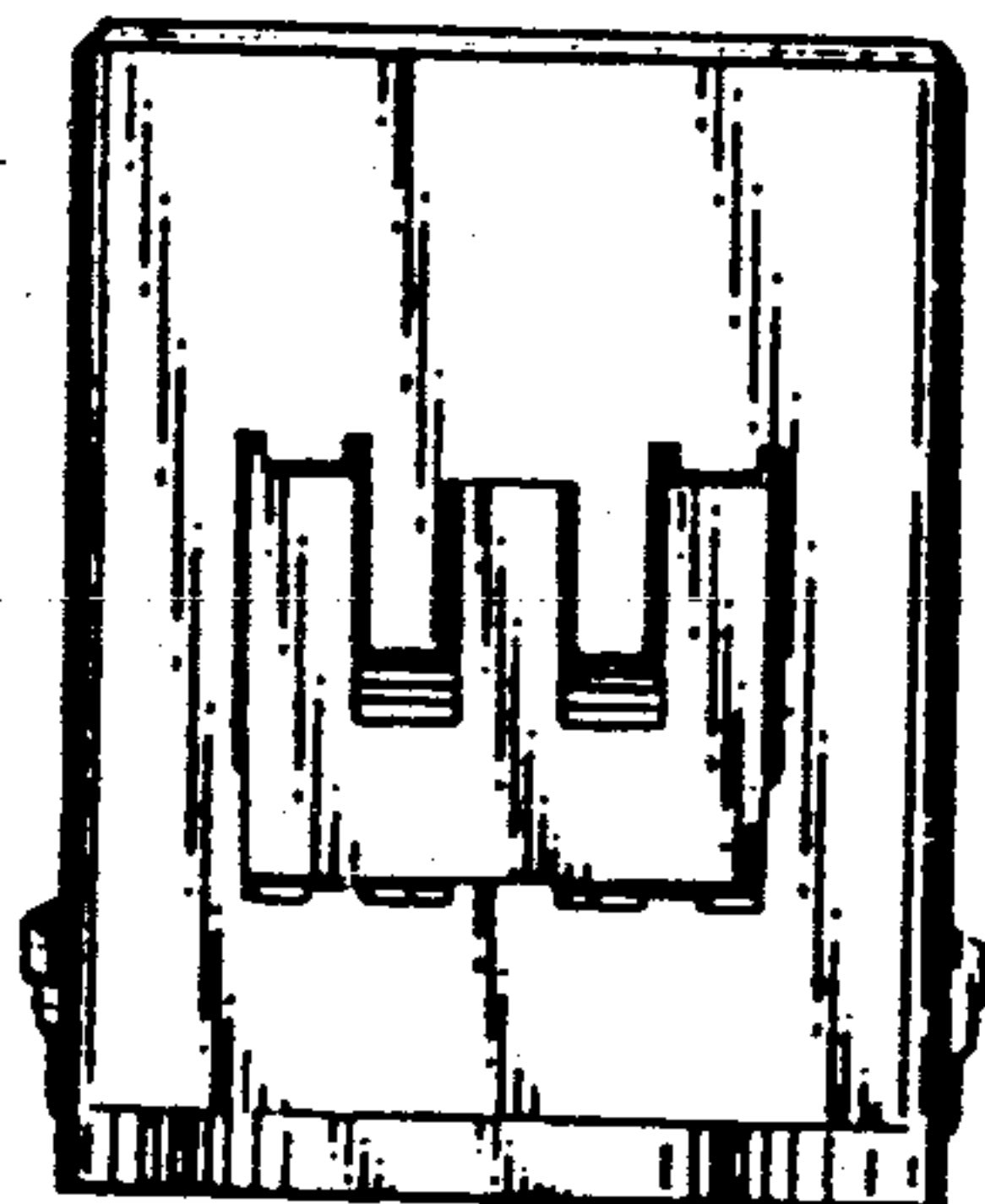
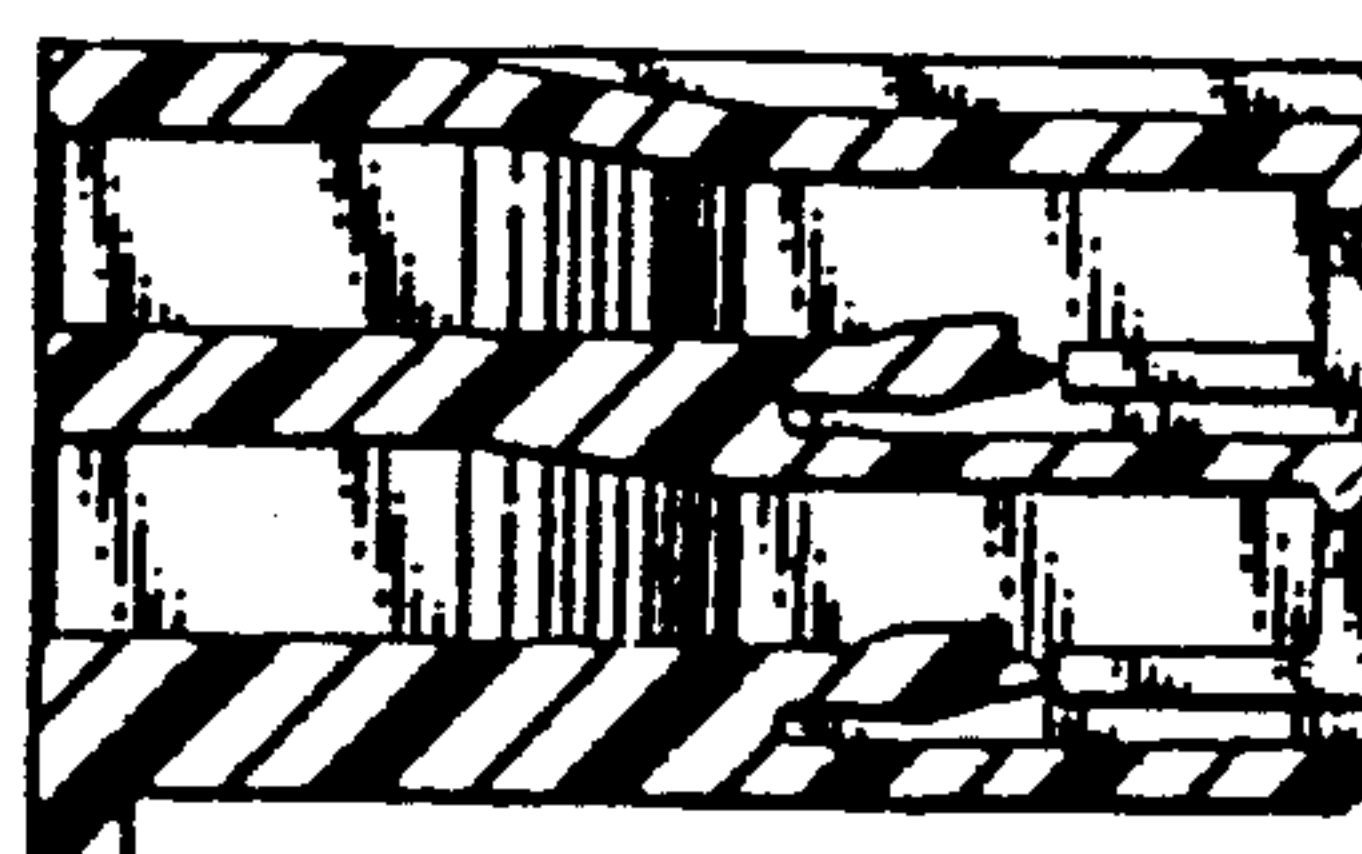

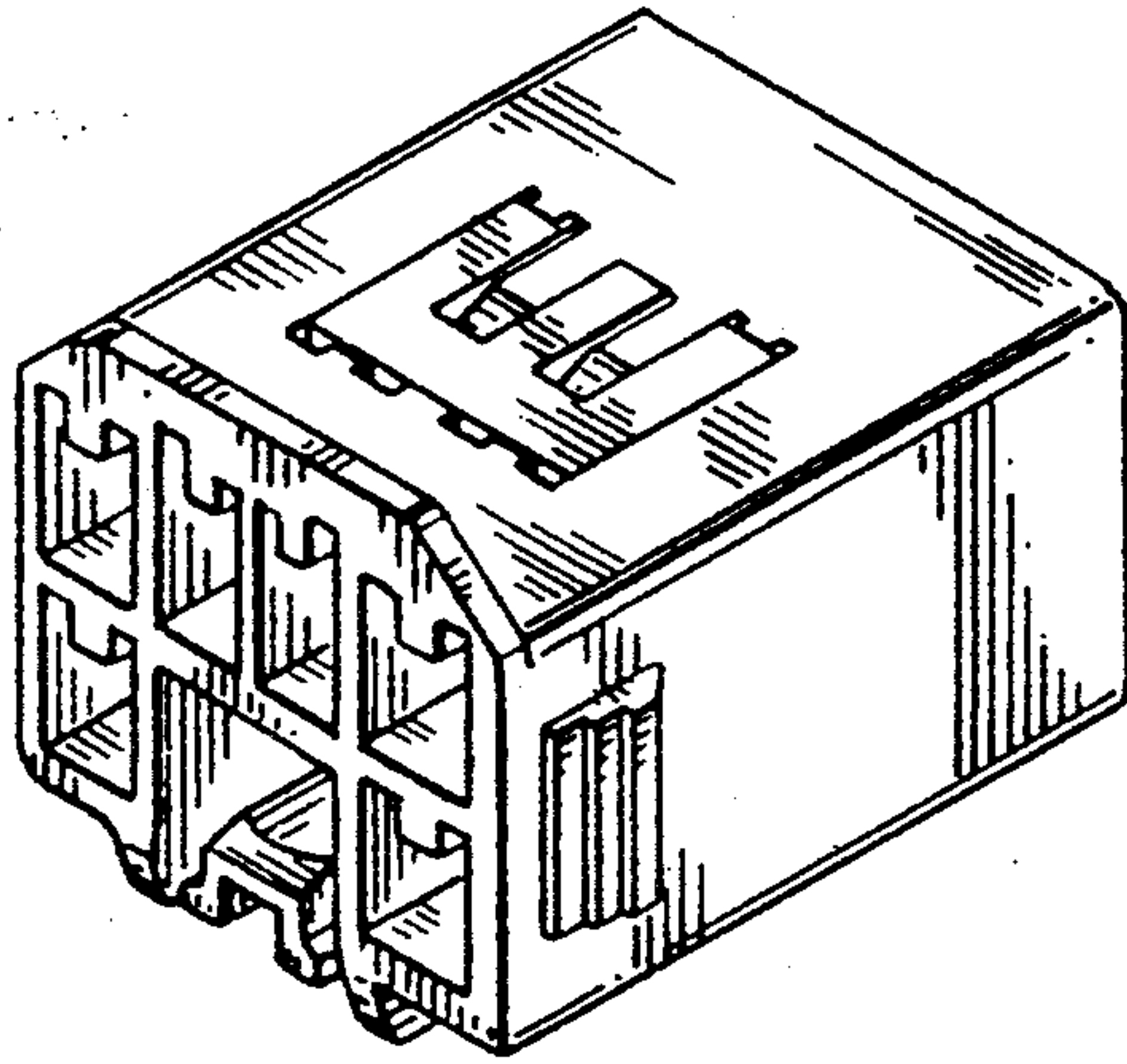
