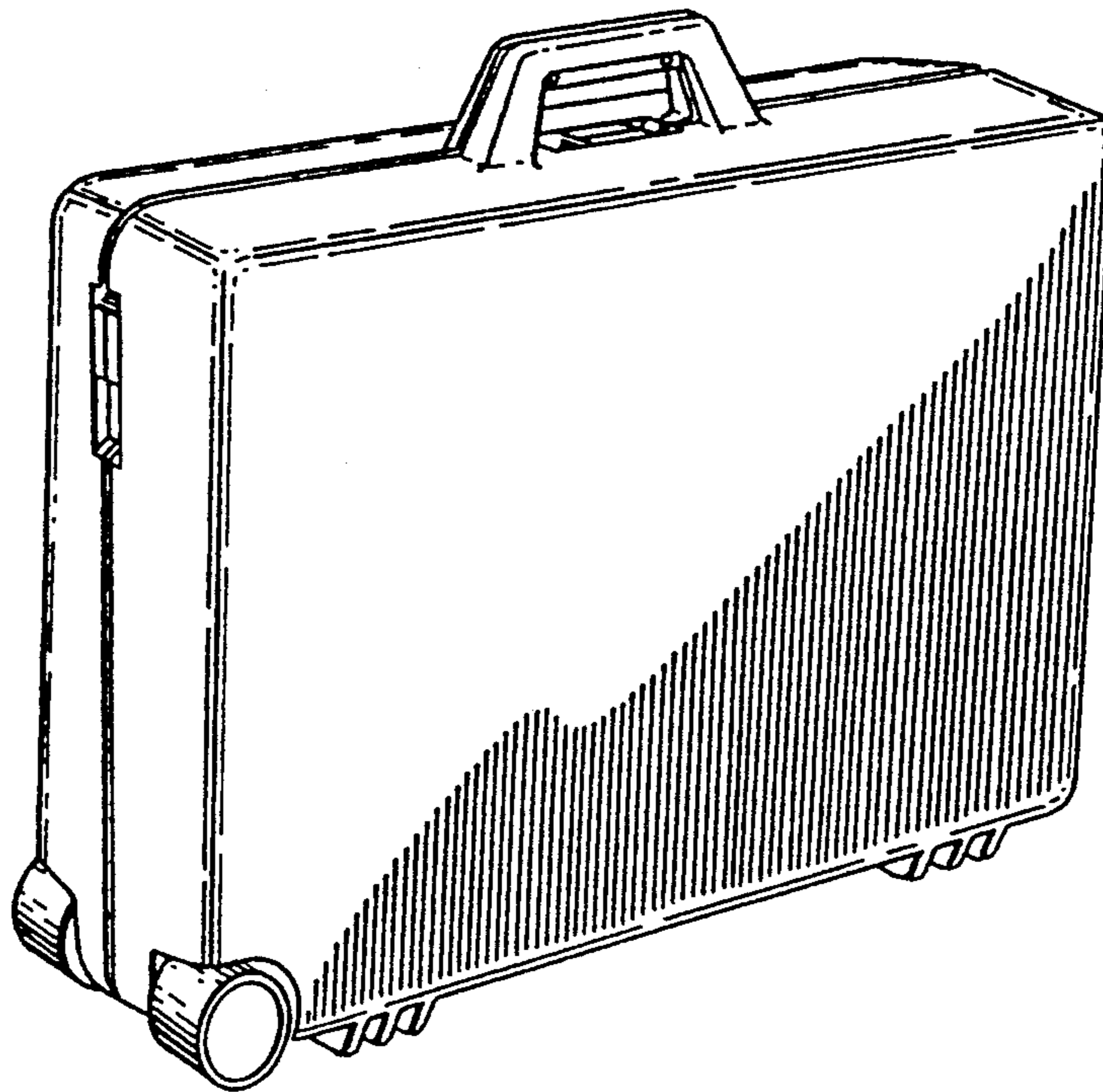

[57] **CLAIM**

The ornamental design for a suitcase, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a suitcase showing my new design;
FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image thereof;
FIG. 3 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a perspective view of a suitcase showing a second embodiment of my new design;
FIG. 7 is a front elevational view thereof, the rear elevational view being a mirror image thereof; and
FIG. 8 is a left side elevational view thereof.
The right side of the suitcase shown in FIG. 6 is the same as the embodiment of the suitcase shown in FIG. 3 and the bottom is the same as that shown in FIG. 5 except for the addition of the wheels and wheelwell.



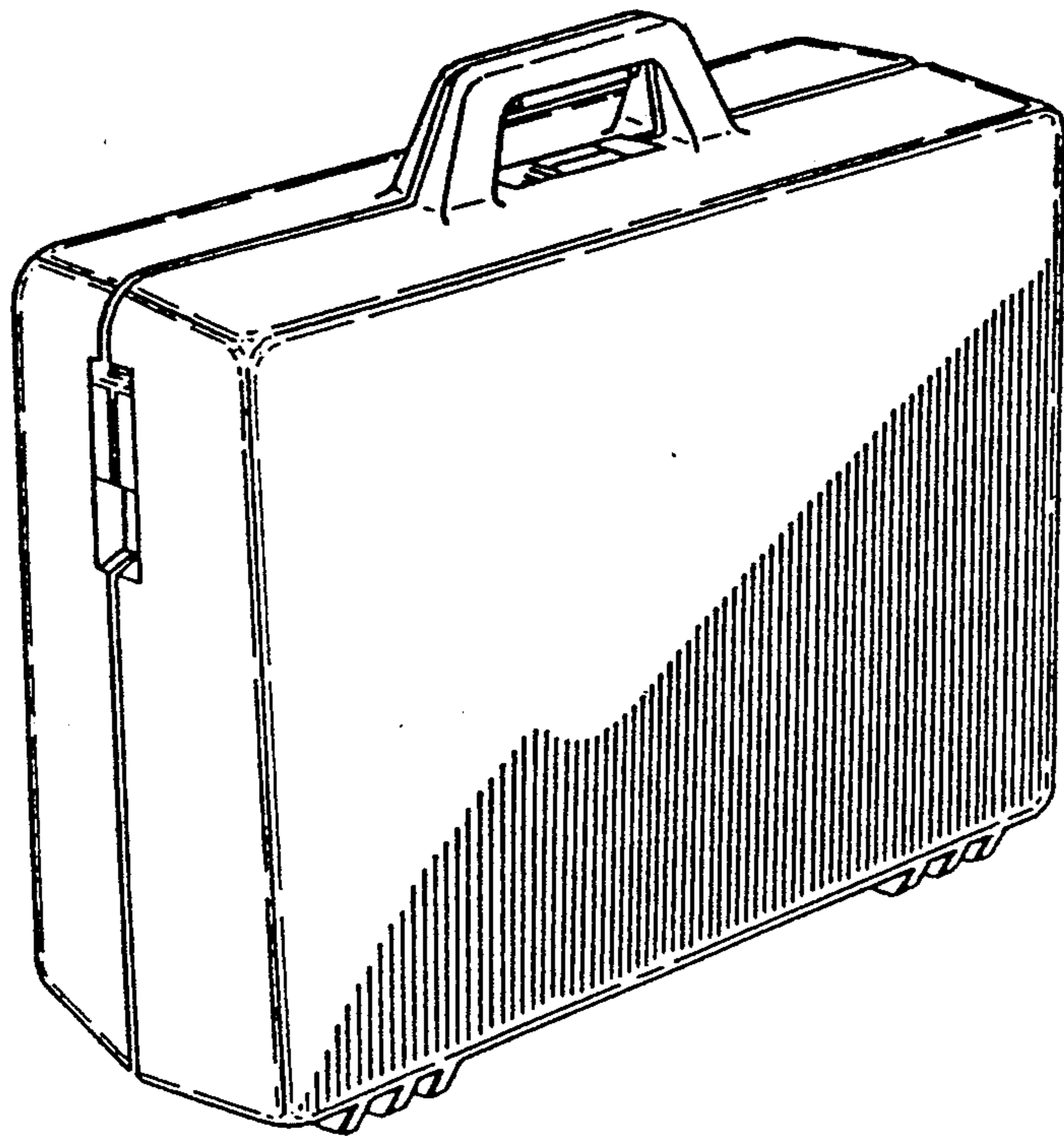

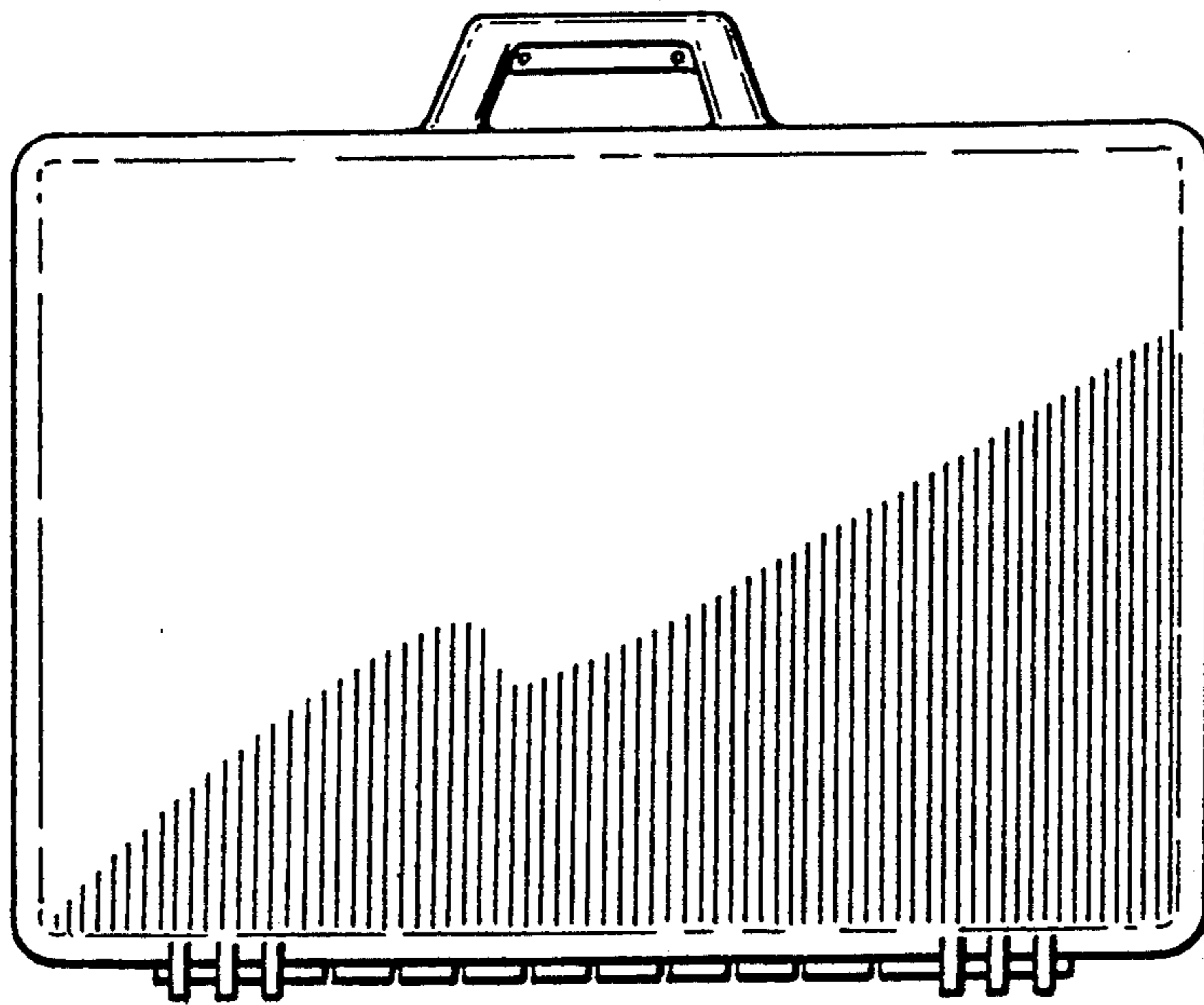

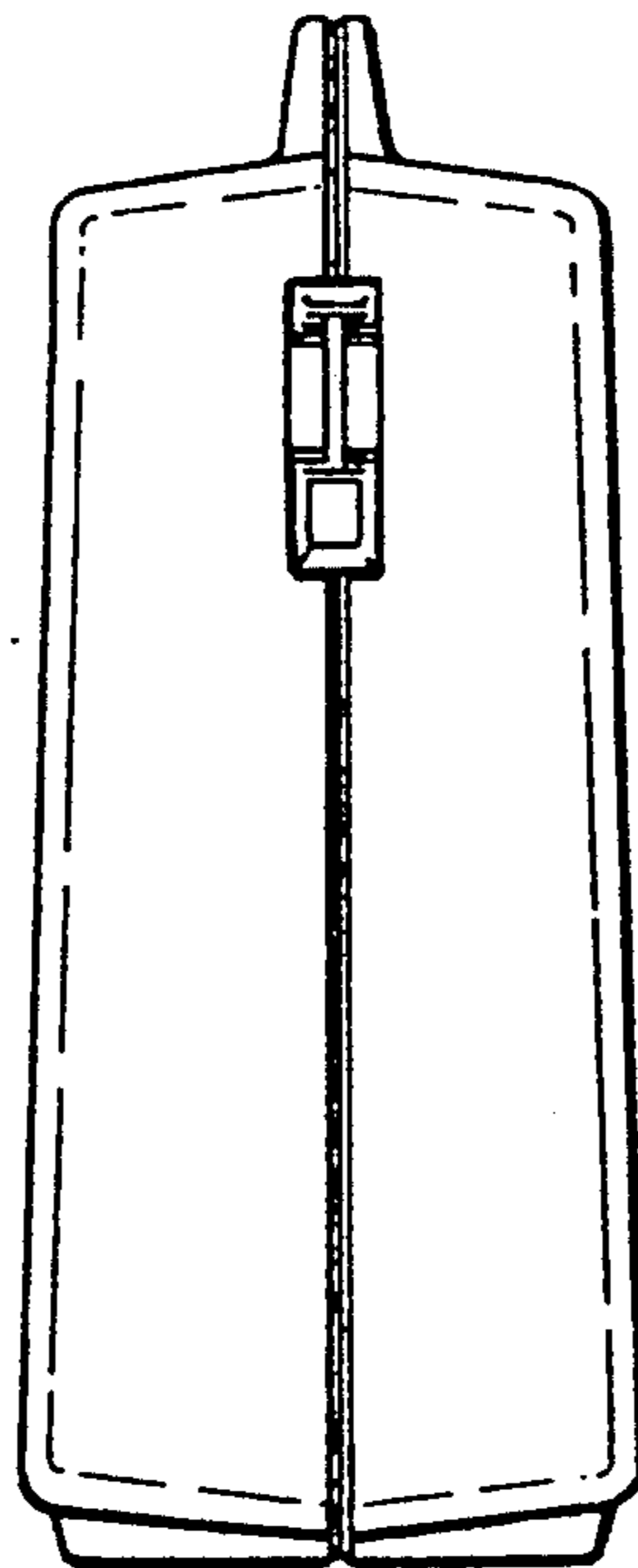

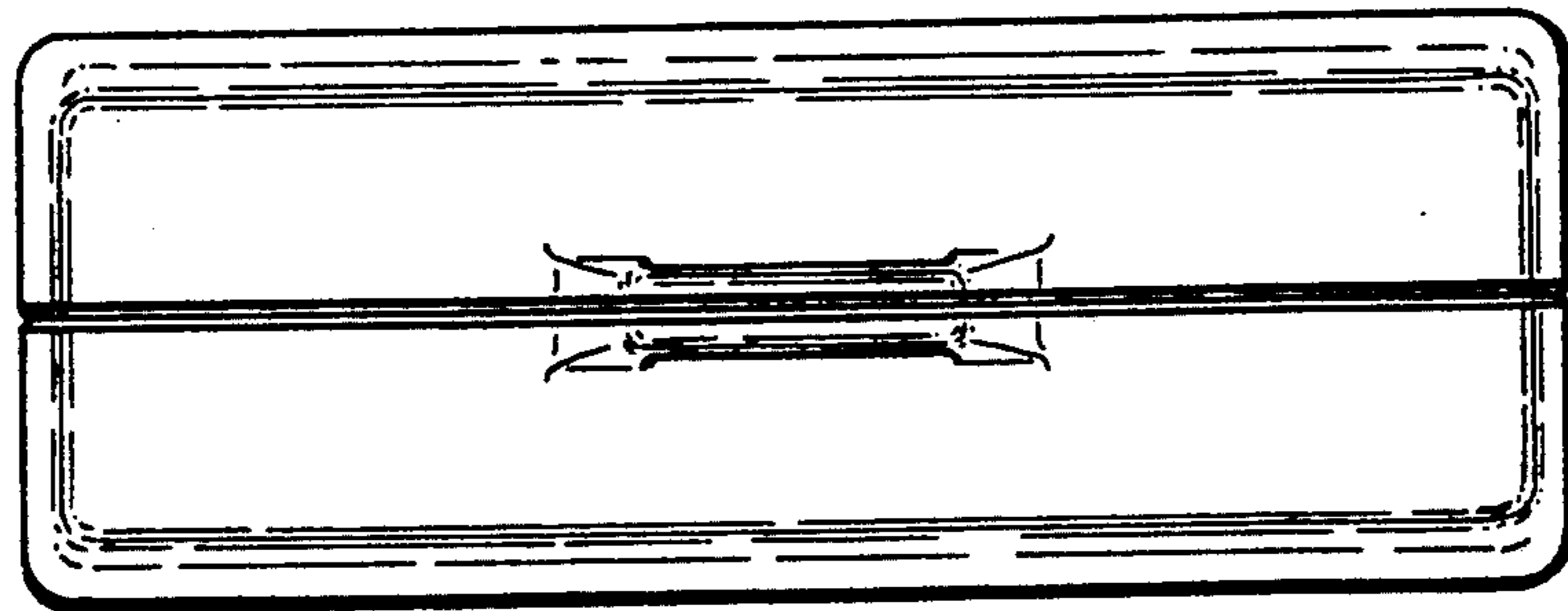

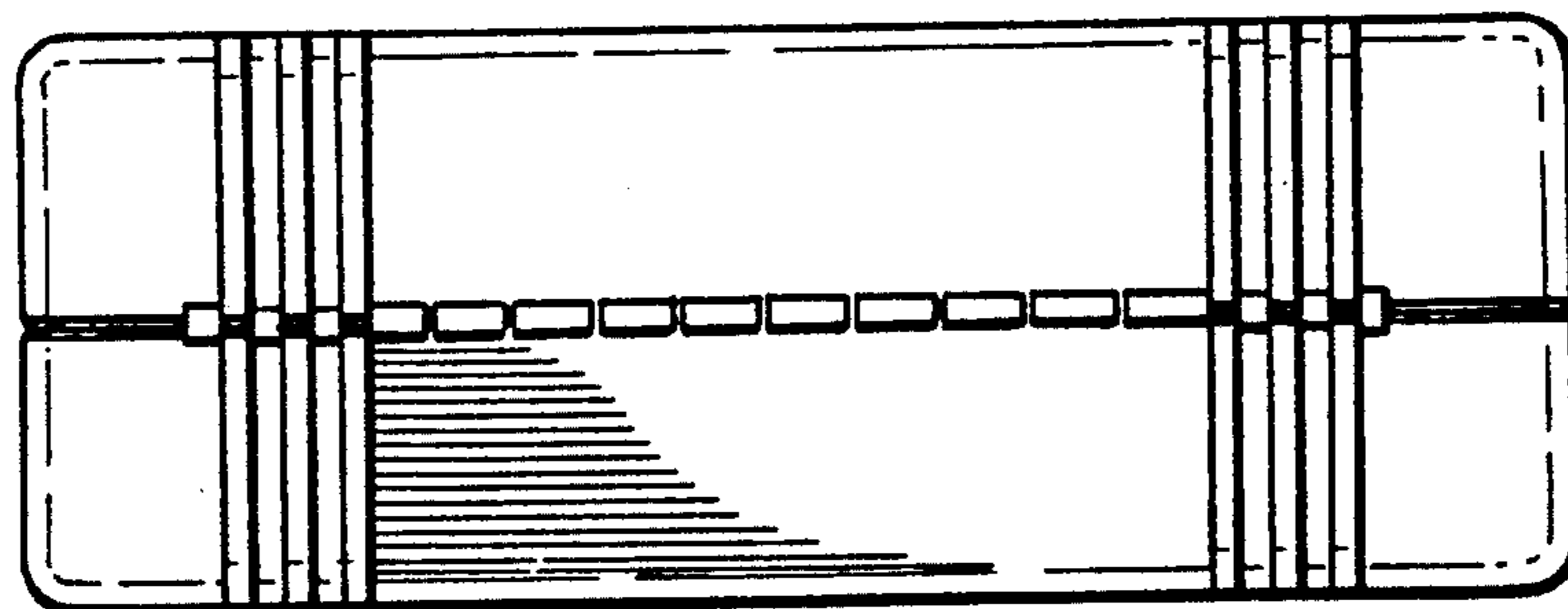

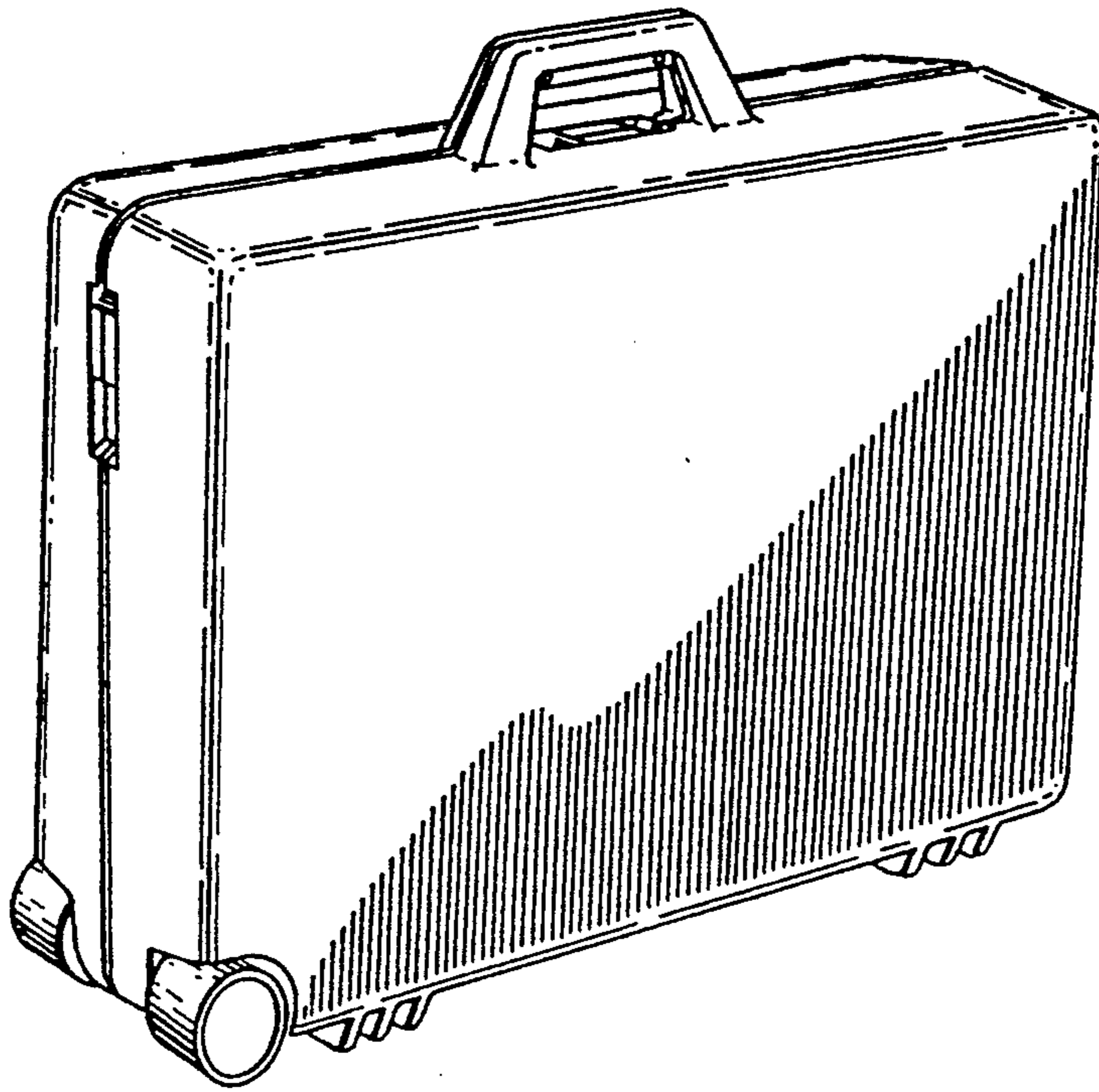

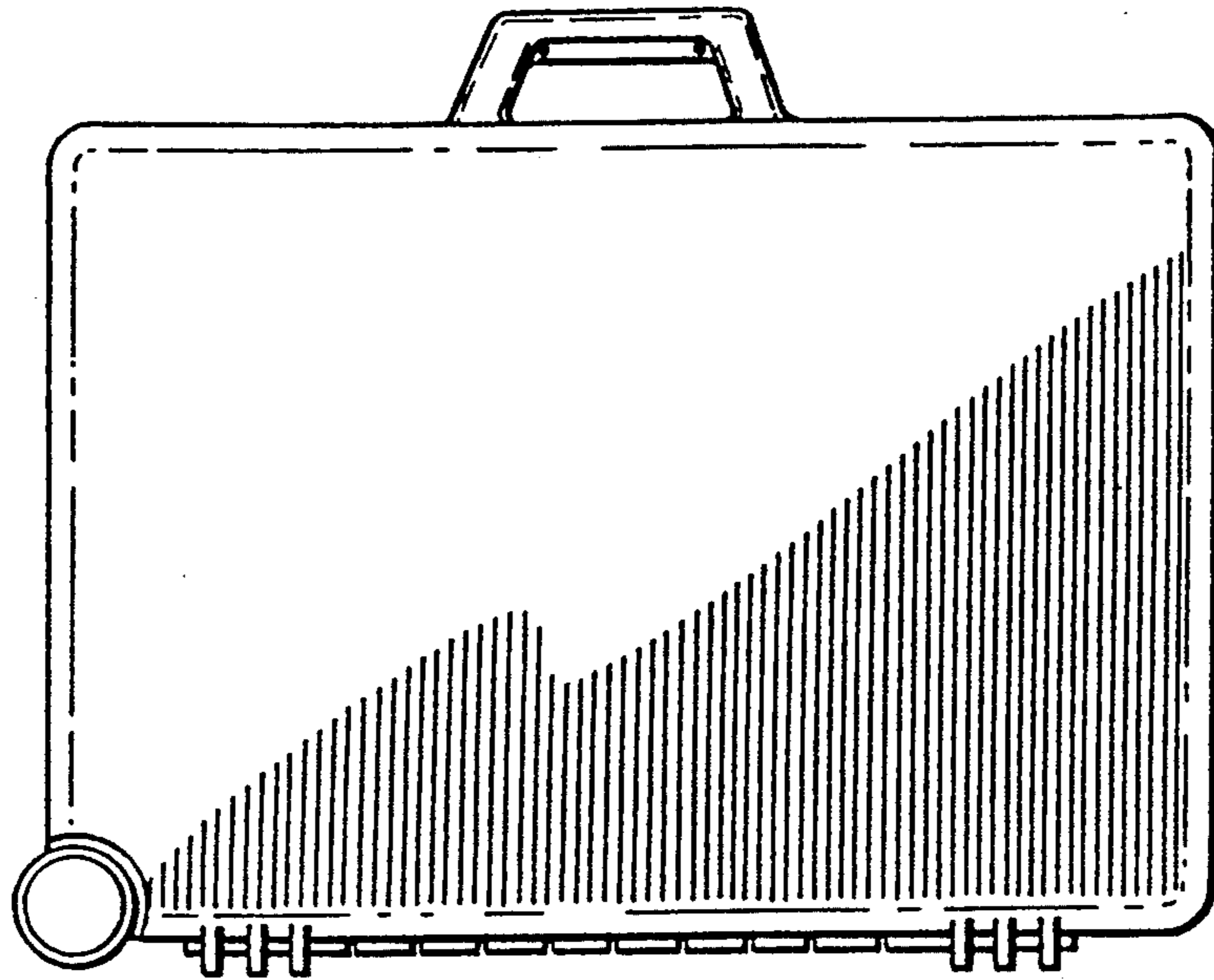

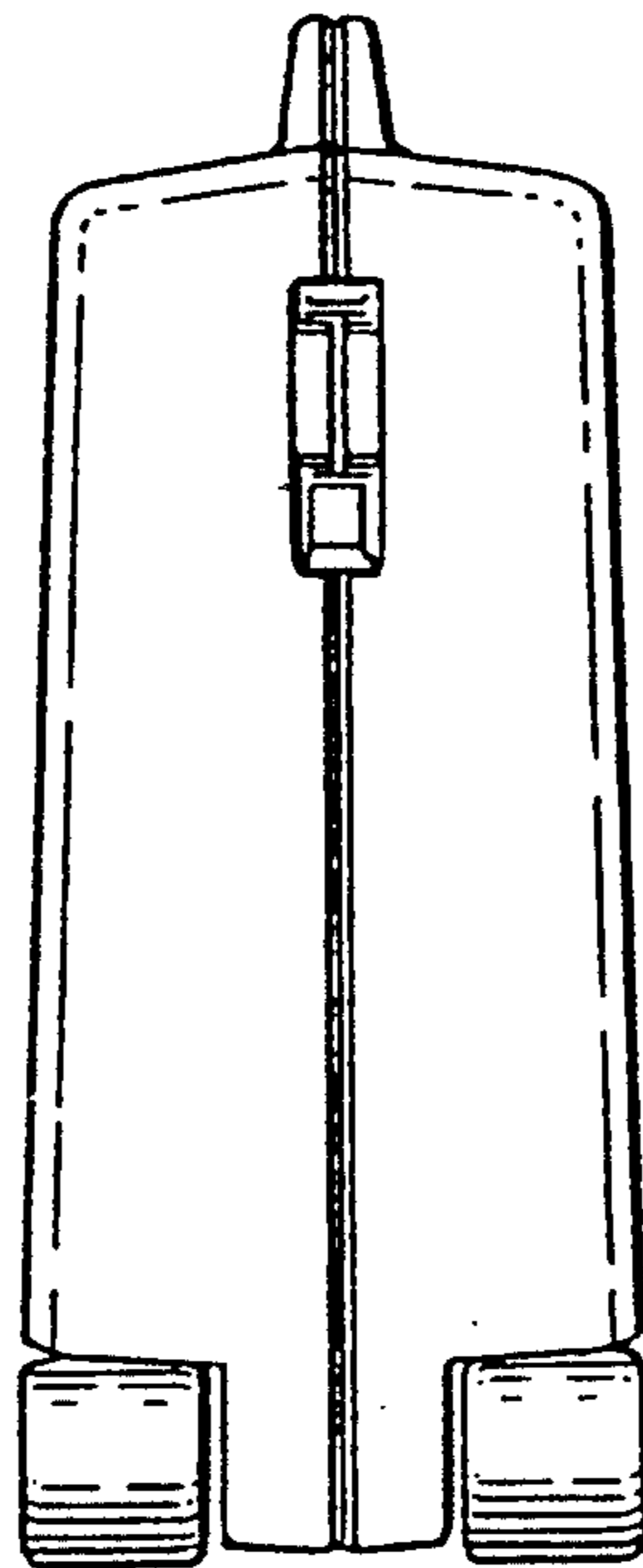
