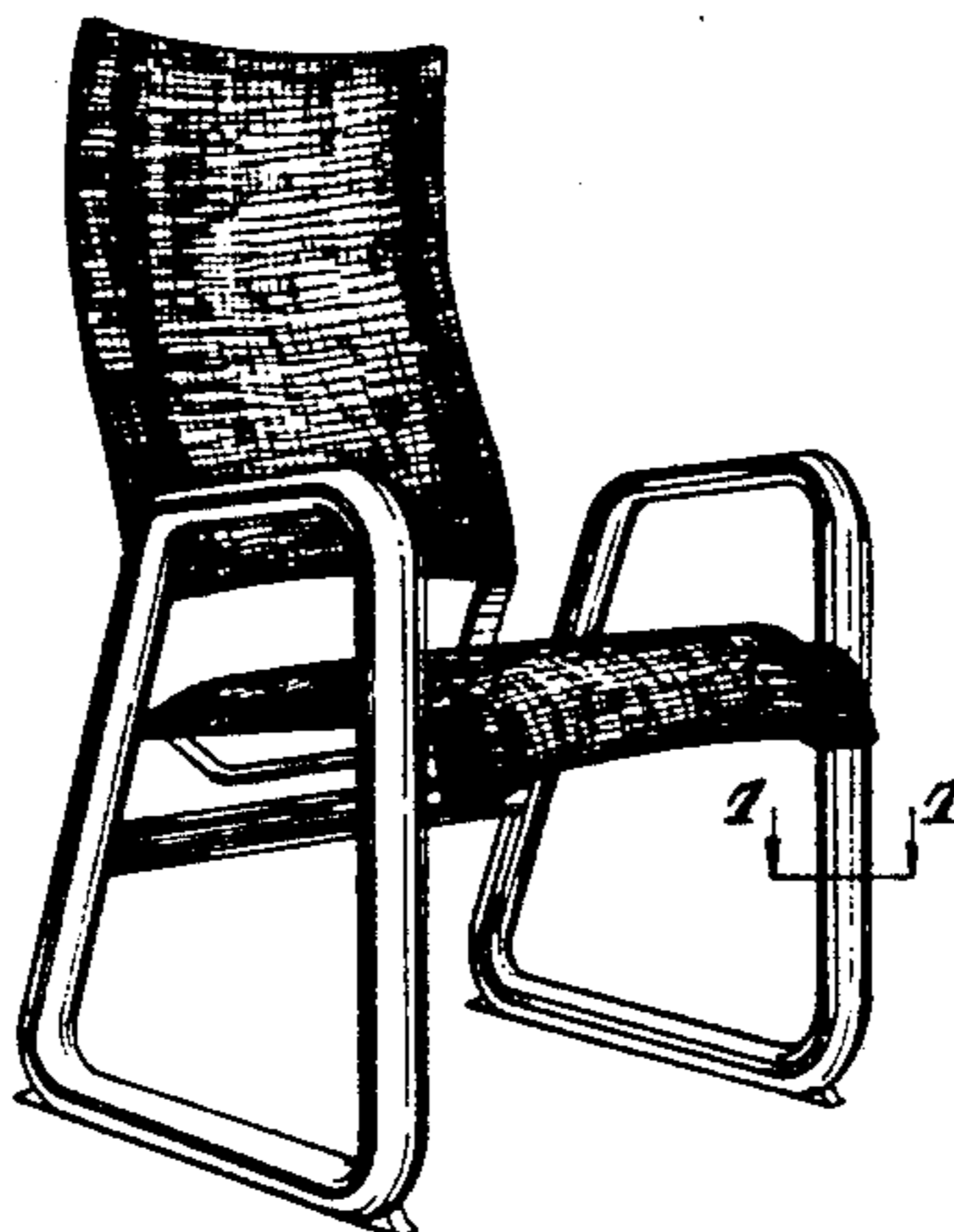

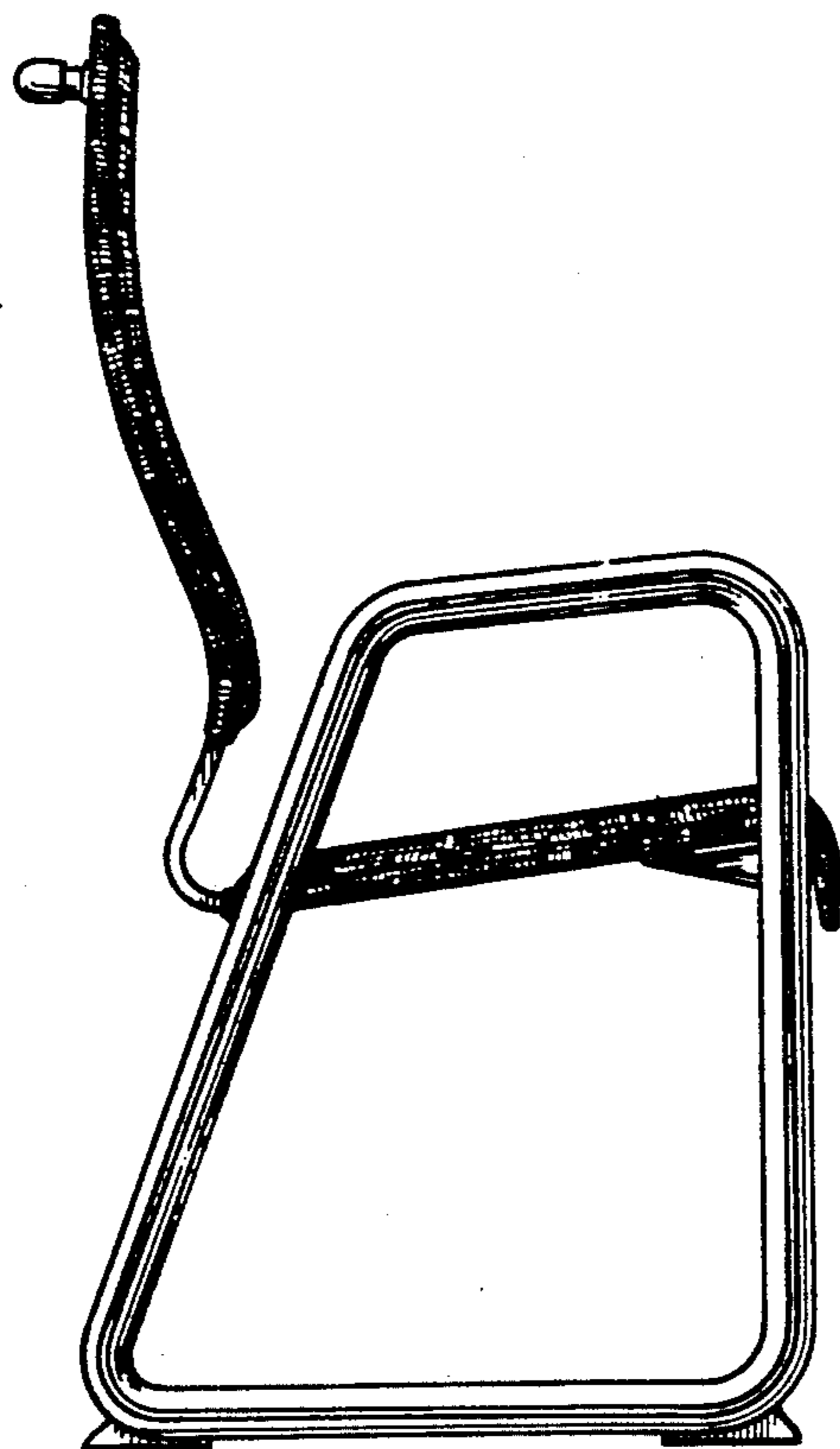
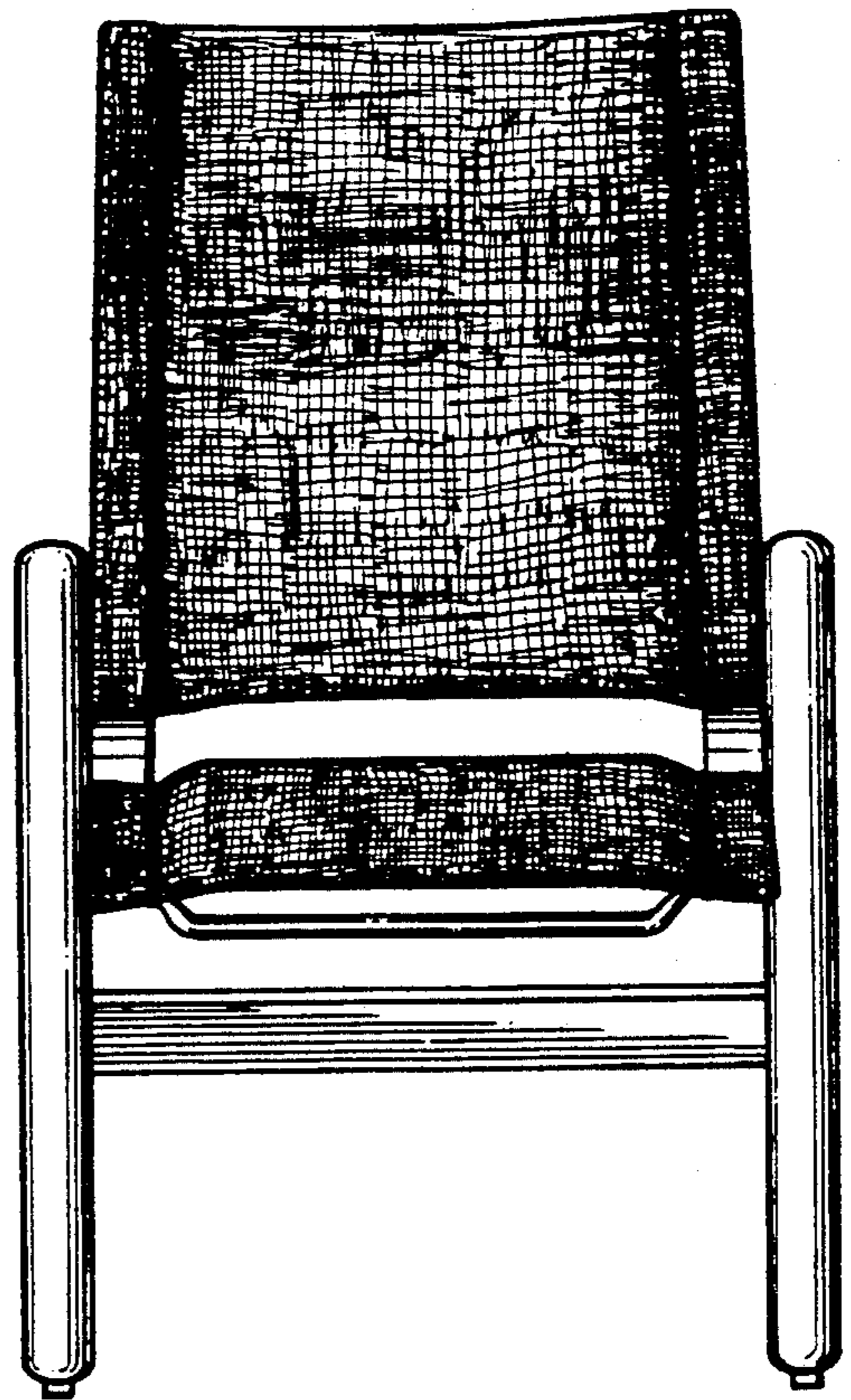
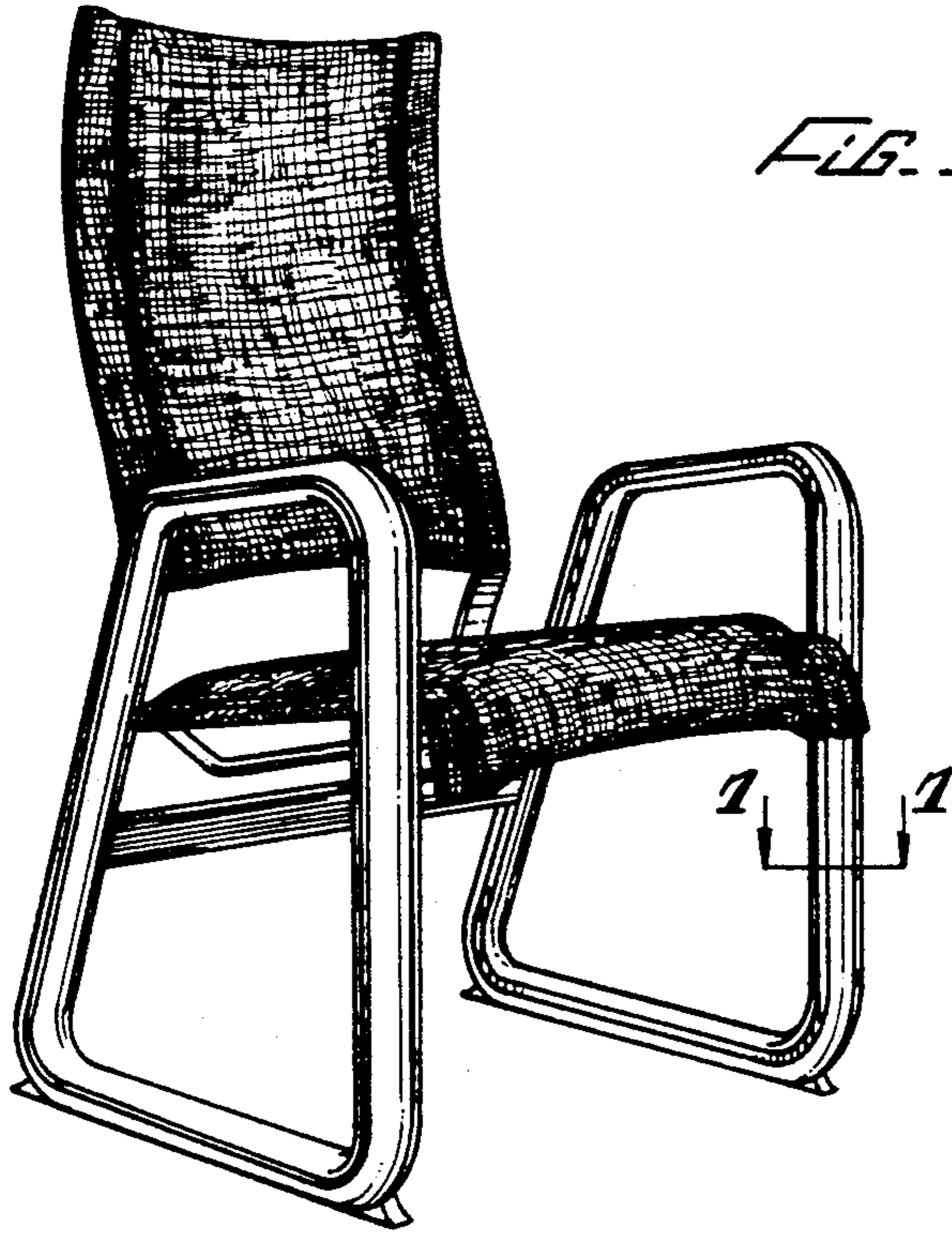
The ornamental design for an arm chair, as shown and described.



**DESCRIPTION**

FIG. 1 is a front top-left perspective view of an arm chair showing my new design;  
FIG. 2 is a front elevational view;

FIG. 3 is a left side elevational view the right side being a mirror image;  
FIG. 4 is a rear elevational view;  
FIG. 5 is a top plan view;  
FIG. 6 is a bottom plan view thereof; and  
FIG. 7 is a cross-sectional view of FIG. 1 as taken from line 7—7.



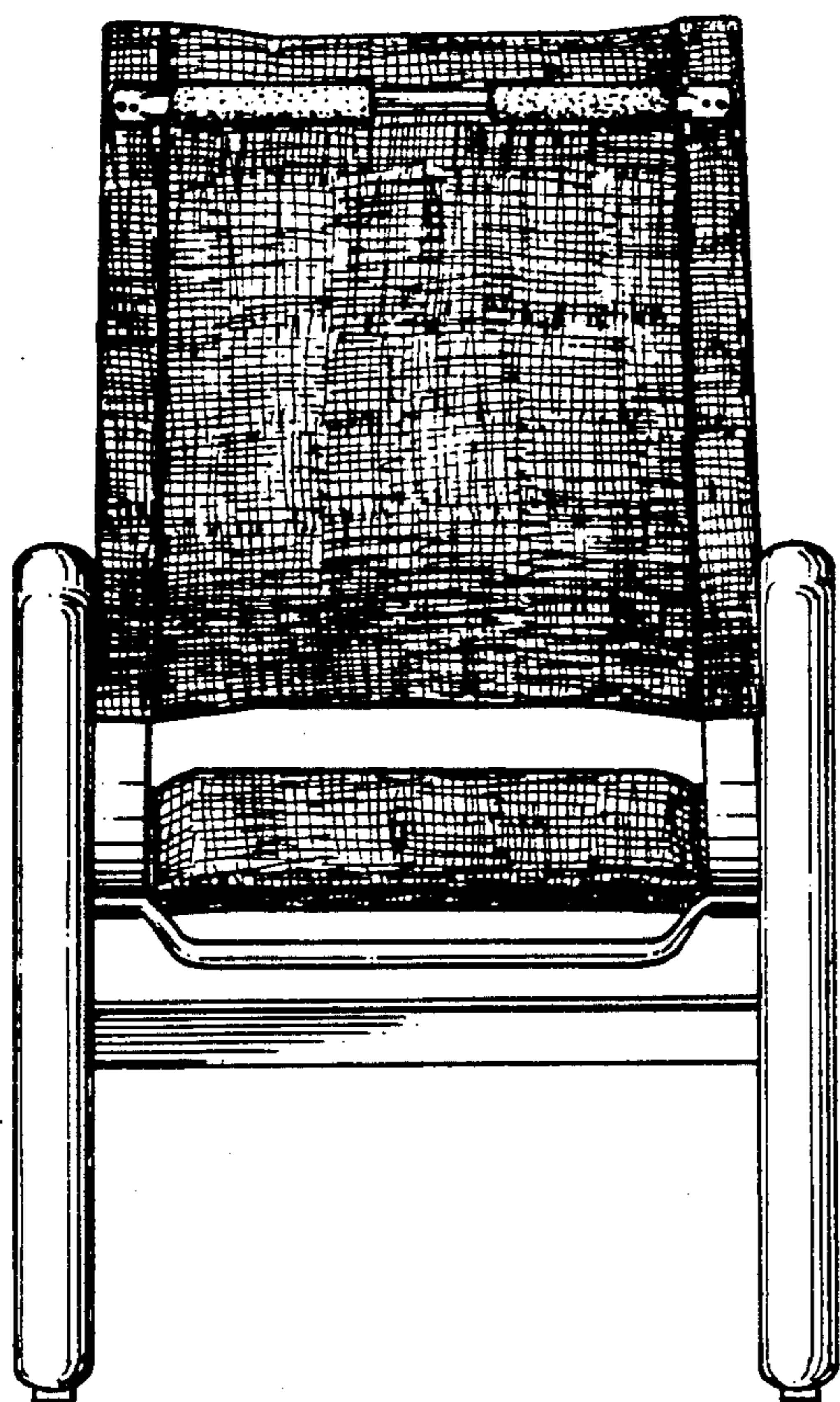

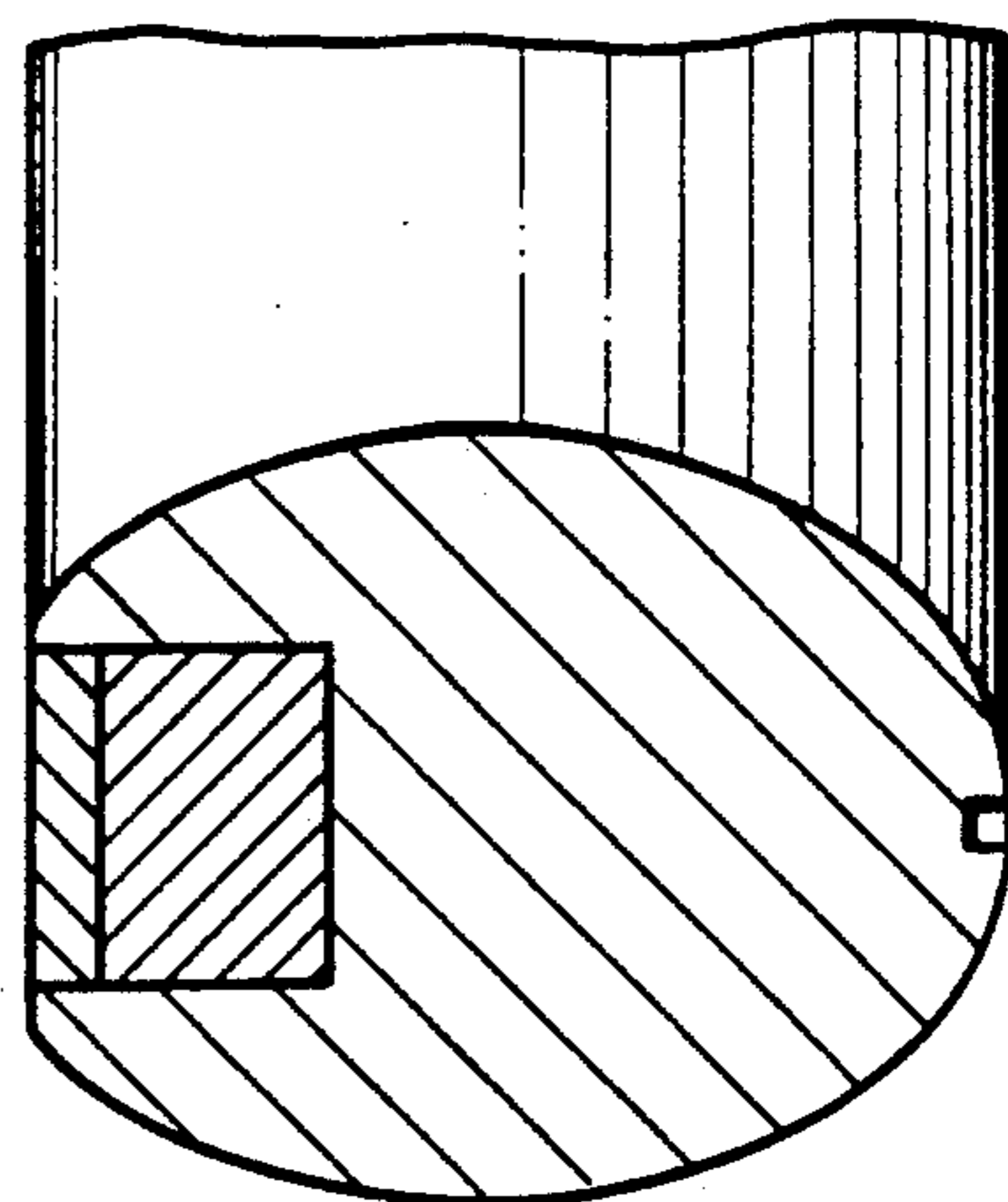

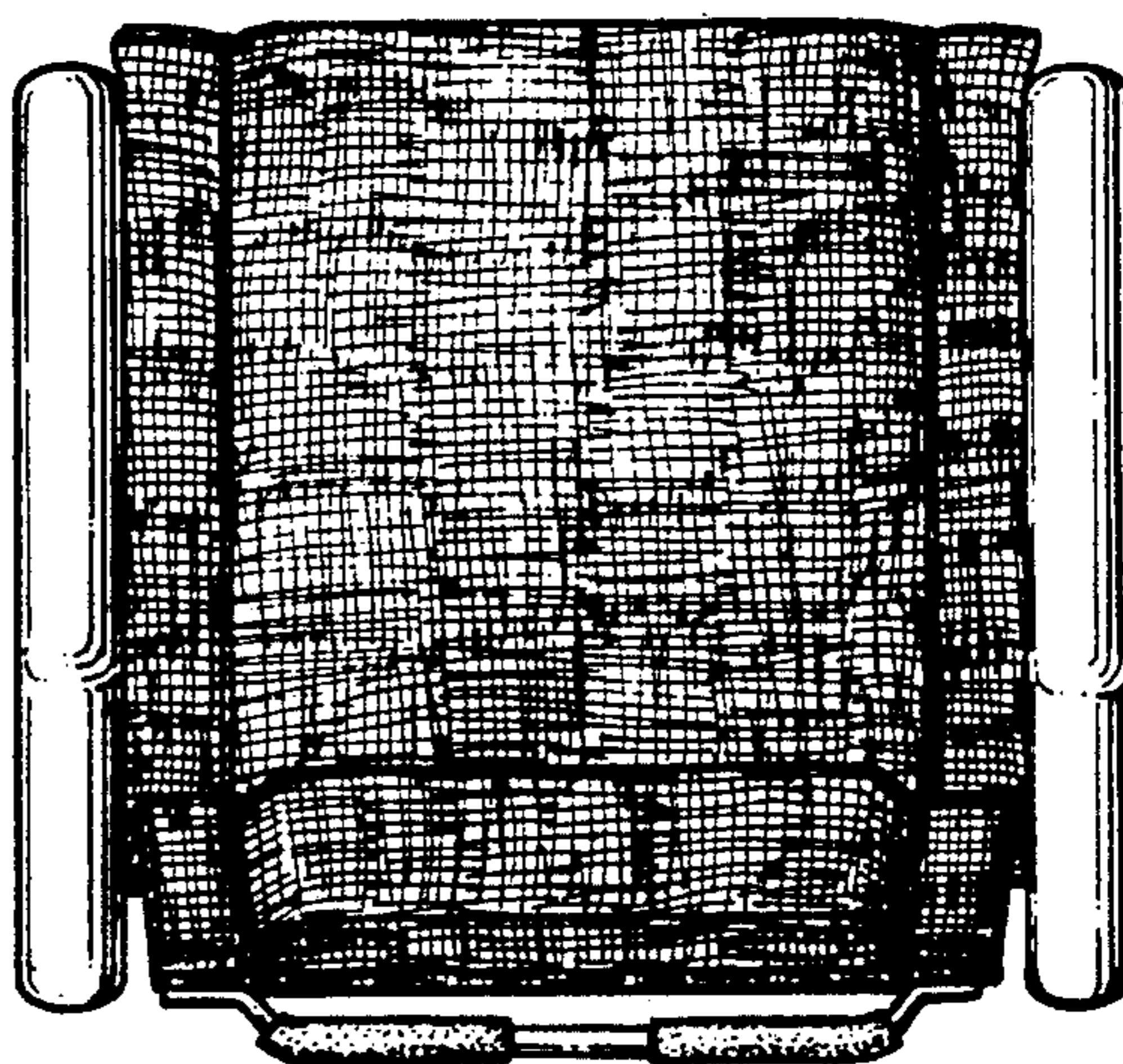

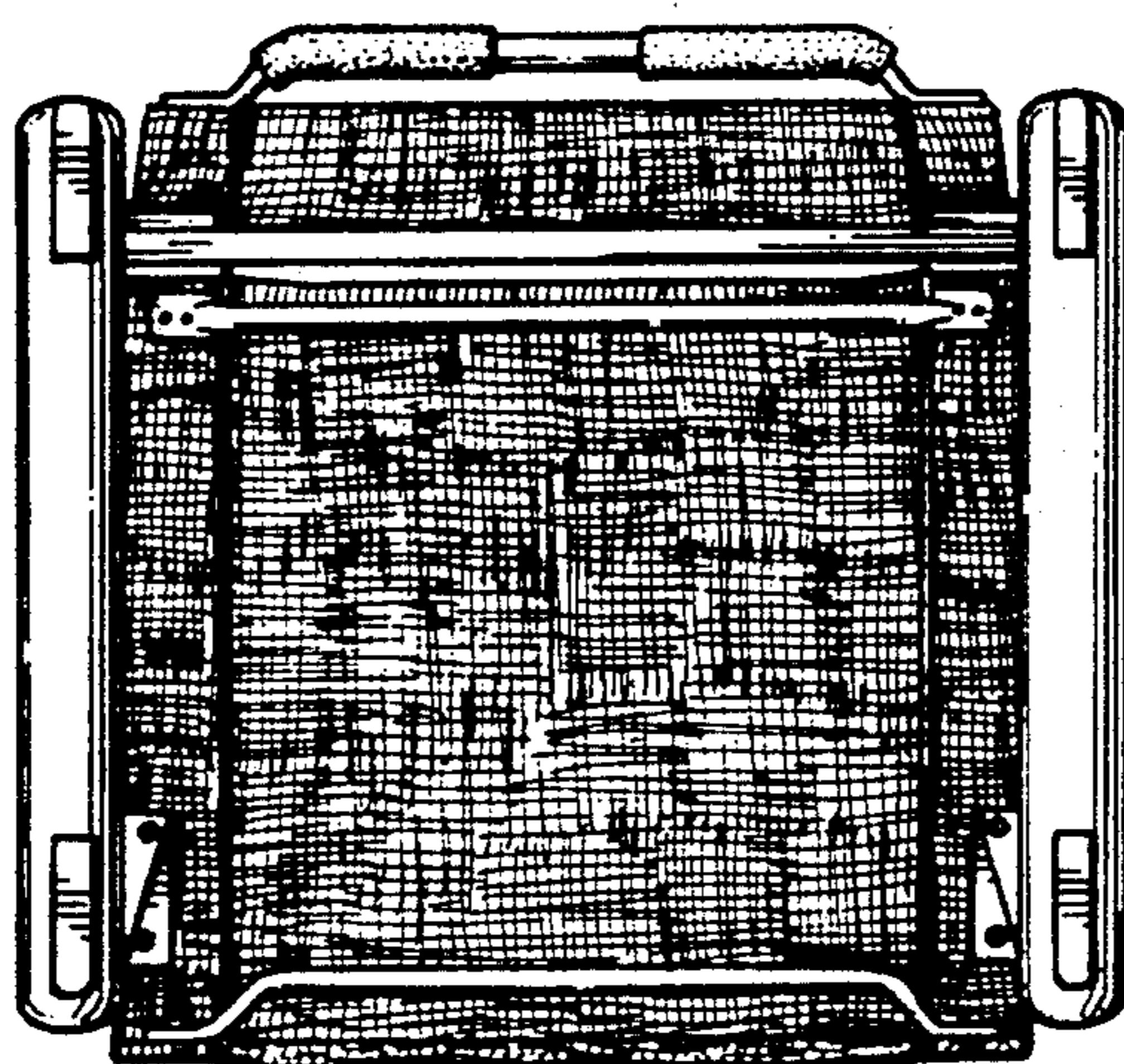
