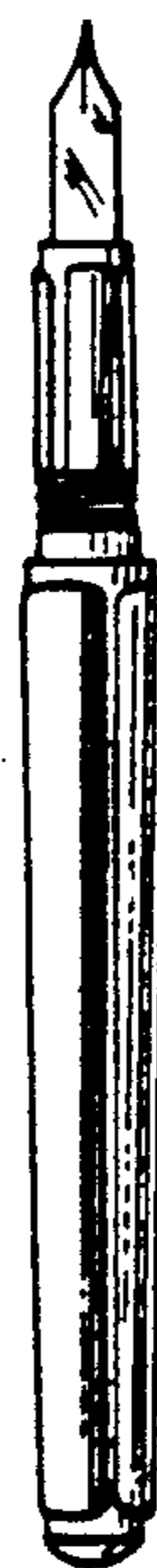

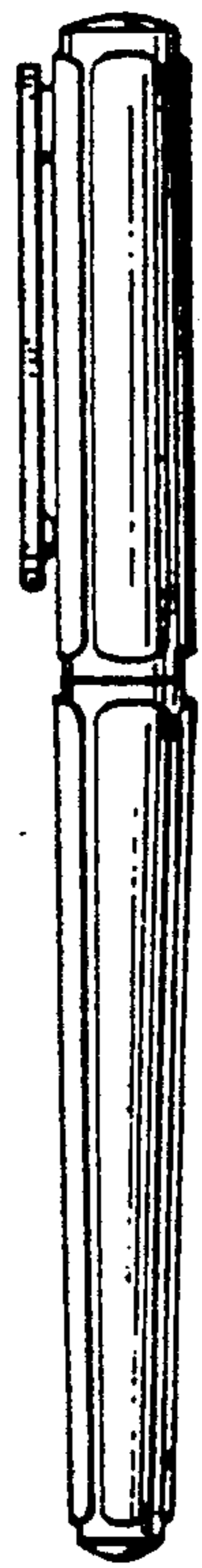
The ornamental design for a pen, as shown and described.
