[57] **CLAIM**

The ornamental design for a desk organizer, as shown and described.

DESCRIPTION

FIG. 1 is a top, left front perspective view of a desk organizer showing my new design; FIG. 2 is a front elevational view on an enlarged scale; FIG. 3 is a top plan view of FIG. 2; FIG. 4 is a right side elevational view of FIG. 2, the left side being a mirror image thereof; FIG. 5 is a rear elevational view of FIG. 2; FIG. 6 is a bottom plan view of FIG. 2; and FIG. 7 is a cross-sectional view taken in the direction of arrows 7-7 in FIG. 2.

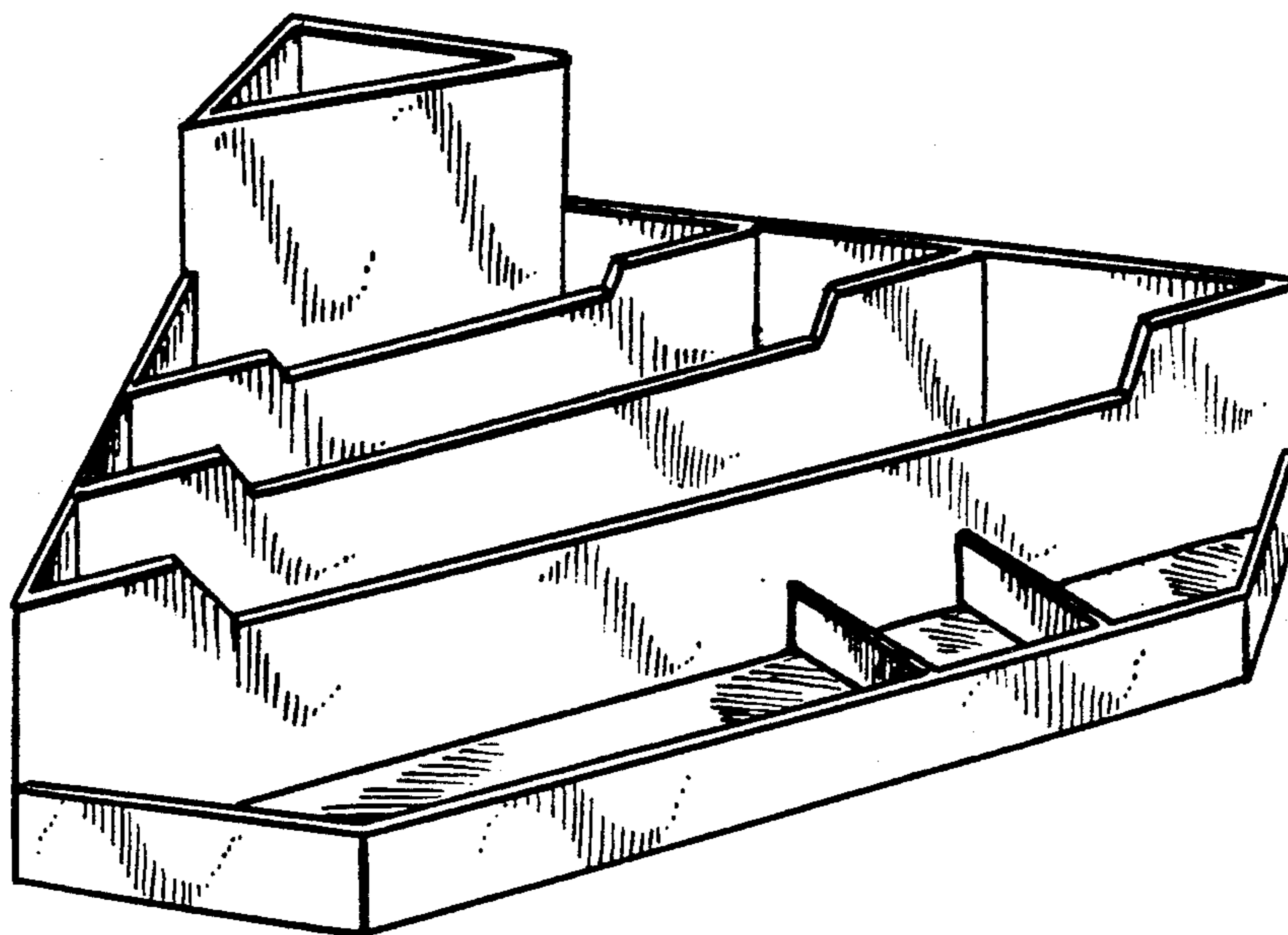

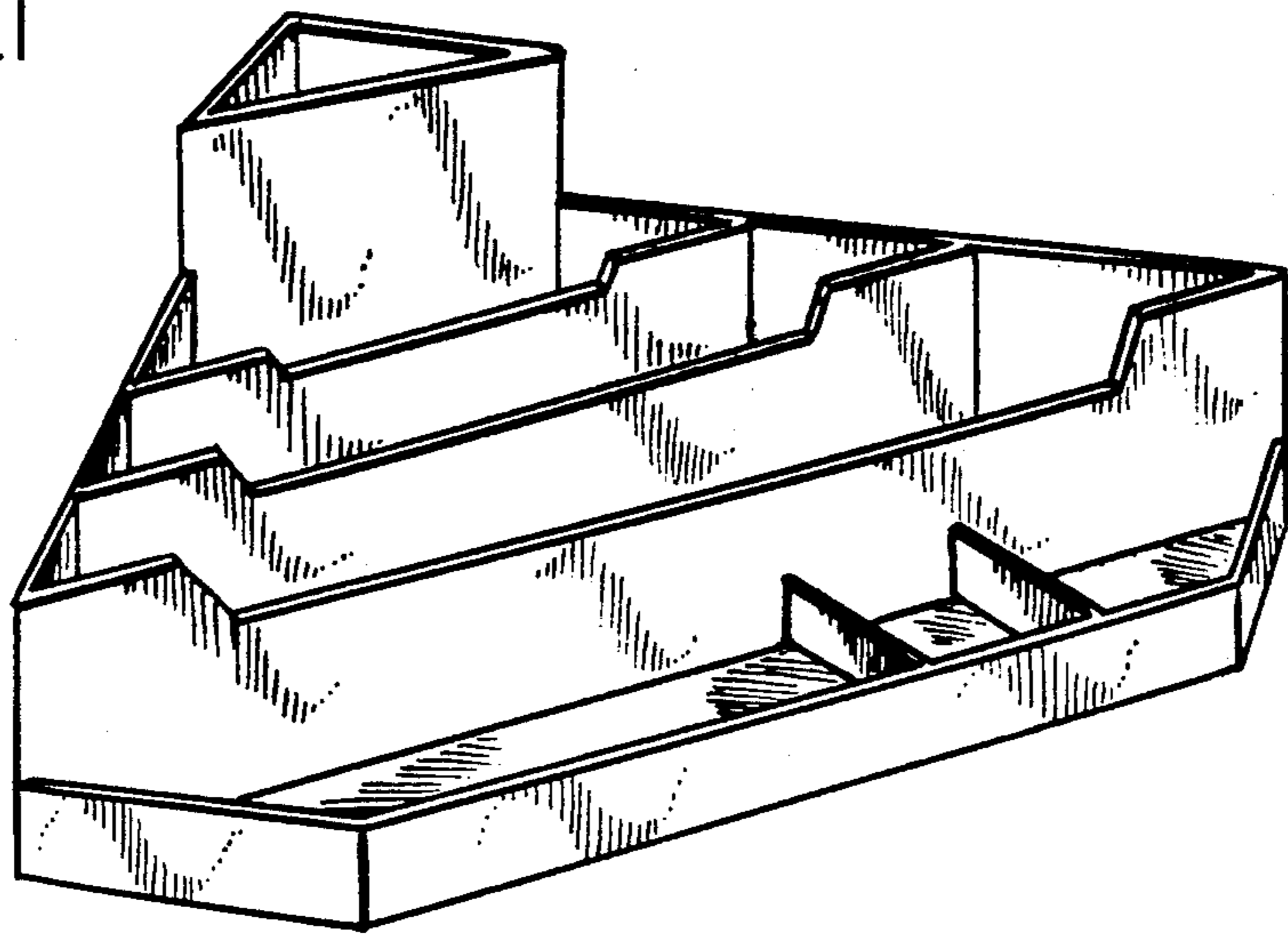

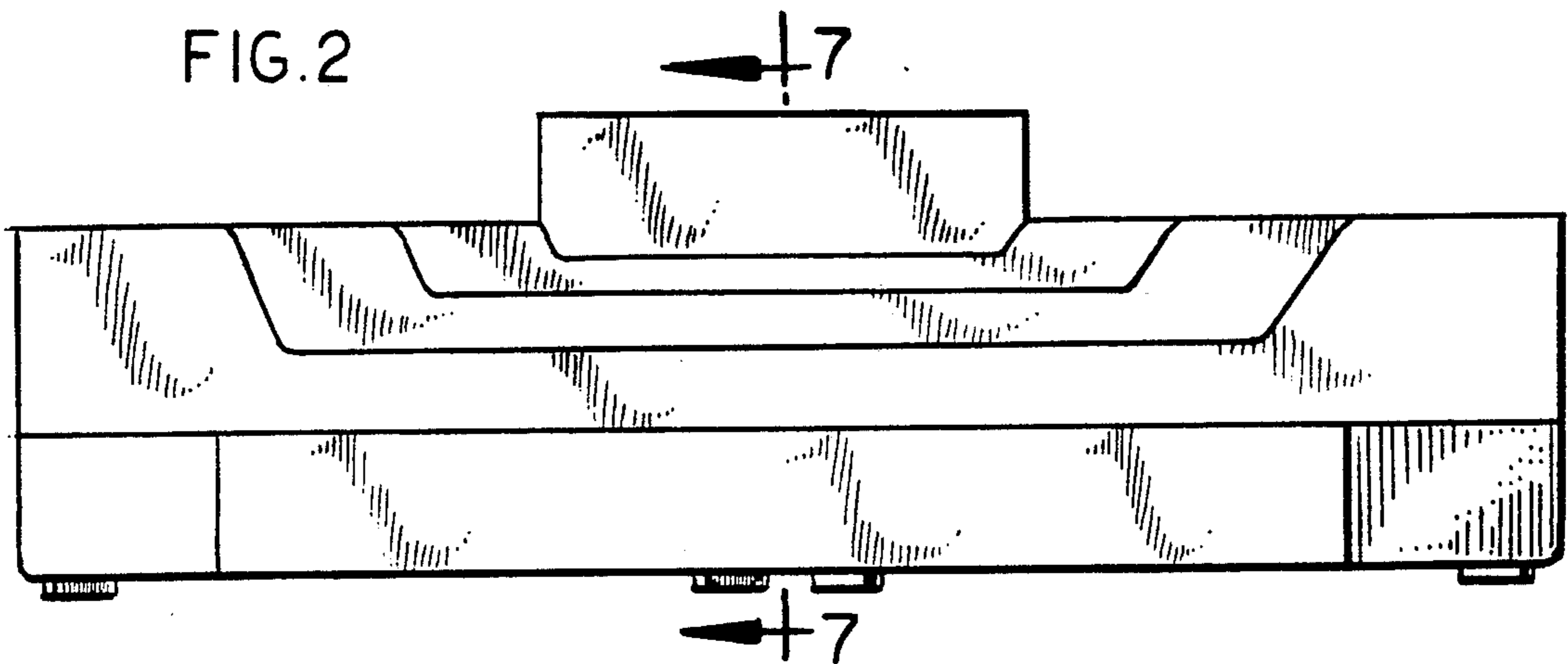

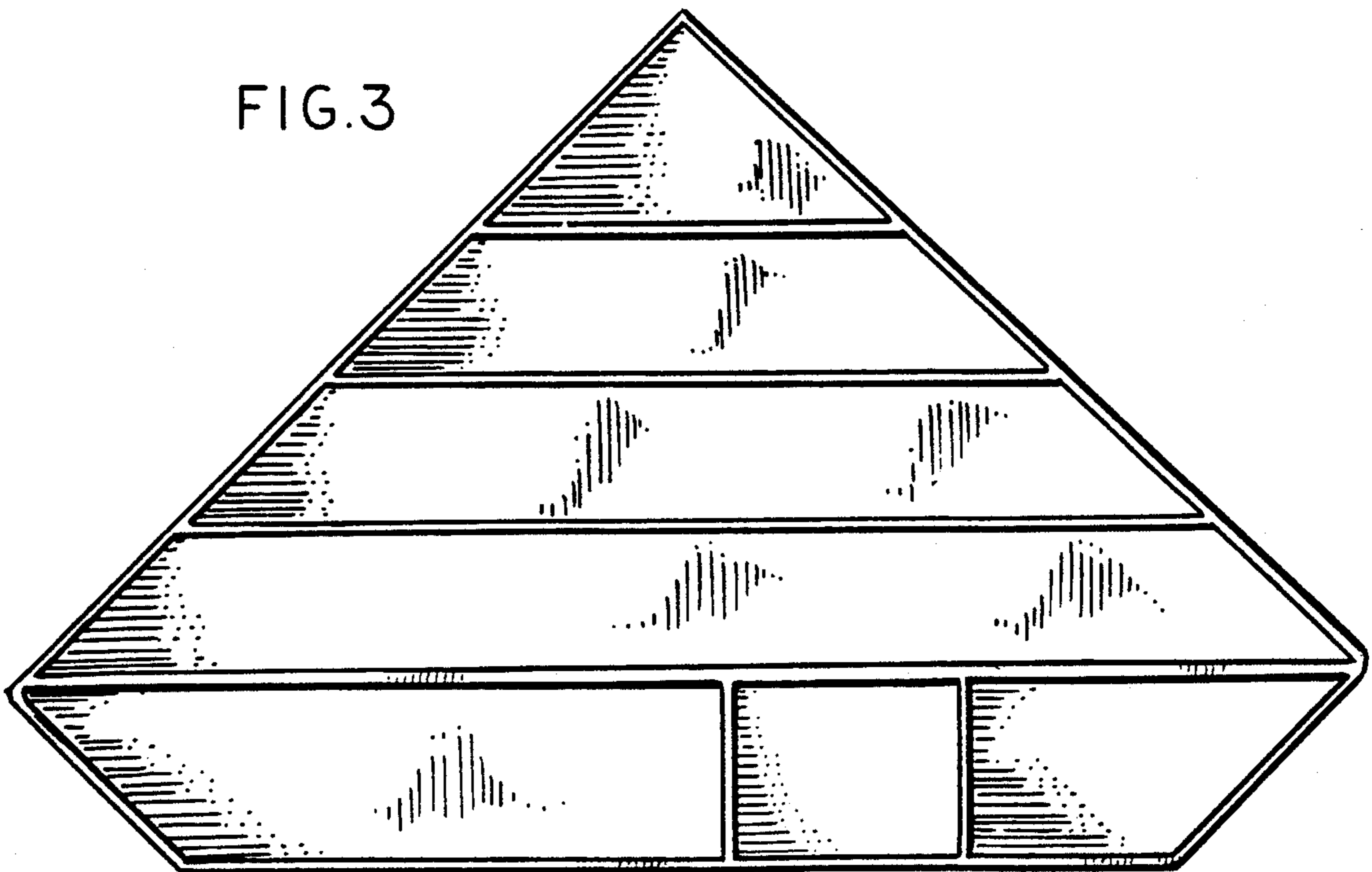

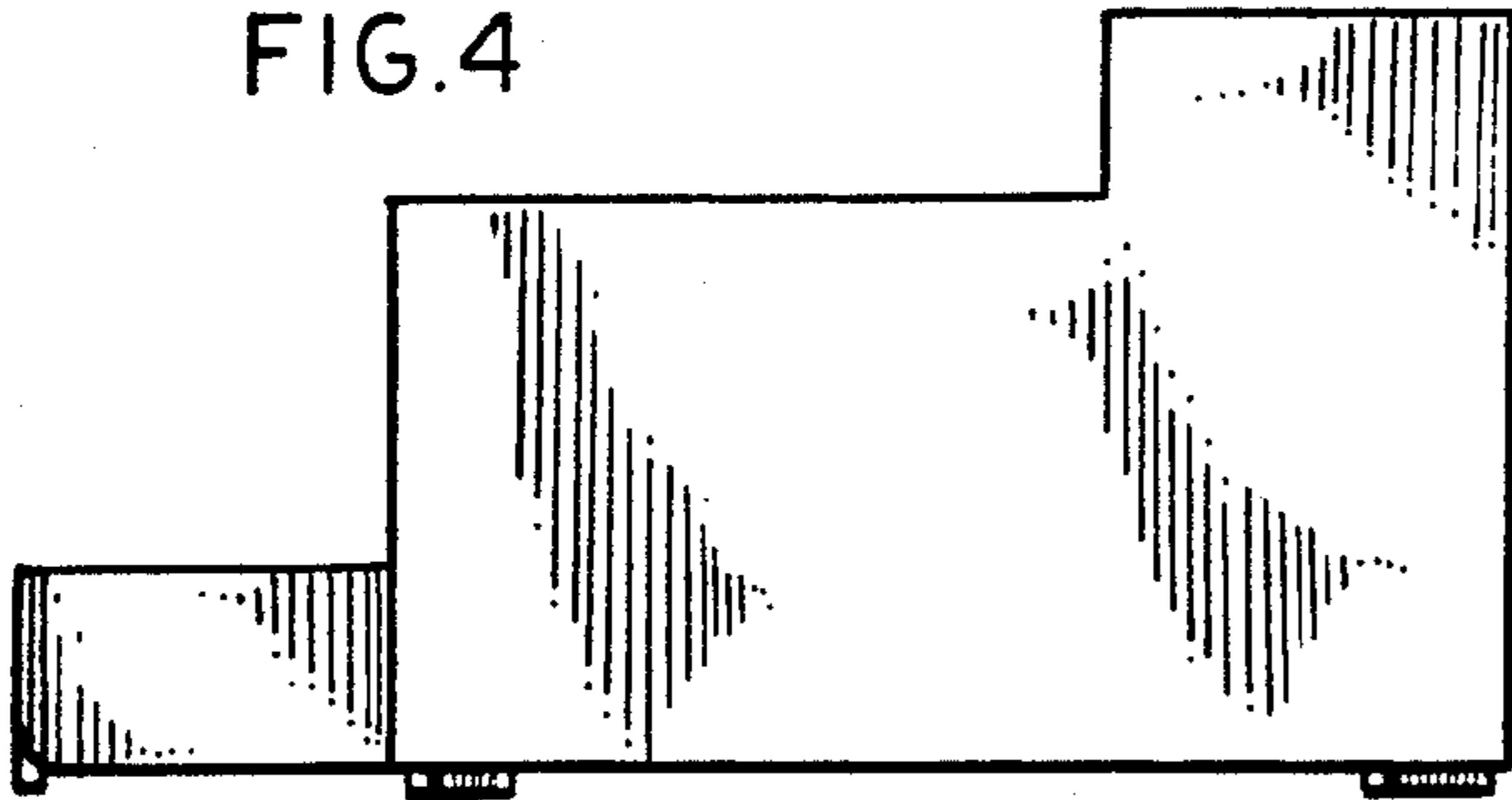

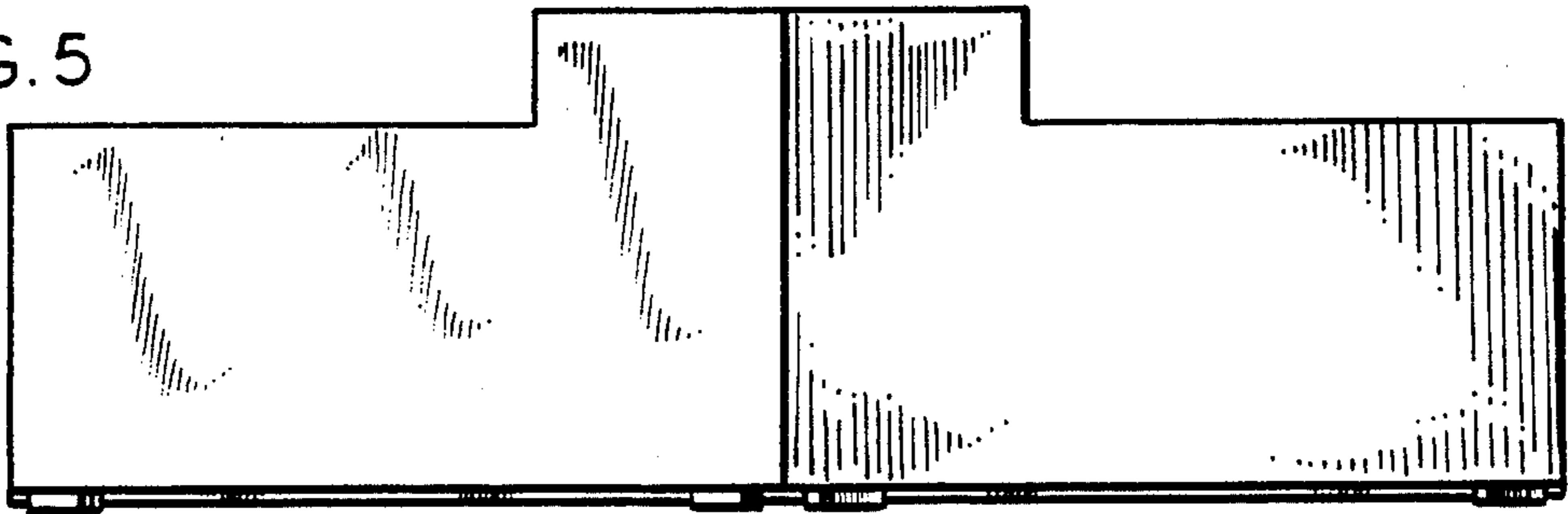

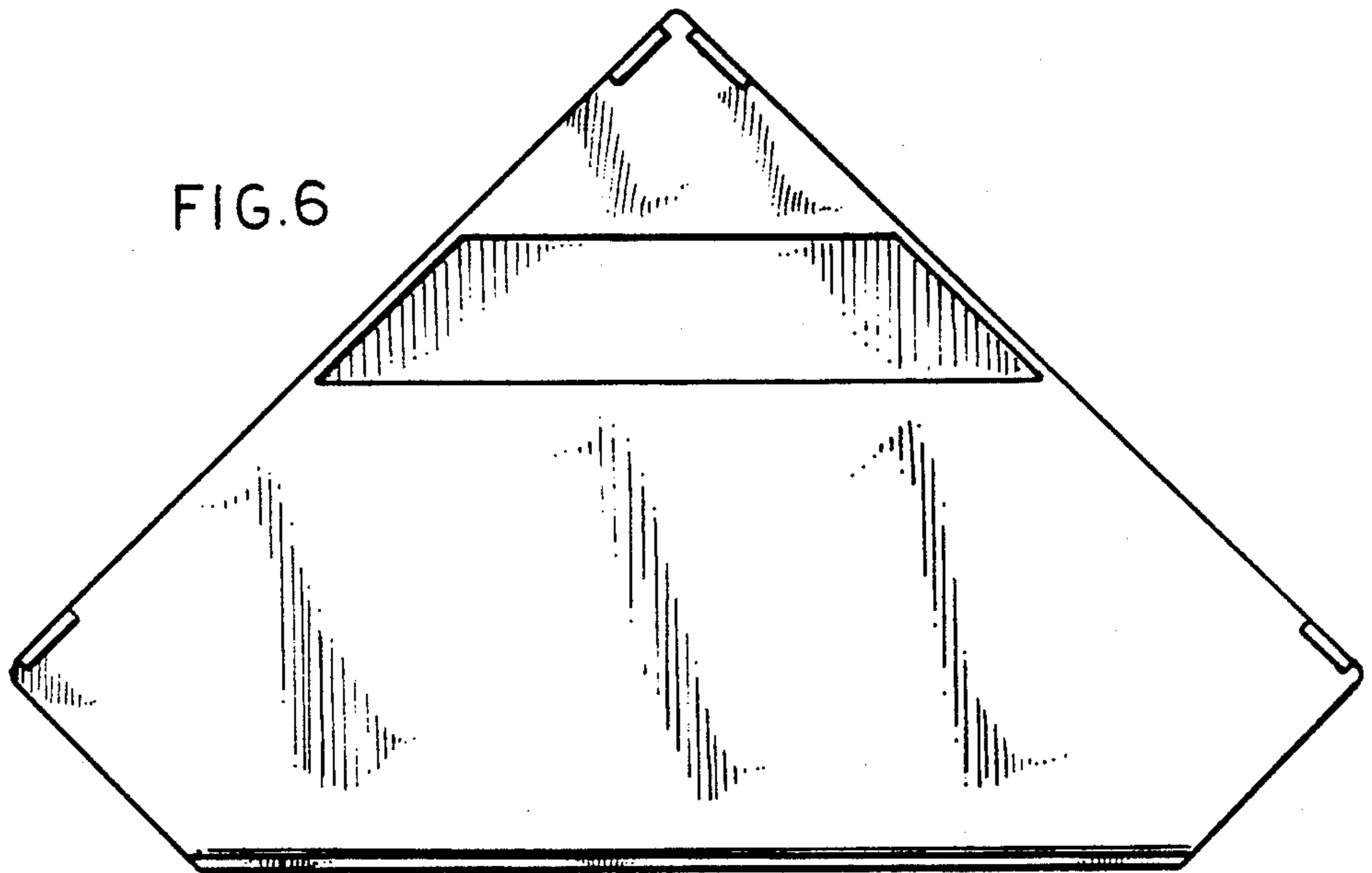
