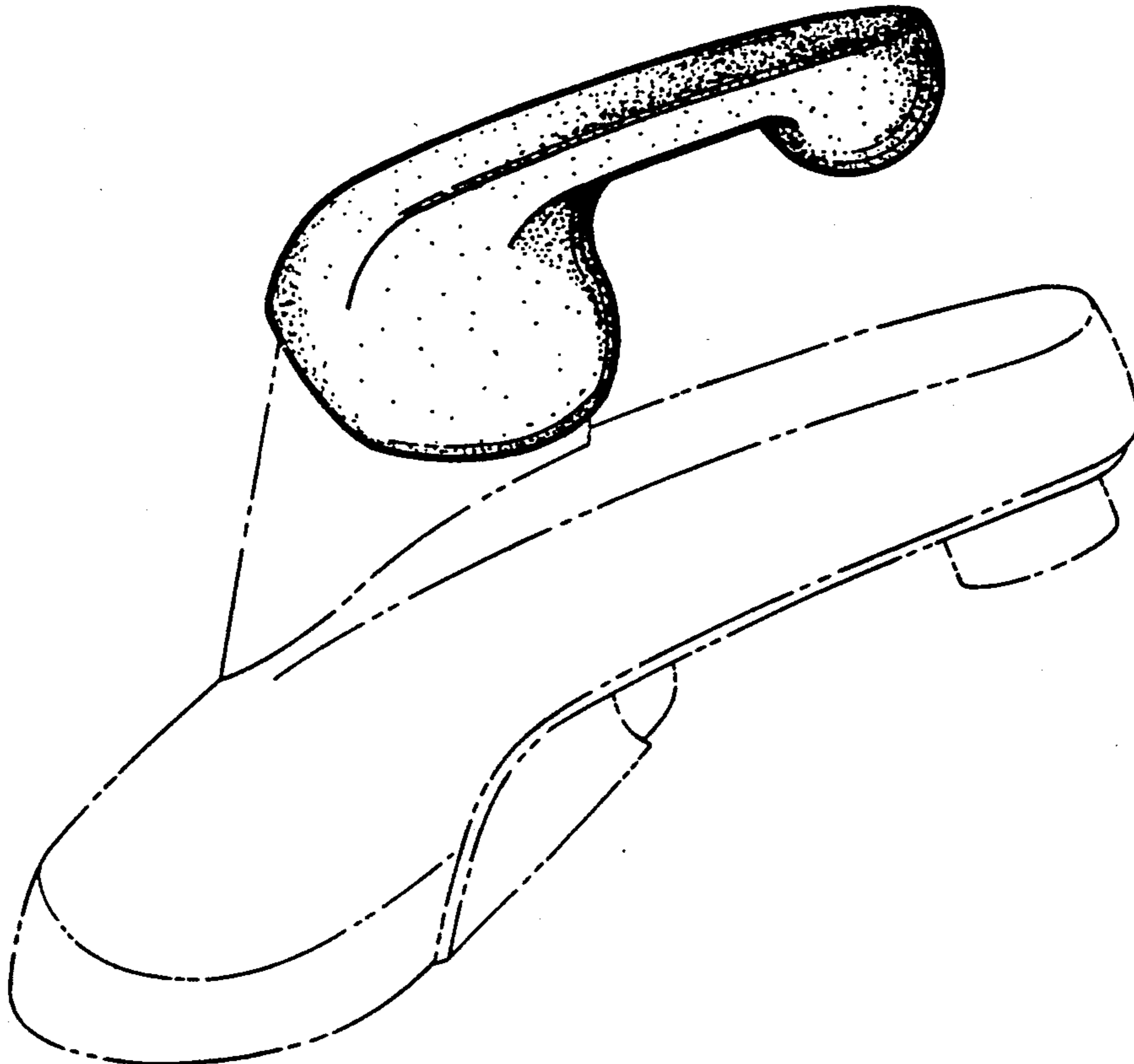

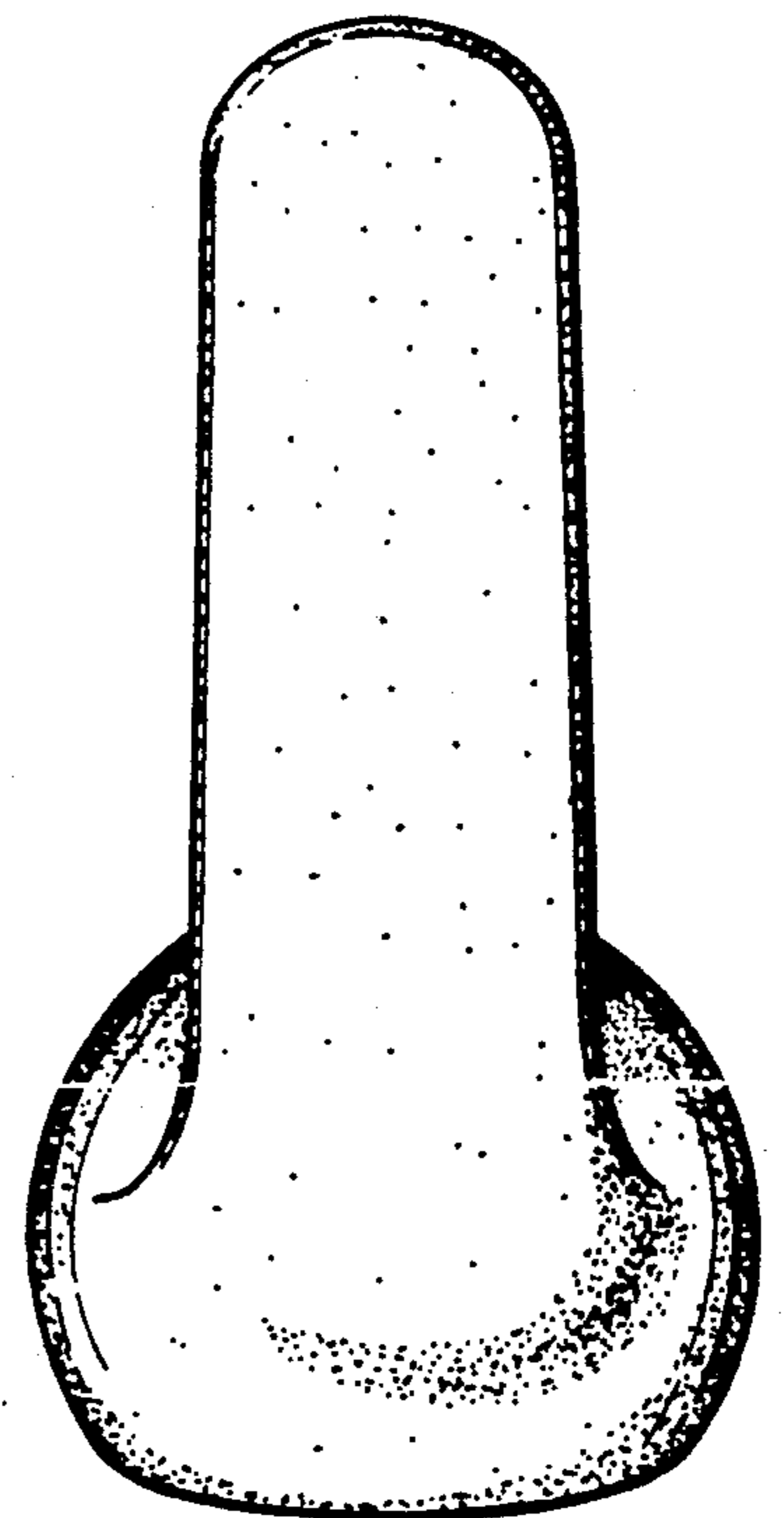
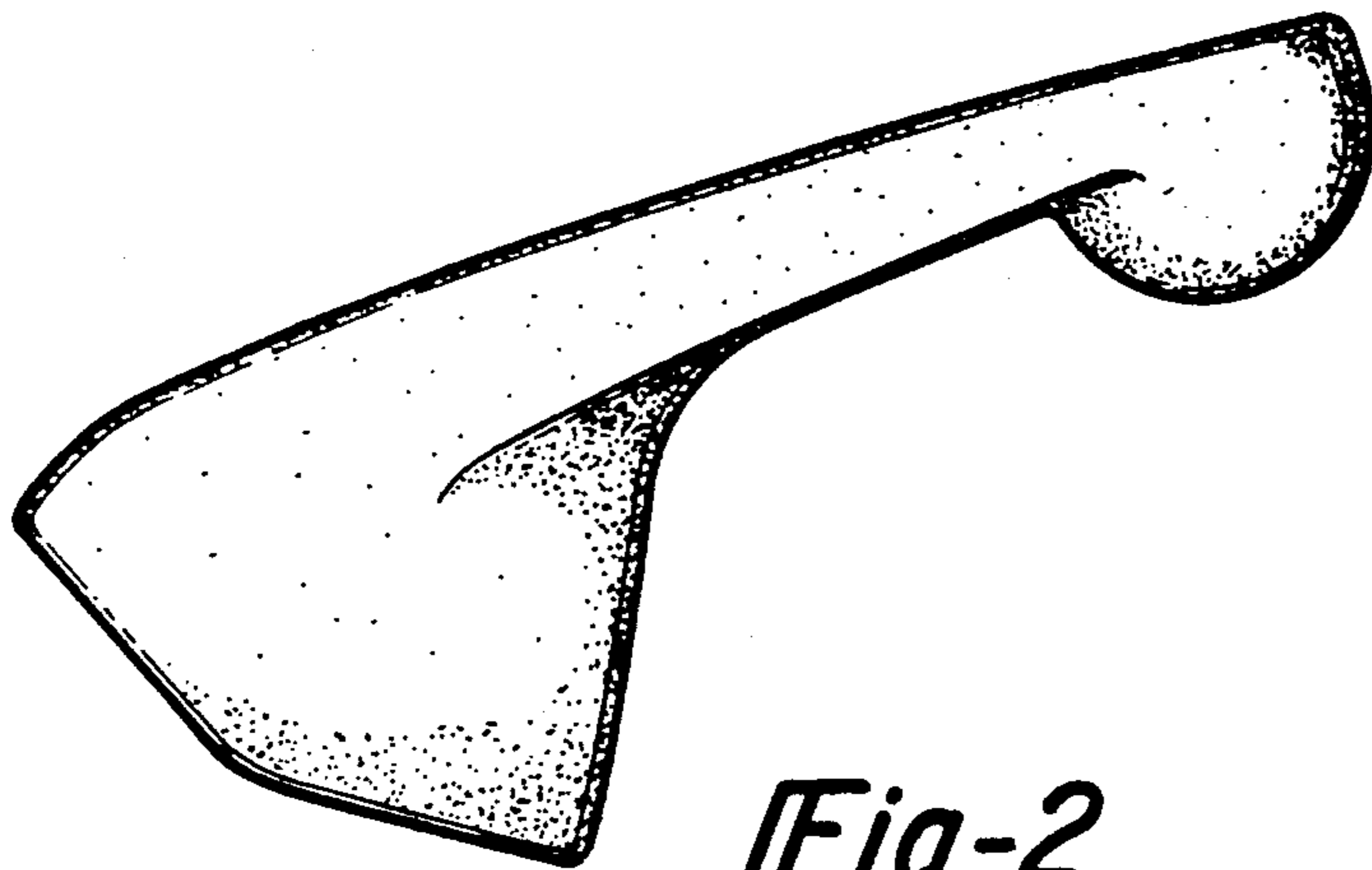
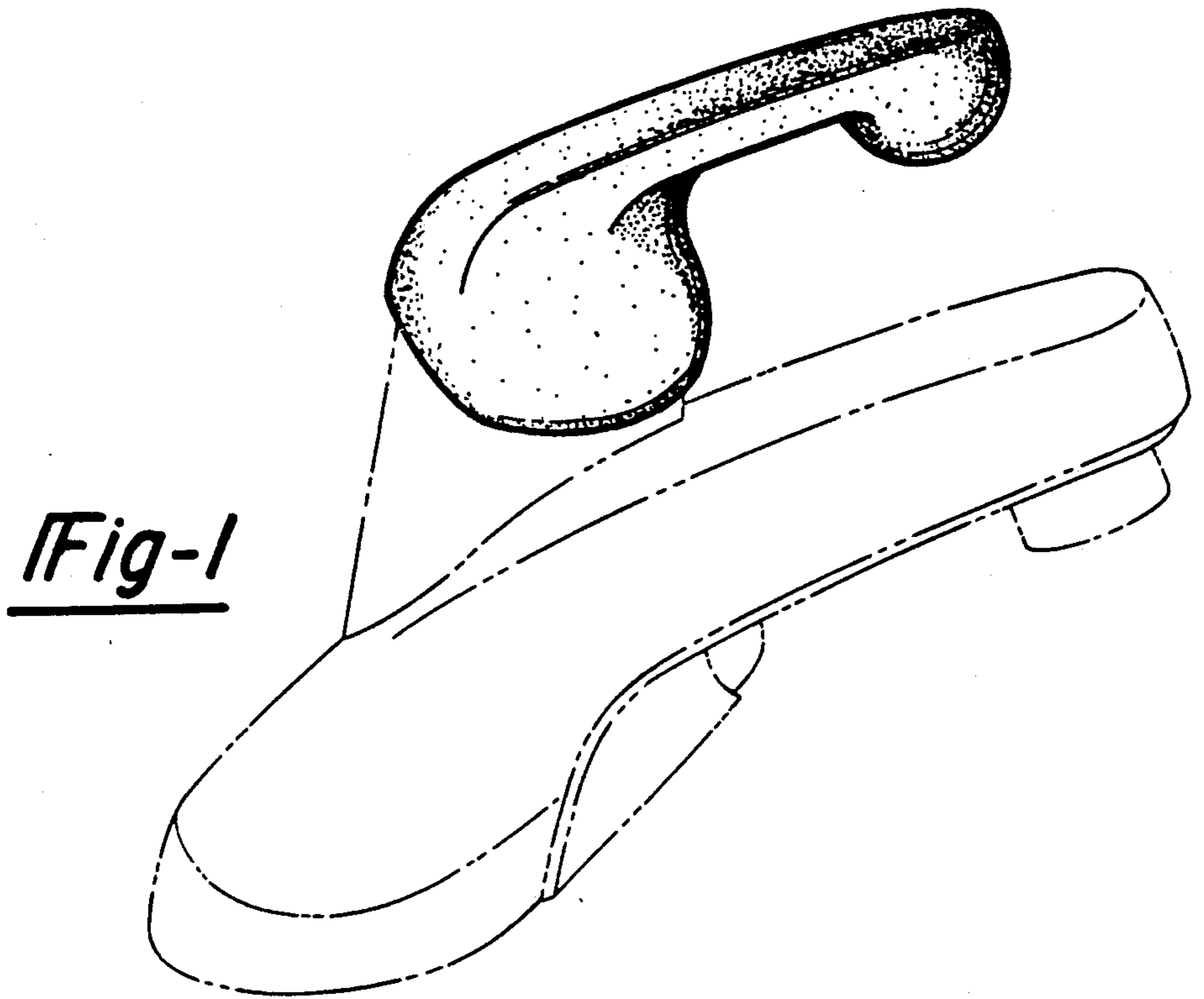

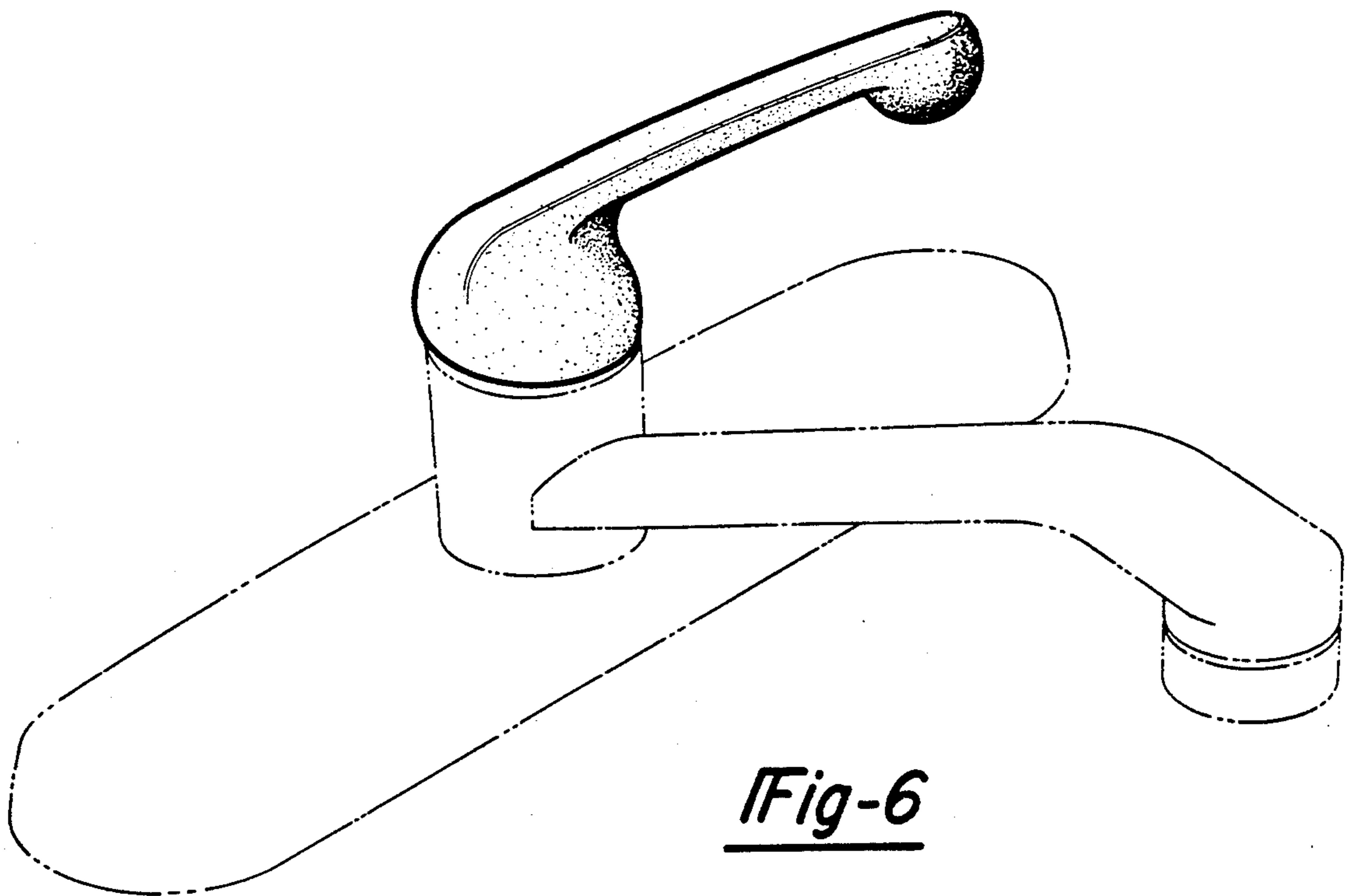
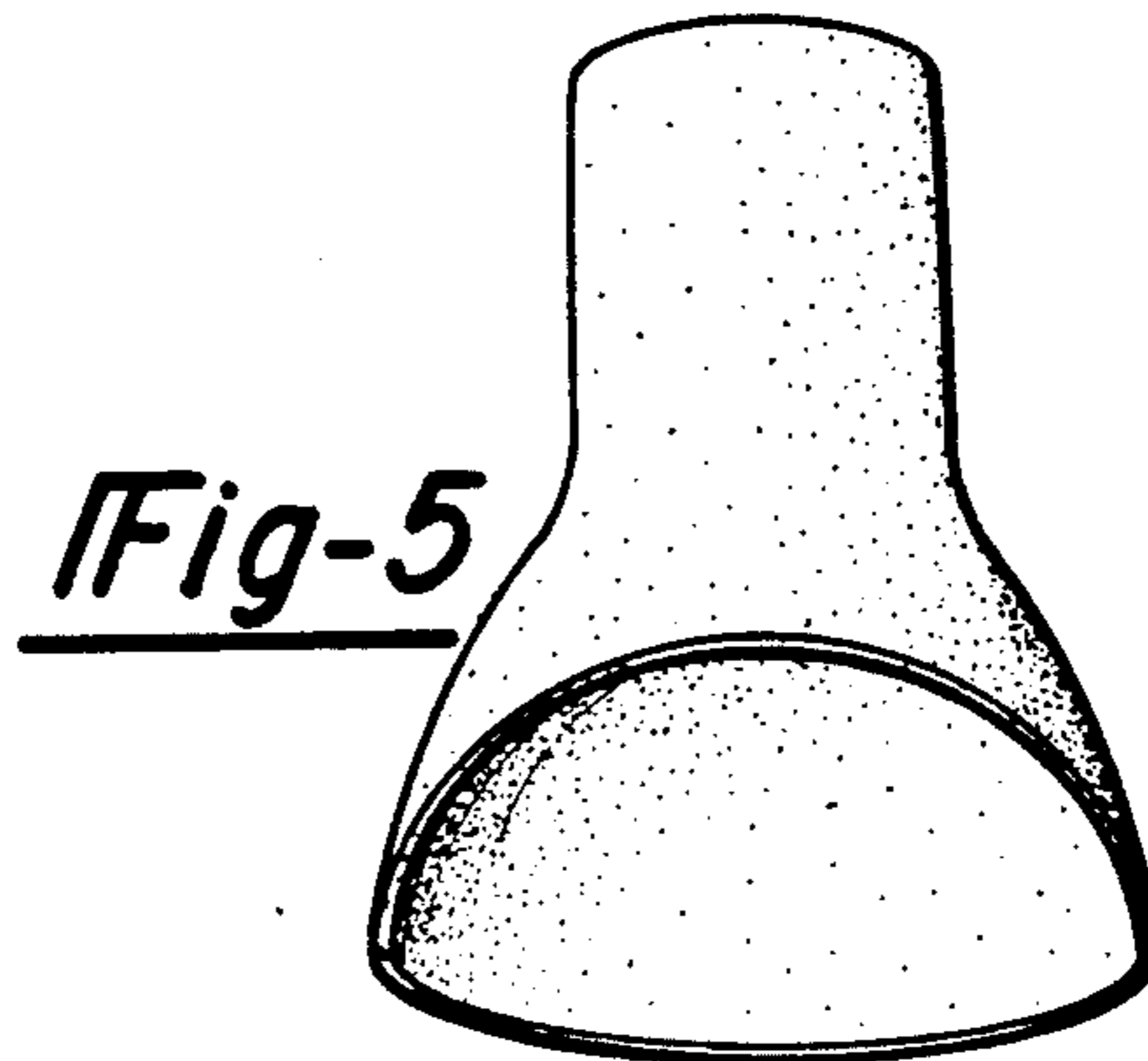
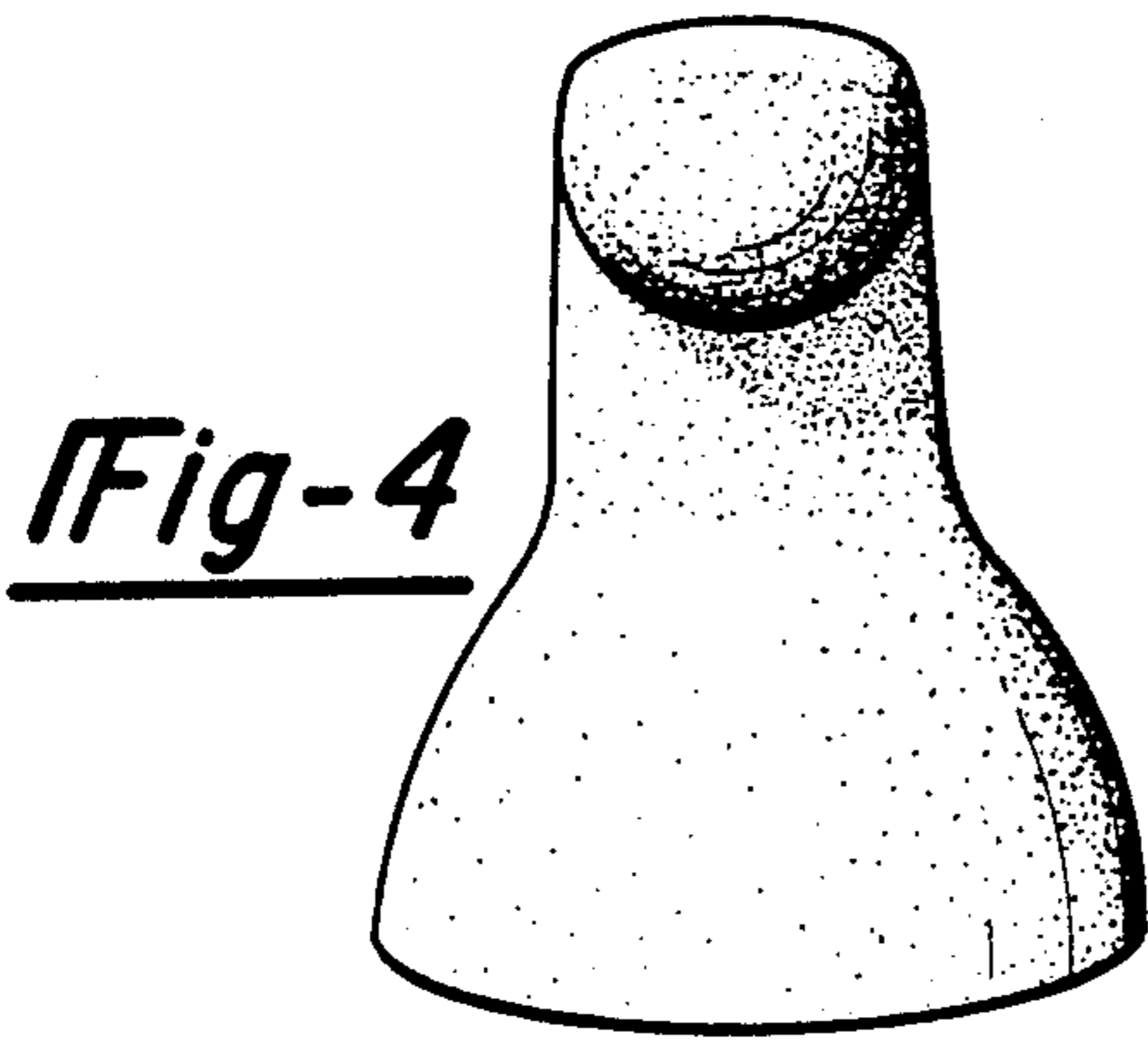
The ornamental design of a handle for a faucet or the like, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a handle for a faucet or the like showing our new design;
FIG. 2 is a left side elevational view thereof, the right side being a mirror image of the left side;
FIG. 3 is a top plan view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a perspective view of a second embodiment thereof;
FIG. 7 is a left side elevational view of FIG. 6, the right side being a mirror image of the left side;
FIG. 8 is a top plan view of FIG. 6;
FIG. 9 is a front elevational view of FIG. 6; and
FIG. 10 is a rear elevational view of FIG. 6.







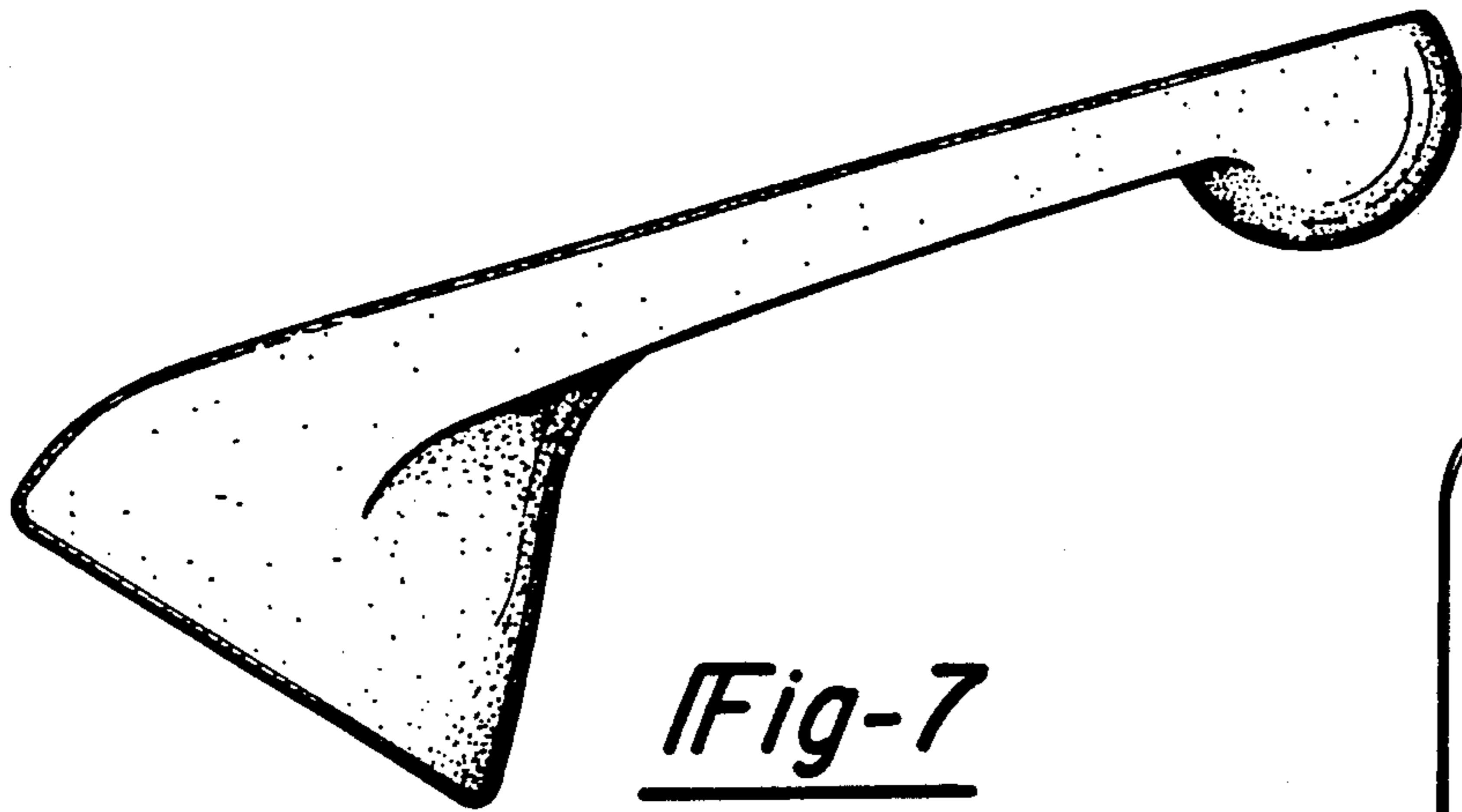

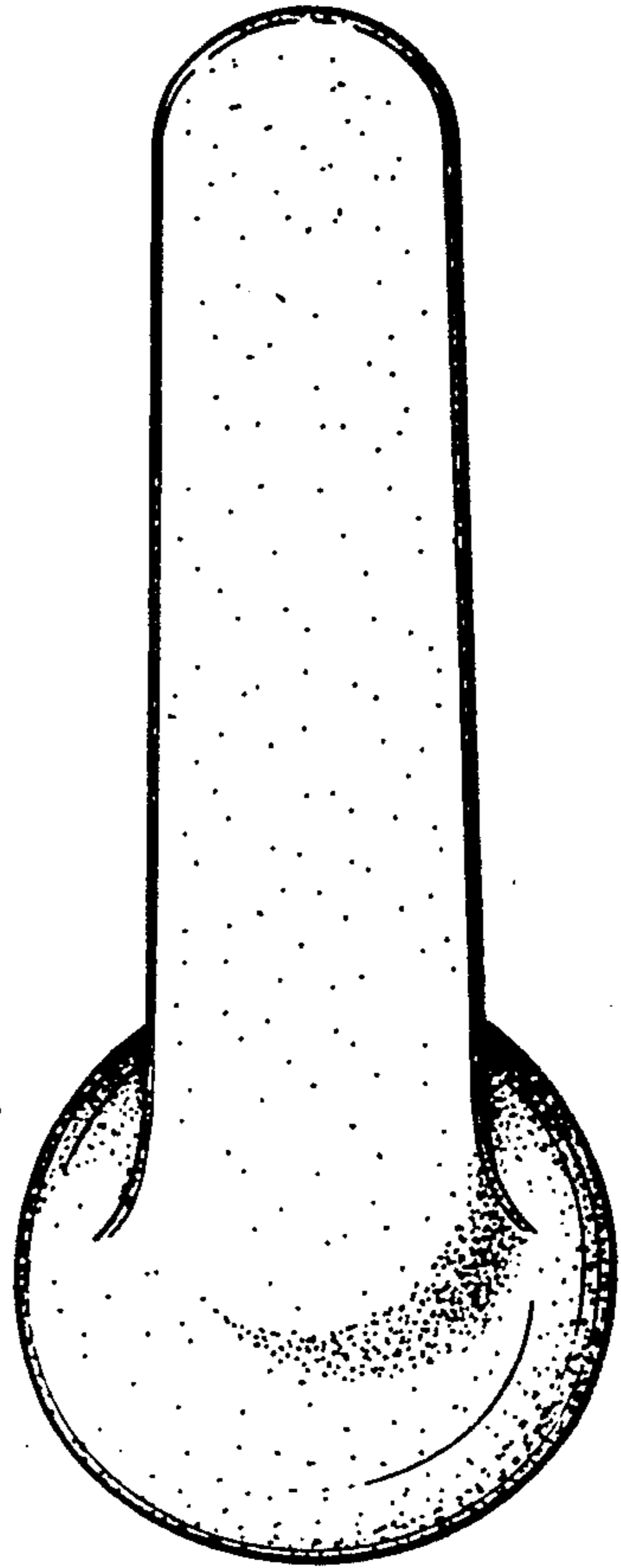

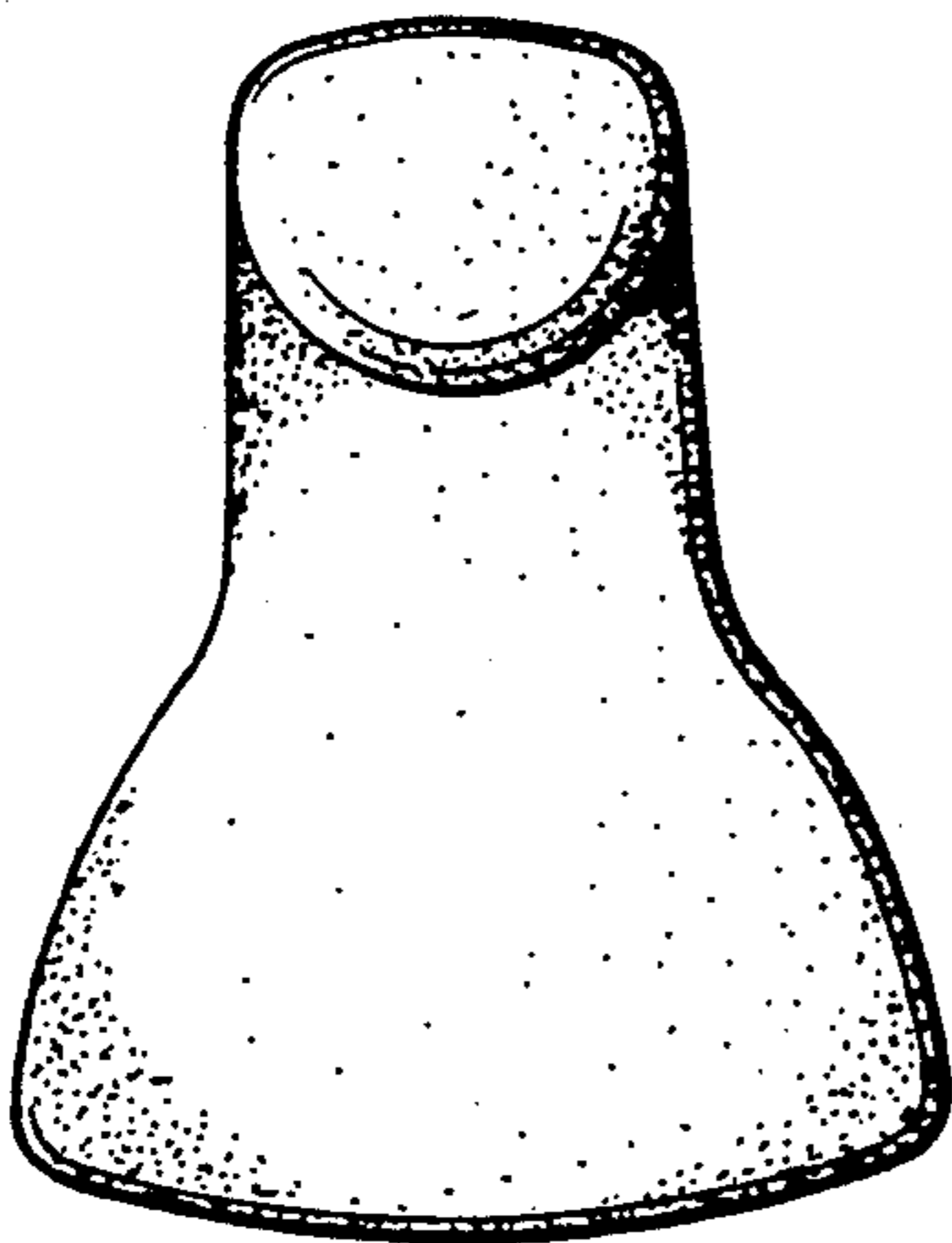

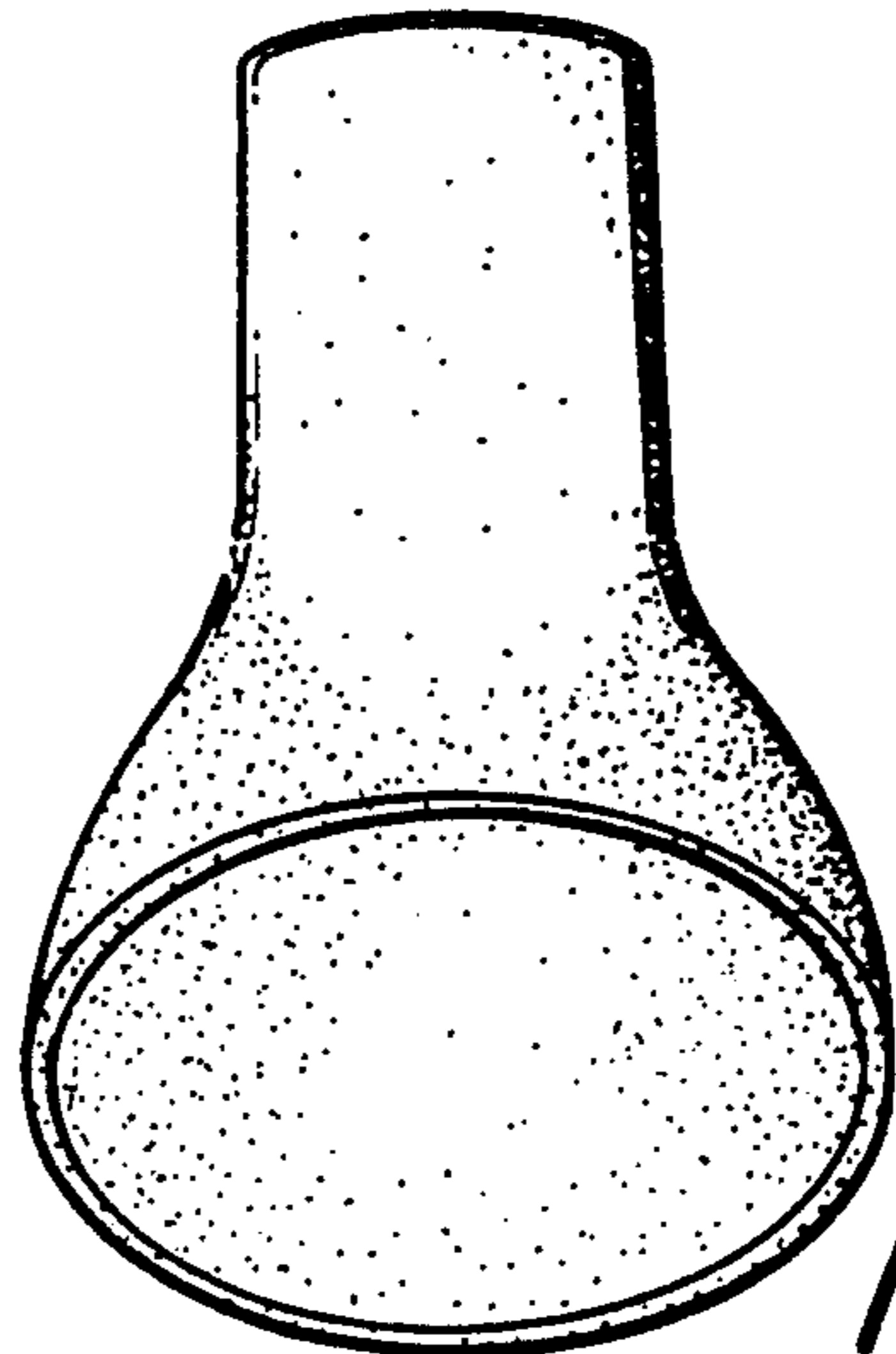
