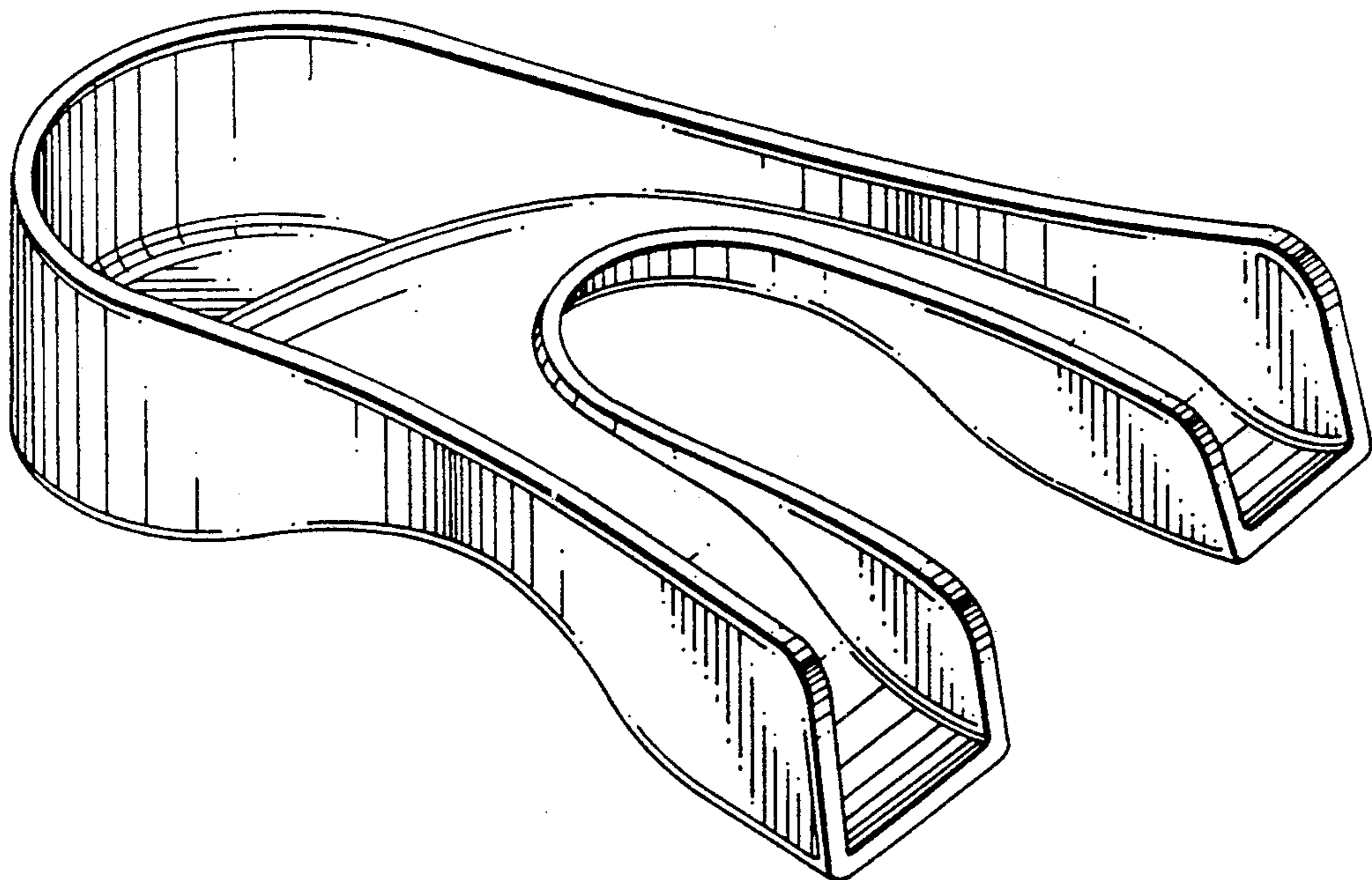

[57] **CLAIM**

The ornamental design for a dental impression tray for small animals, as shown and described.

**DESCRIPTION**

FIG. 1 is a top side, perspective view of a dental impression tray for small animals showing my new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is an opposite side elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a top, side perspective view of a second embodiment thereof; FIG. 8 is a rear elevational view thereof; FIG. 9 is a front elevational view thereof; FIG. 10 is an opposite side elevational view thereof; FIG. 11 is a top plan view thereof; FIG. 12 is a bottom plan view thereof; FIG. 13 is a top, side perspective view of a third embodiment thereof; FIG. 14 is a rear elevational view thereof; FIG. 15 is a front elevational view thereof; FIG. 16 is an opposite side elevational view thereof; FIG. 17 is a top plan view thereof; and FIG. 18 is a bottom plan view thereof.



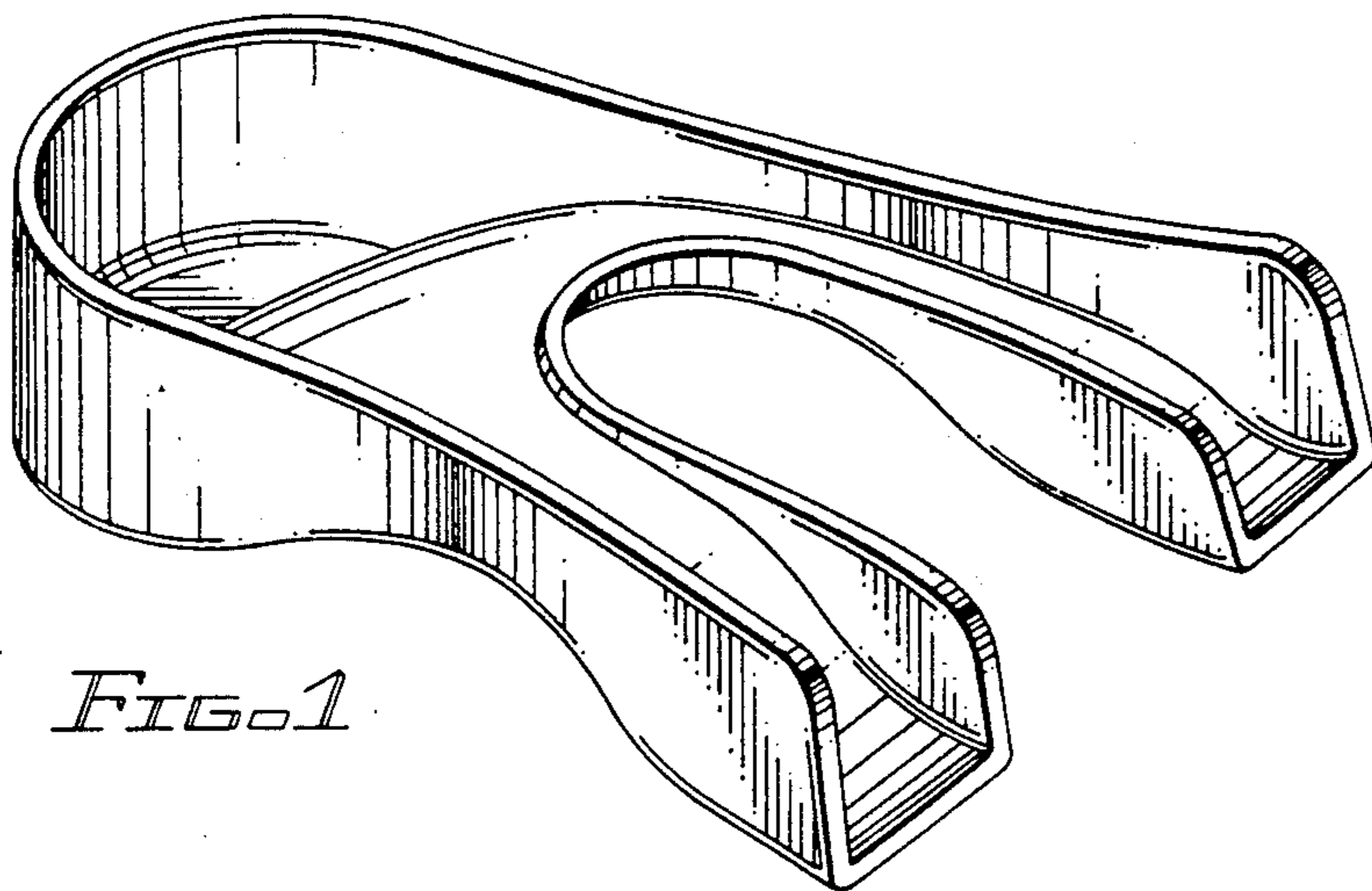

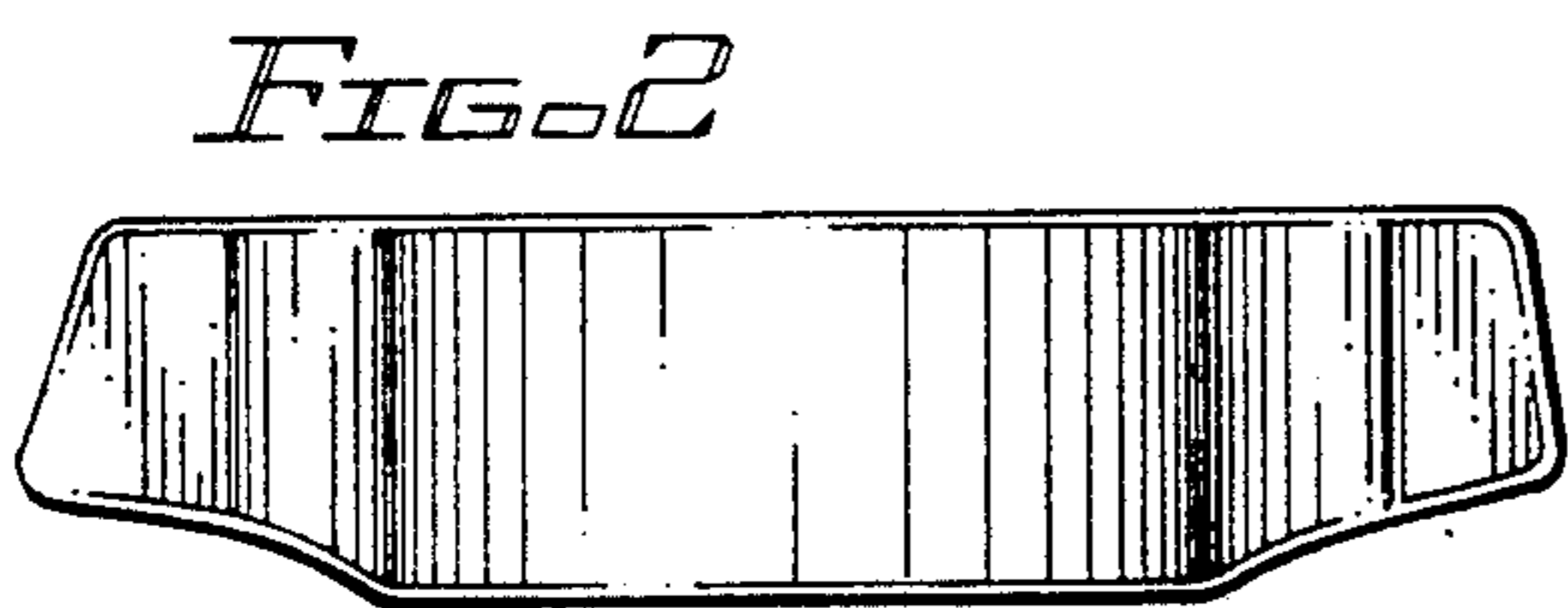

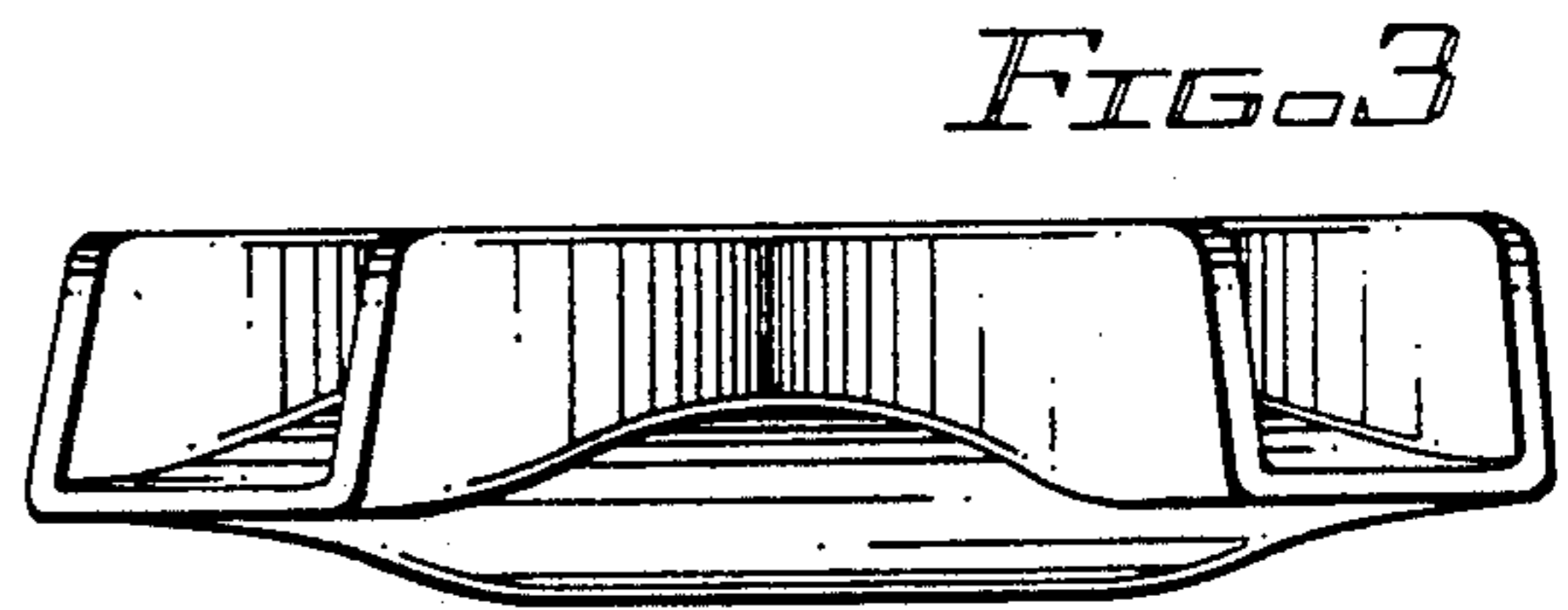

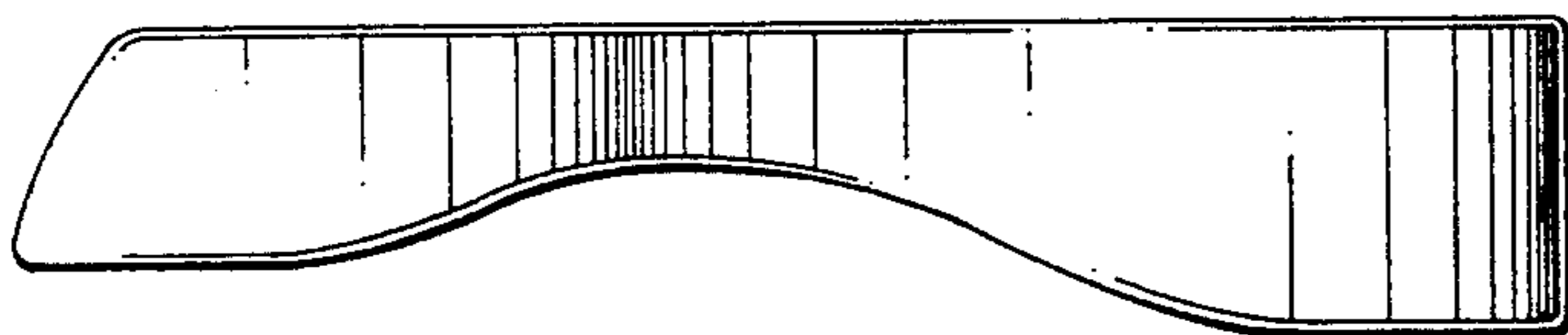

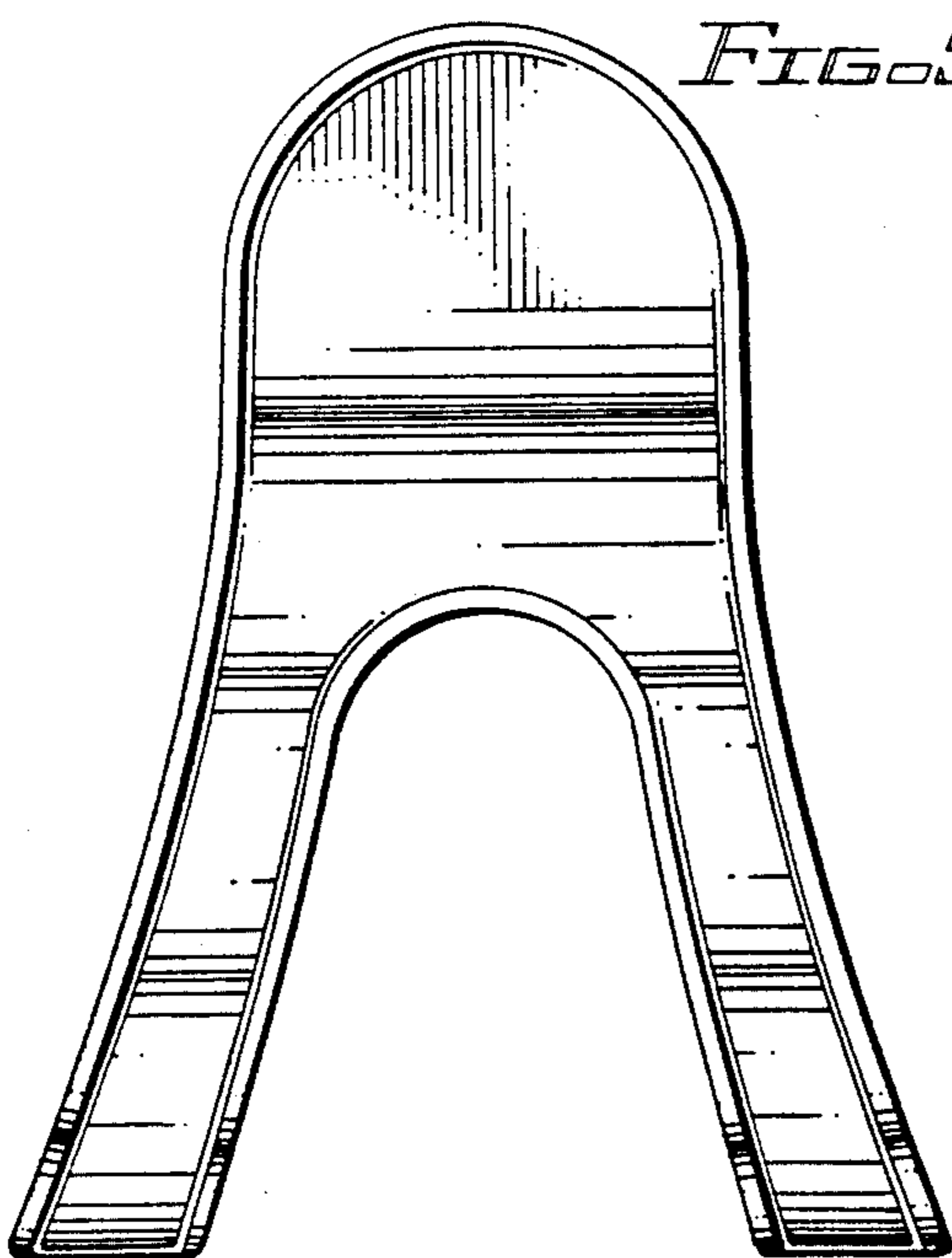

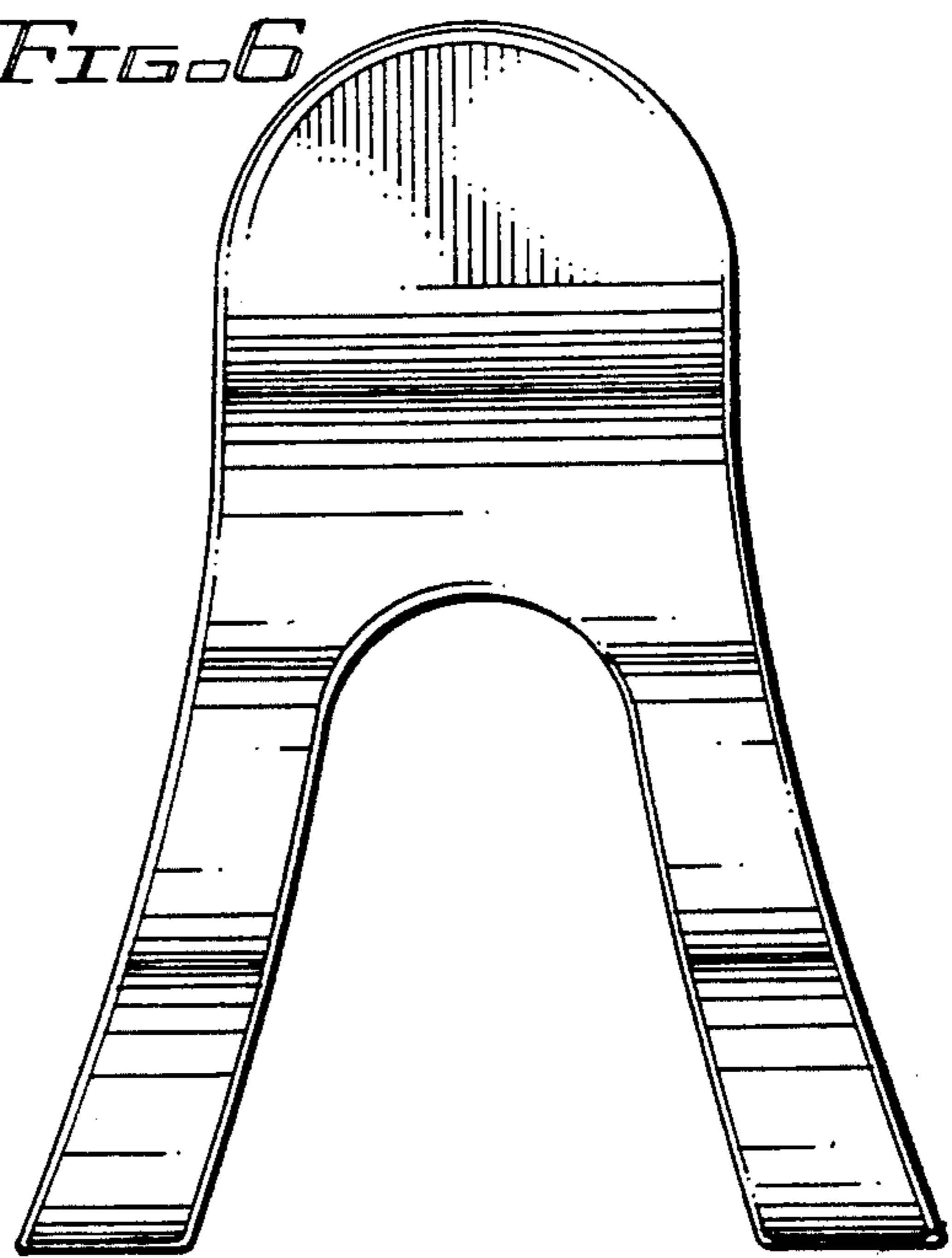

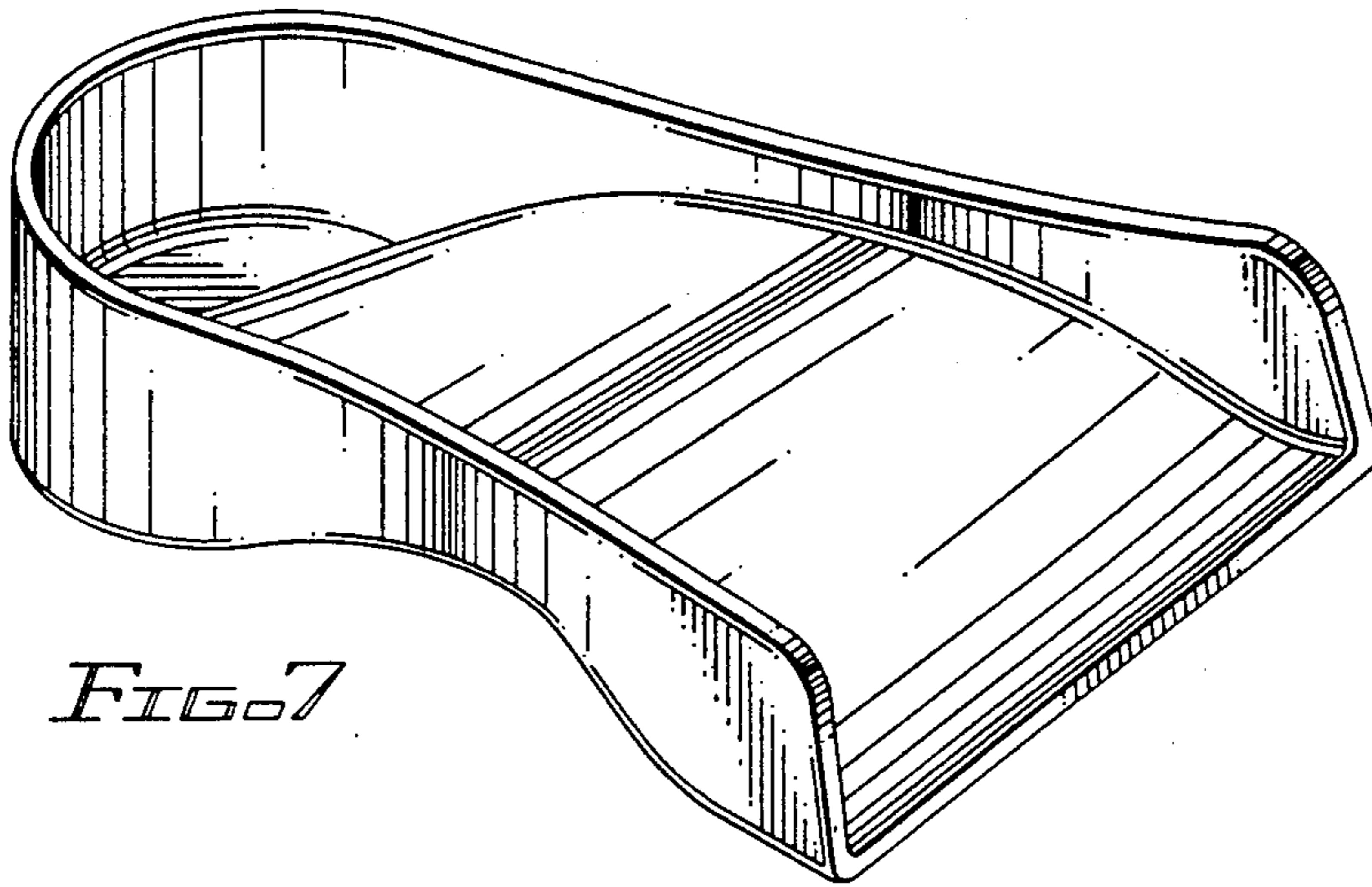

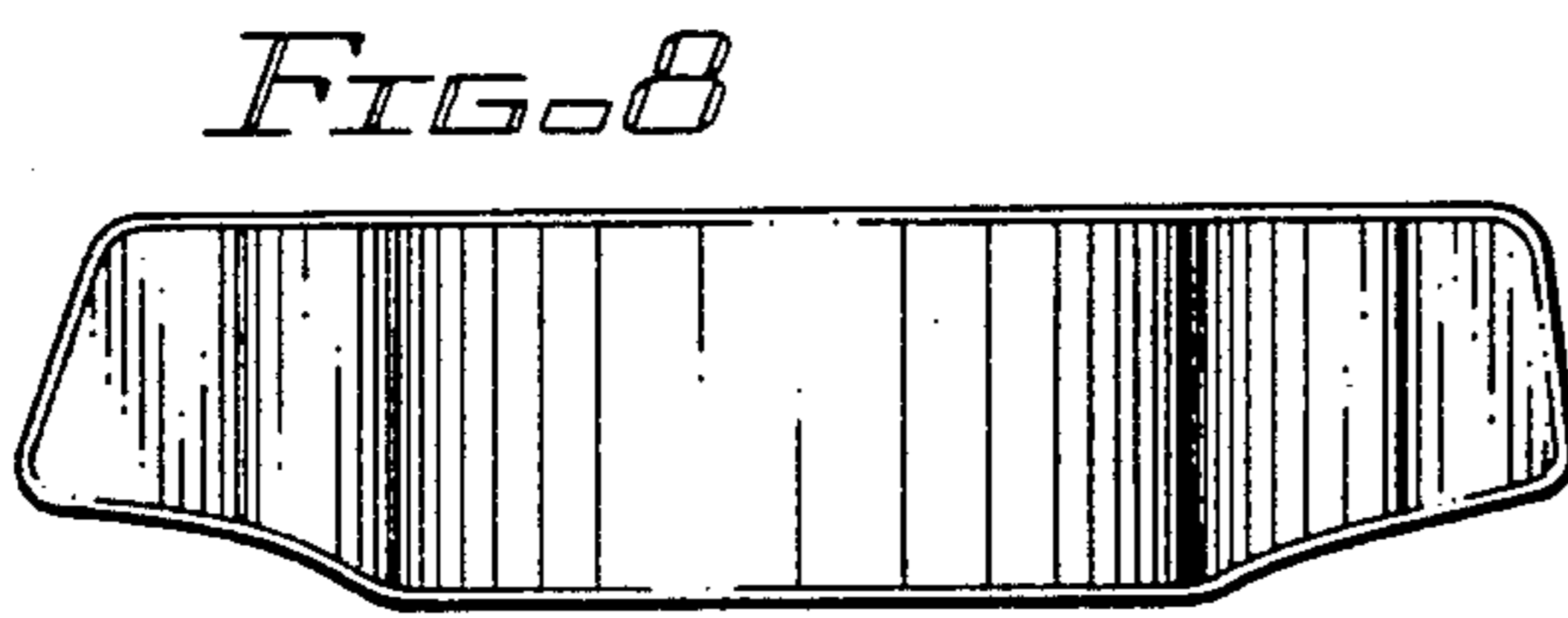

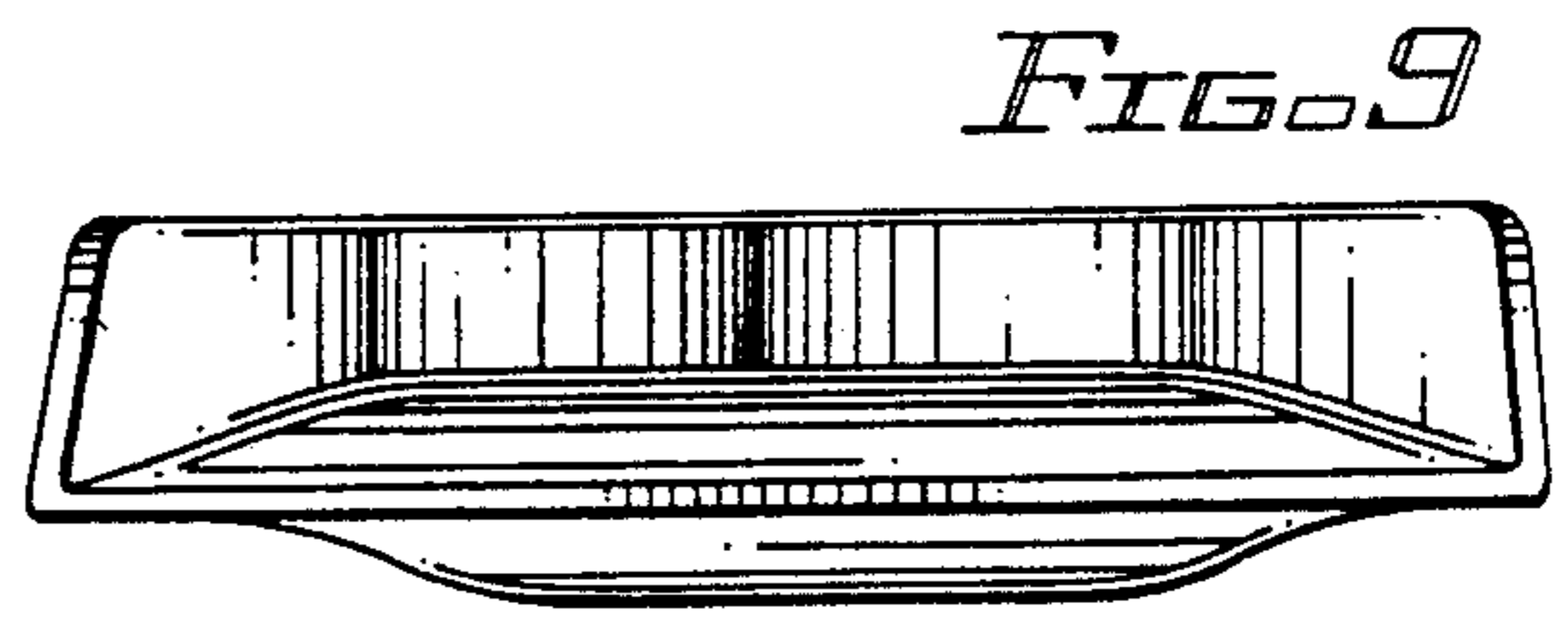

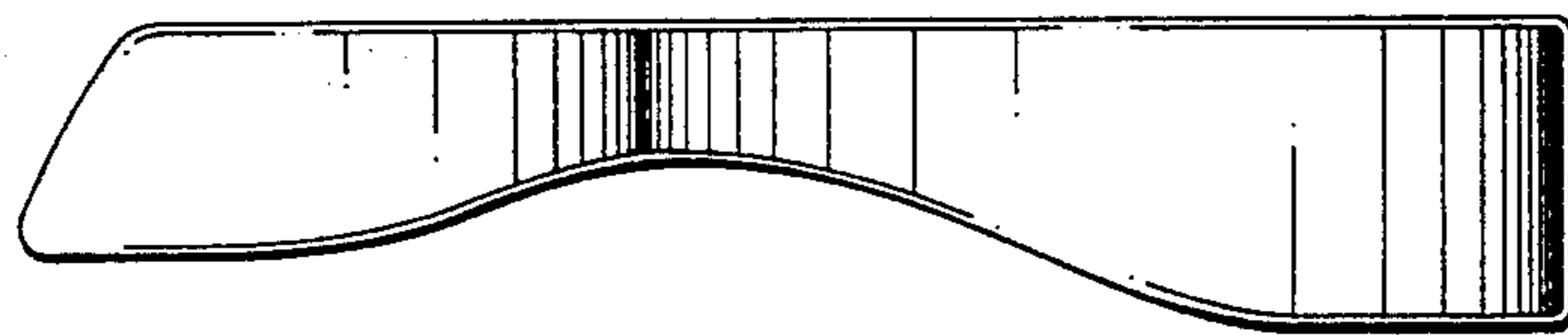

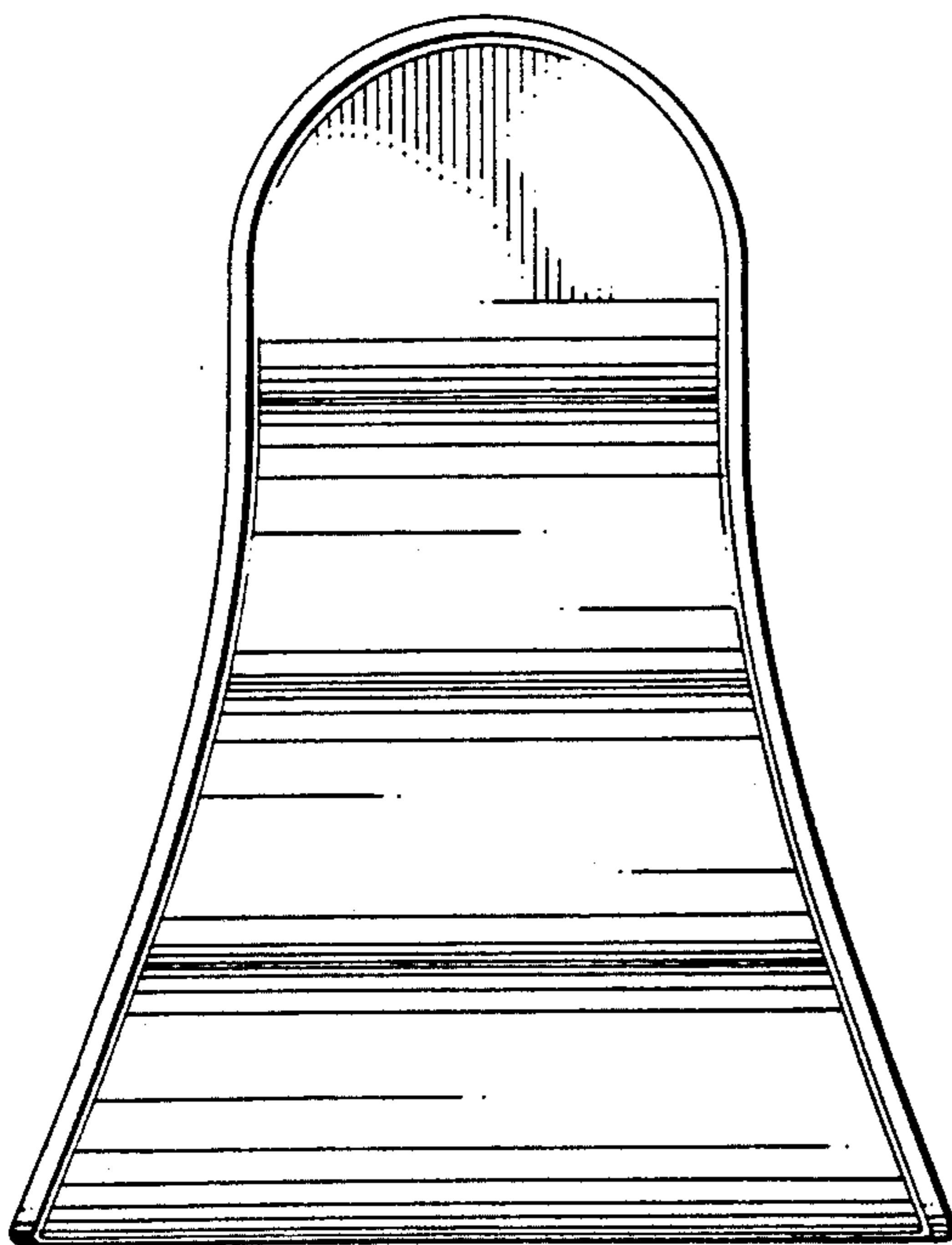

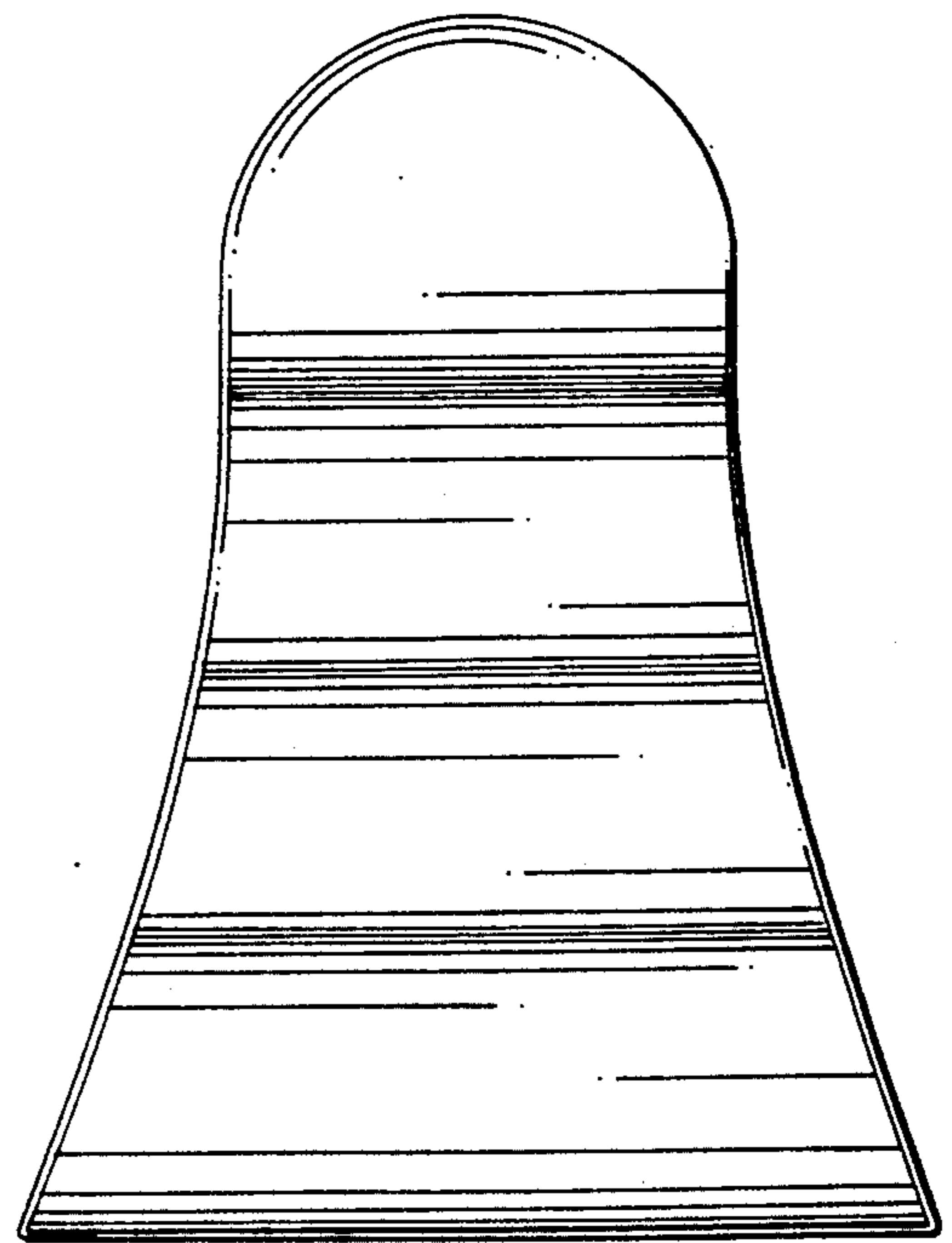

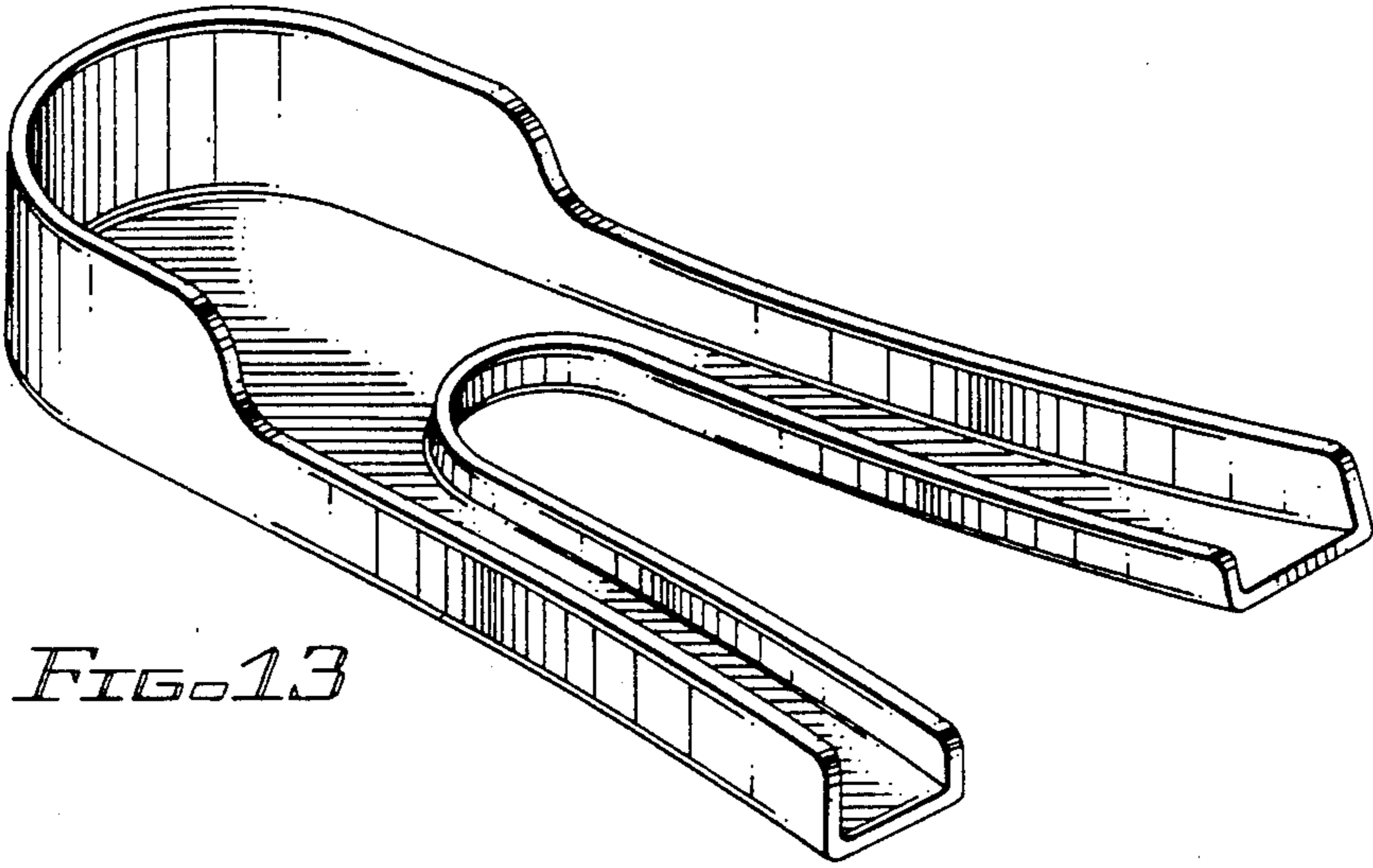

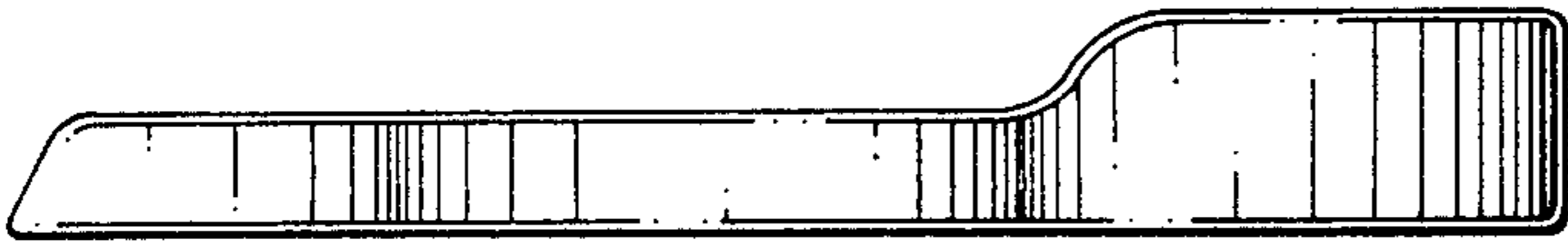

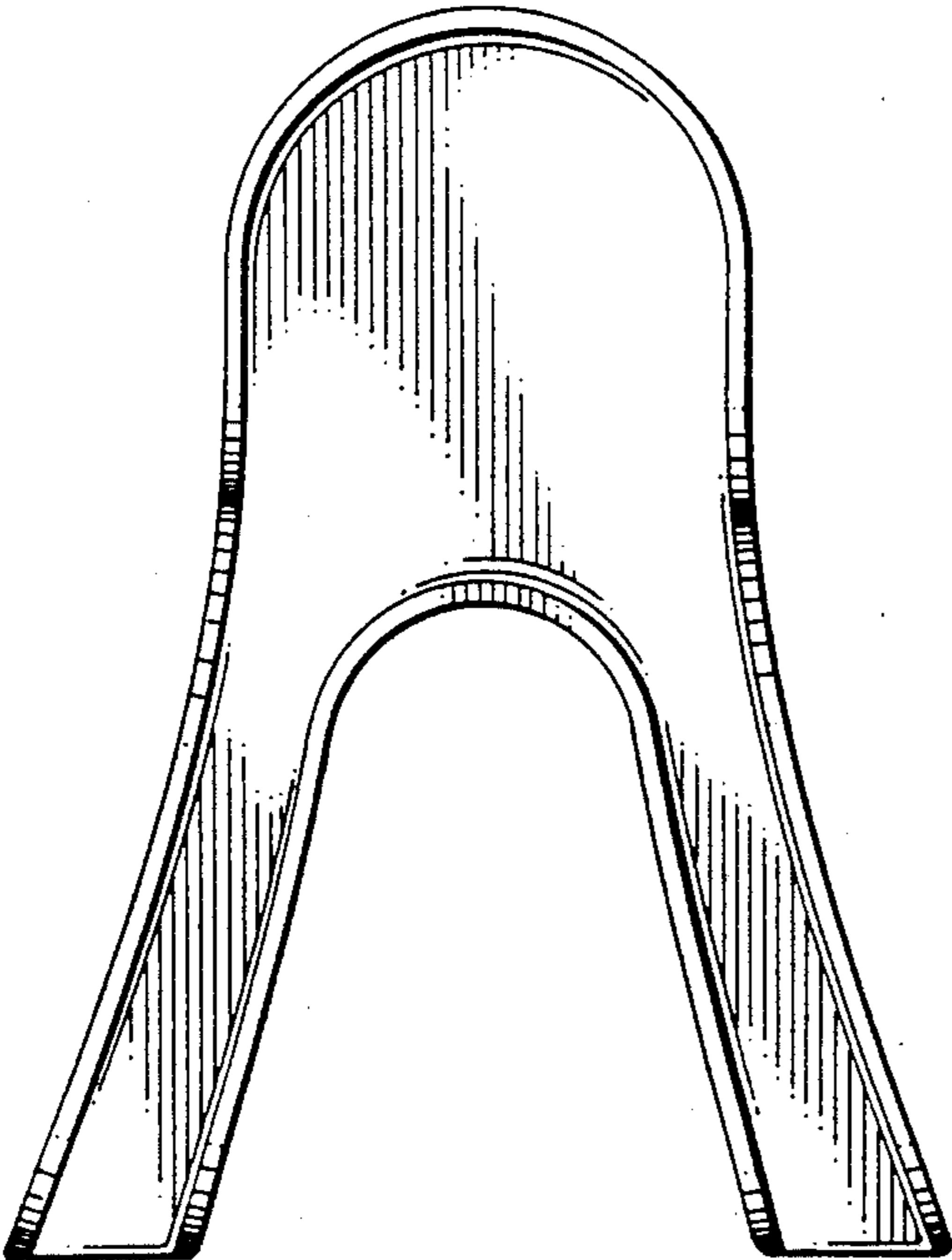

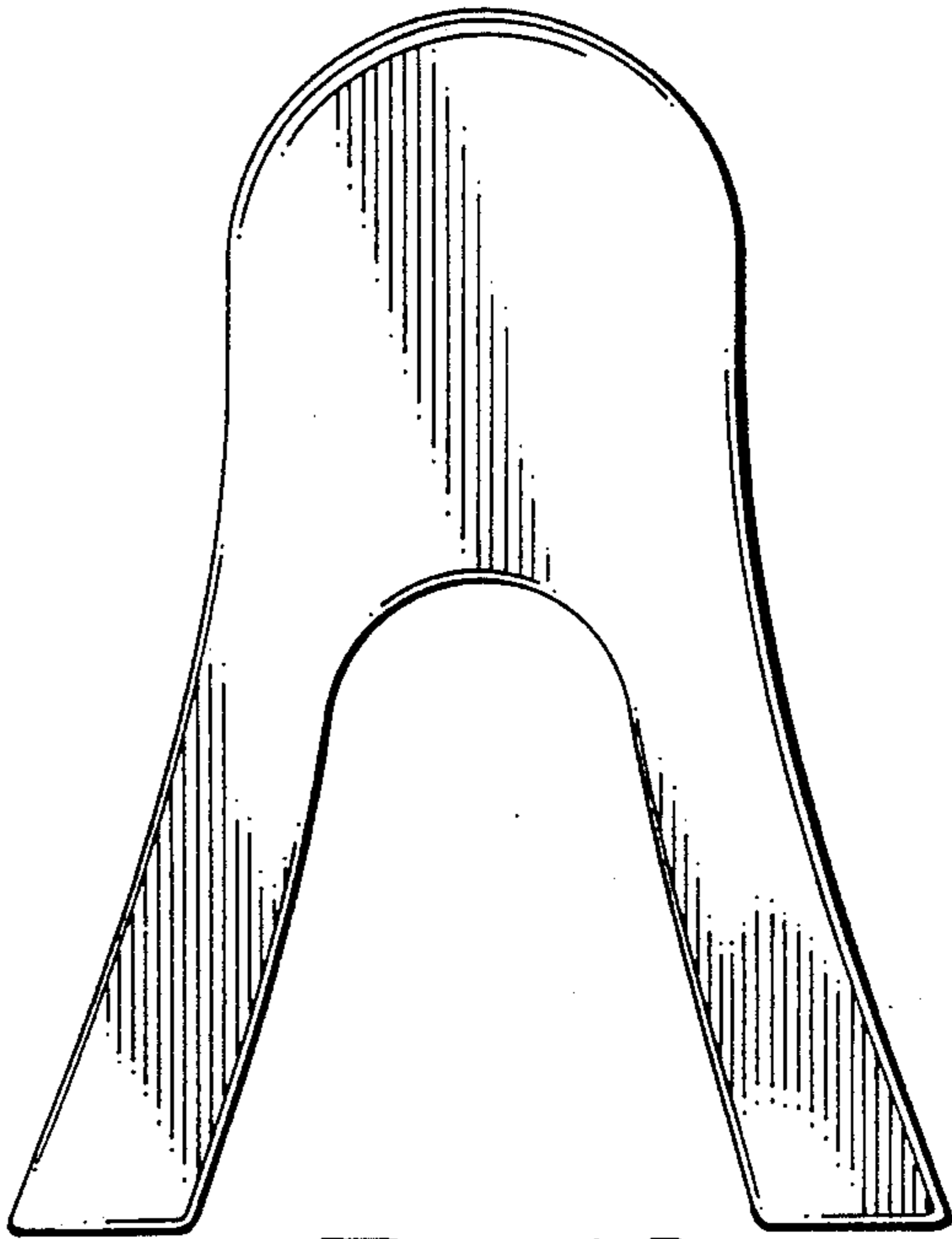
