[57] **CLAIM**

The ornamental design for a combined wall mounted security light and light activating infrared motion sensor, as shown and described.

DESCRIPTION

FIG. 8 is a top, front, left side perspective view thereof.

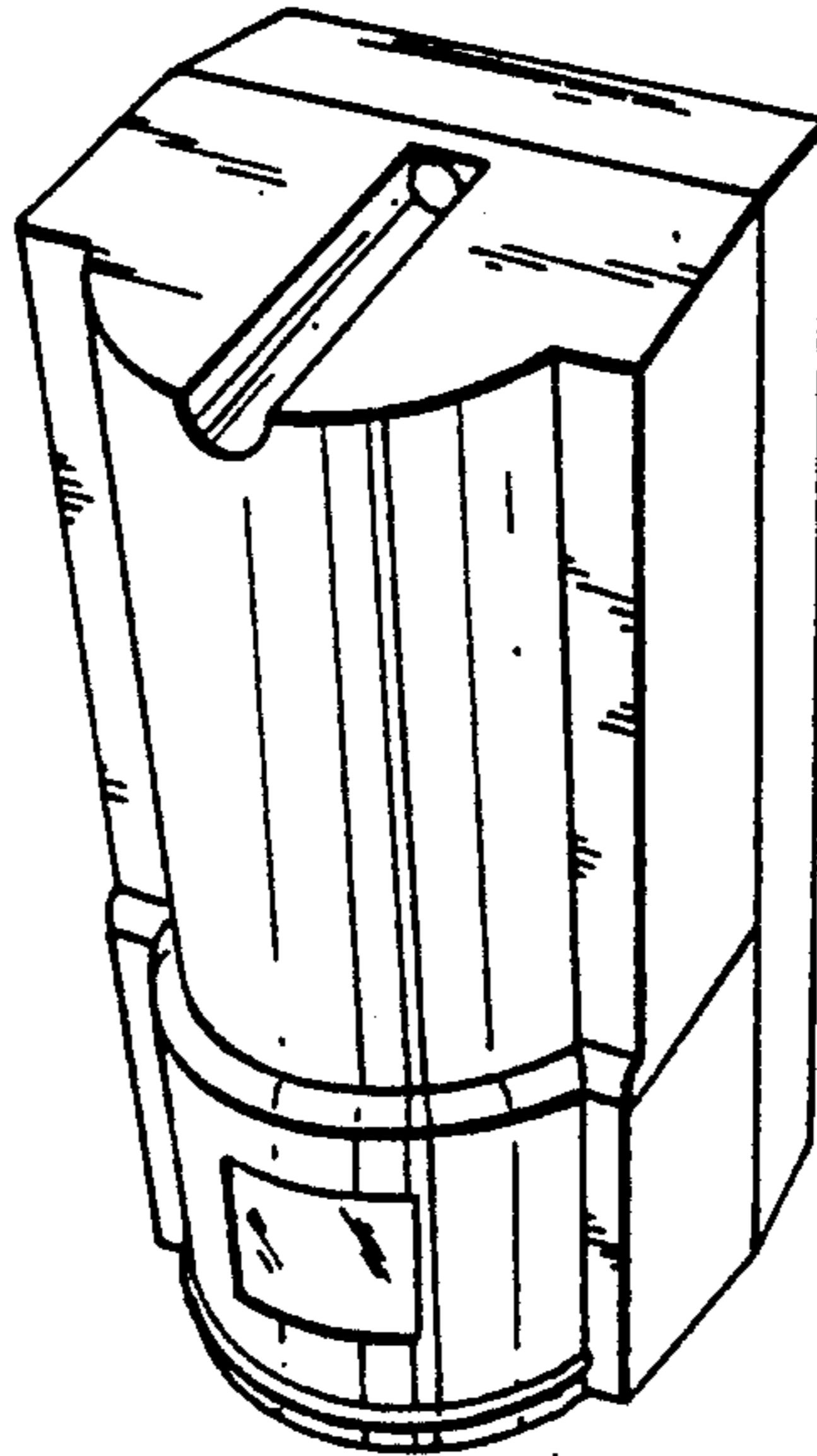

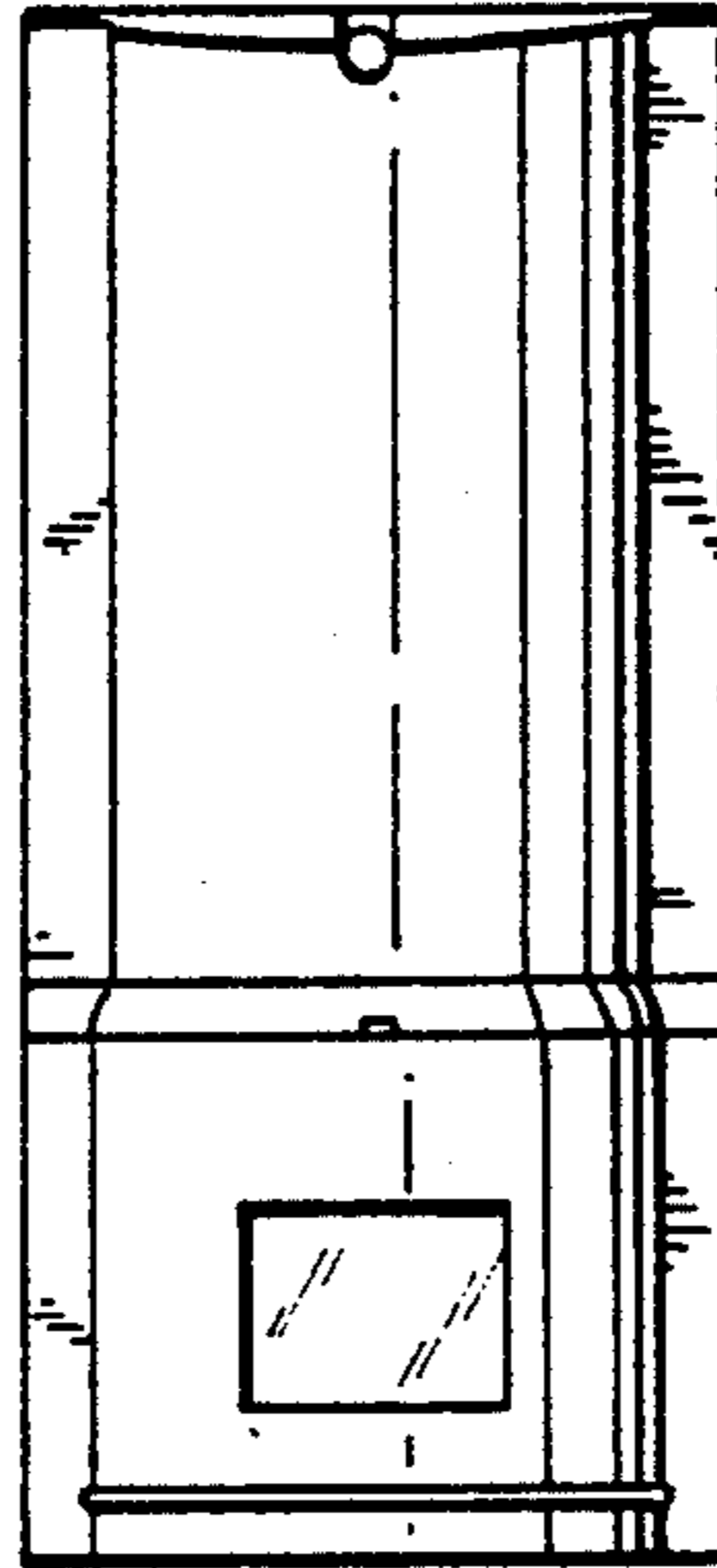

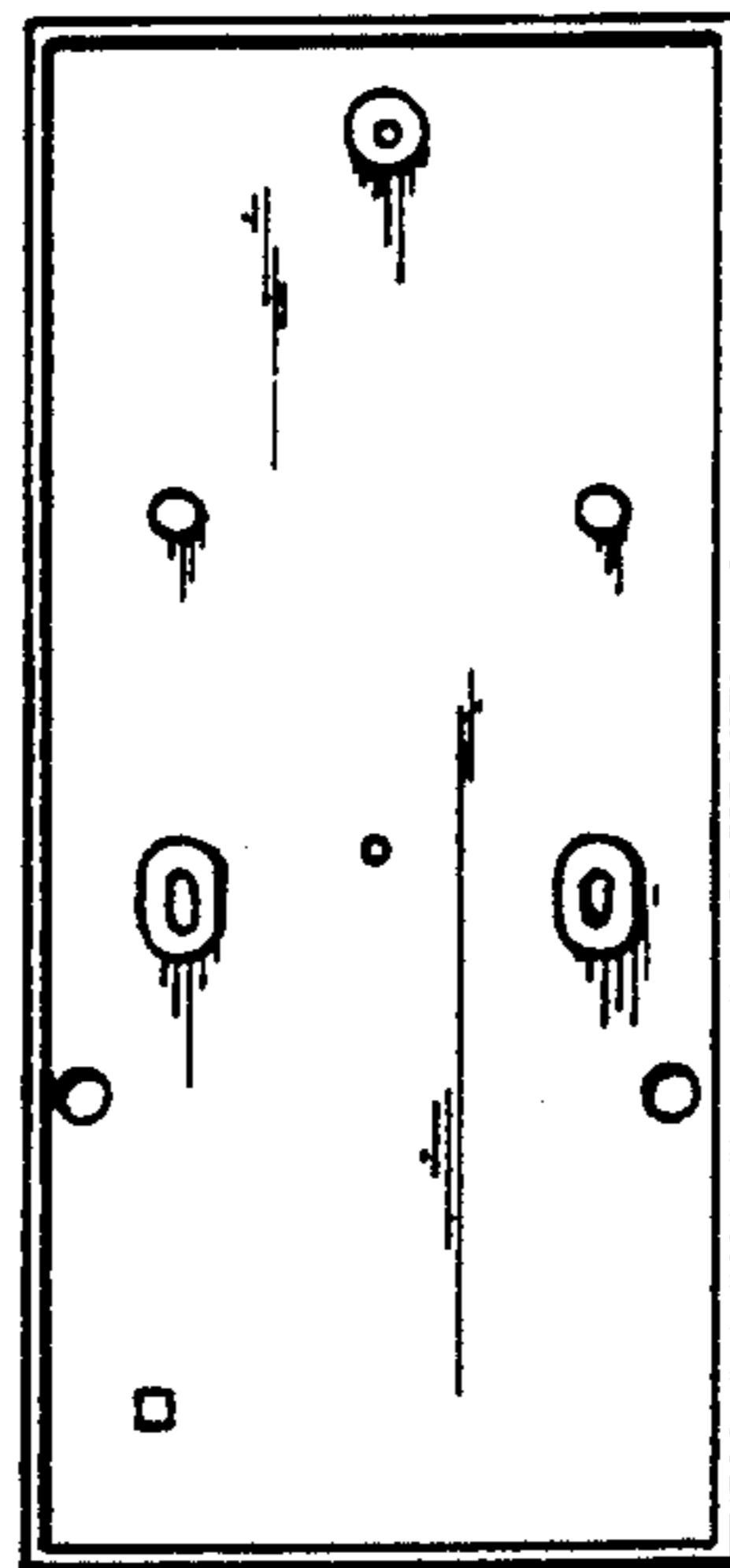

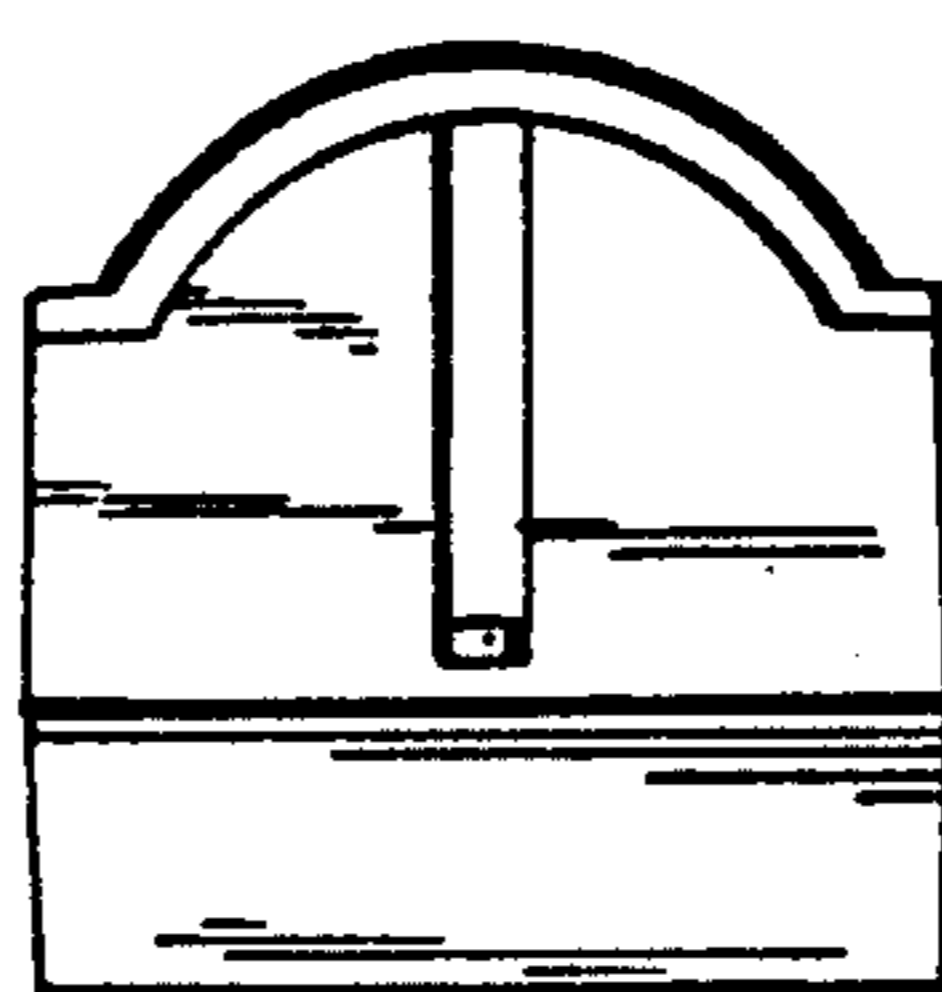

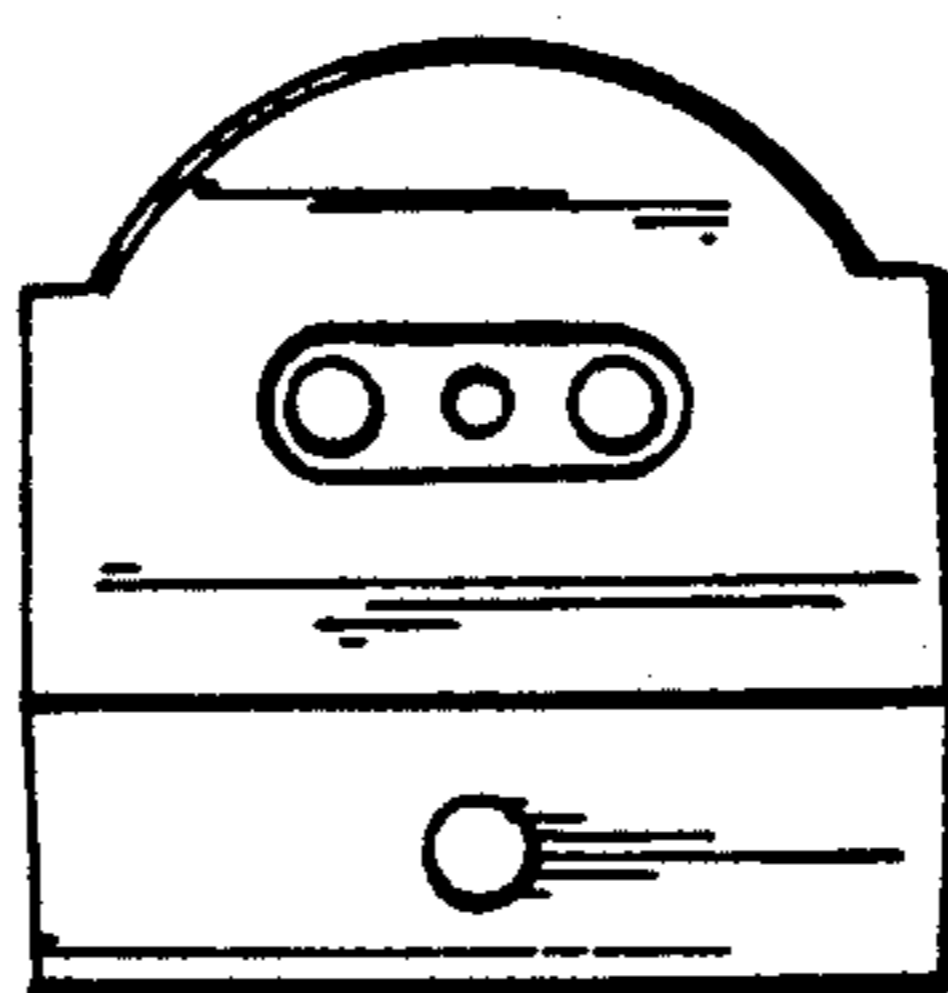

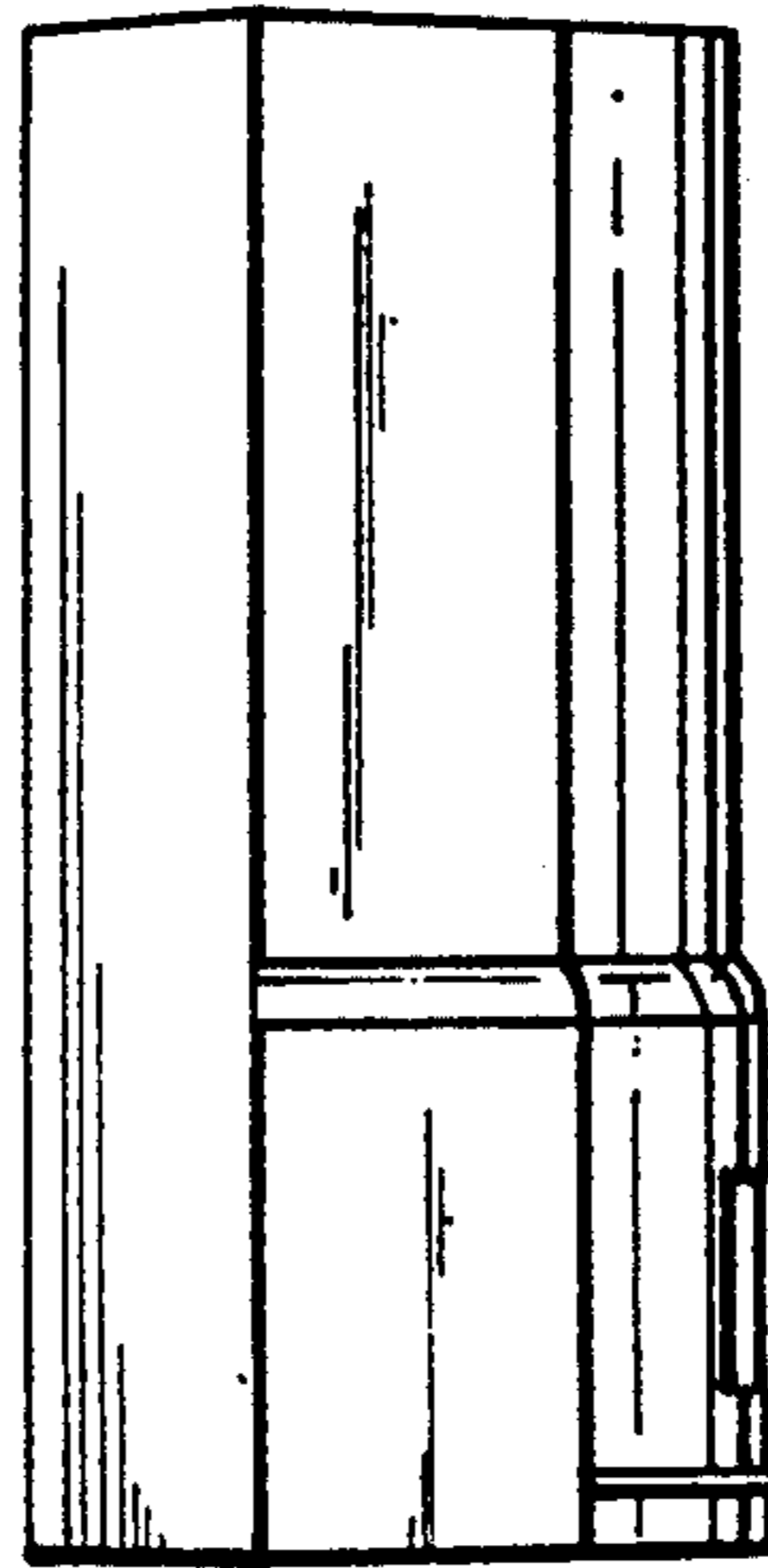

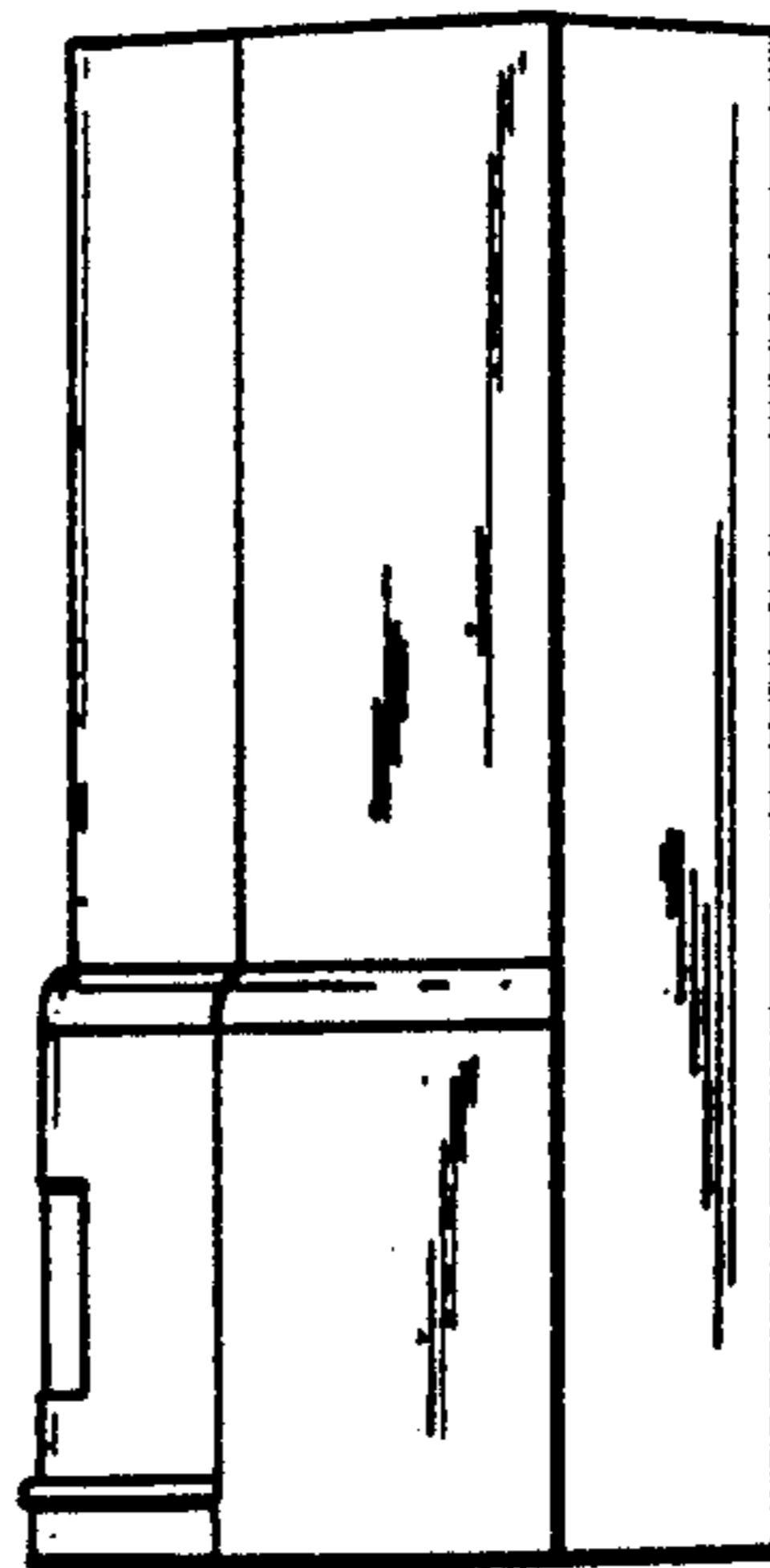

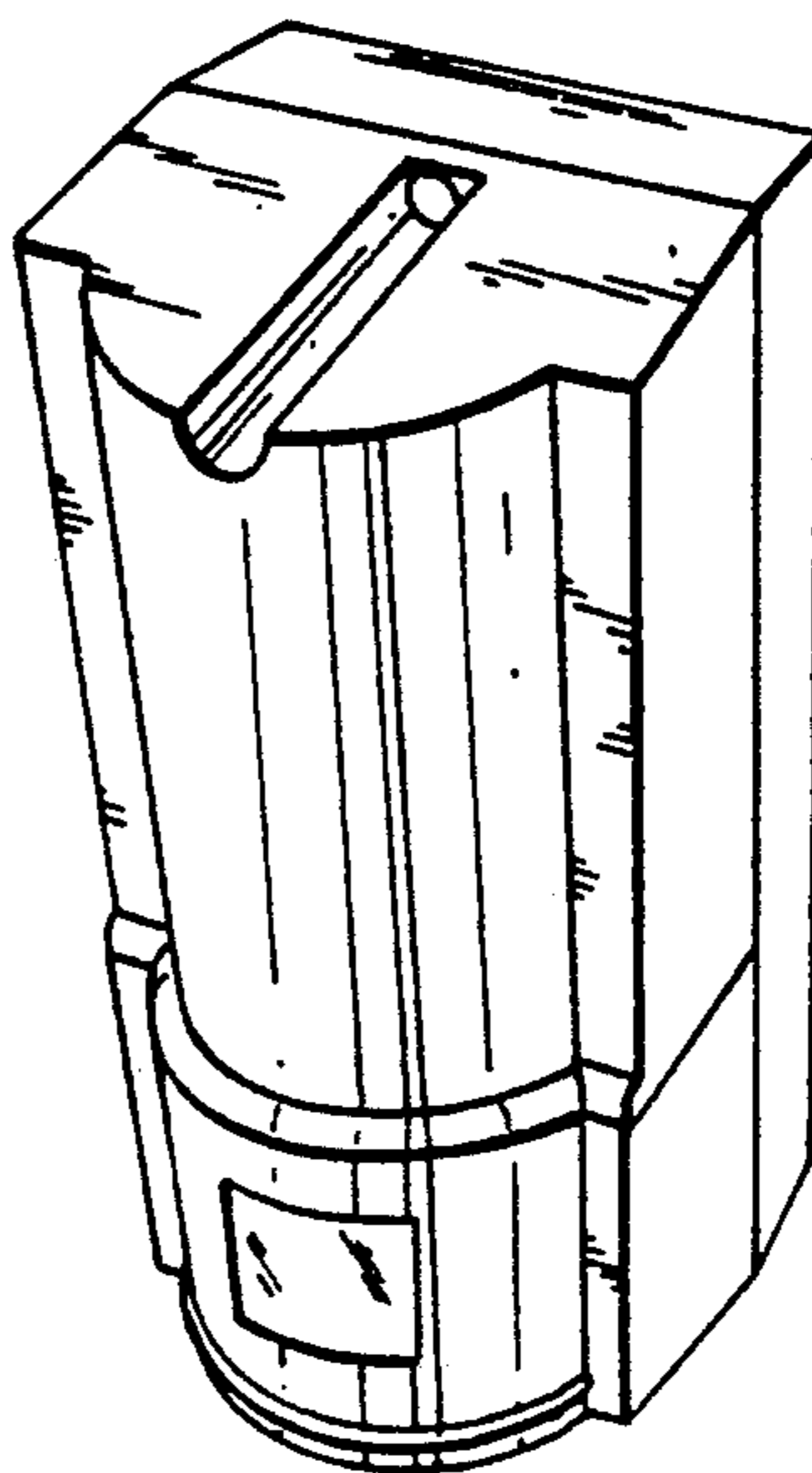
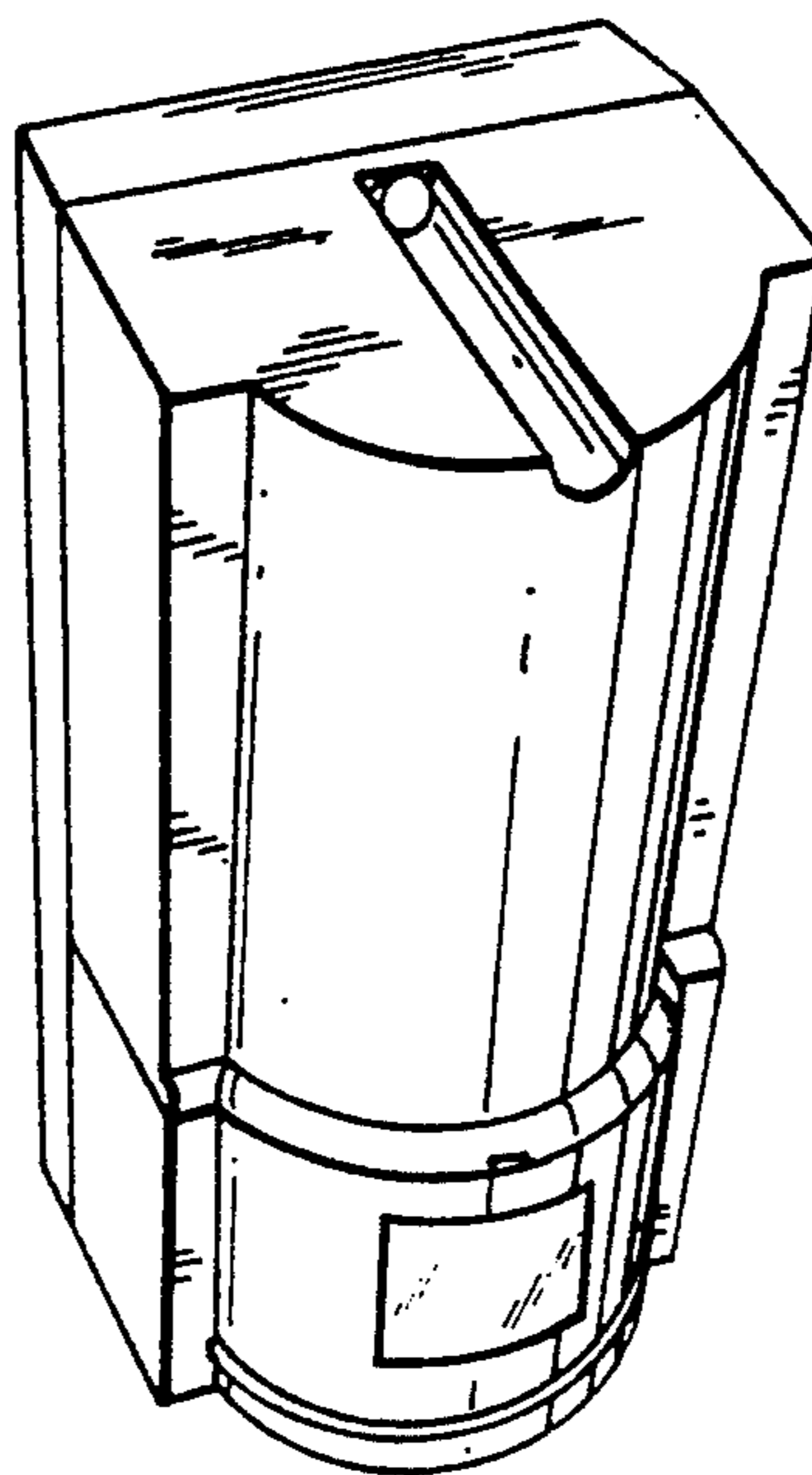
