[57] CLAIM

The ornamental design for a strand material dispenser or the like, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a strand material dispenser or the like, showing my new design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a top, plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a rear elevational view thereof; FIG. 7 is a front perspective view thereof; FIG. 8 is a rear perspective view thereof; FIG. 9 is a front perspective view thereof in an exploded condition; and FIG. 10 is a rear perspective view thereof in an exploded condition.

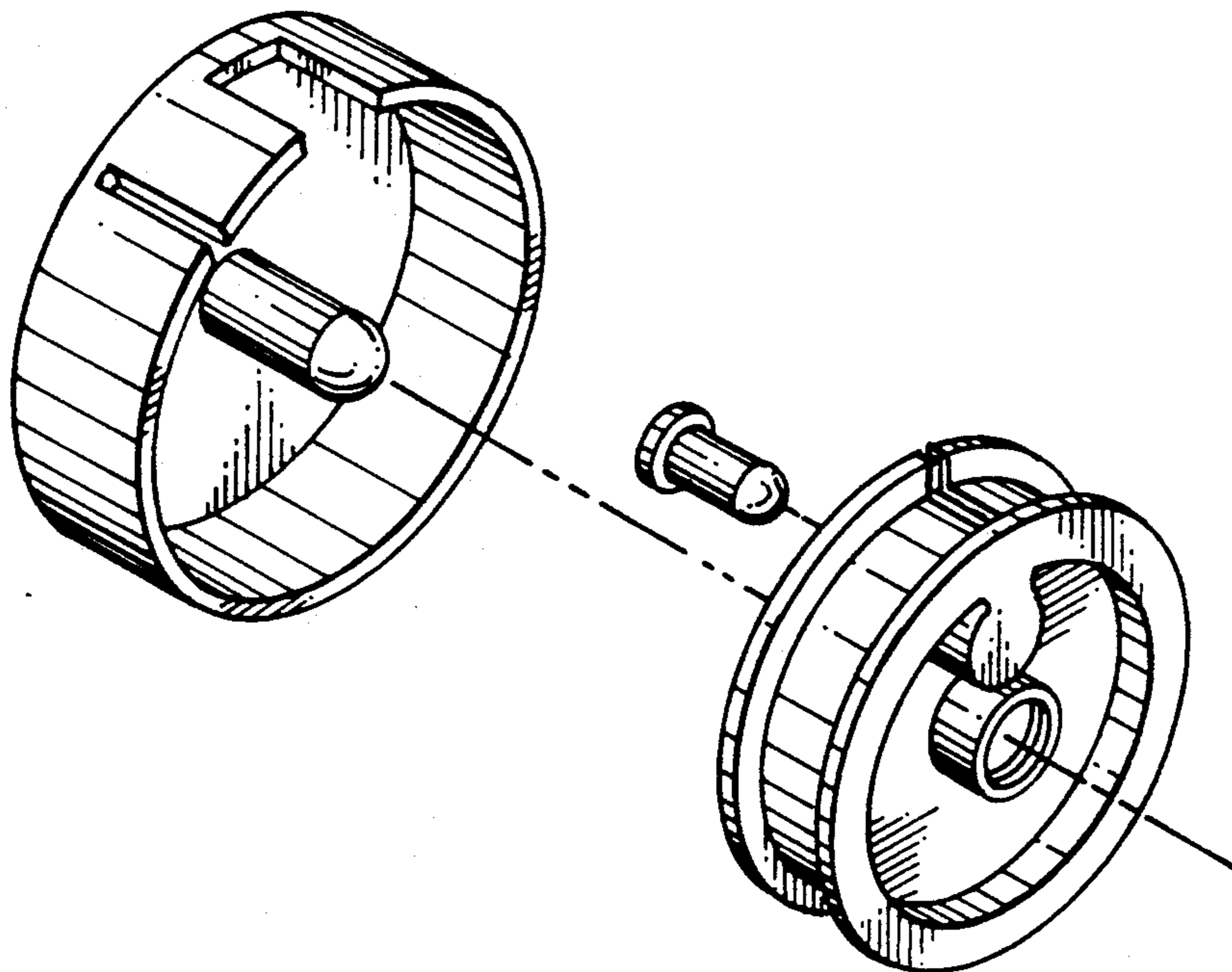

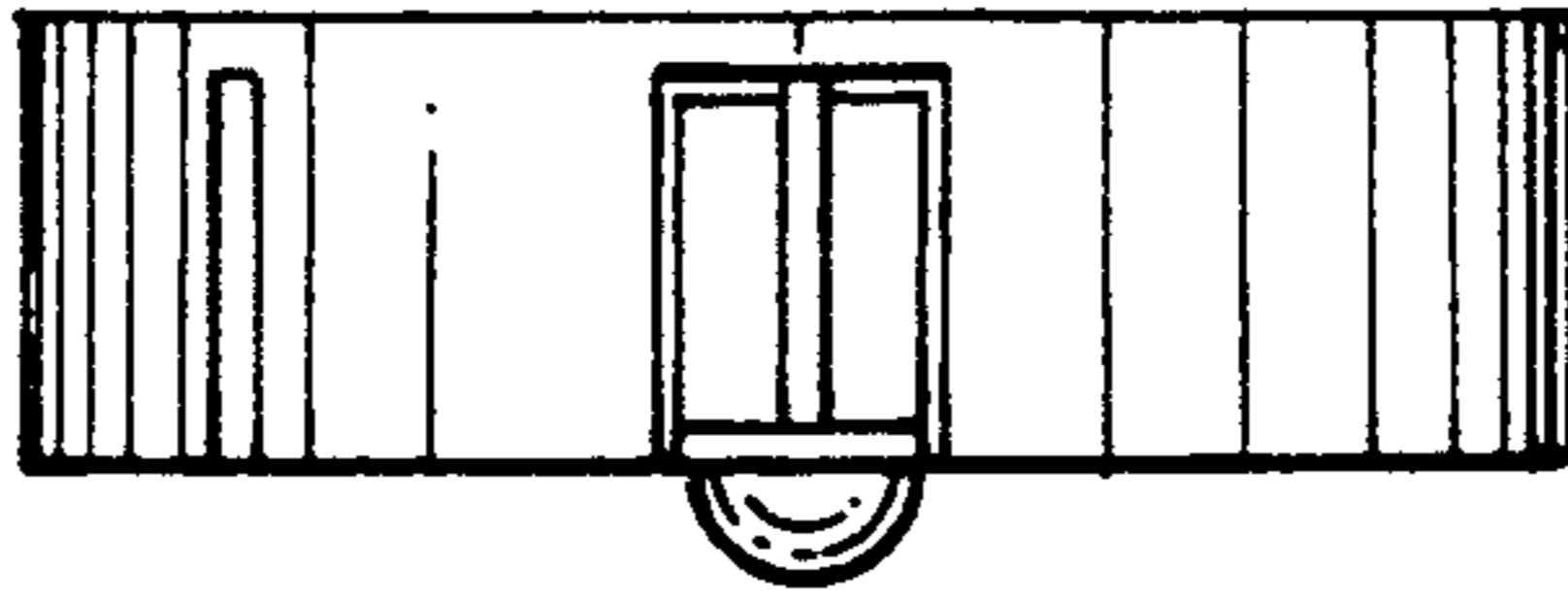

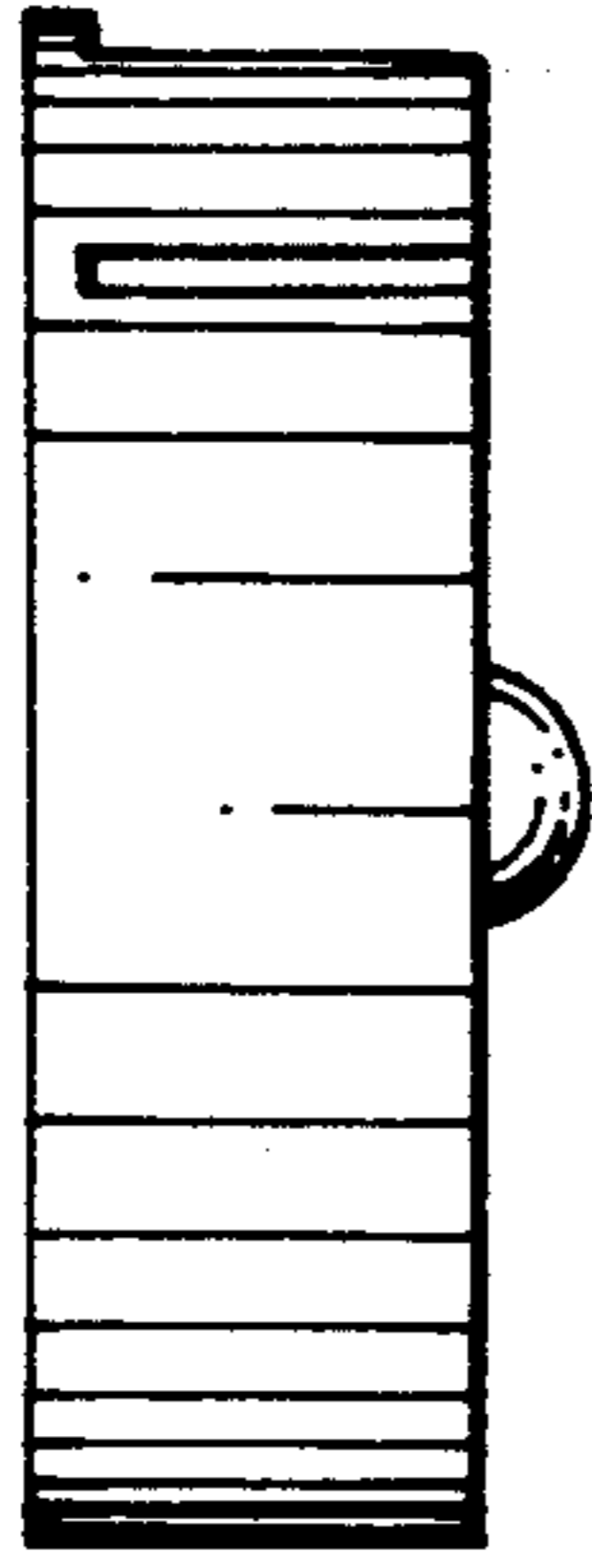

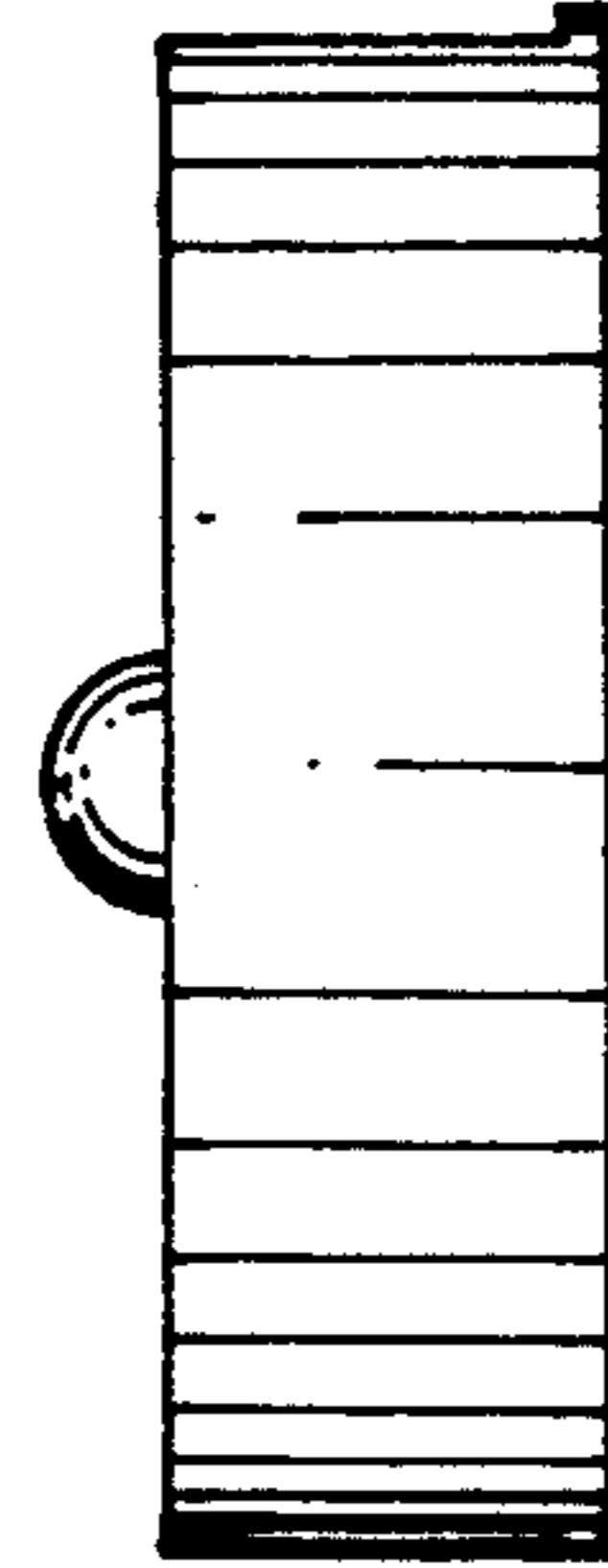

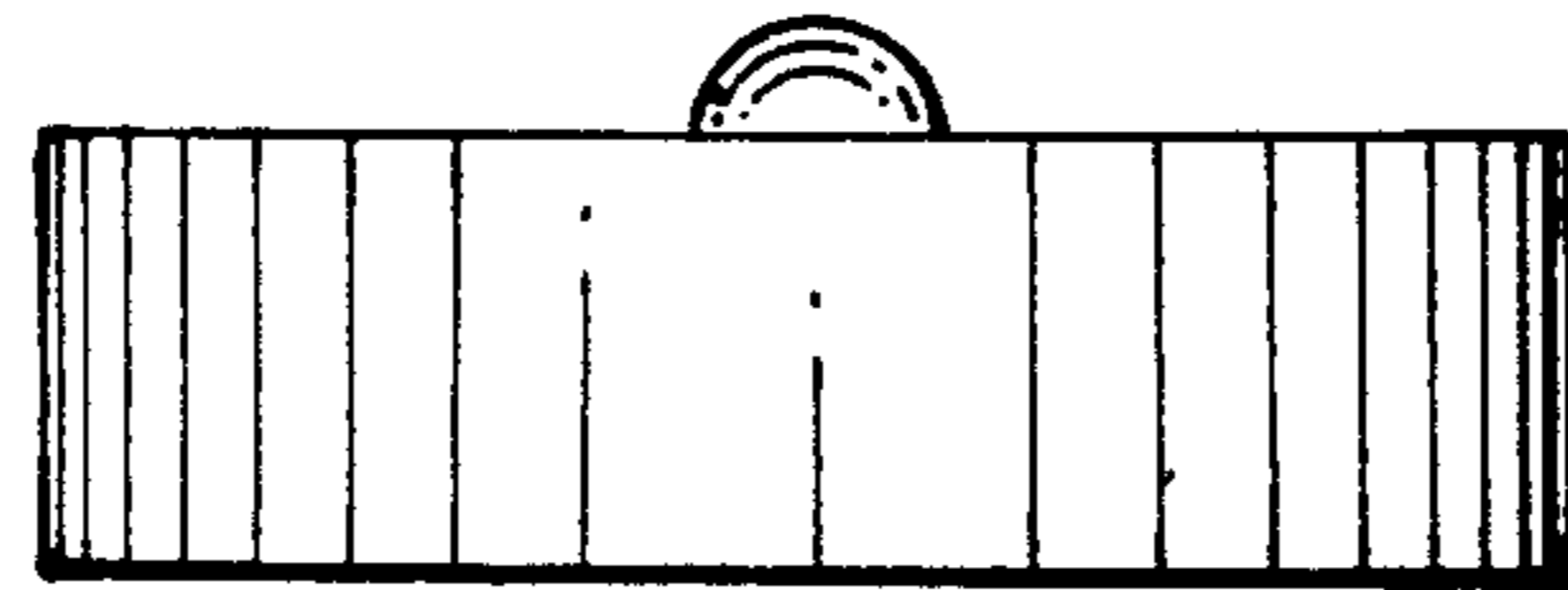

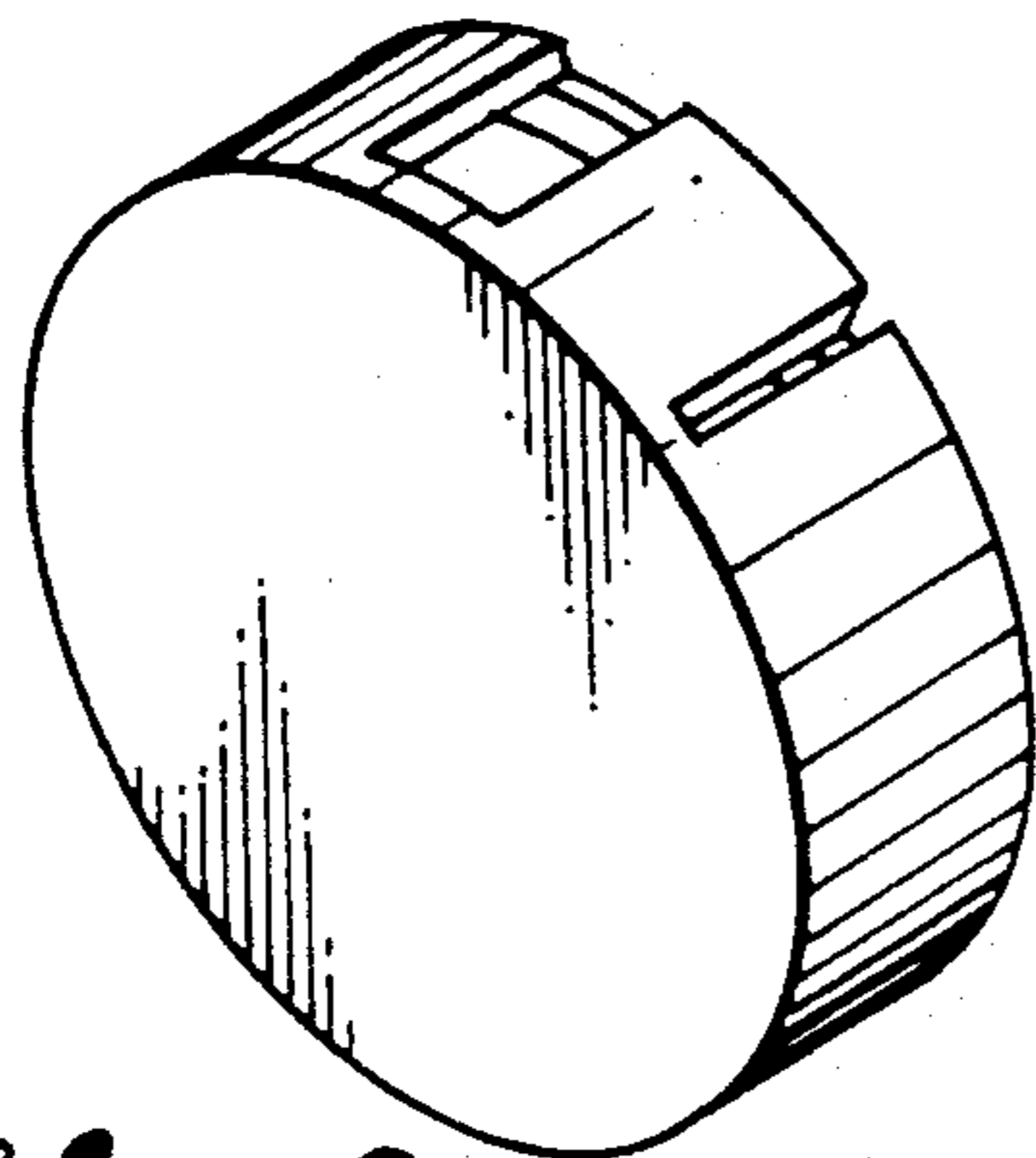
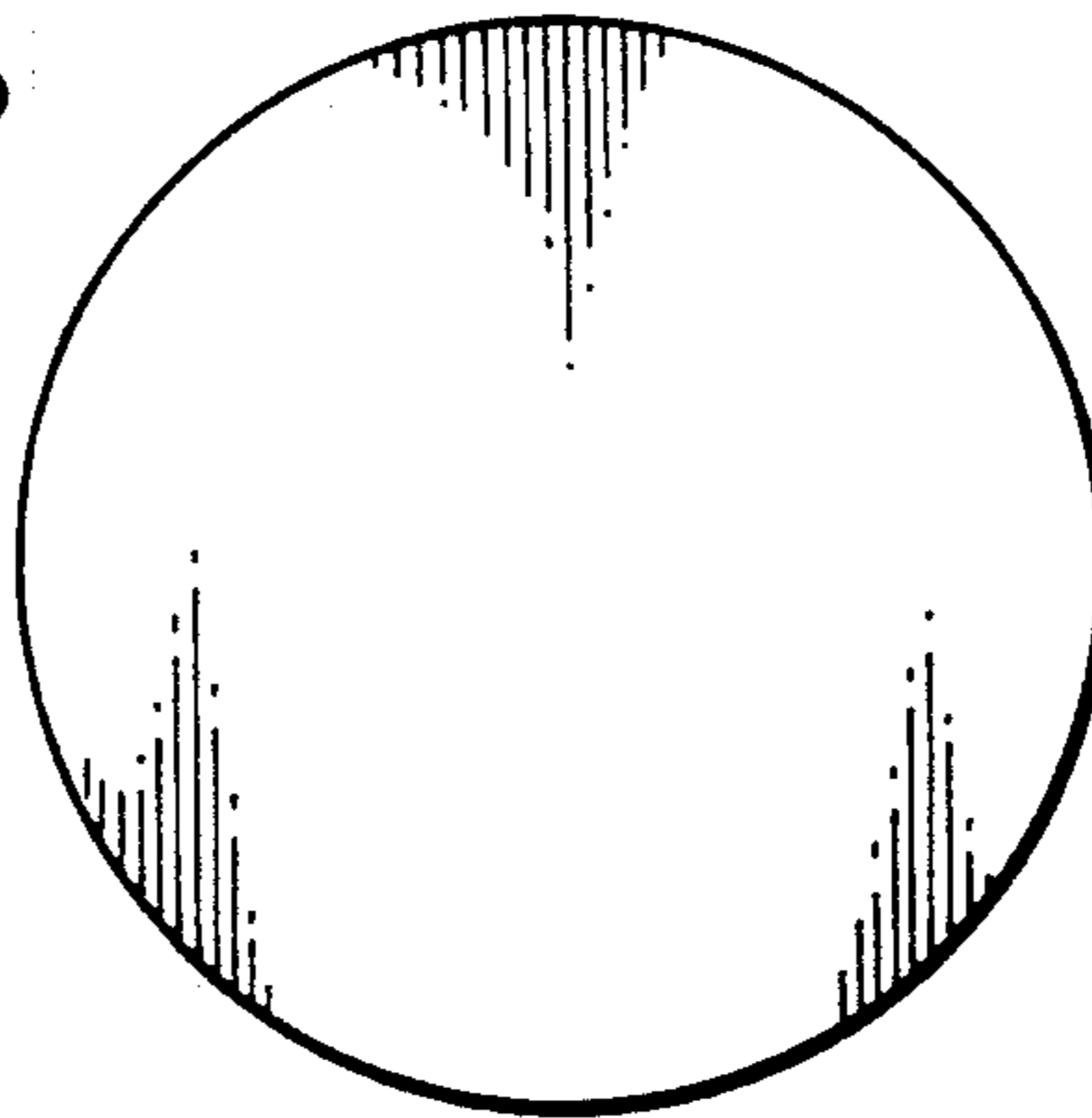

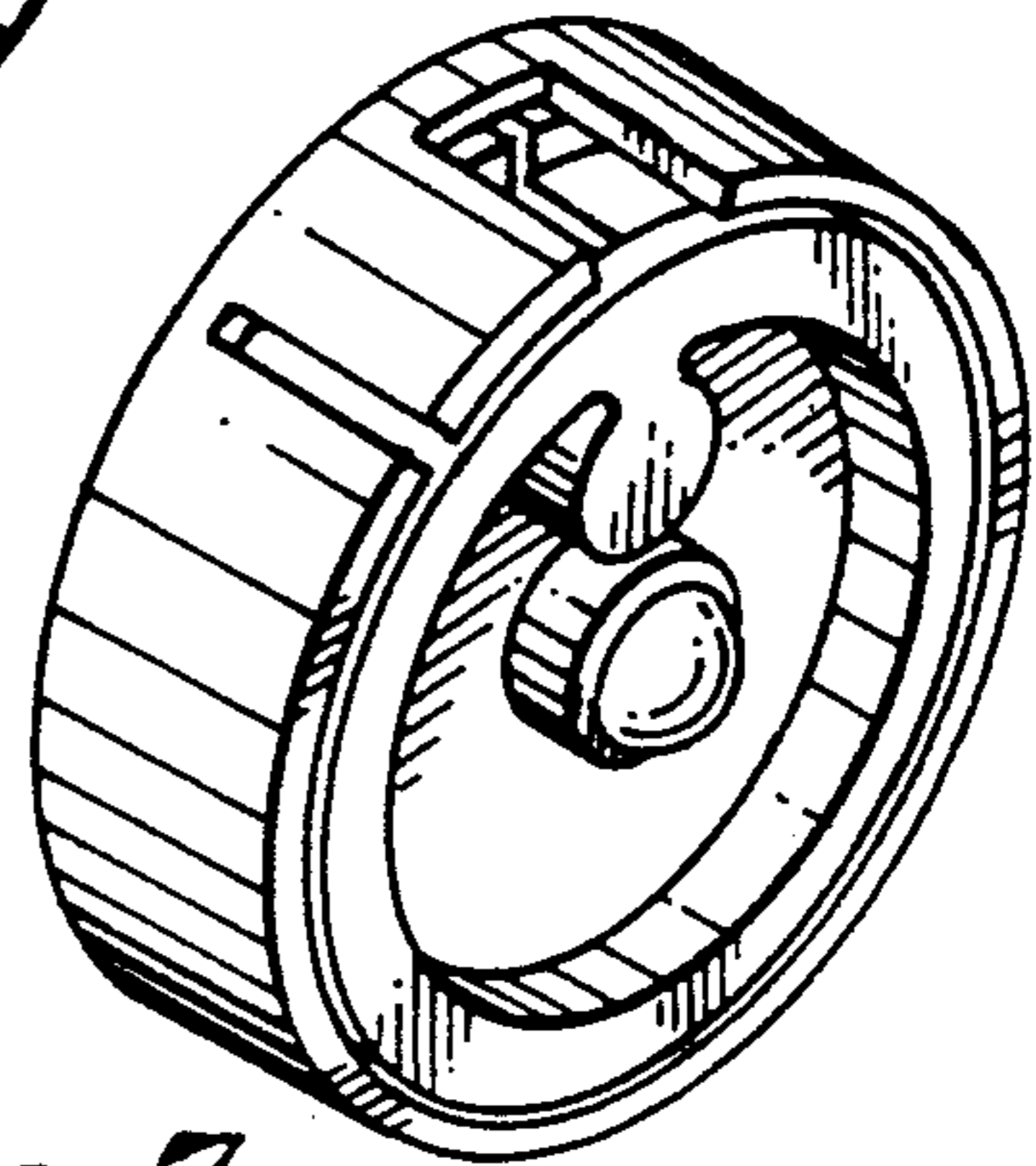

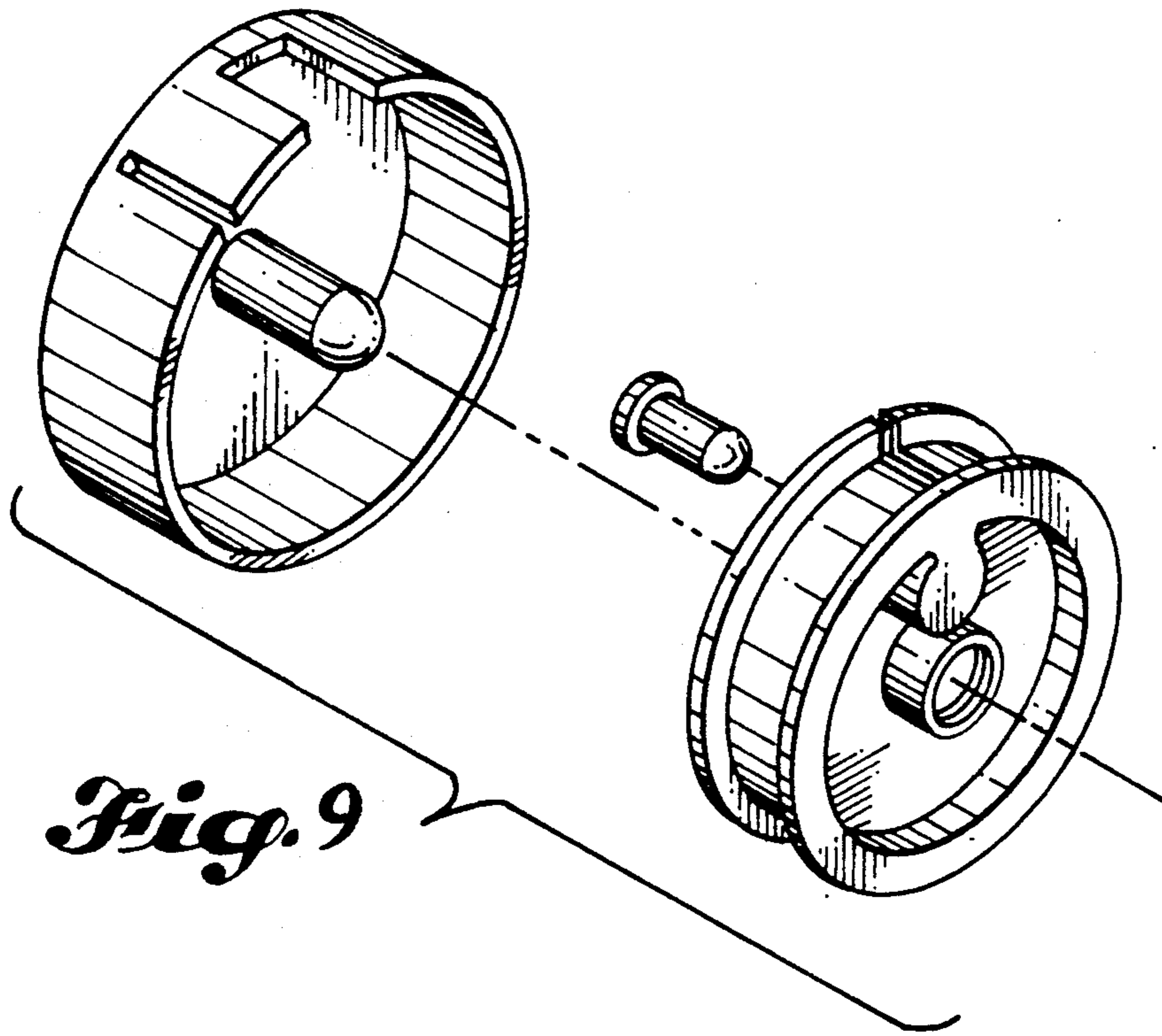

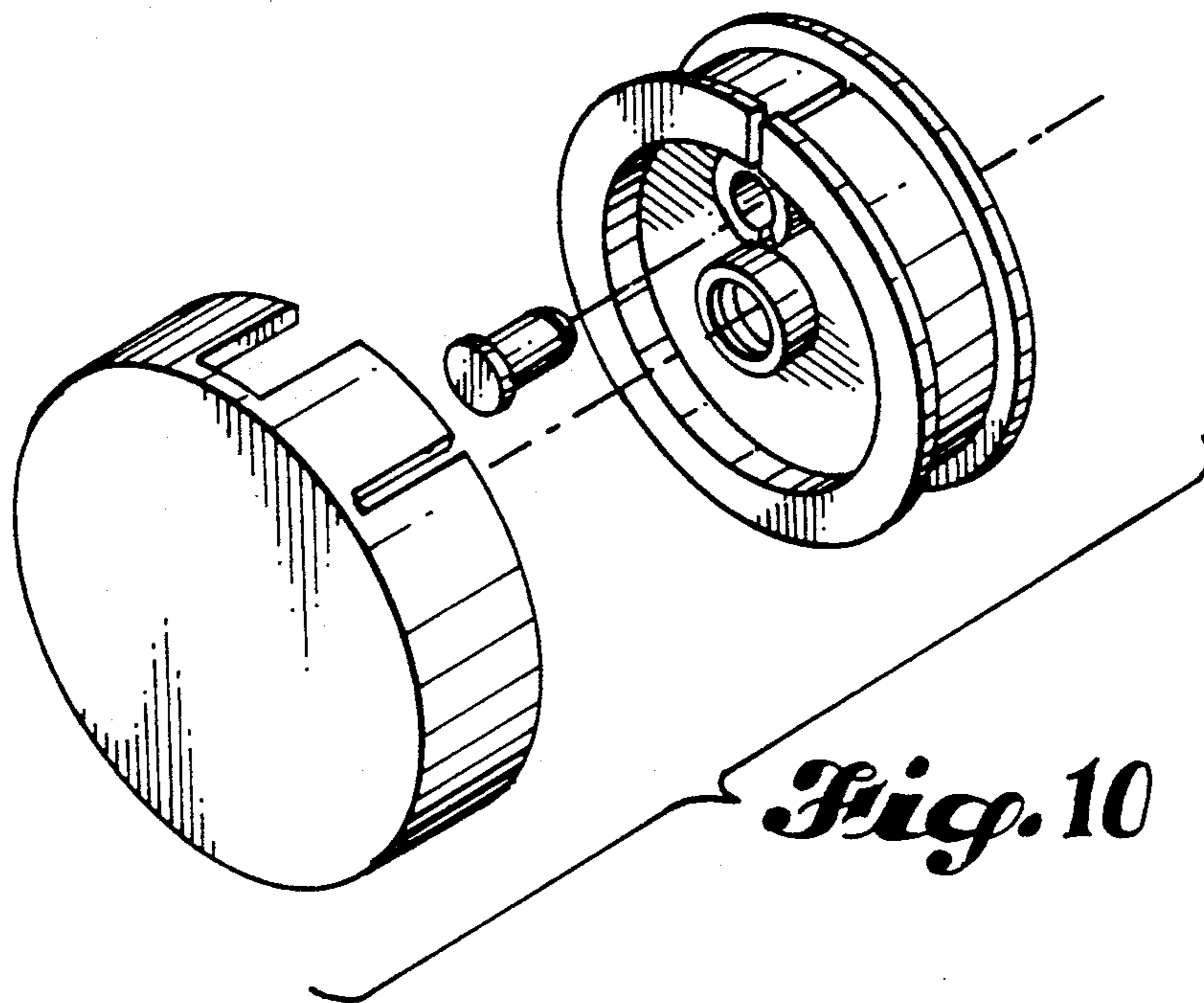
