DESCRIPTION

FIG. 1 is a perspective view taken from the top, front and right side of a faucet shown my new design;
 FIG. 2 is a right side elevational view thereof, the left side being a mirror image of the right side;

 FIG. 5 is a front elevational view thereof; and
 FIG. 6 is a rear elevational view thereof.

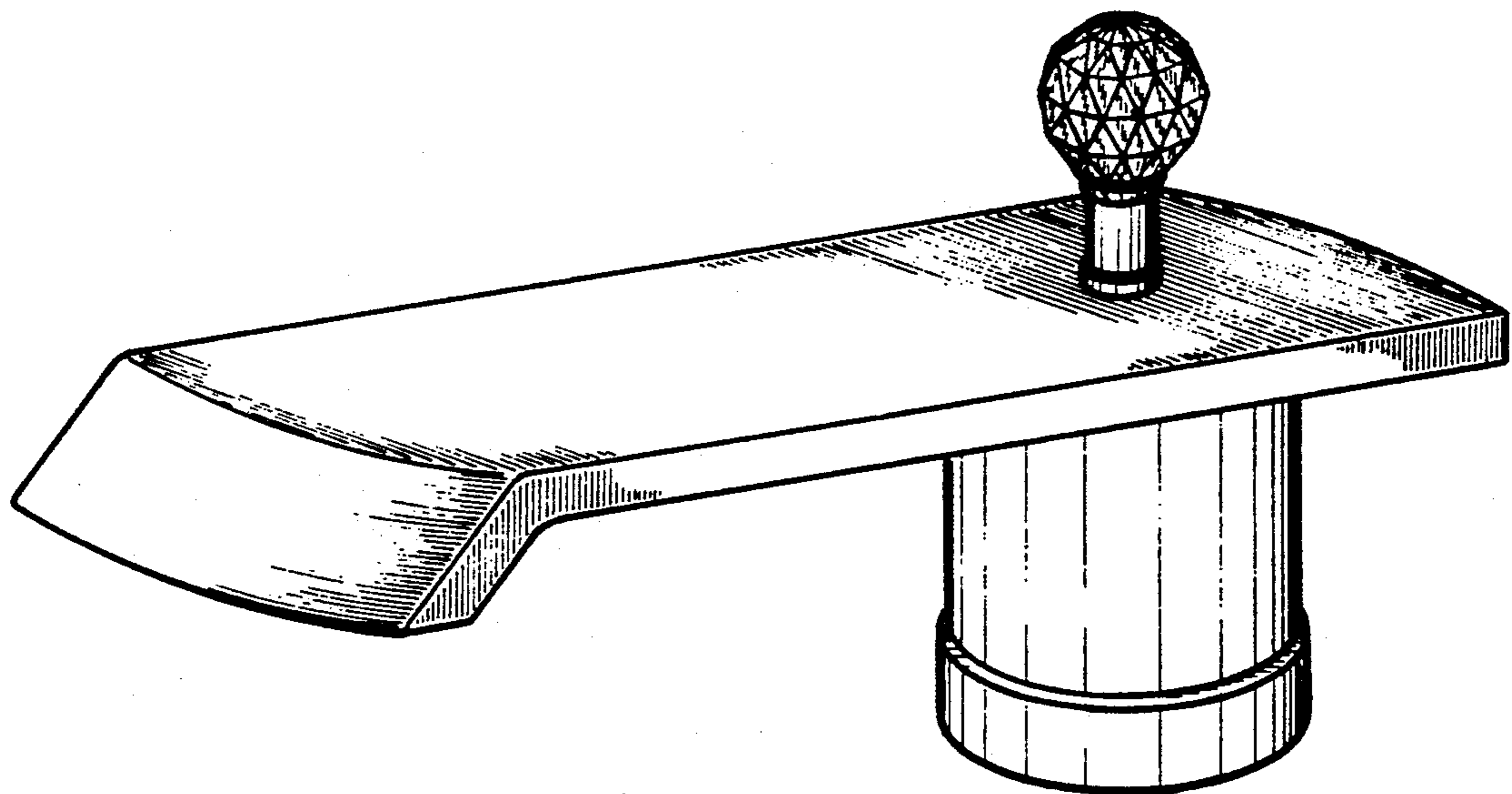

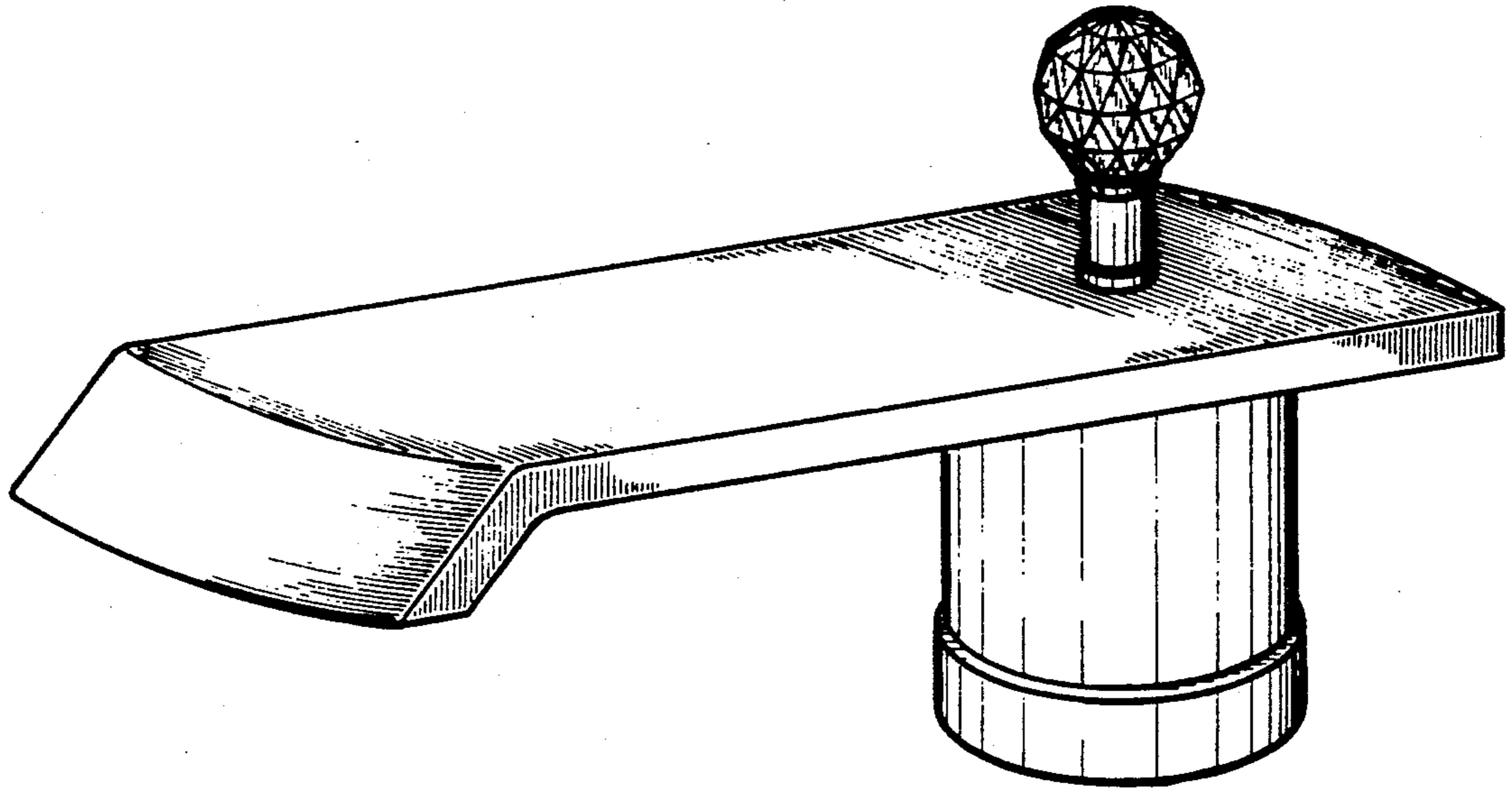

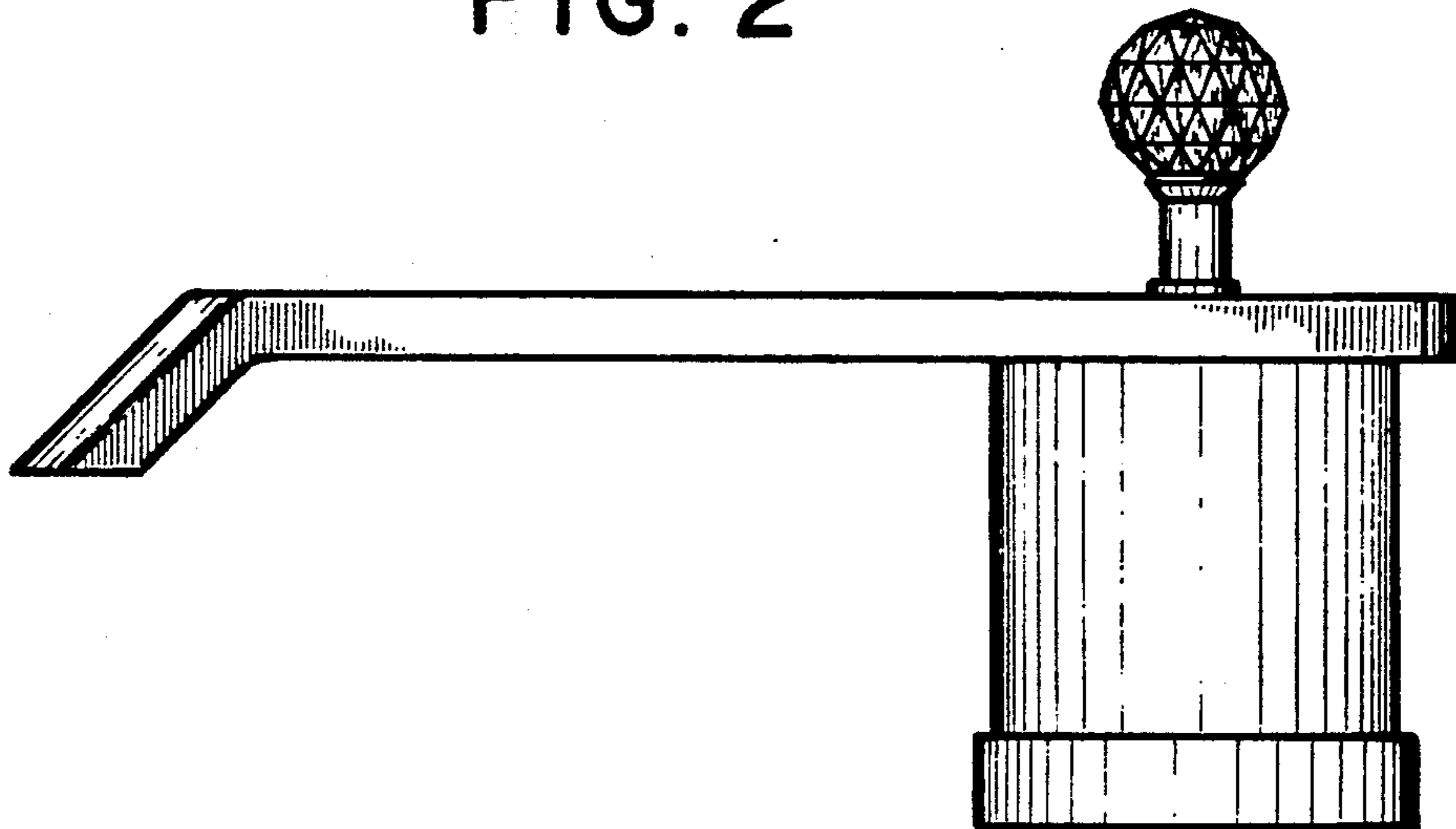

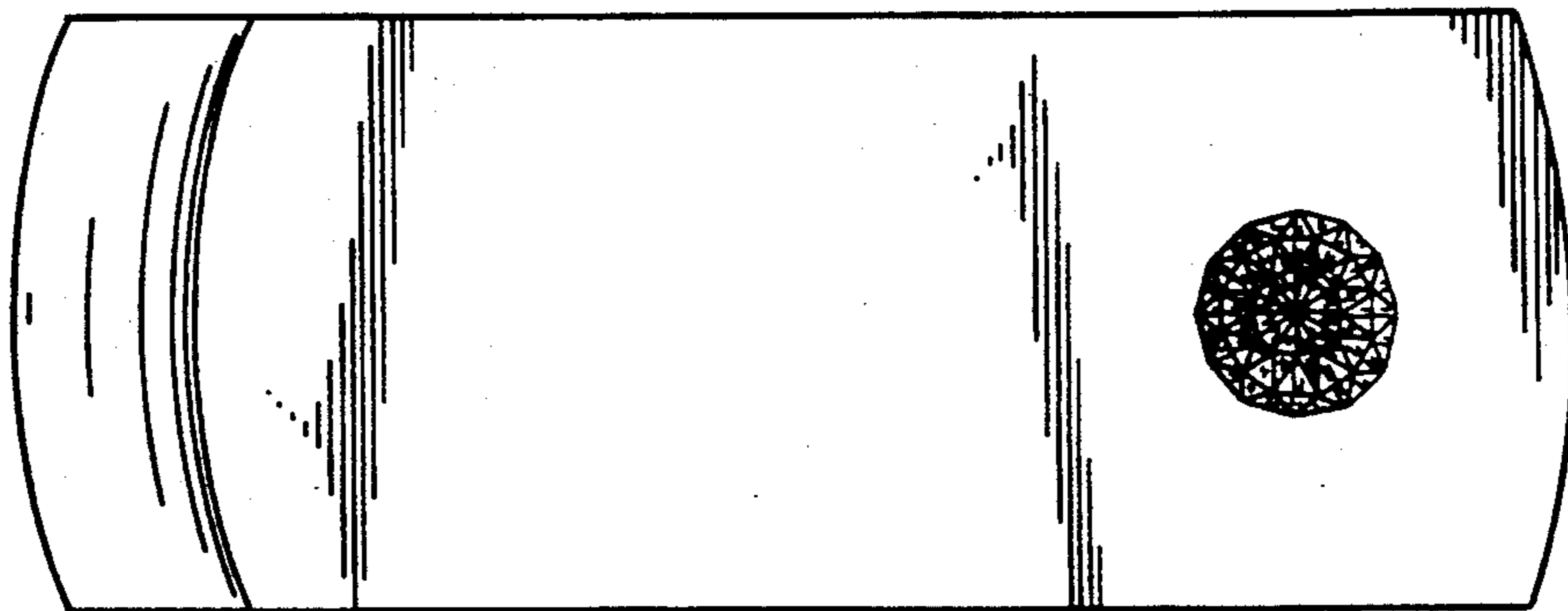

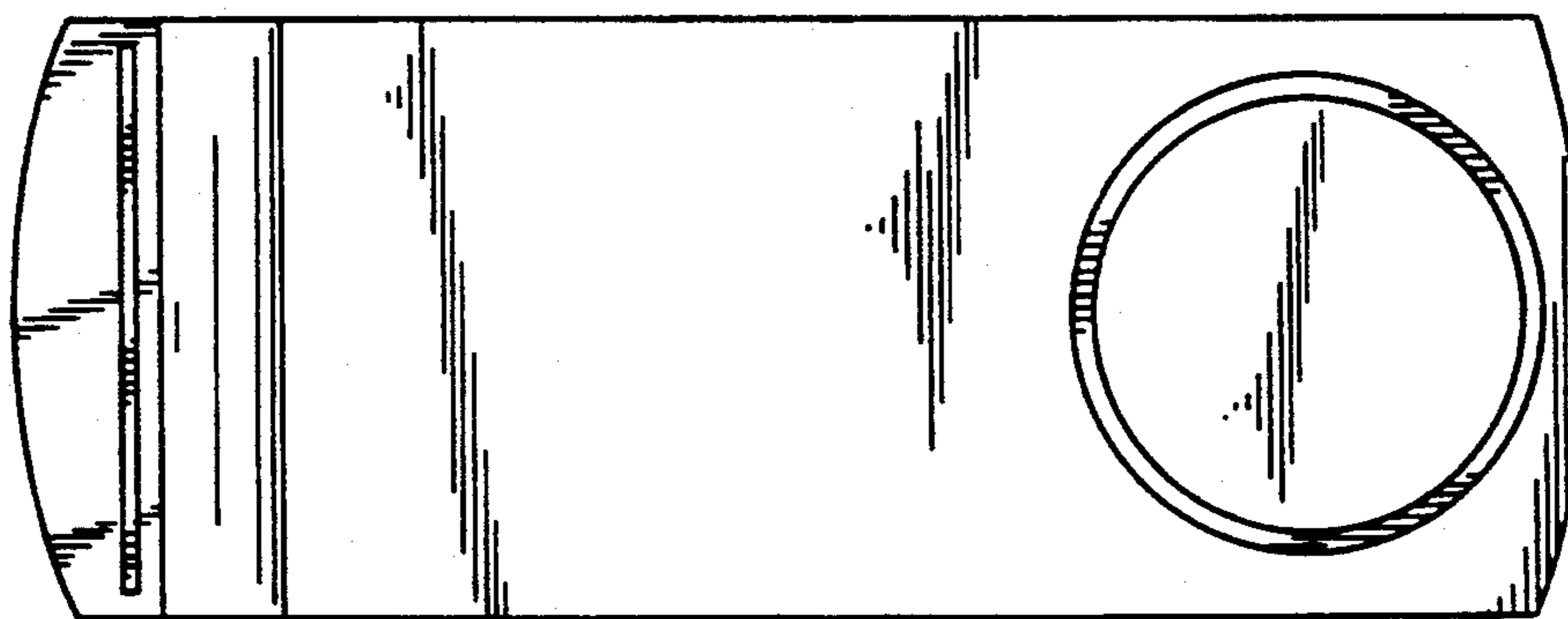

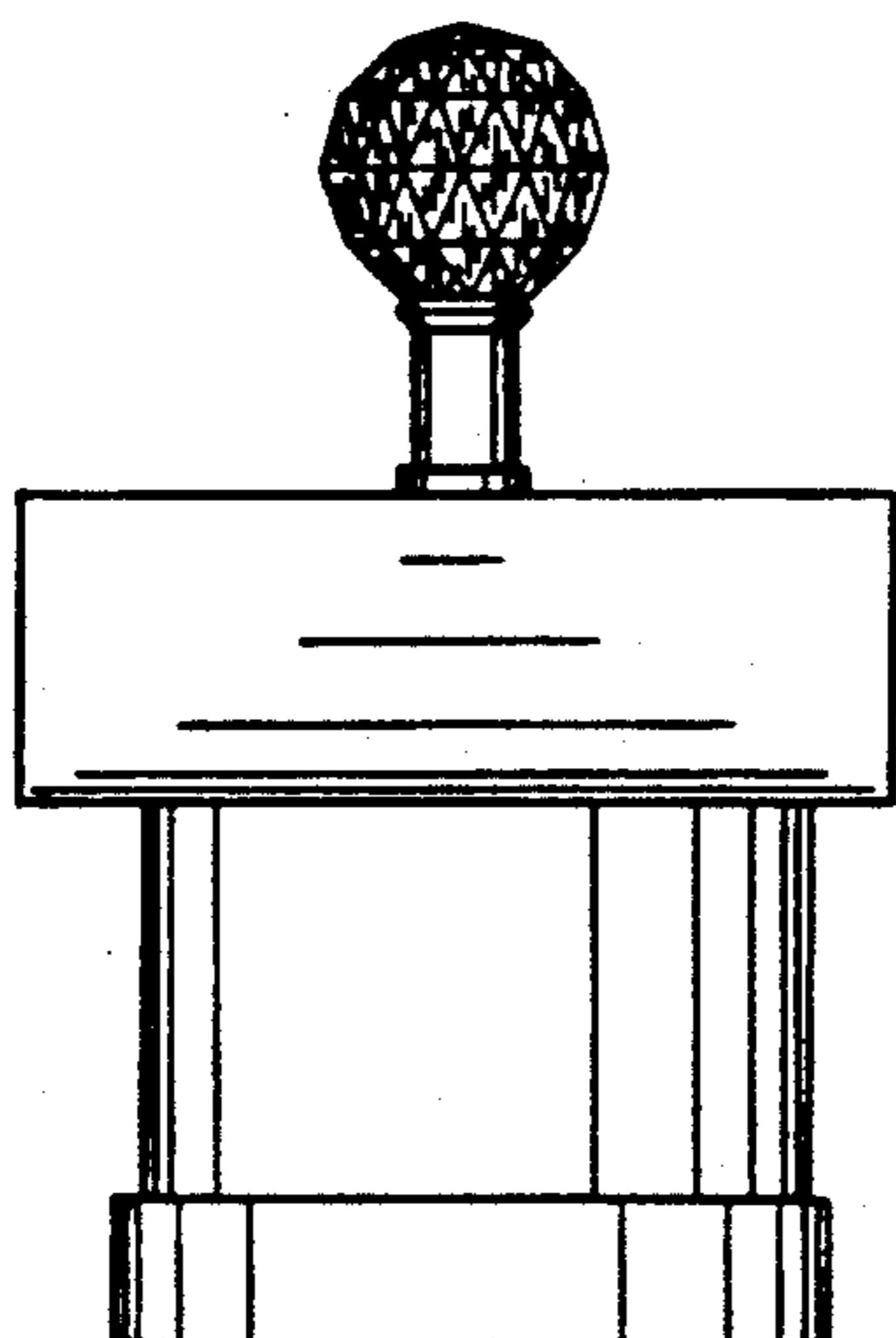
