The ornamental design for a box for a roll of film, as shown and described.

DESCRIPTION

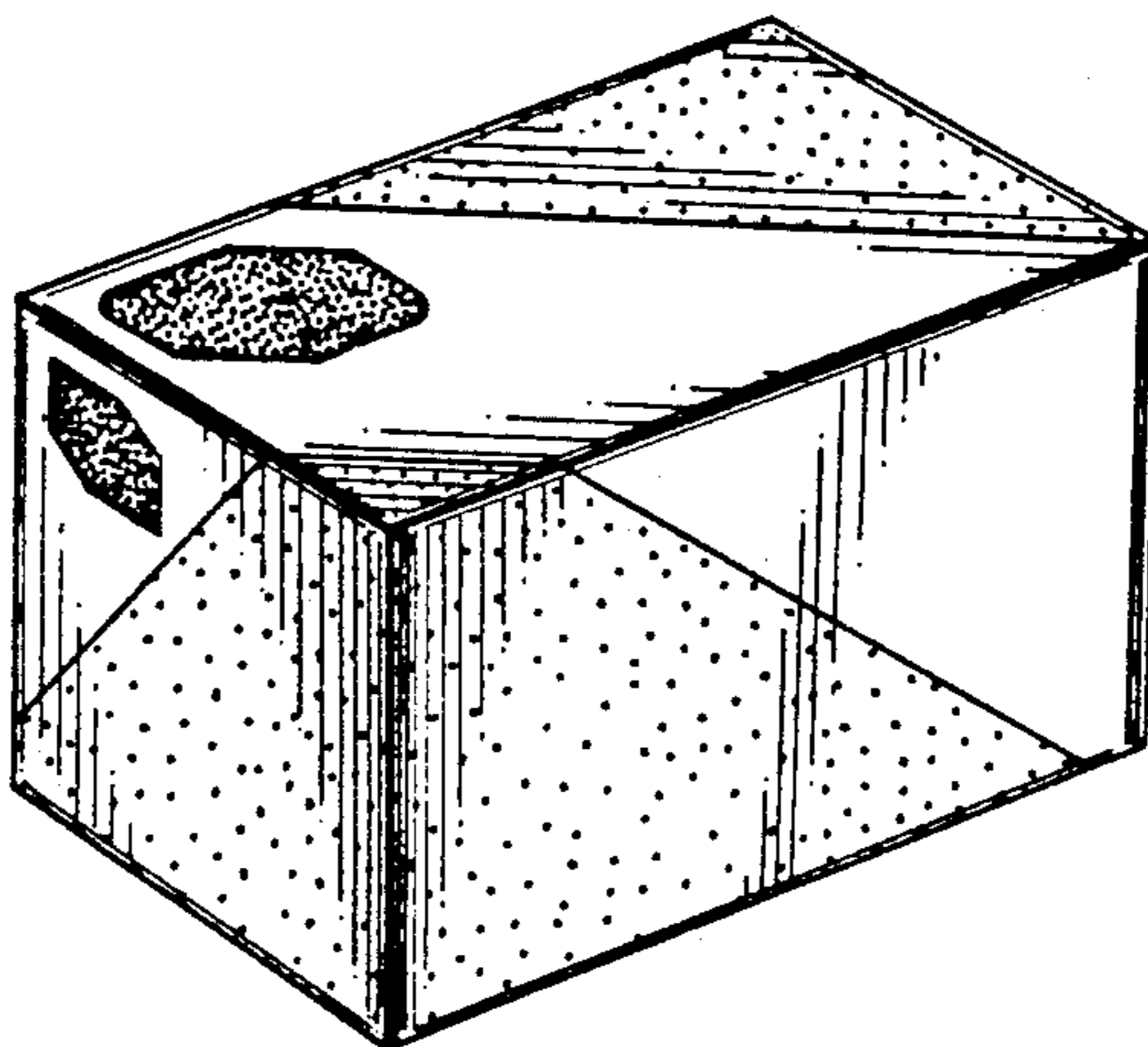

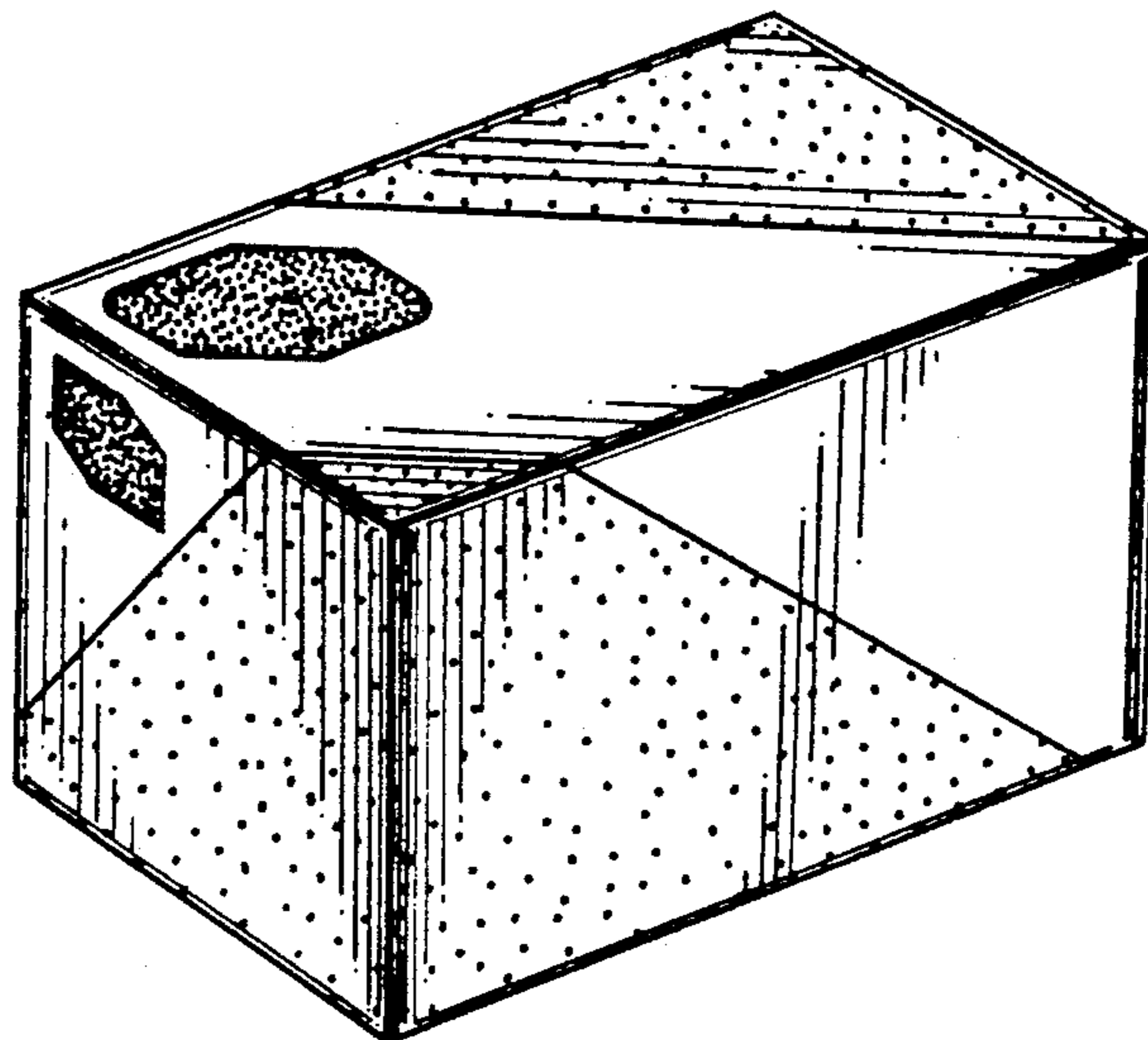

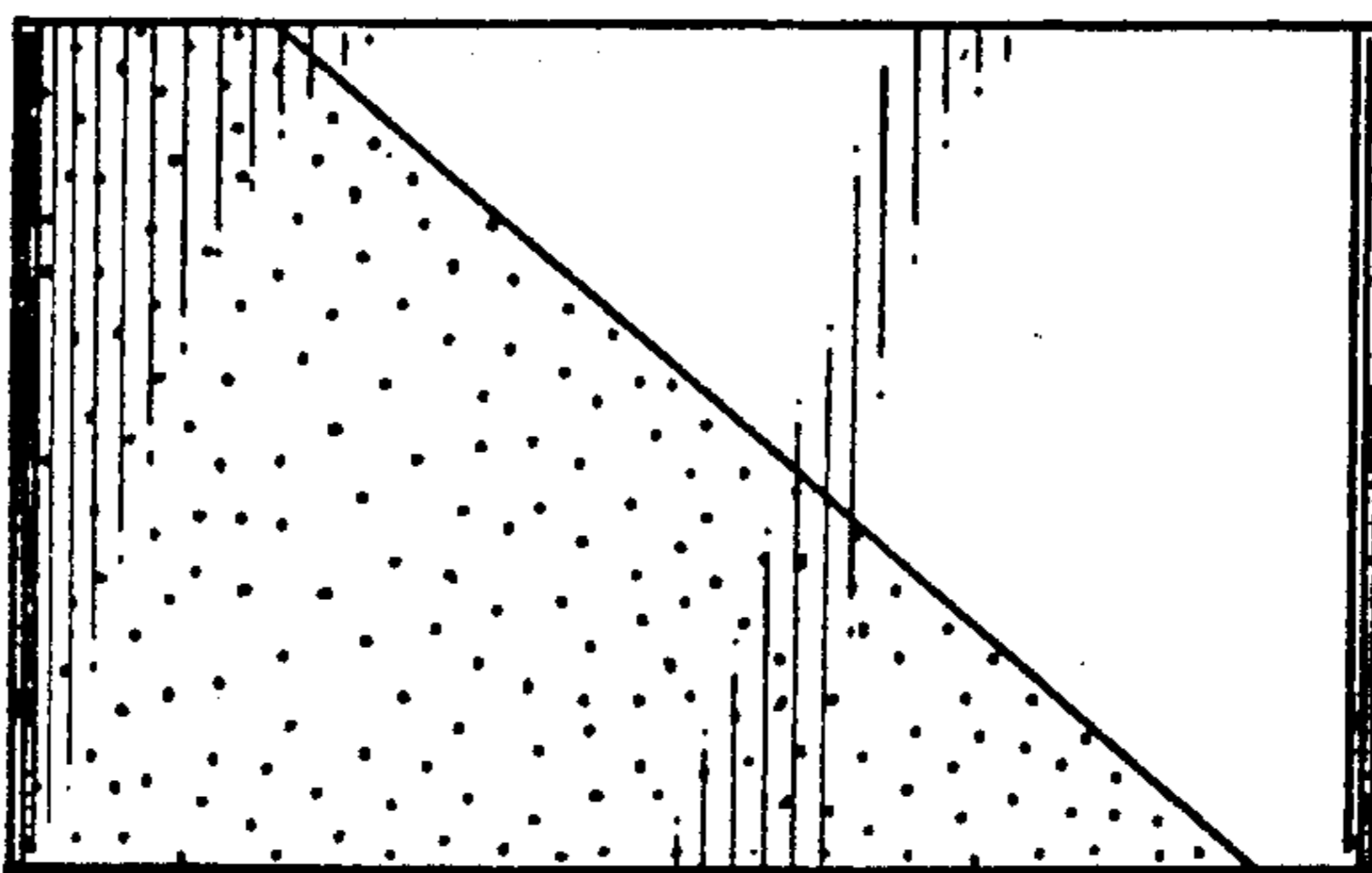

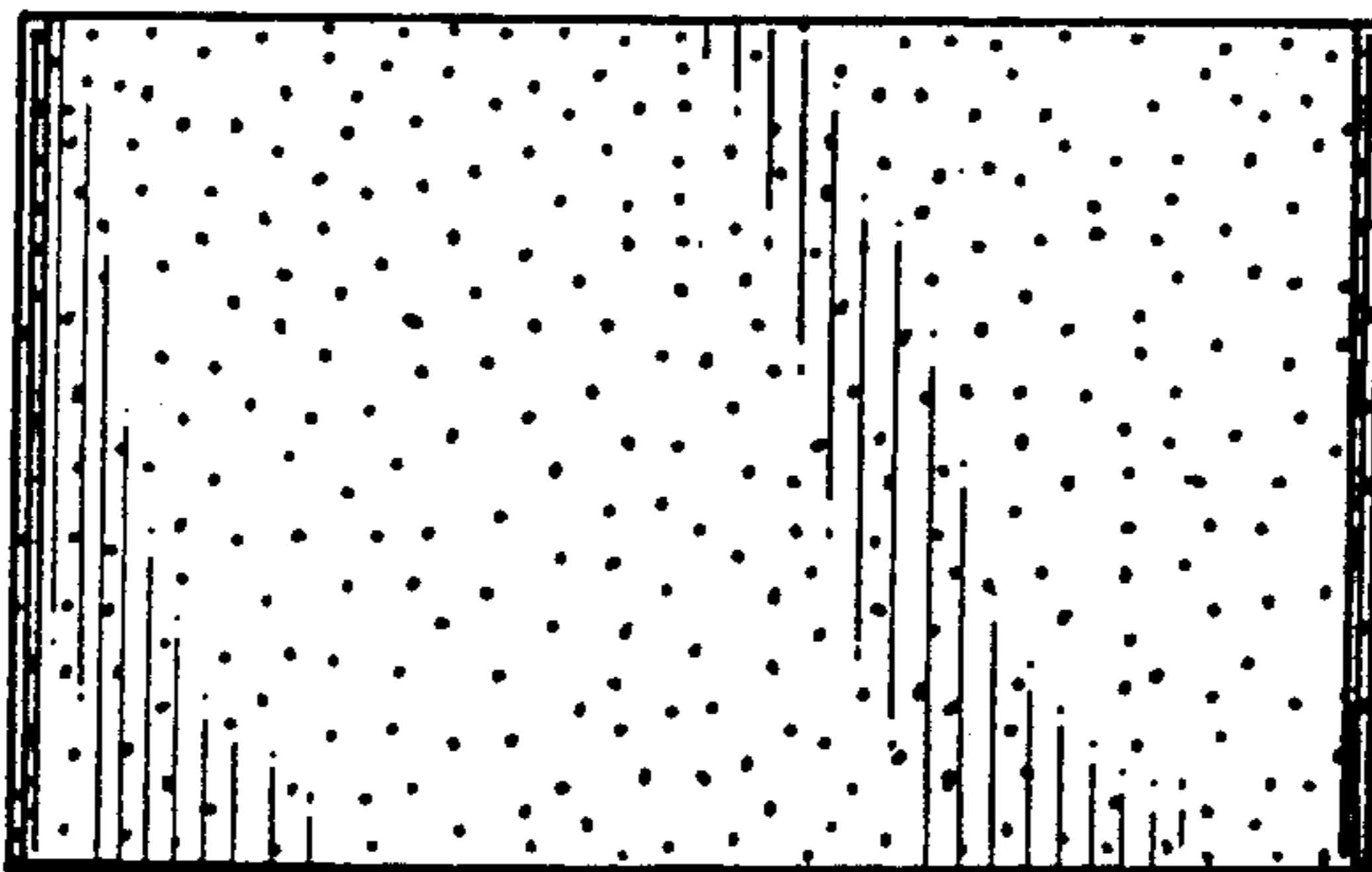

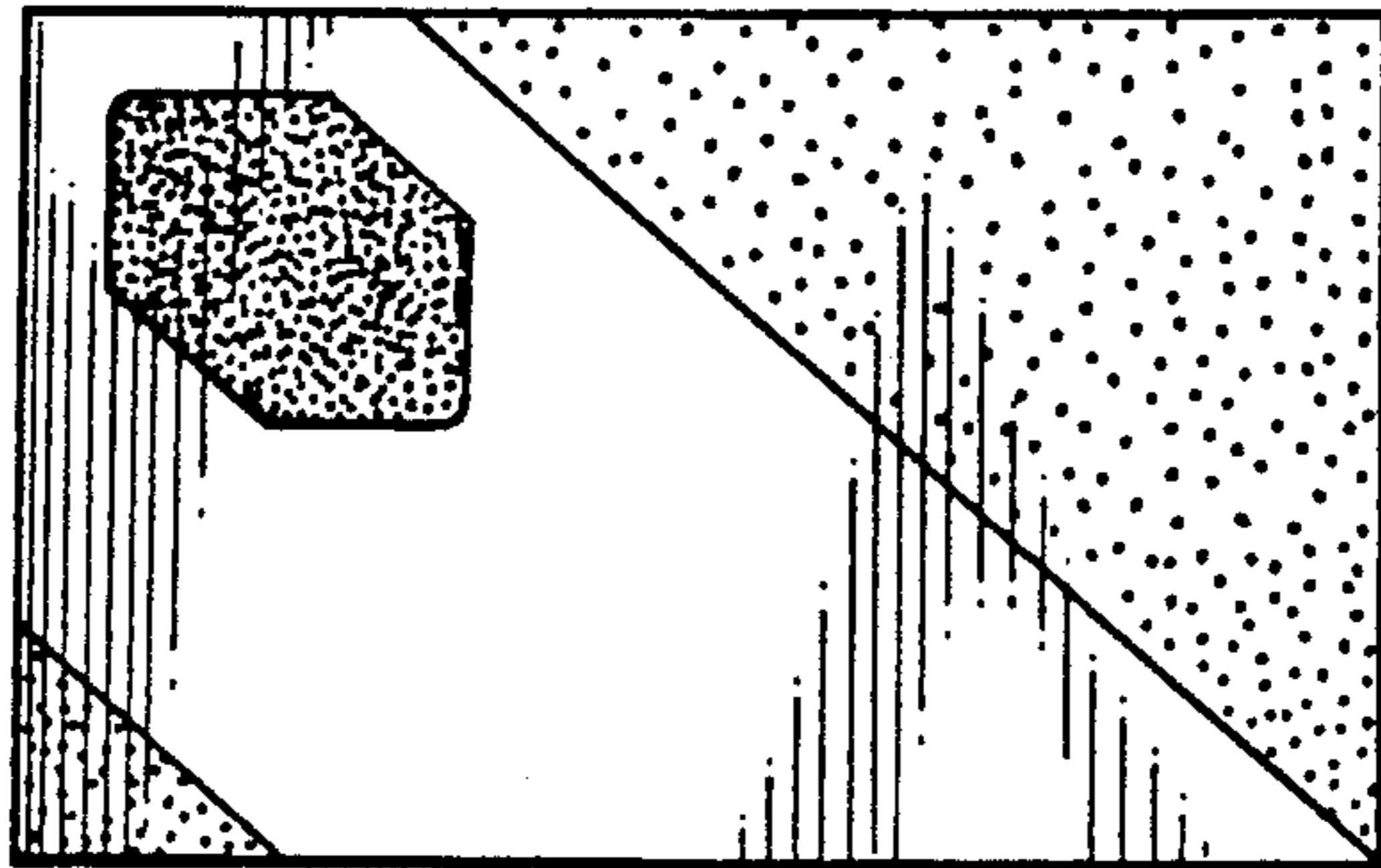

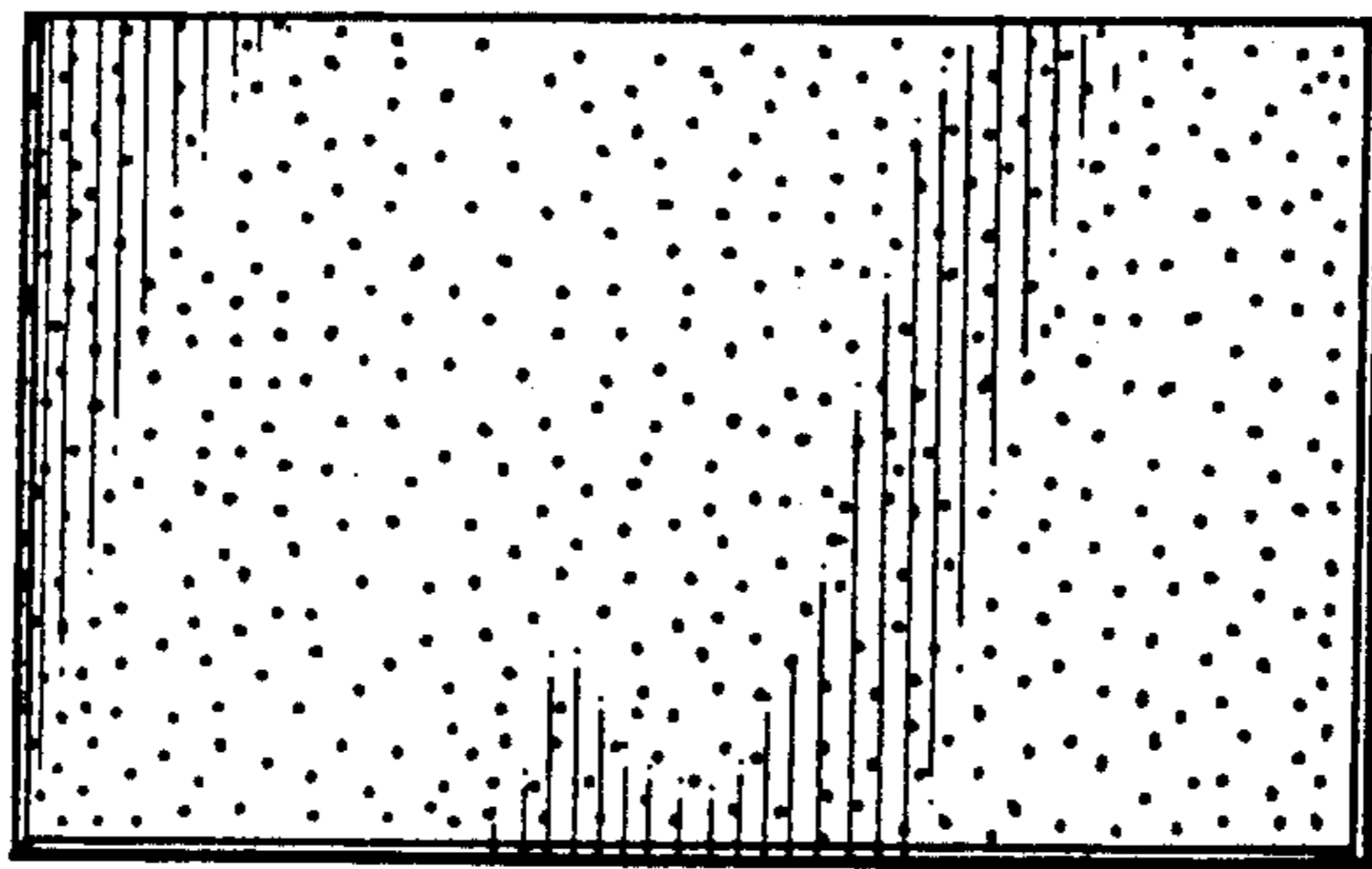

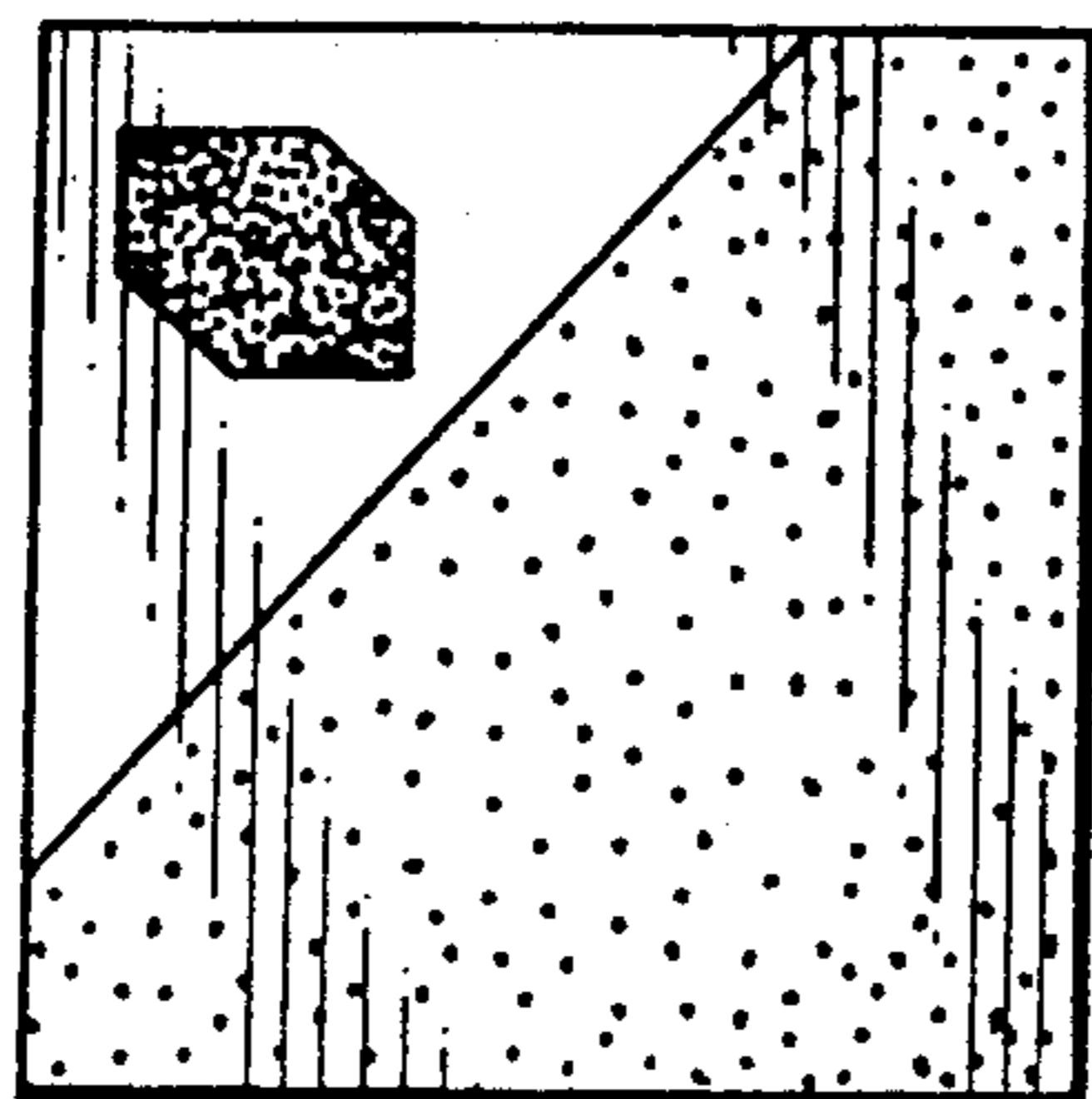

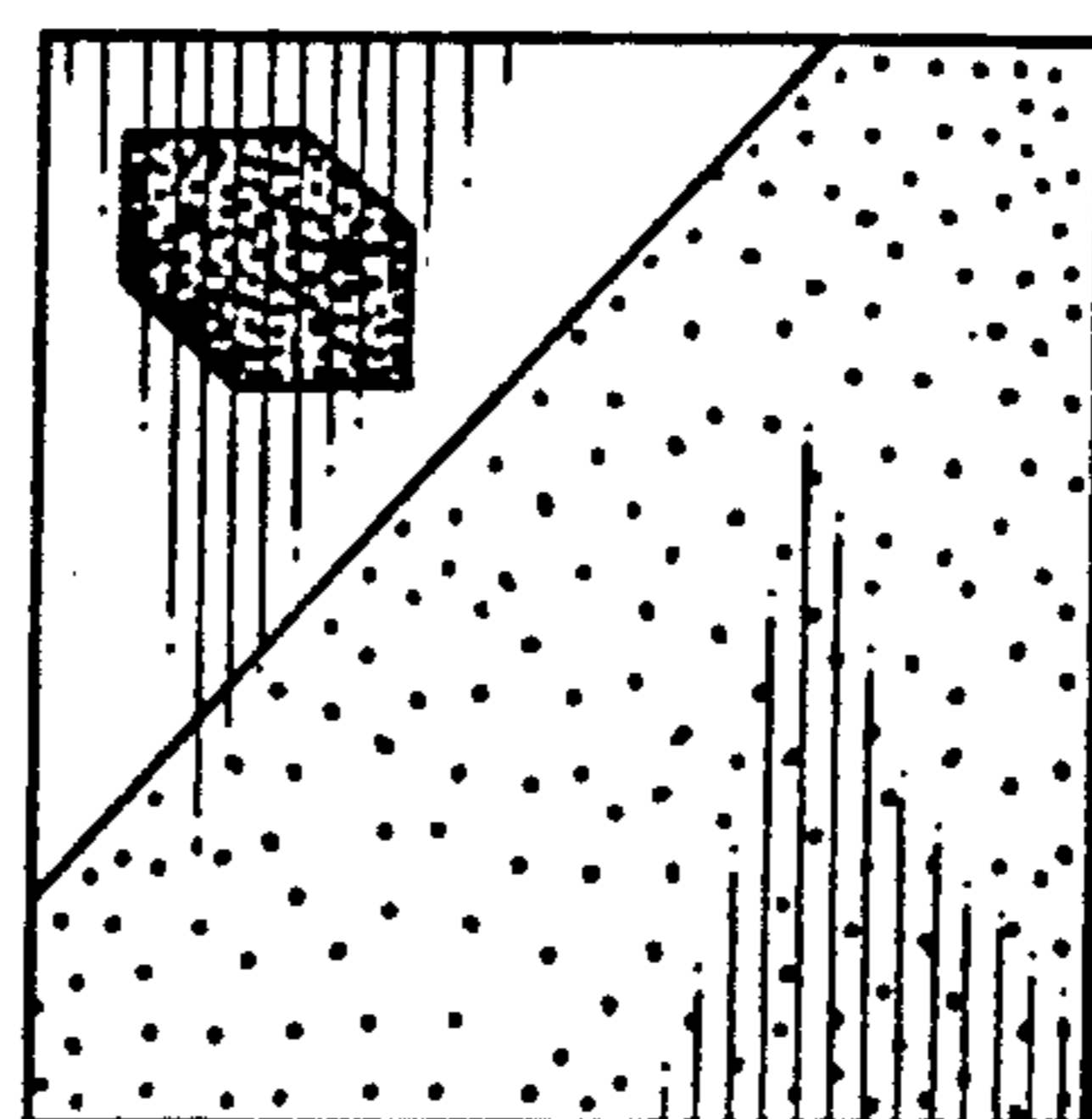

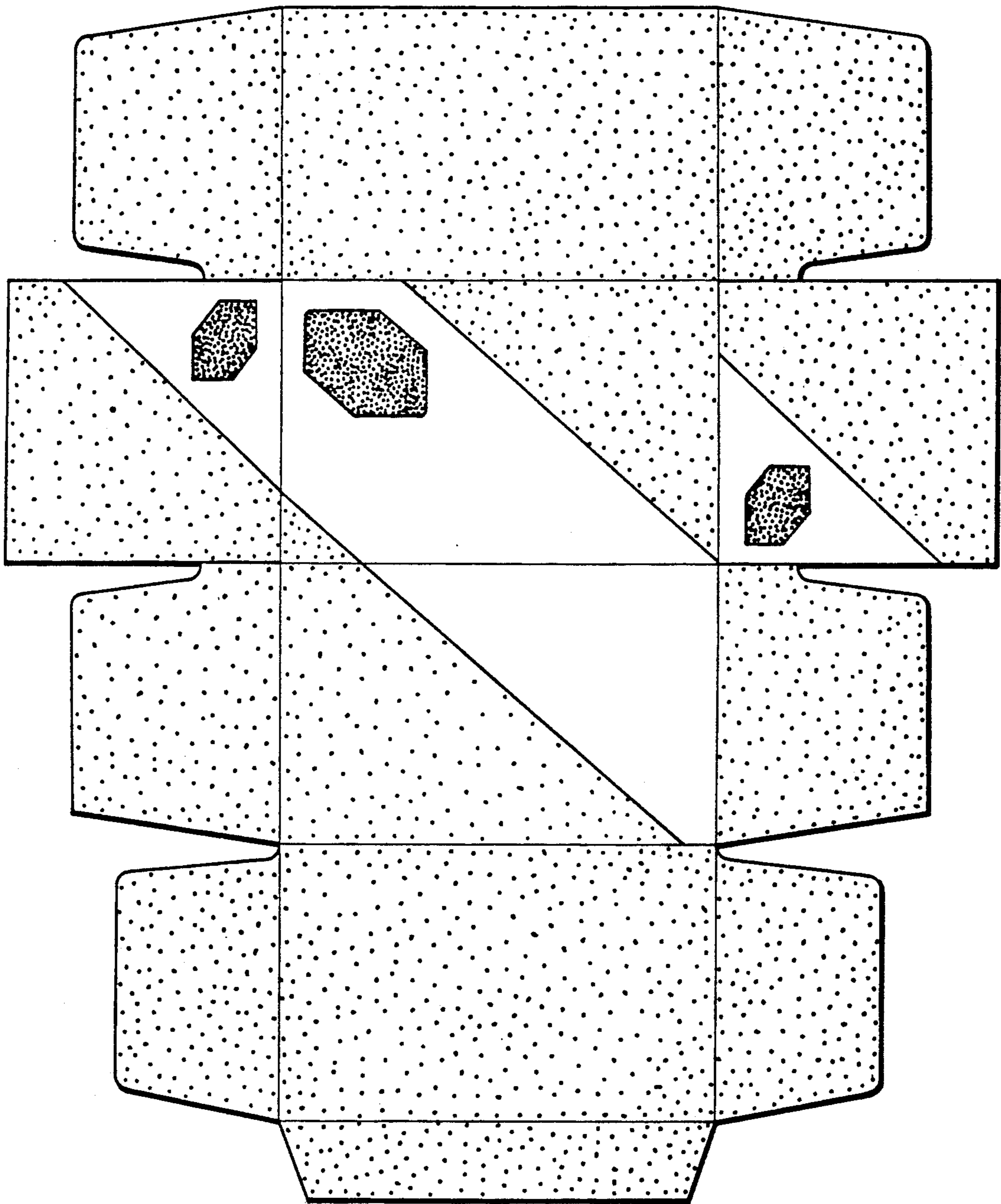

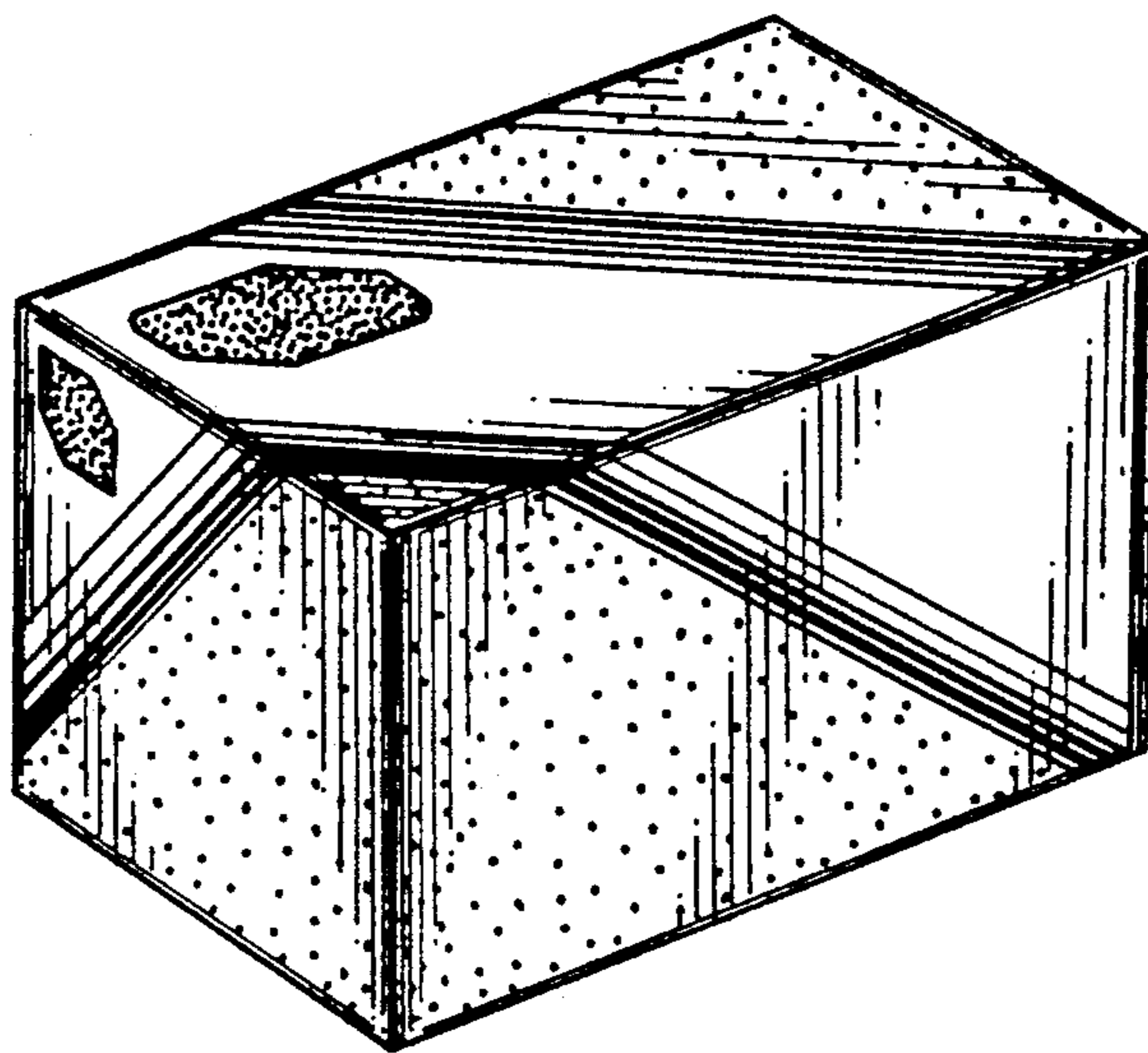

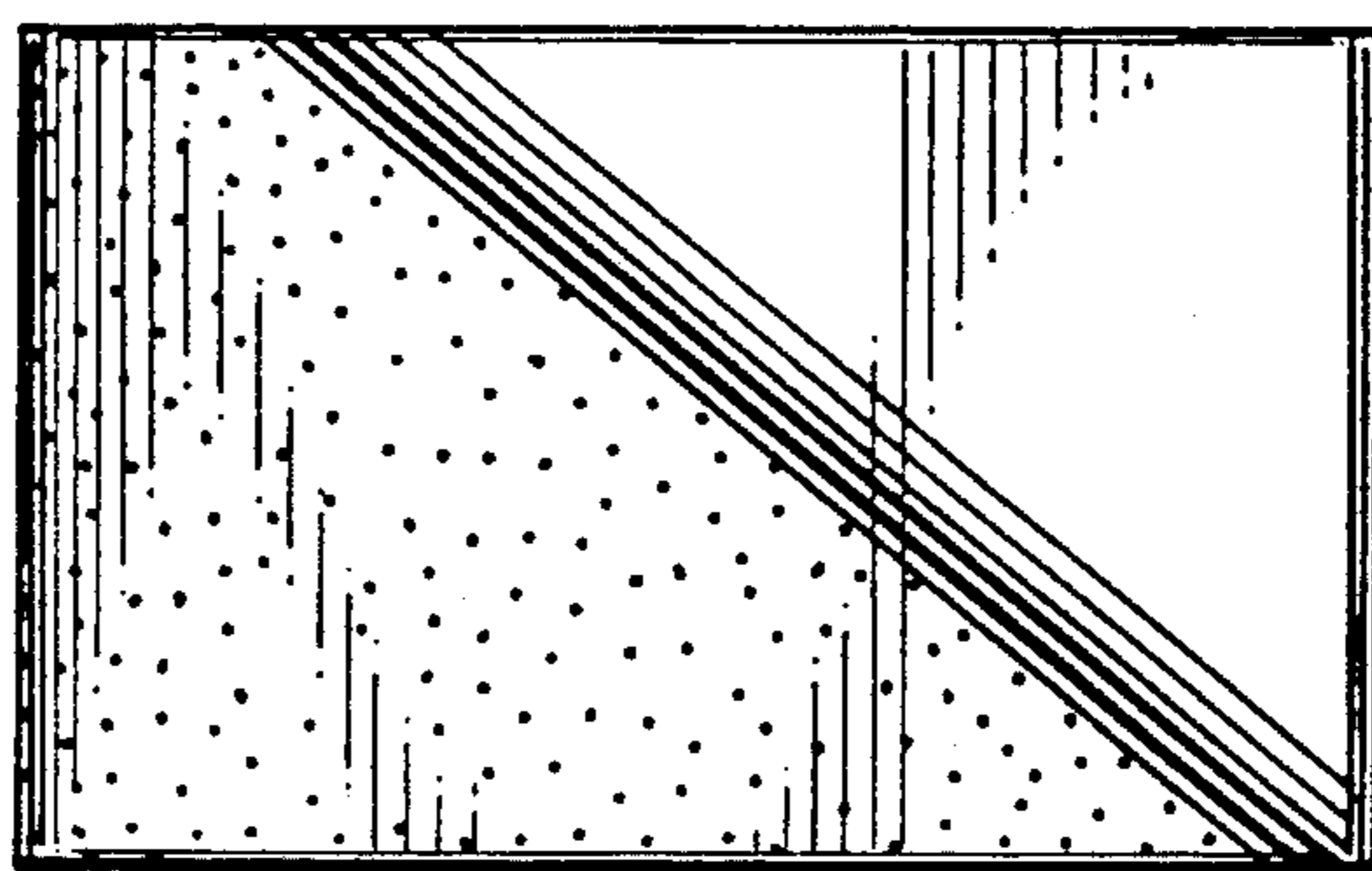

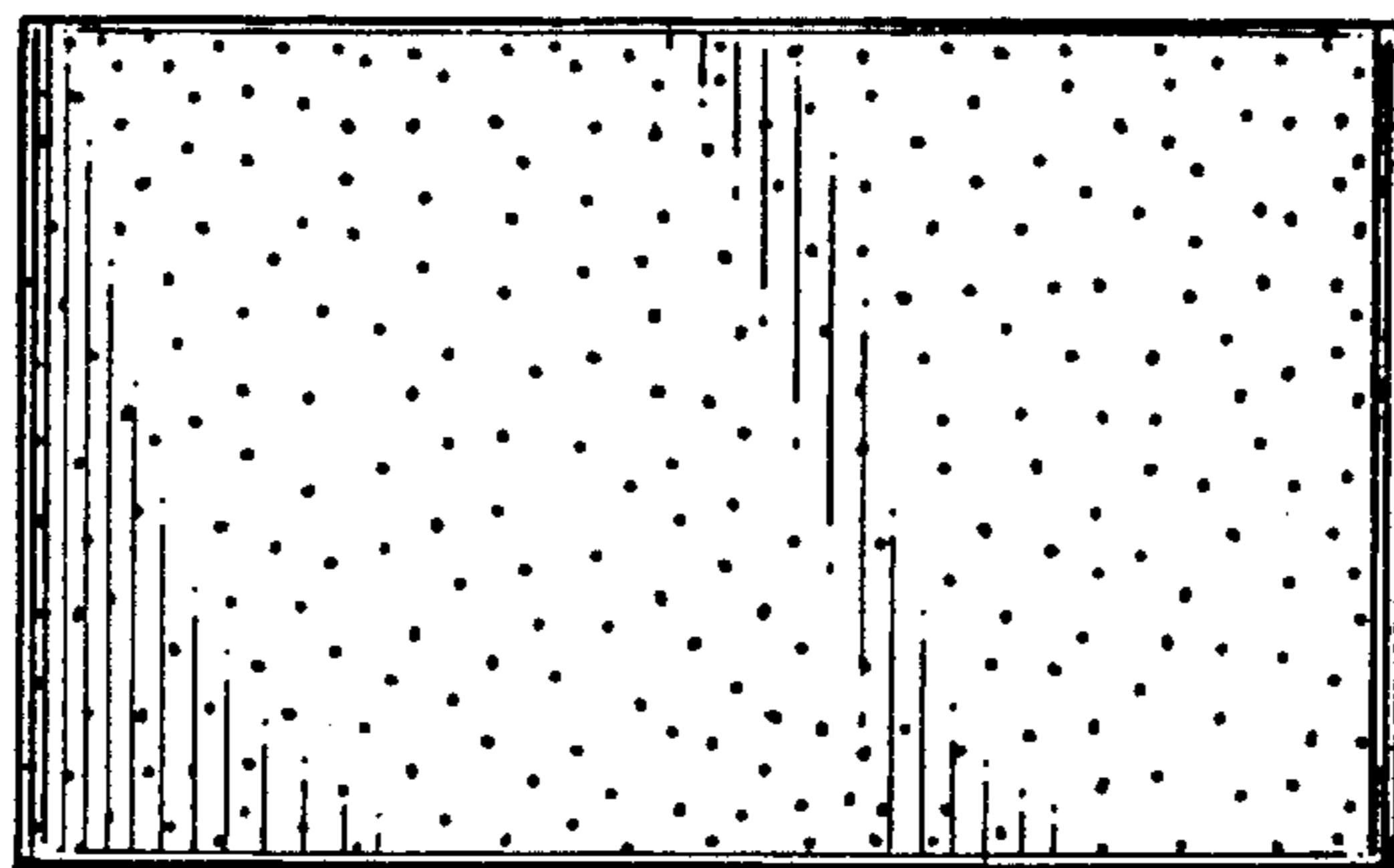

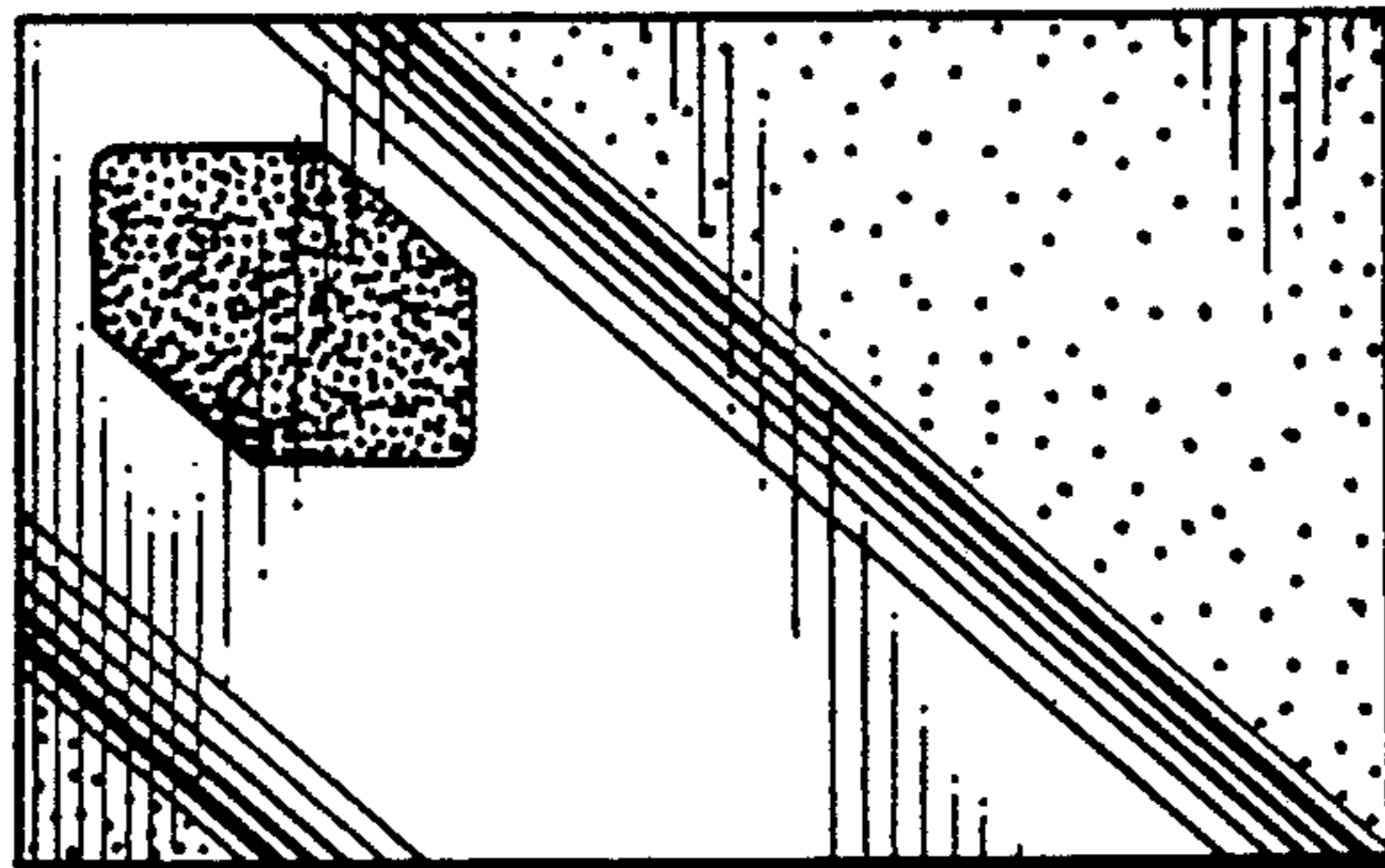

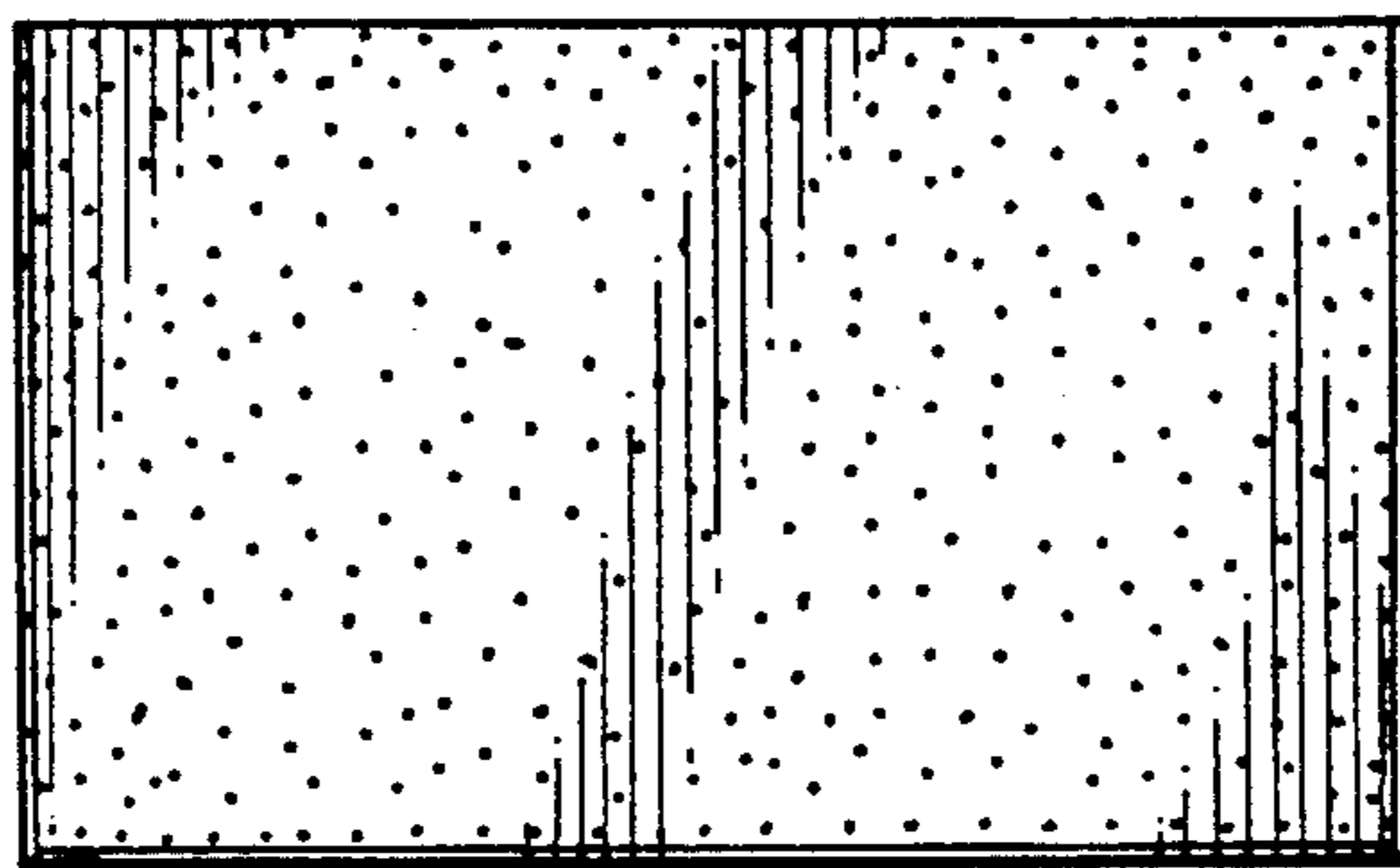

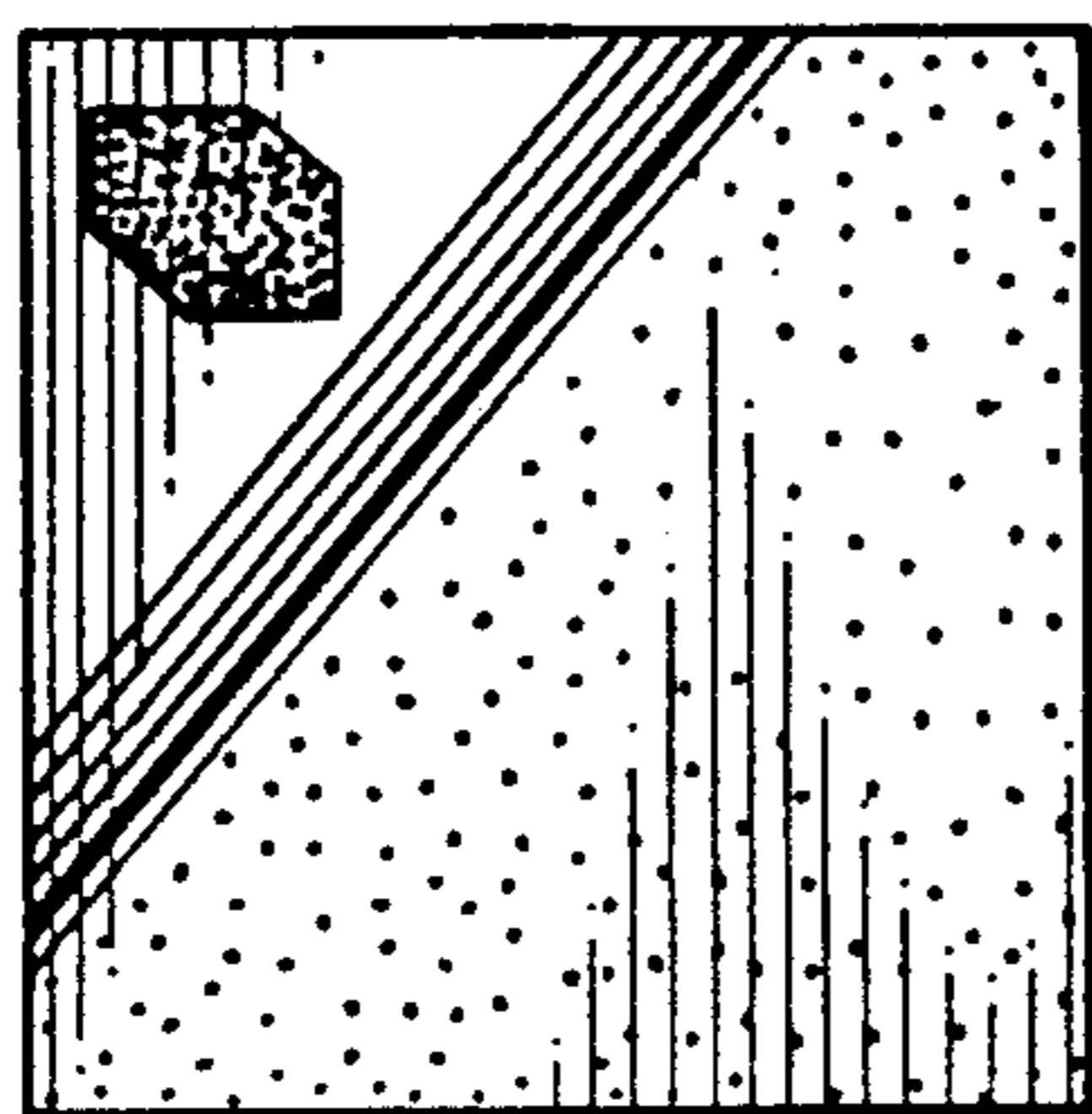

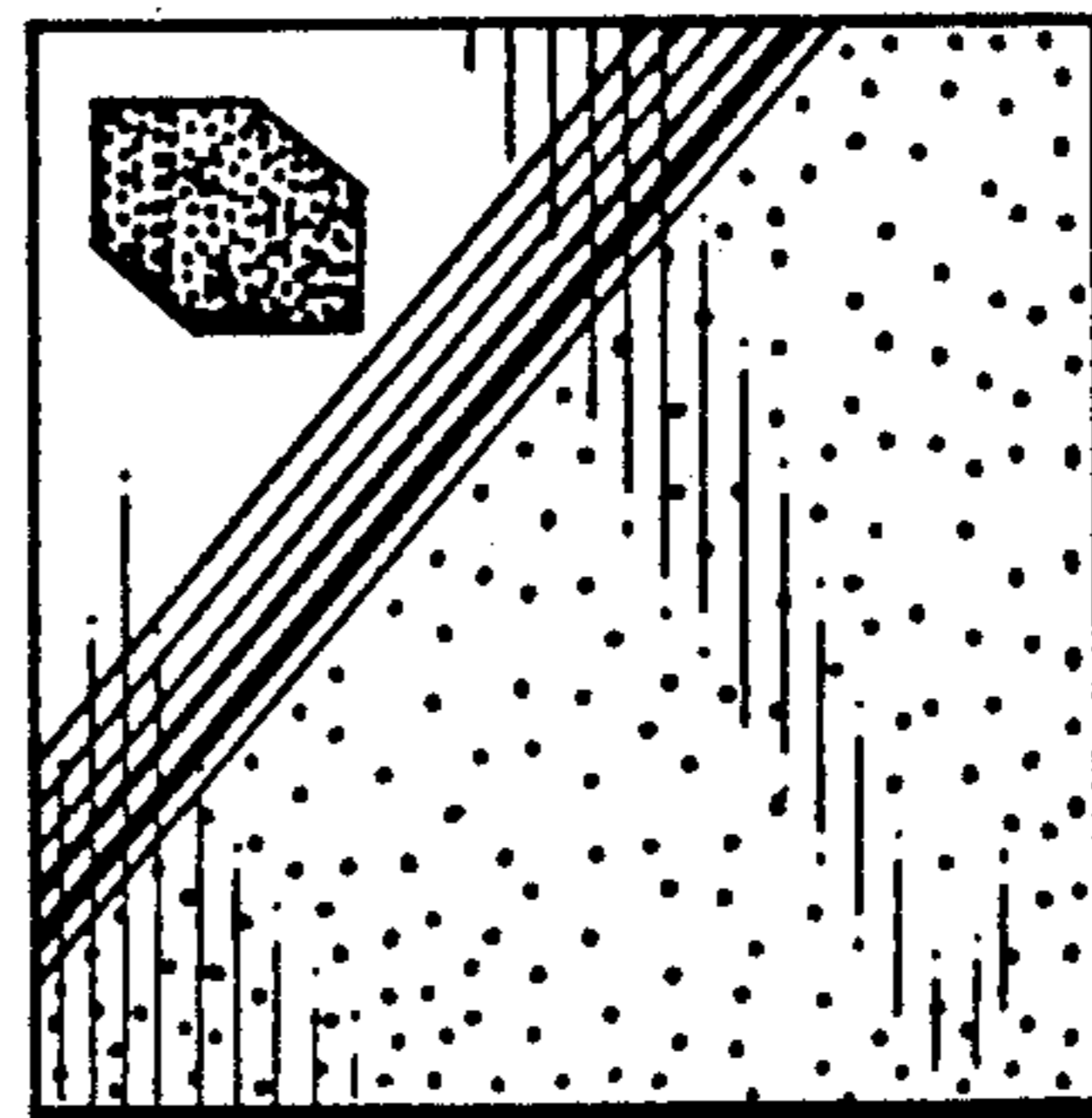

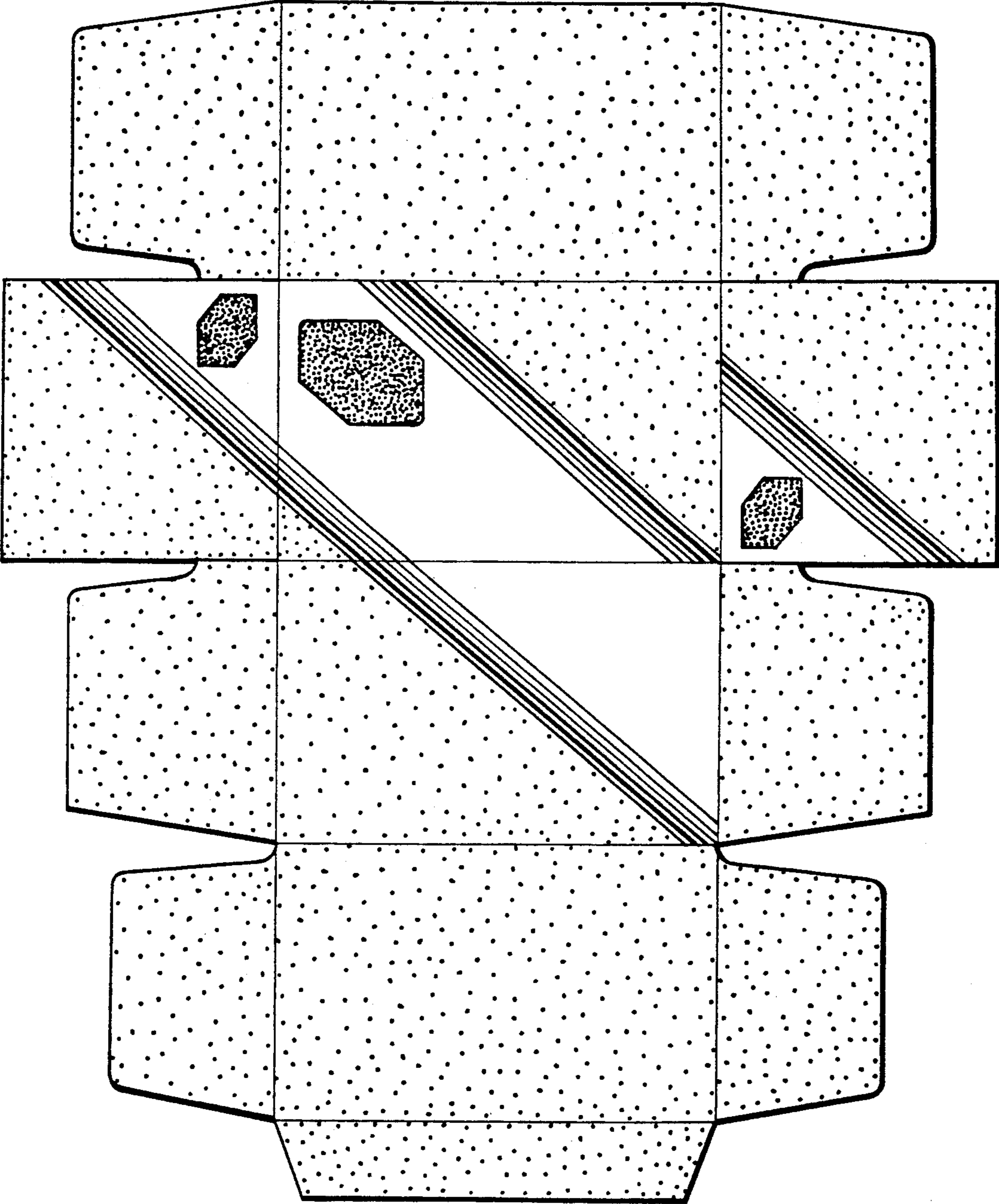

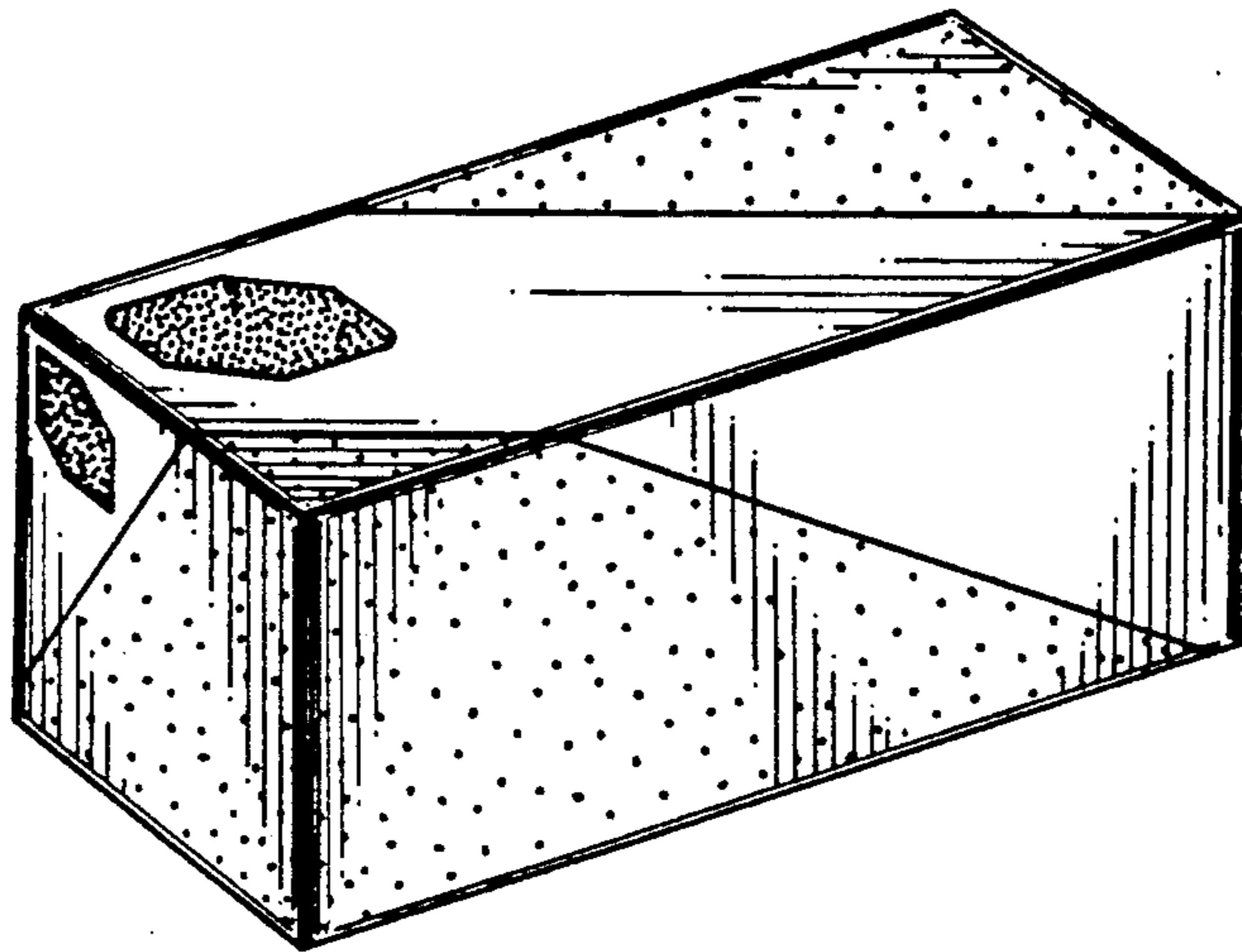

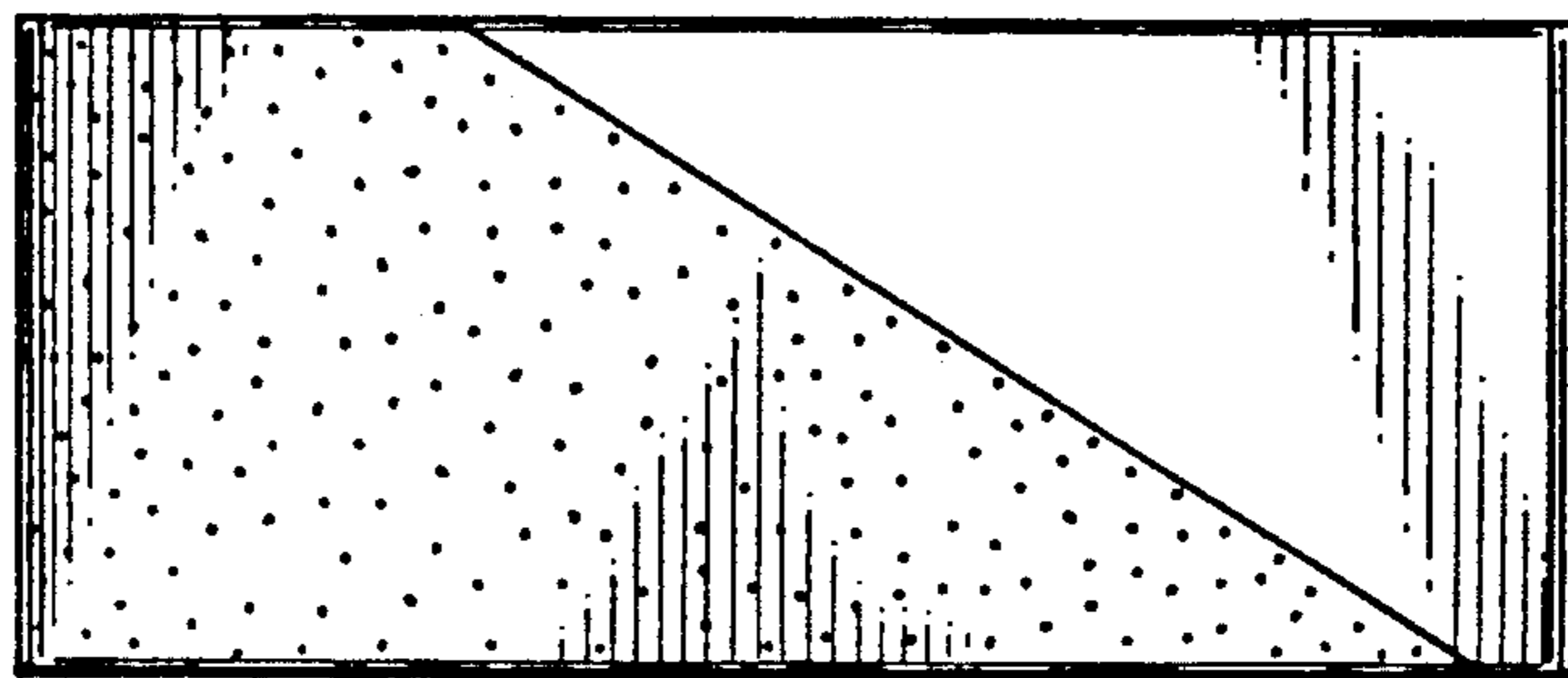

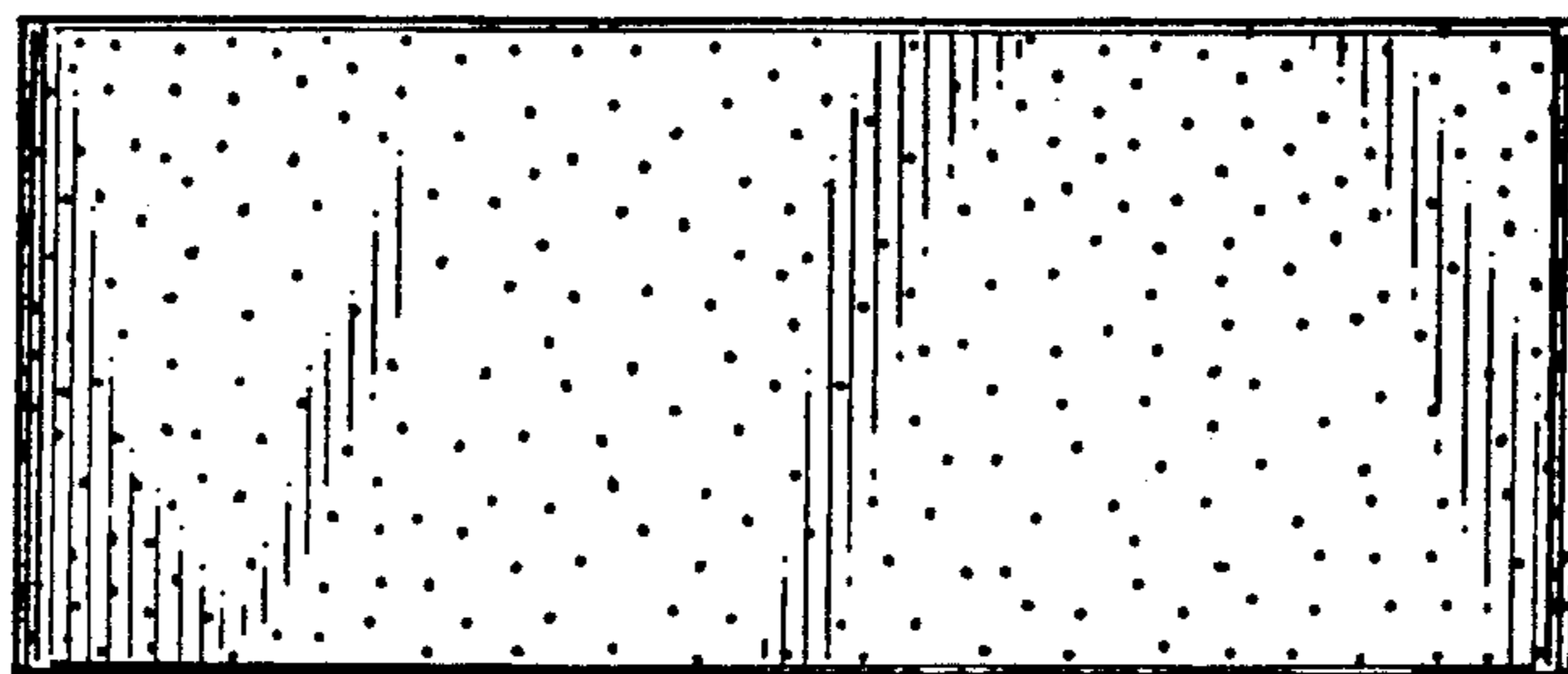

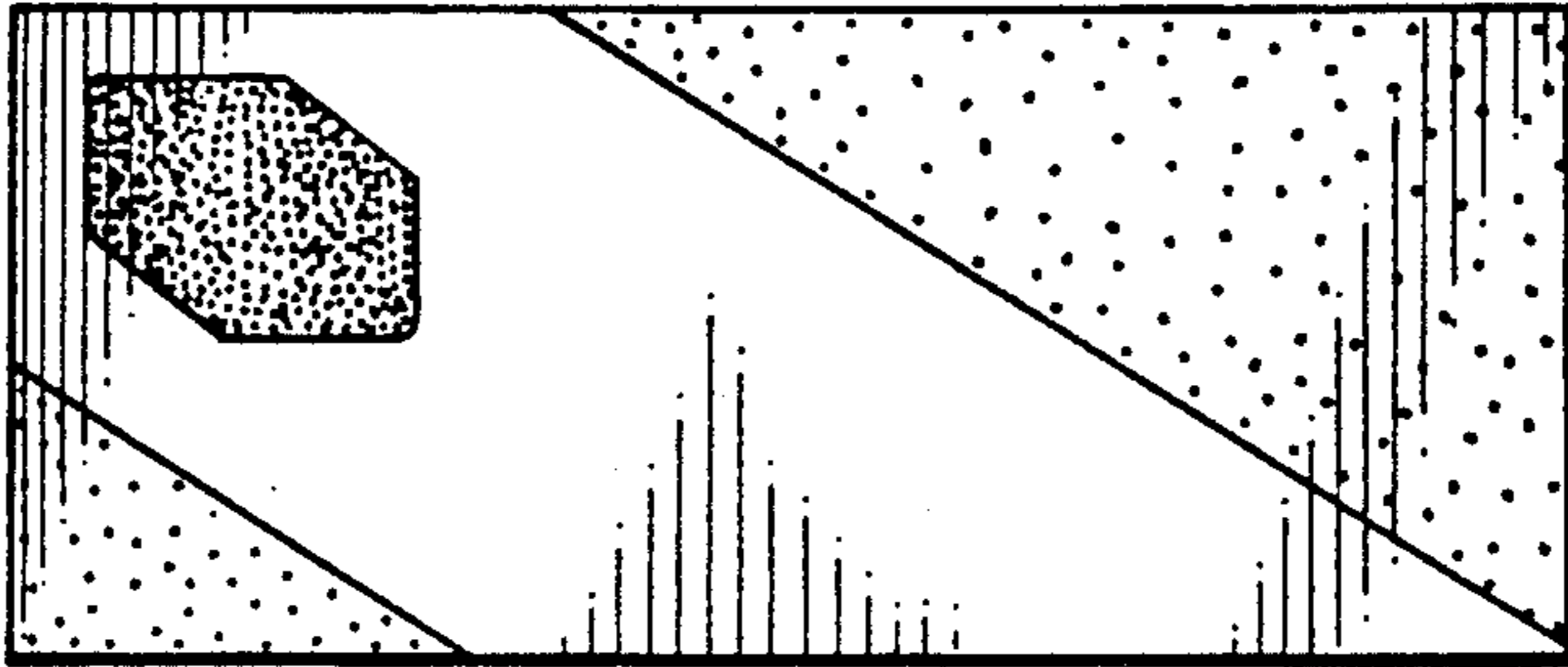

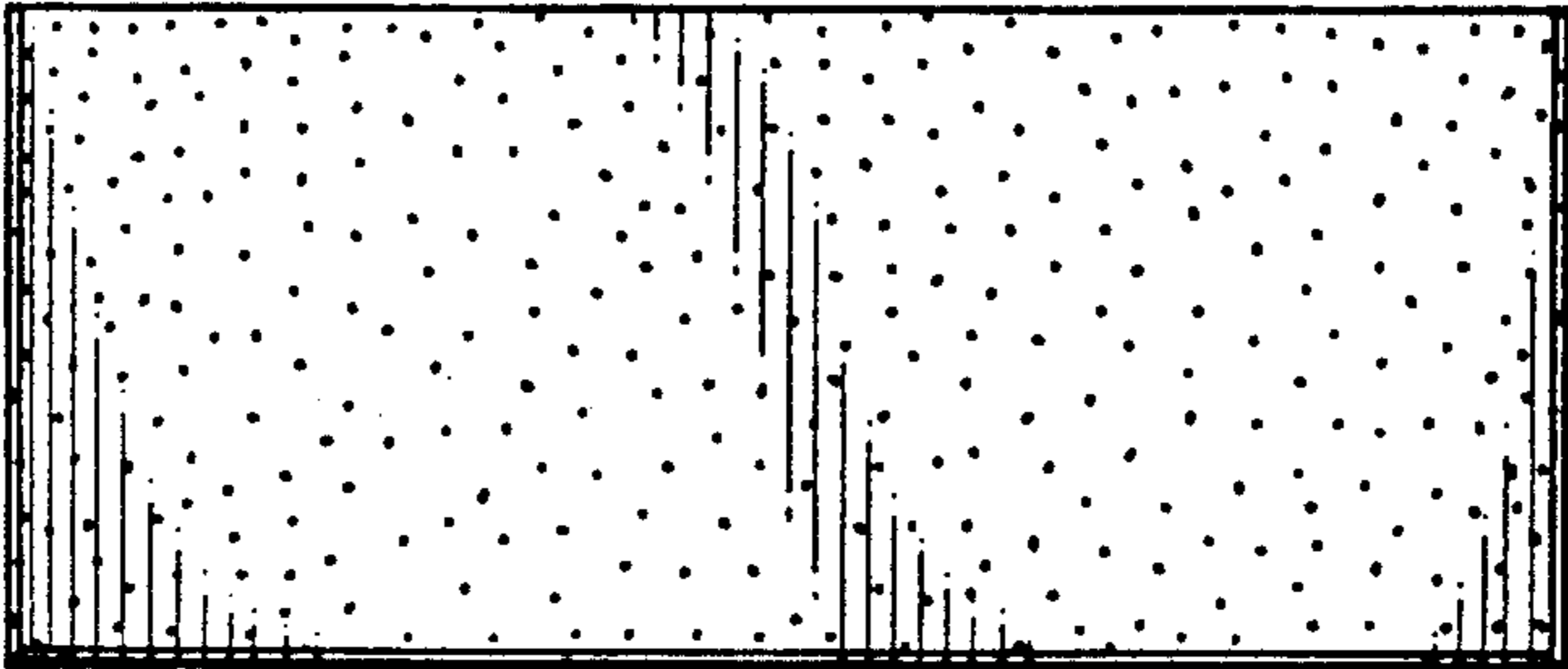

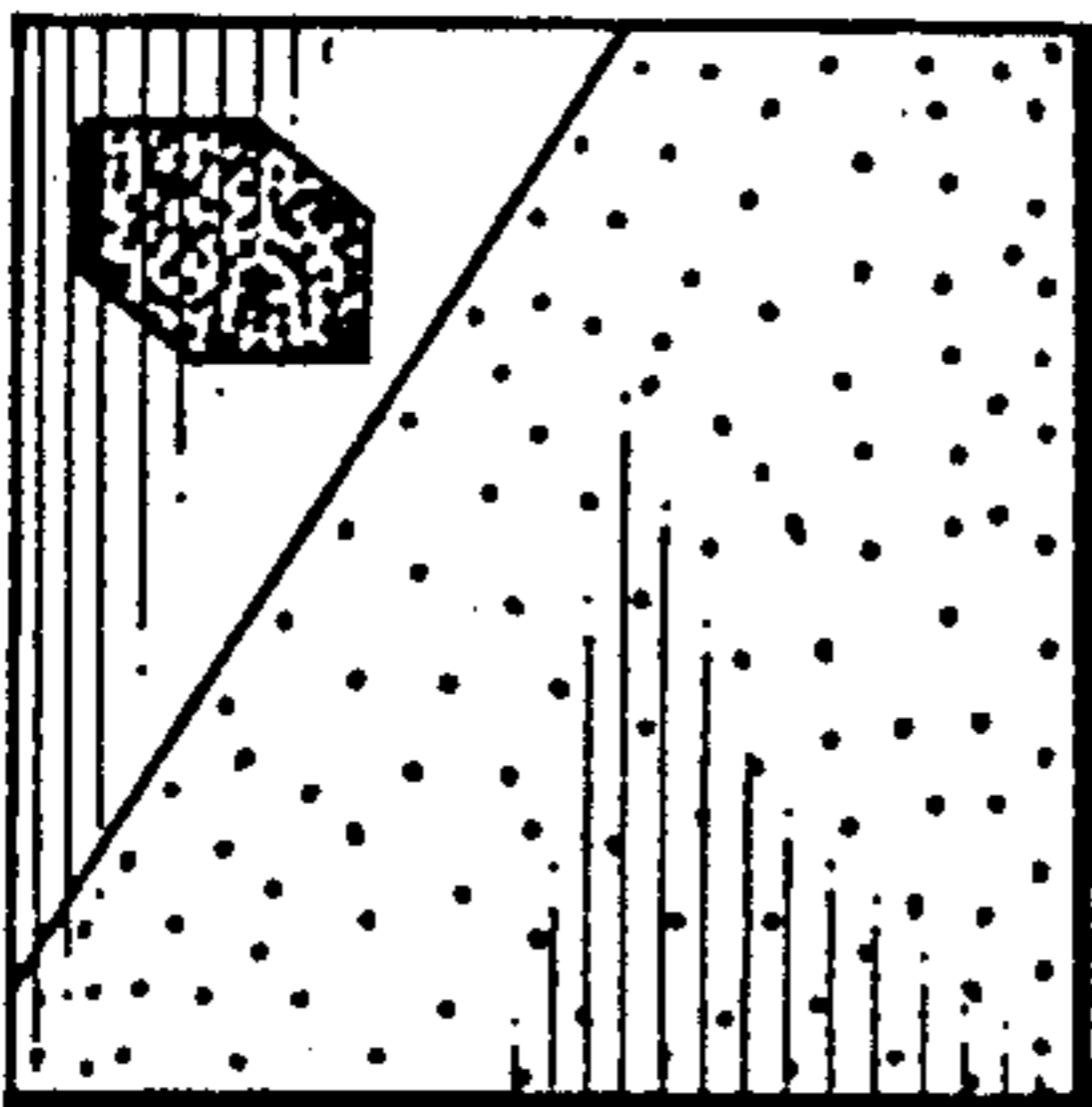

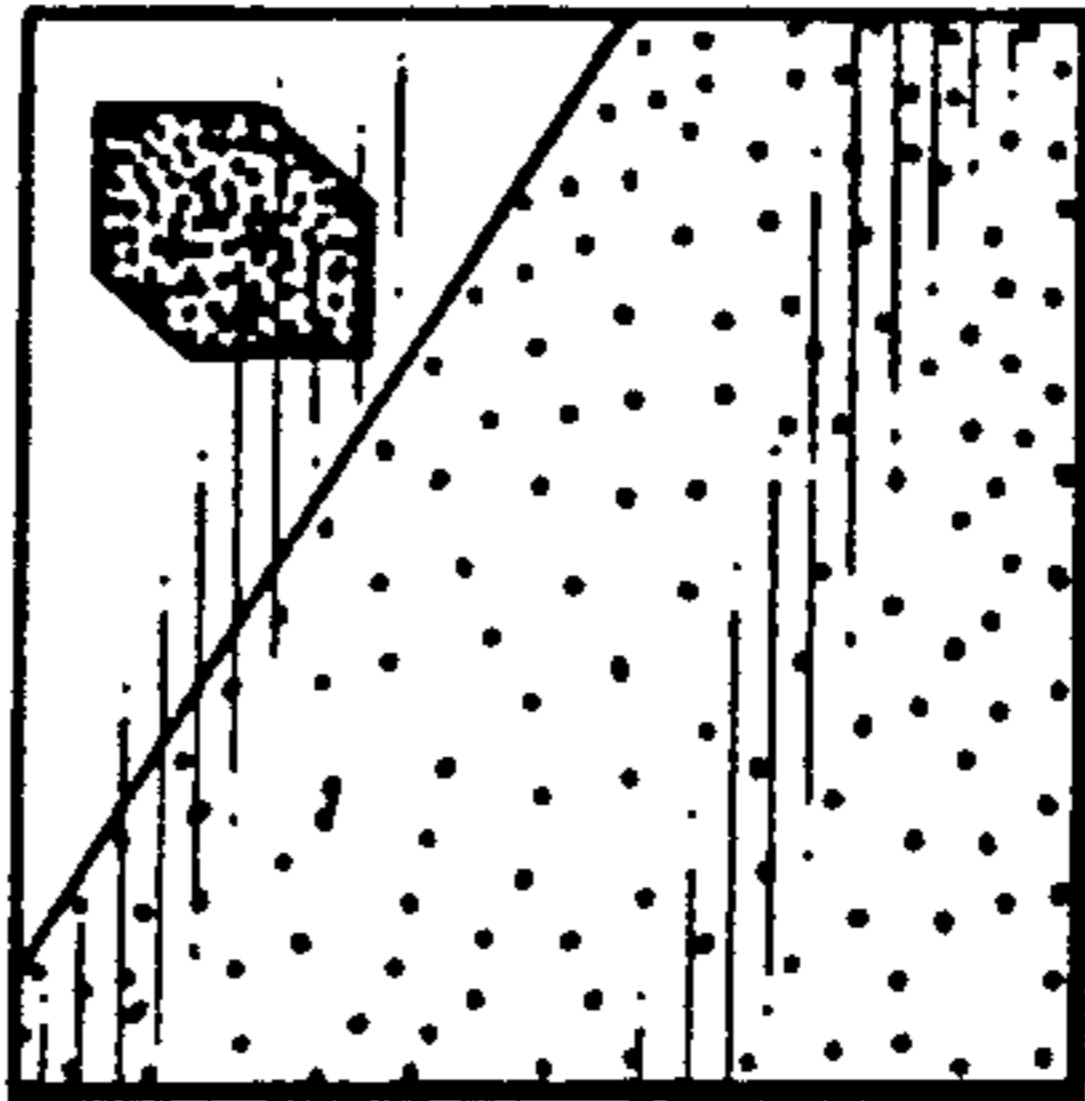

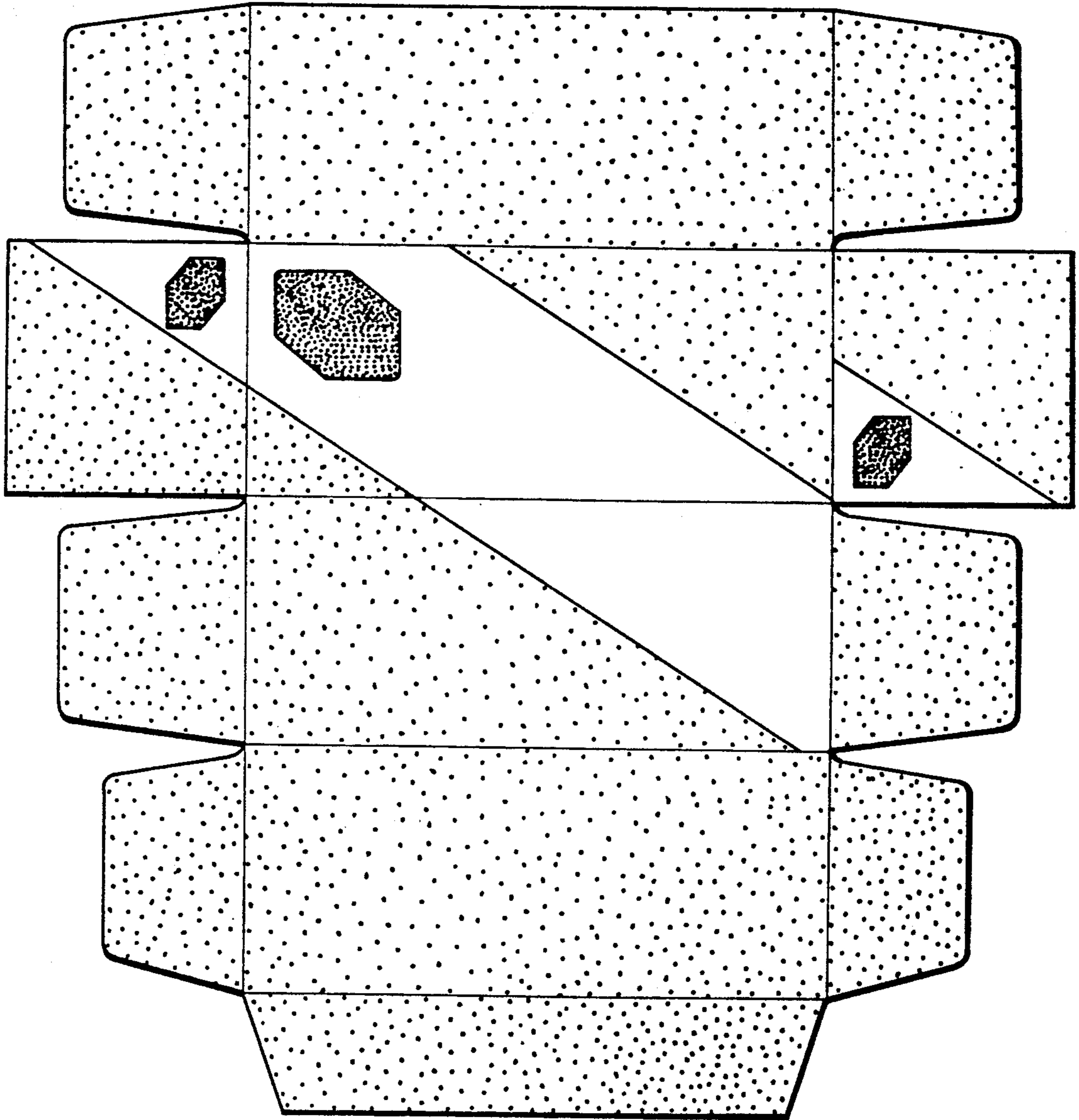

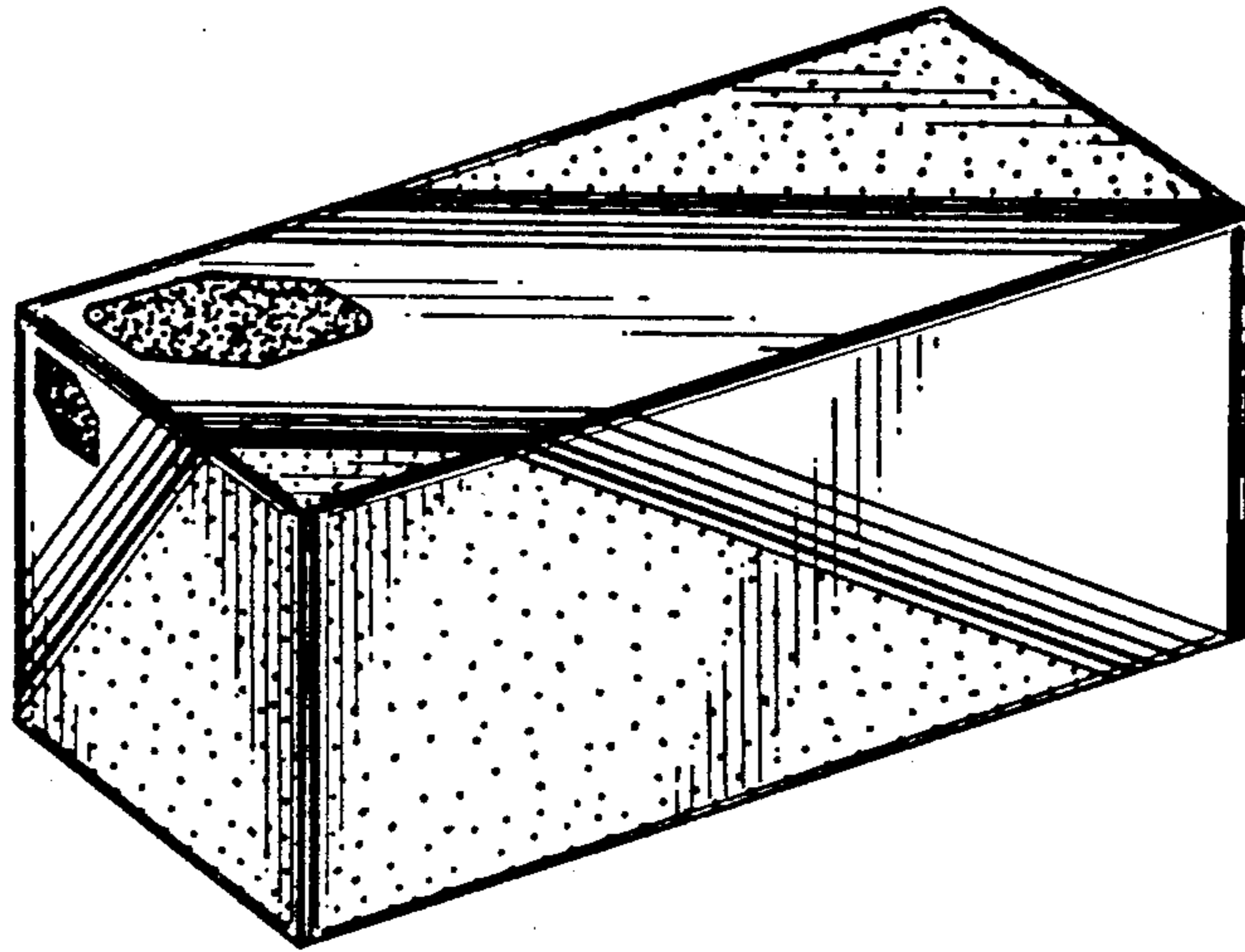

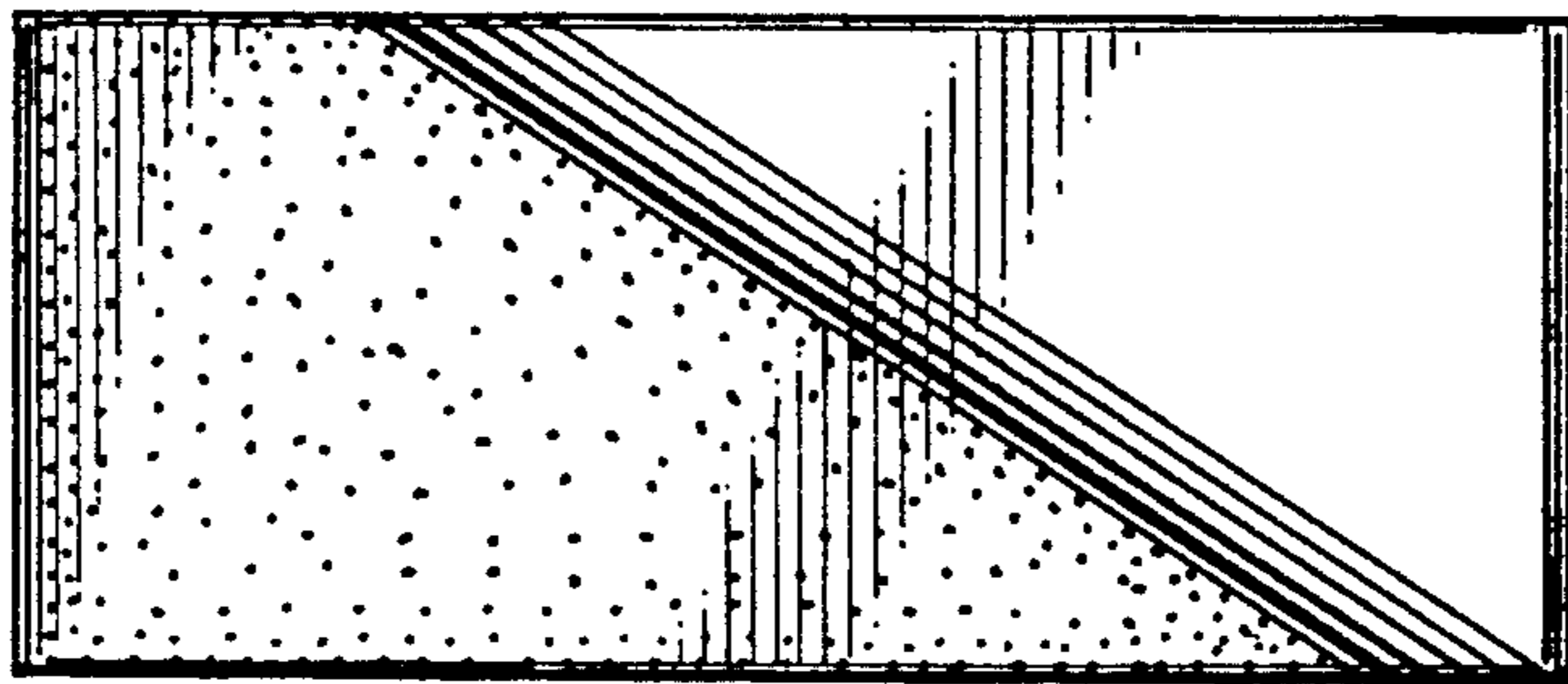

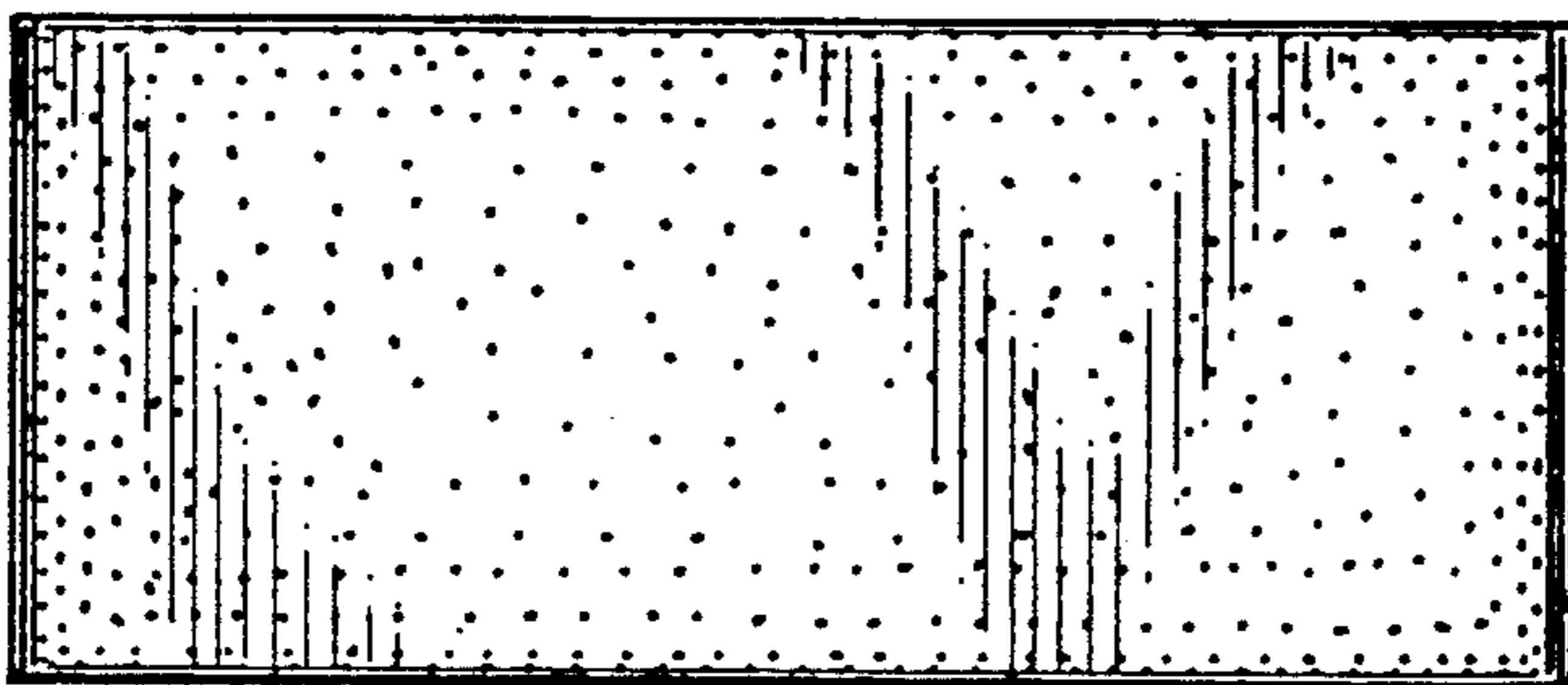

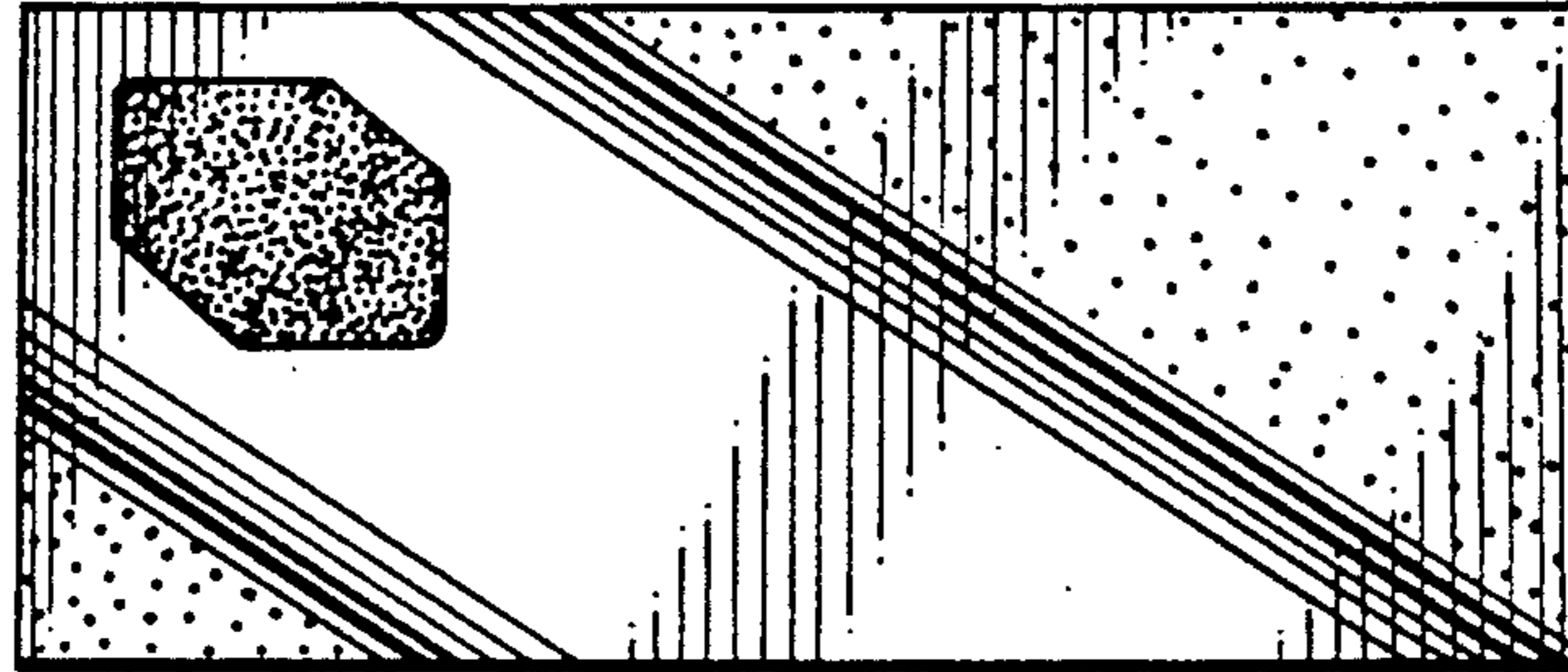

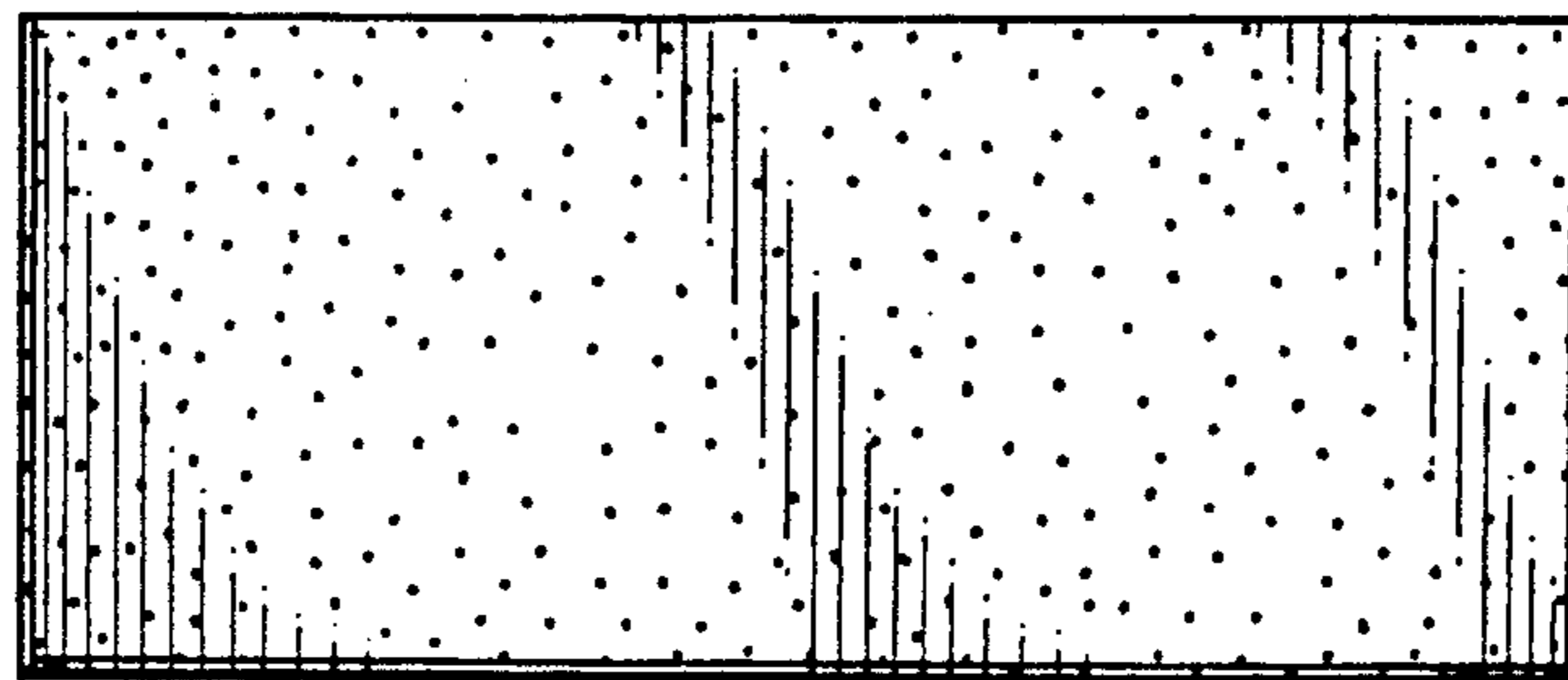

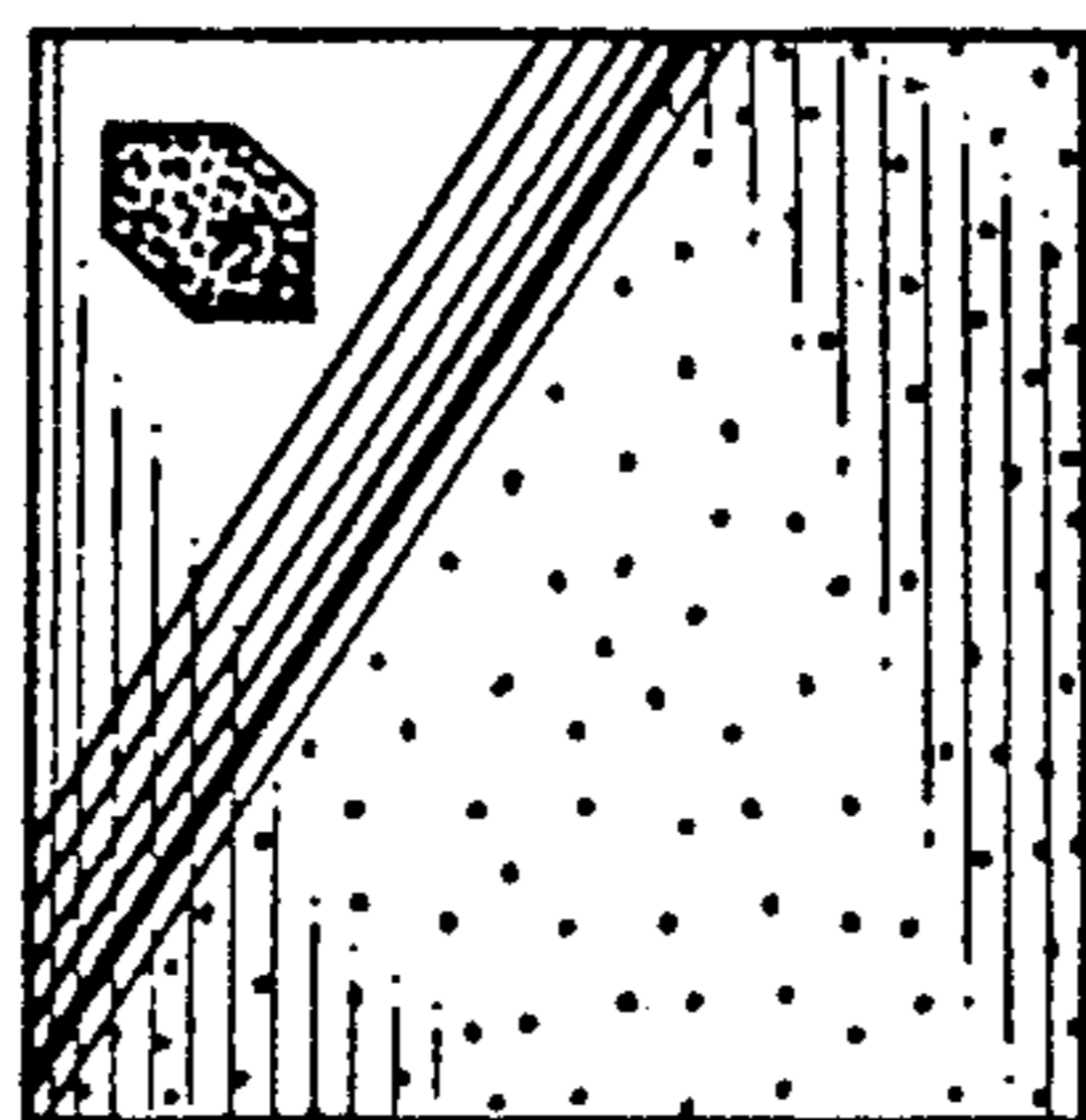

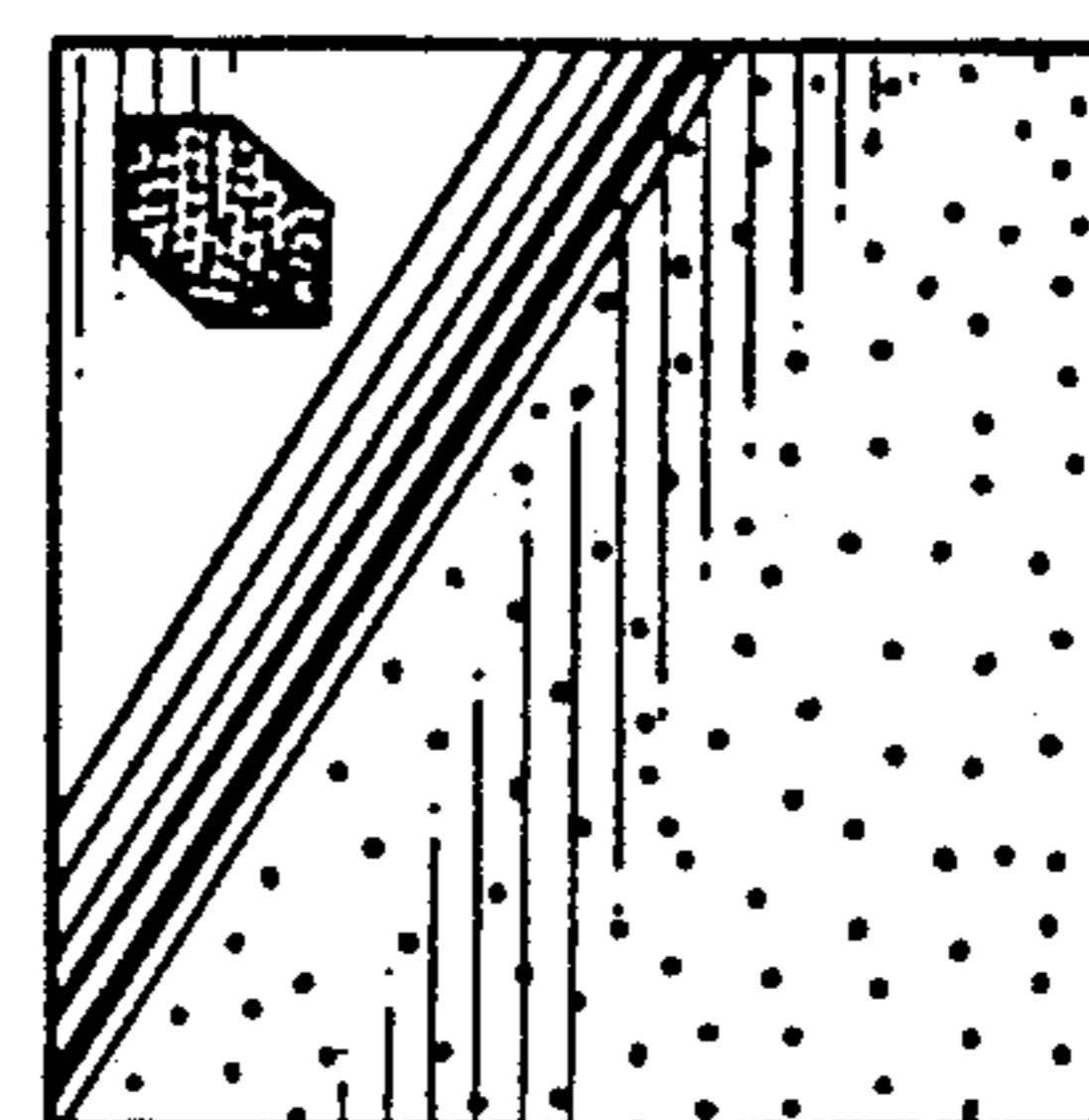
