[57] **CLAIM**

The ornamental design for a golf club head, as shown and described.

### DESCRIPTION

FIG. 1 is a rear elevational view of a golf club head showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a toe end view thereof;

FIG. 4 is a bottom plan view thereof taken along the line 4—4 of FIG. 3;

FIG. 5 is a sectional view taken along the line 5—5 of FIG. 2;

FIG. 6 is a sectional view taken along the line 6—6 of FIG. 2; and

FIG. 7 is a sectional view taken along the line 7—7 of FIG. 2.
