The ornamental design for a clip-on purse, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a clip-on purse showing my new design in open position;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof in closed position;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a rear elevation view thereof;
FIG. 6 is a front elevational view thereof in open position; and
FIG. 7 is a right side elevational view thereof.

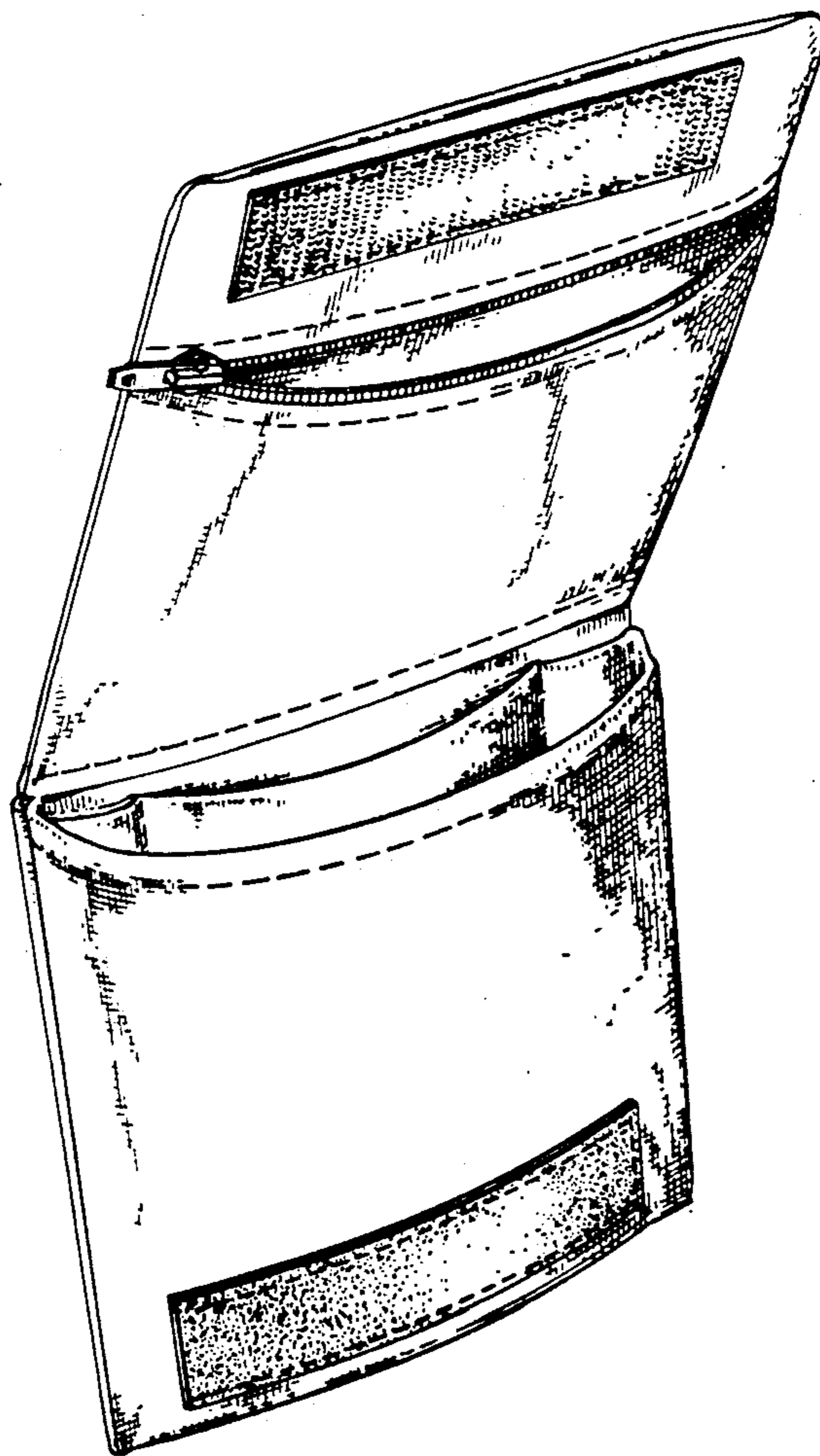

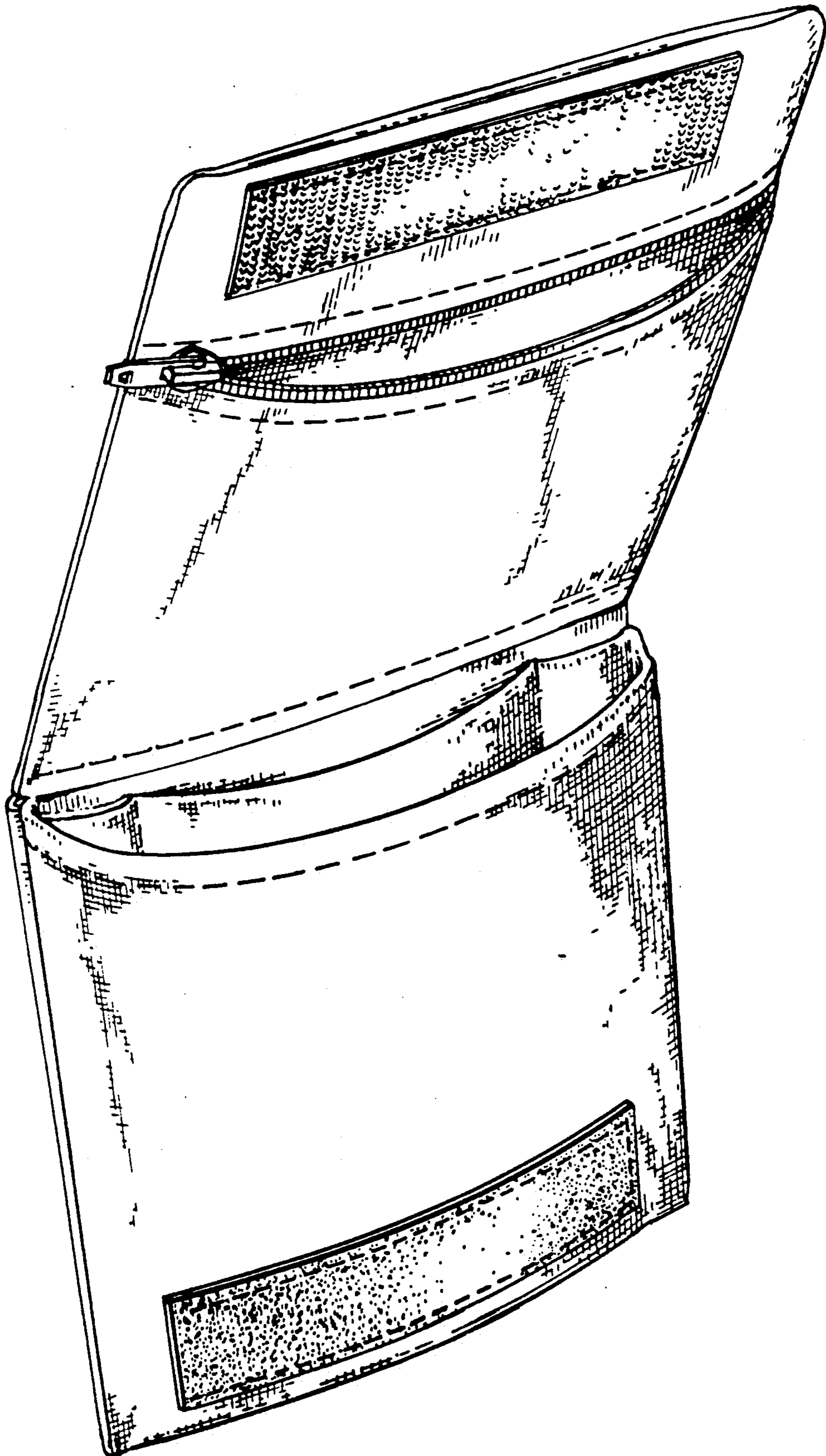

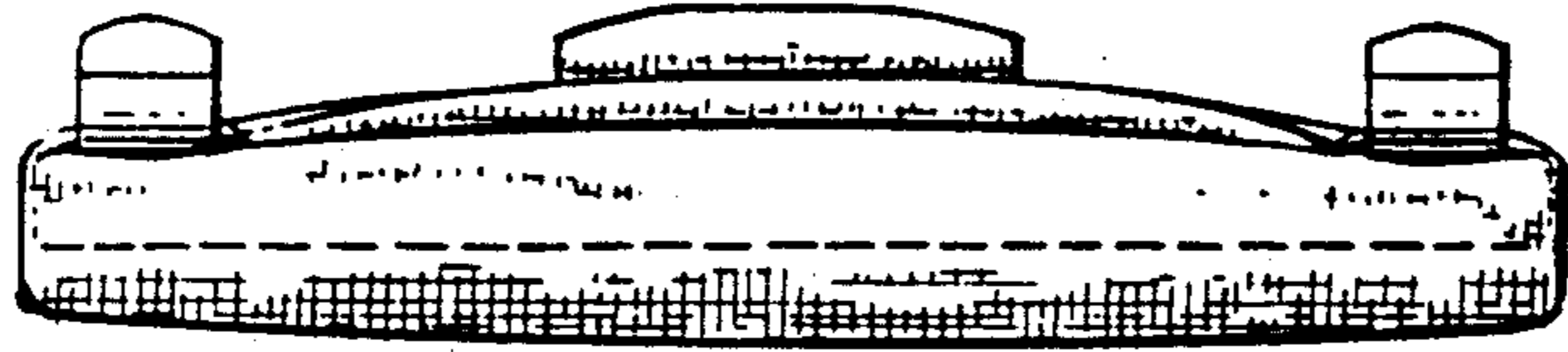

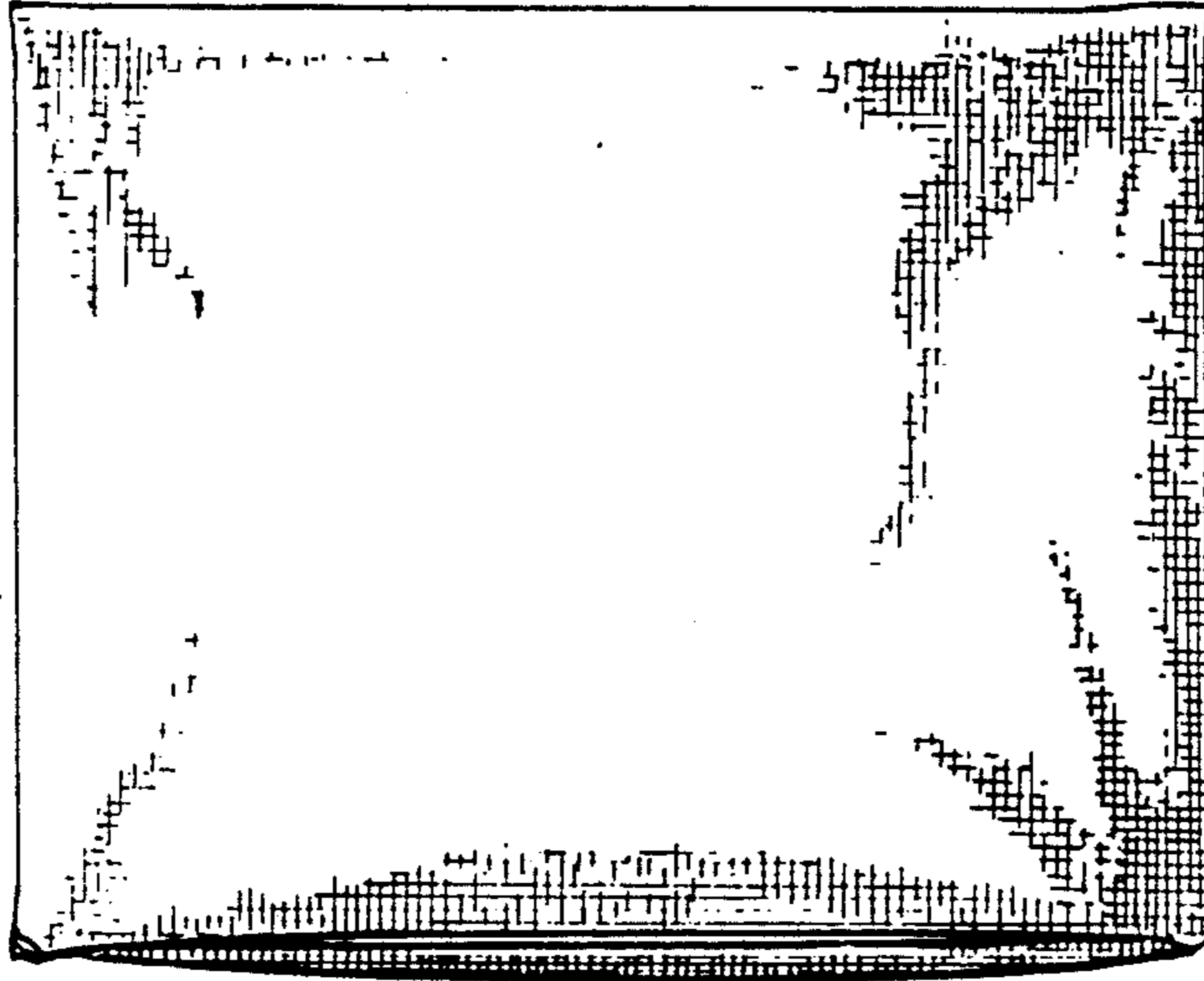

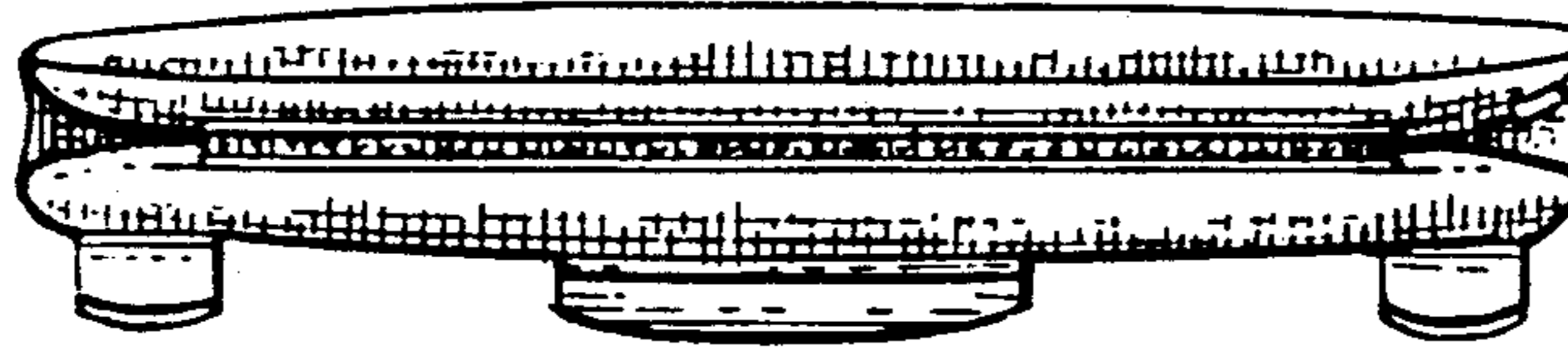

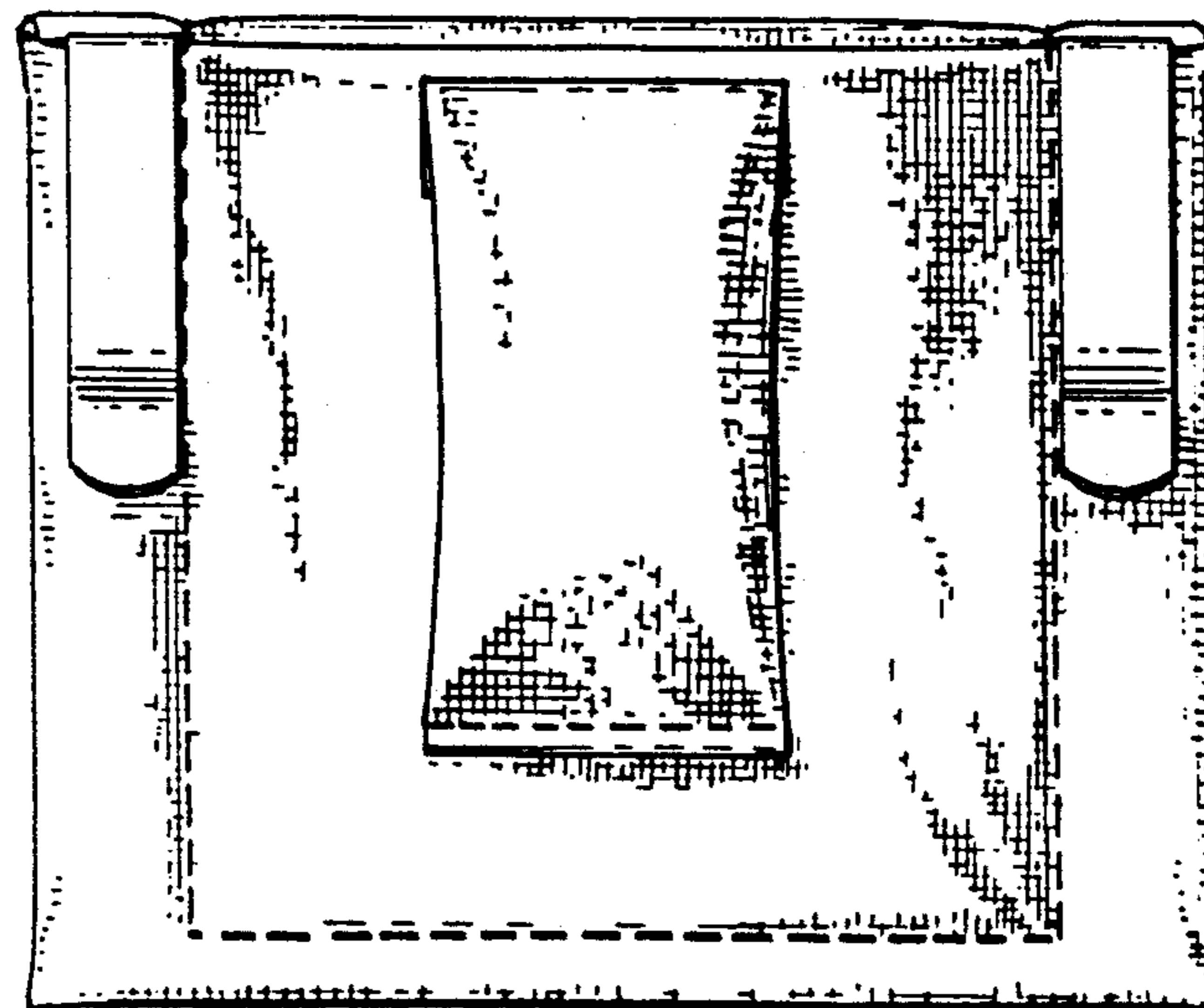

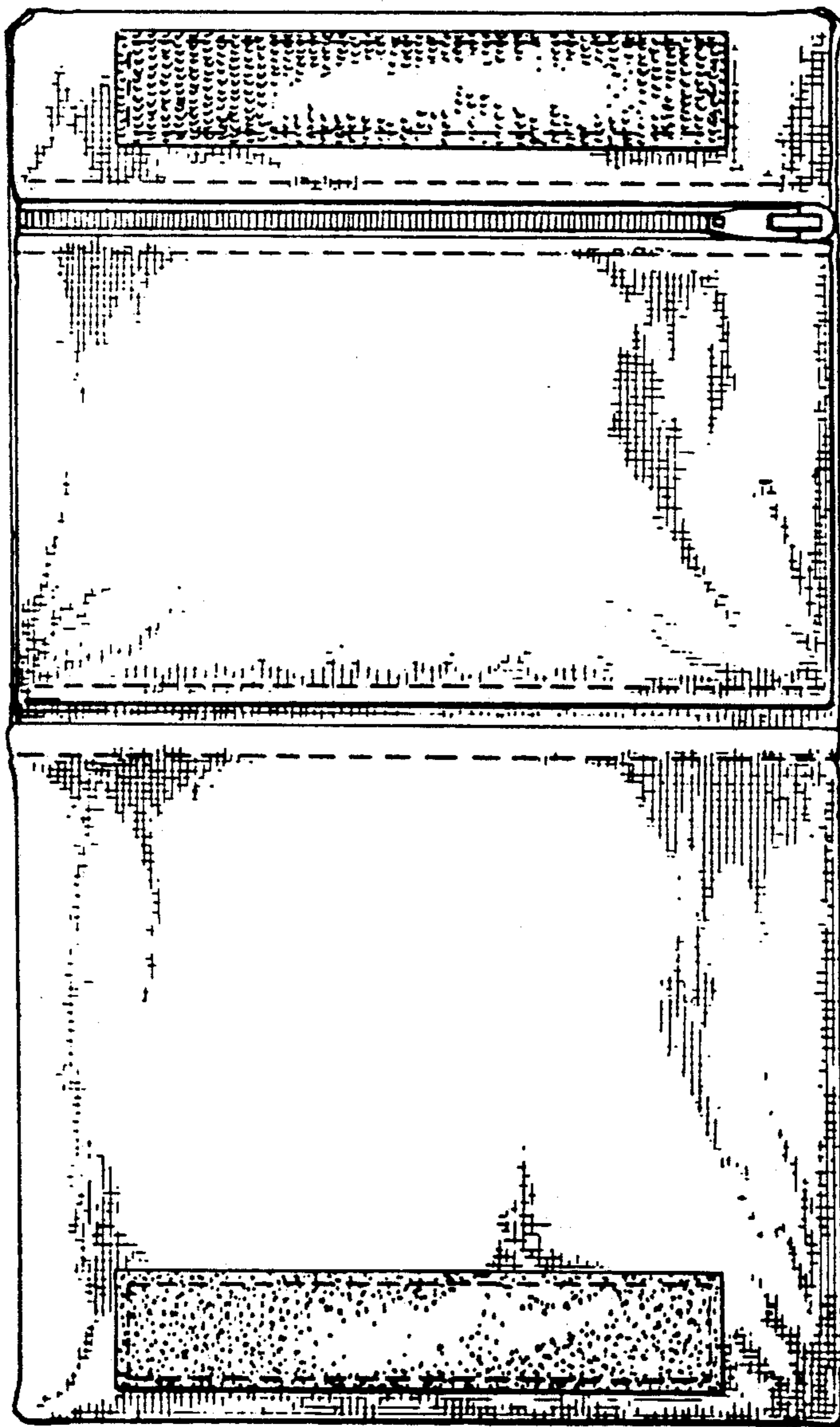
