[57] **CLAIM**

The ornamental design for a headphone support stand, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and right side perspective view of a headphone support stand showing my new design; FIG. 2 is a rear perspective view, the headphone set and associated electrical chord being shown in broken lines for illustrative purposes only; FIG. 3 is a left side elevational view; FIG. 4 is a front elevational view; FIG. 5 is a rear elevational view; FIG. 6 is a top plan view; and FIG. 7 is a bottom plan view thereof. FIGS. 2-7 have been shown on a reduced scale with respect to FIG. 1.

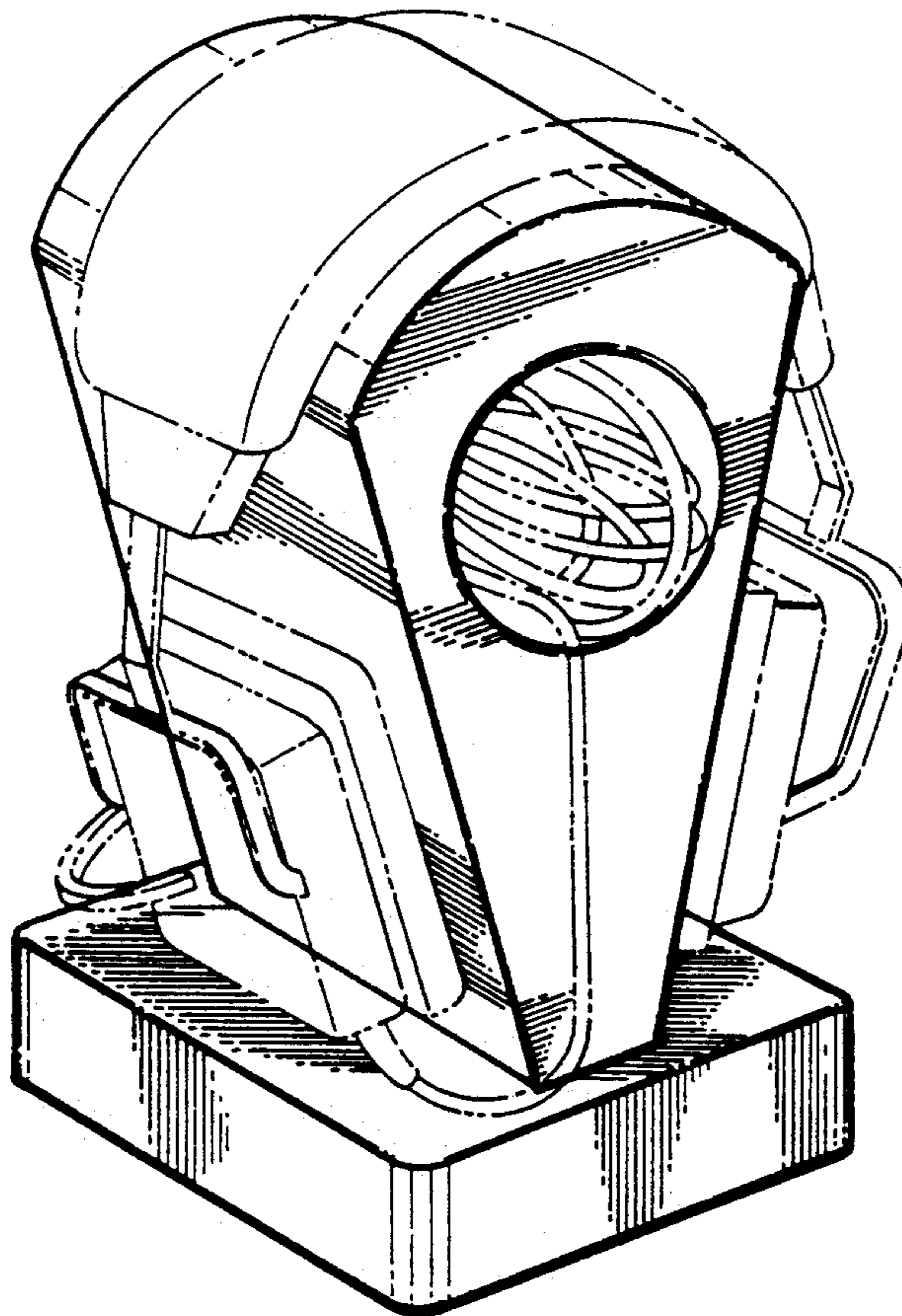
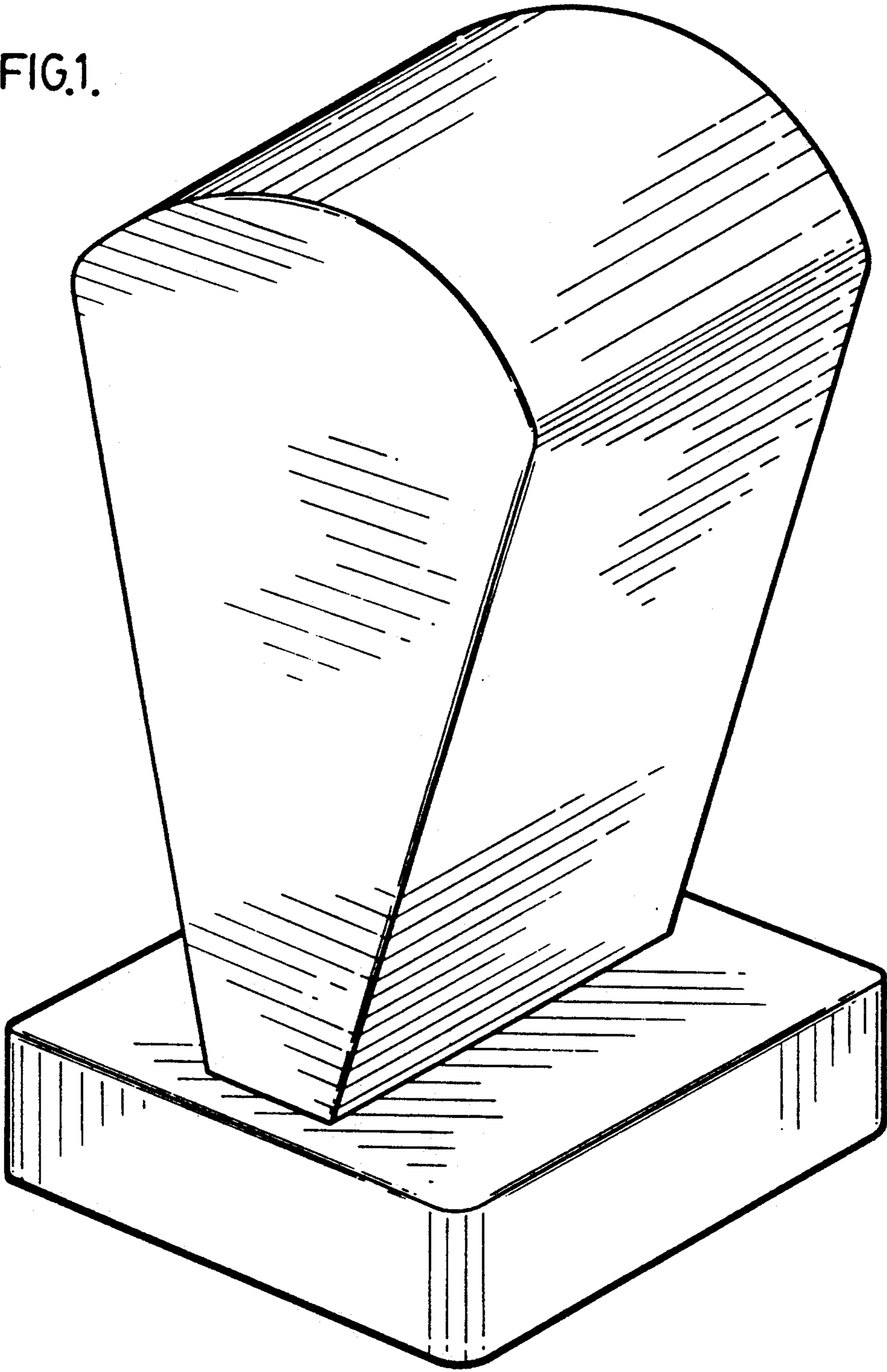

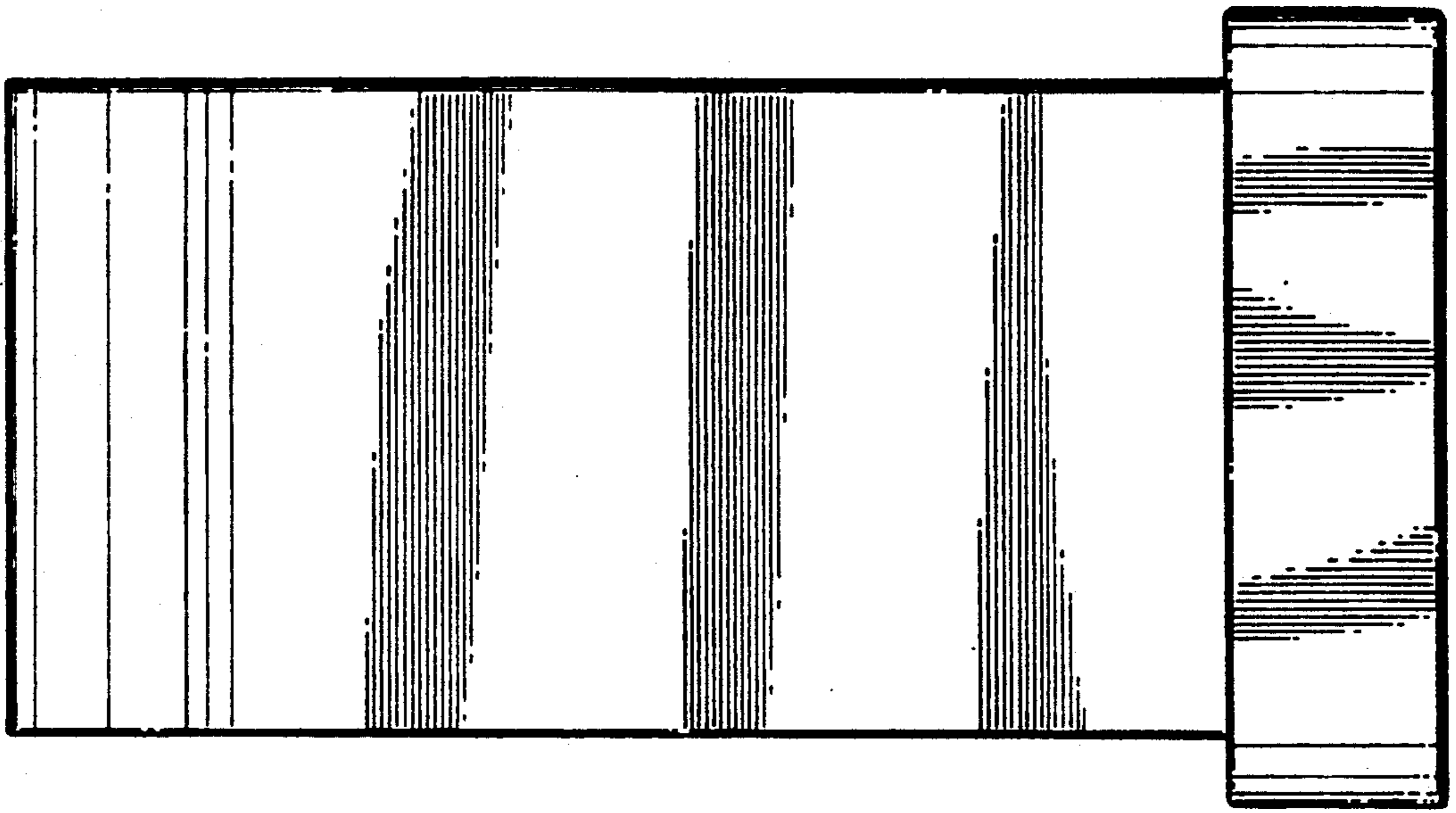

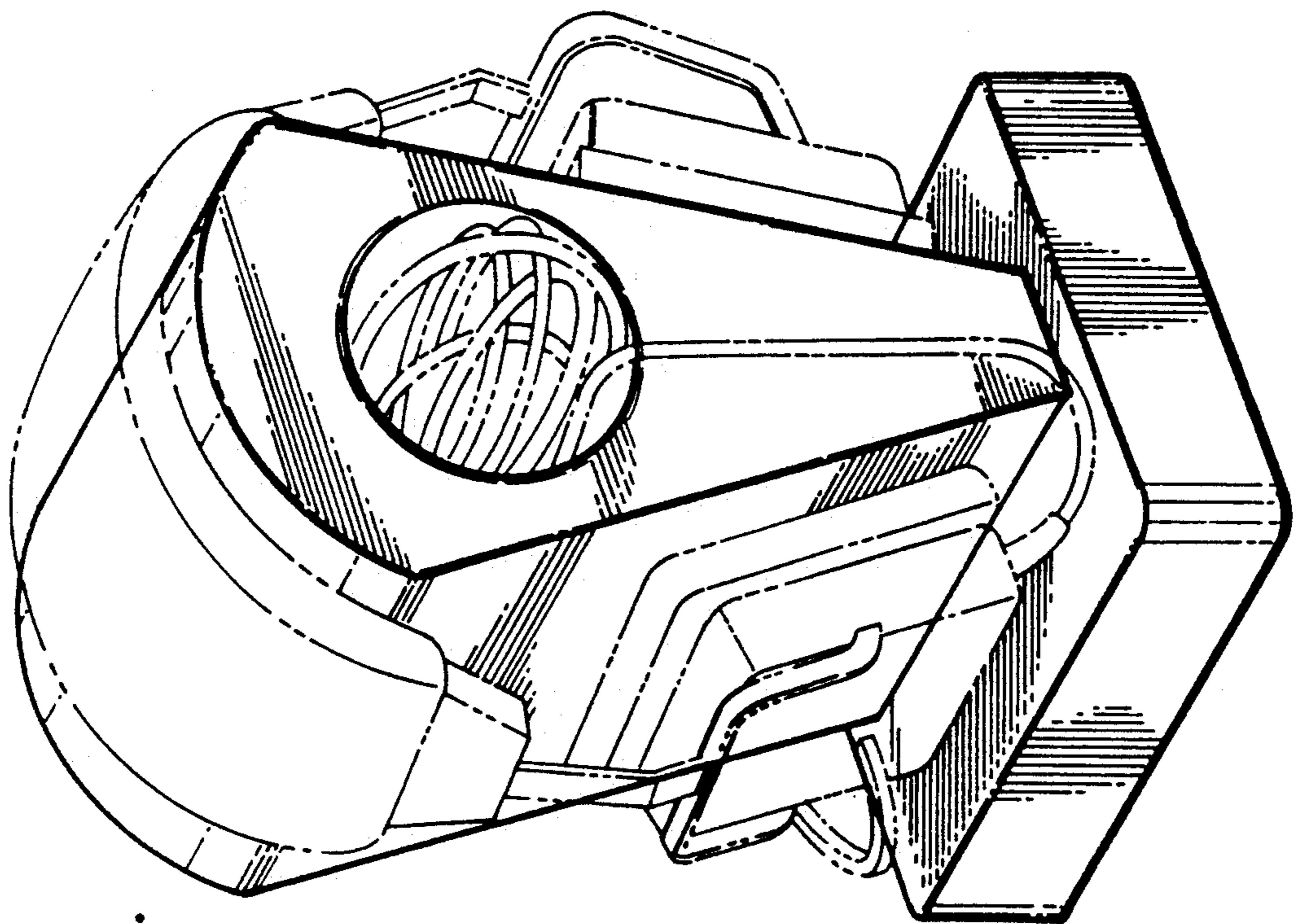

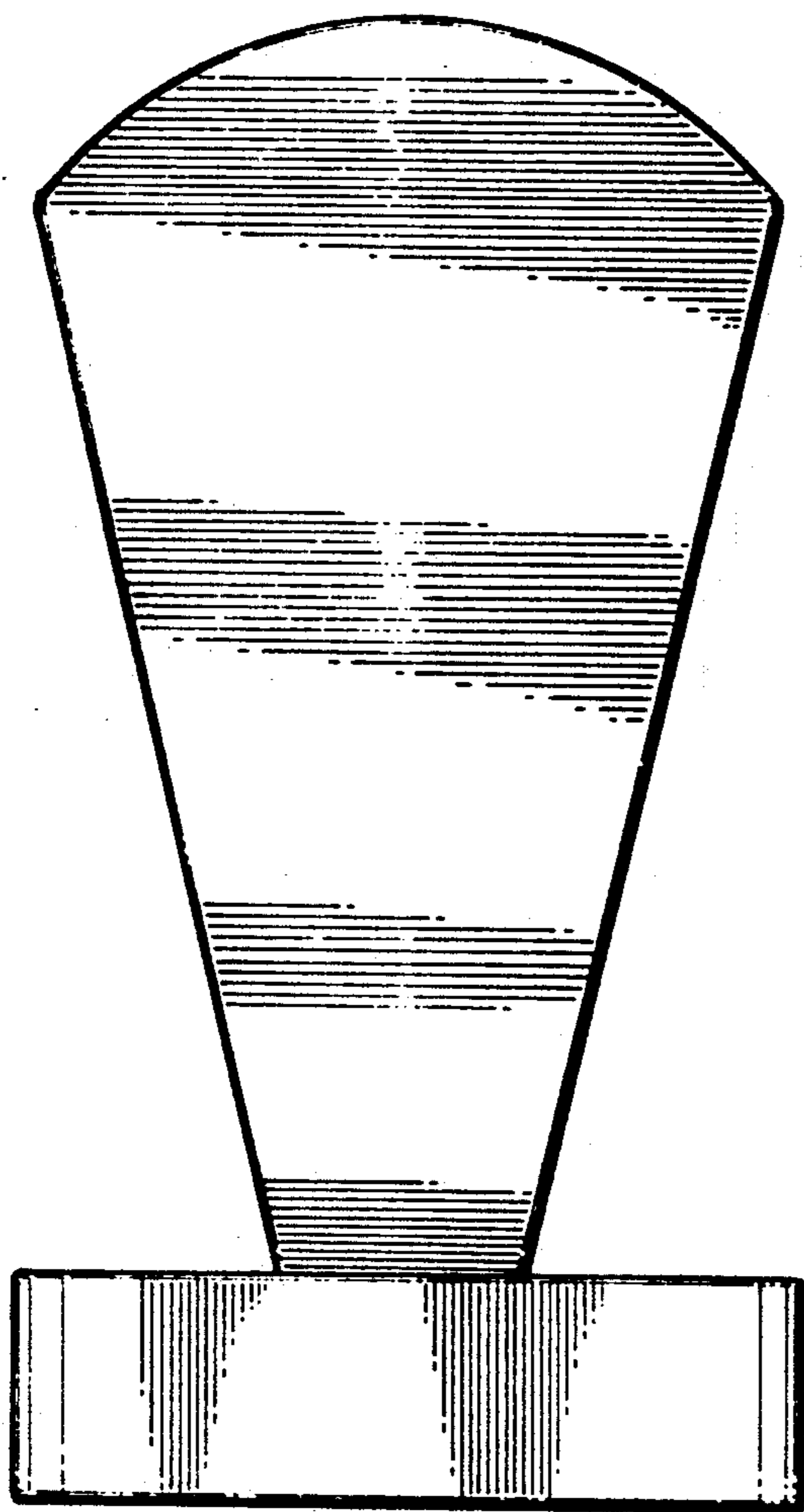

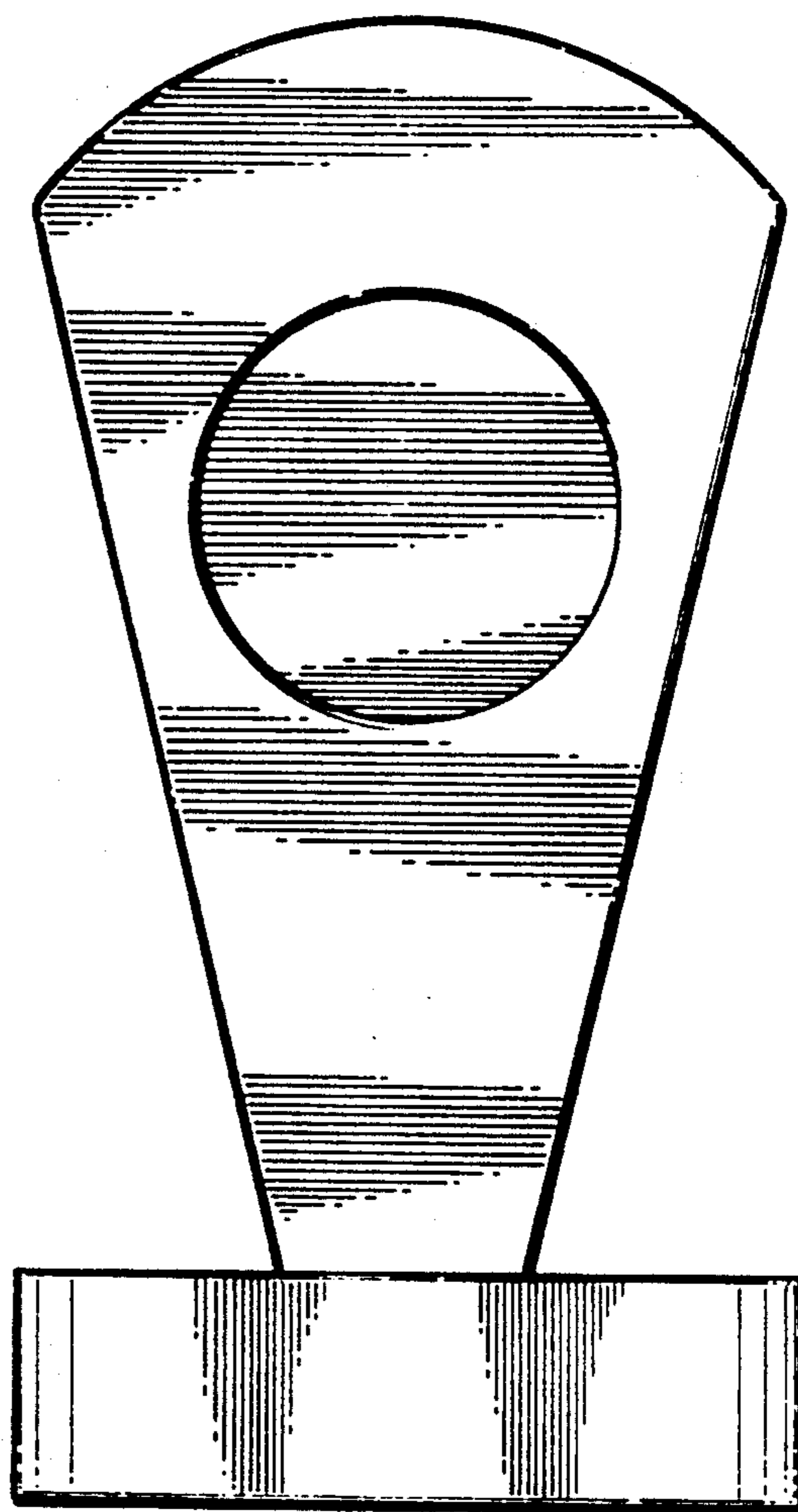

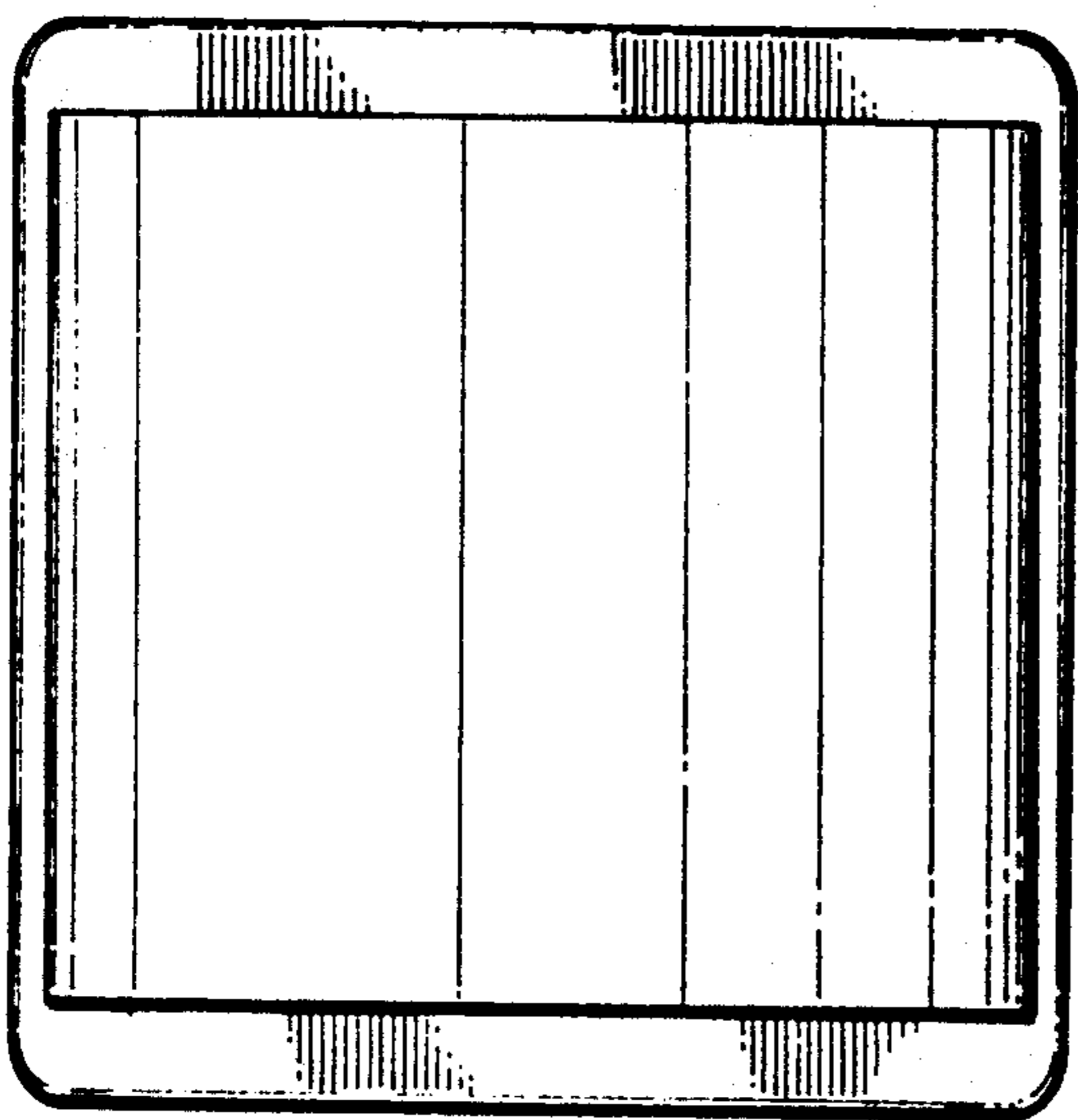
