 FIG. 6 is a top, left front perspective view thereof, drawn to a reduced scale.

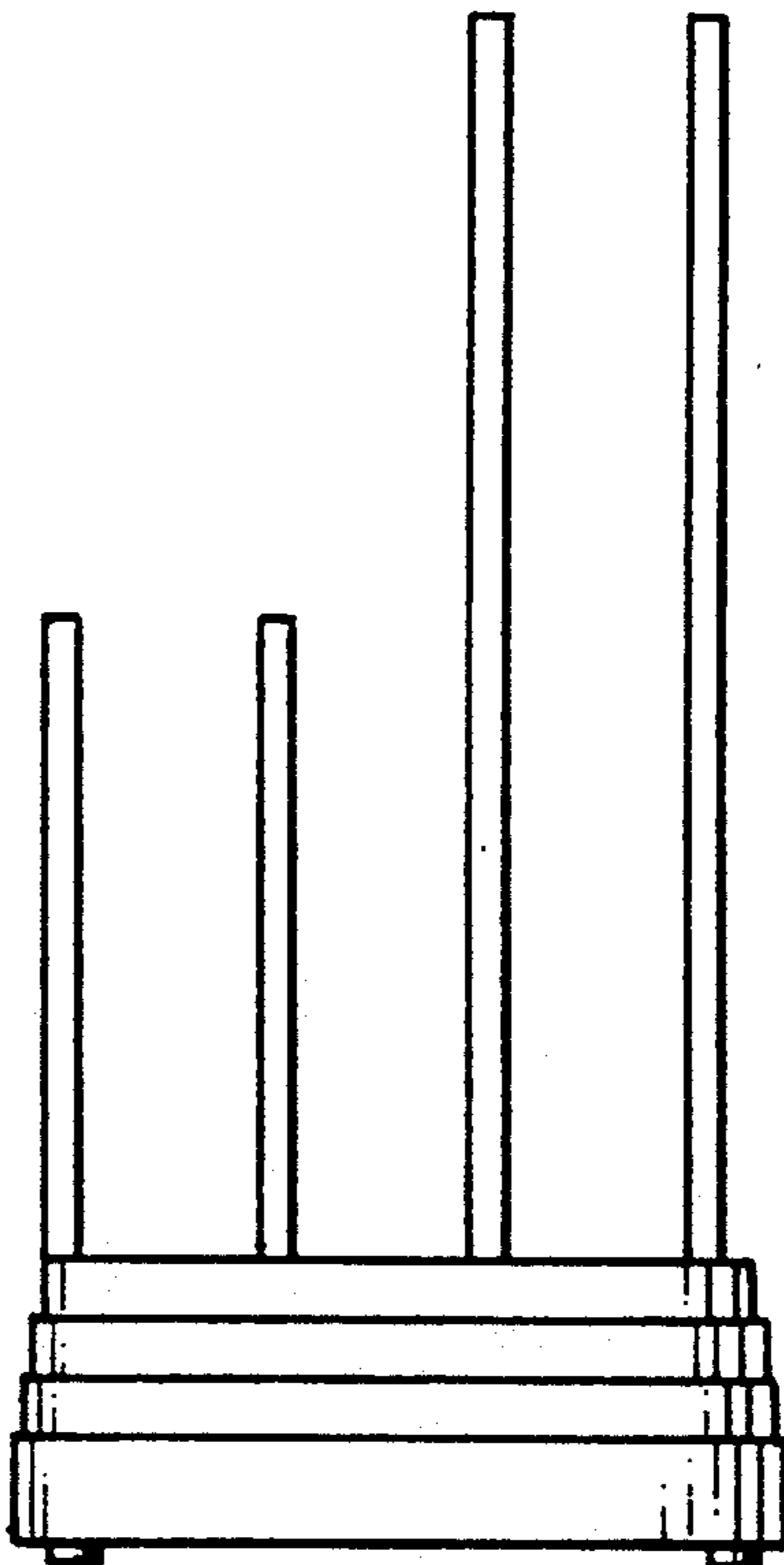

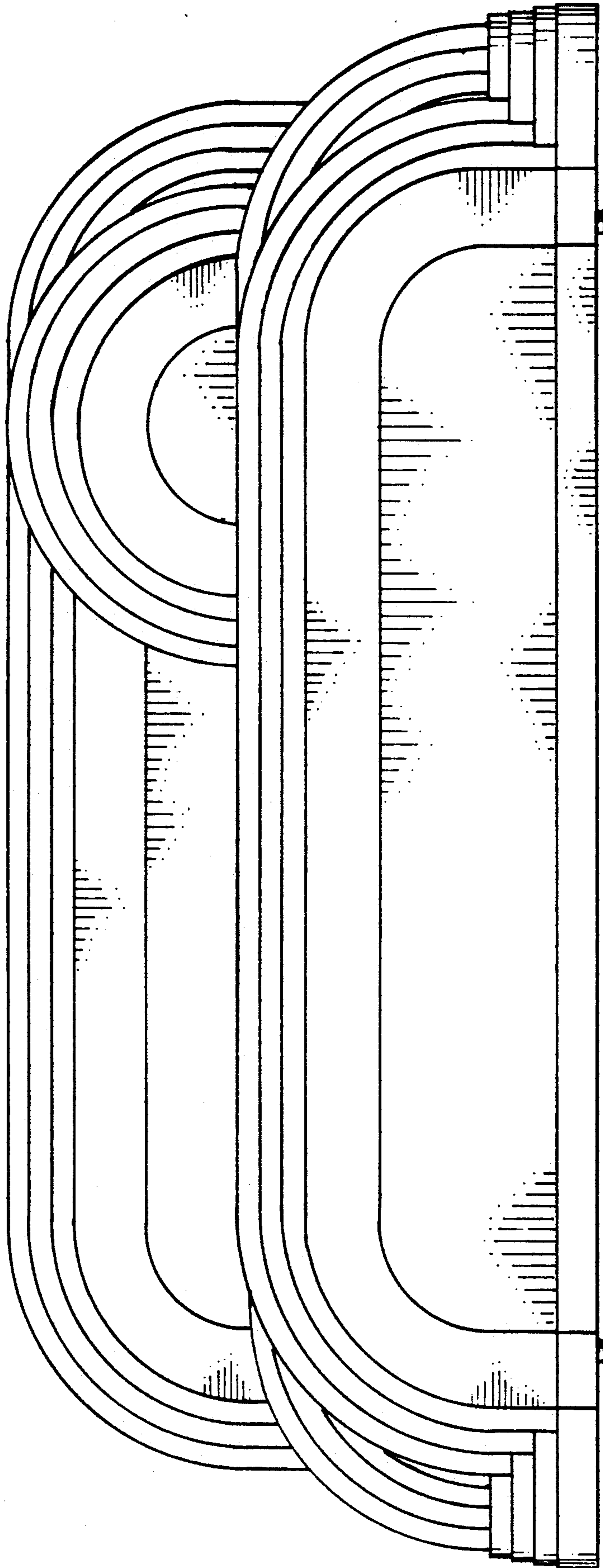

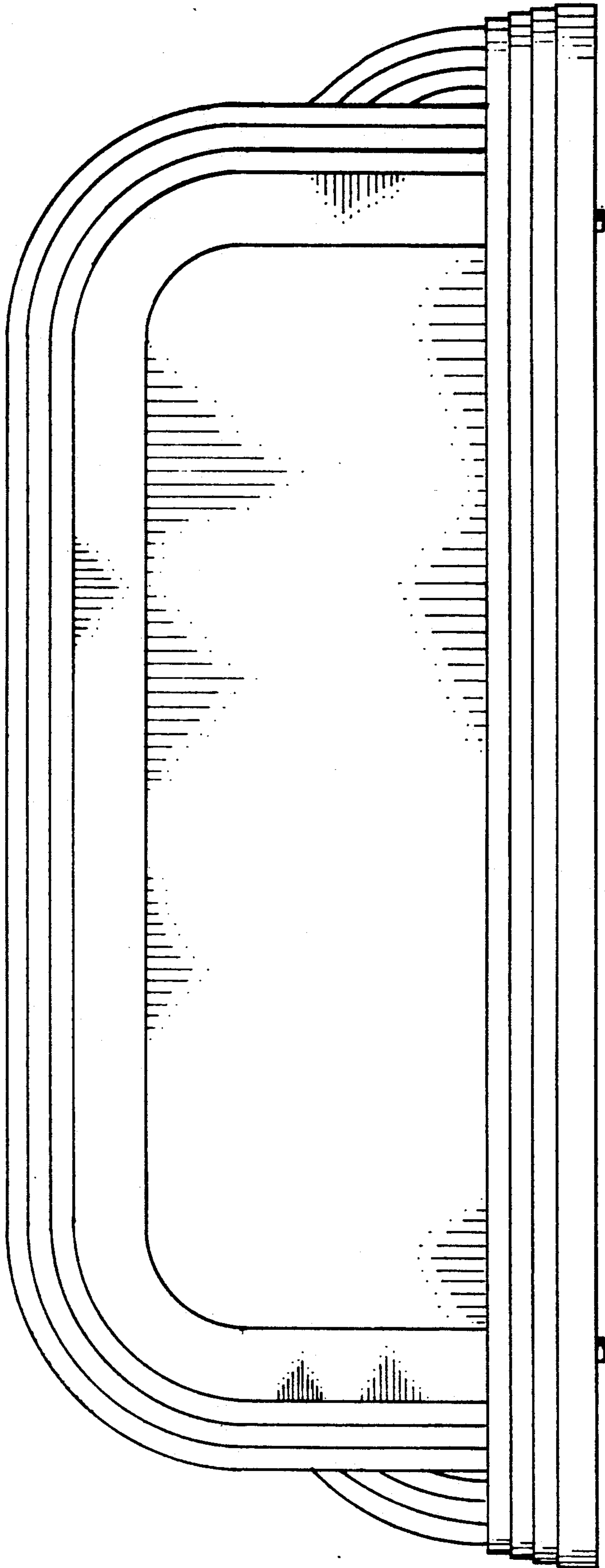

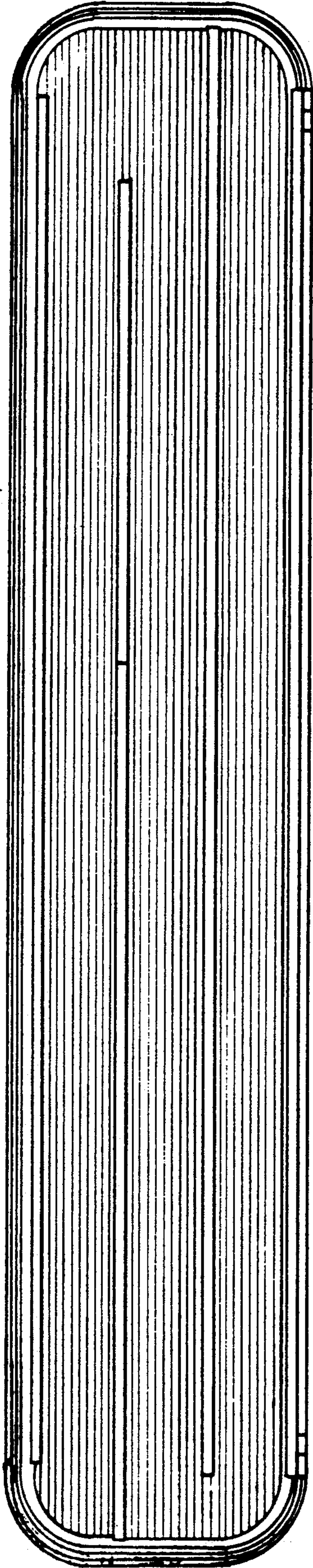

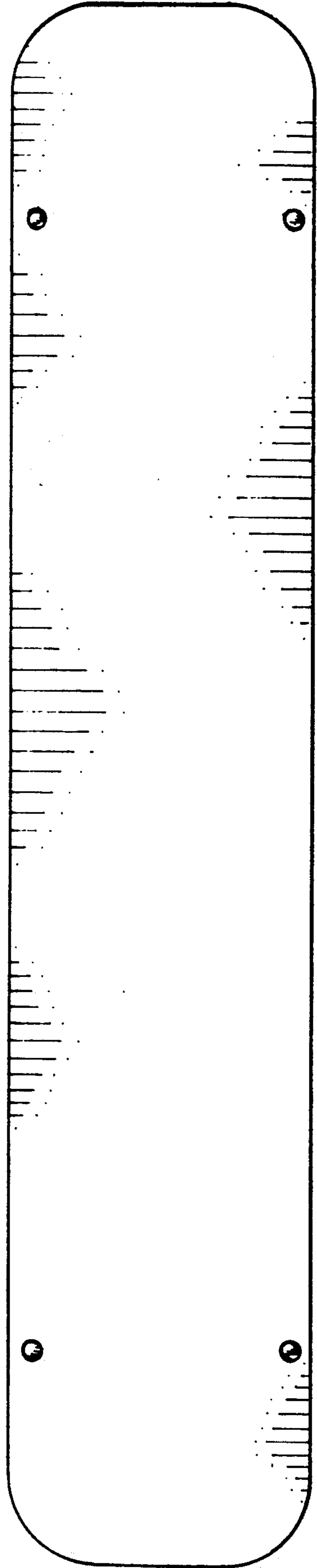

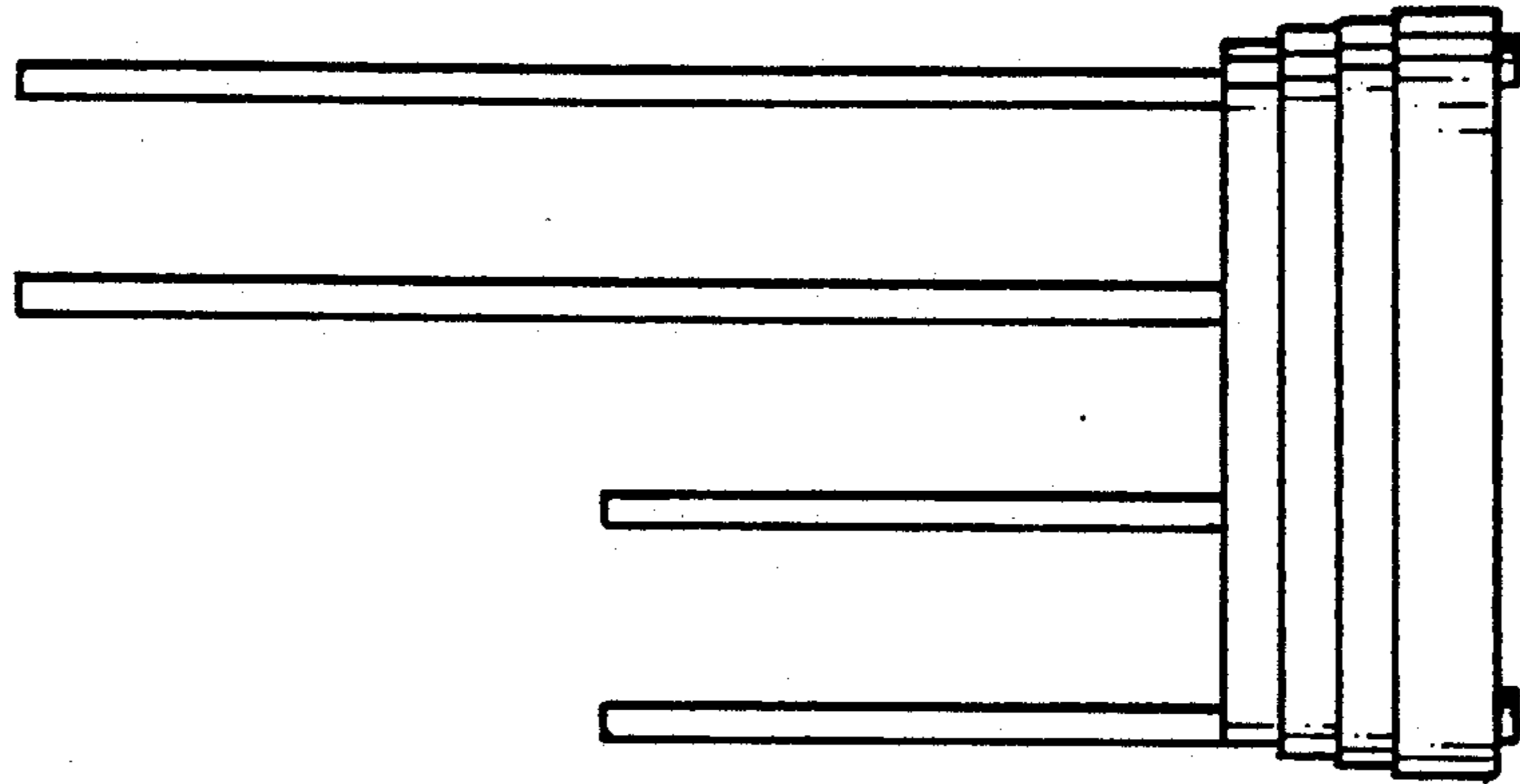
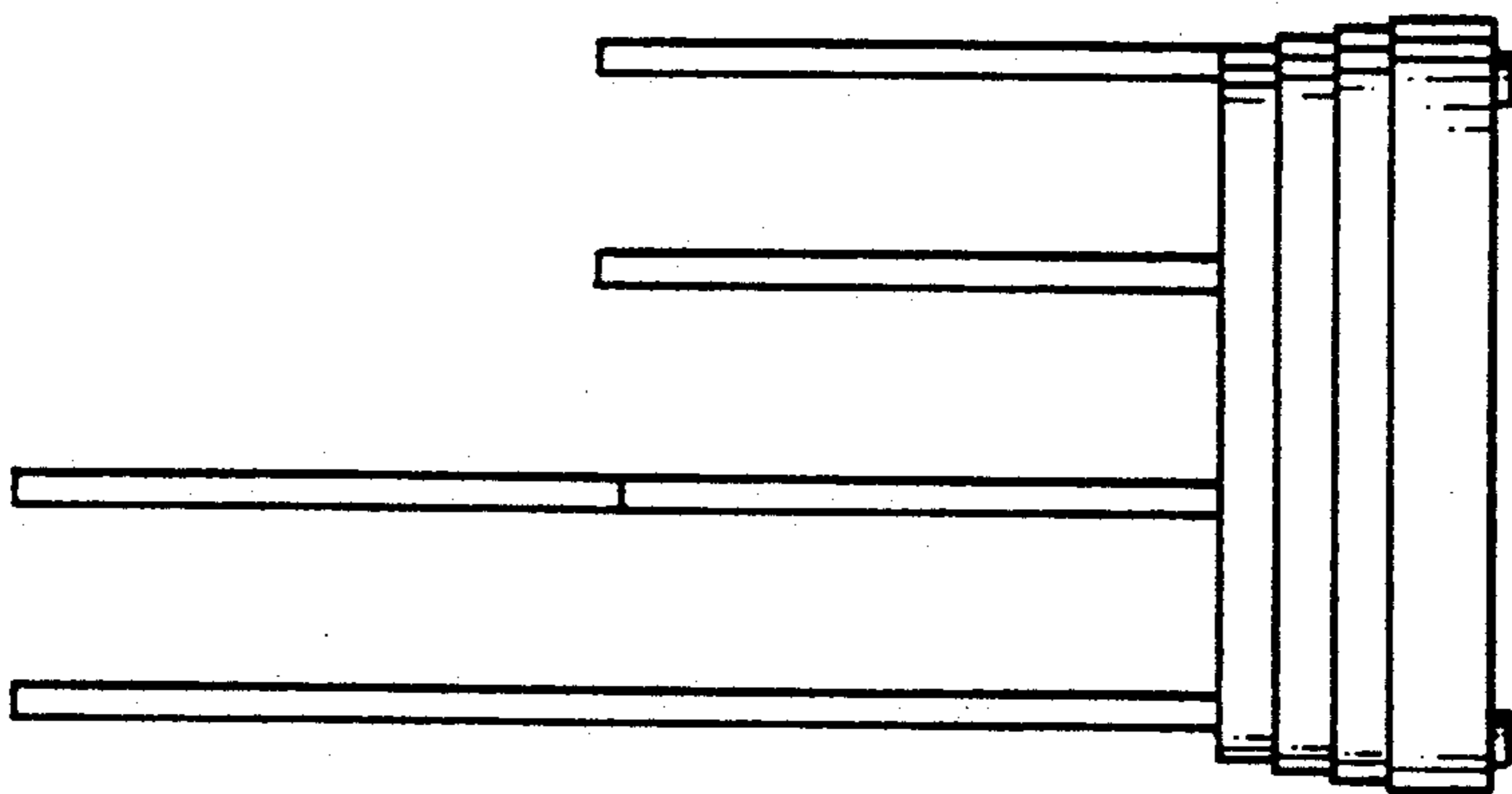

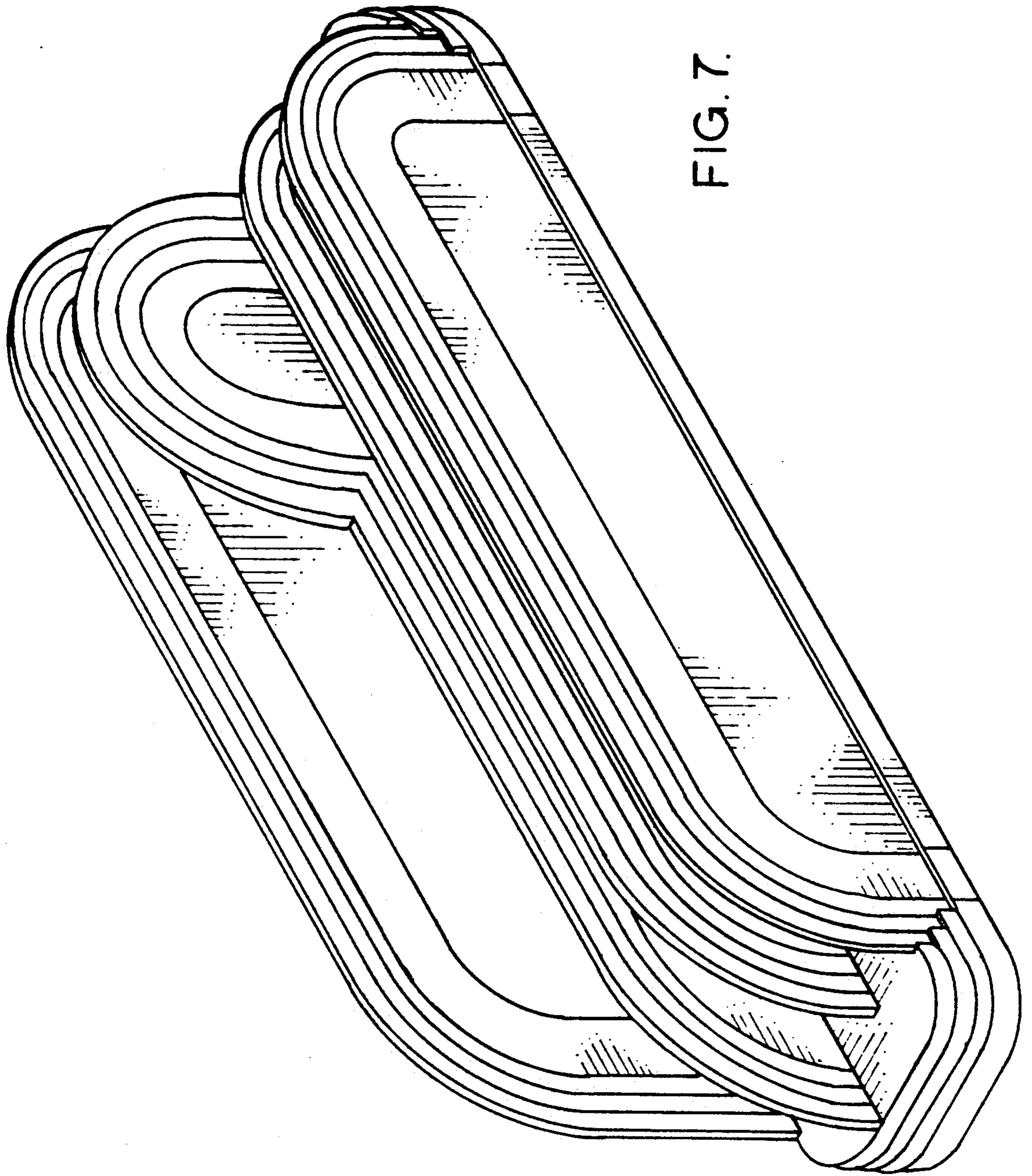

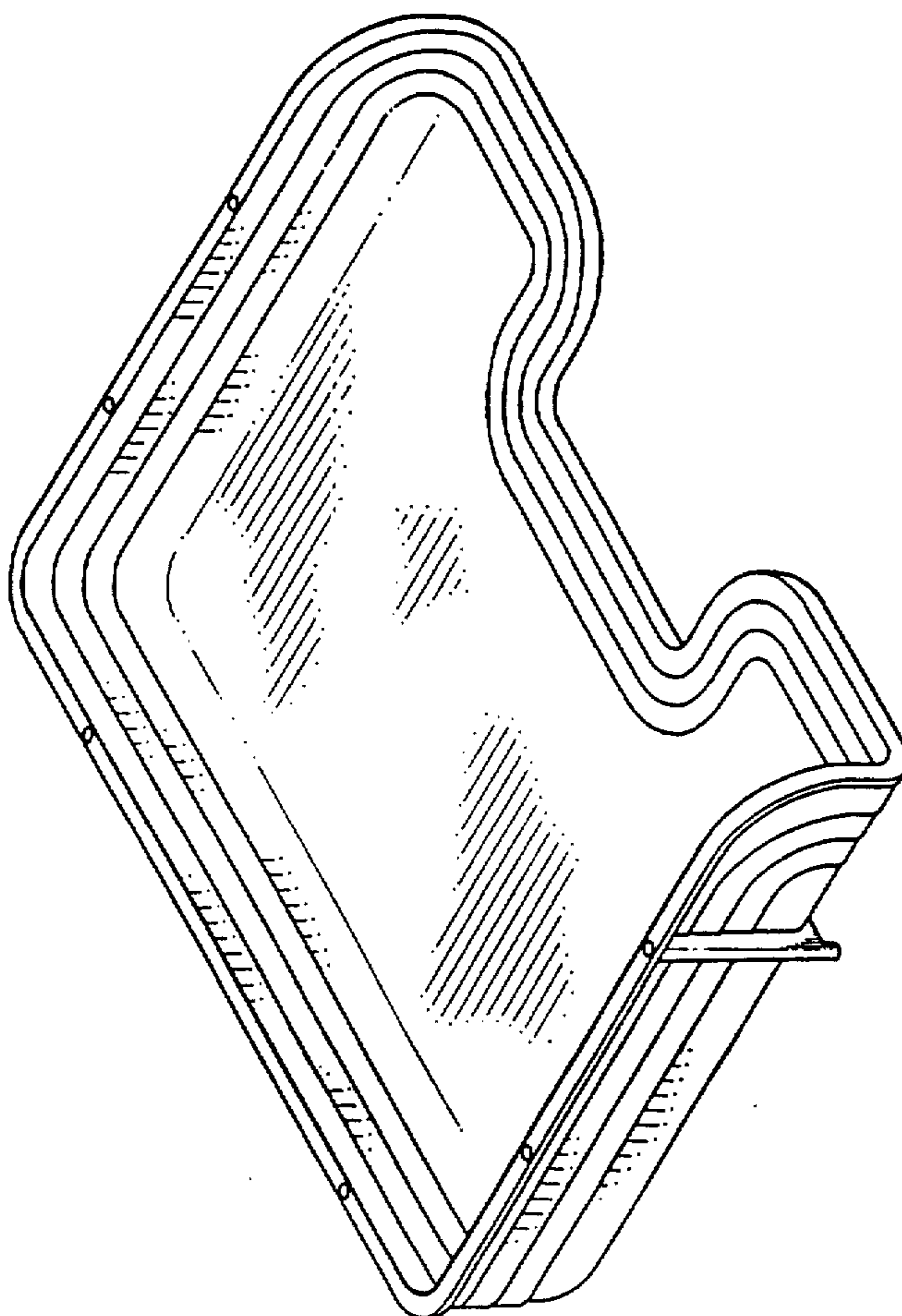

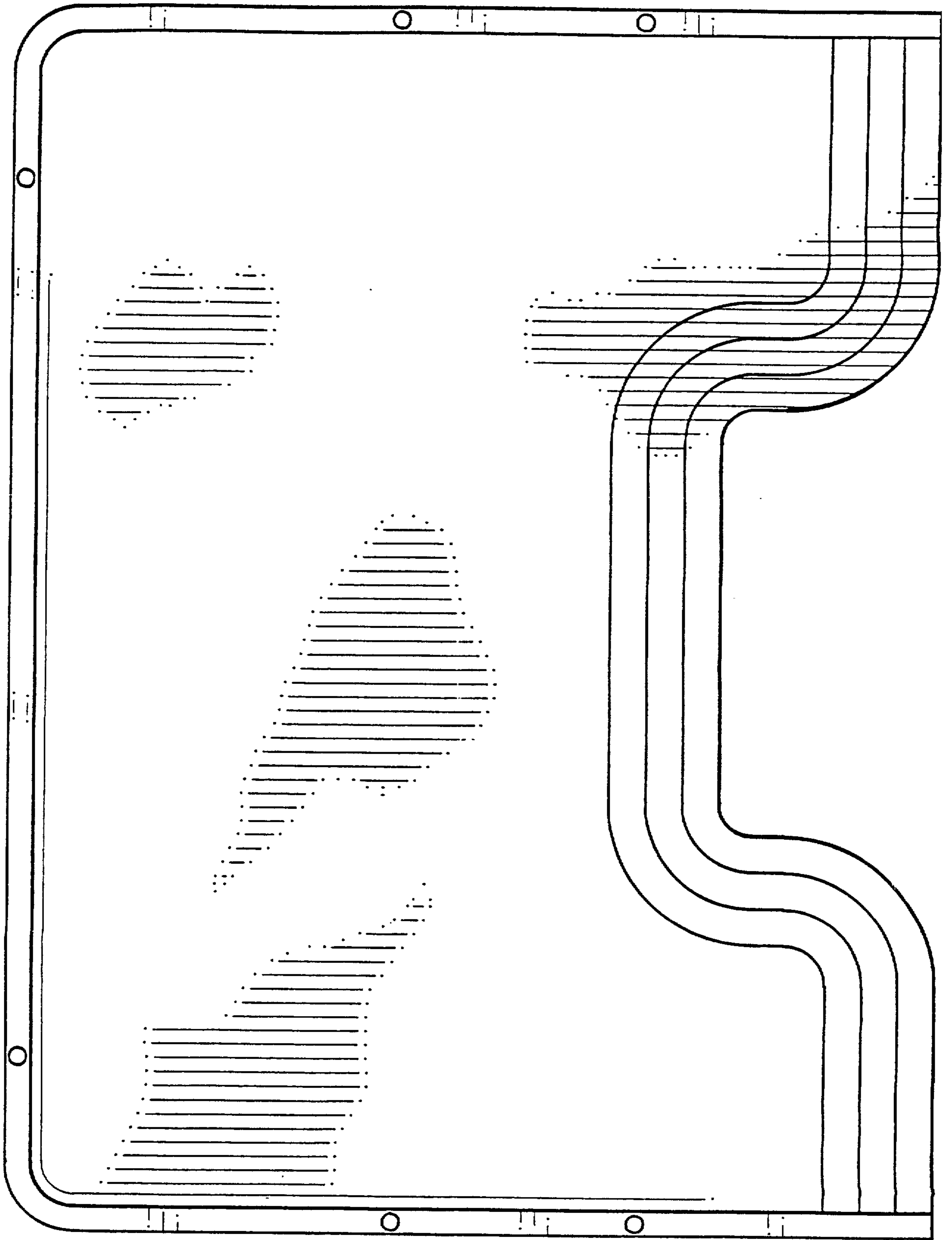

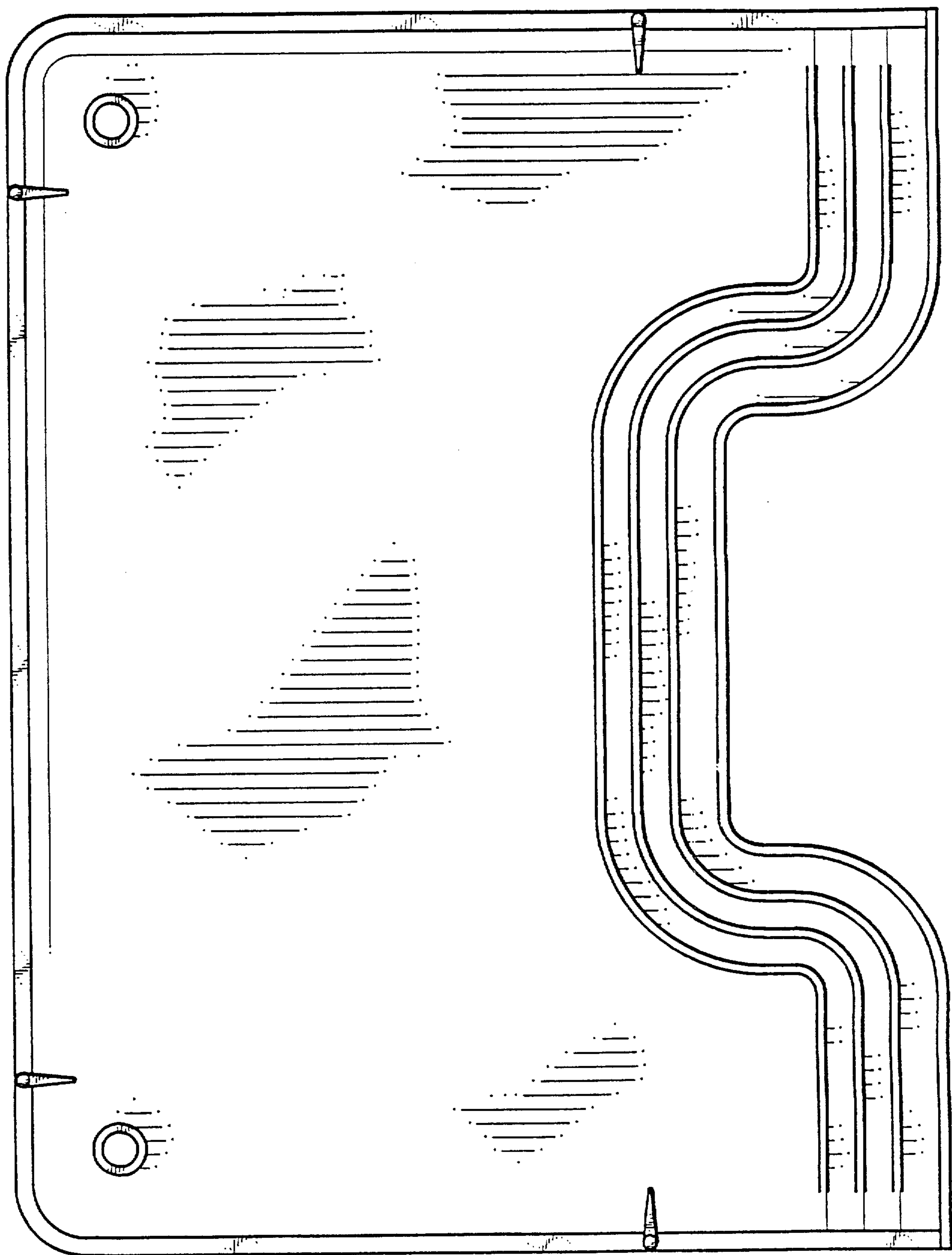

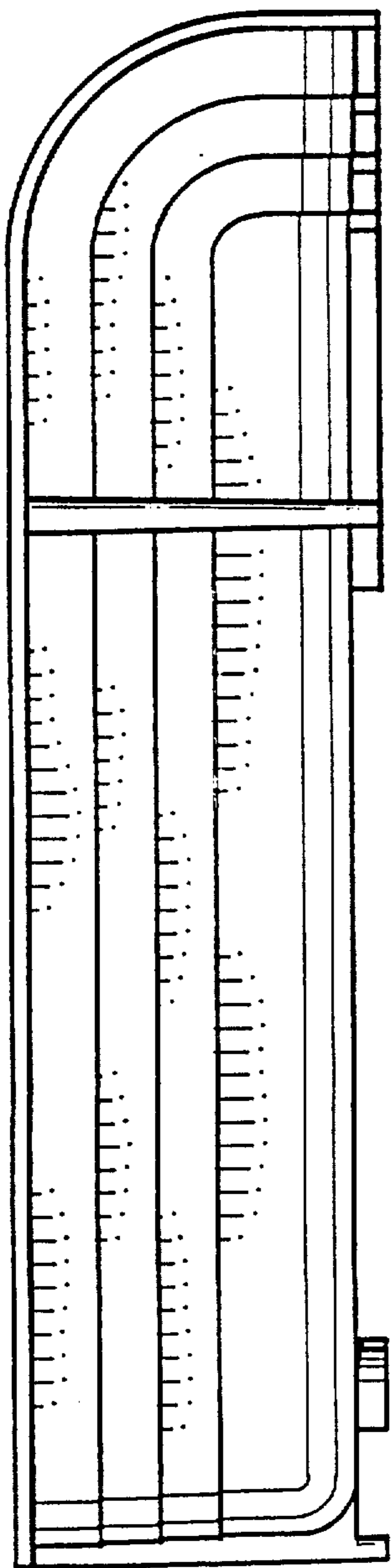

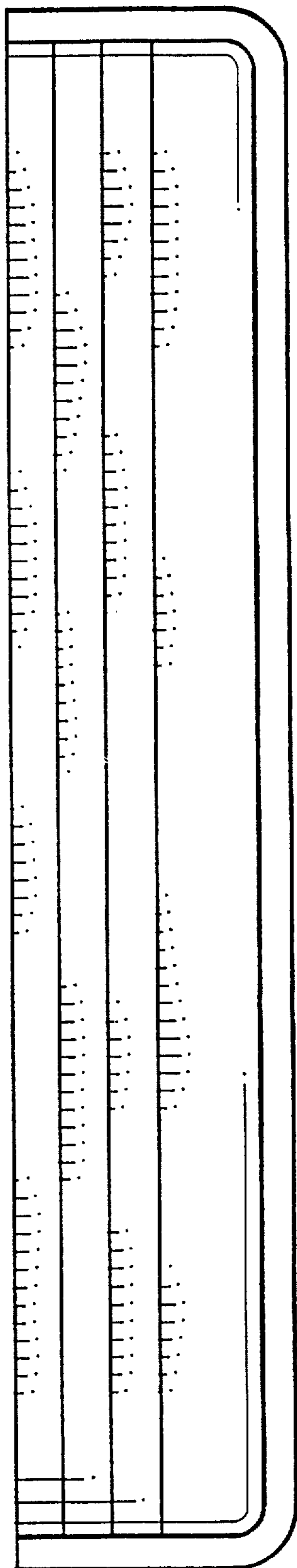
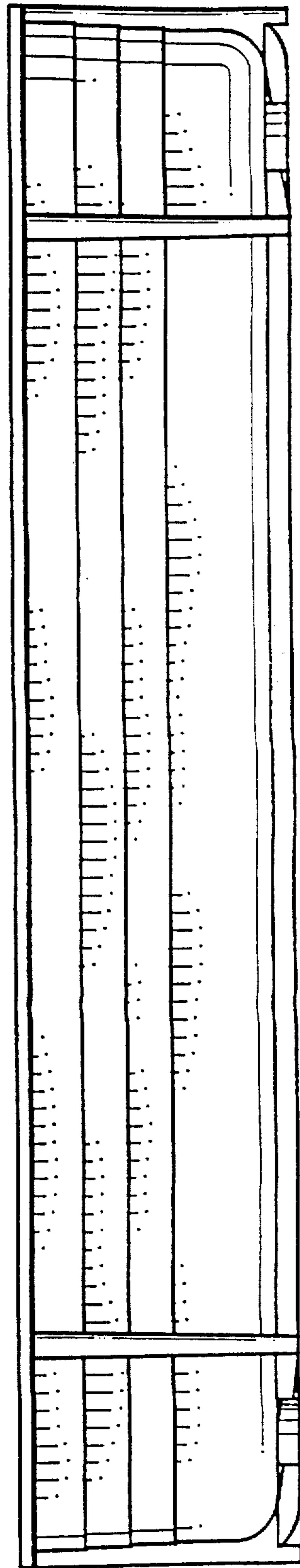

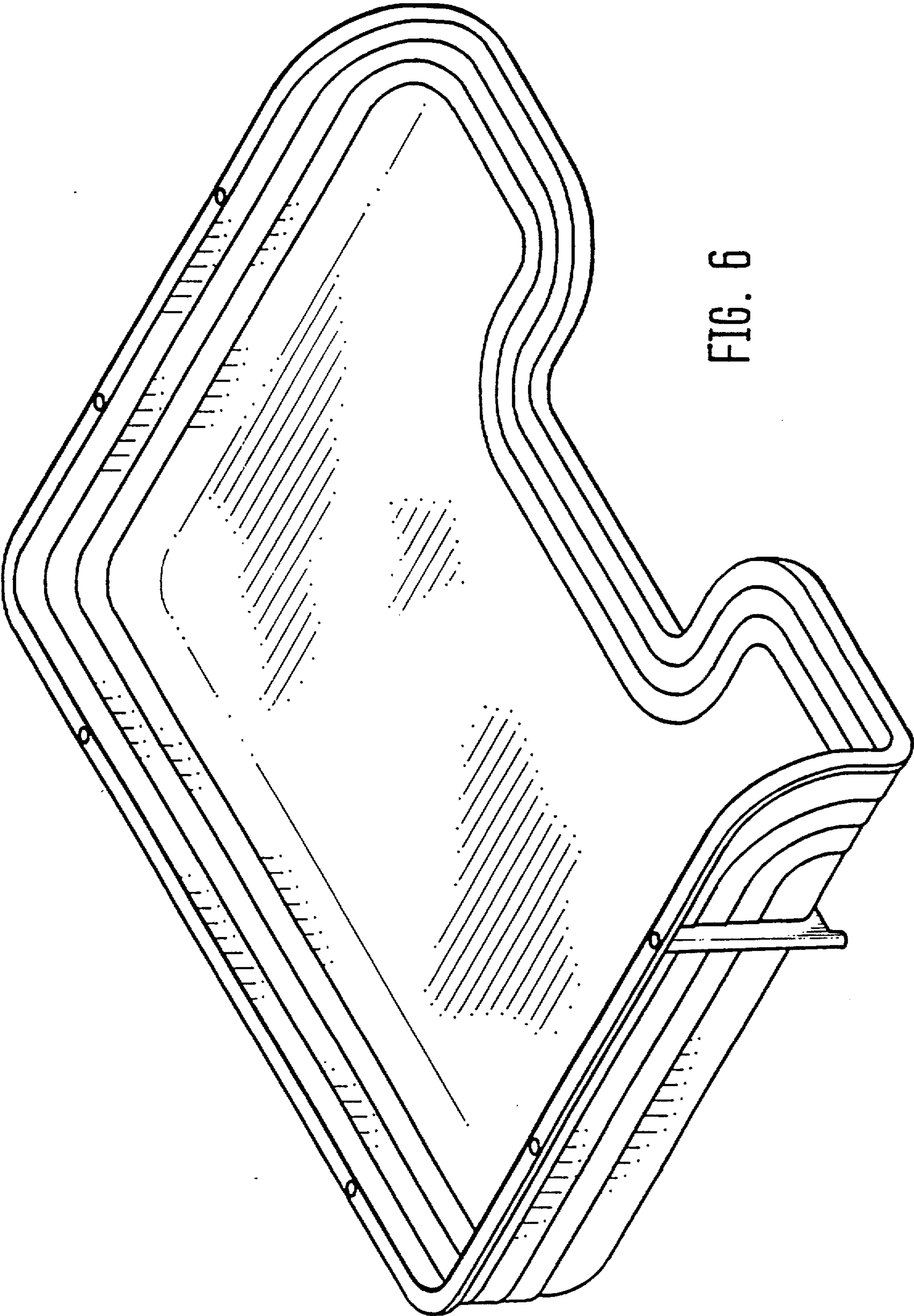
