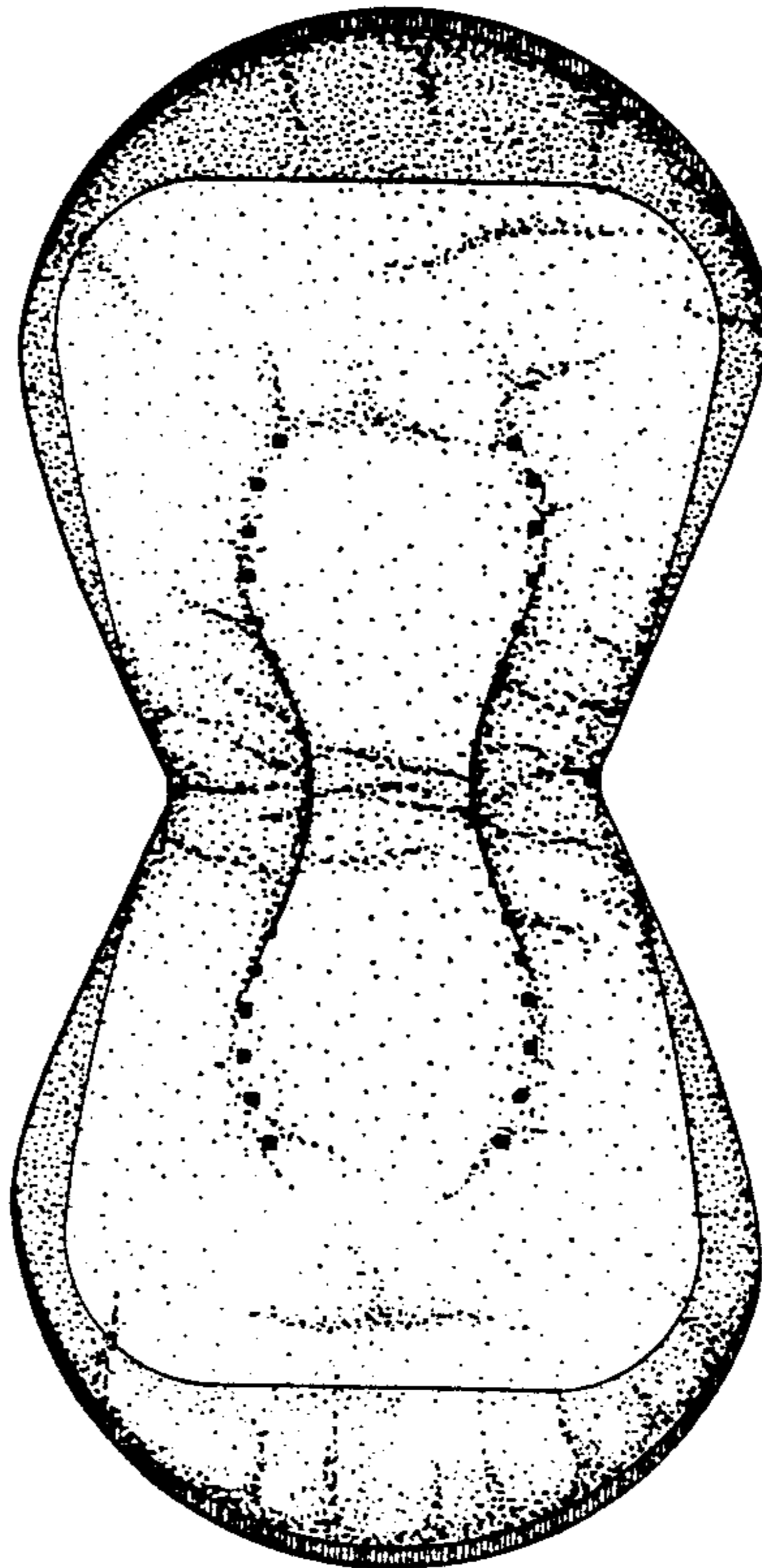
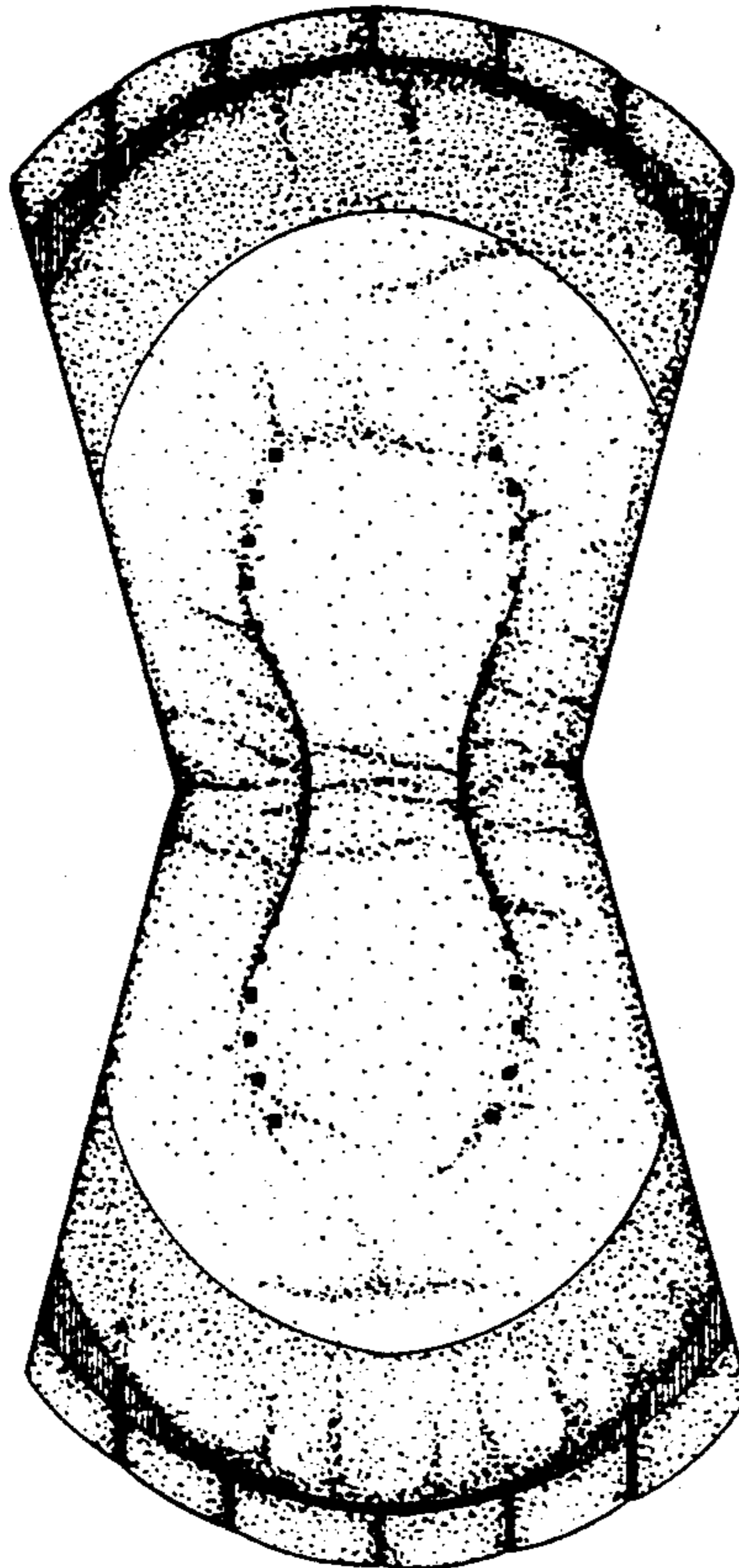

[57] CLAIM

The ornamental design for a disposable urinary pad, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a disposable urinary pad showing our new design;
 FIG. 2 is a bottom plan view thereof;
 FIG. 3 is a side elevational view thereof;
 FIG. 4 is an end elevational view thereof;
 FIG. 5 is a top perspective view thereof in use position;
 FIG. 6 is a side elevational view thereof;
 FIG. 7 is a top plan view thereof in folded position;
 FIG. 8 is a side elevational view thereof, seen from the right side of FIG. 7;
 FIG. 9 is a side elevational view thereof, seen from the bottom of FIG. 7;
 FIG. 10 is a side elevational view thereof, seen from the left side of FIG. 7;
 FIG. 11 is a top plan view of a modified embodiment thereof;
 FIG. 12 is a bottom plan view thereof;
 FIG. 13 is a side elevational view thereof;
 FIG. 14 is an end elevational view thereof;
 FIG. 15 is a top perspective view thereof, in use position;
 FIG. 16 is a side elevational view thereof;
 FIG. 17 is a top plan view thereof in folded position;
 FIG. 18 is a side elevational view thereof, seen from the right side of FIG. 17;
 FIG. 19 is a side elevational view thereof, seen from the bottom of FIG. 17; and
 FIG. 20 is a side elevational view thereof, seen from the left side of FIG. 17.
 The opposite sides of FIGS. 7 and 17 are similar thereto.



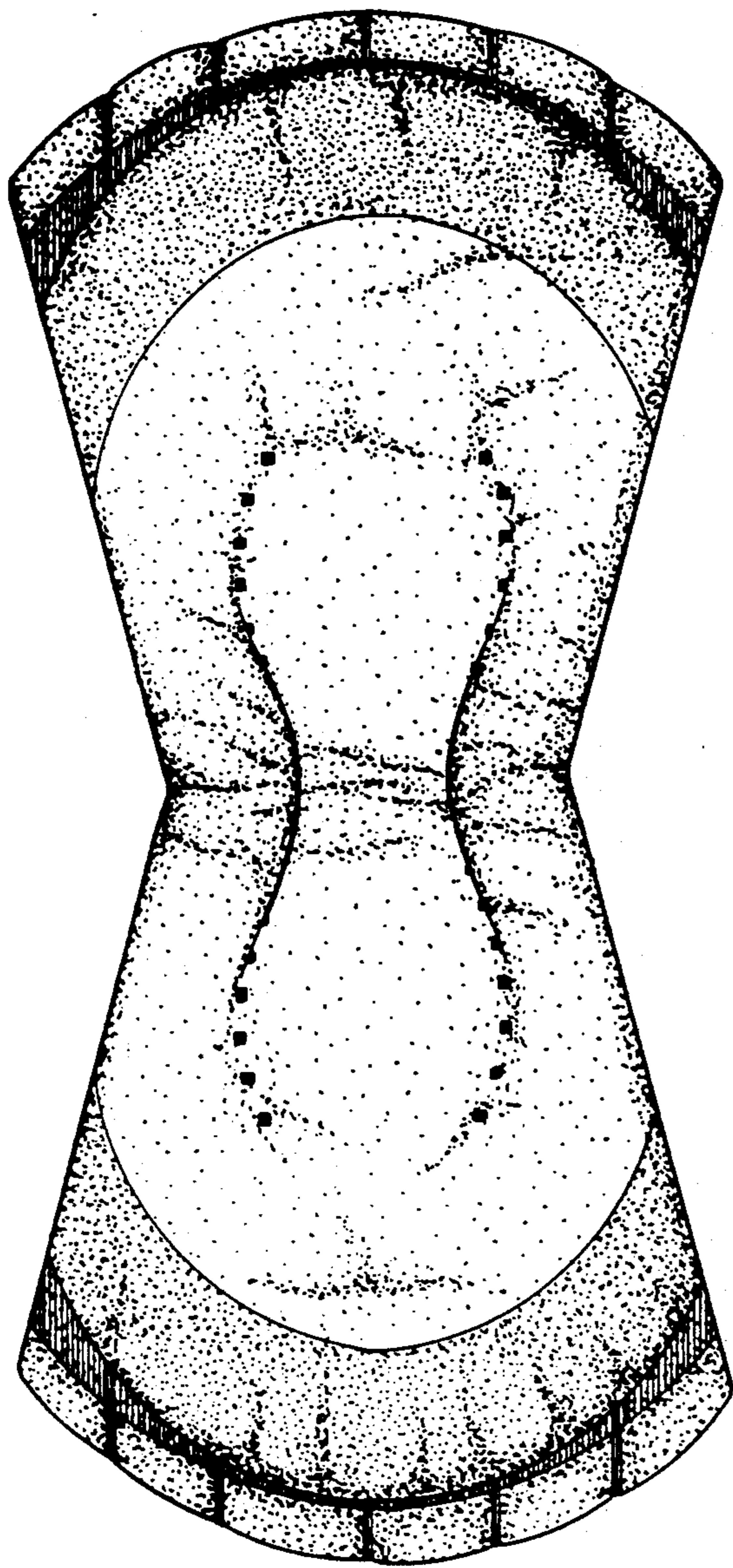

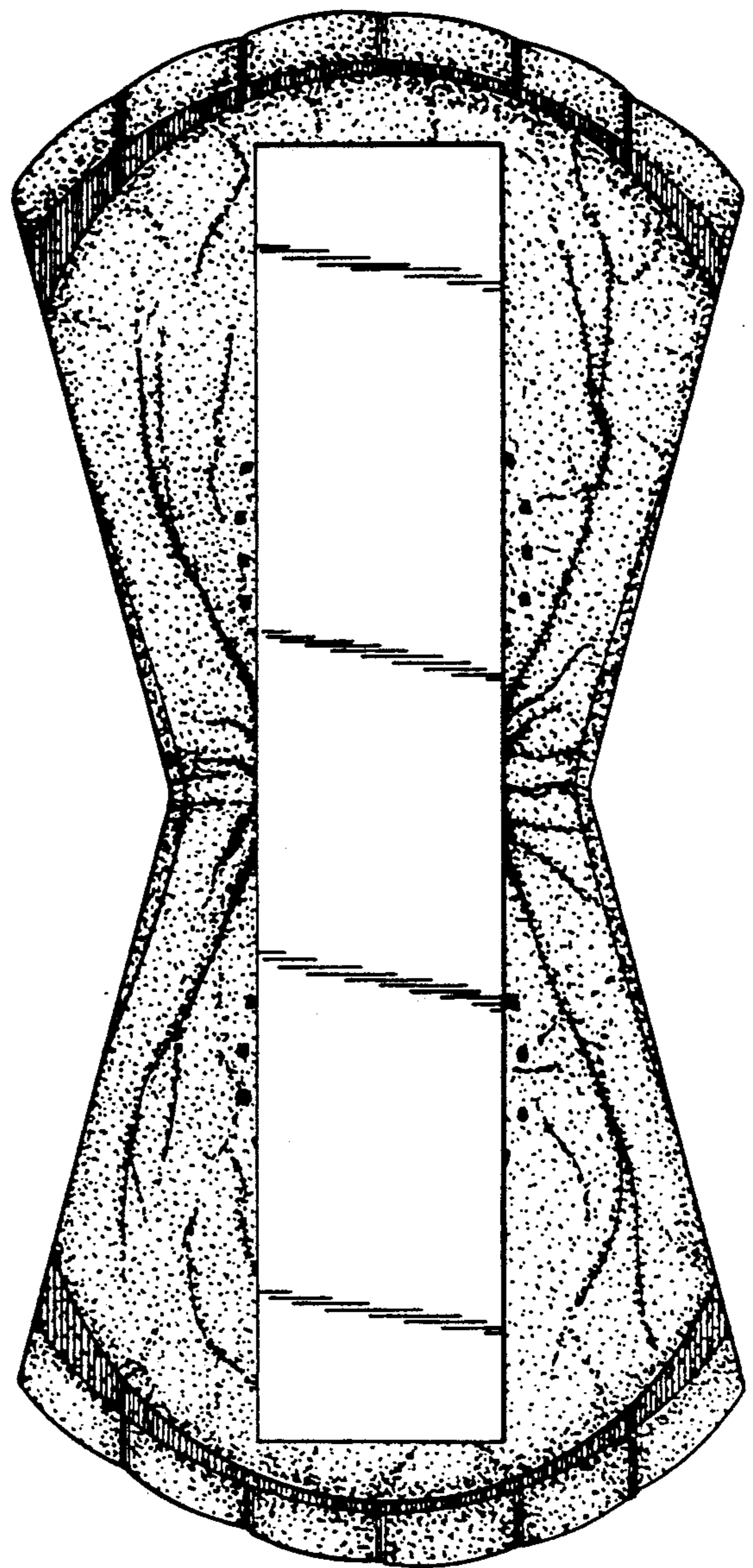

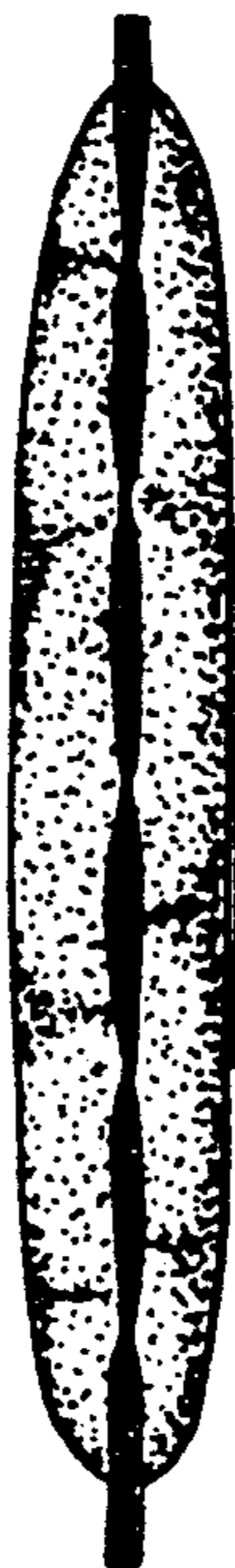

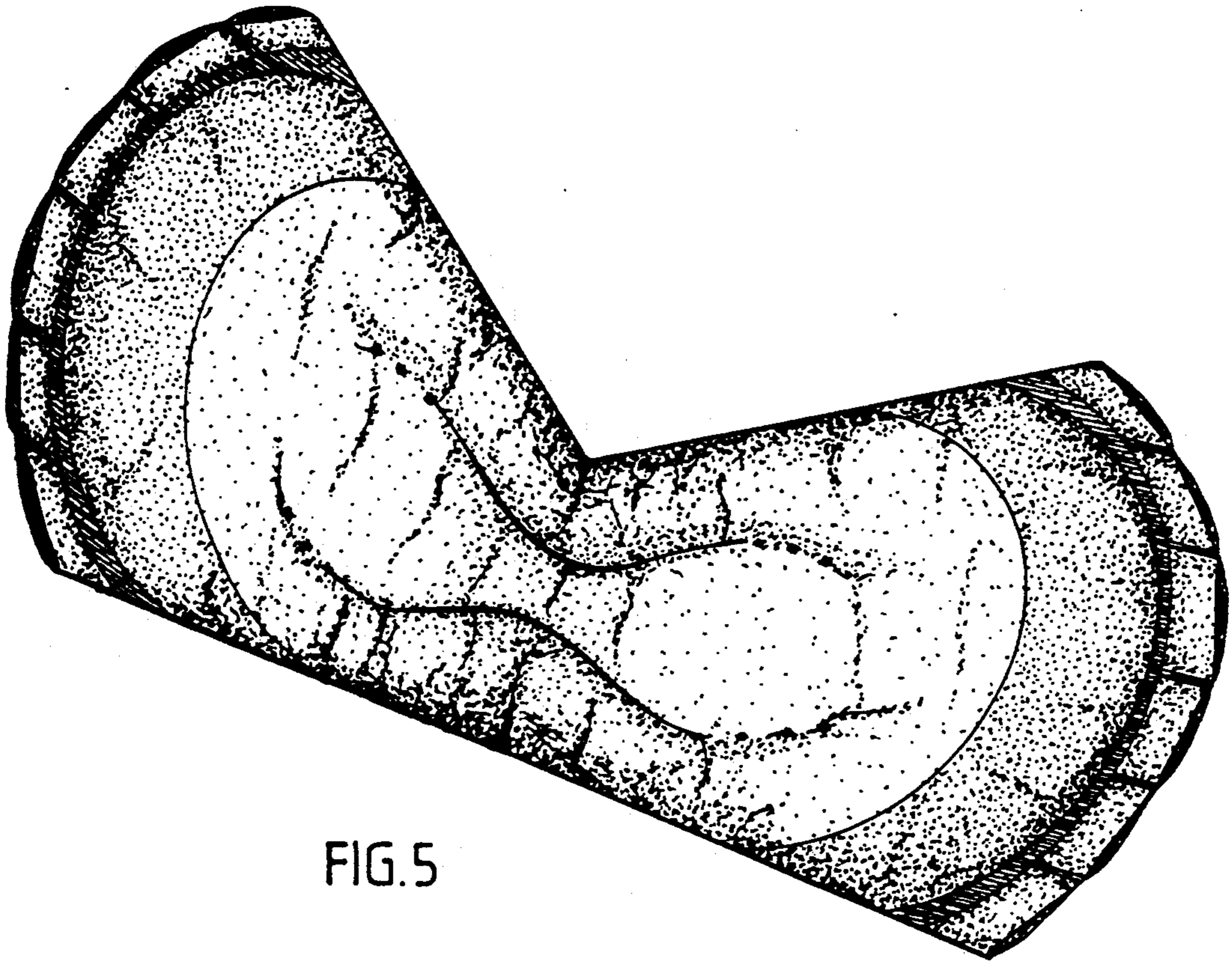

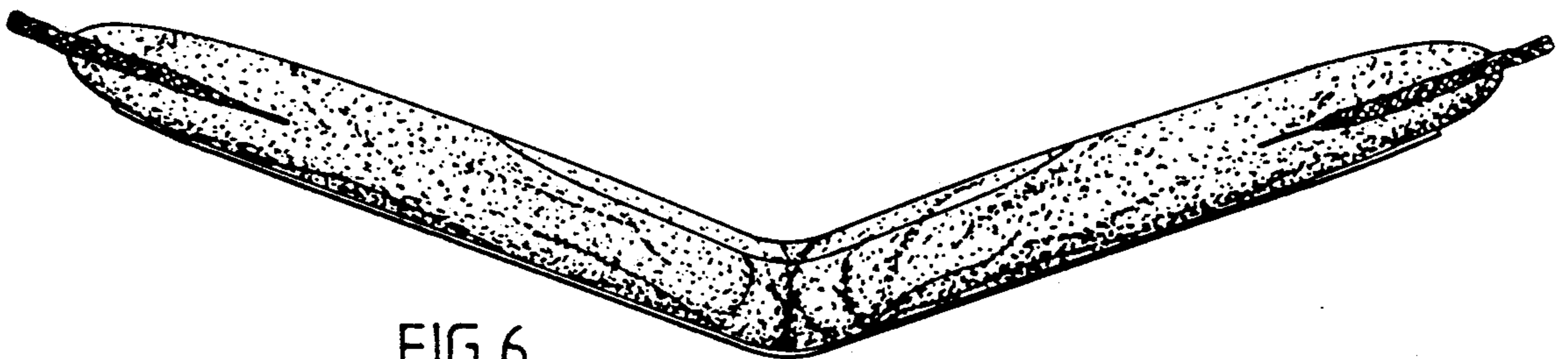

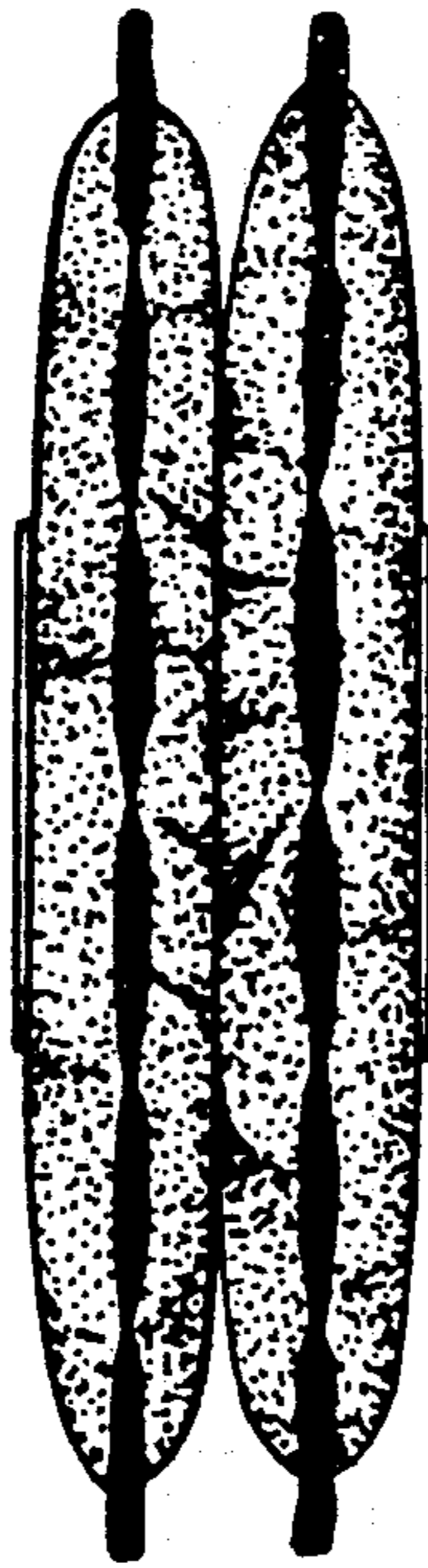

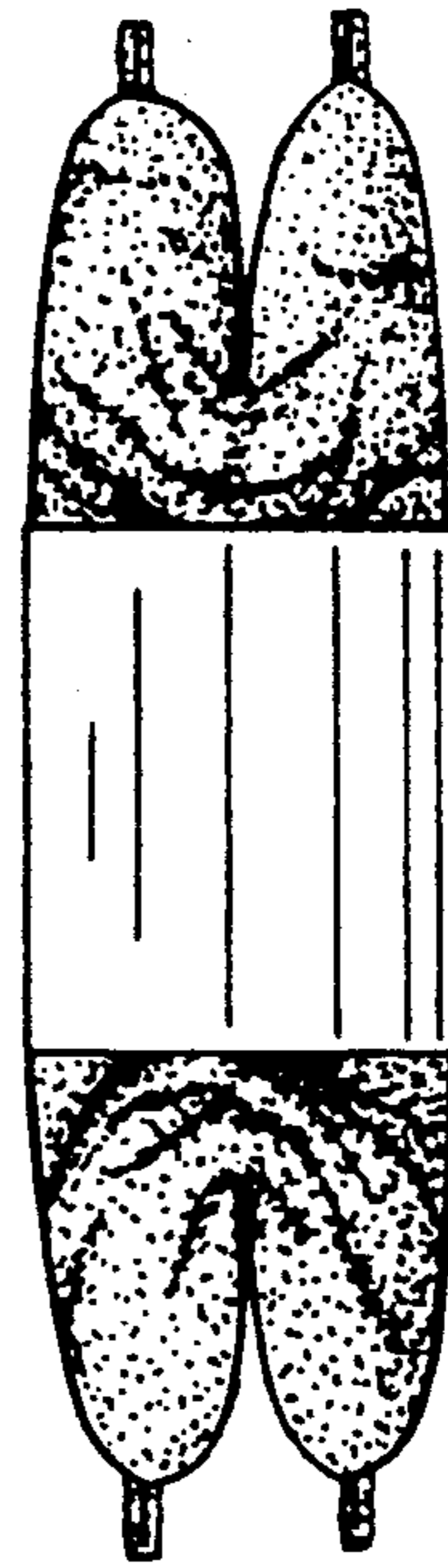

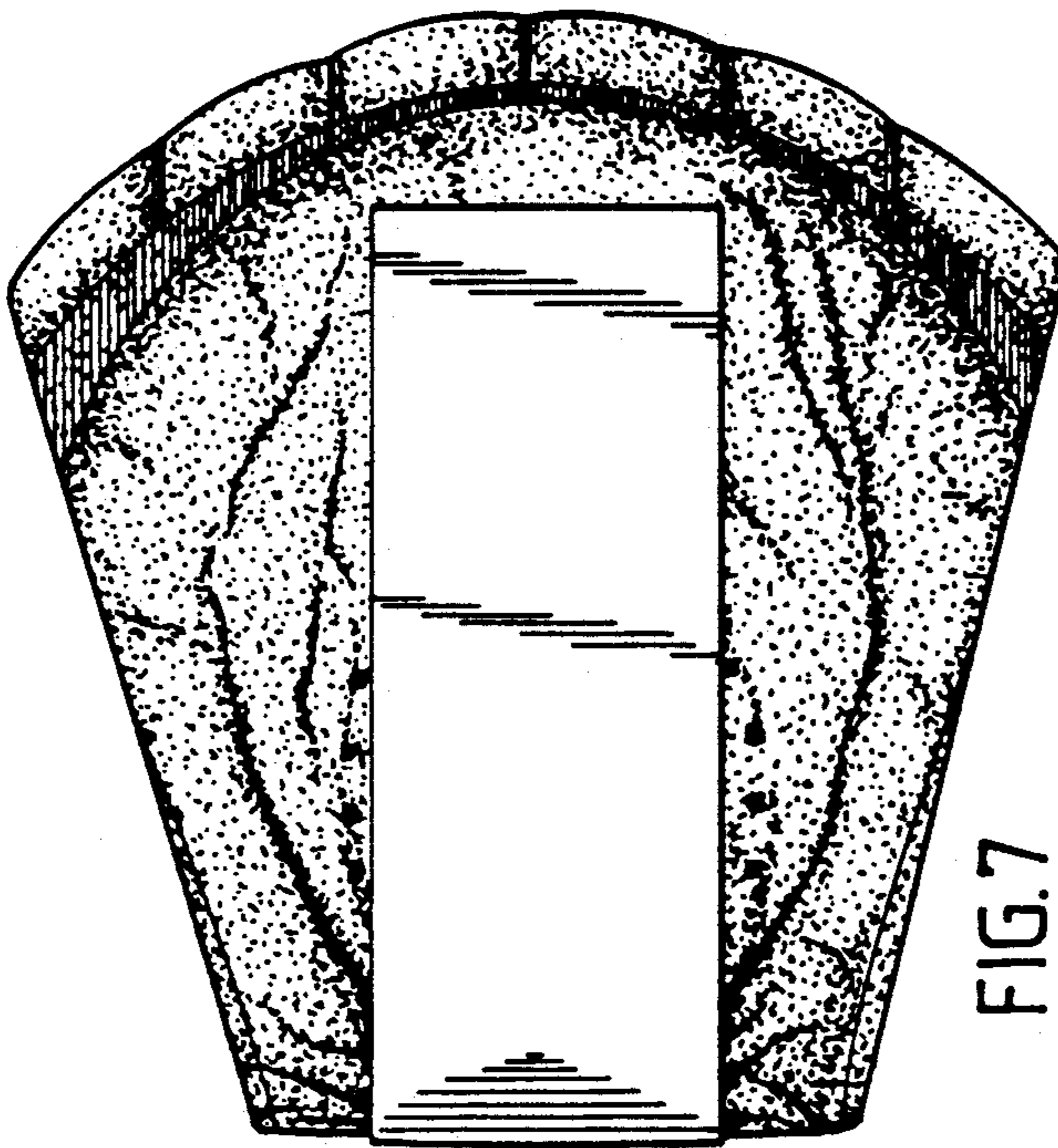

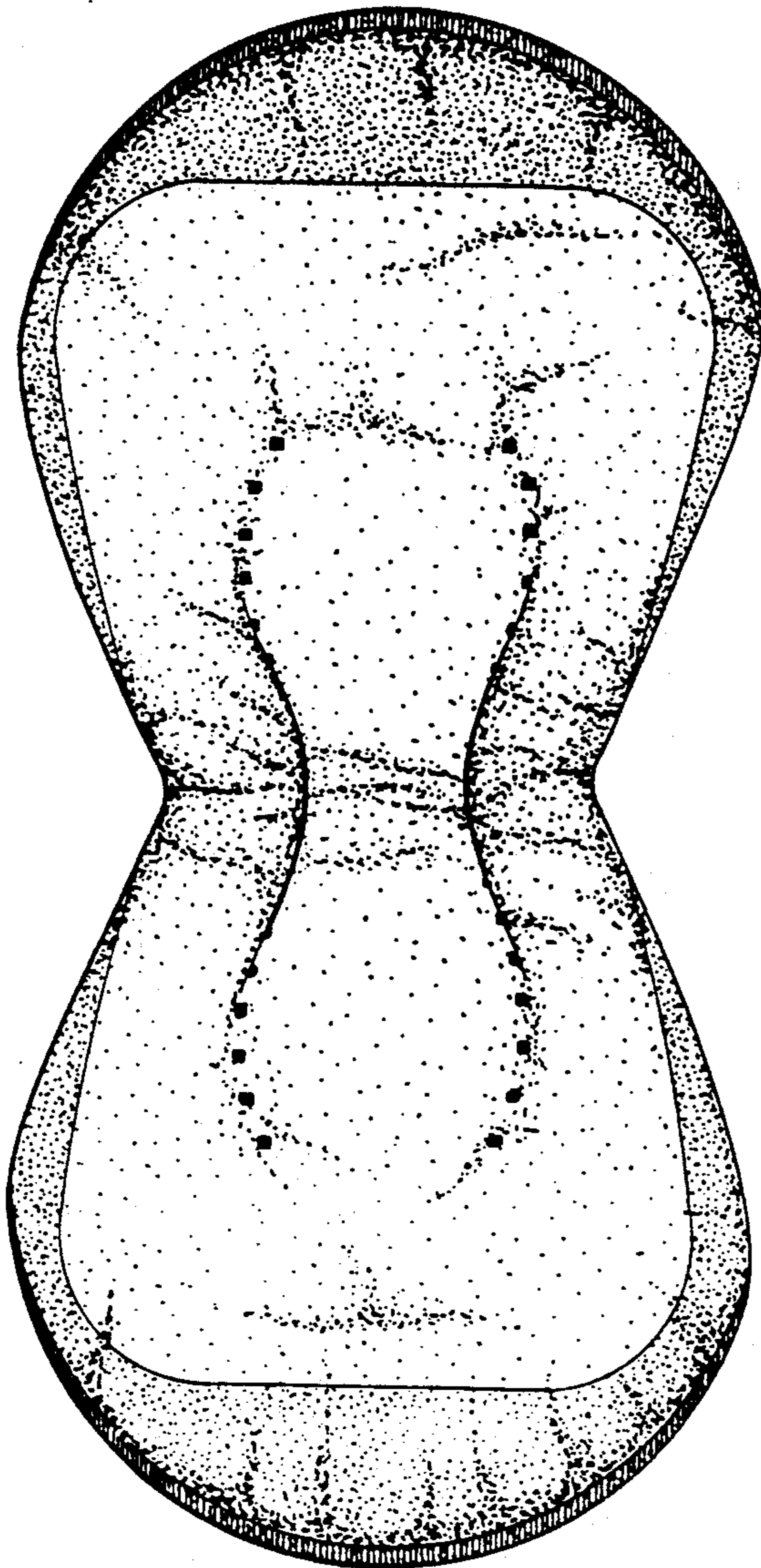

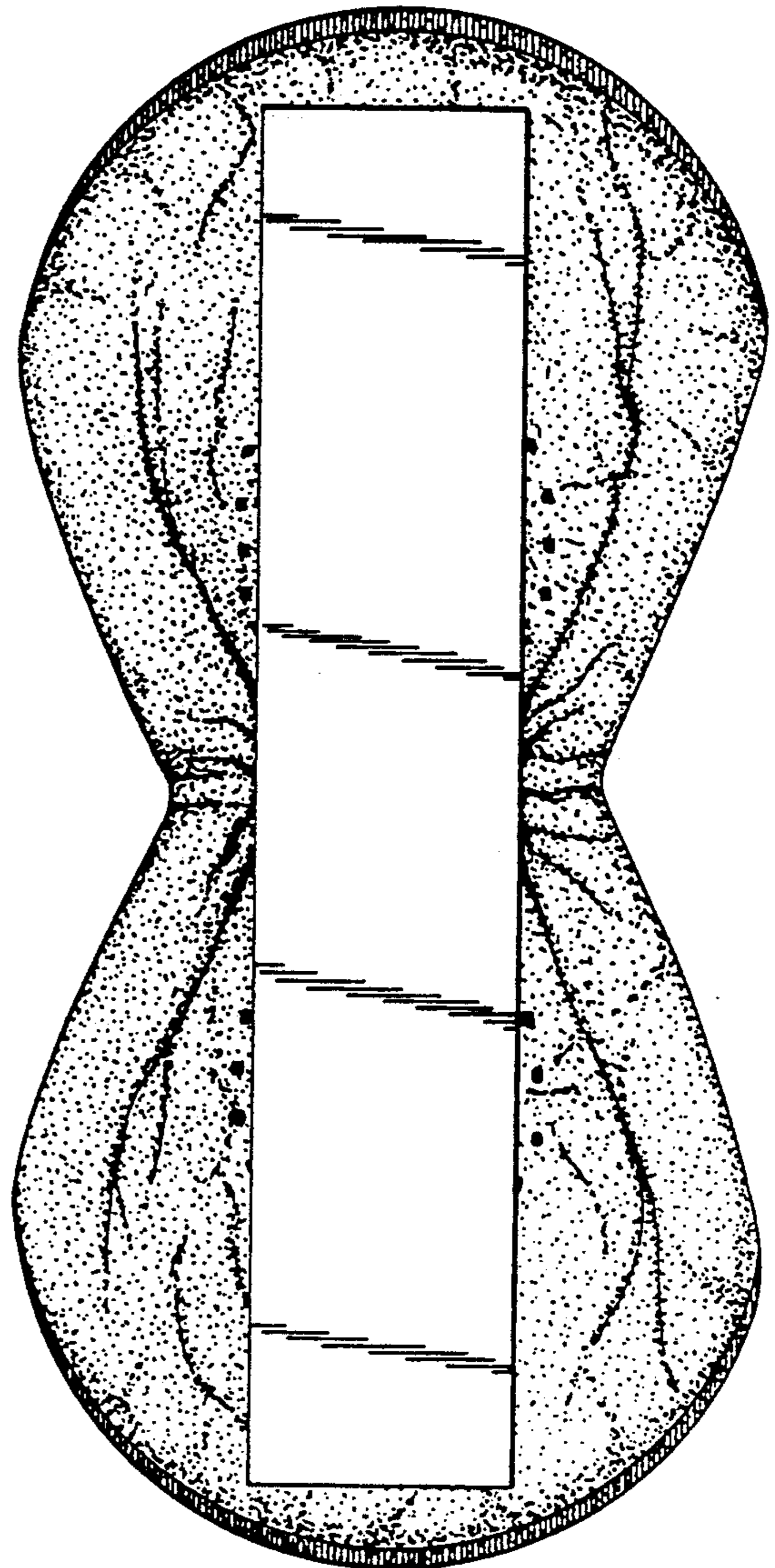

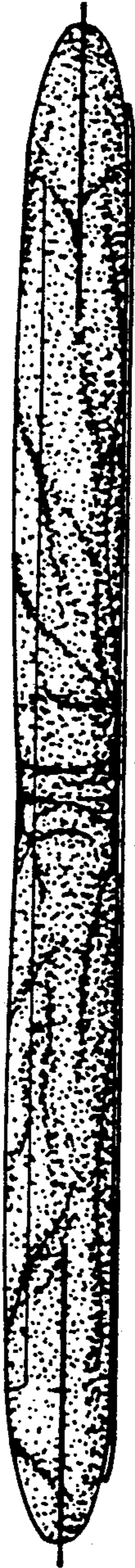

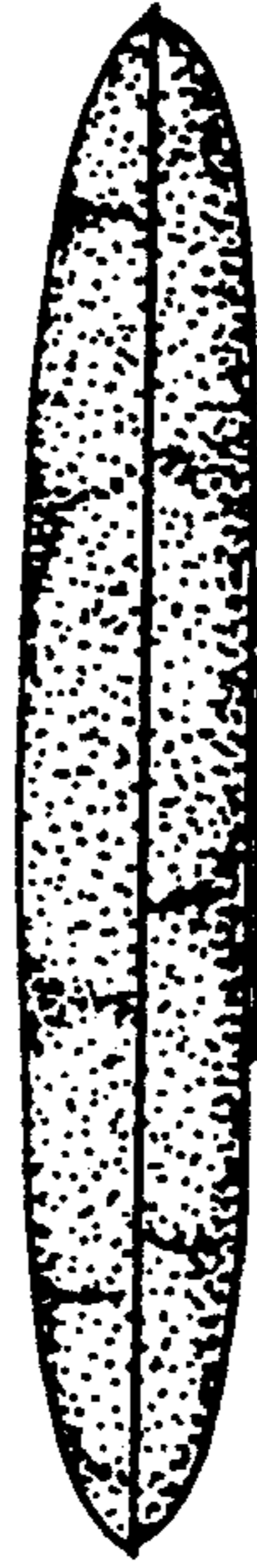

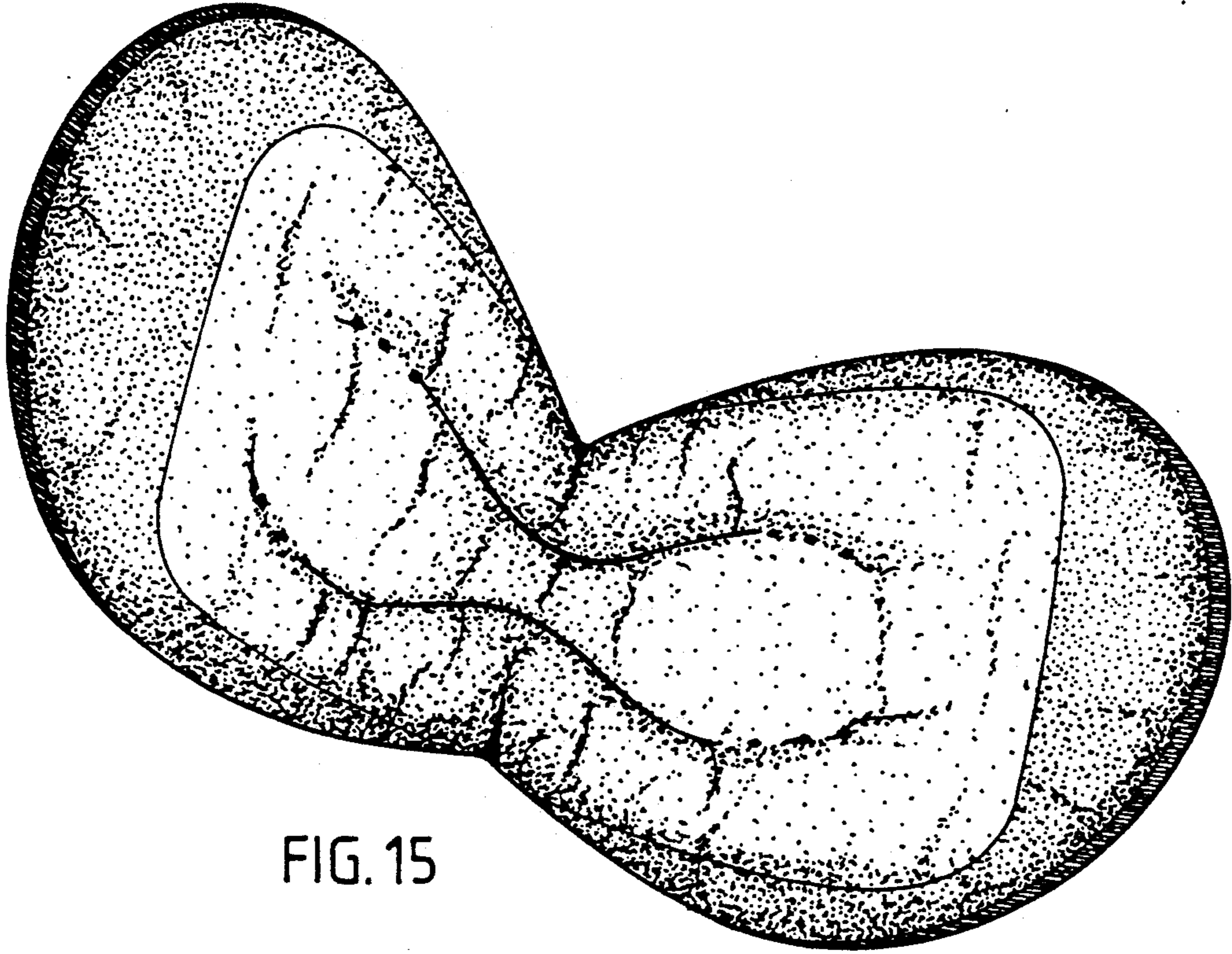

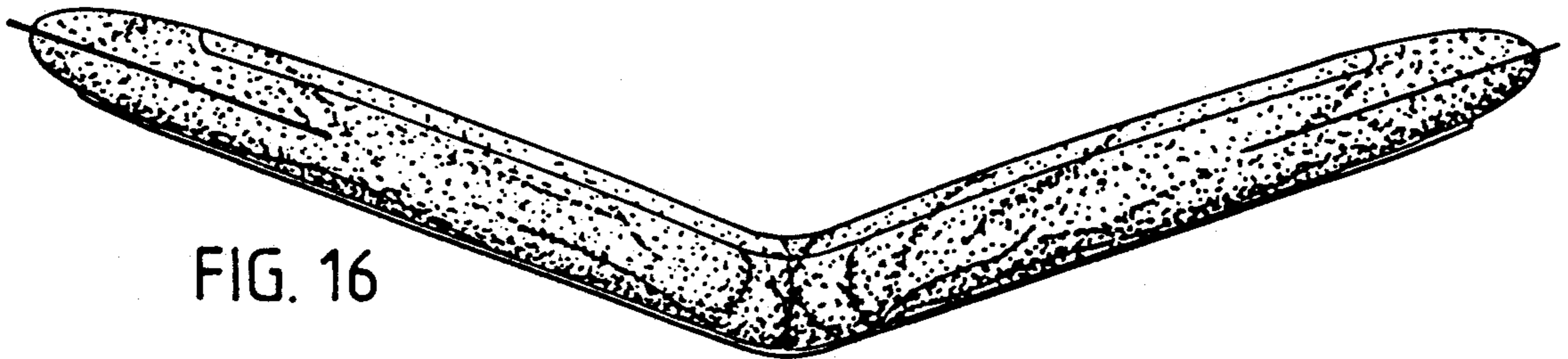

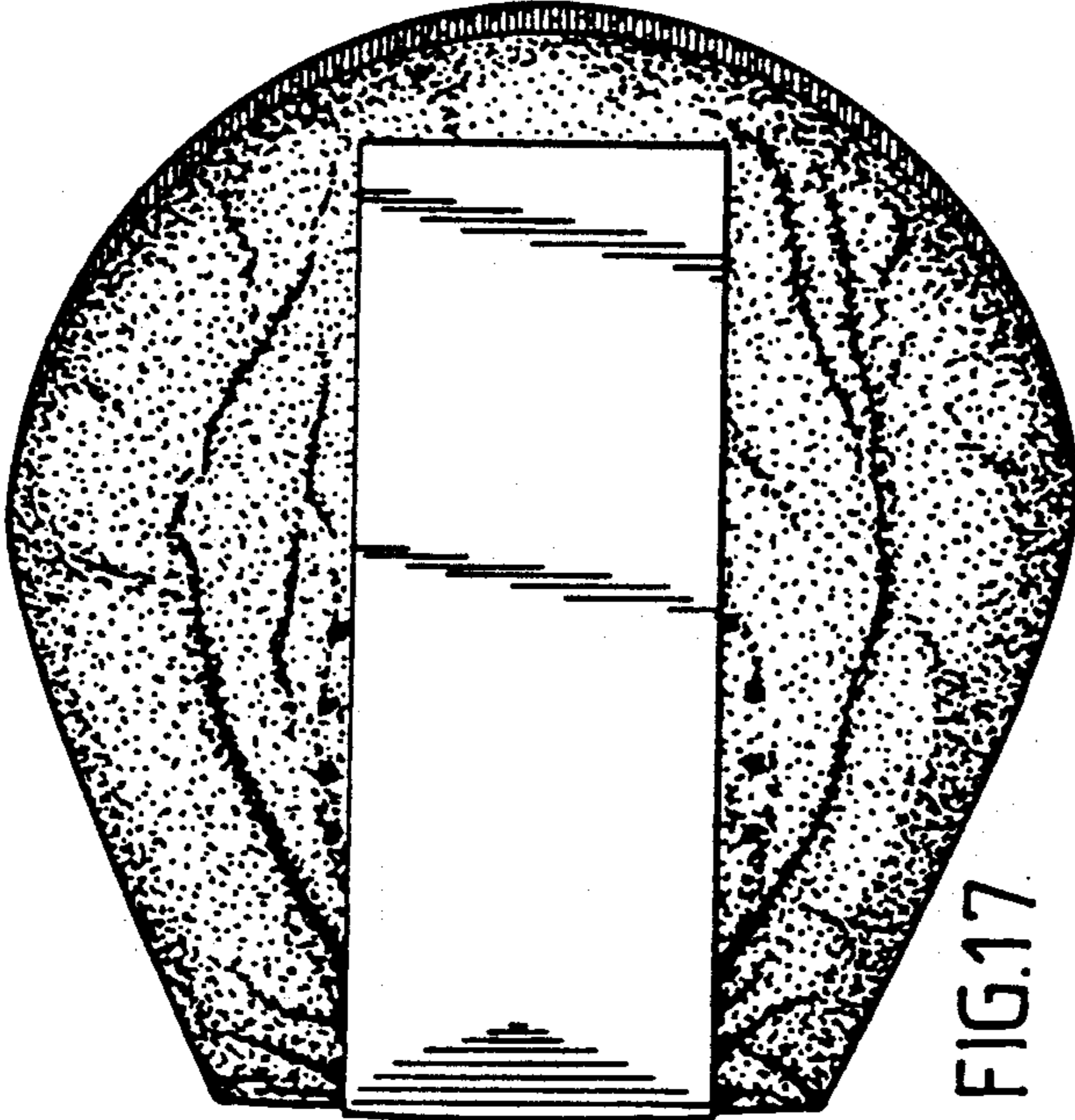

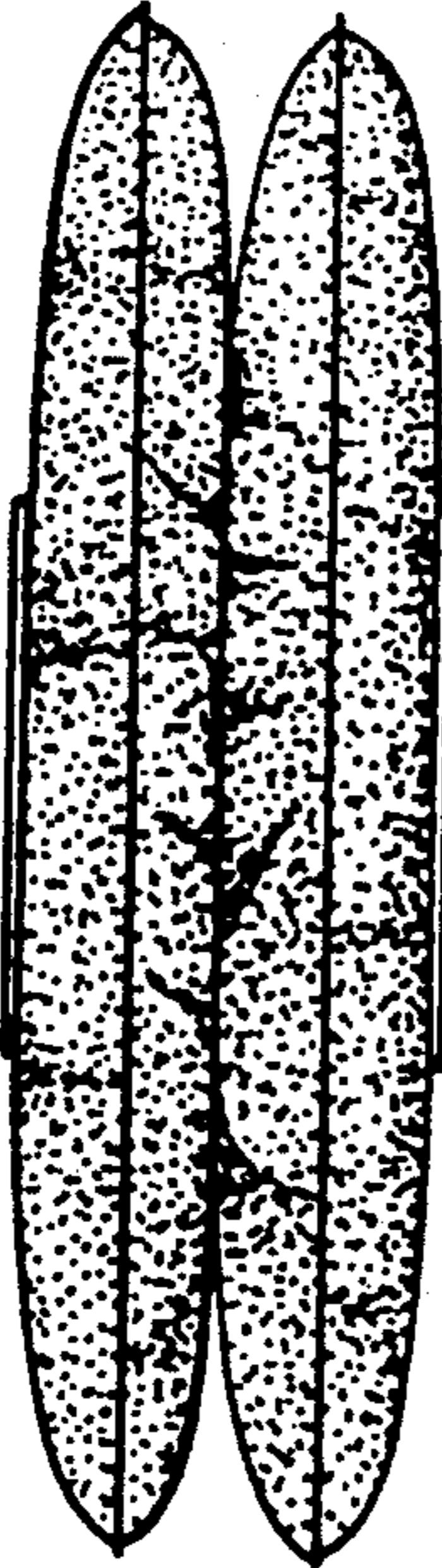

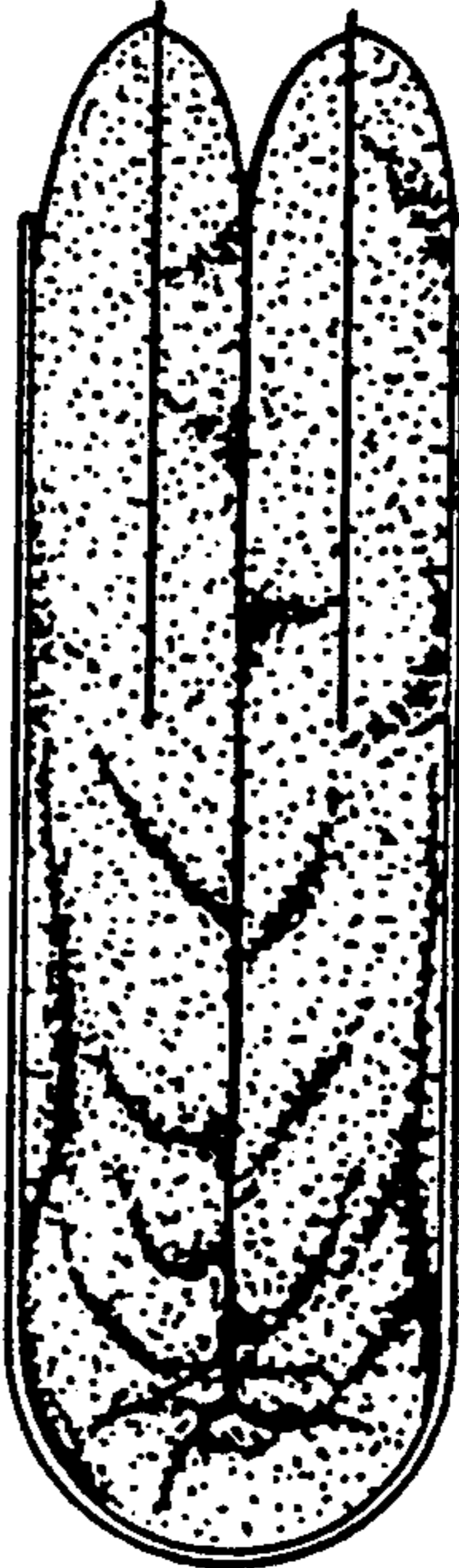

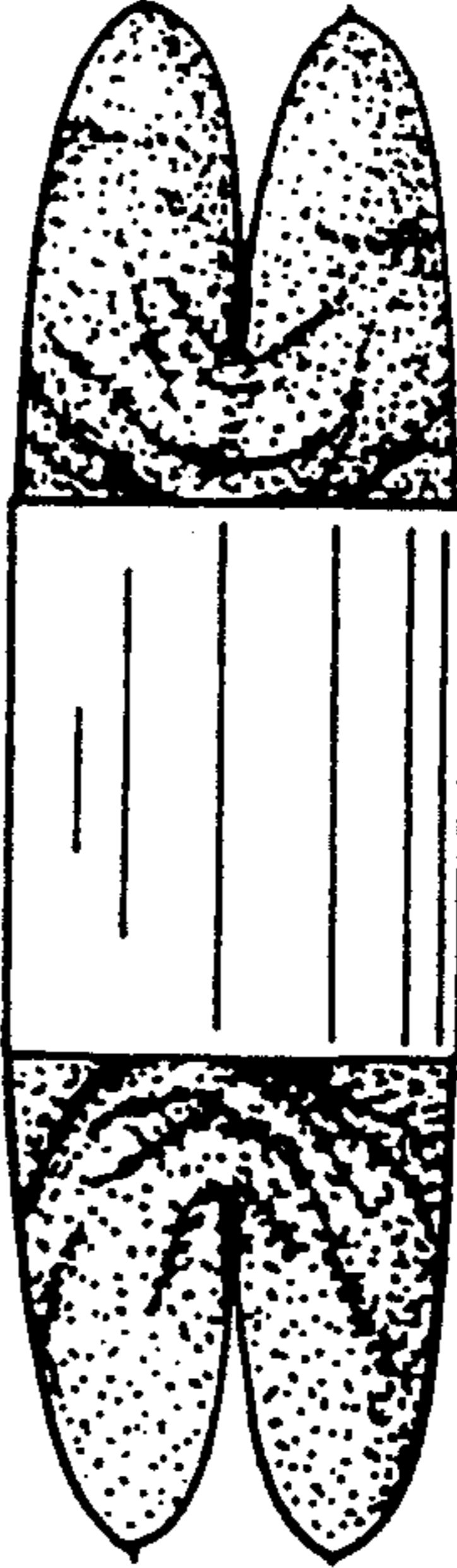
