FIG. 3 is a bottom plan view thereof;

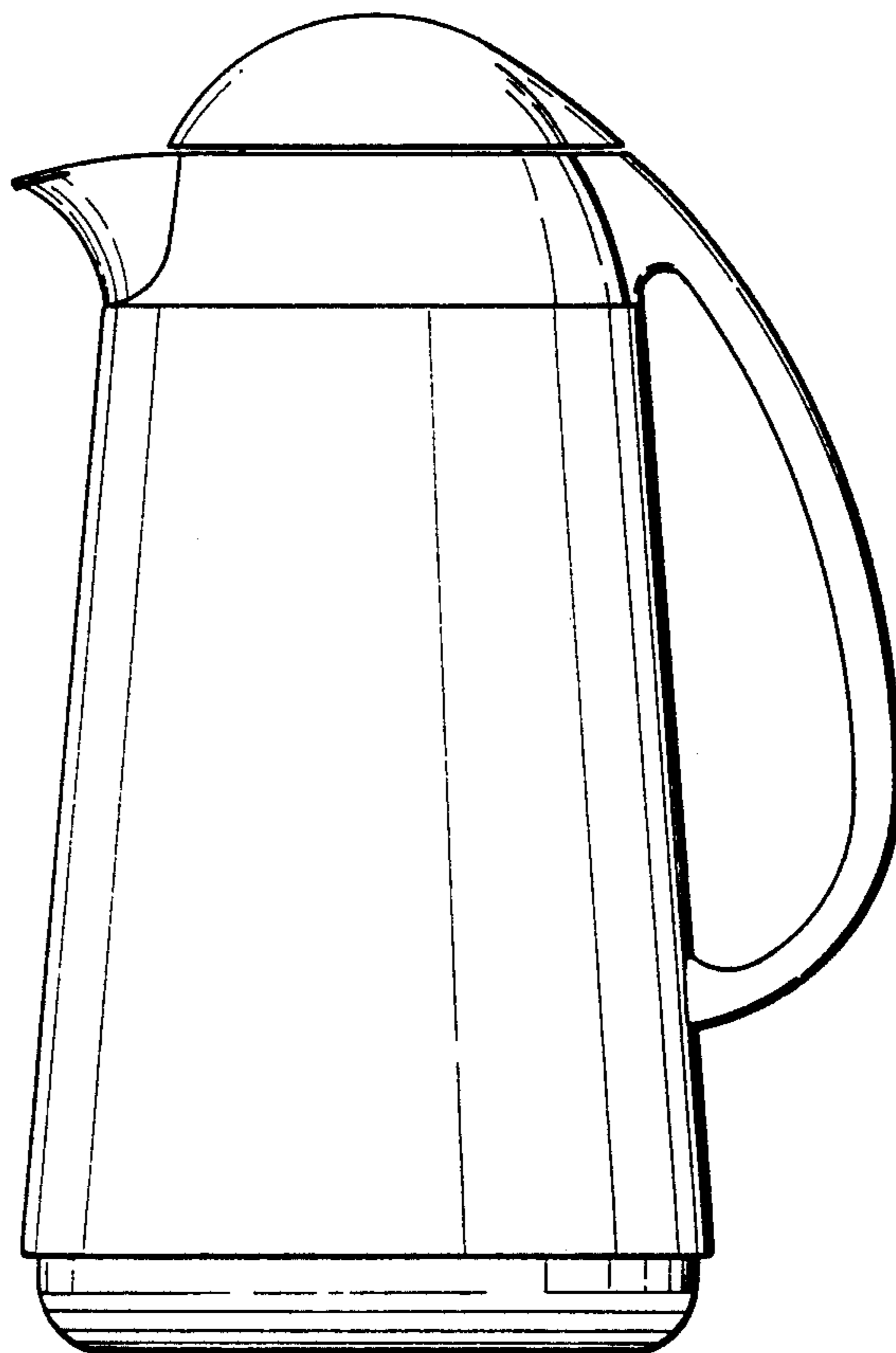
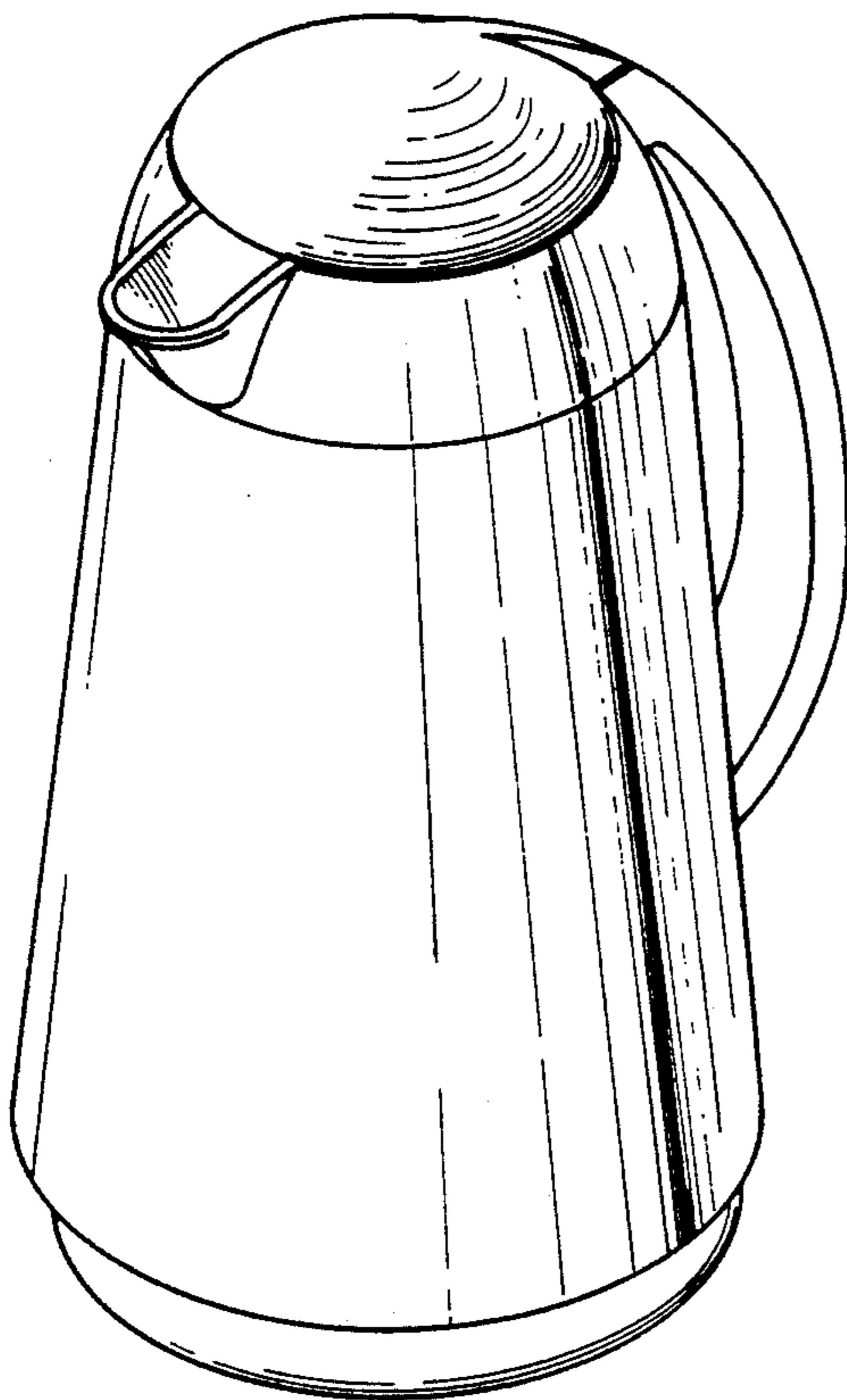
FIG. 4 is a left side elevational view, the right side view being a mirror image thereof;

FIG. 8 is a cross-sectional view thereof.



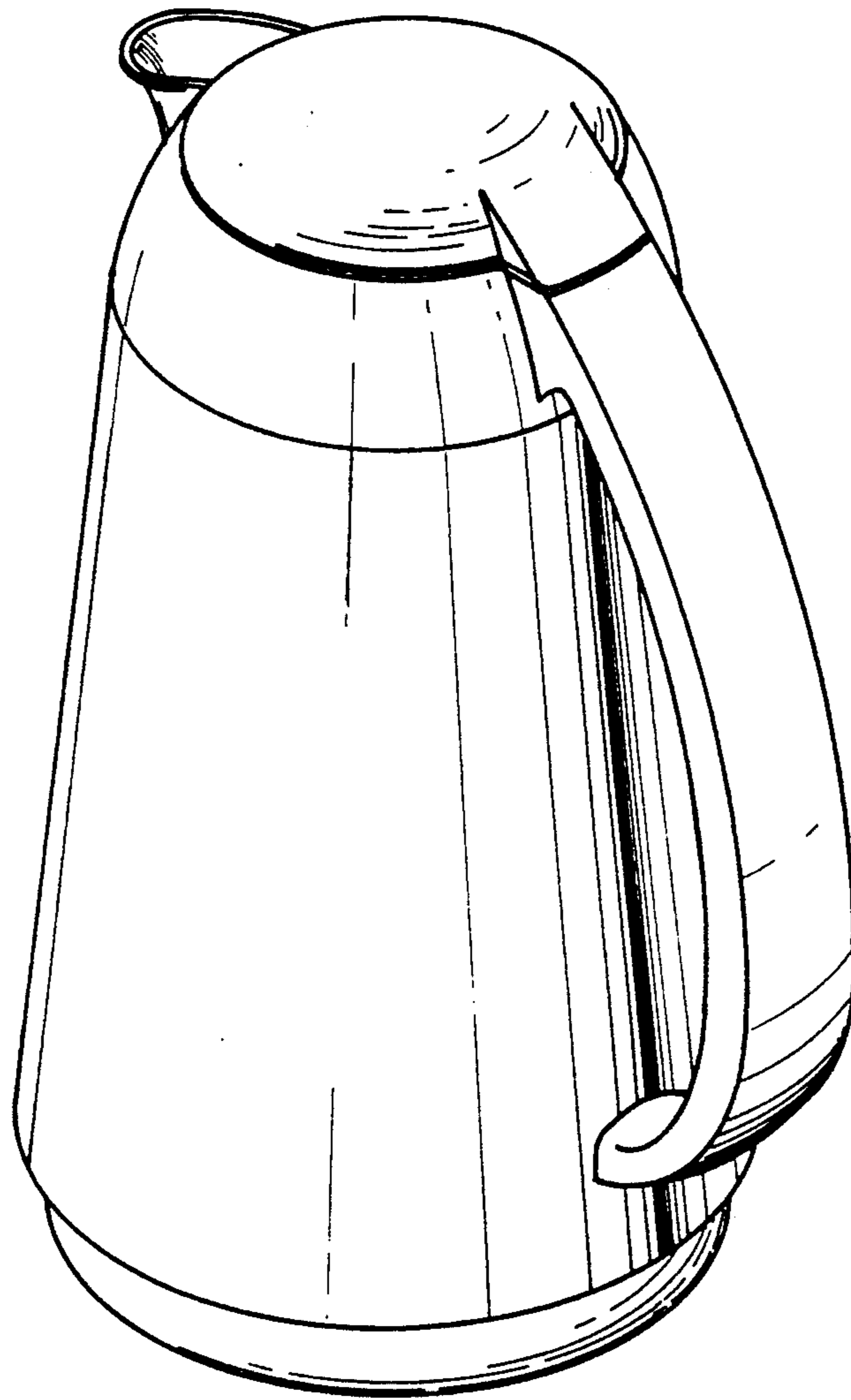

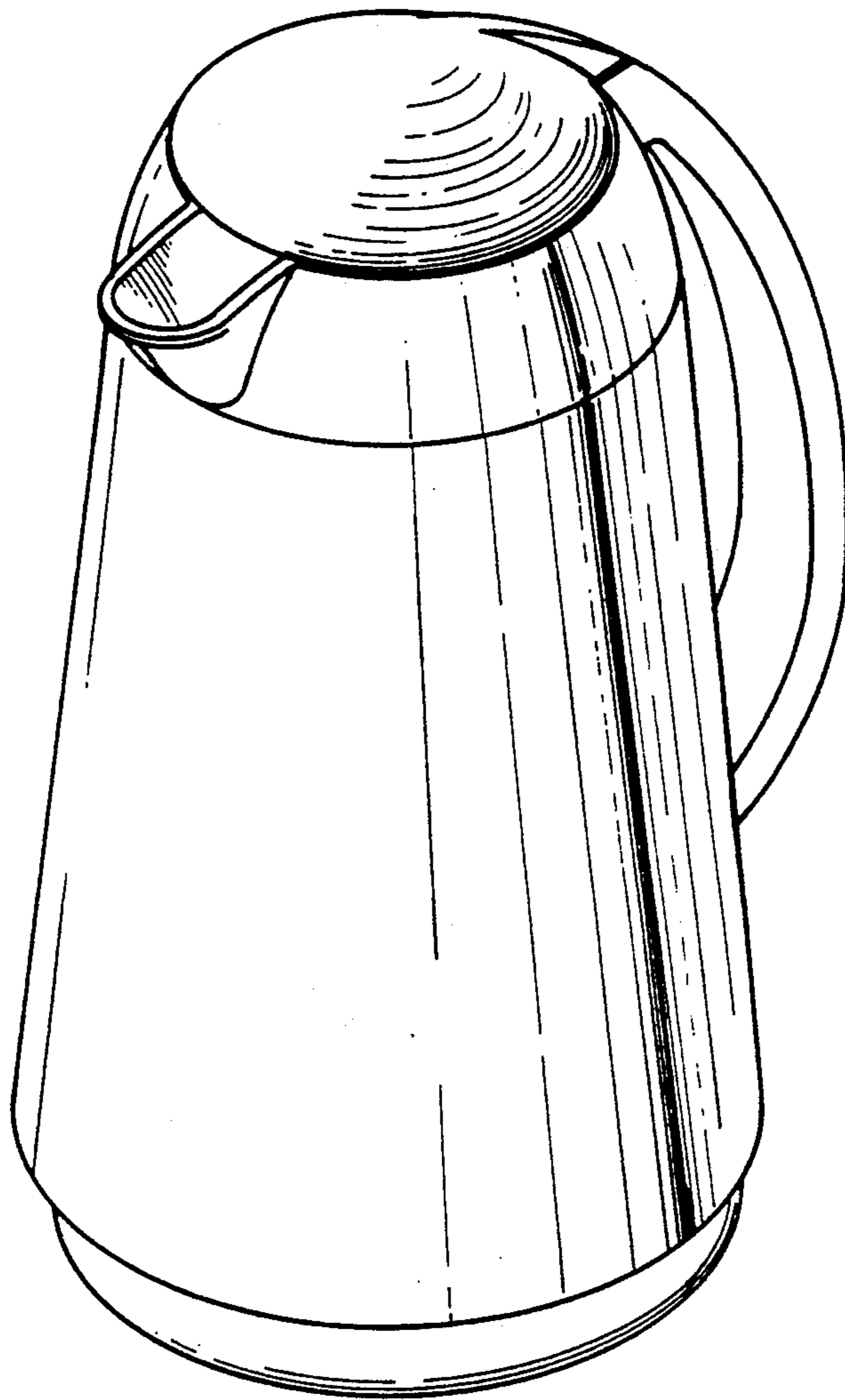

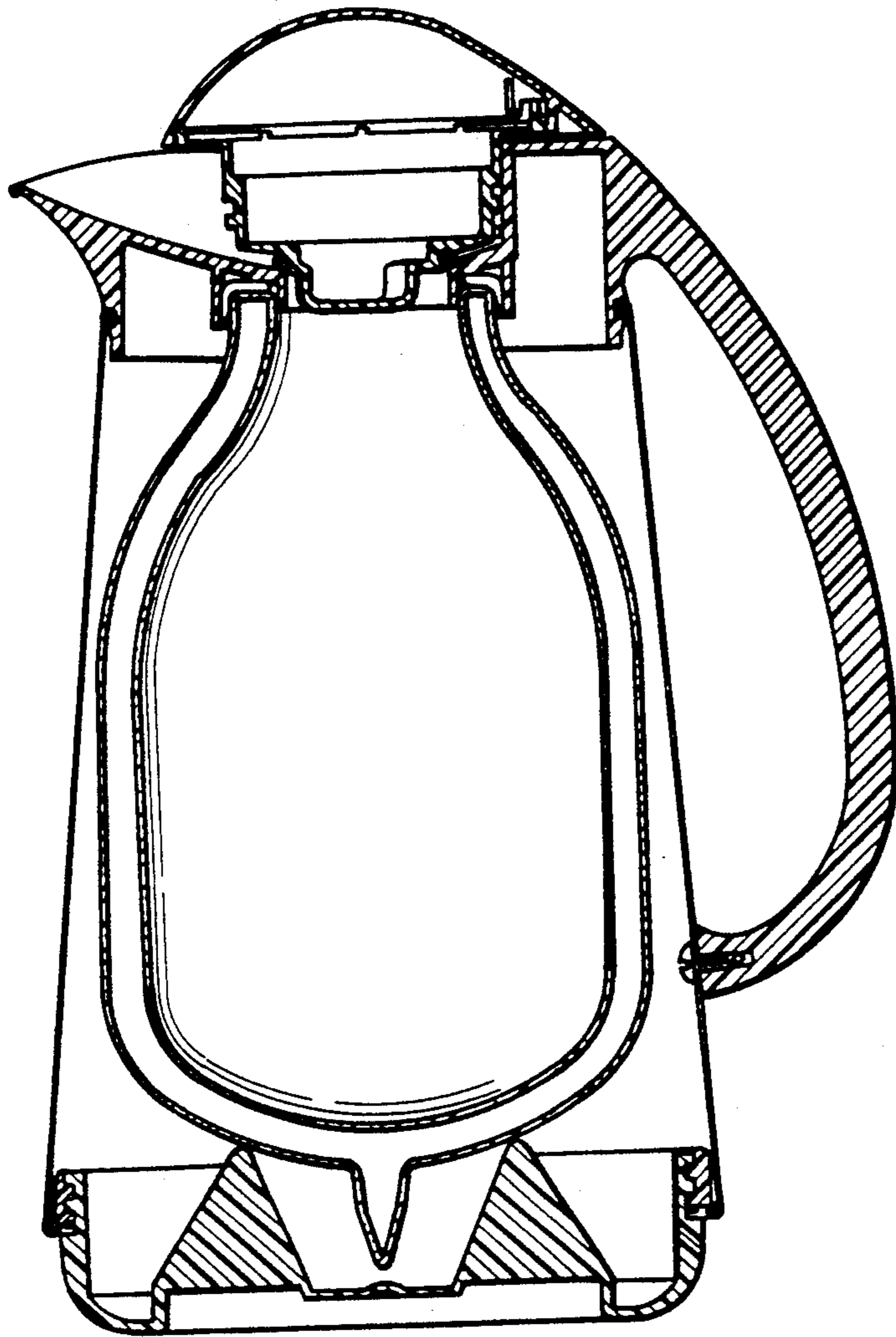

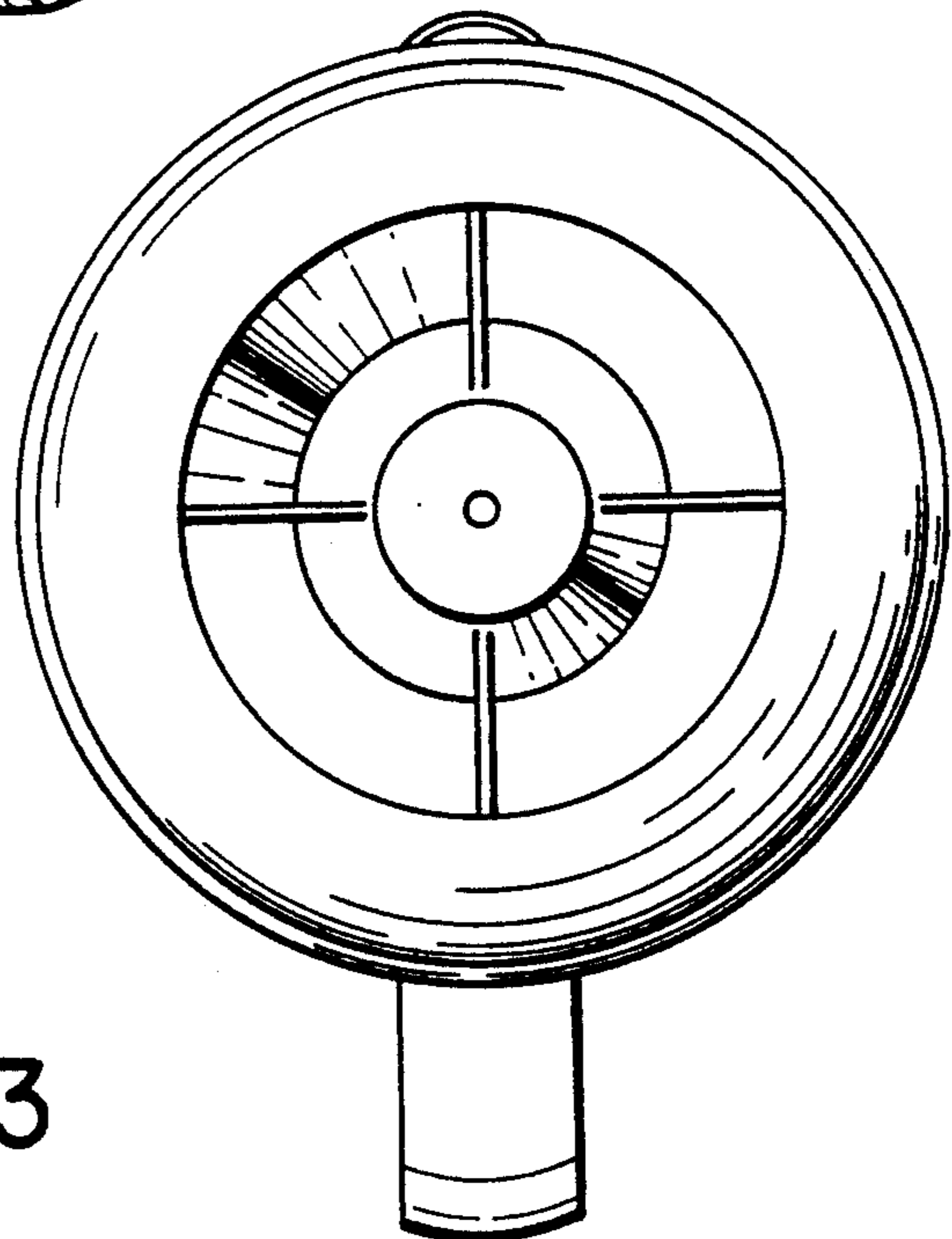

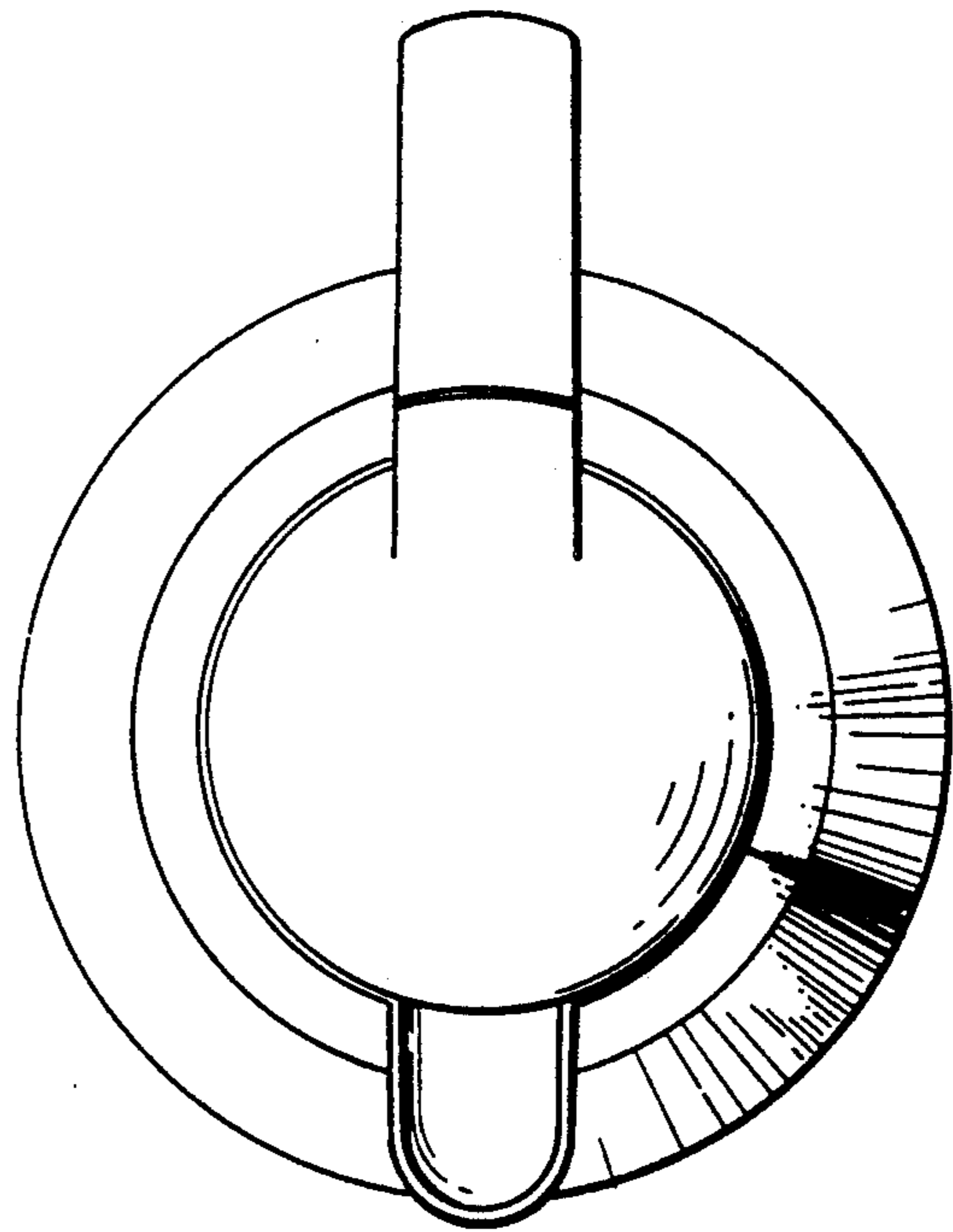

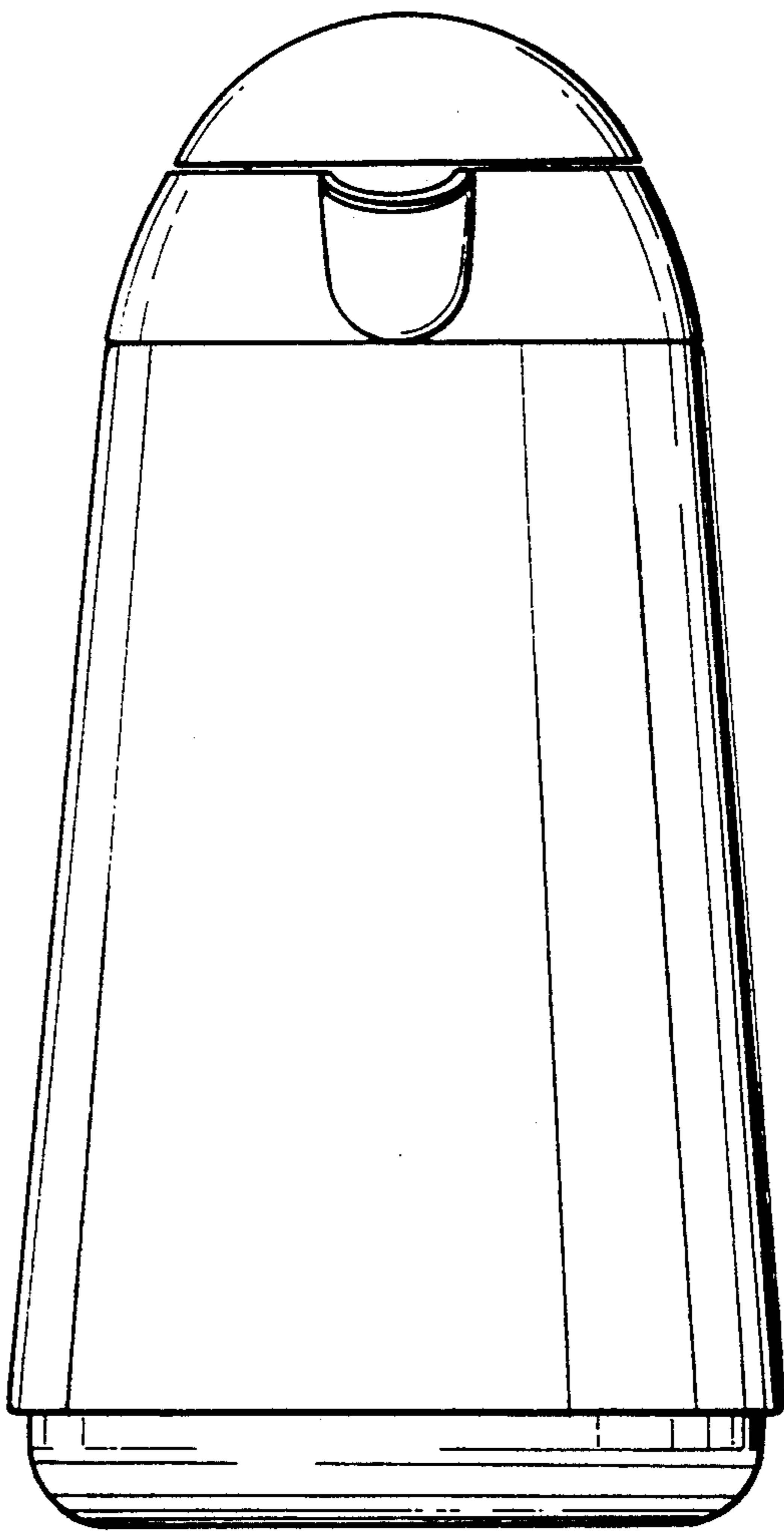

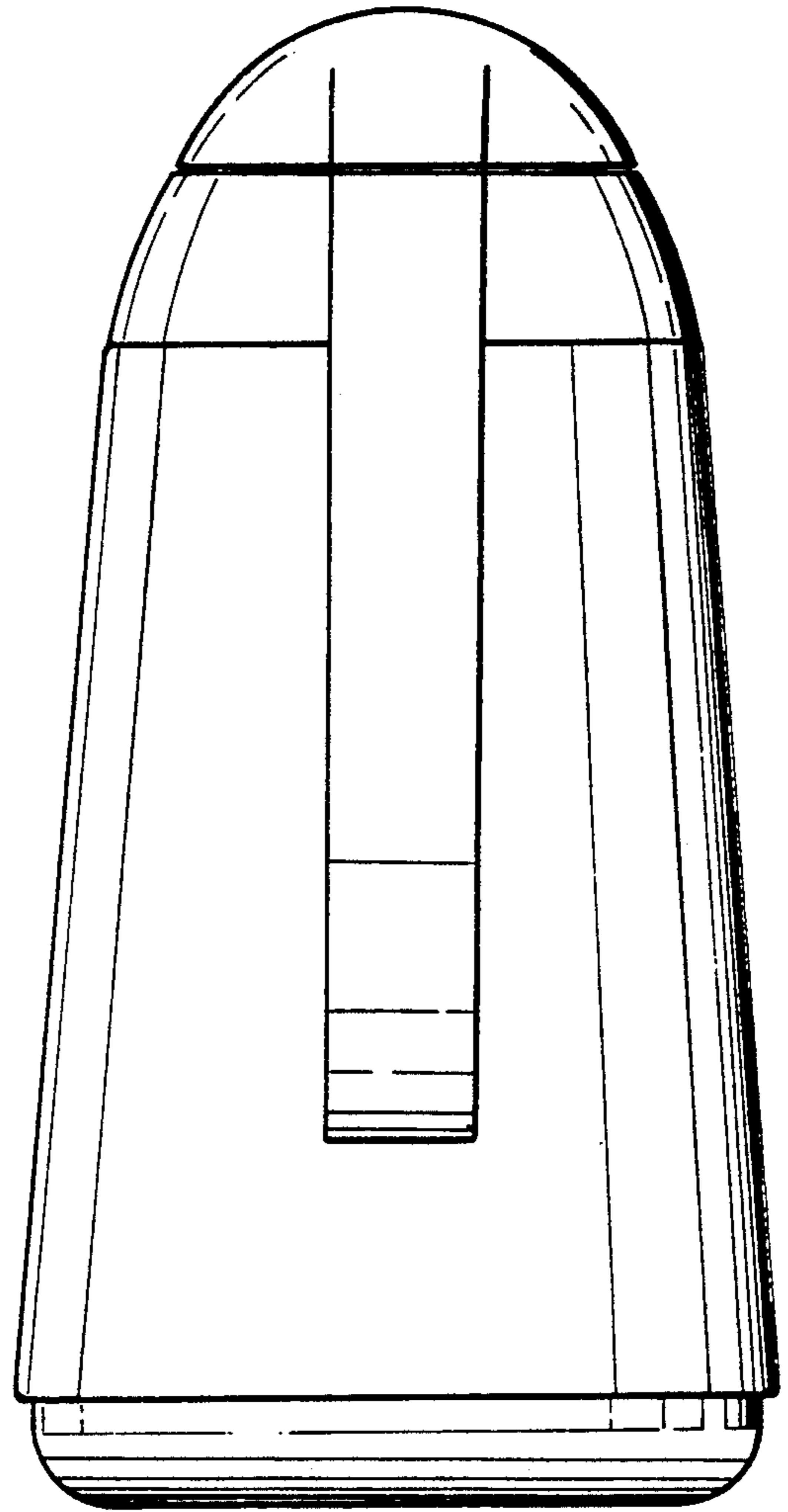
