[57] **CLAIM**

The ornamental design for a door prop, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a door prop showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a left side elevational view thereof taken at a 90 degree angle;

FIG. 5 is a right side elevational view thereof taken at a 270 degree angle;

FIG. 6 is a front elevational view thereof;

FIG. 7 is a rear elevational view thereof taken at a 180 degree angle;

FIG. 8 is a perspective view of a second embodiment of the design of FIG. 1;

FIG. 9 is a top plan view of FIG. 8;

FIG. 10 is a bottom plan view of FIG. 8;

FIG. 11 is a left side elevational view of FIG. 8 taken at a 90 degree angle;

FIG. 12 is a right side elevational view of FIG. 8 taken at a 270 degree angle;

FIG. 13 is a front elevational view of FIG. 8;

FIG. 14 is a rear elevational view of FIG. 8 taken at a 180 degree angle;

FIG. 15 is a perspective view of a third embodiment of the design of FIG. 1;

FIG. 16 is a top plan view of FIG. 15;

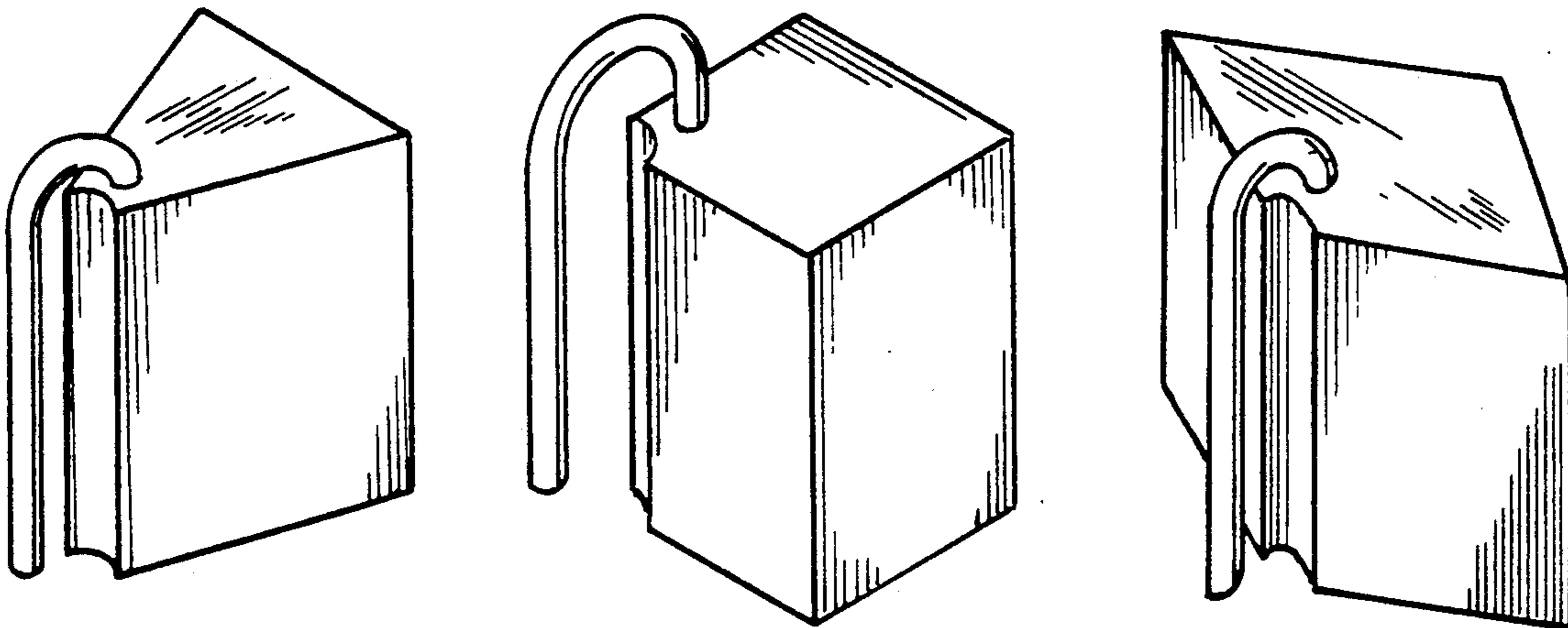
FIG. 17 is a bottom plan view of FIG. 15;

FIG. 21 is a rear elevational view of FIG. 15 taken at a 180 degree angle.



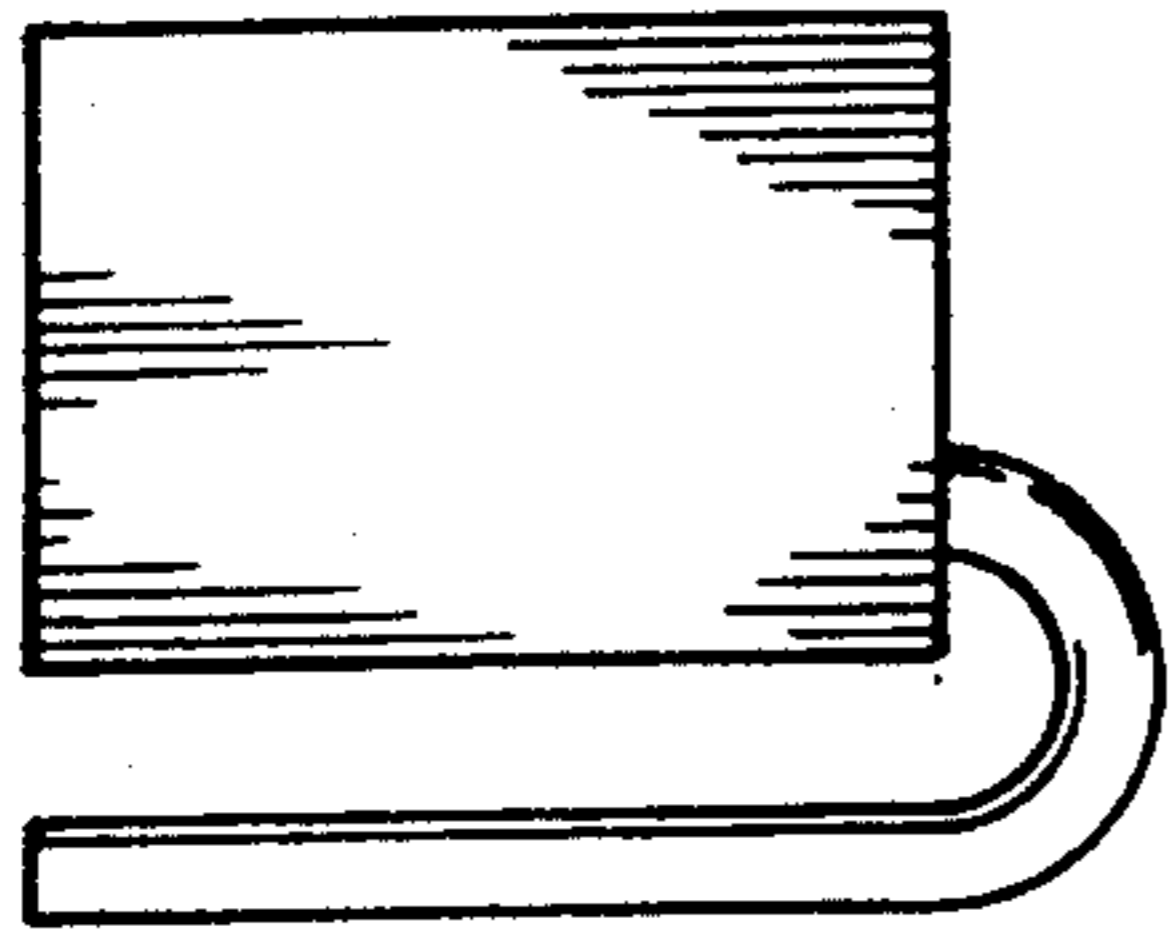

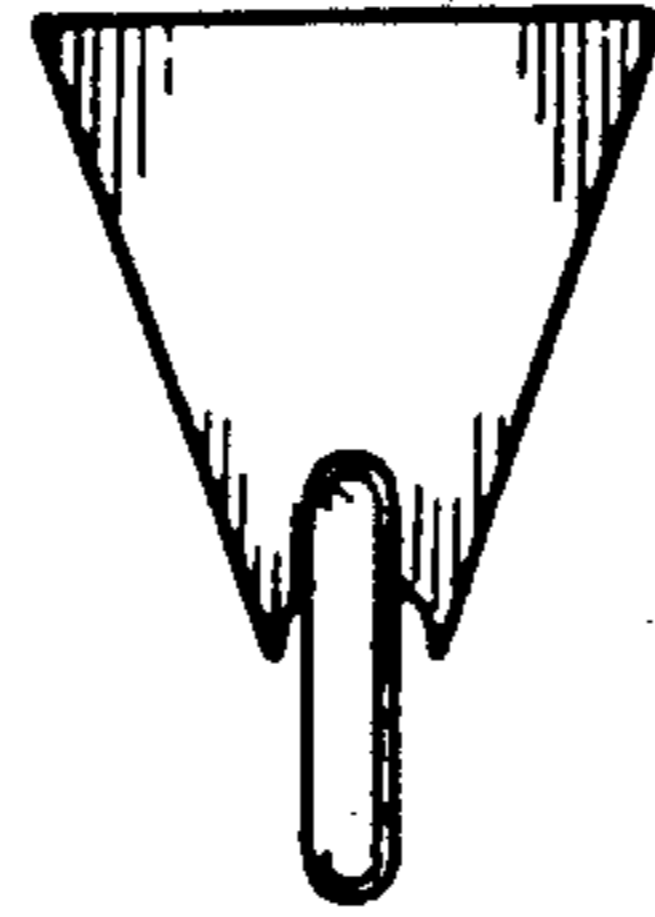

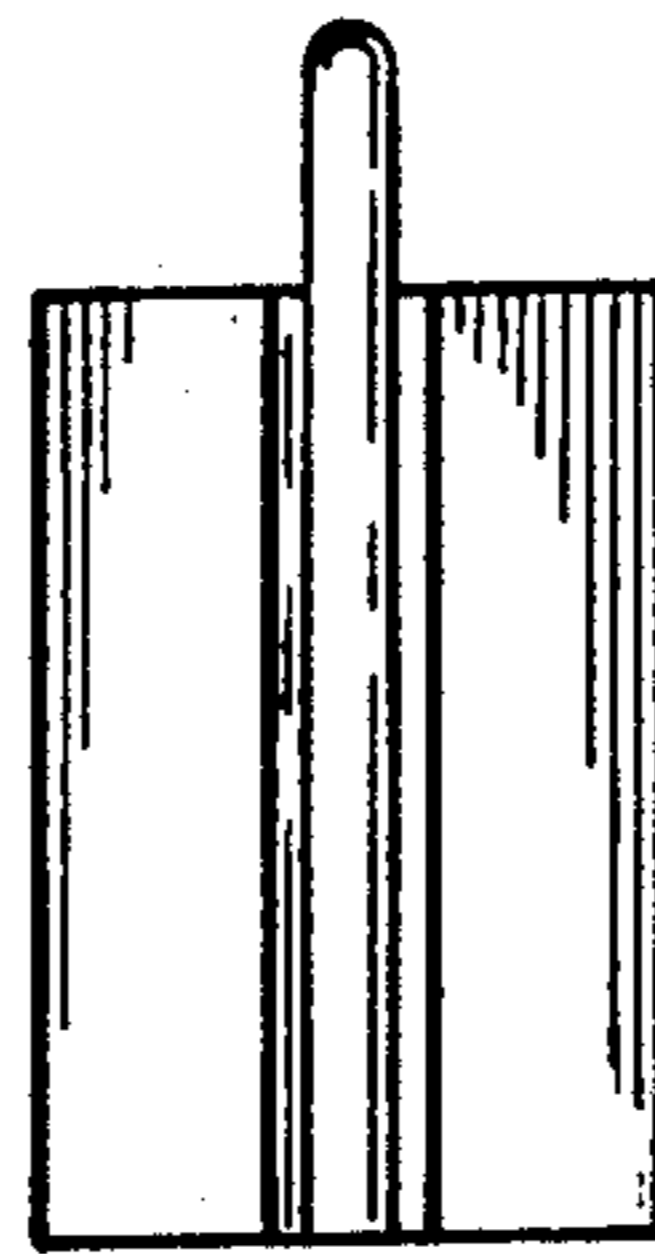

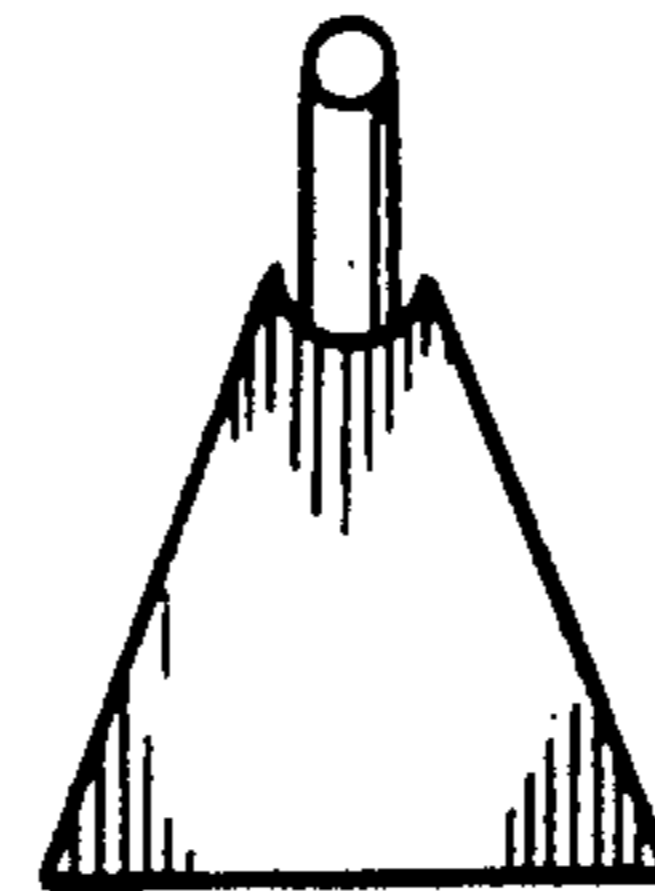

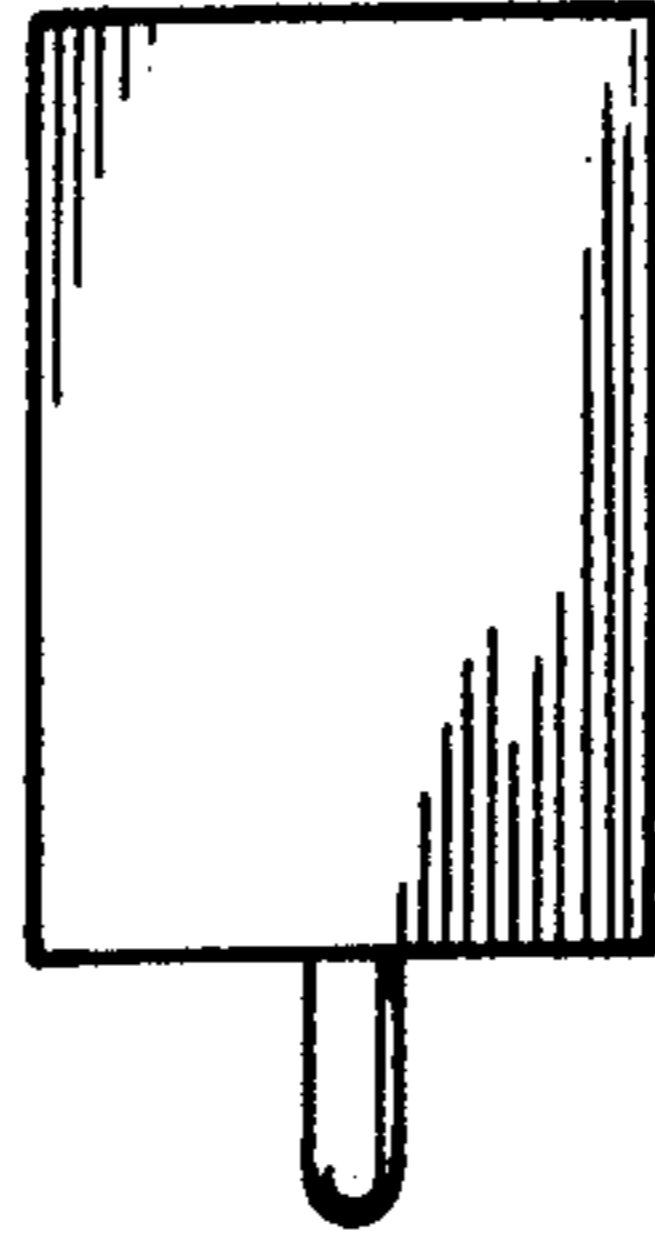

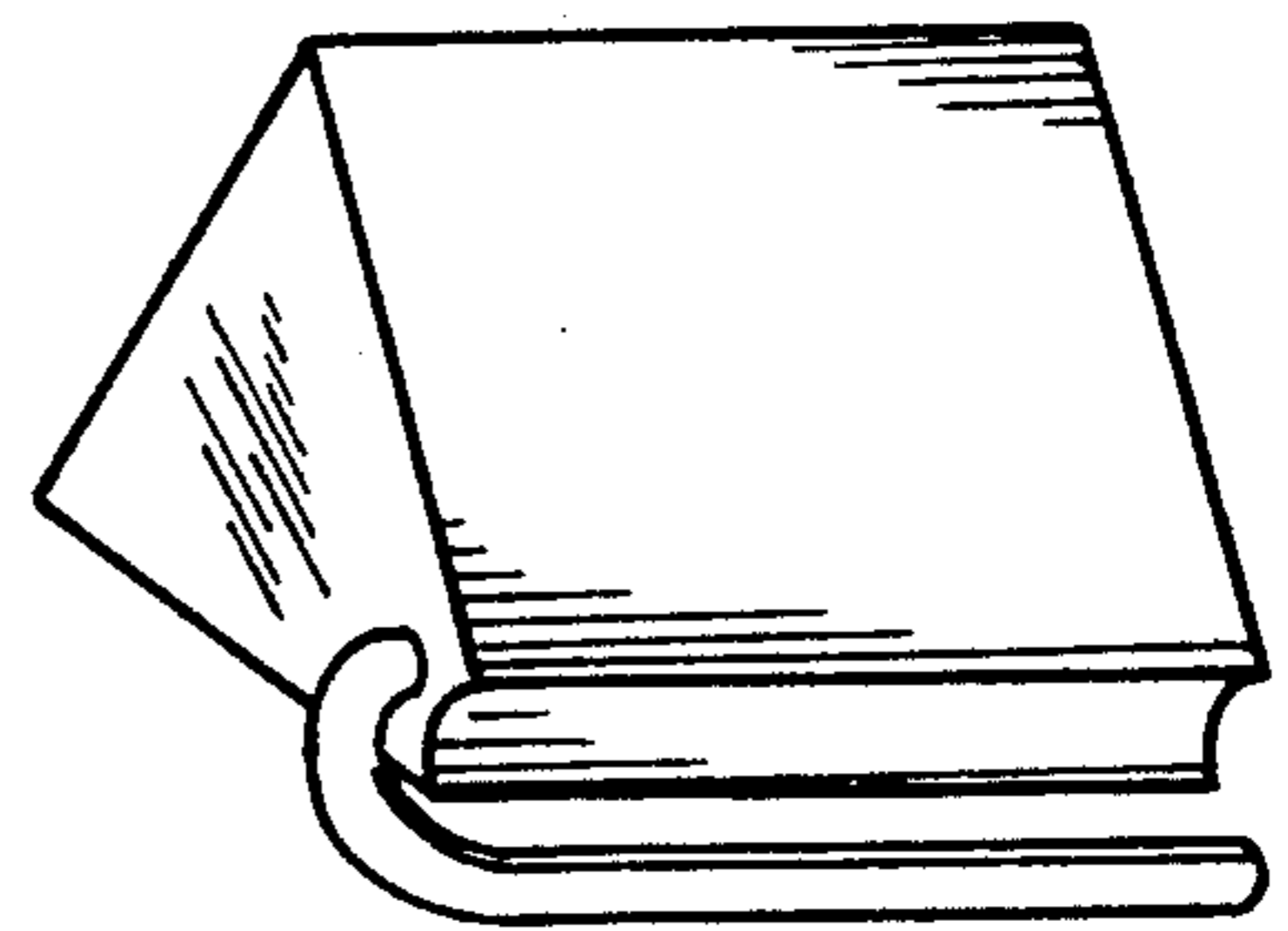

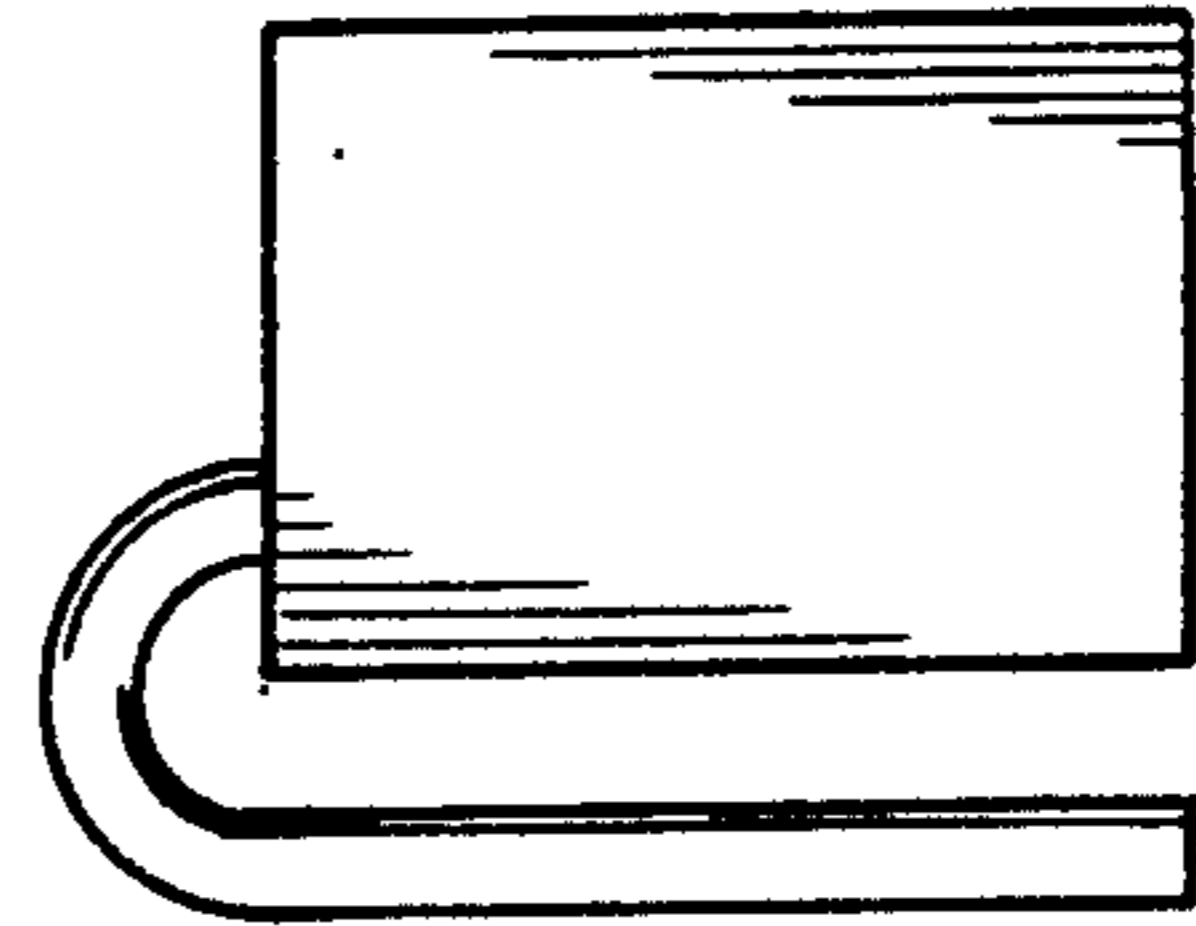

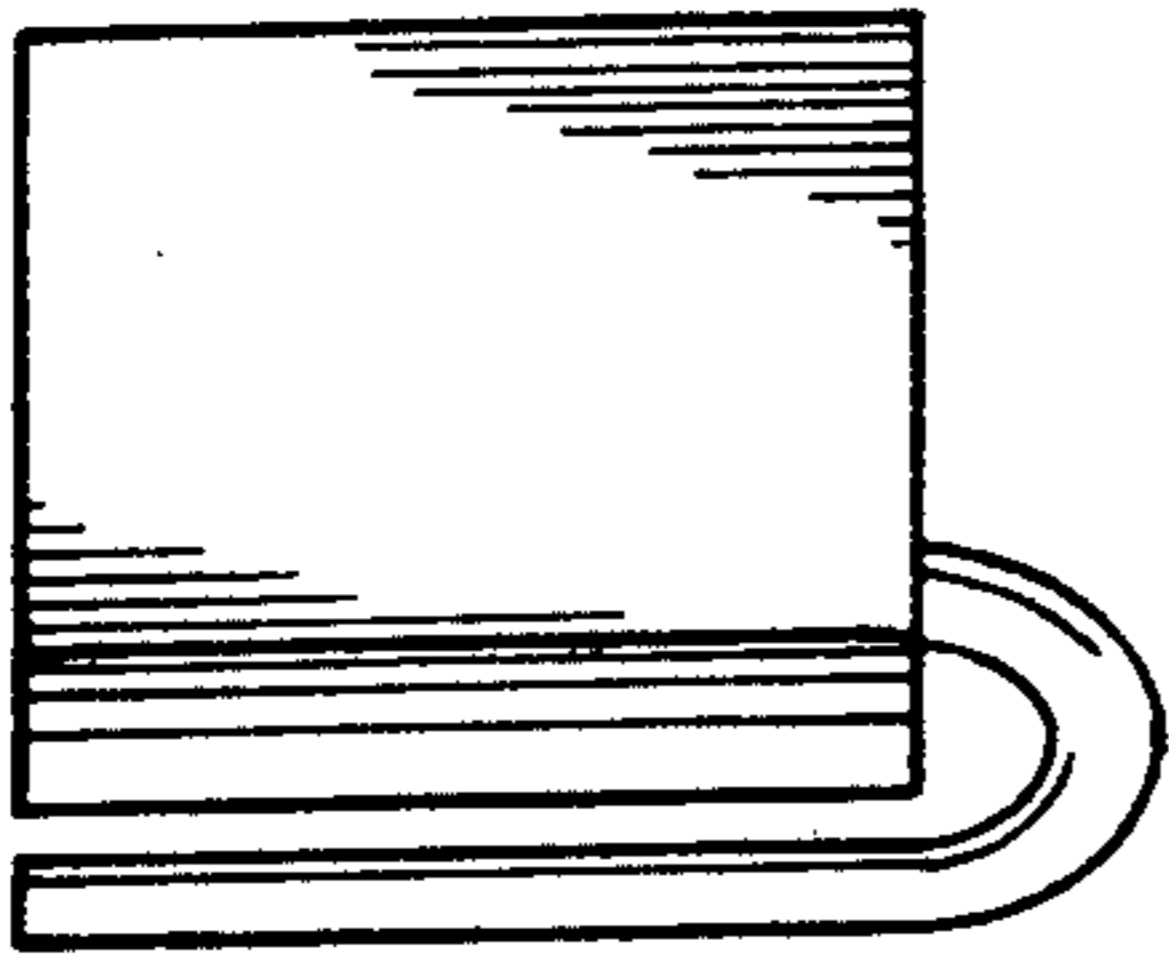

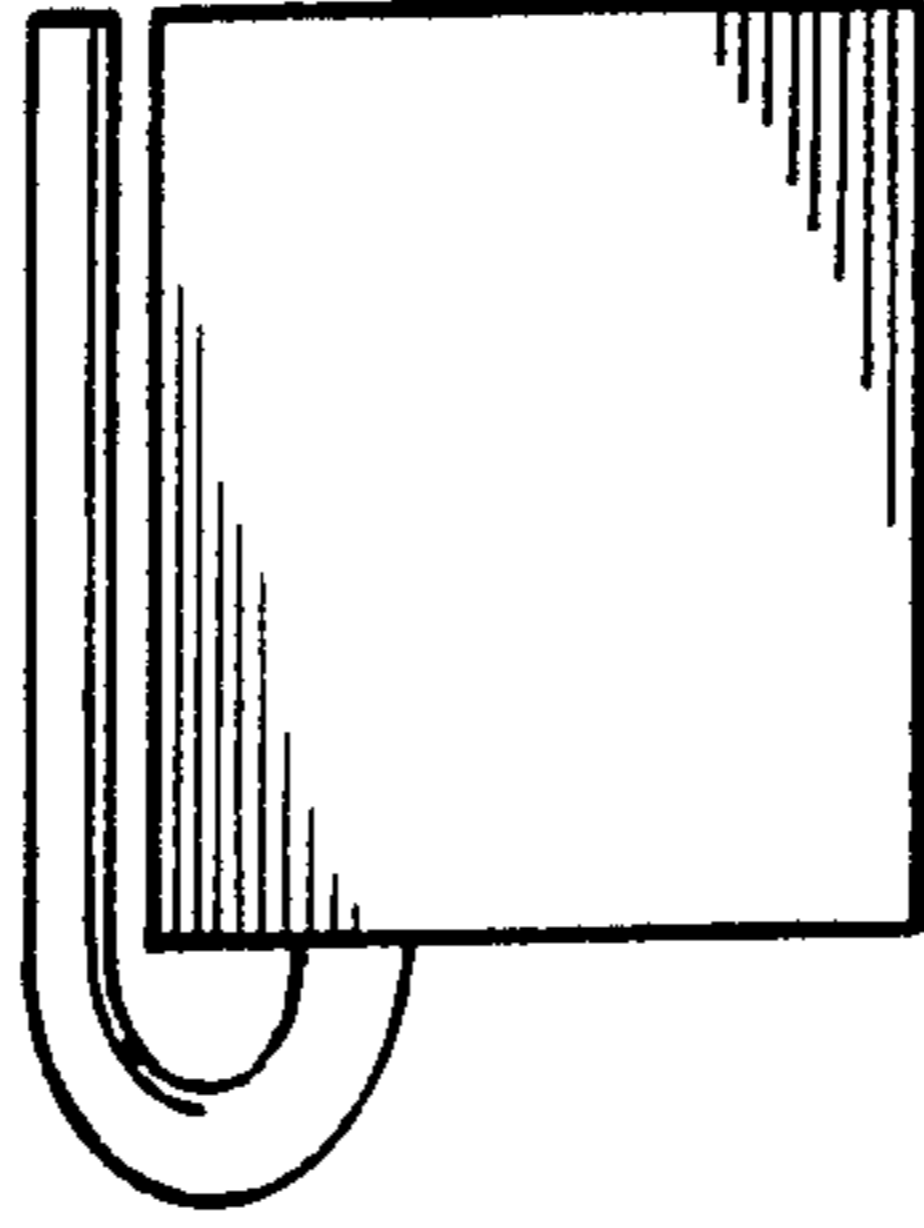

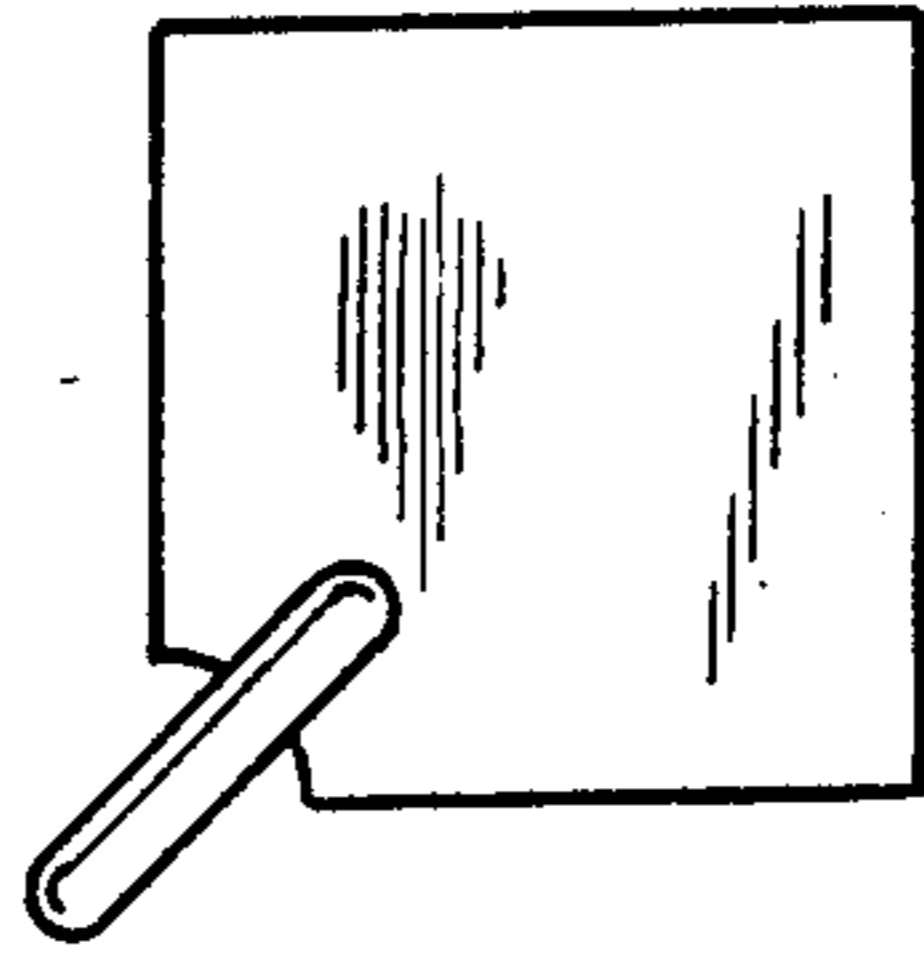

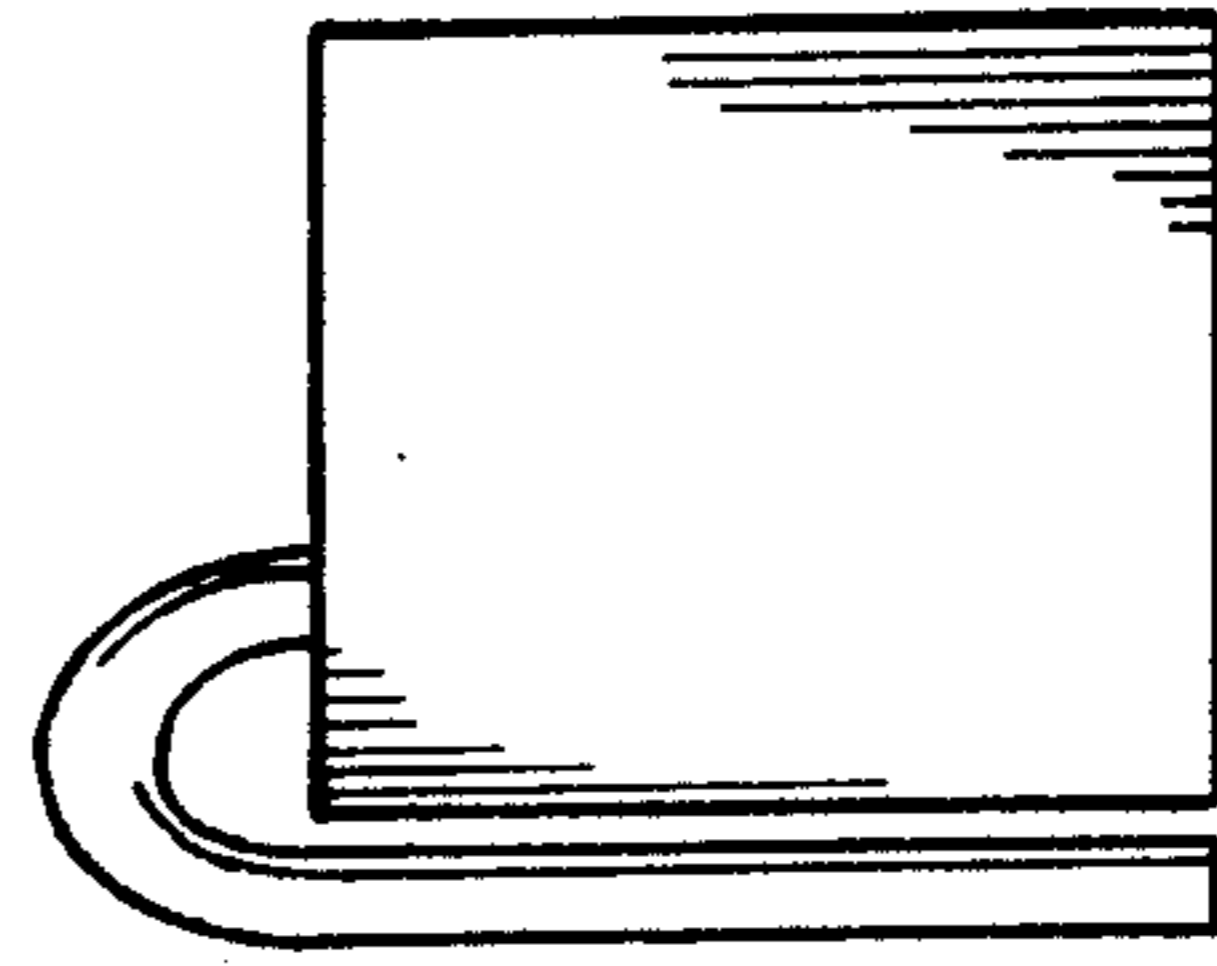

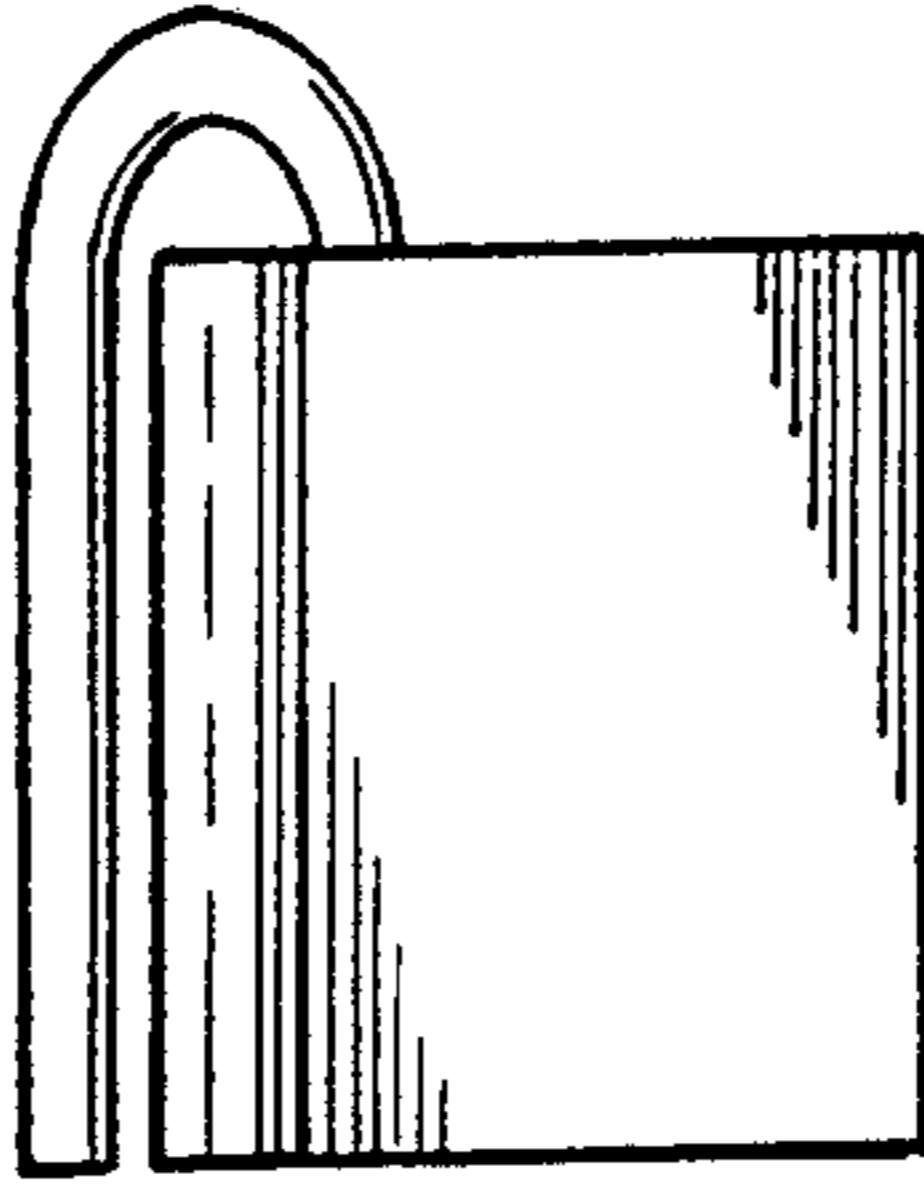

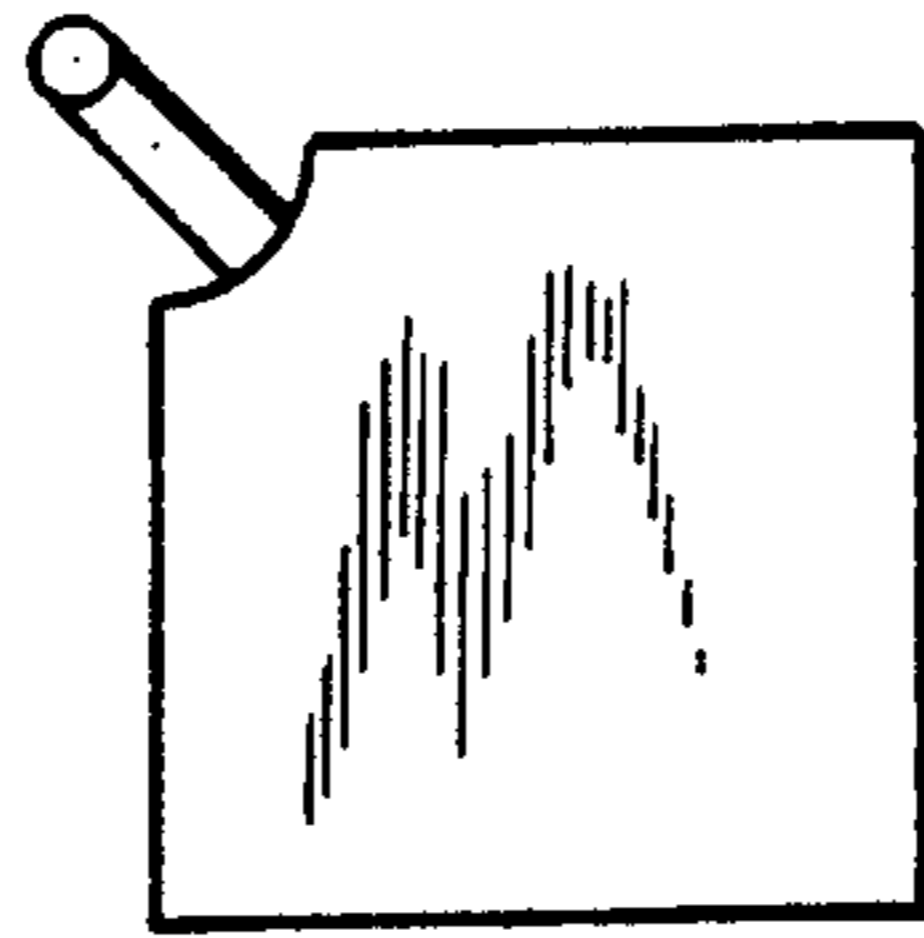

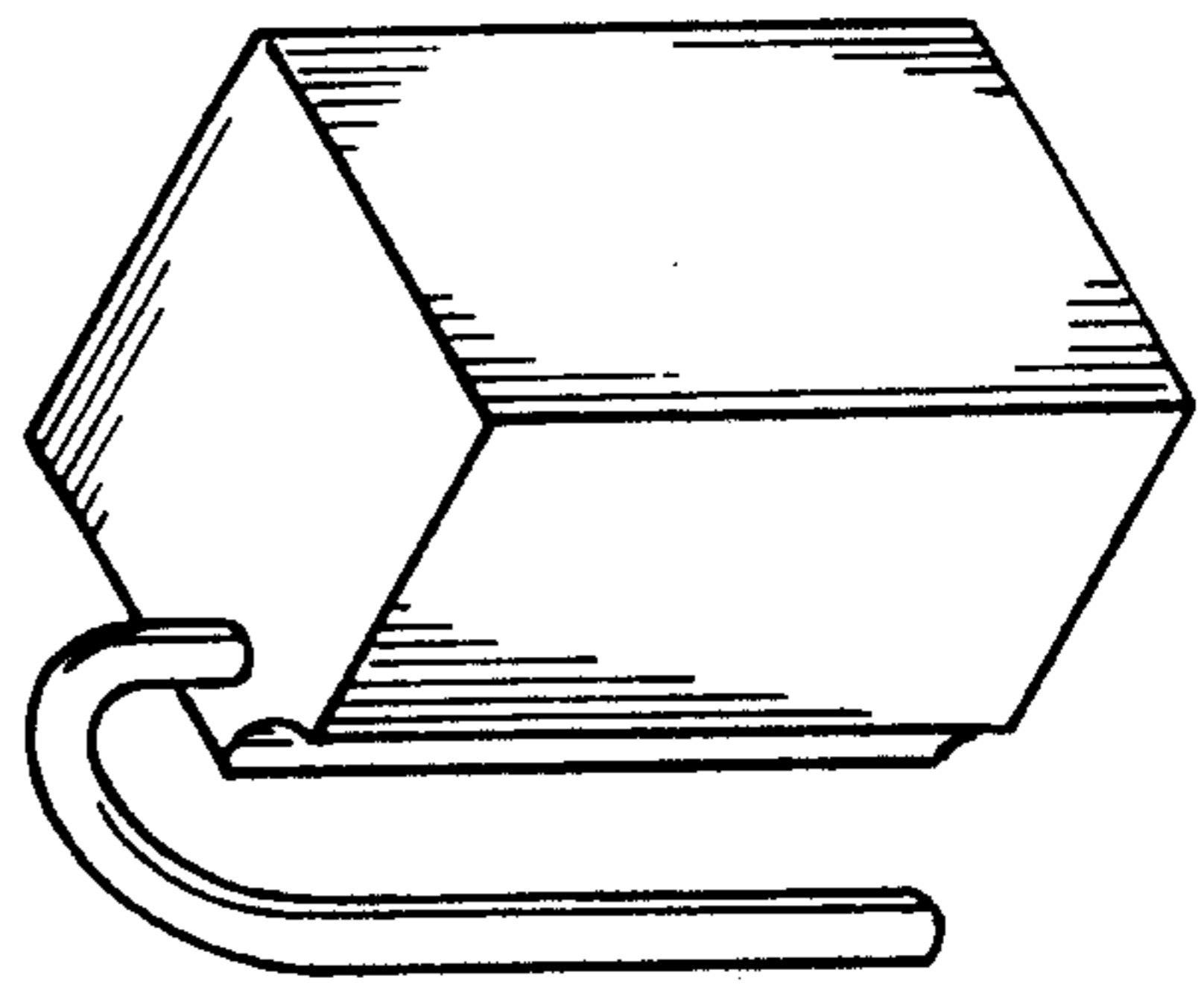

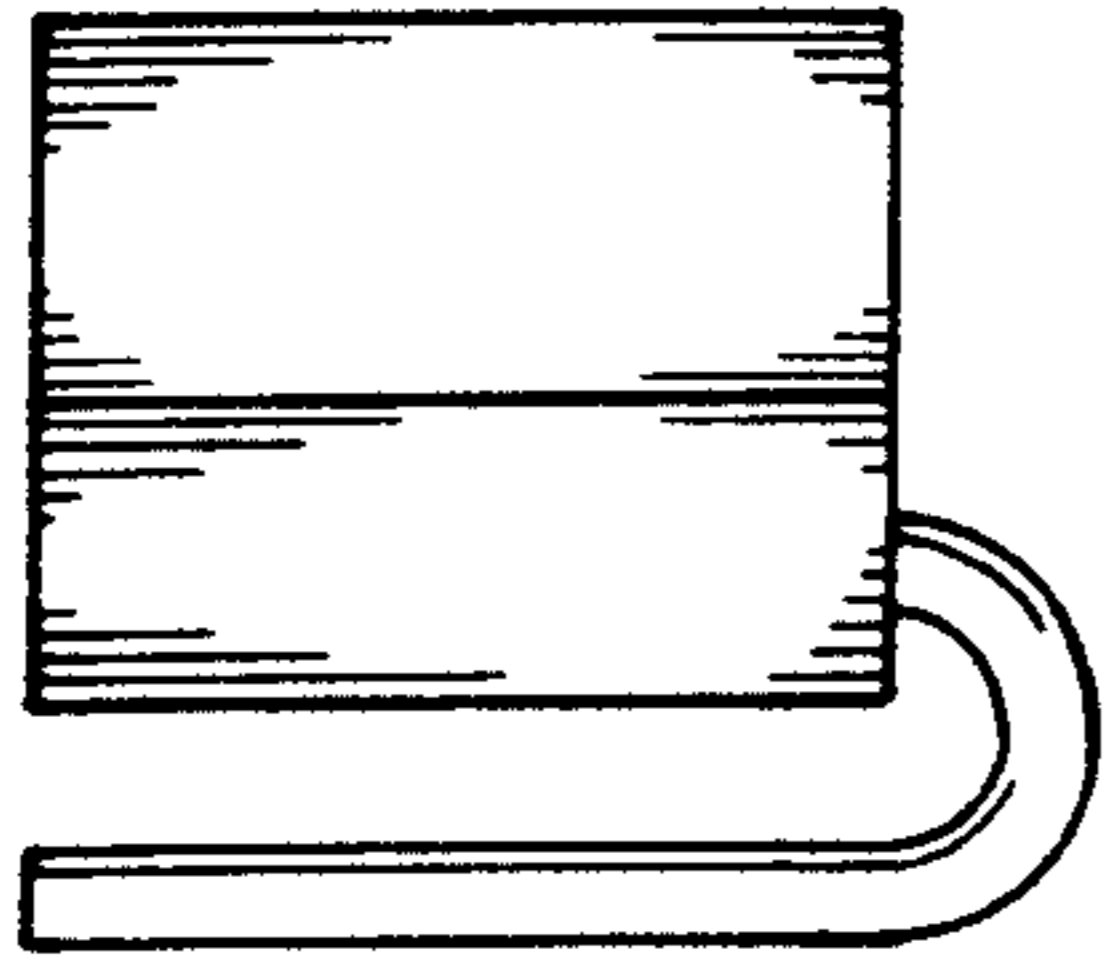

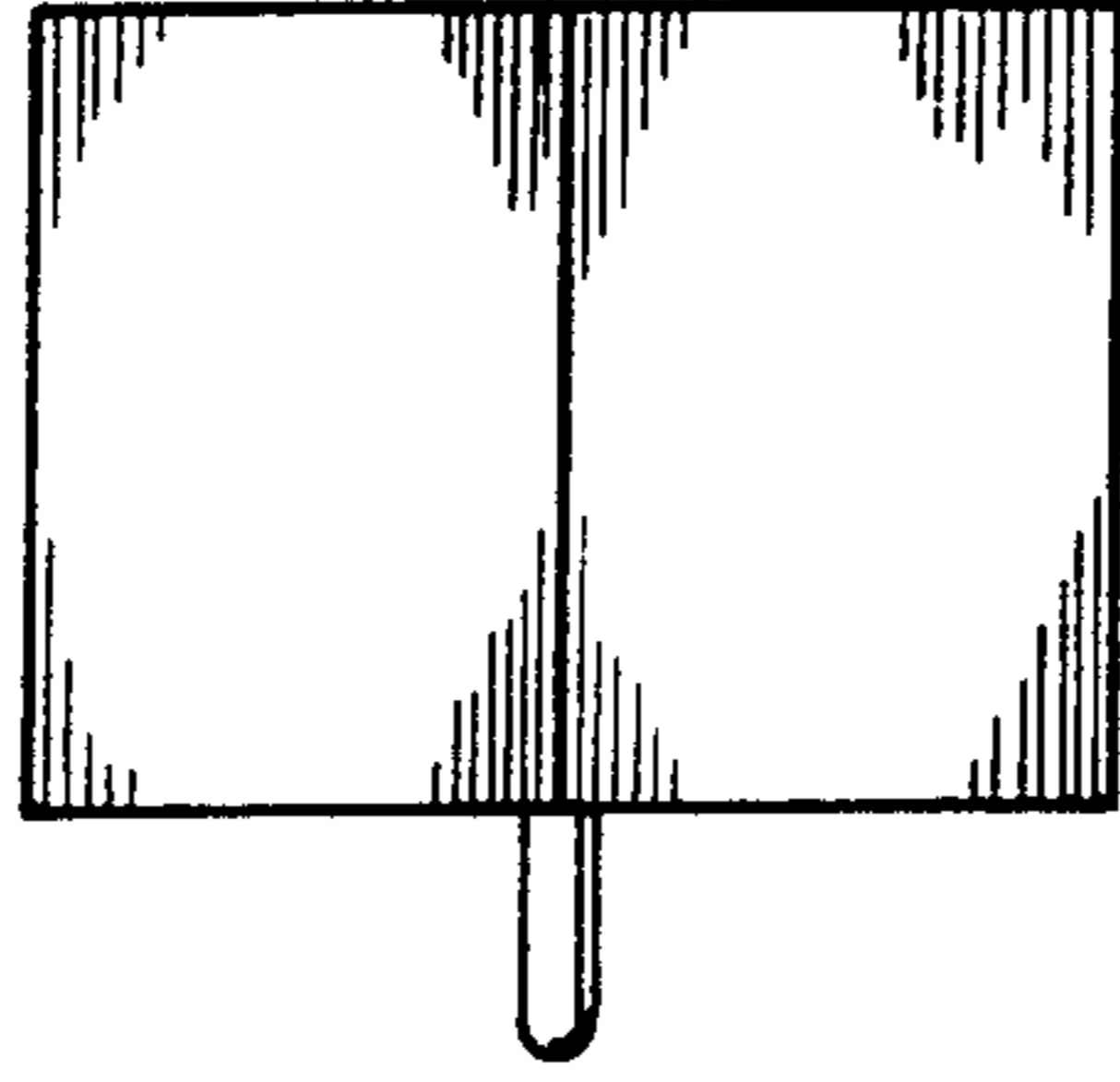

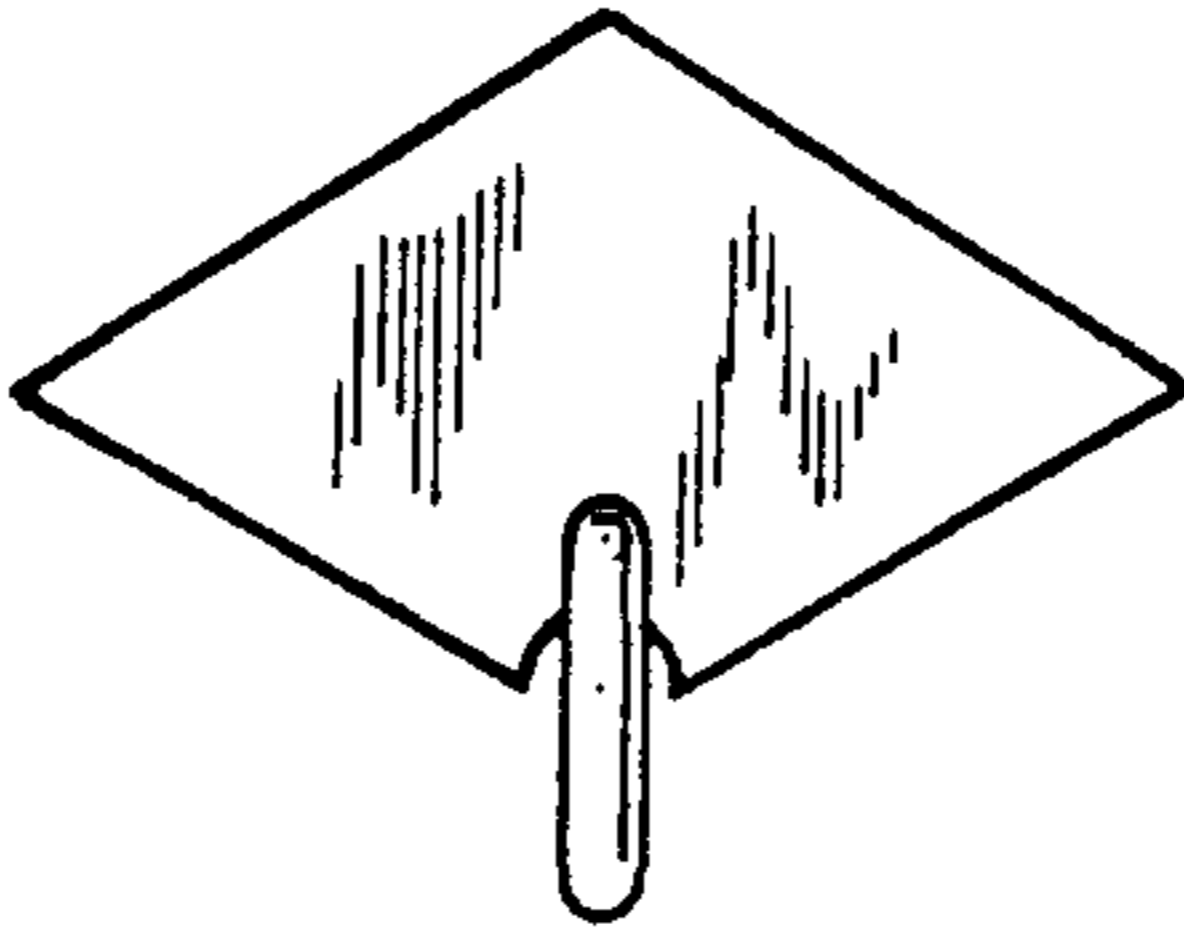

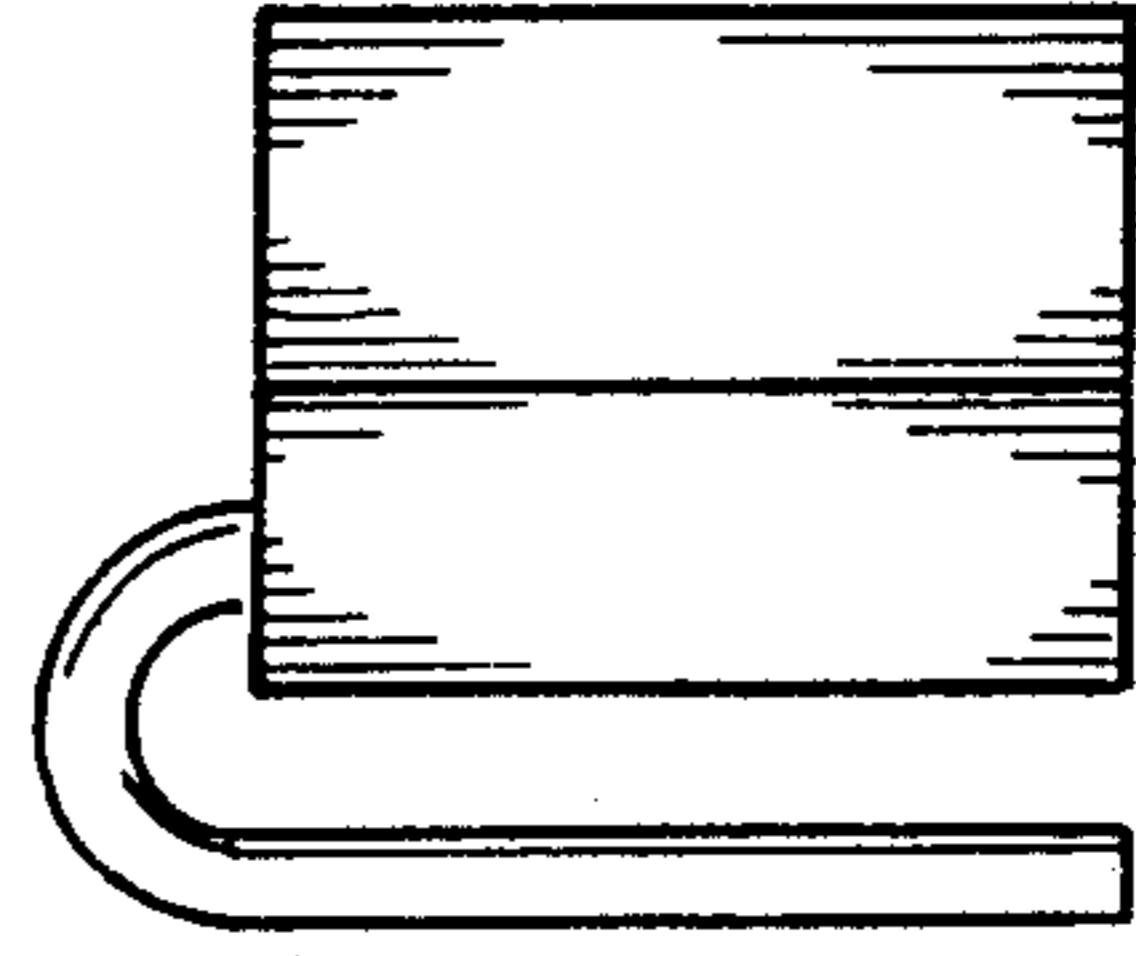

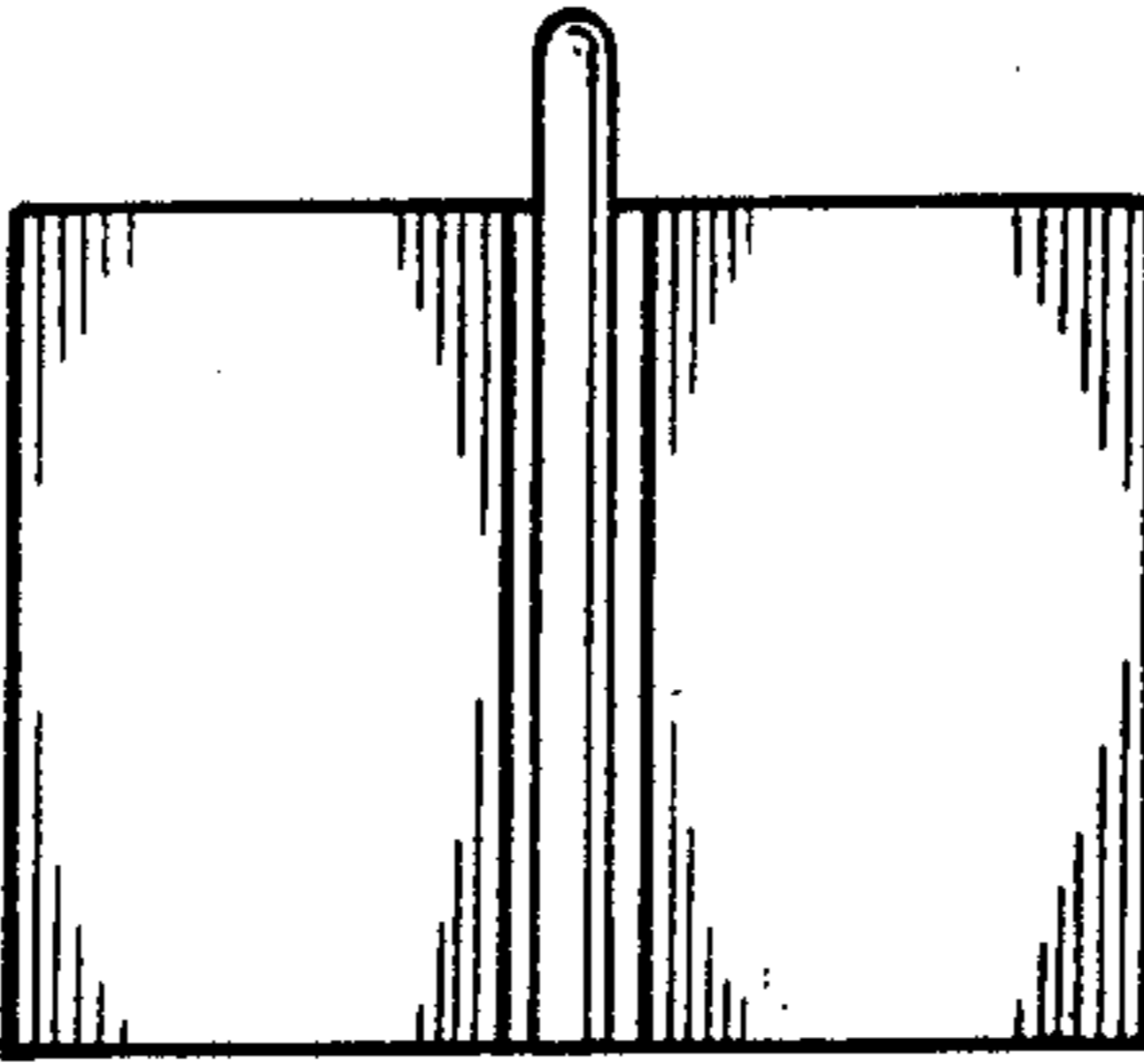

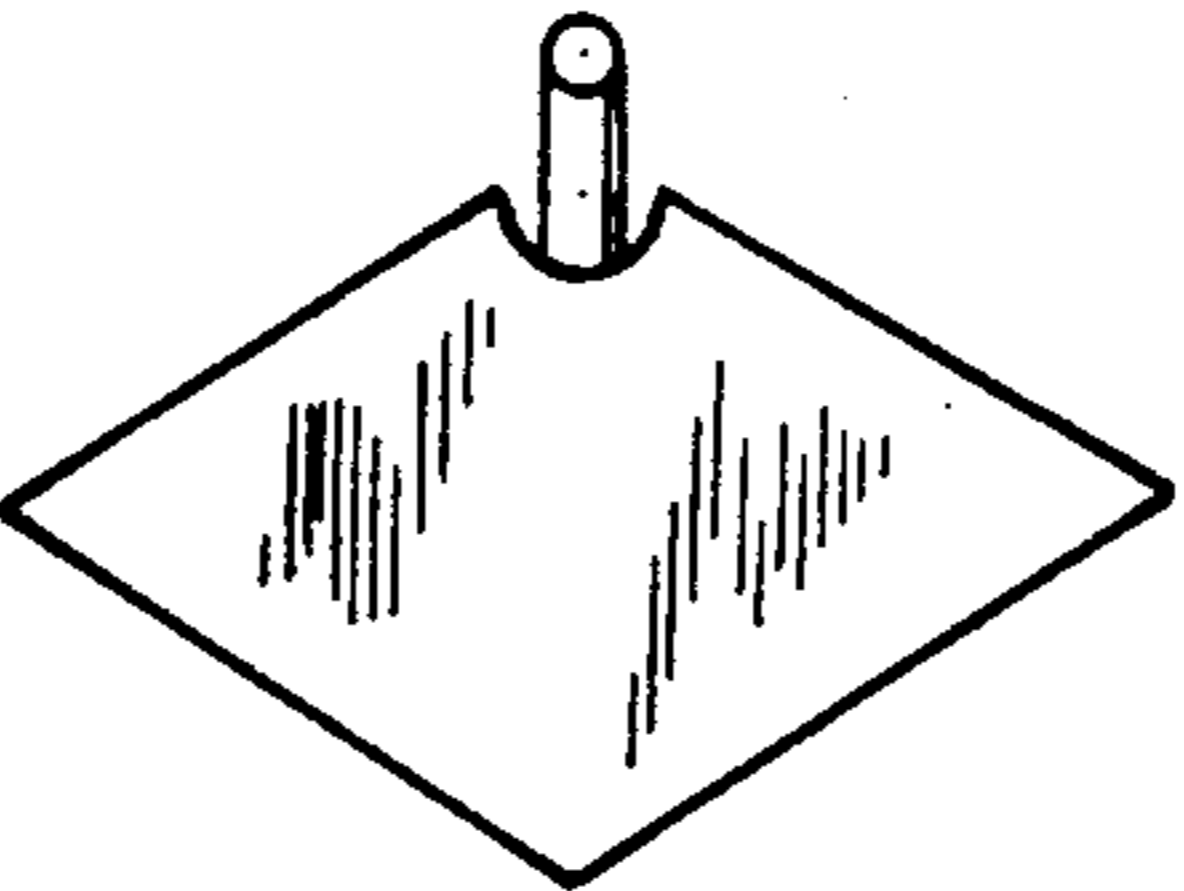

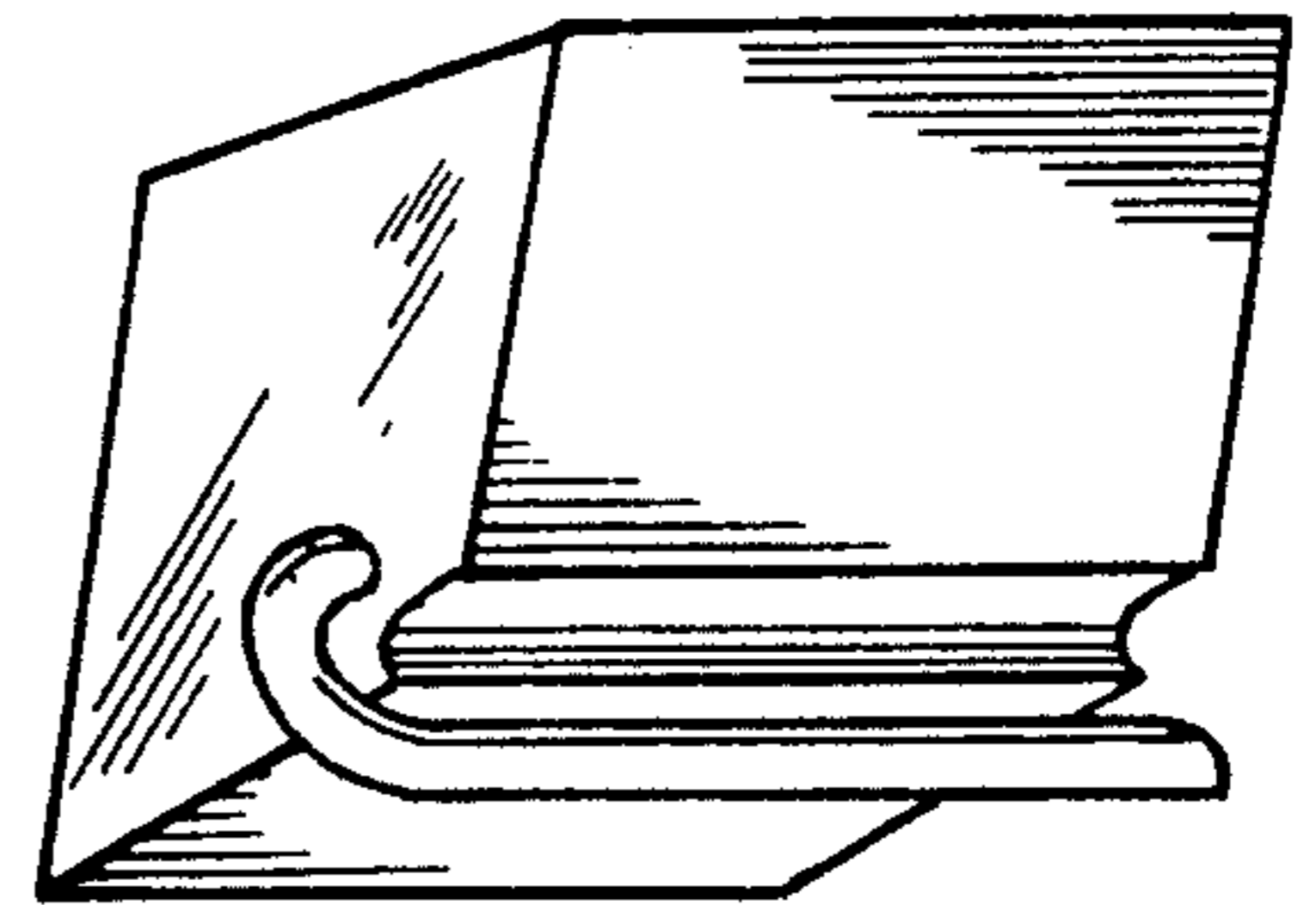
