The ornamental design for a voice controlled telephone with loudspeaker, as shown and described.

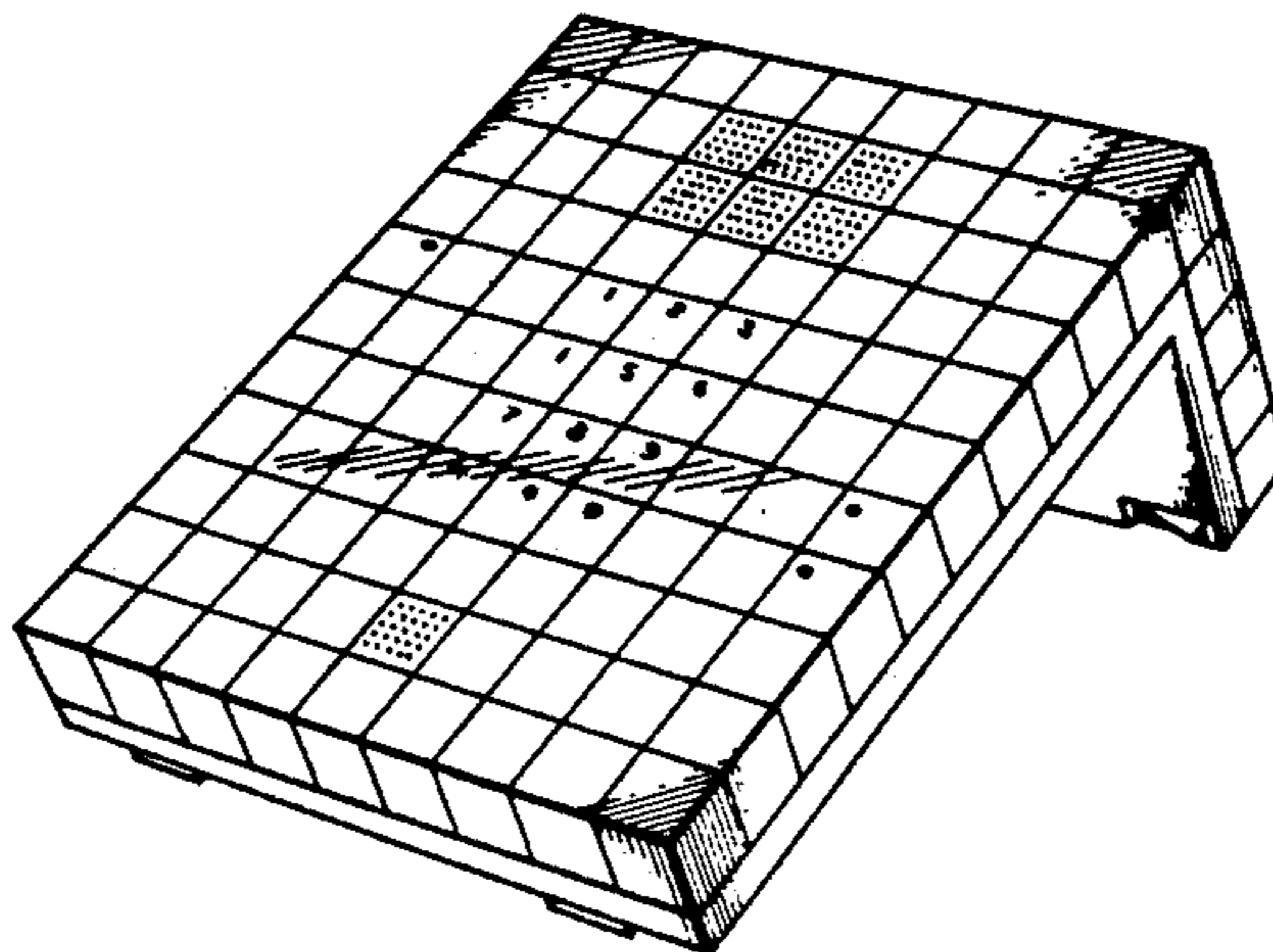
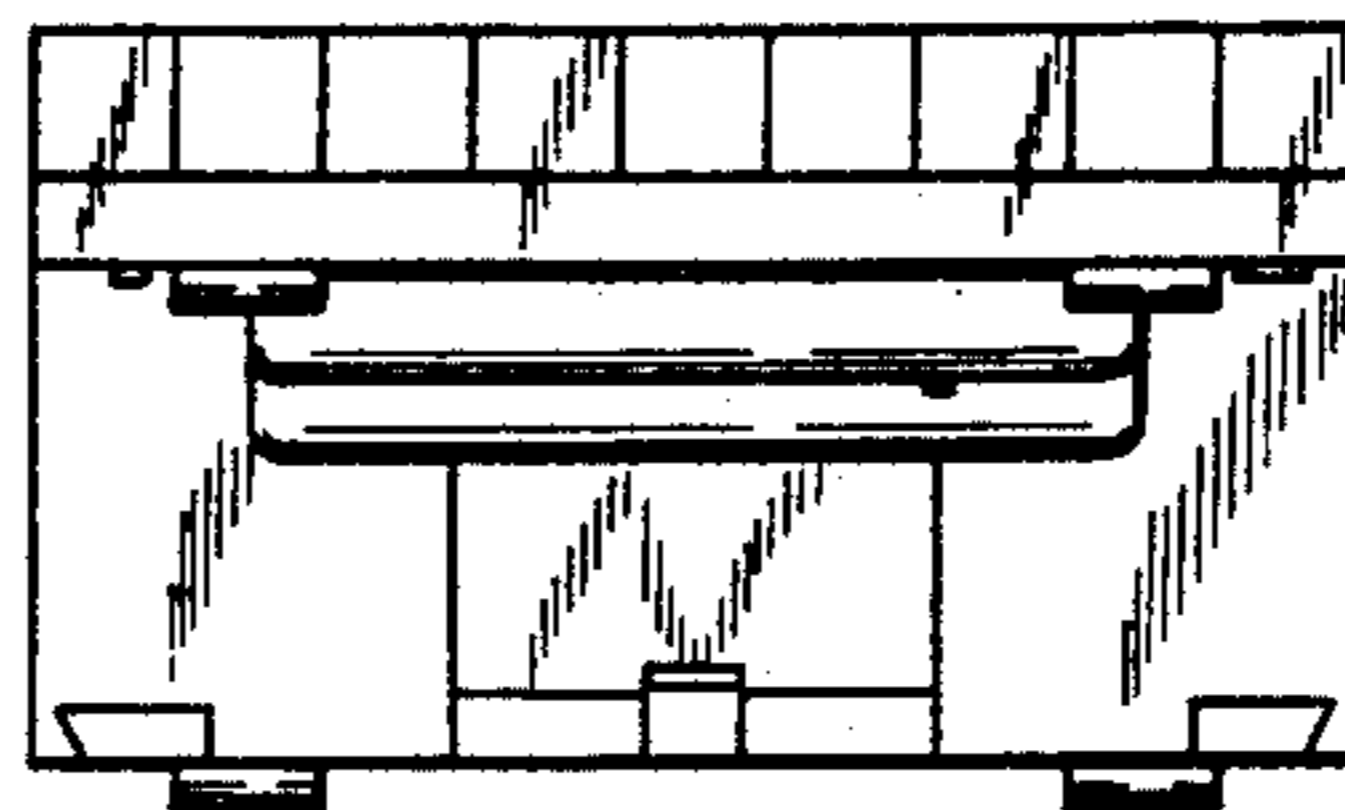
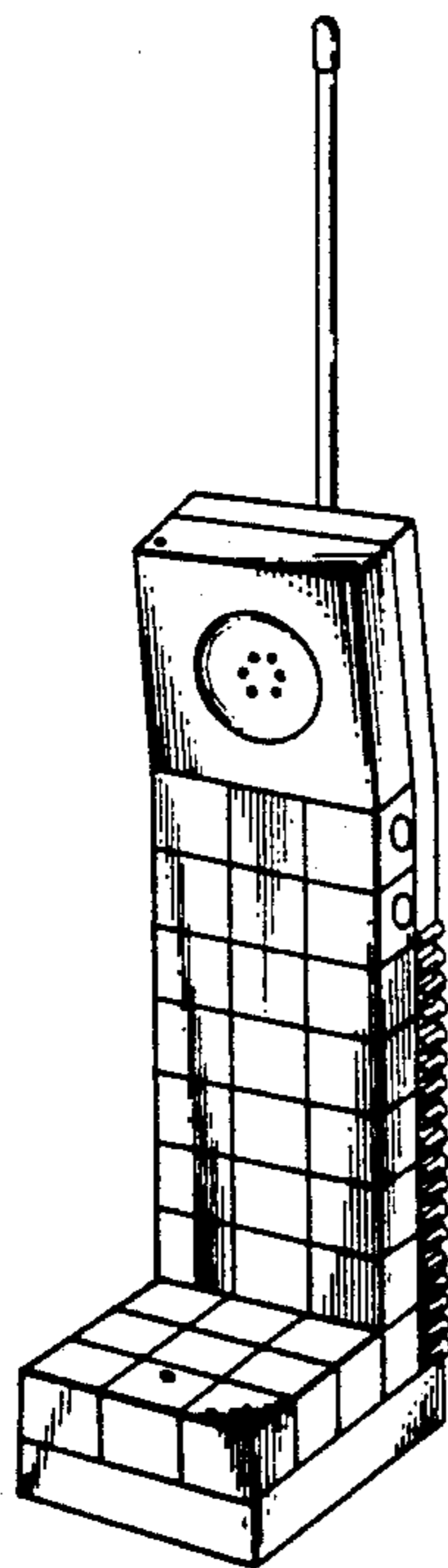
**DESCRIPTION**

FIGS. 1 and 2 are respectively front and rear elevational views of a voice controlled telephone with loudspeaker showing our new design;

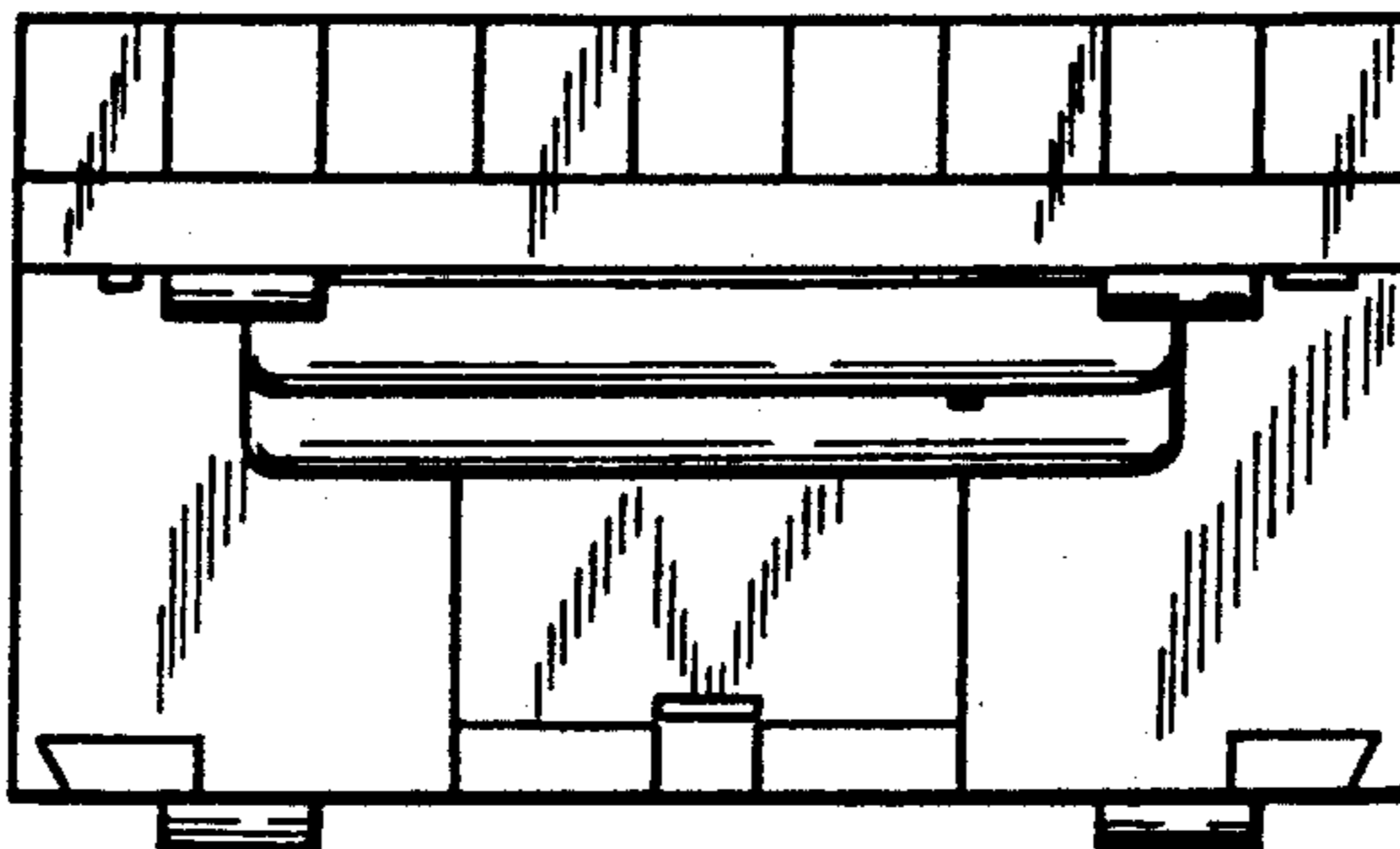
FIGS. 3 and 4 are respectively top and bottom plan views thereof;

FIGS. 5 and 6 are respectively left and right side elevational view thereof; and

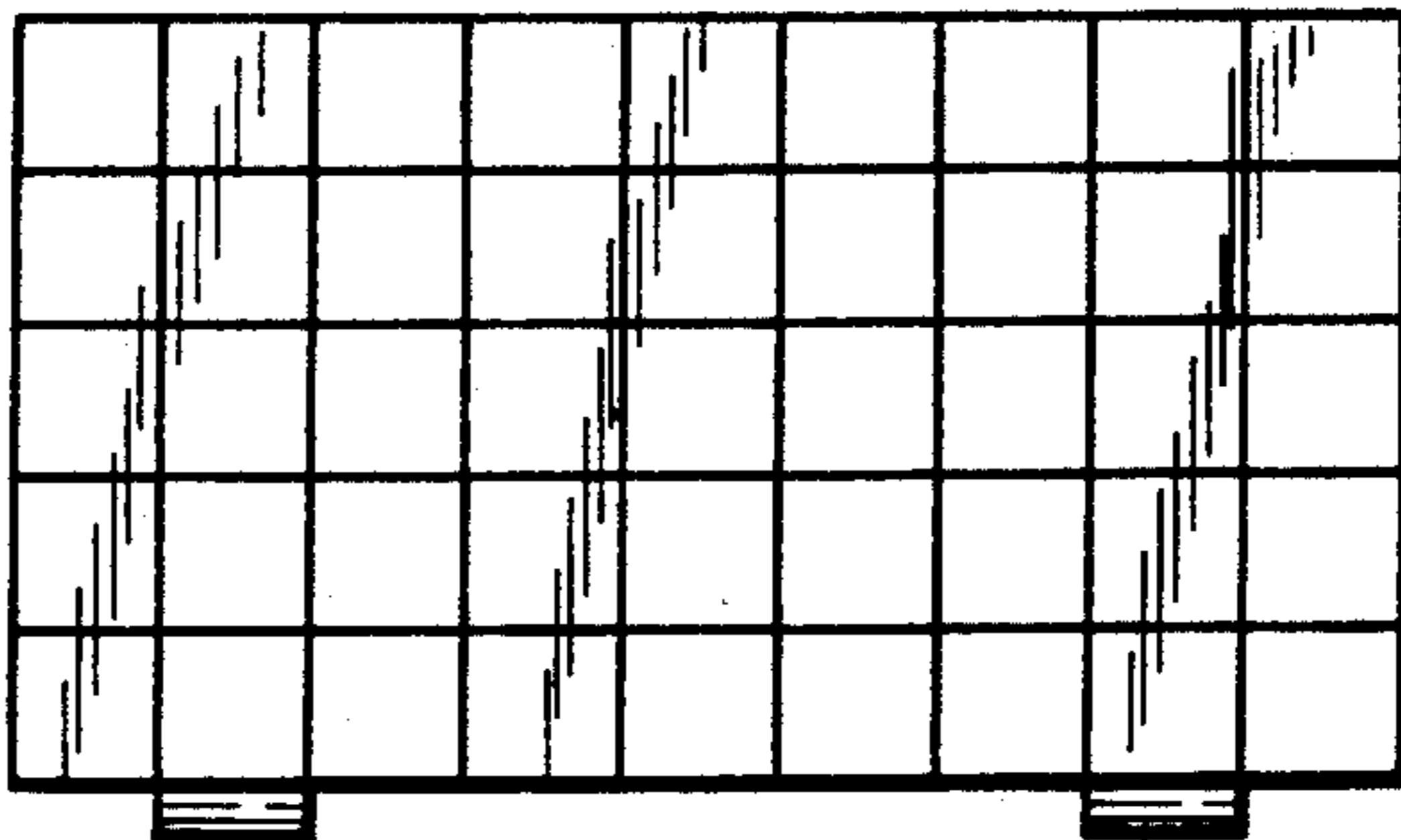
FIG. 7 is a front, top and right side perspective view thereof.



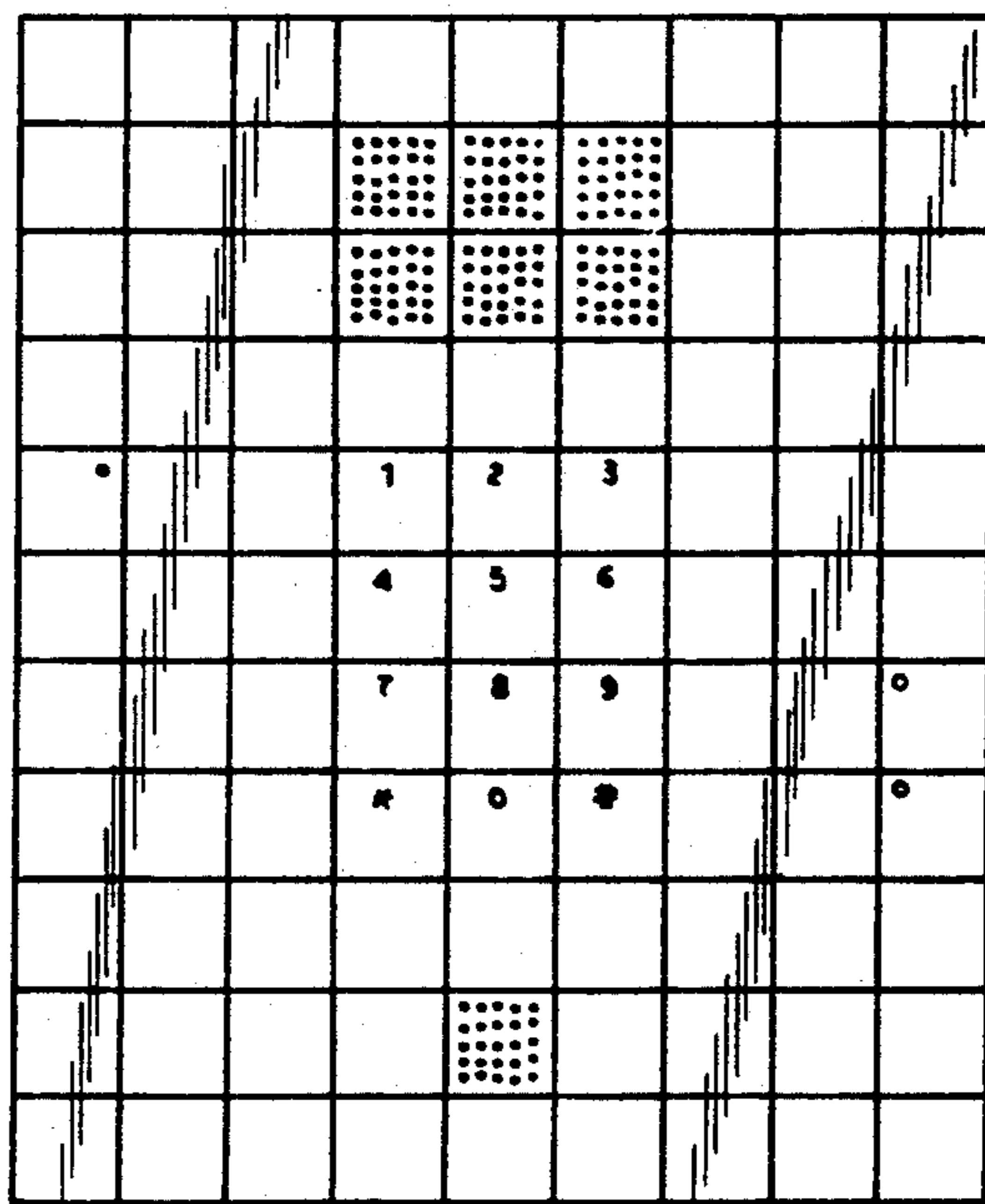

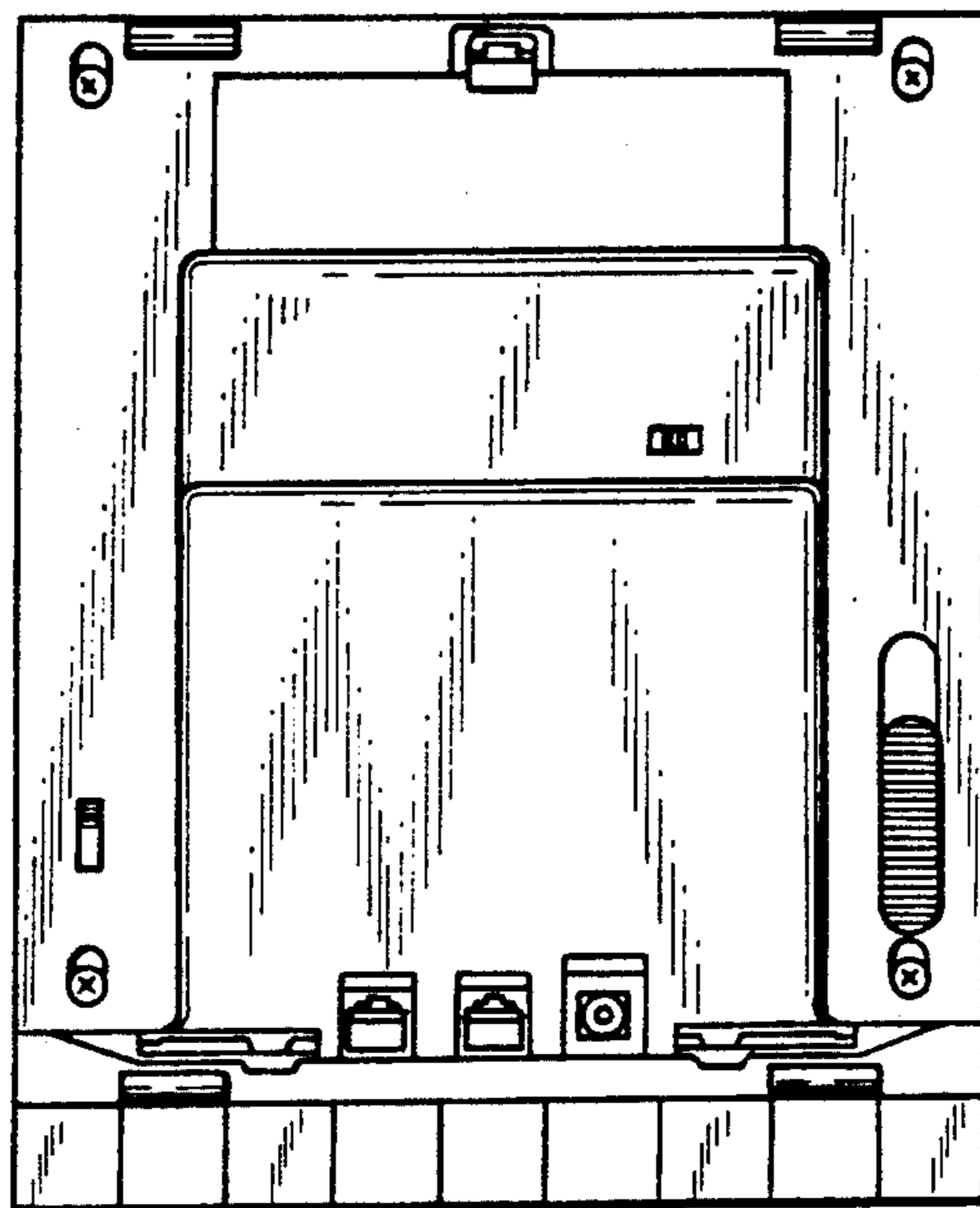

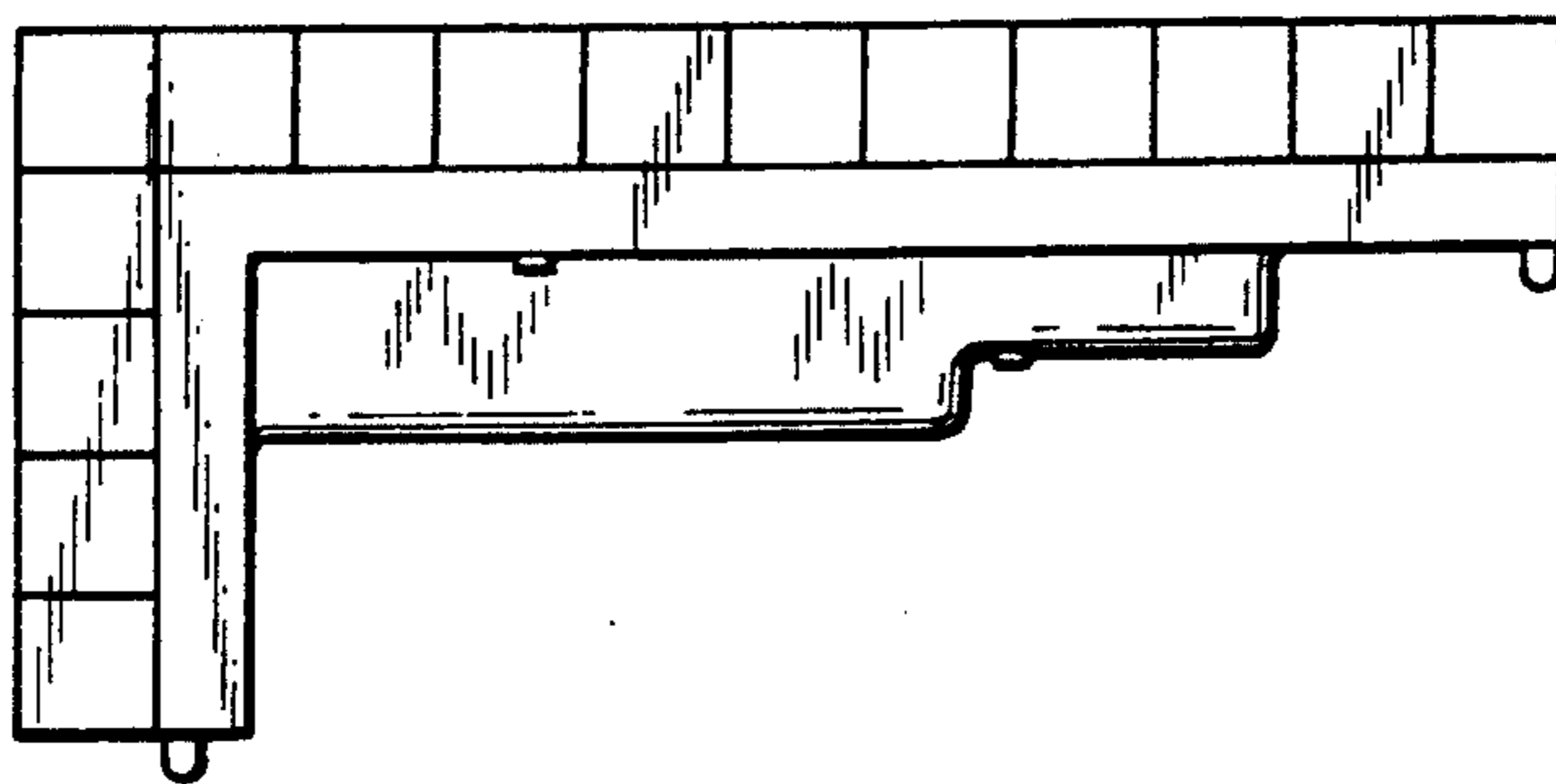

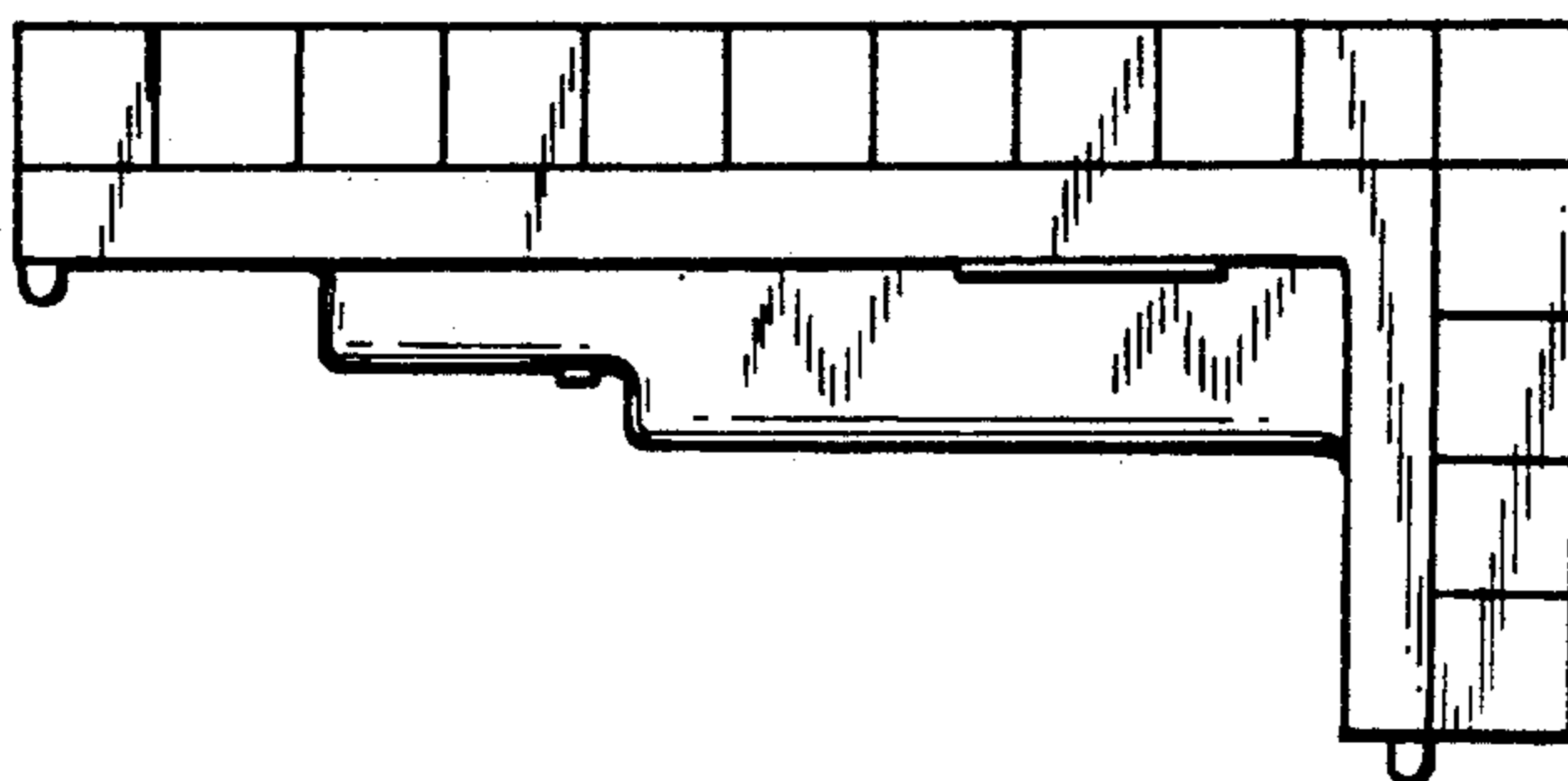

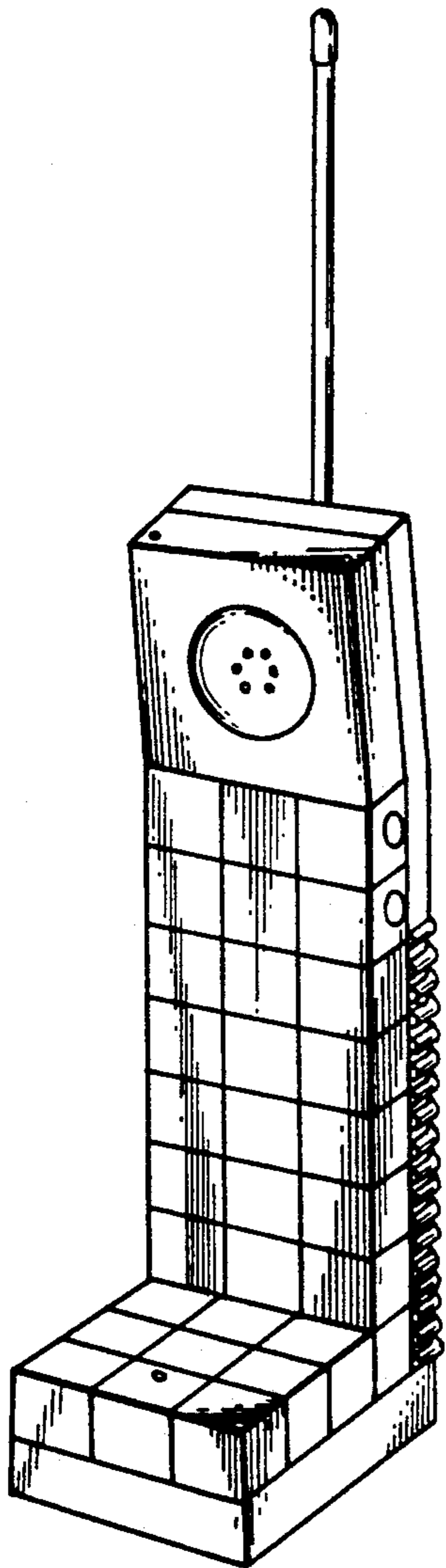
