DESCRIPTION

FIG. 1 is a top, left front perspective view of a lead holder showing my new design;

FIG. 6 is a bottom plan view thereof.

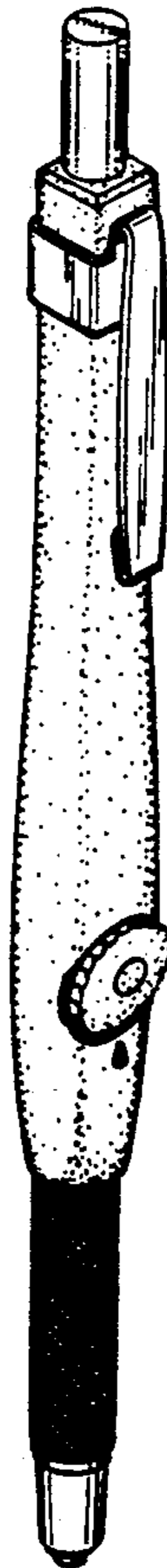

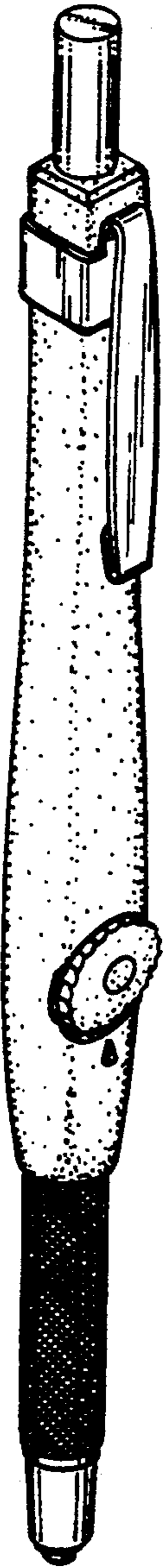

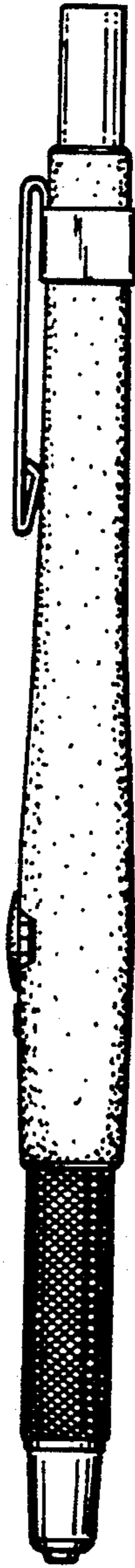
