## DESCRIPTION

FIG. 1 is a side elevation view of an automobile showing our new design, the opposite side being substantially a mirror image thereof;

FIG. 2 is a top plan view thereof;

FIG. 3 is an enlarged front elevation view thereof;

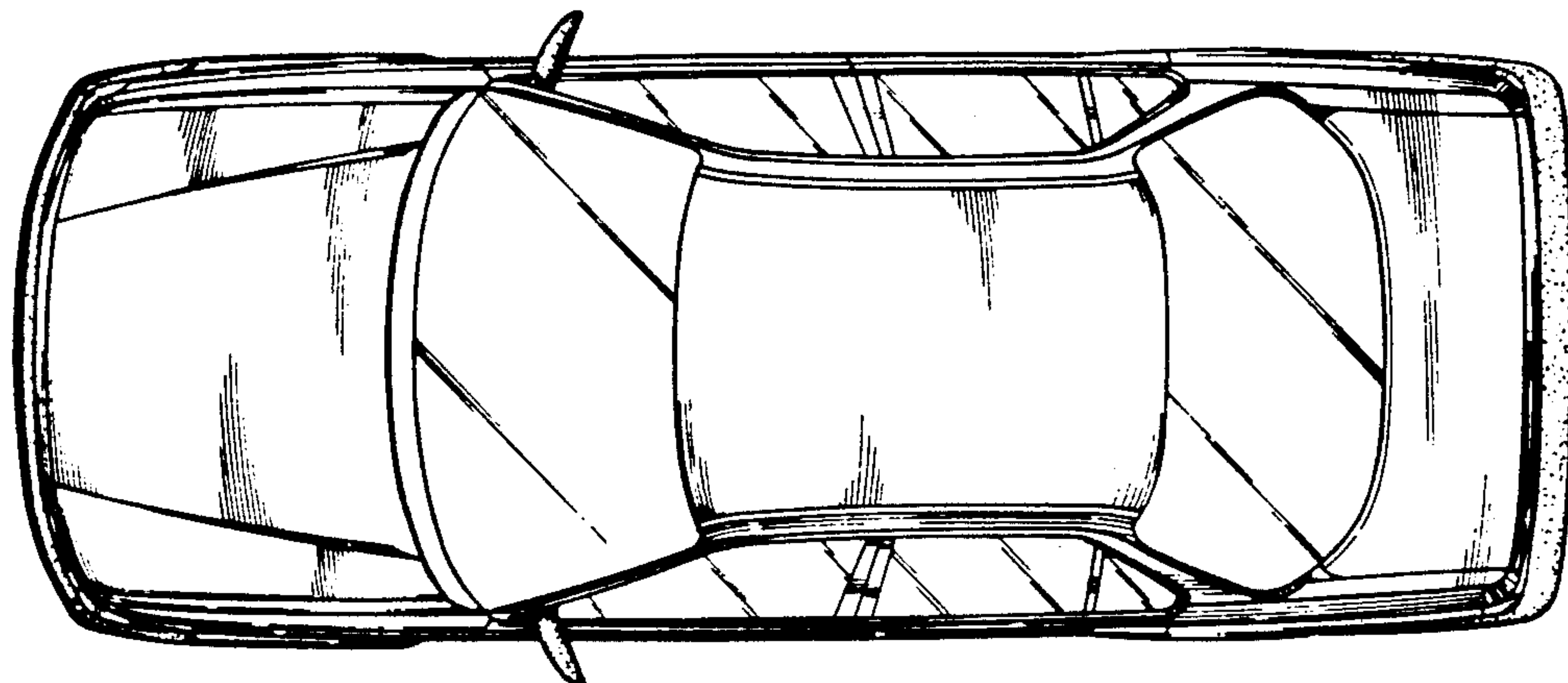
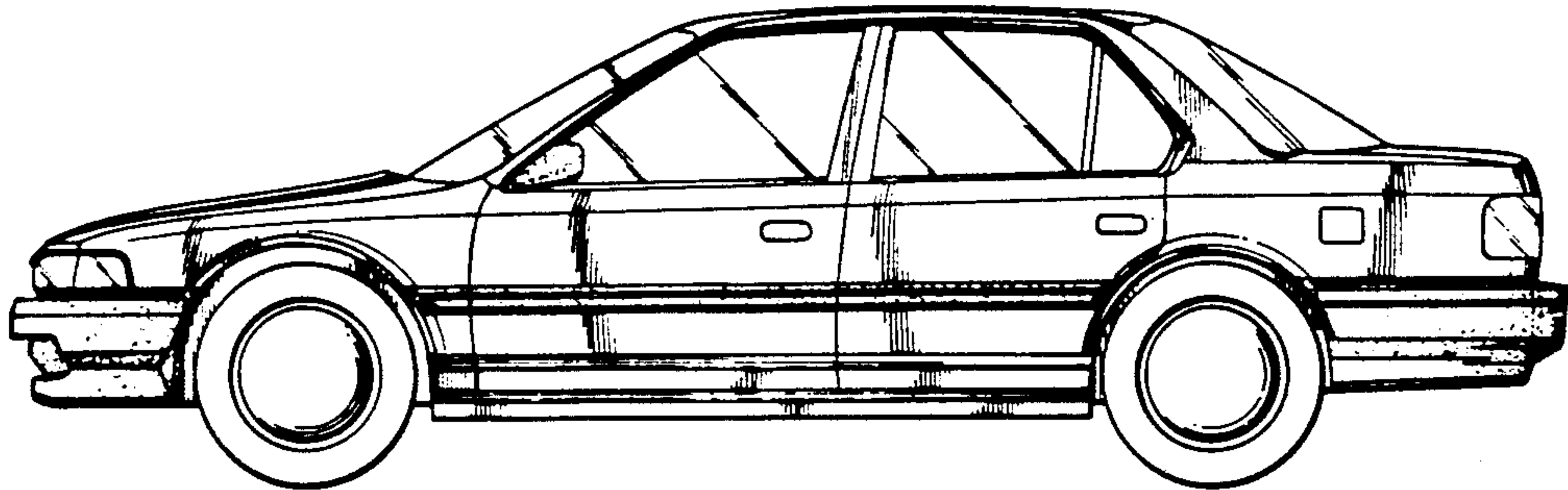
FIG. 4 is an enlarged rear elevation view thereof;

FIG. 8 is an enlarged rear elevation view of FIG. 5.



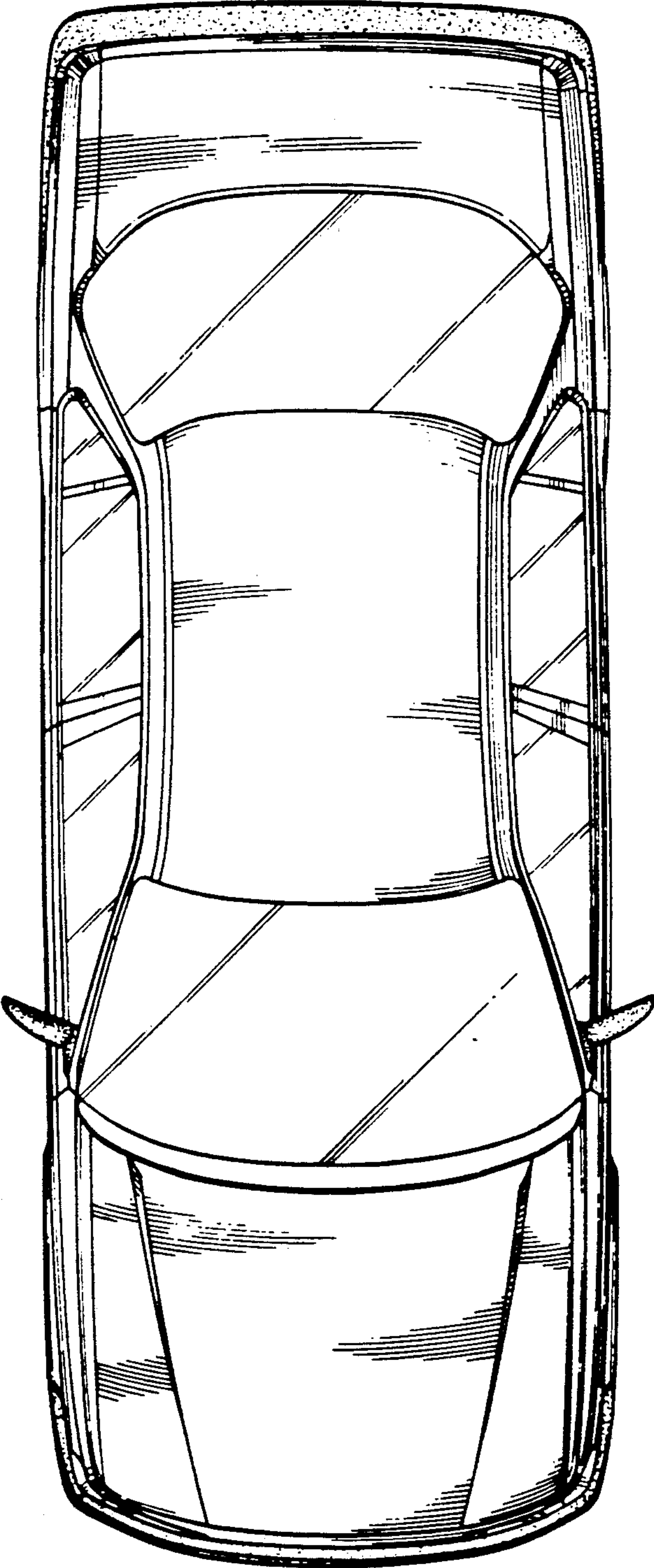

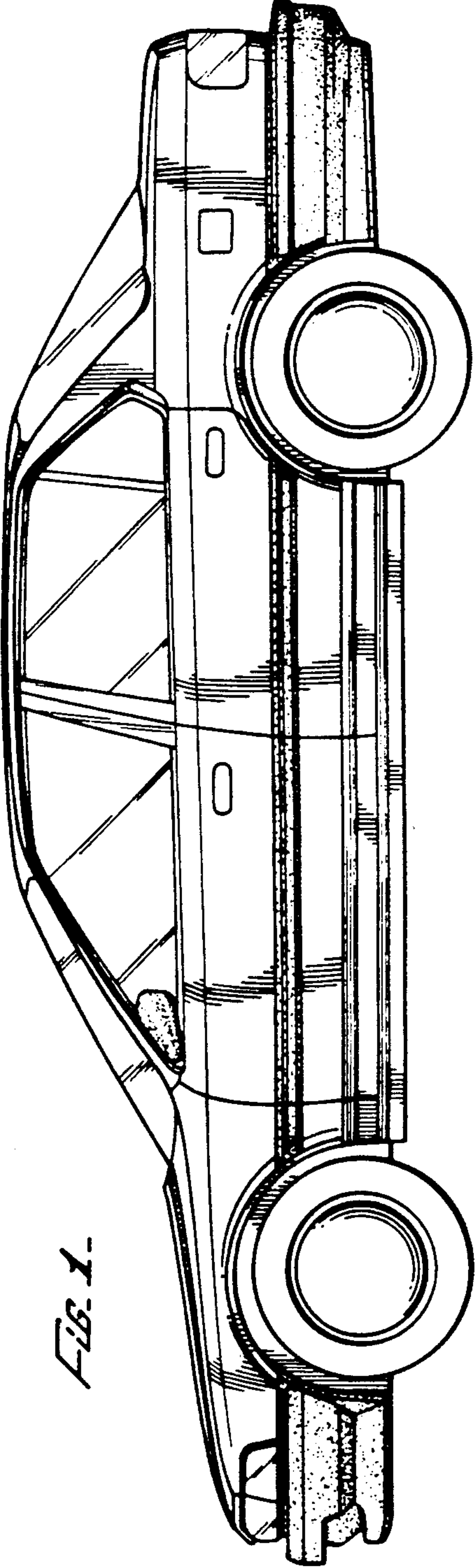

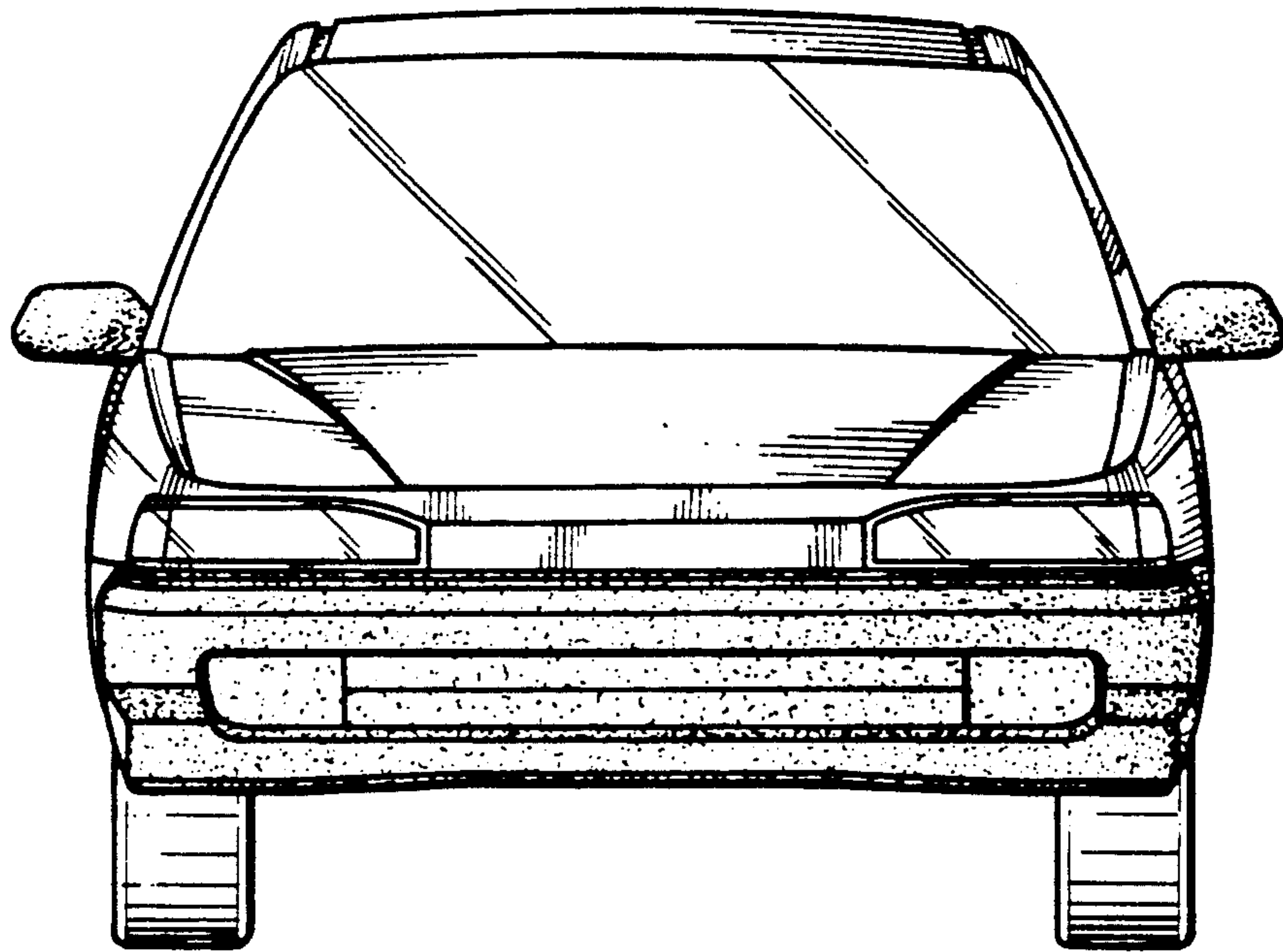

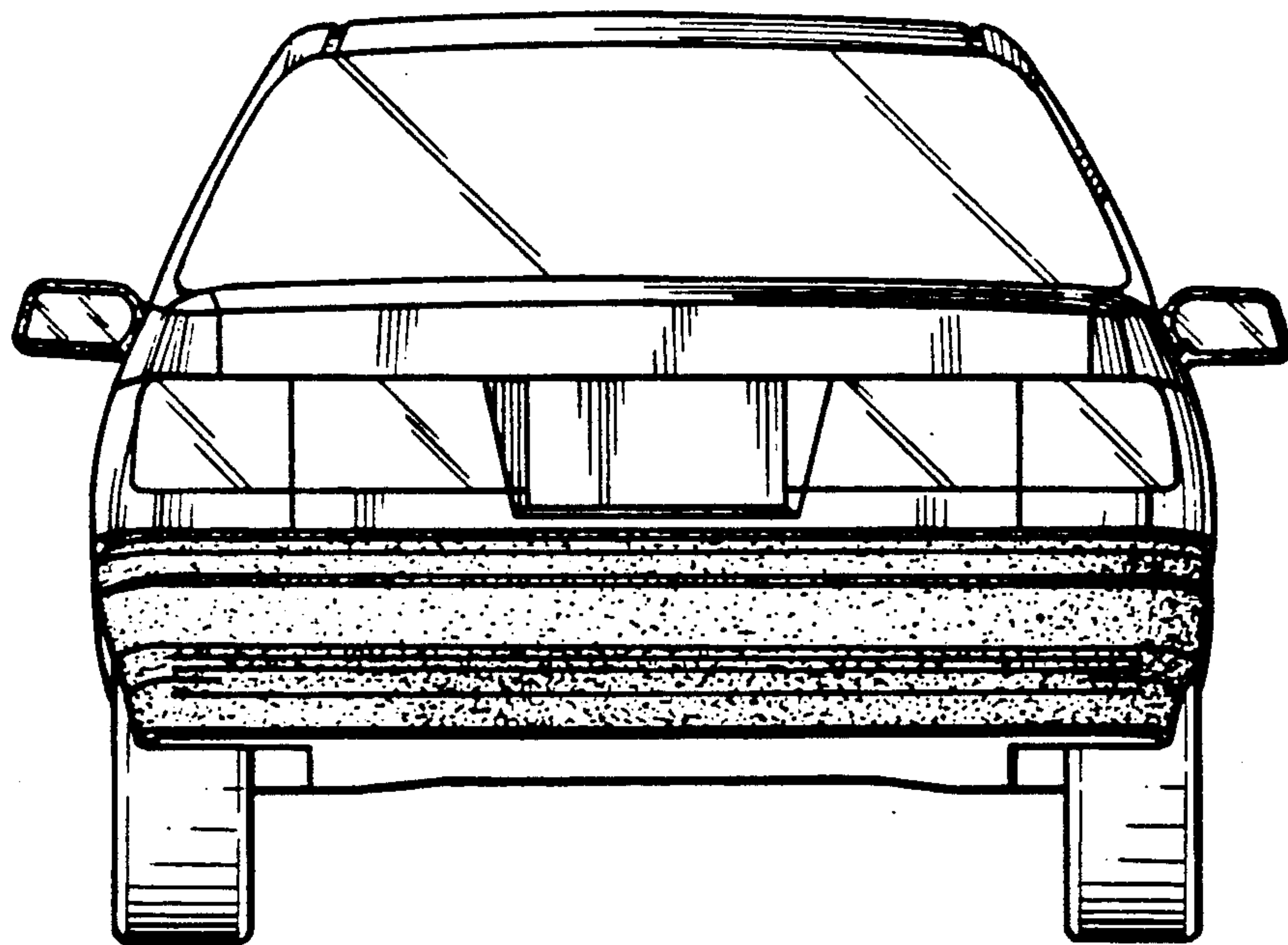

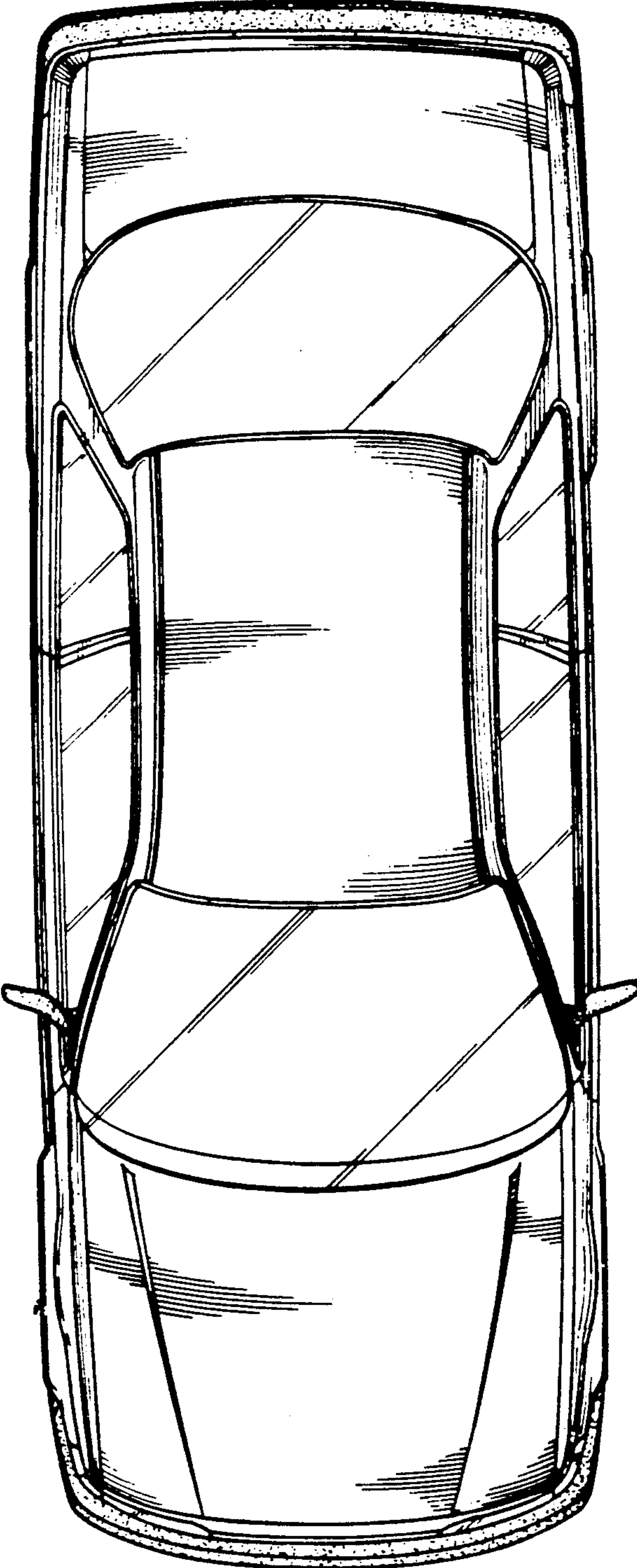

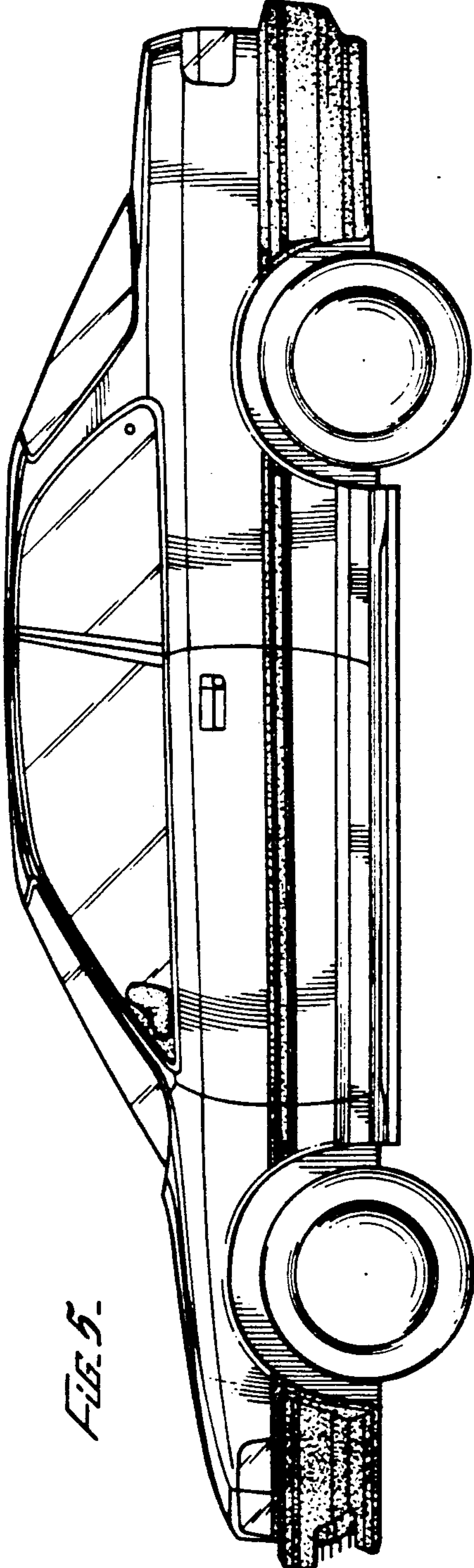
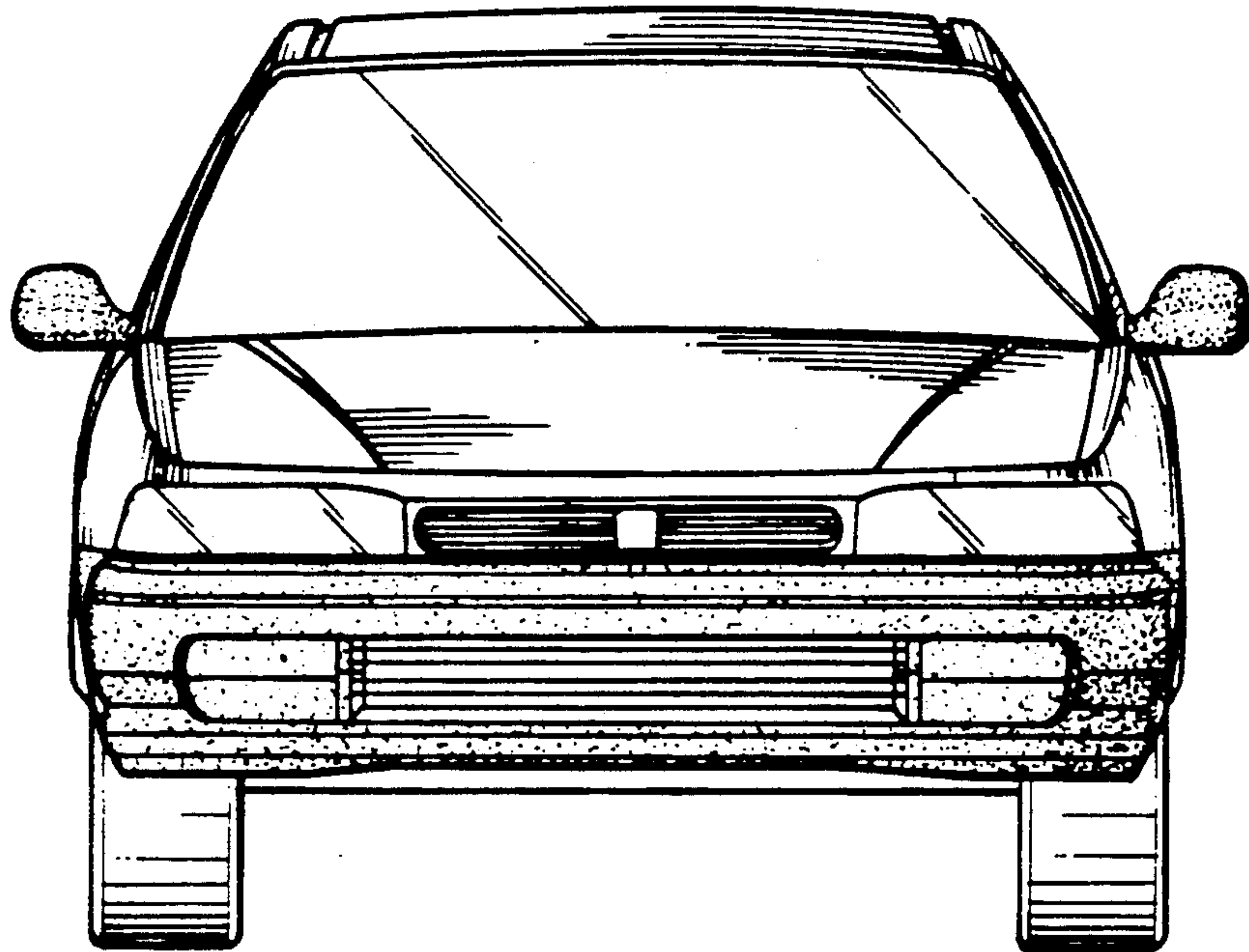
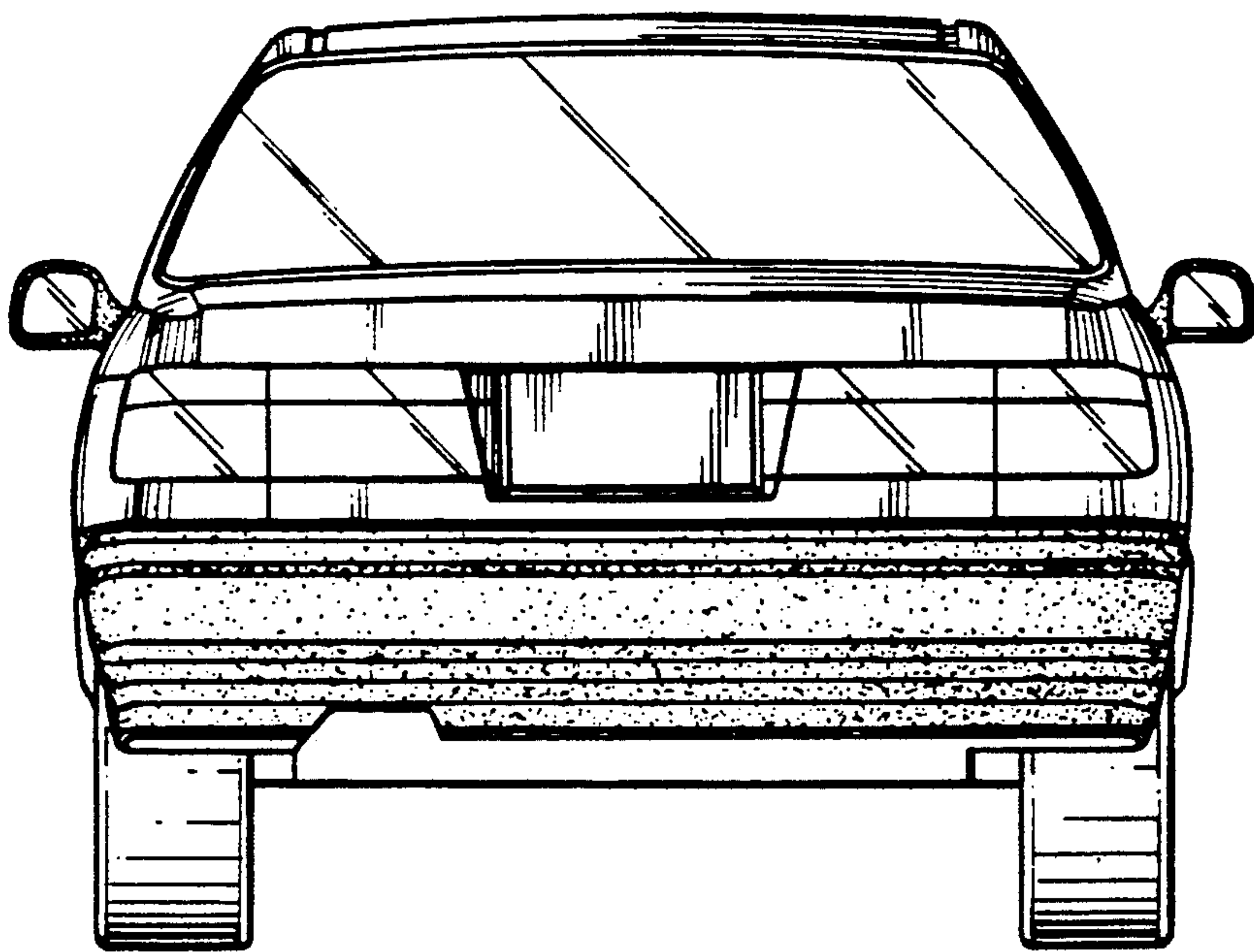
