FIG. 2 is a front elevational view;

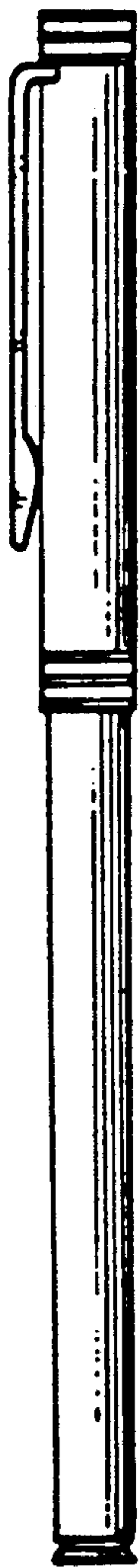
FIG. 3 is a rear elevational view;

FIG. 6 is a top plan view thereof.

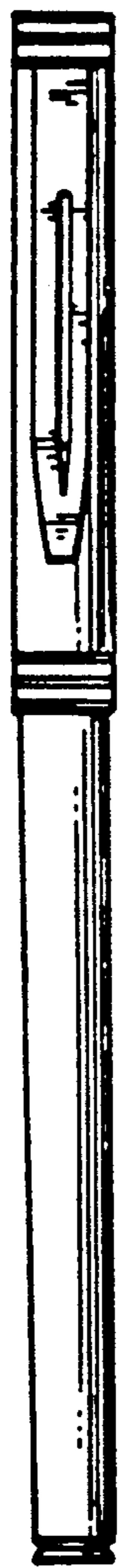

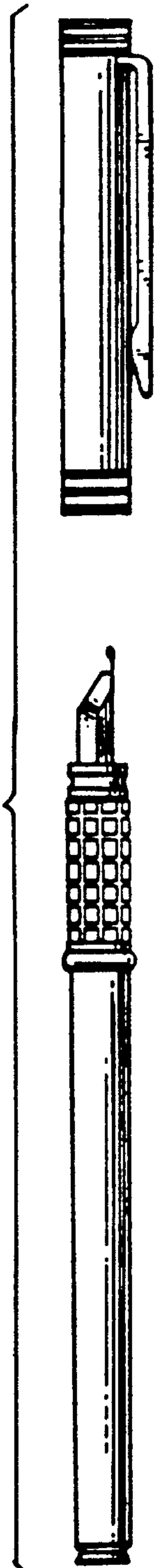
