[57] **CLAIM**

The ornamental design for writing instrument, as shown and described.

**DESCRIPTION**

FIG. 1 is a right front perspective view of a writing instrument showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a left side elevational view thereof; and FIG. 5 is a rear elevational view thereof; FIG. 6 is a right front perspective view with the writing tip in an extended position; FIG. 7 is a top plan view of FIG. 6; and FIG. 8 is a bottom plan view of FIG. 6.

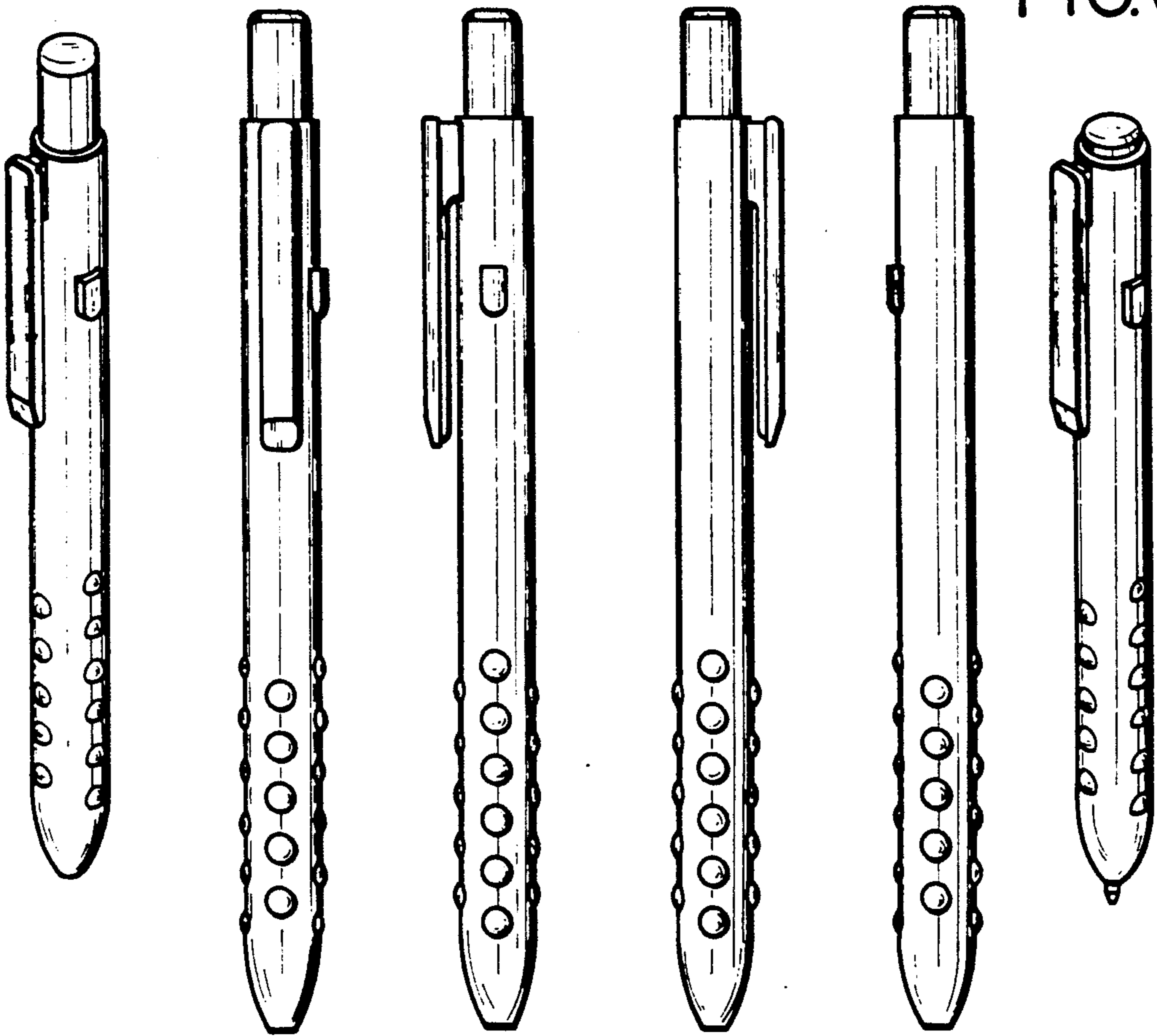
