FIG. 8 is a top plan view thereof, the bottom being plain unornamented;

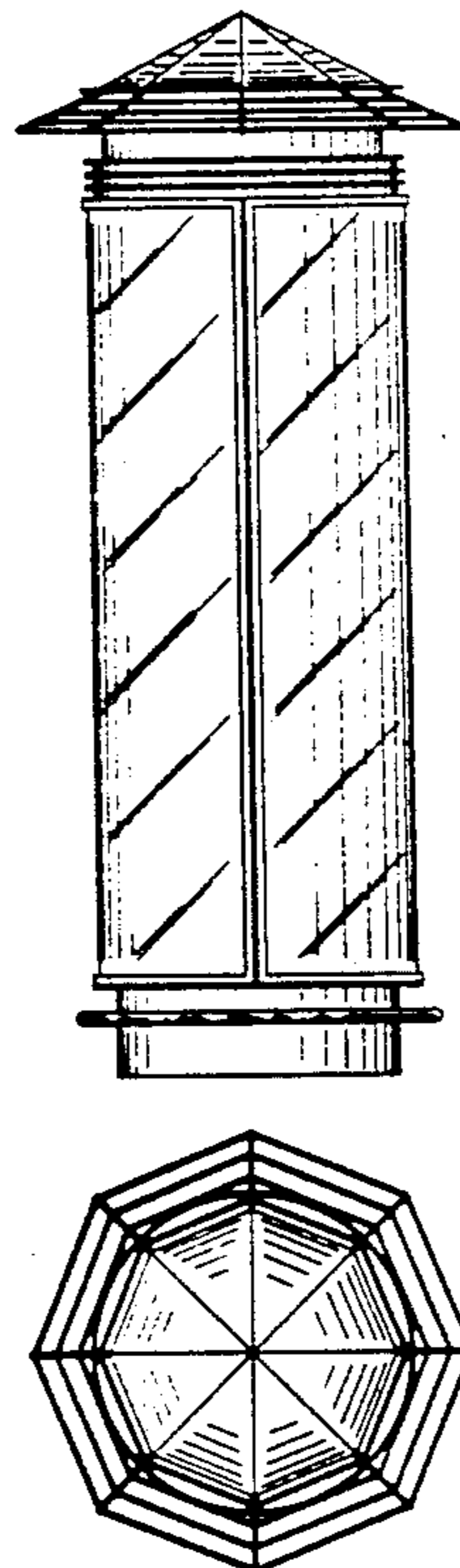
FIG. 9 is a side elevational view thereof, the opposite side being identical thereto;

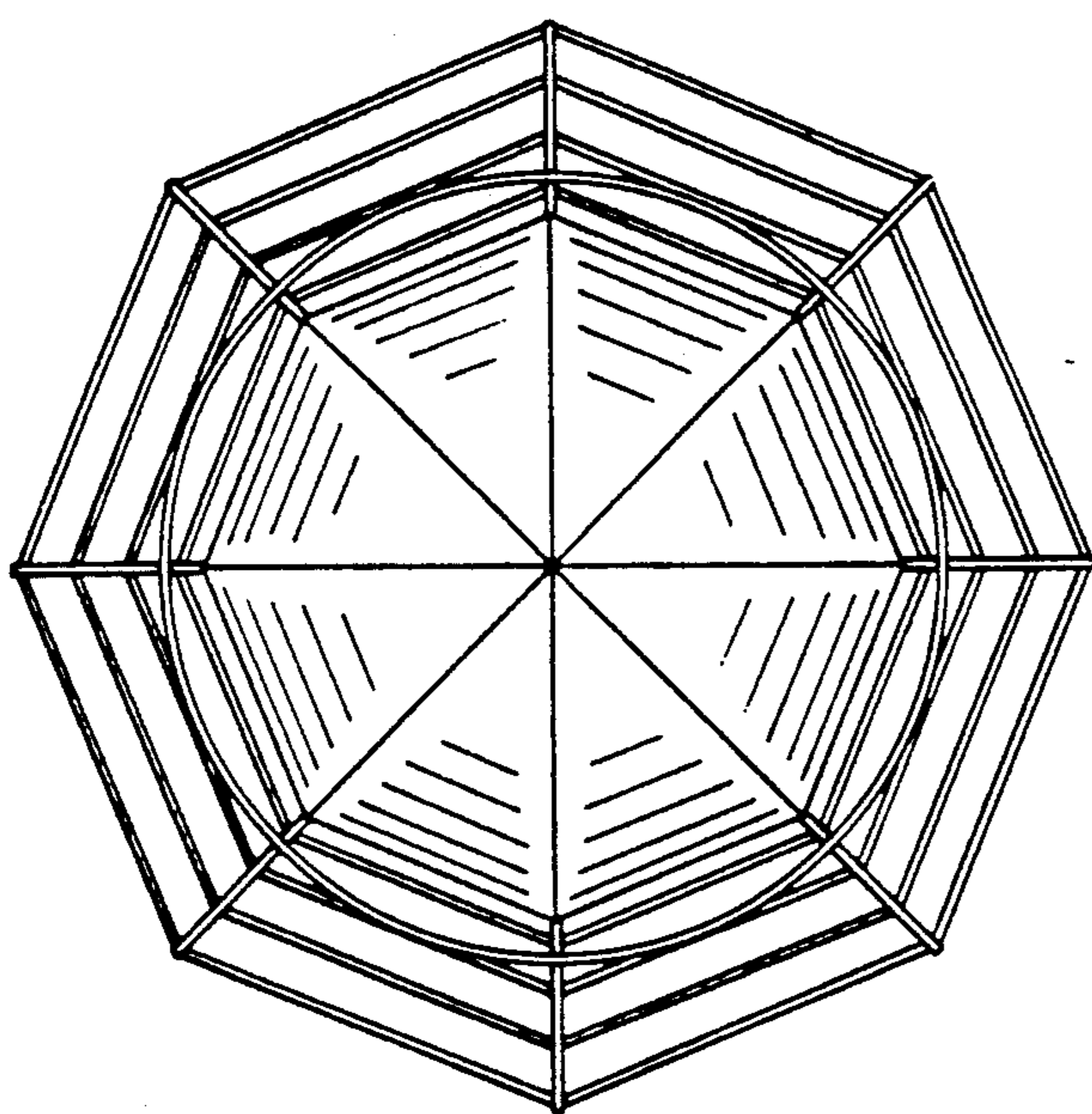

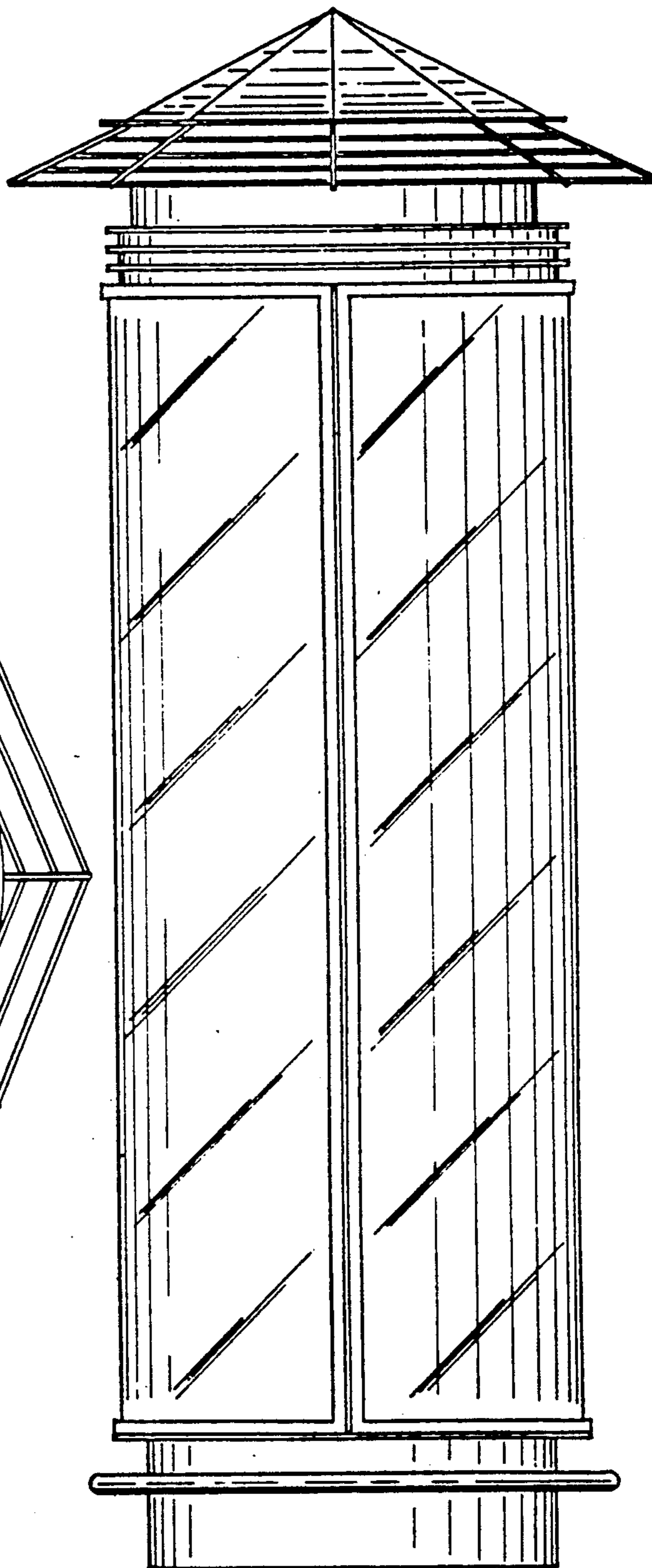

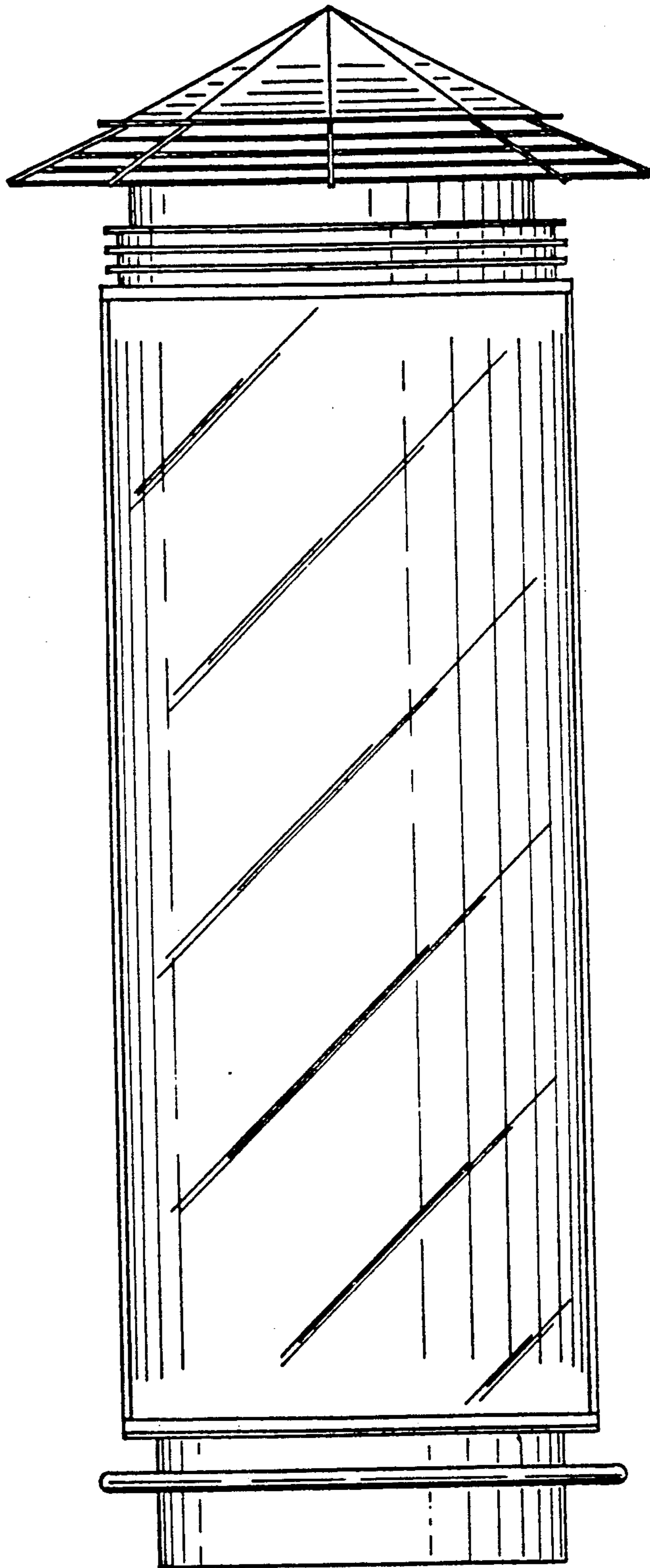

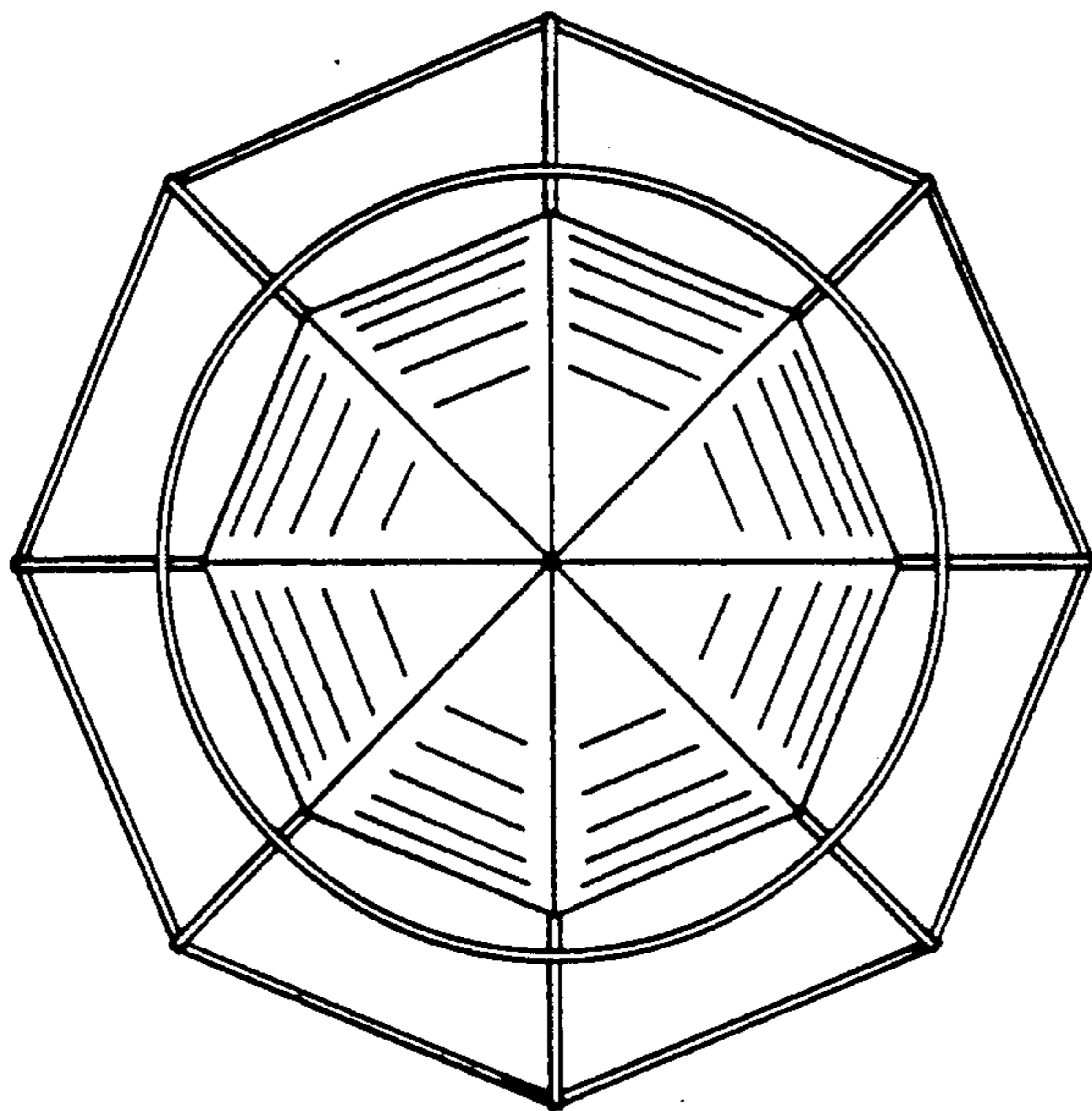

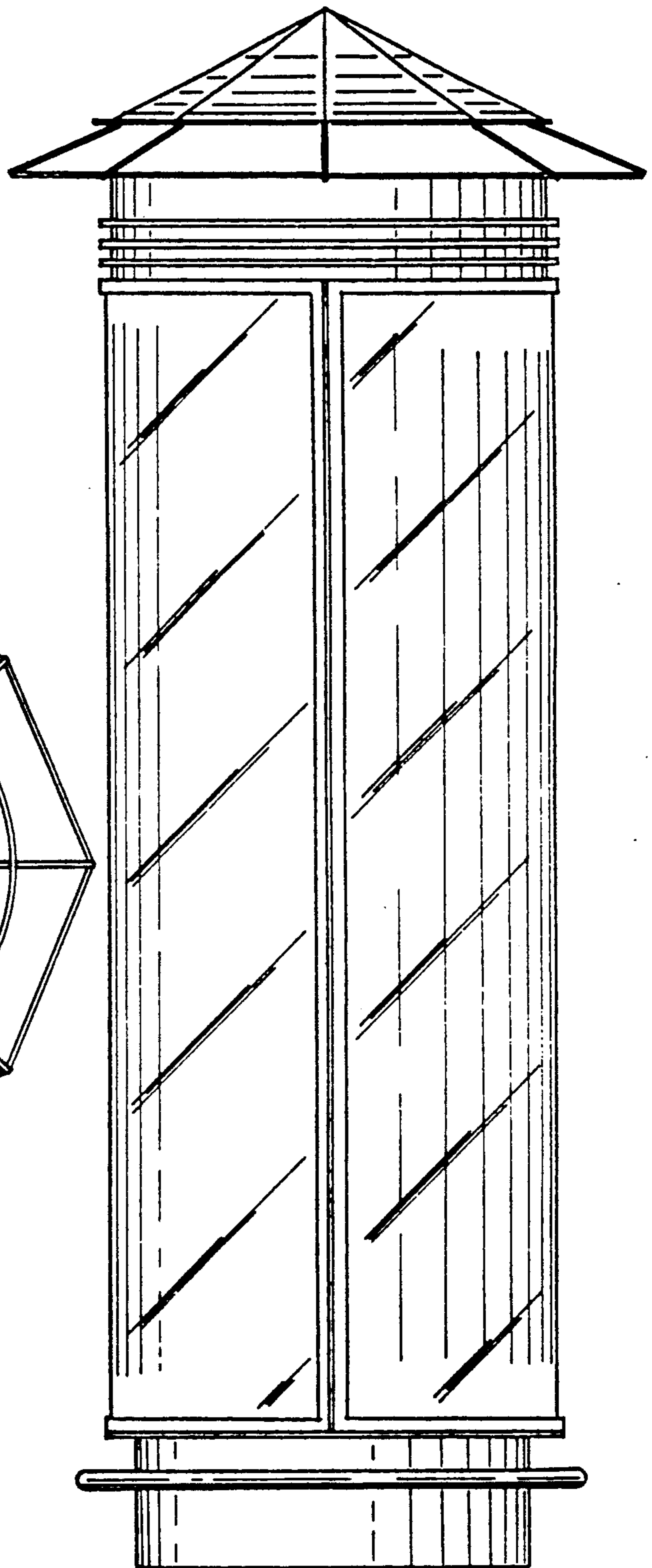

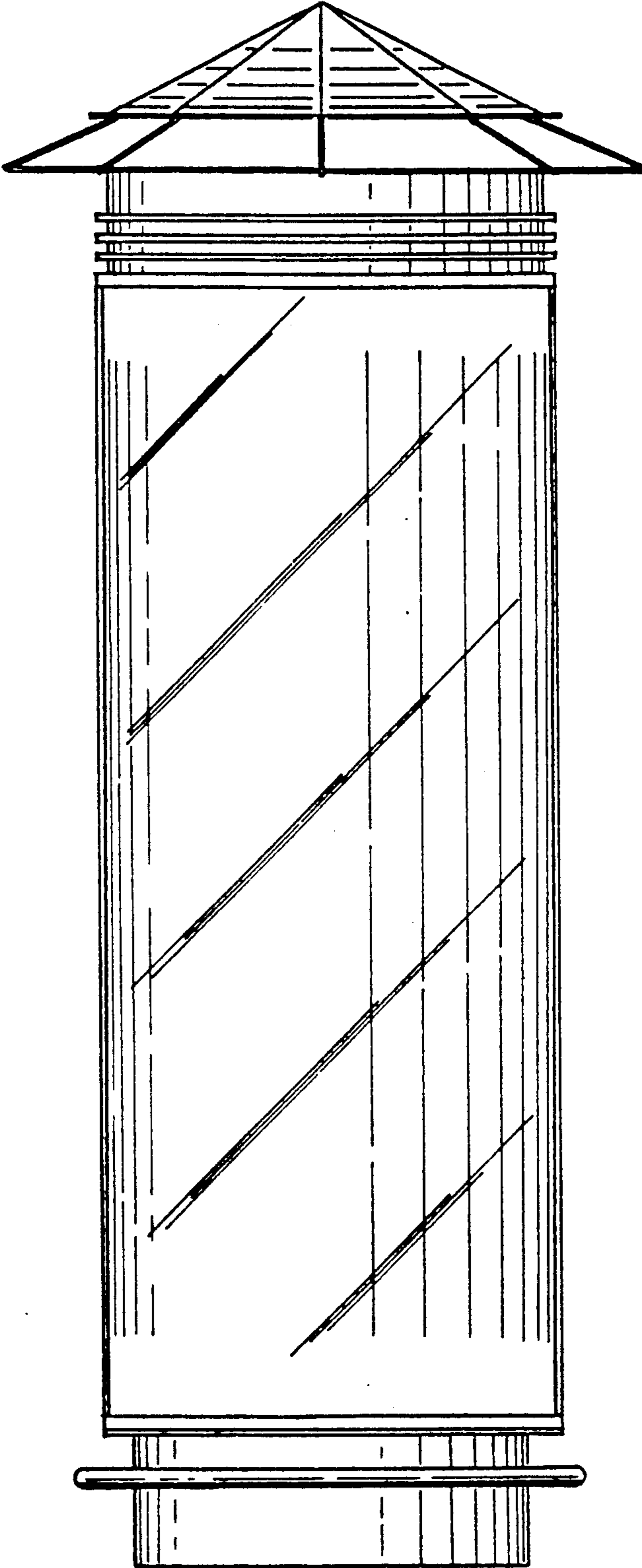

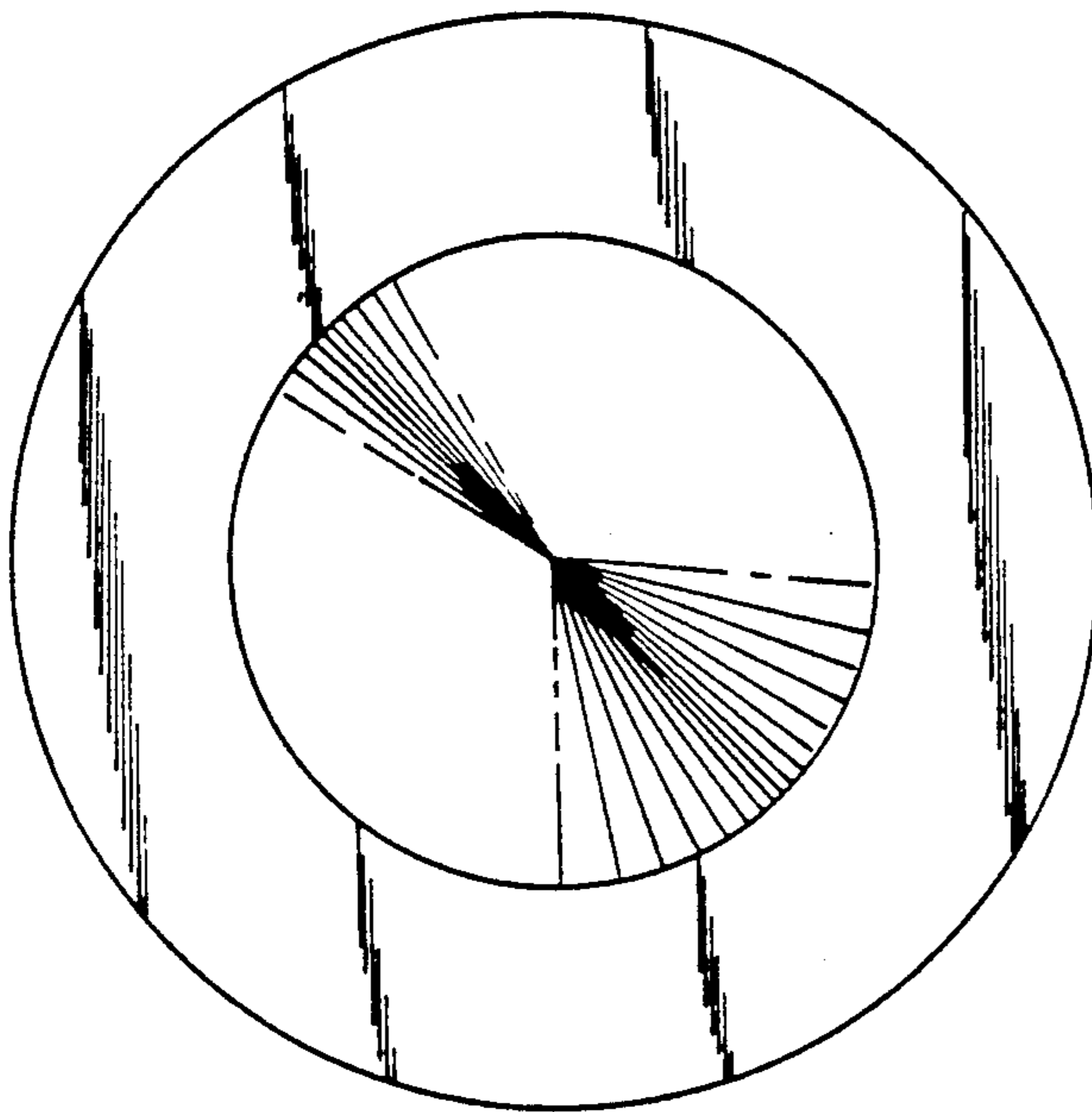

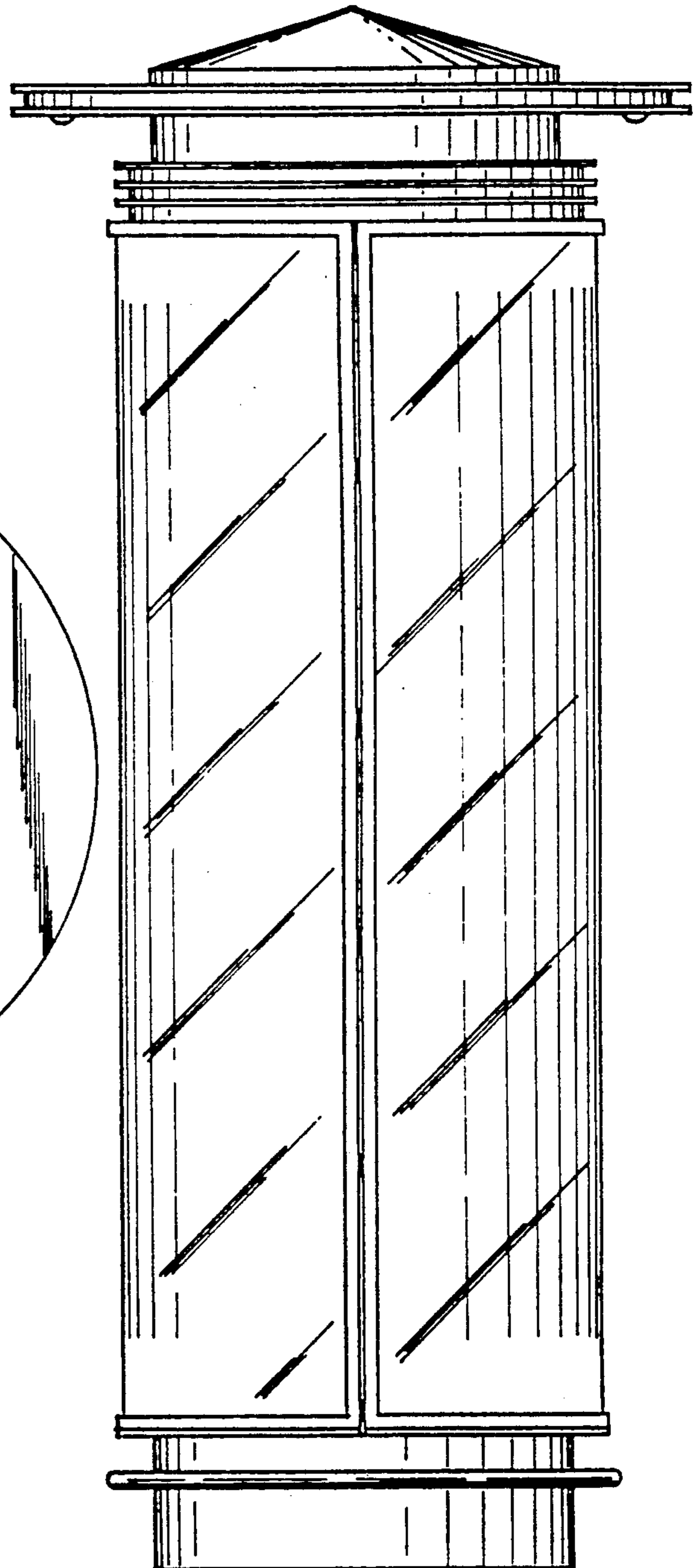

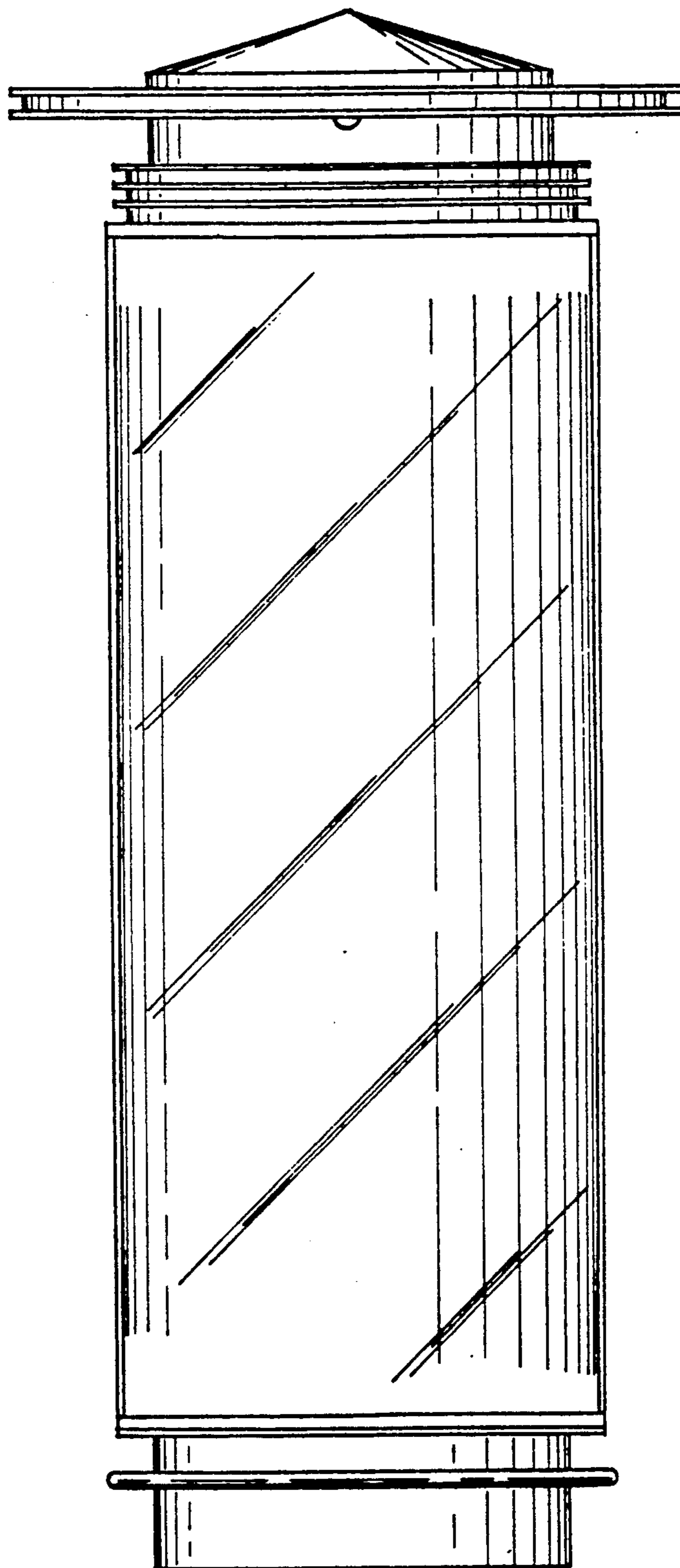

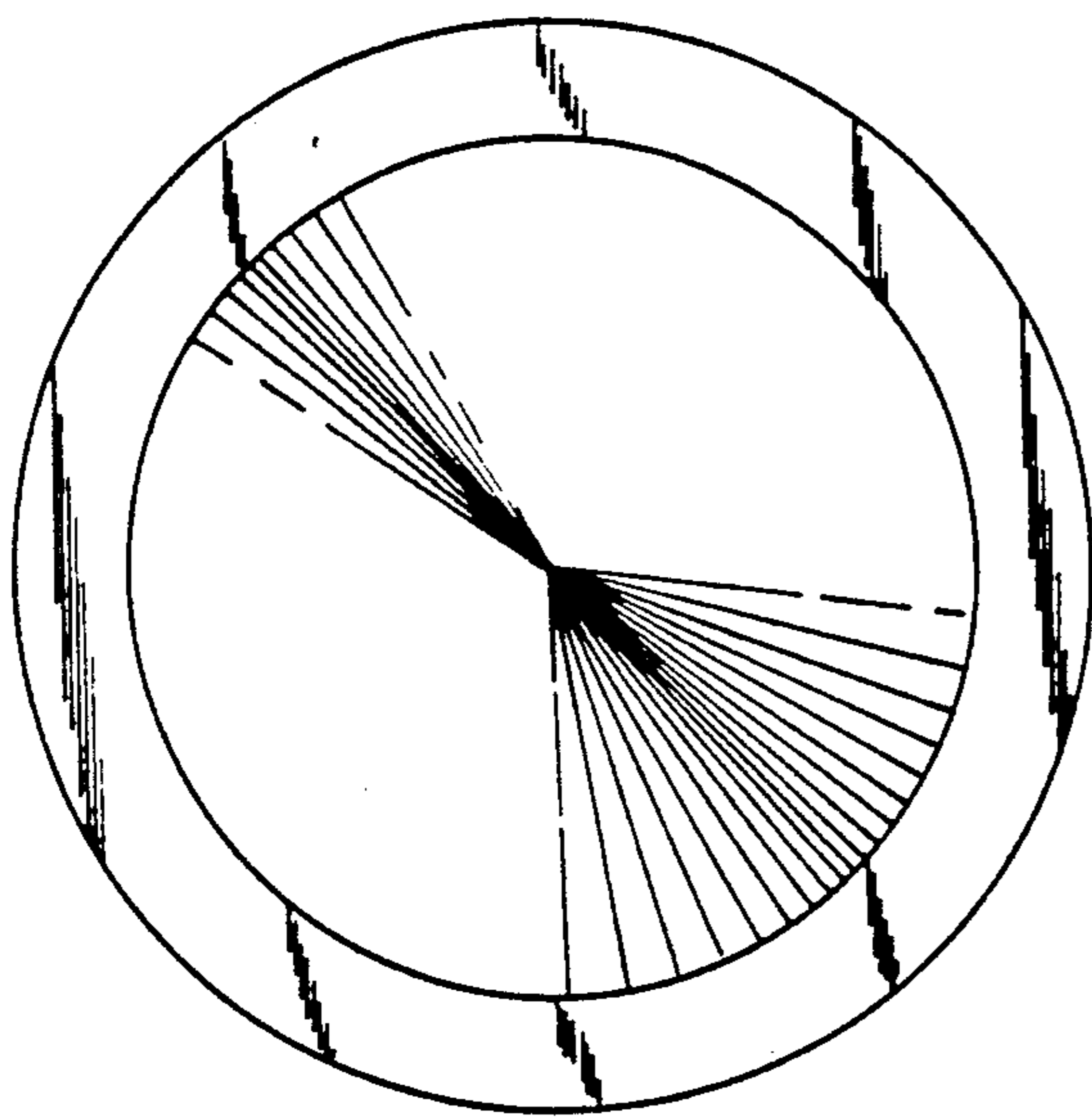

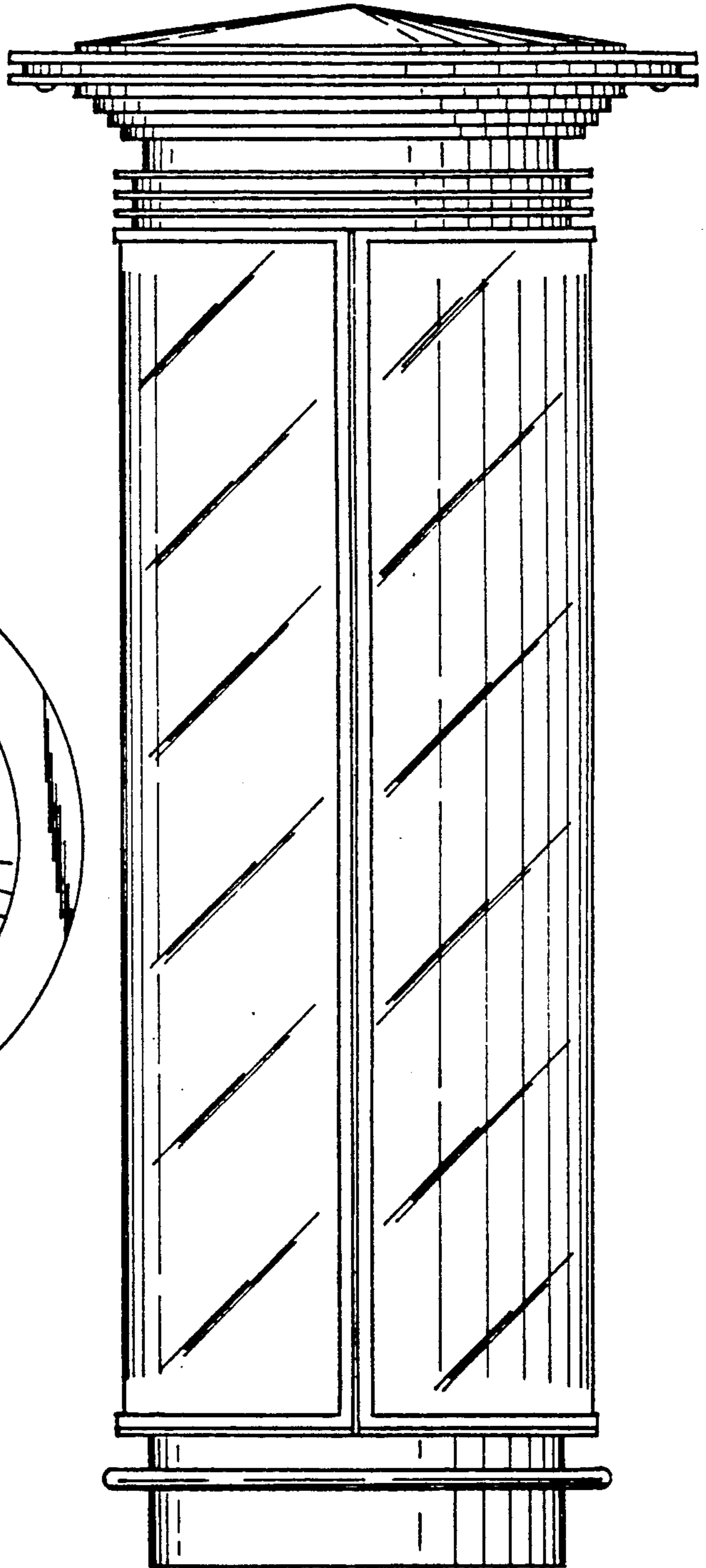

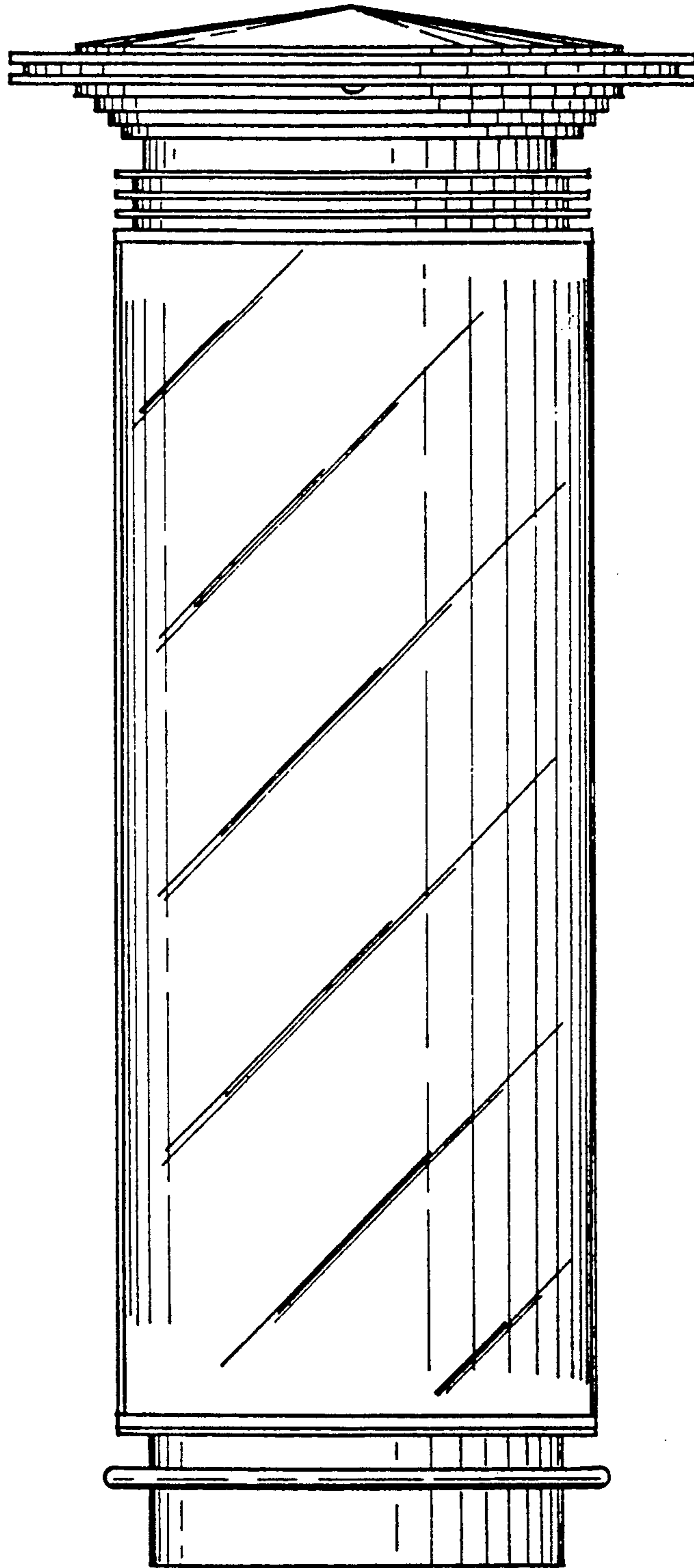
