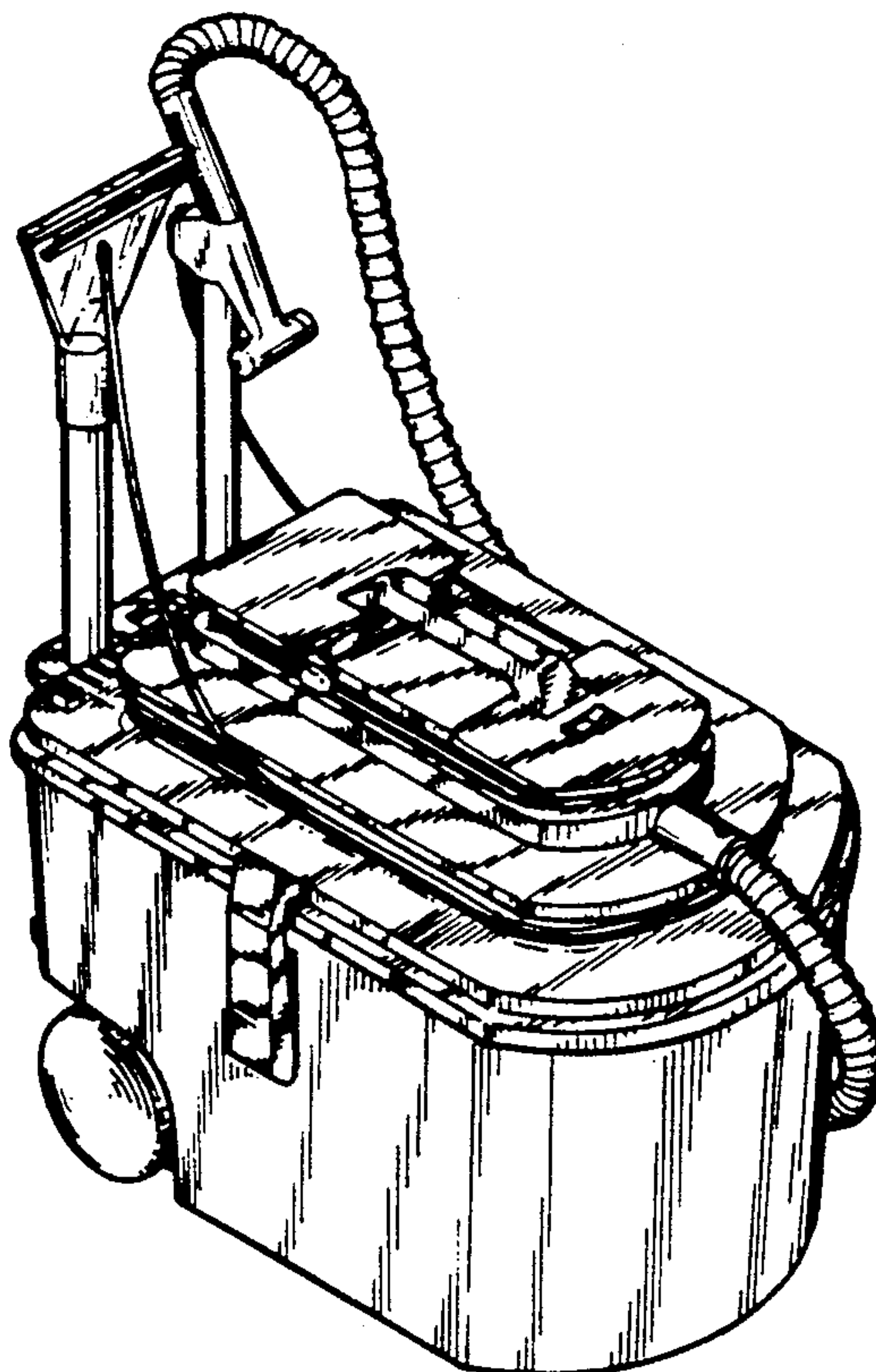

**CLAIM**

[57] The ornamental design for a liquid extraction surface cleaner, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view taken from the top, front and left side of a liquid extraction surface cleaner showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a right side elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a top plan view thereof;  
FIG. 6 is a rear elevational view thereof; and  
FIG. 7 is a bottom plan view thereof.



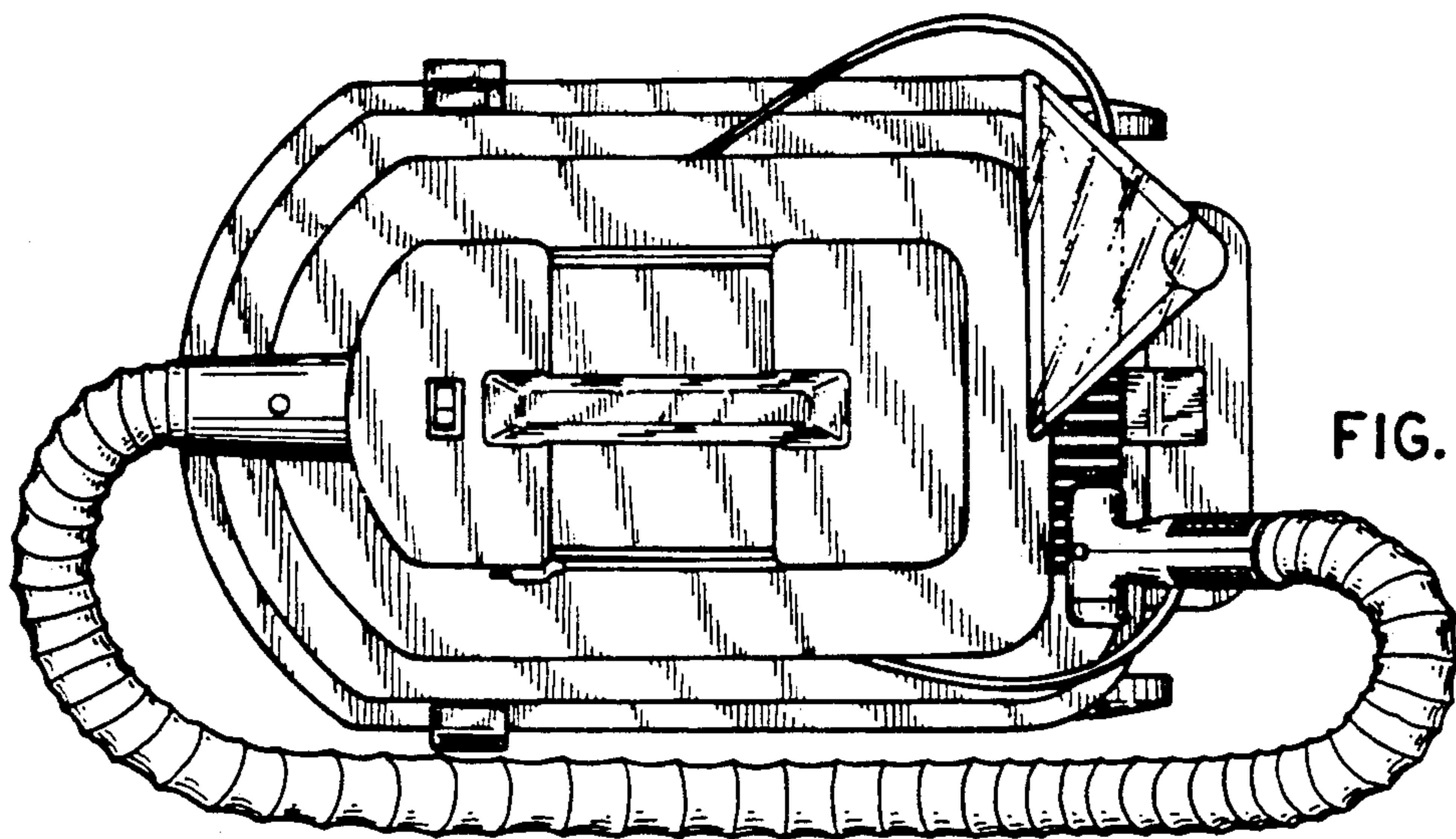

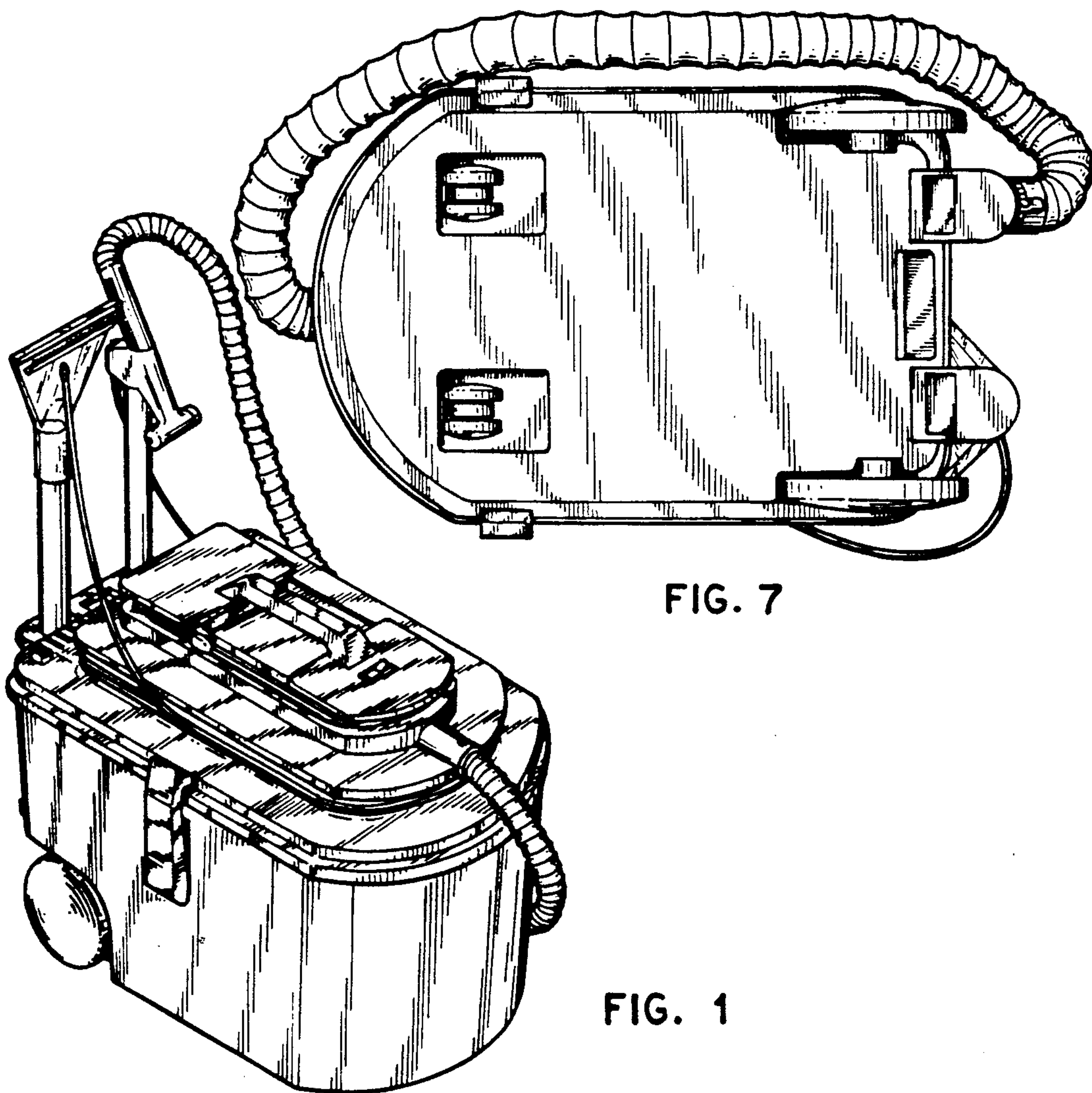

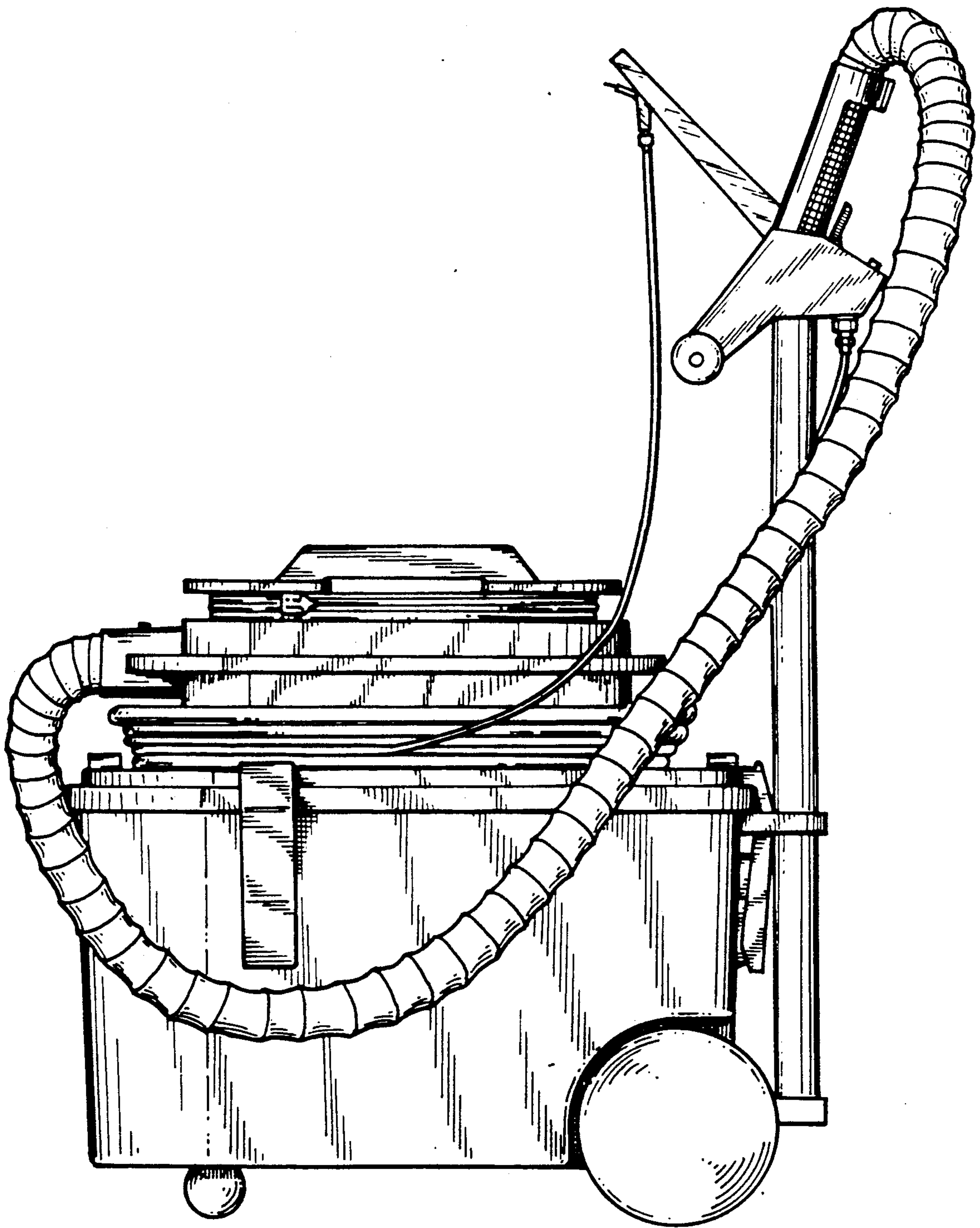

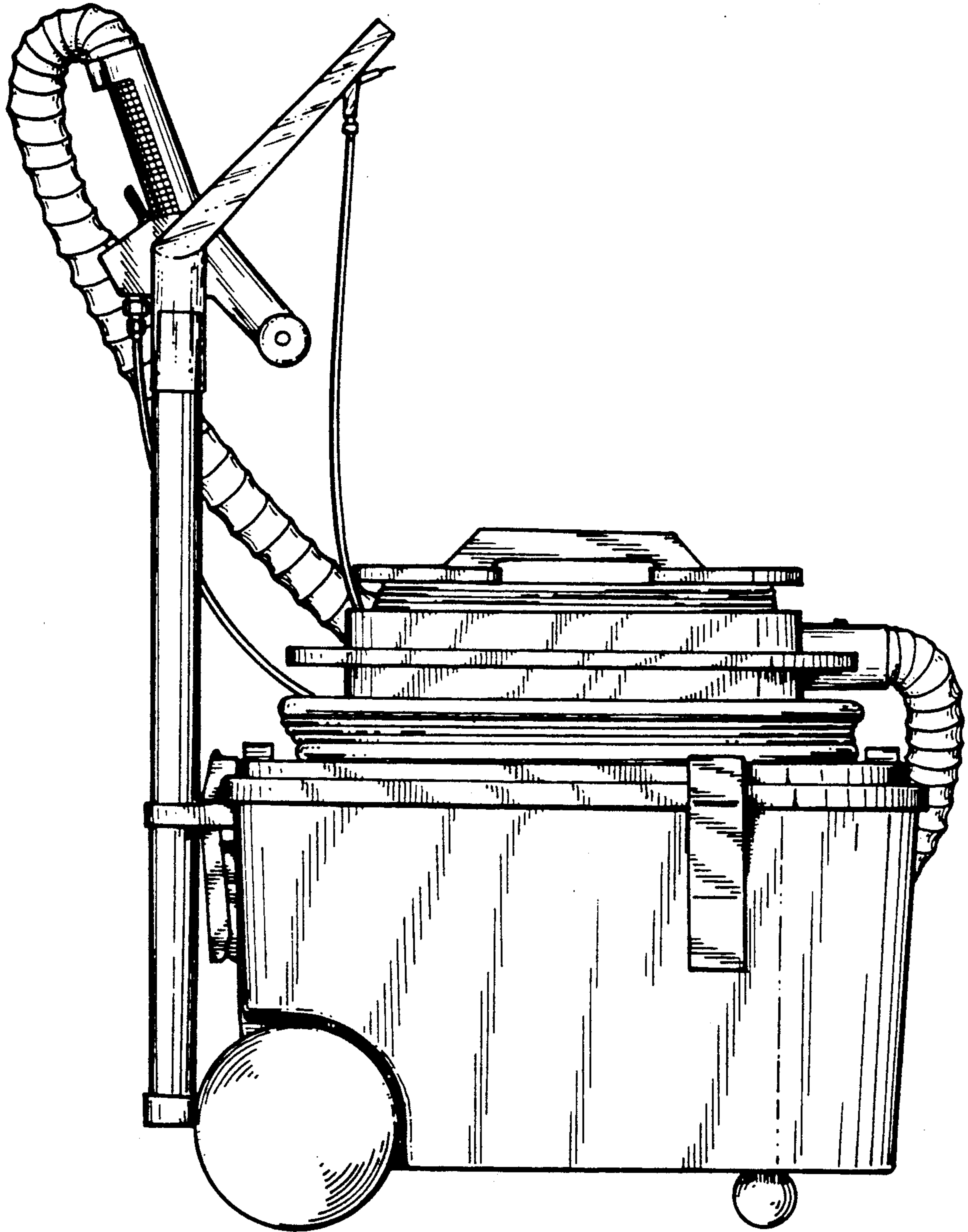

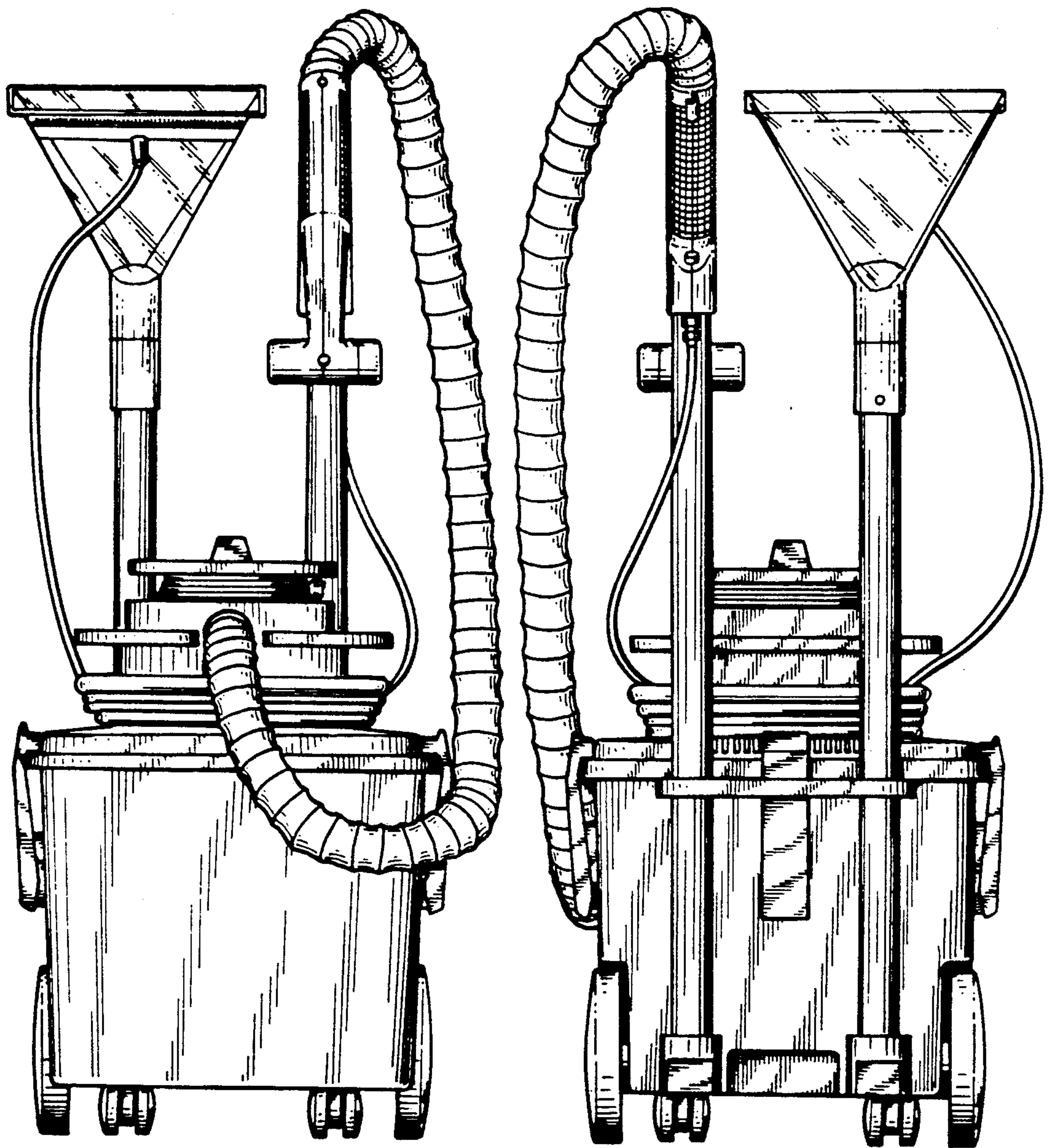
