[57] **CLAIM**

The ornamental design for a spout or the like, as shown
and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a spout or the
like embodying our new design, the right side being a
mirror image of the left side shown;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a perspective view taken from the top, front
and left side thereof;
FIG. 7 is a left side elevational view of a second em-
bodiment thereof, the right side being a mirror image of
the left side shown;
FIG. 8 is a front elevational view of FIG. 7;
FIG. 9 is a rear elevational view of FIG. 7;
FIG. 10 is a top plan view of FIG. 7;
FIG. 11 is a bottom plan view of FIG. 7; and
FIG. 12 is a perspective view taken from the top front
and left side of FIG. 7.

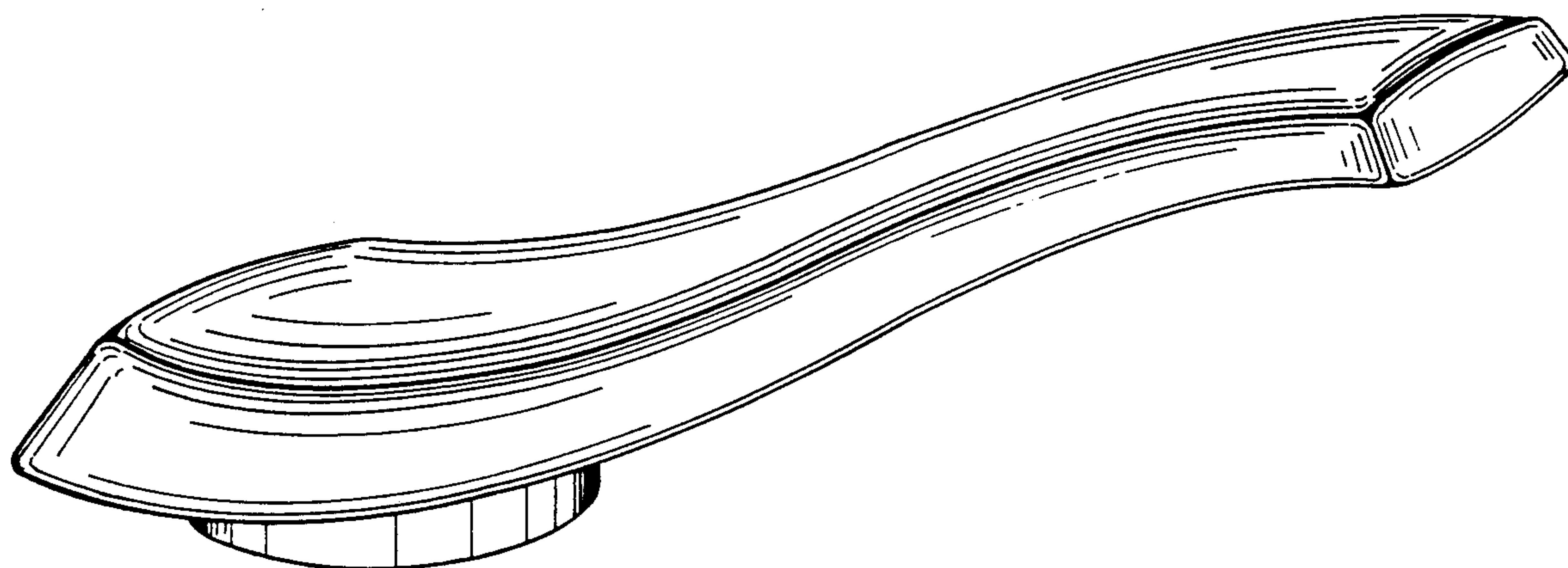
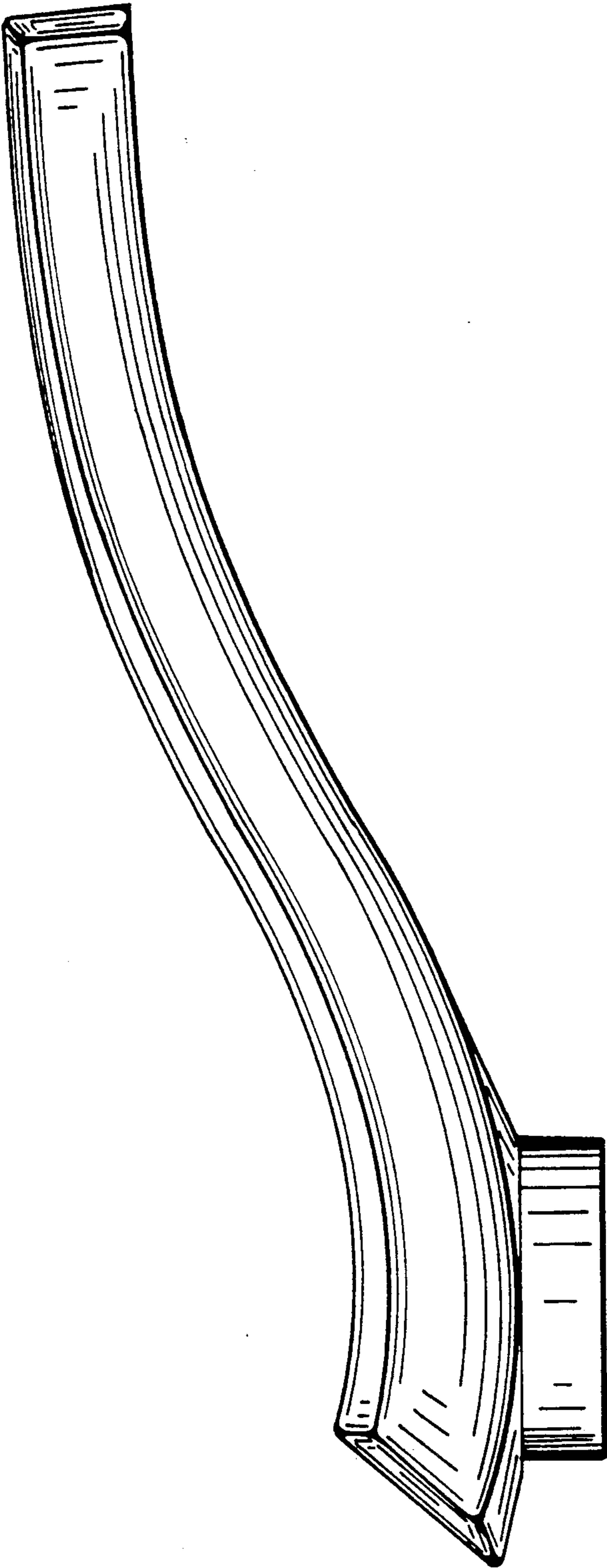

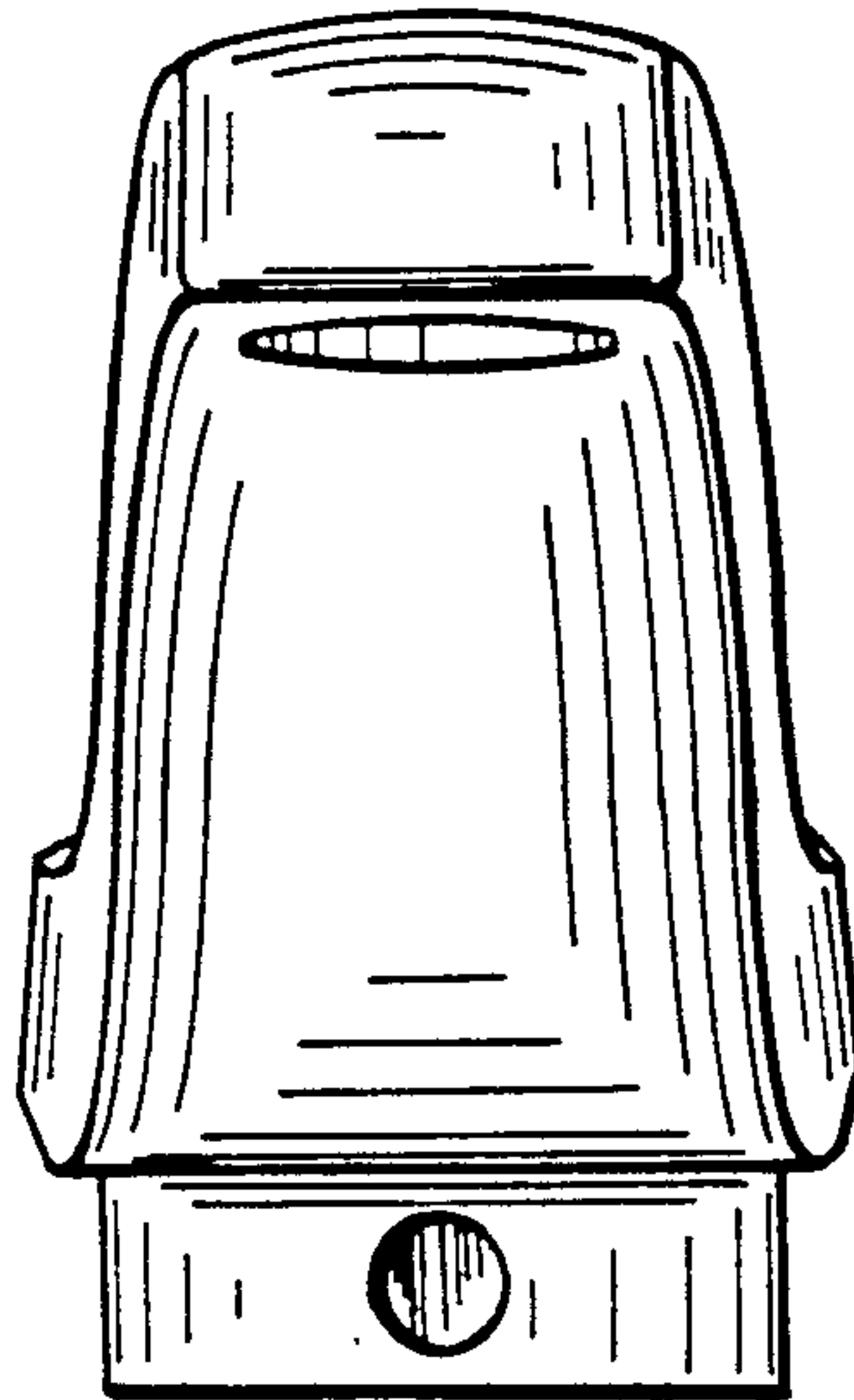
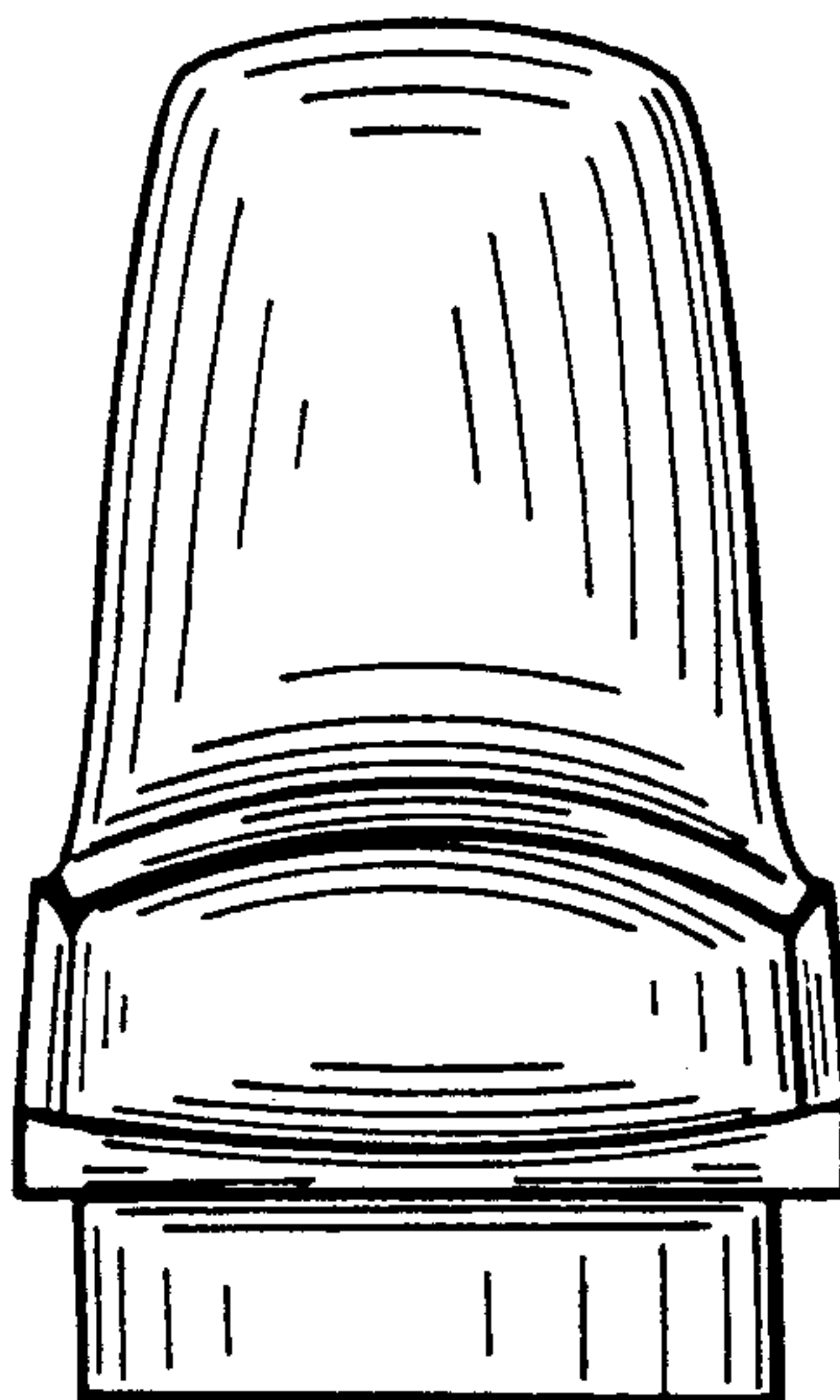

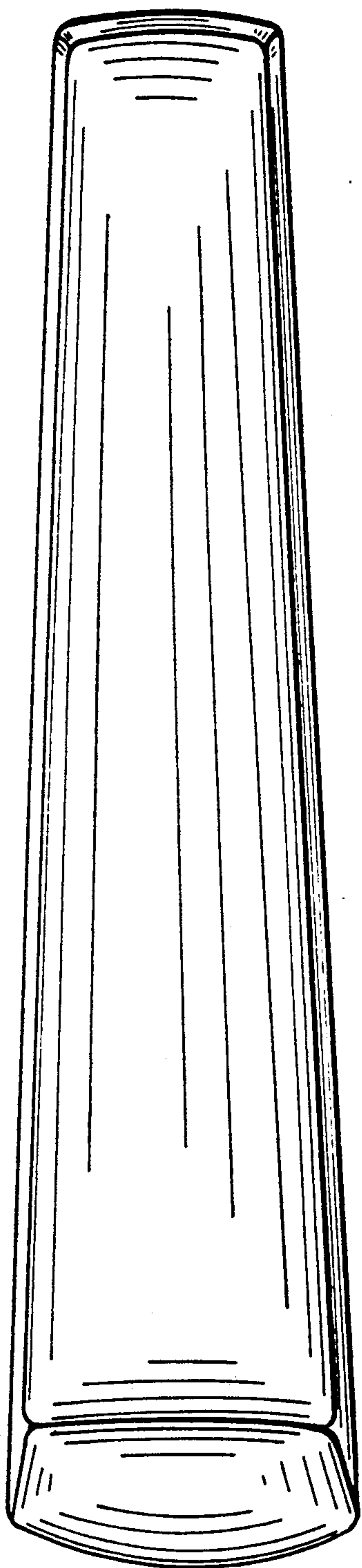

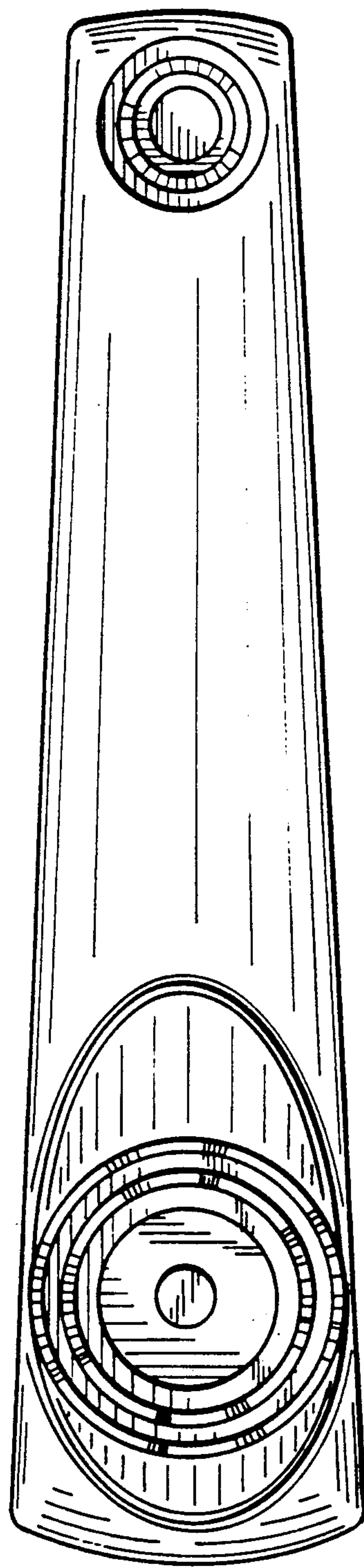

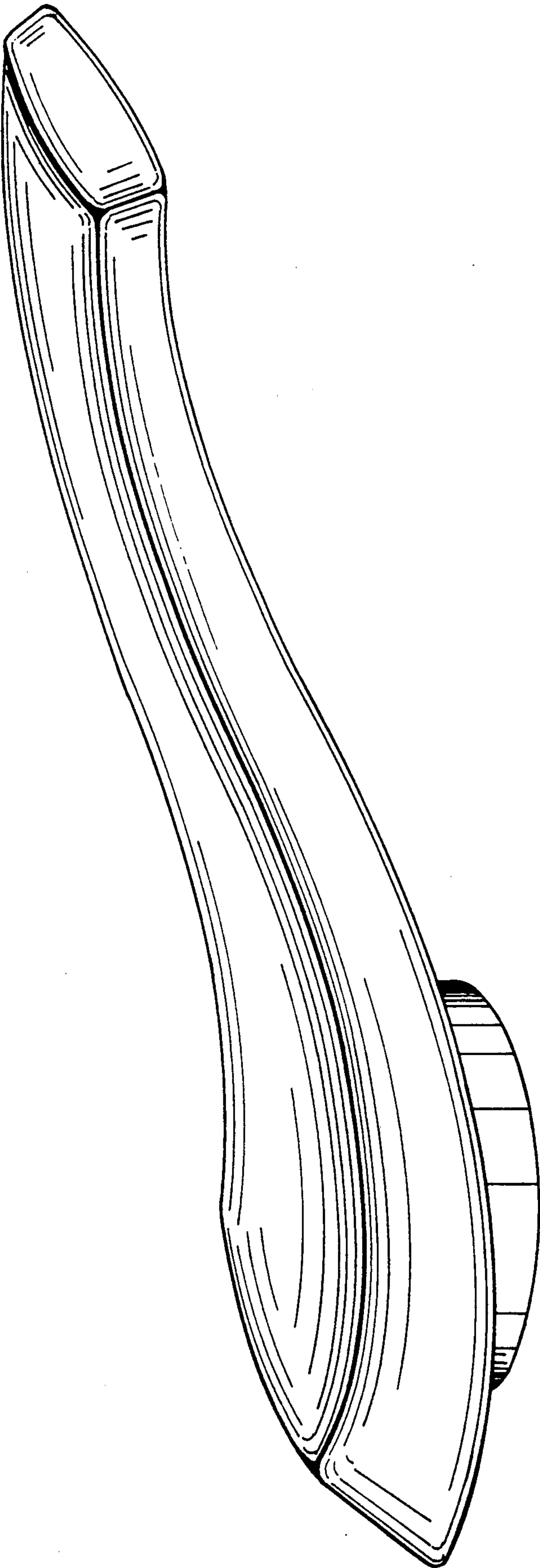

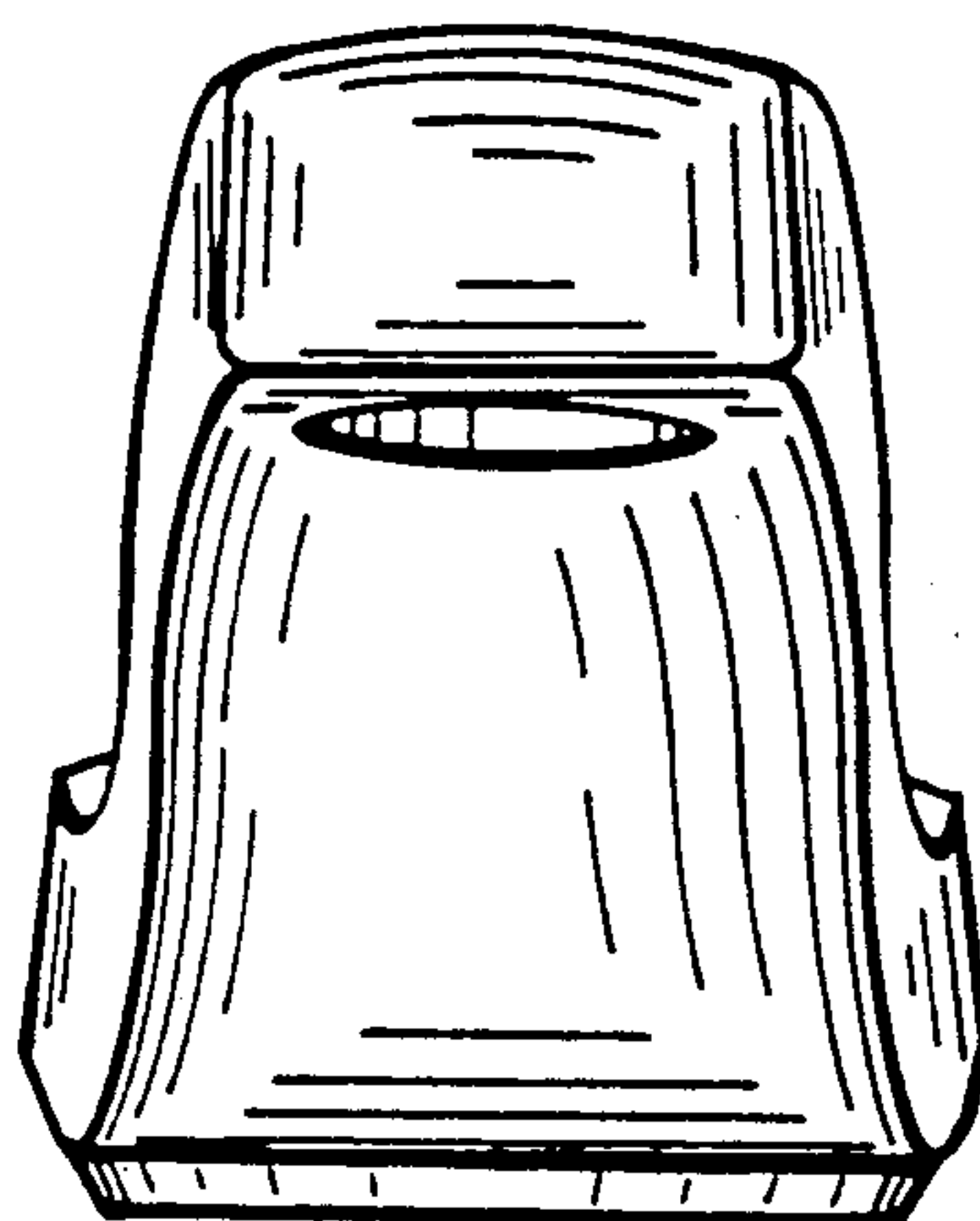
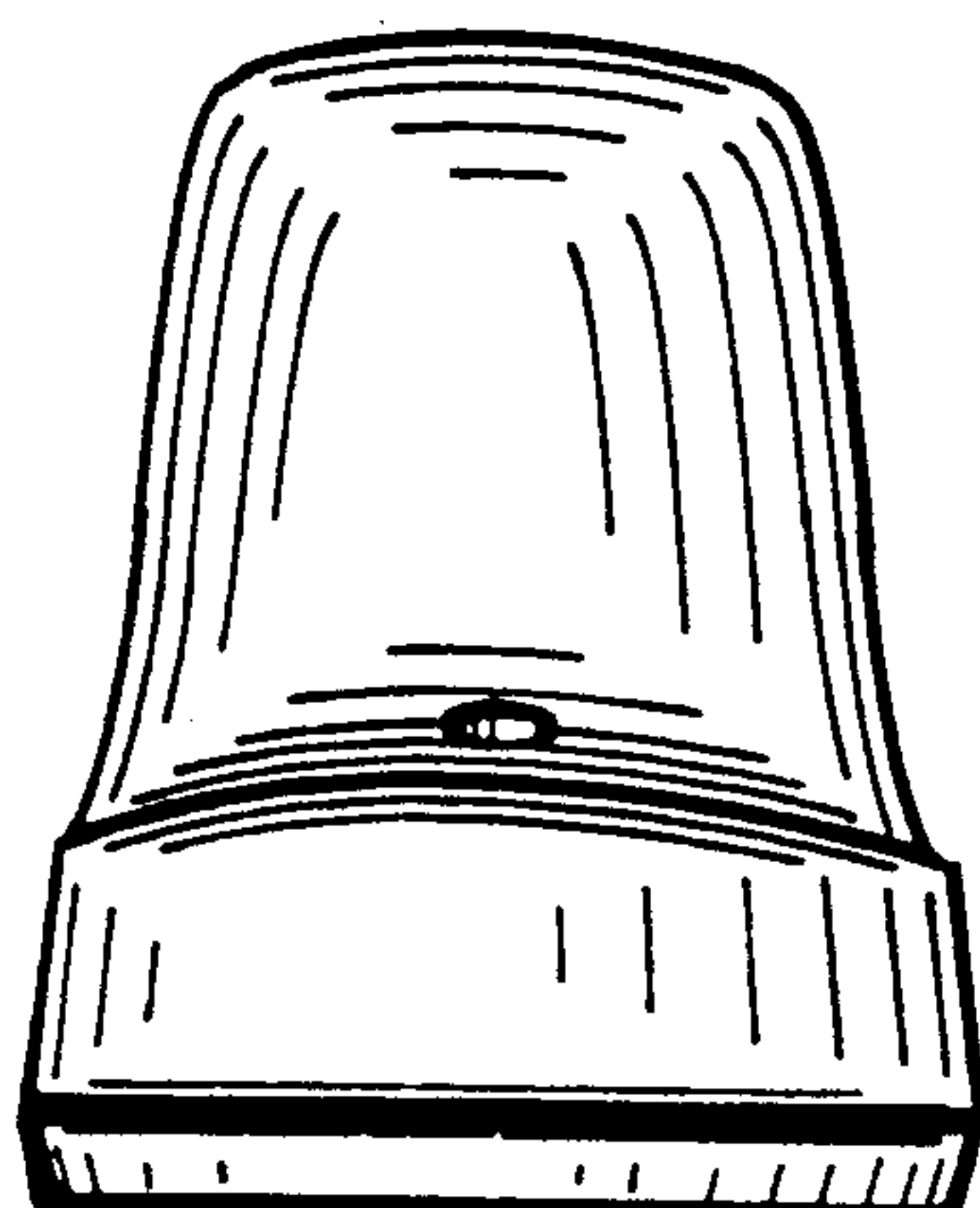

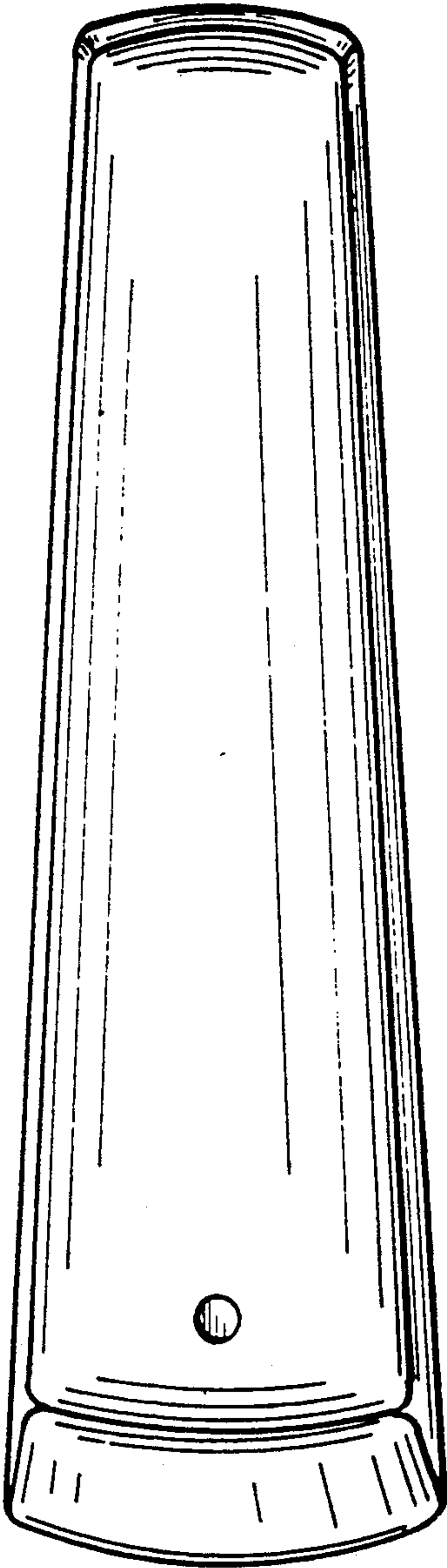

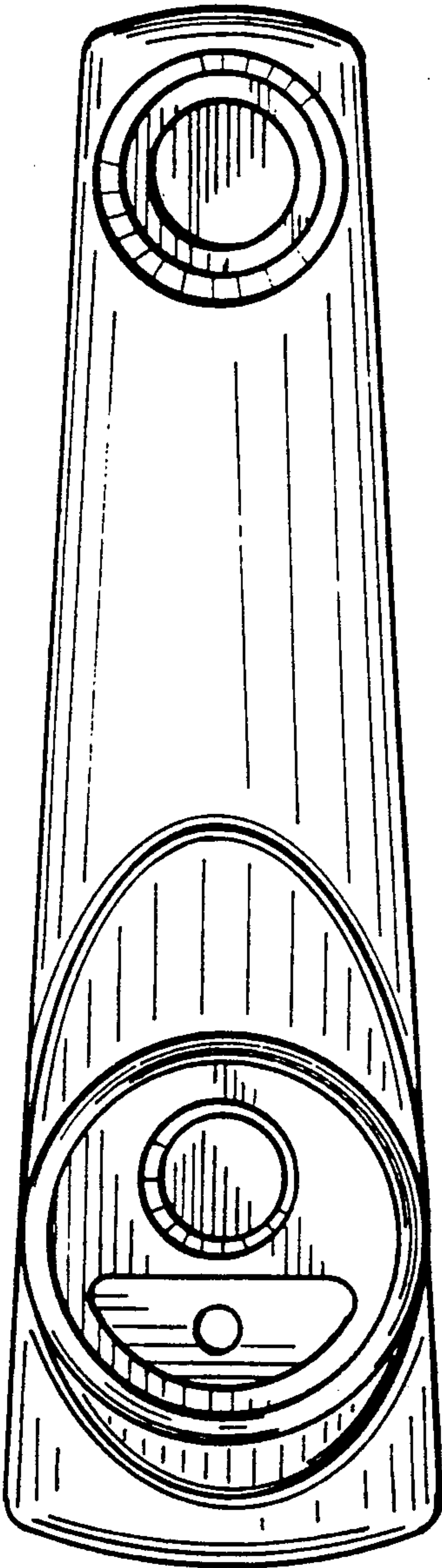
