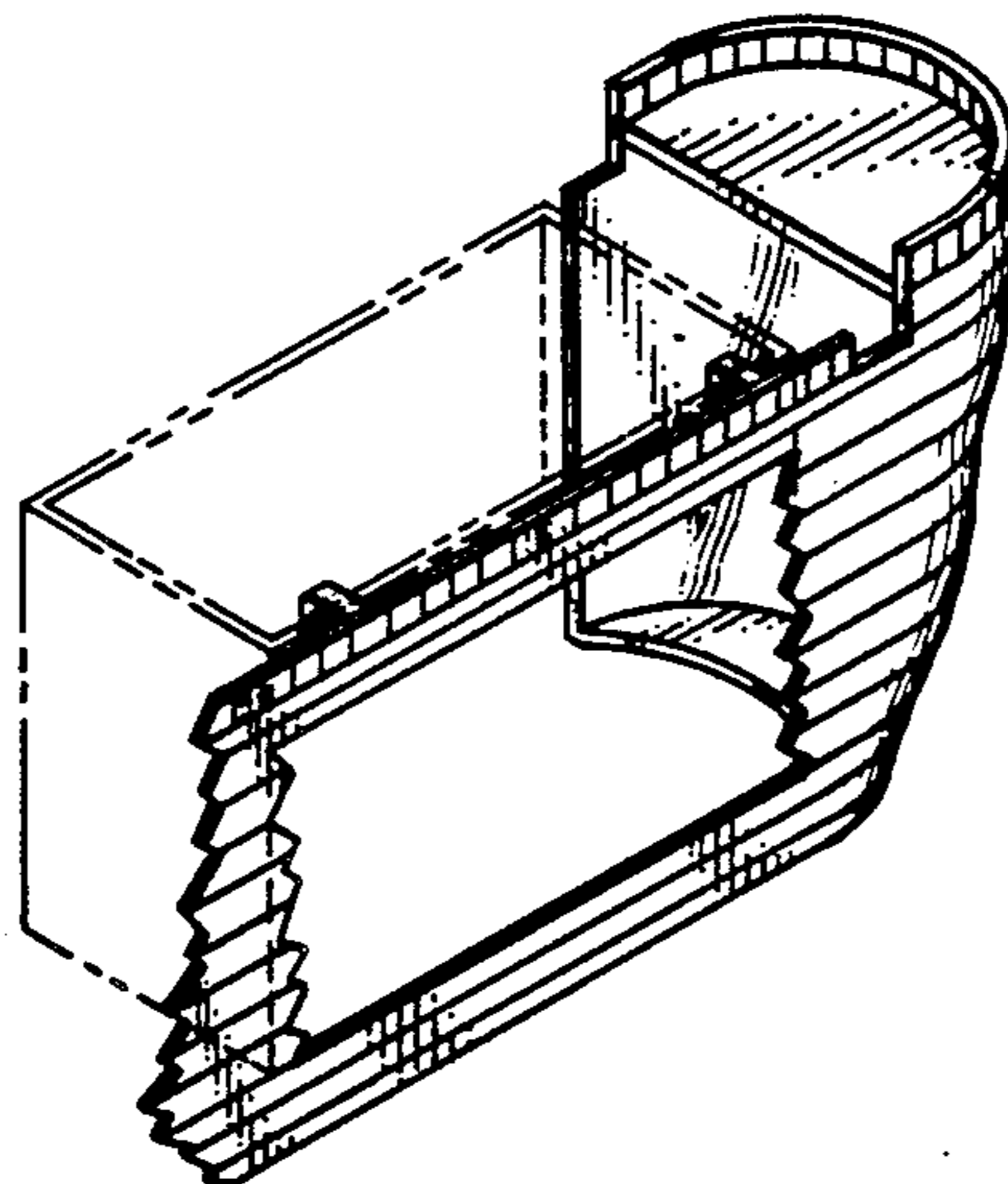
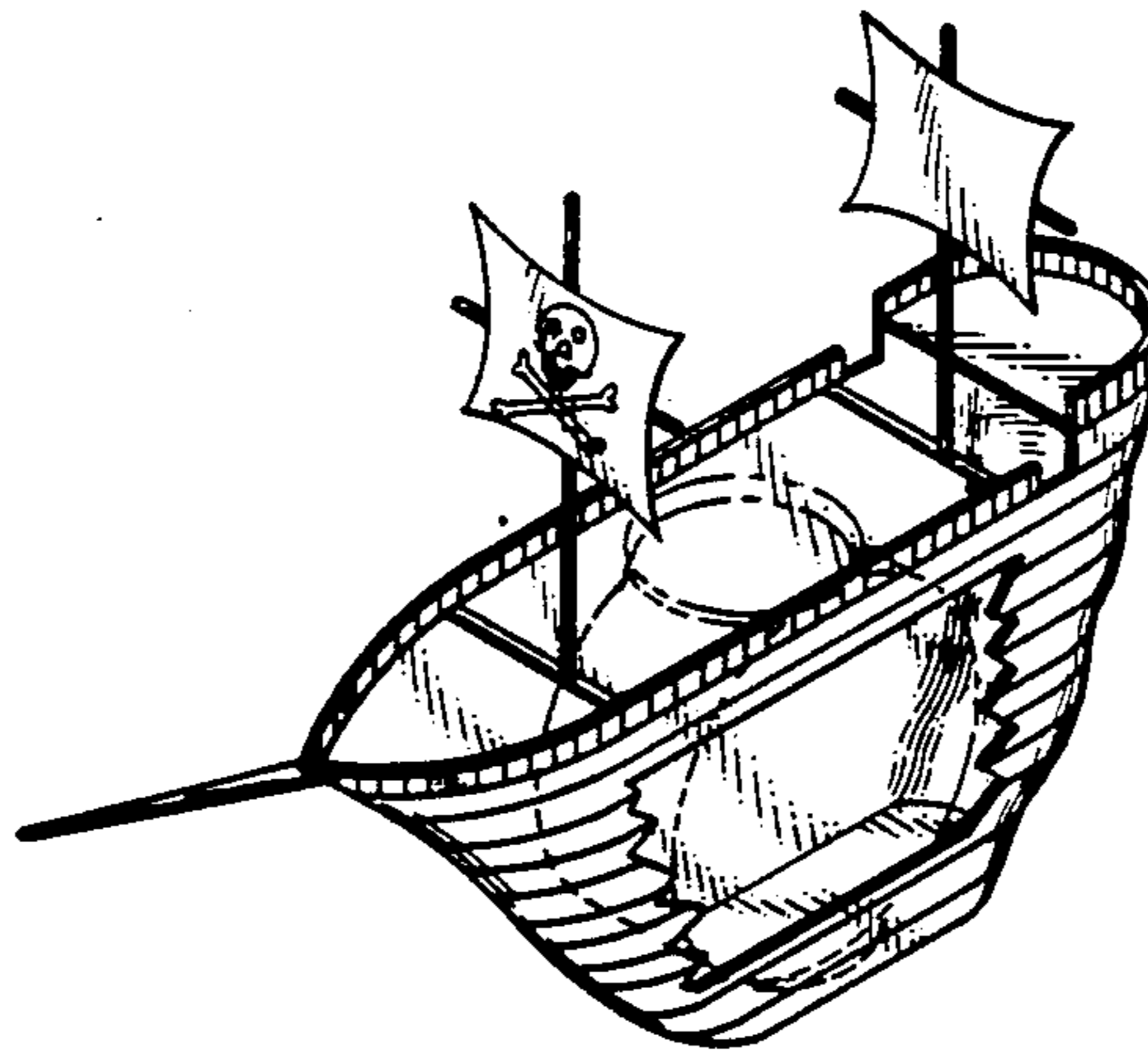

[57] **CLAIM**

The ornamental design for a fish tank facade, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a fish tank facade showing my new design;
 FIG. 2 is a left side elevational view thereof;
 FIG. 3 is a right side elevational view thereof;
 FIG. 4 is a front elevational view thereof;
 FIG. 5 is a rear elevational view thereof;
 FIG. 6 is a top plan view thereof;
 FIG. 7 is a bottom plan view thereof;
 FIG. 8 is a top front perspective view of a second embodiment of FIG. 1;
 FIG. 9 is a left side elevational view thereof;
 FIG. 10 is a right side elevational view thereof;
 FIG. 11 is a front elevational view thereof;
 FIG. 12 is a rear elevational view thereof;
 FIG. 13 is a top plan view thereof; and
 FIG. 14 is a bottom plan view thereof.
 The broken lines in FIGS. 1 and 8 are for purposes of illustration and form no part of the claimed design.



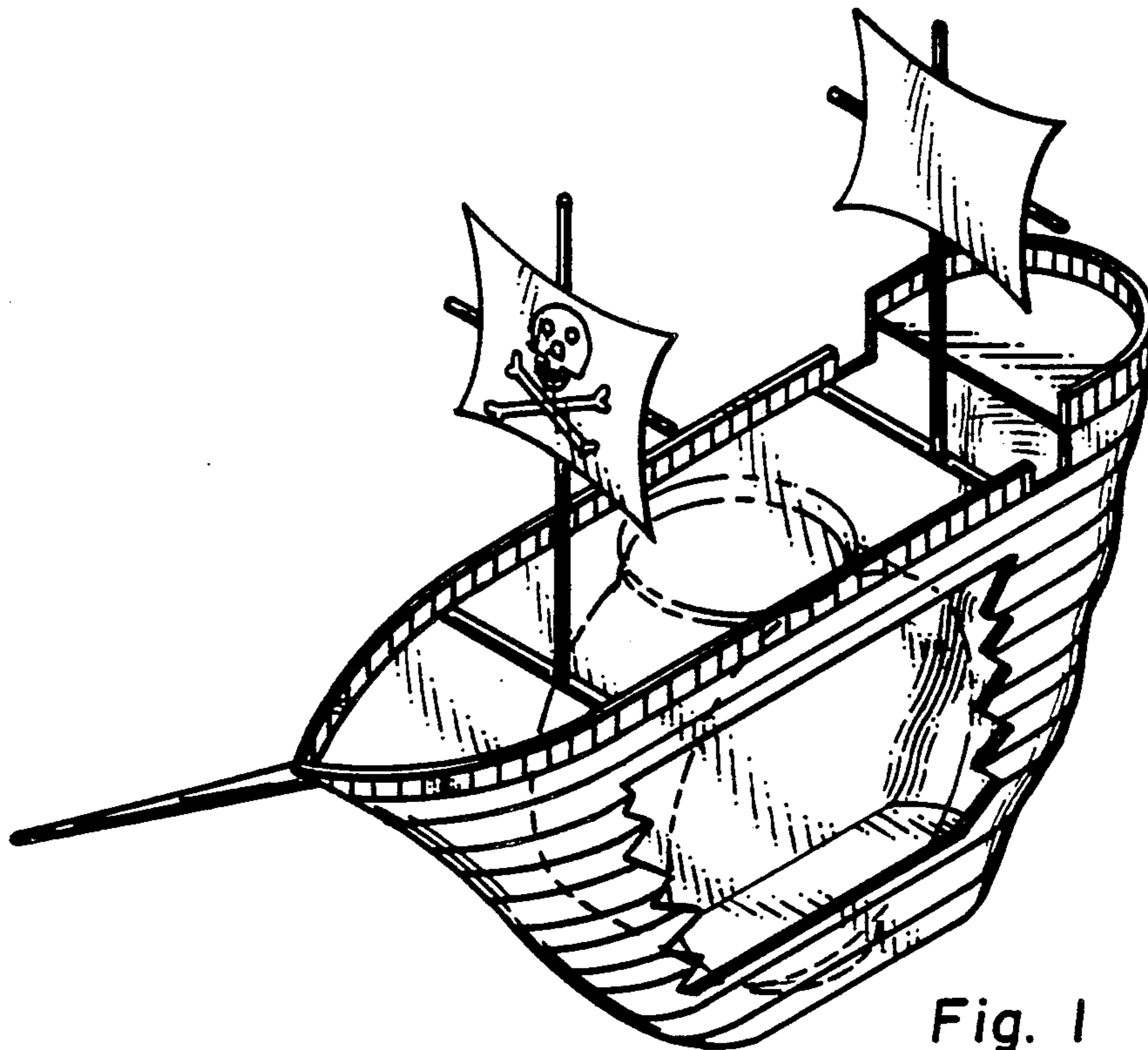

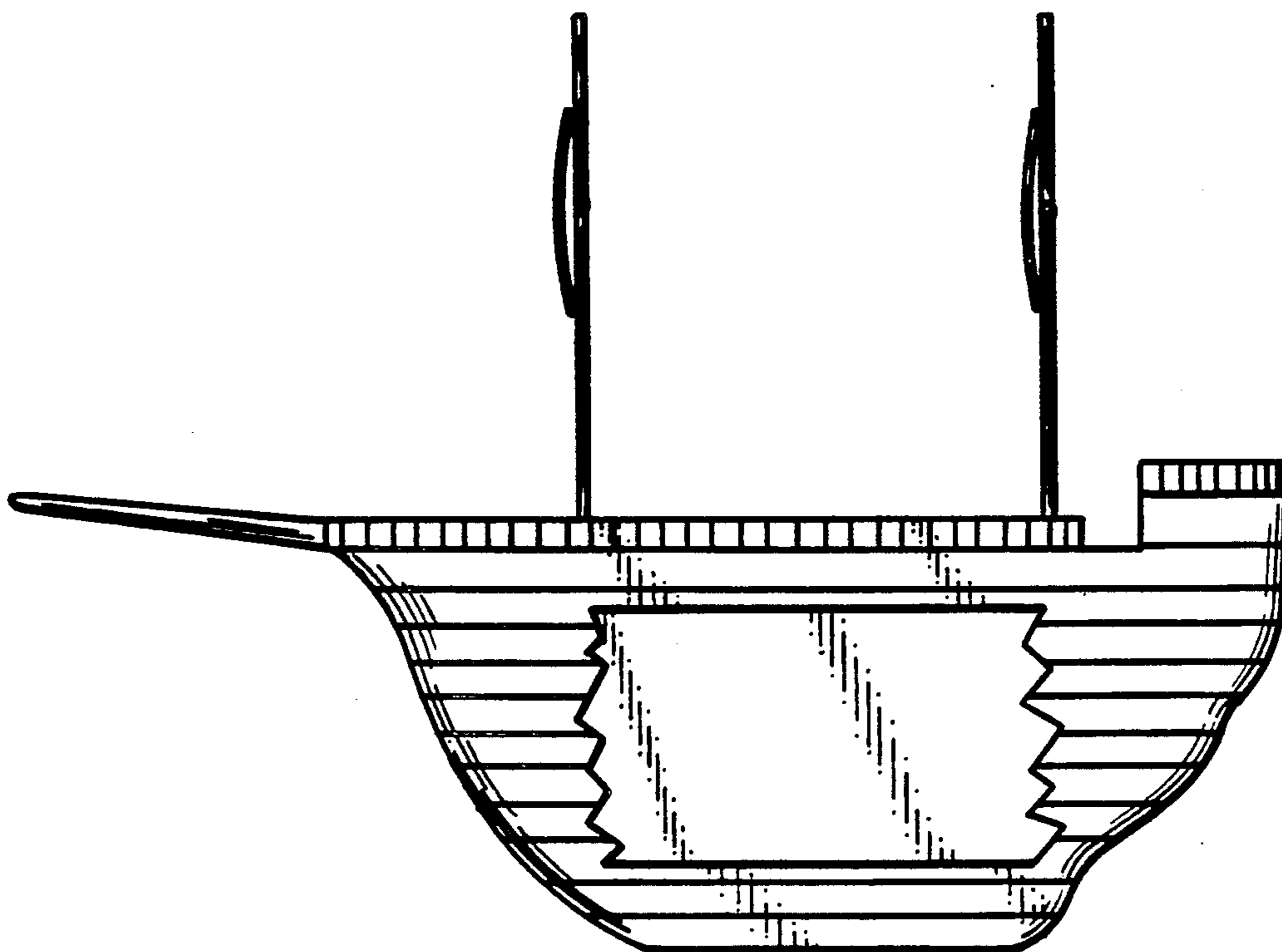

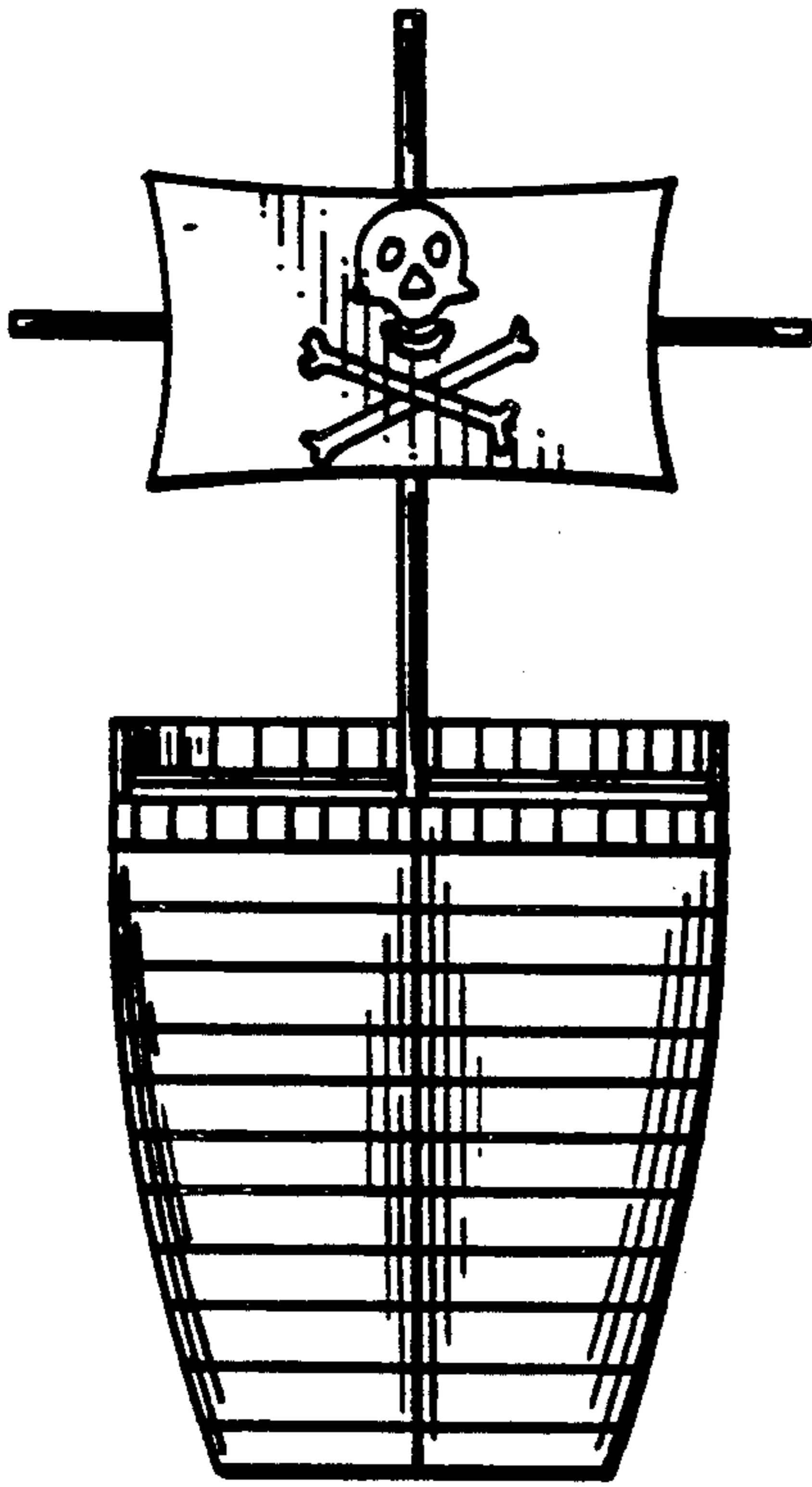

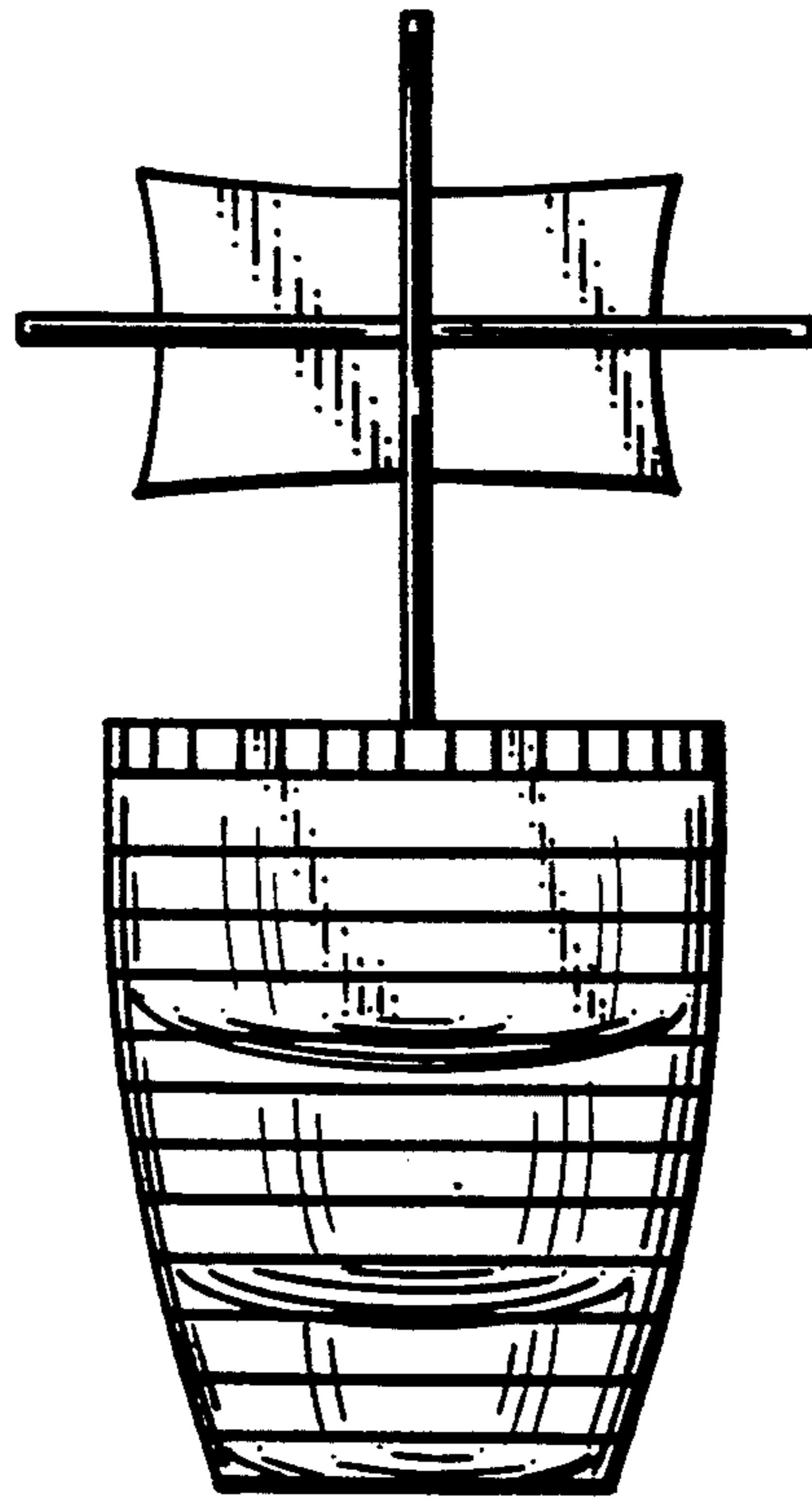

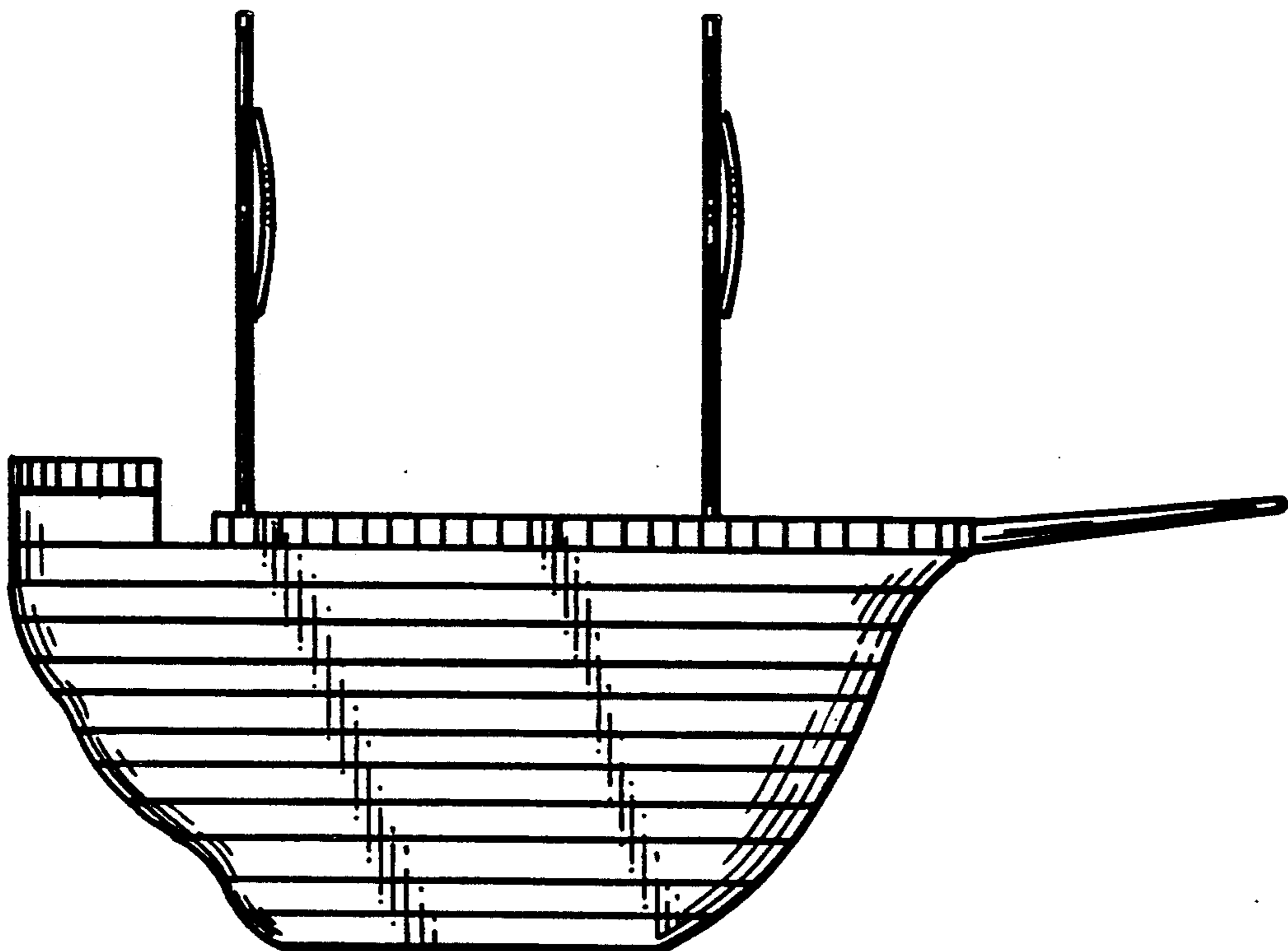

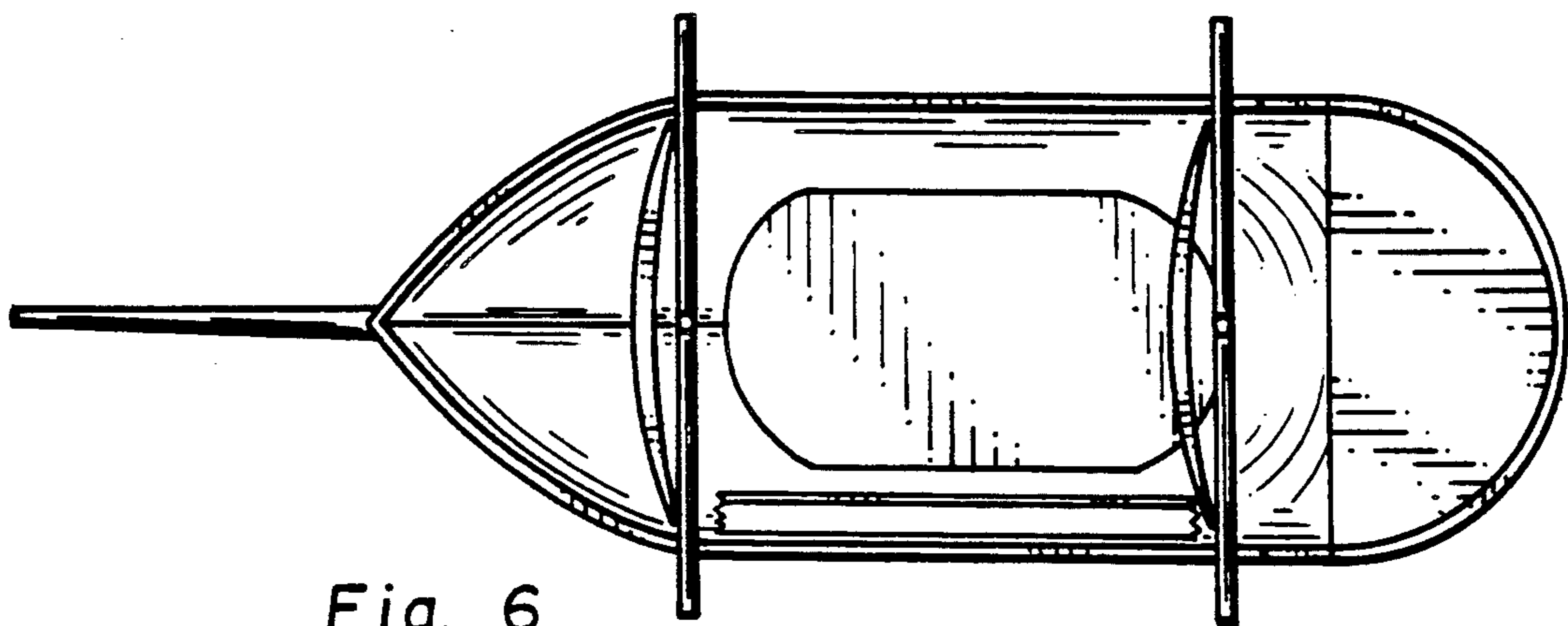

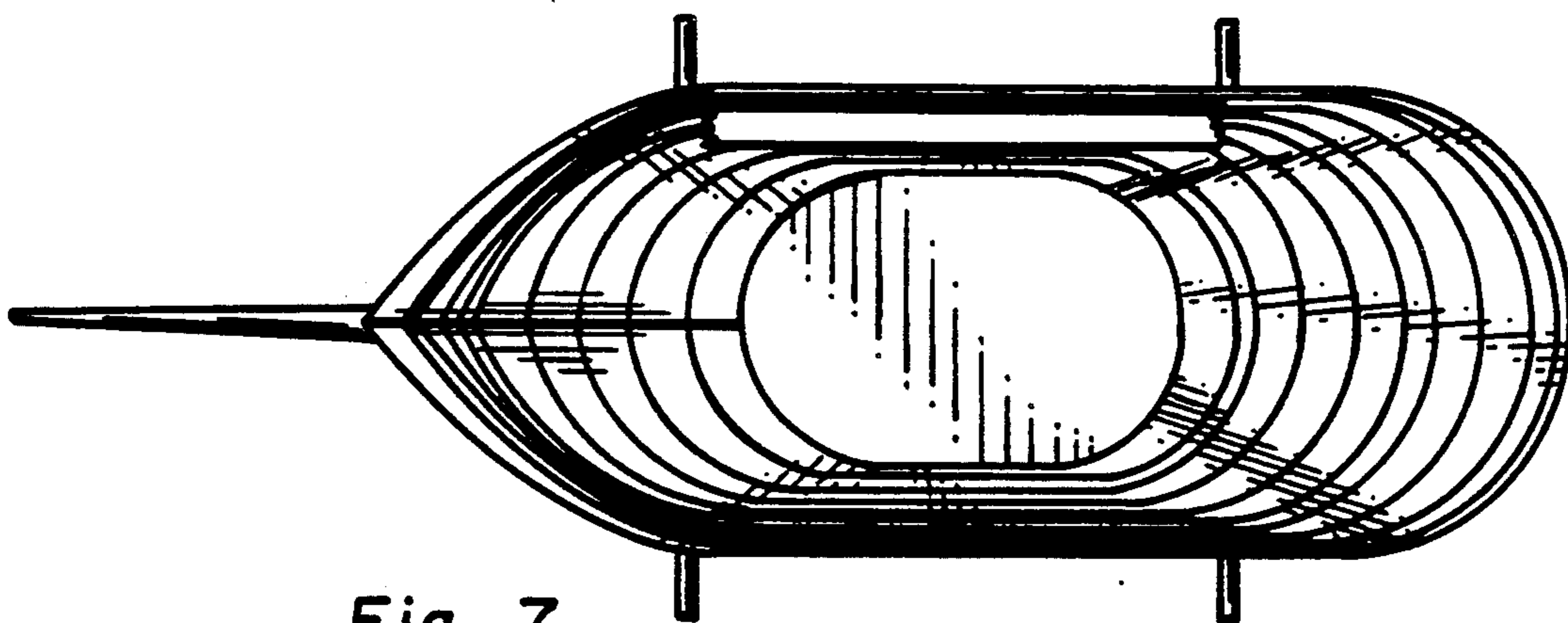

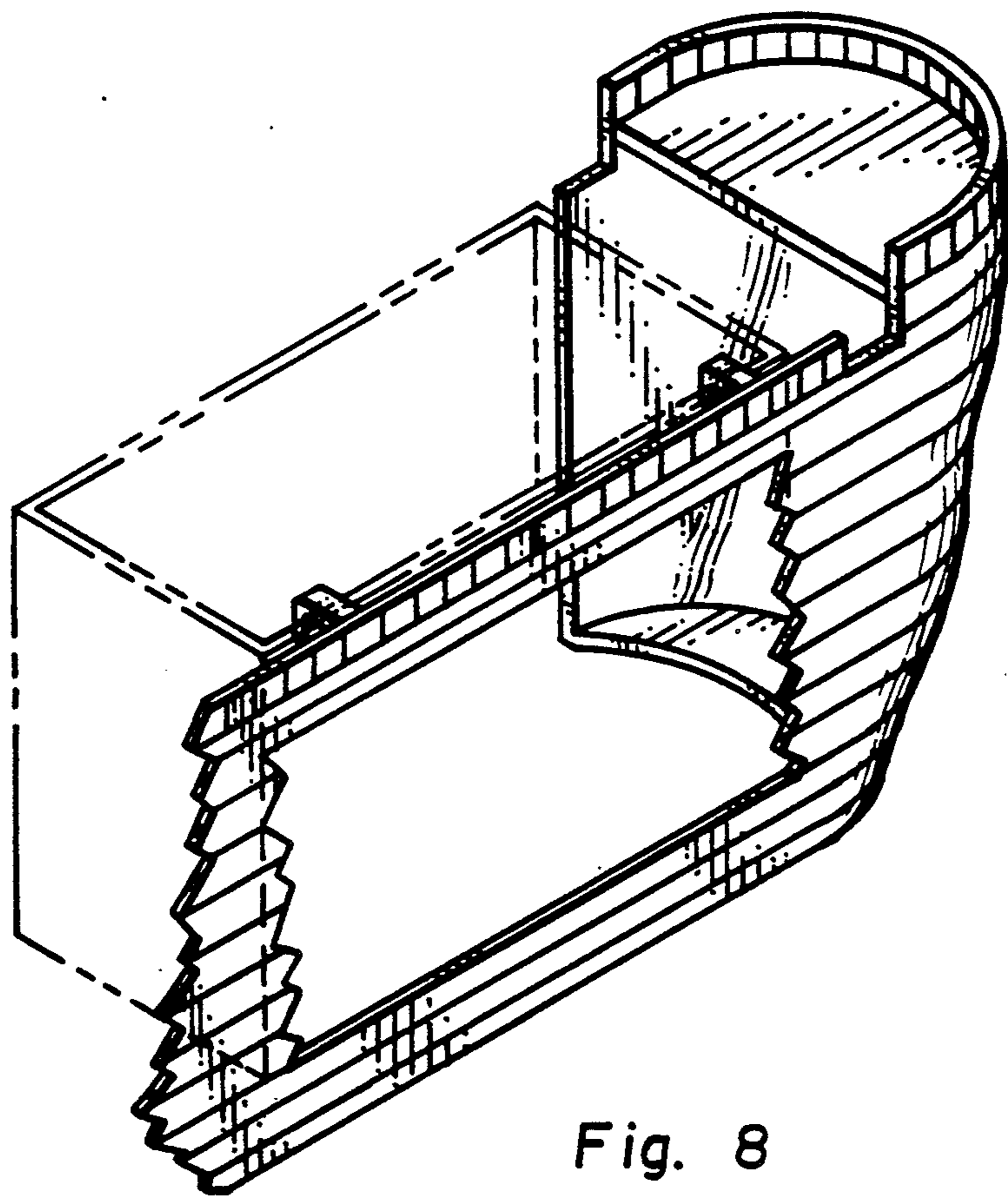

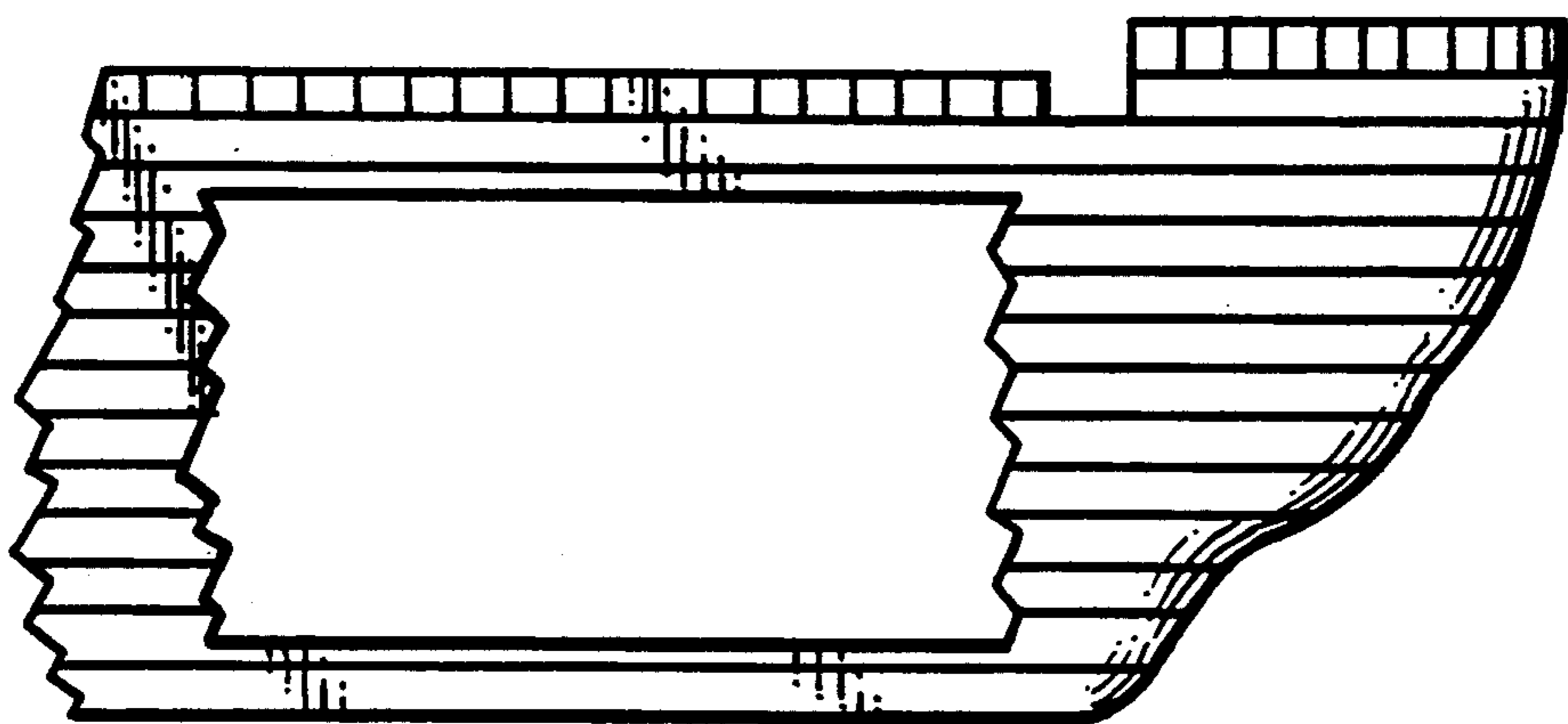

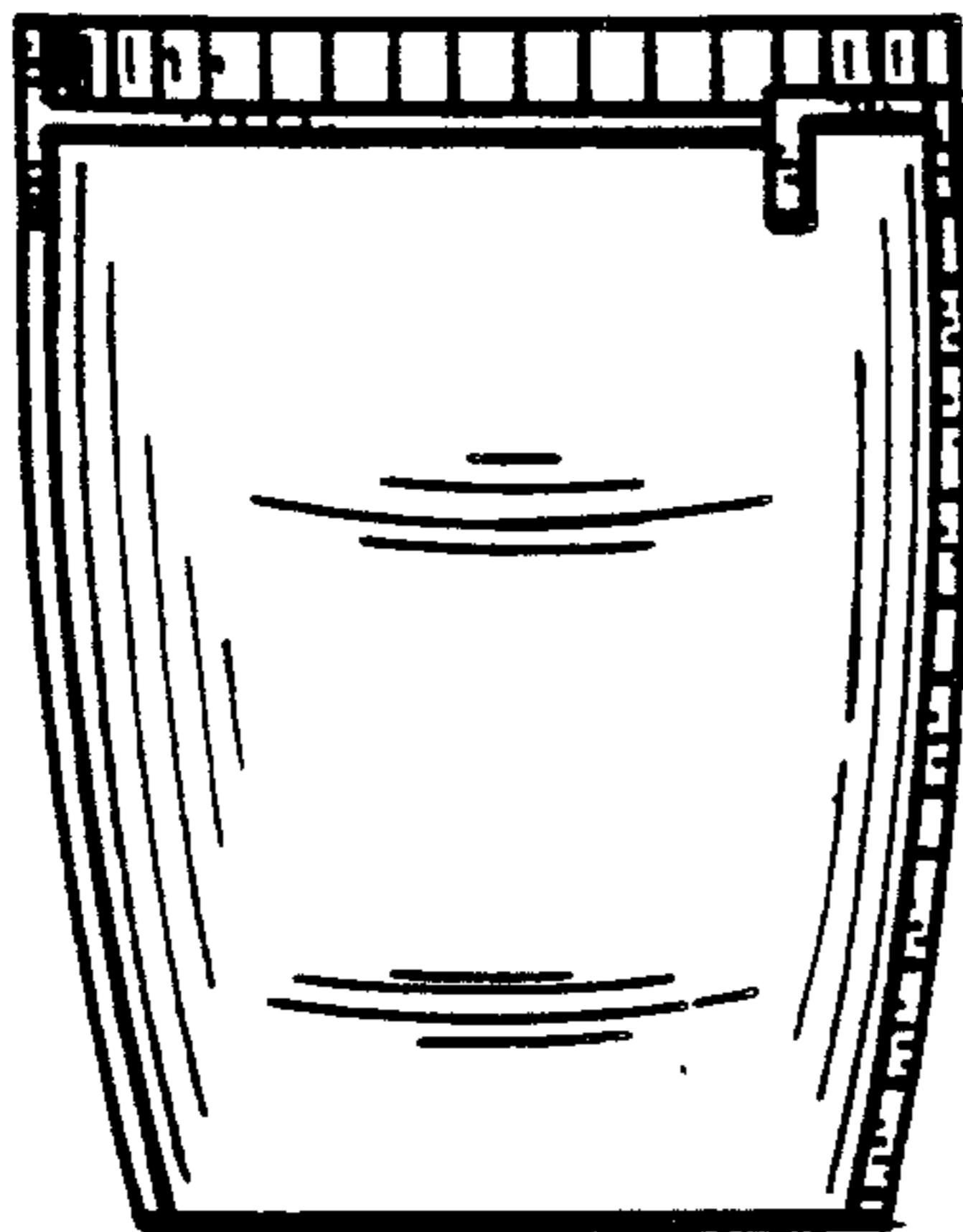

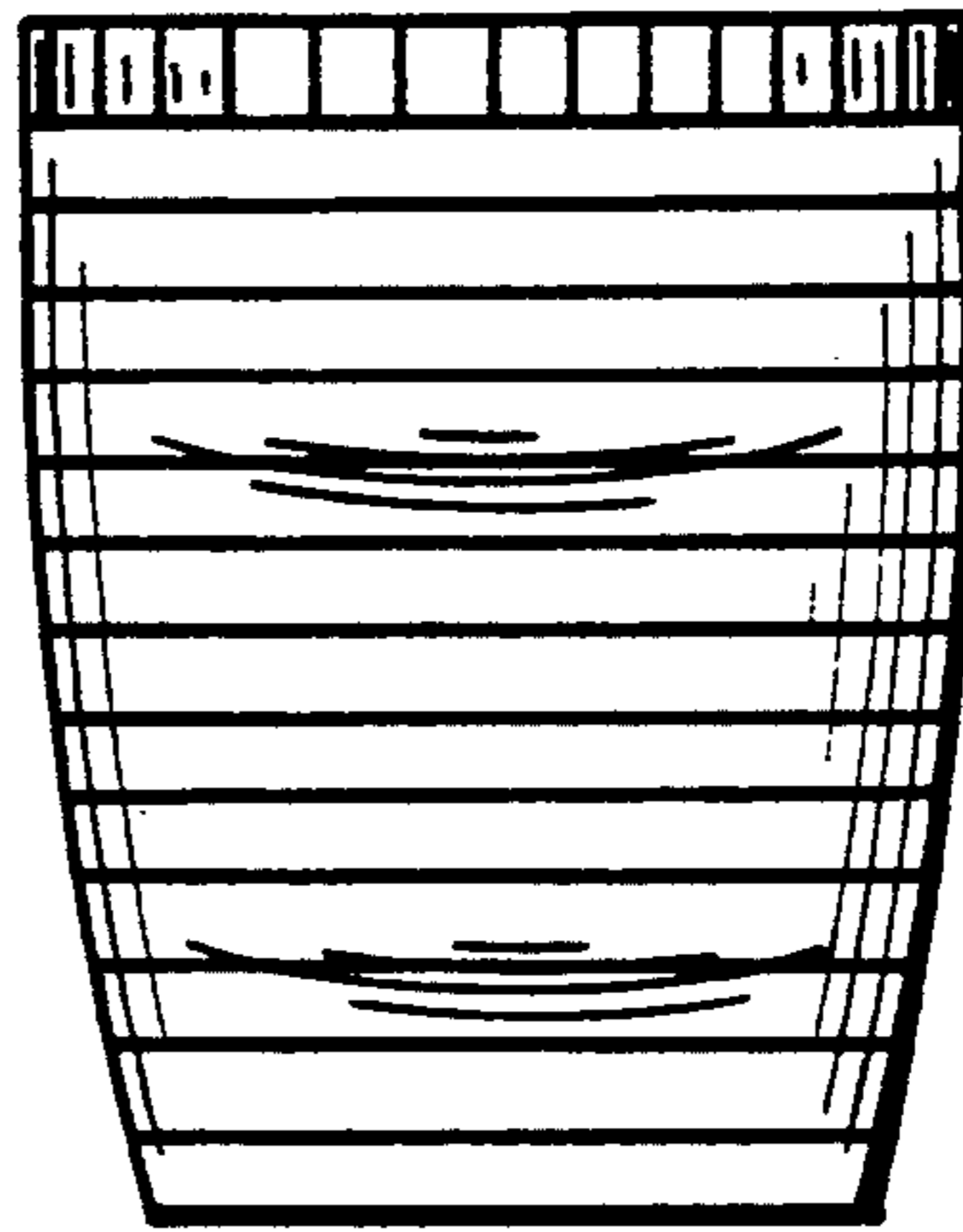

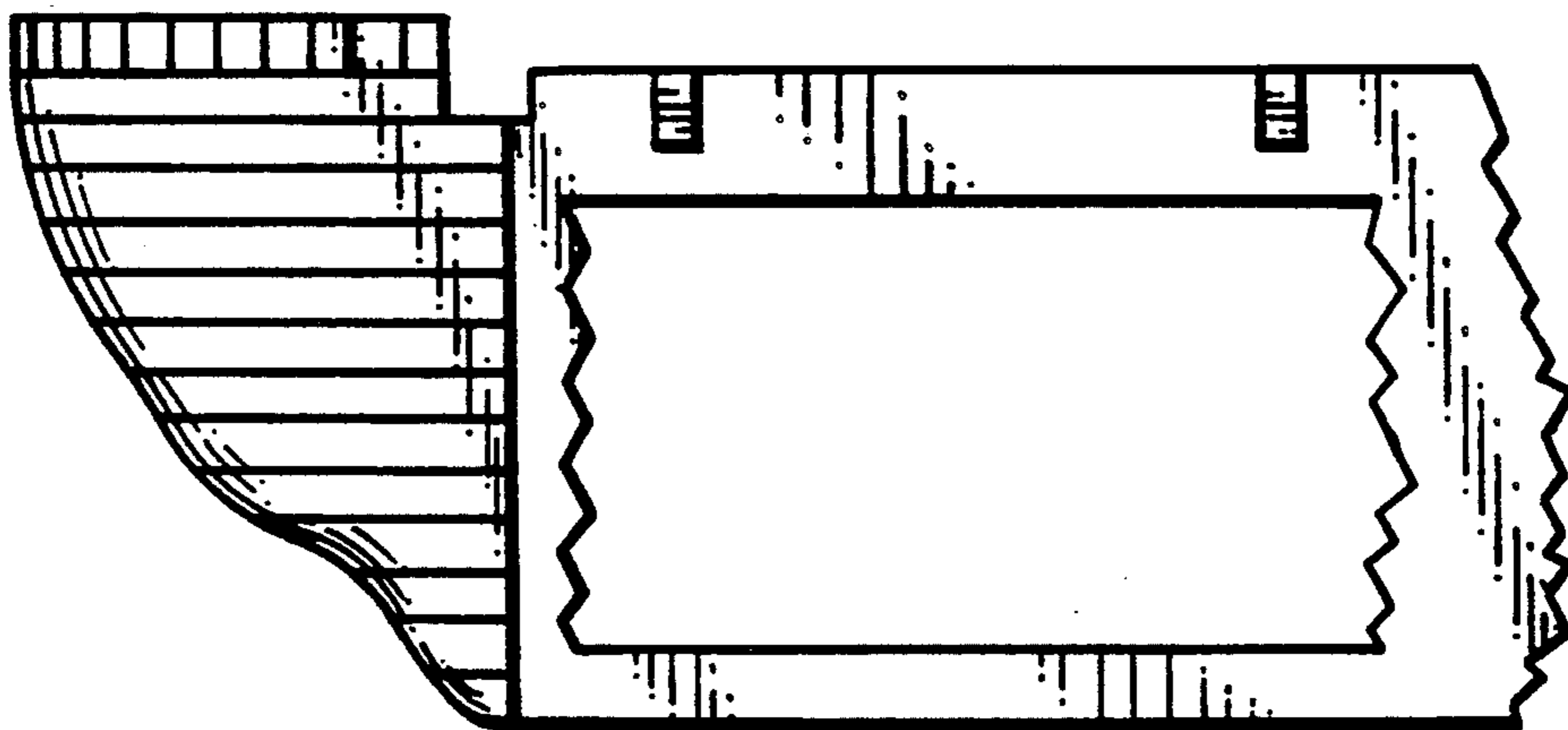

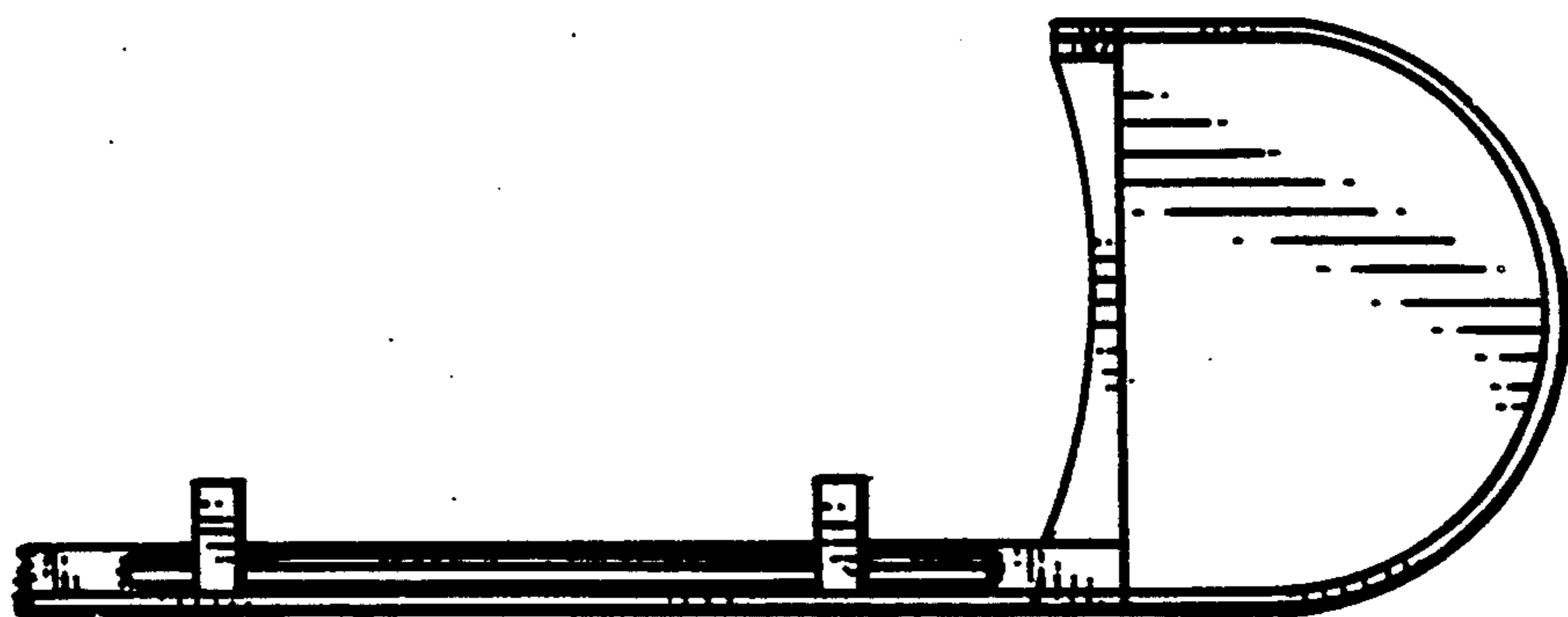

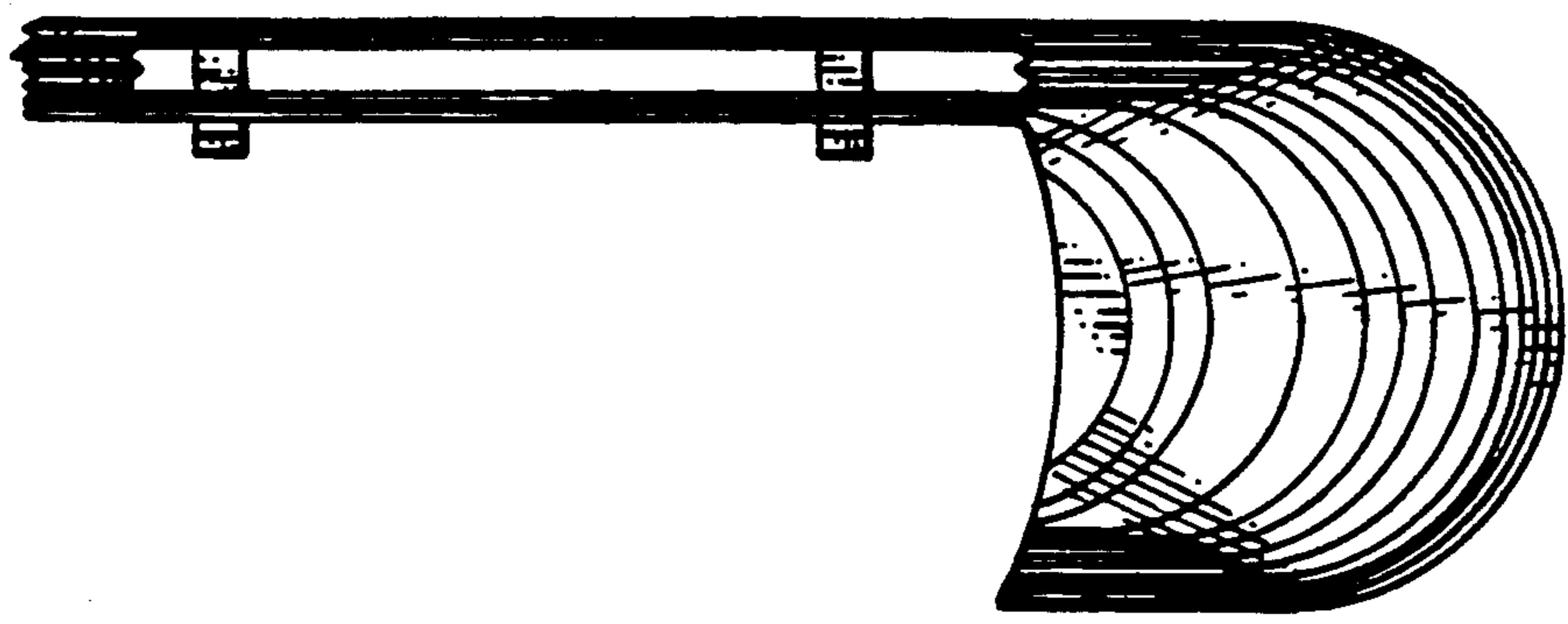
