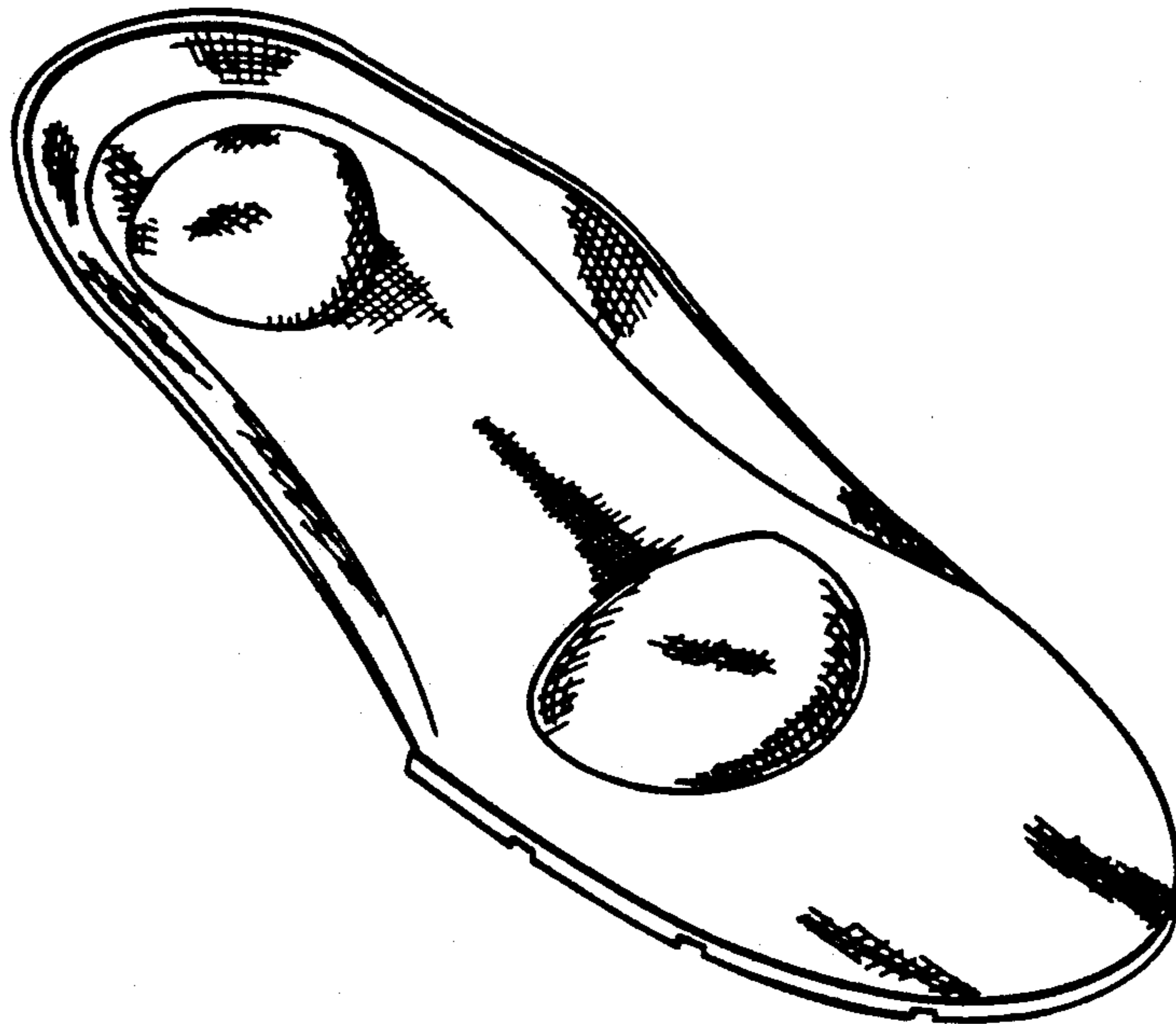

### DESCRIPTION

FIG. 1 is a top perspective view of a shoe insole, showing my new design;  
 FIG. 2 is a top plan view thereof;  
 FIG. 3 is a left side elevational view thereof;  
 FIG. 4 is a bottom view thereof;  
 FIG. 5 is a right side view thereof;  
 FIG. 6 is a front view thereof; and,  
 FIG. 7 is a rear view thereof.



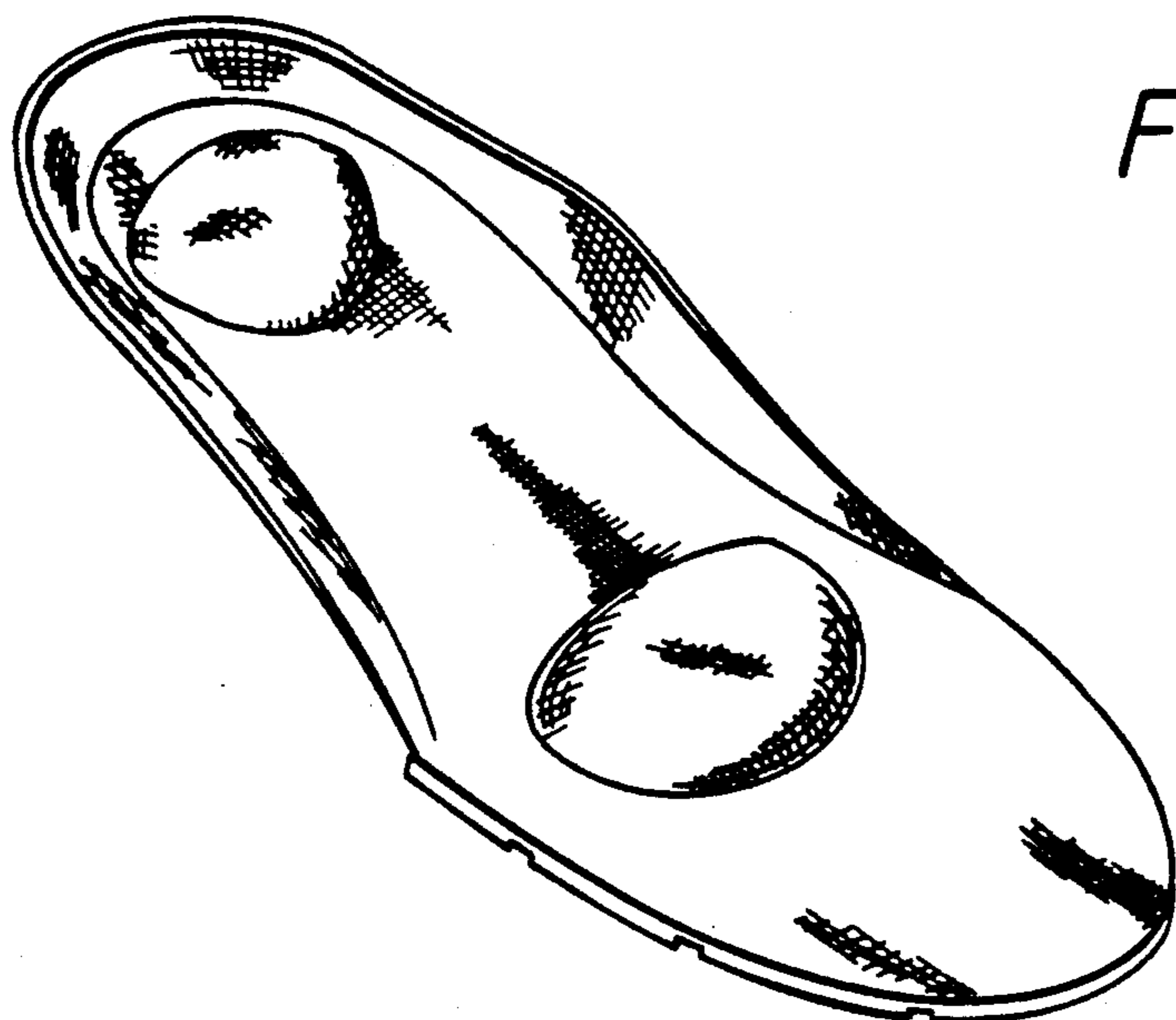

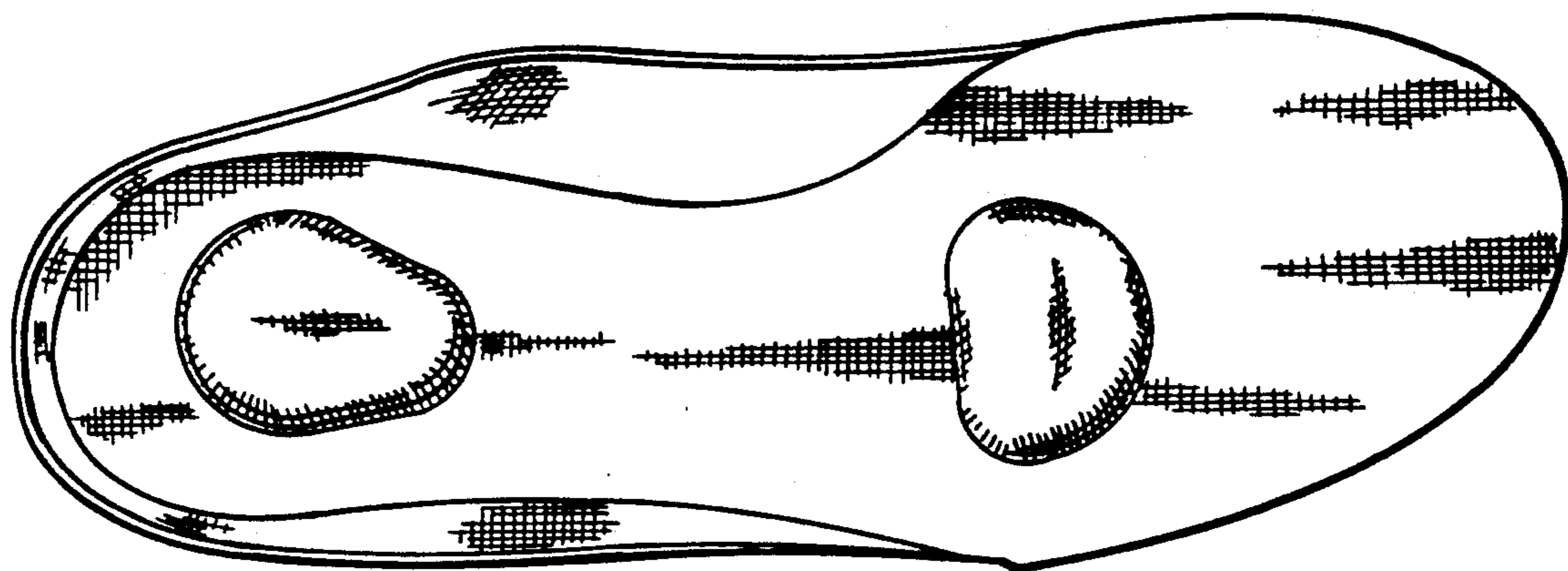

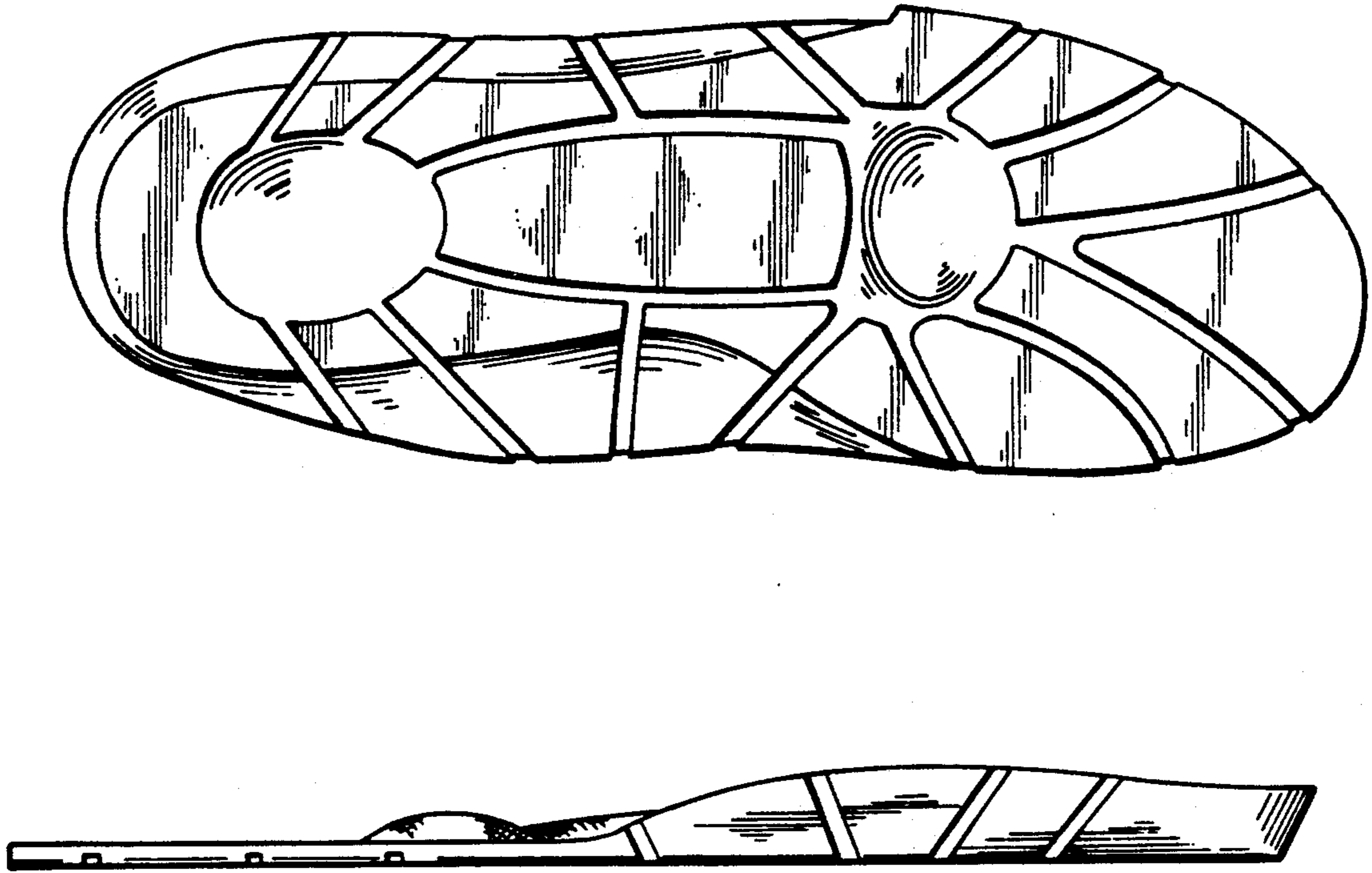

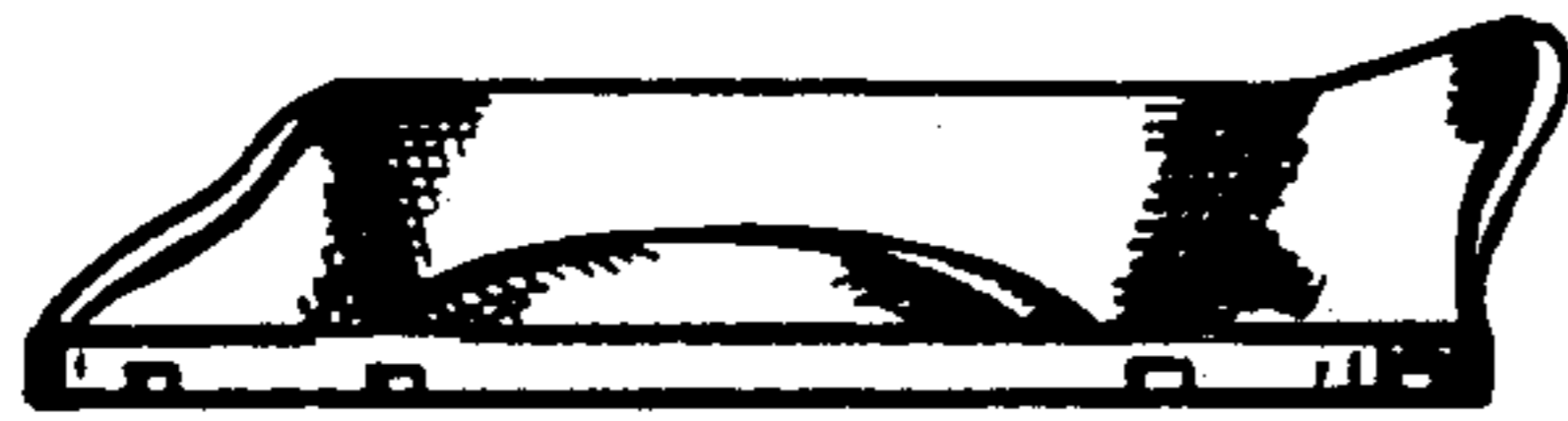

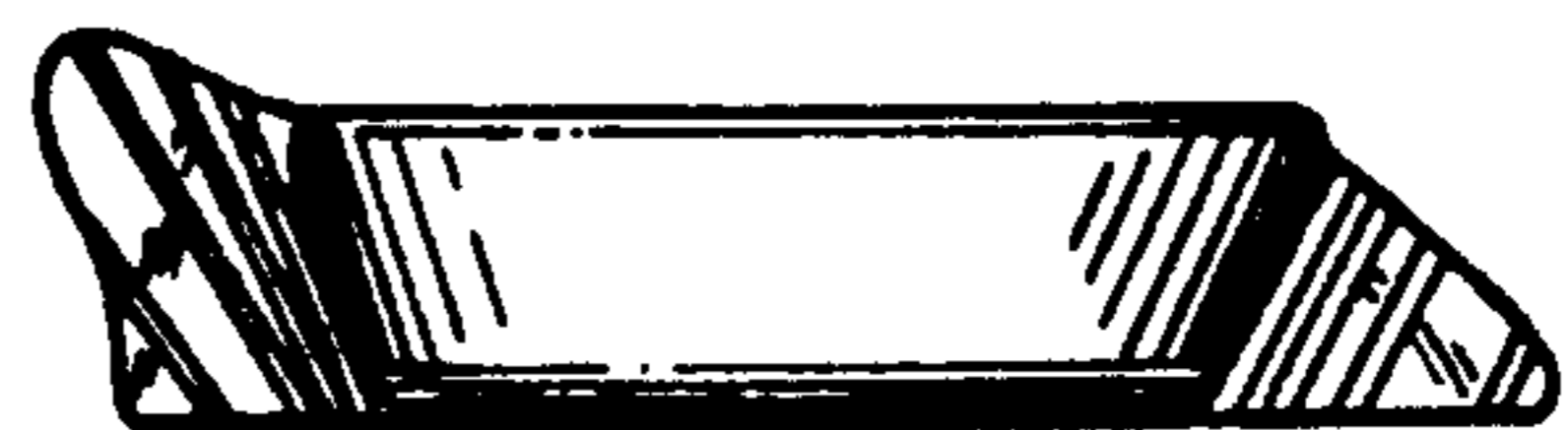
